(57) **CLAIM**

The ornamental design for a glove with palm and finger patch, as shown and described.

DESCRIPTION

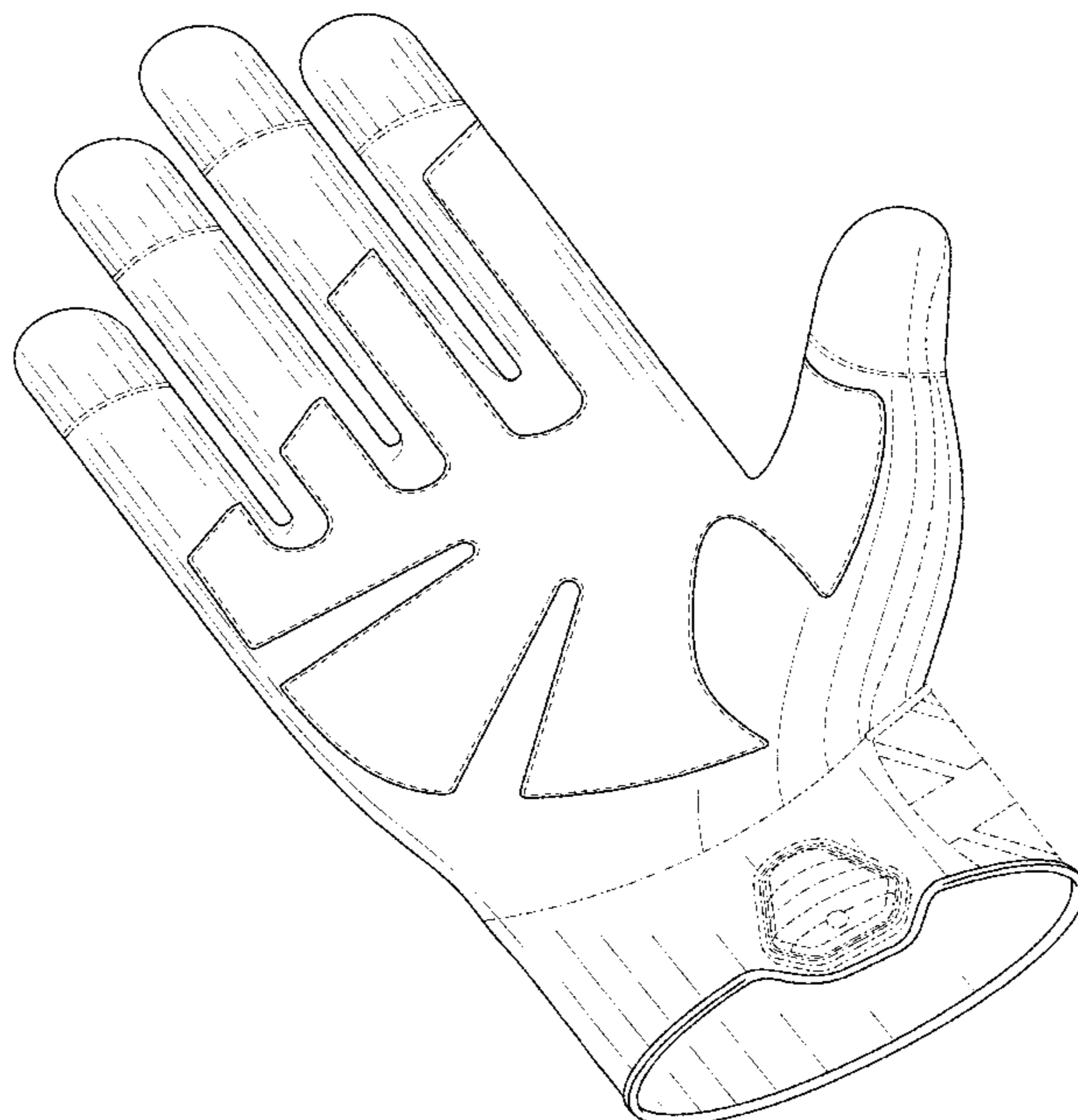
FIG. 1 is a back perspective view of a glove with palm and finger patch, showing our new design; FIG. 2 is a front perspective view thereof; FIG. 3 is a back elevation view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom view thereof.

The dash-dot-dash lines shown in the figures illustrate portions of the glove with palm and finger patch that form no part of the claimed design.

The broken lines shown in the figures represent stitching and form part of the claimed design.

While a right-handed glove is shown and claimed, the right-handed glove is typically sold with a left-handed glove having a design that is a mirror image of the right-handed glove.

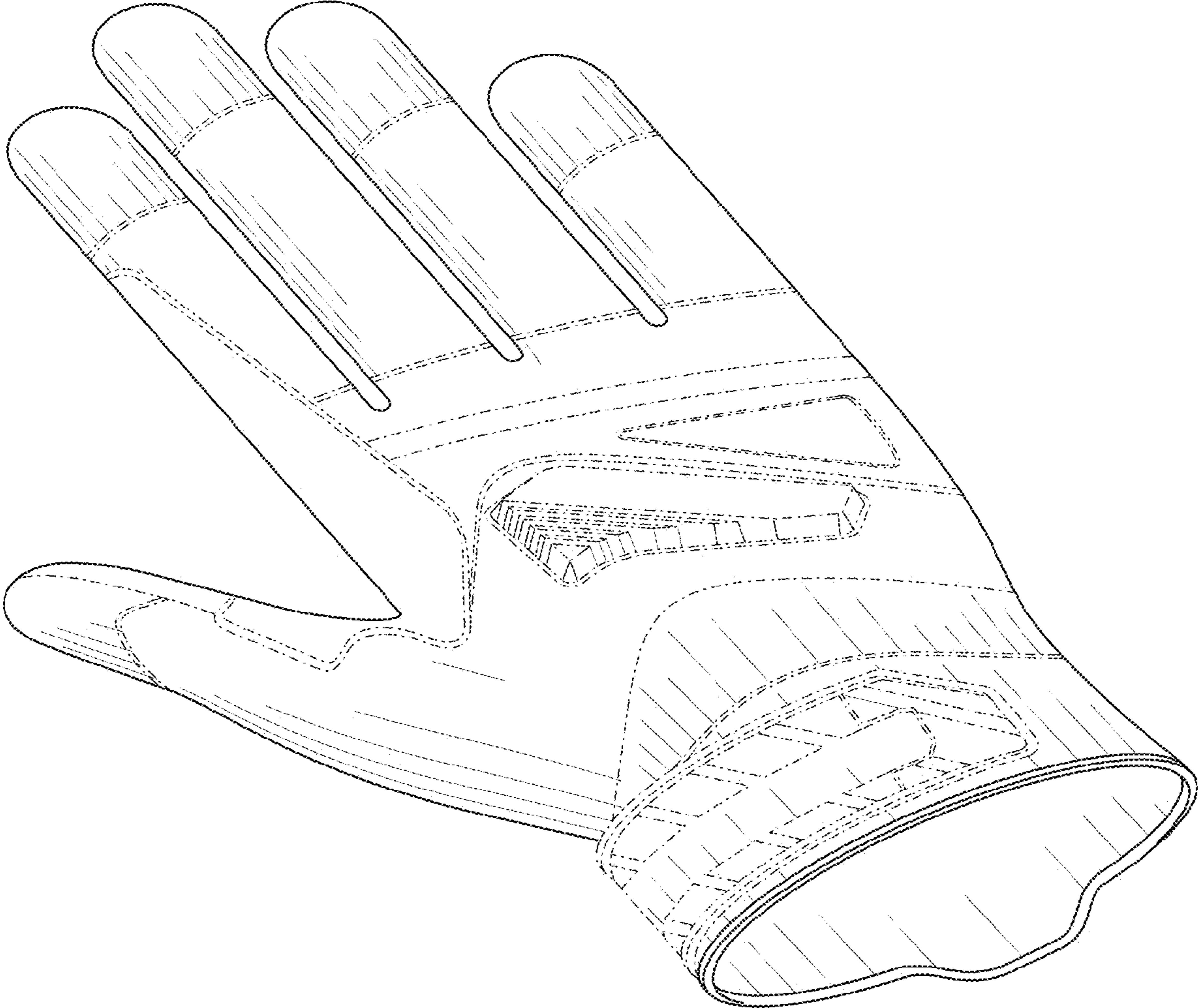

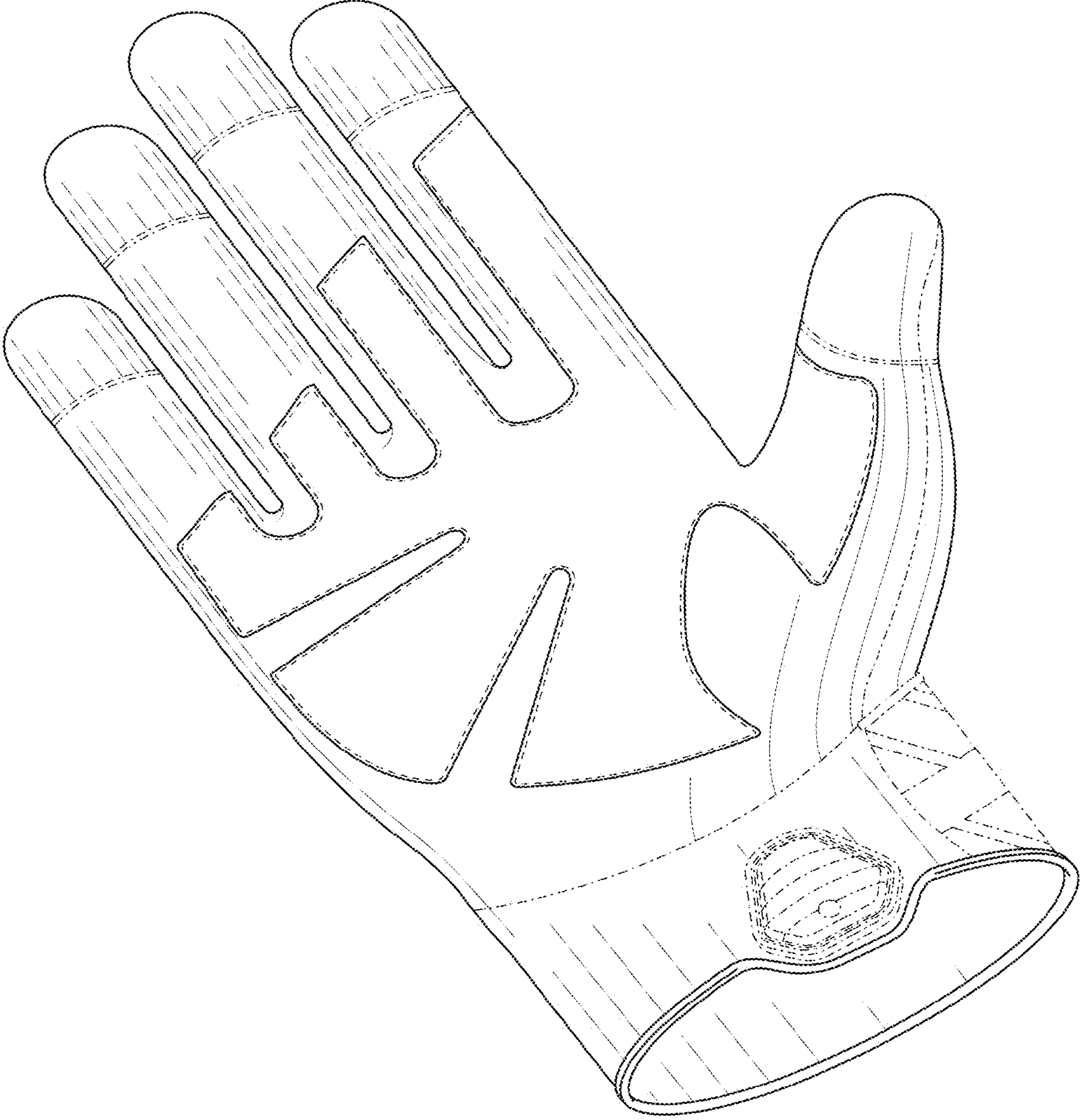

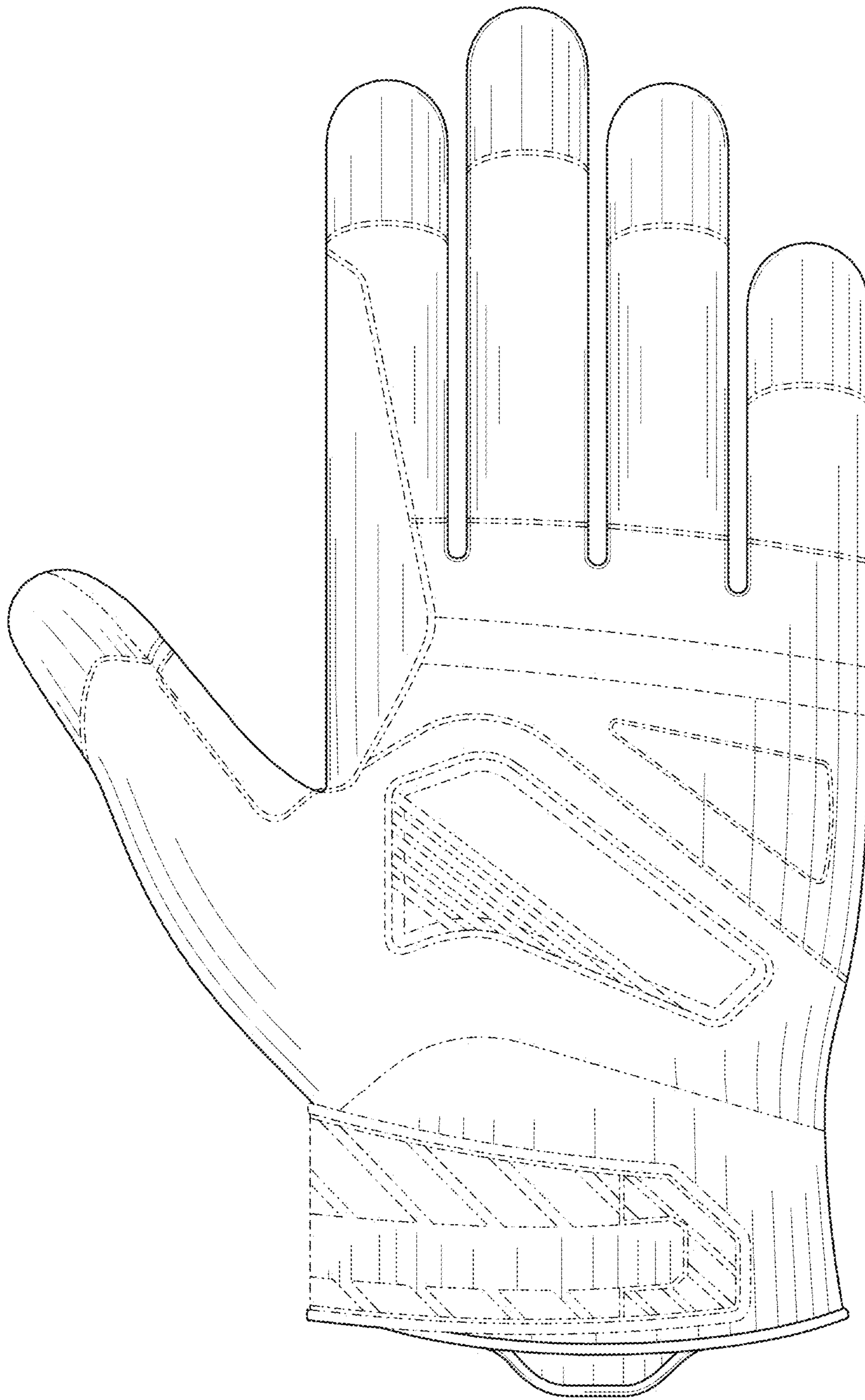

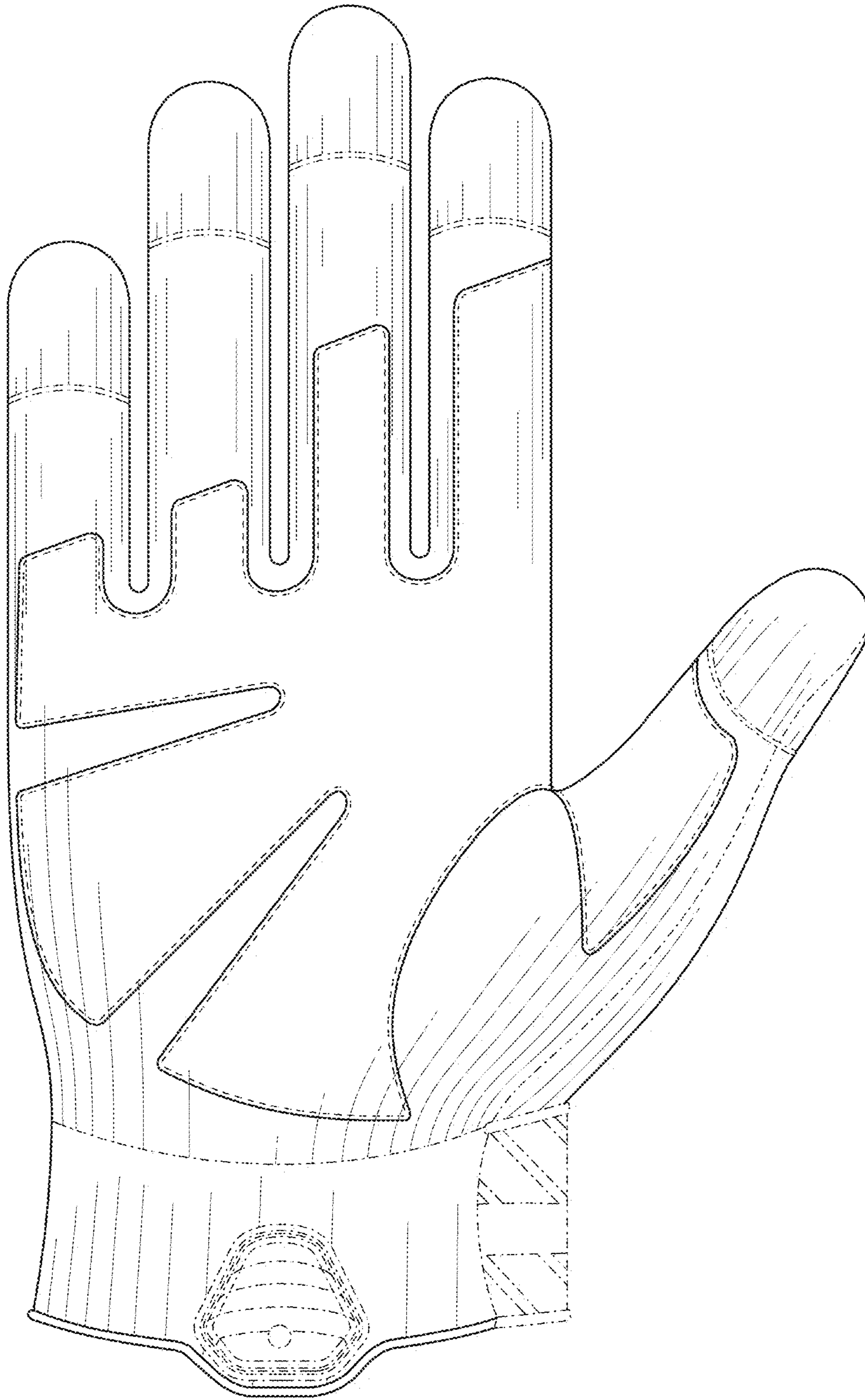

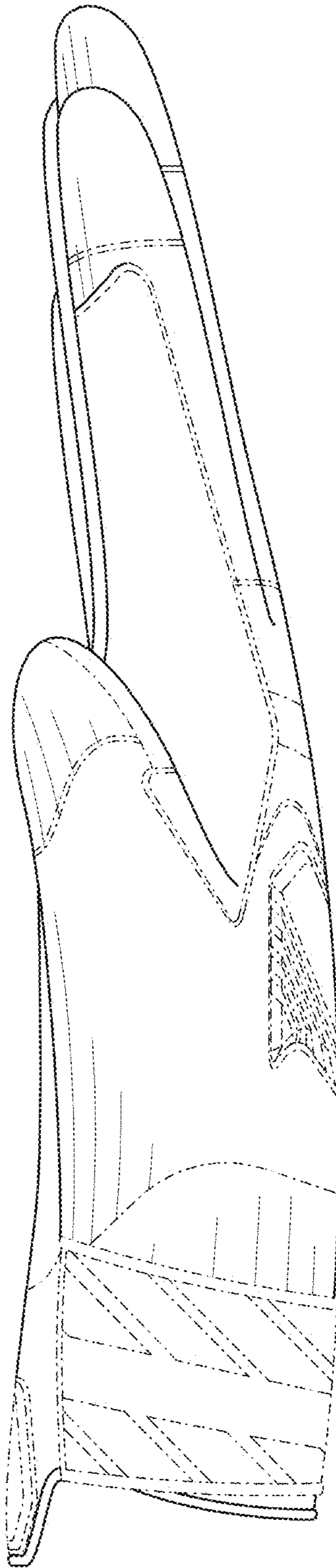

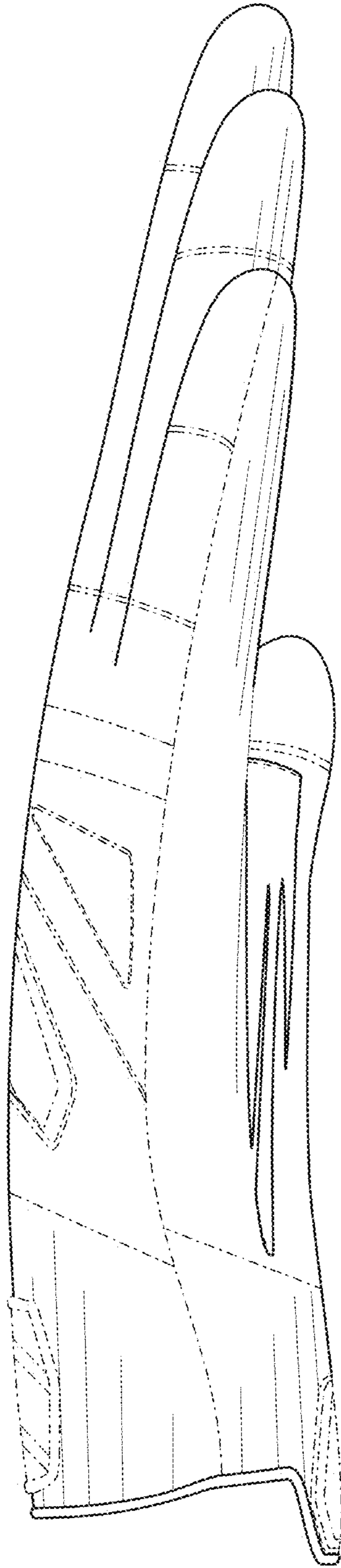

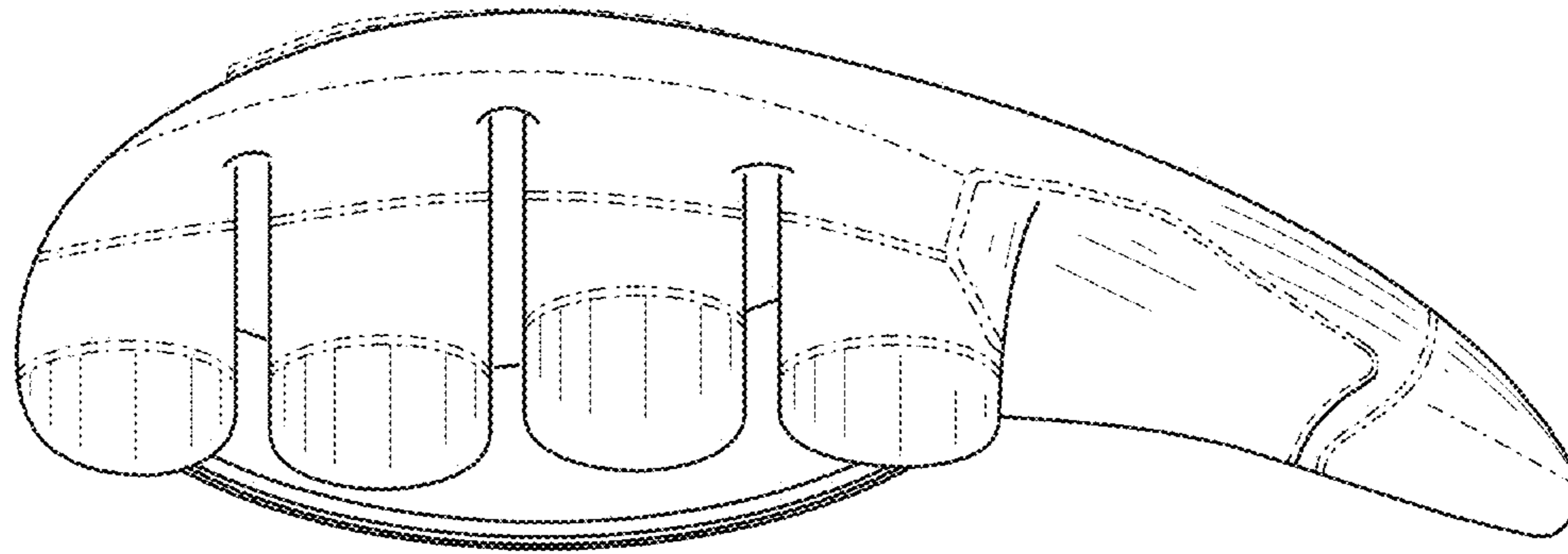

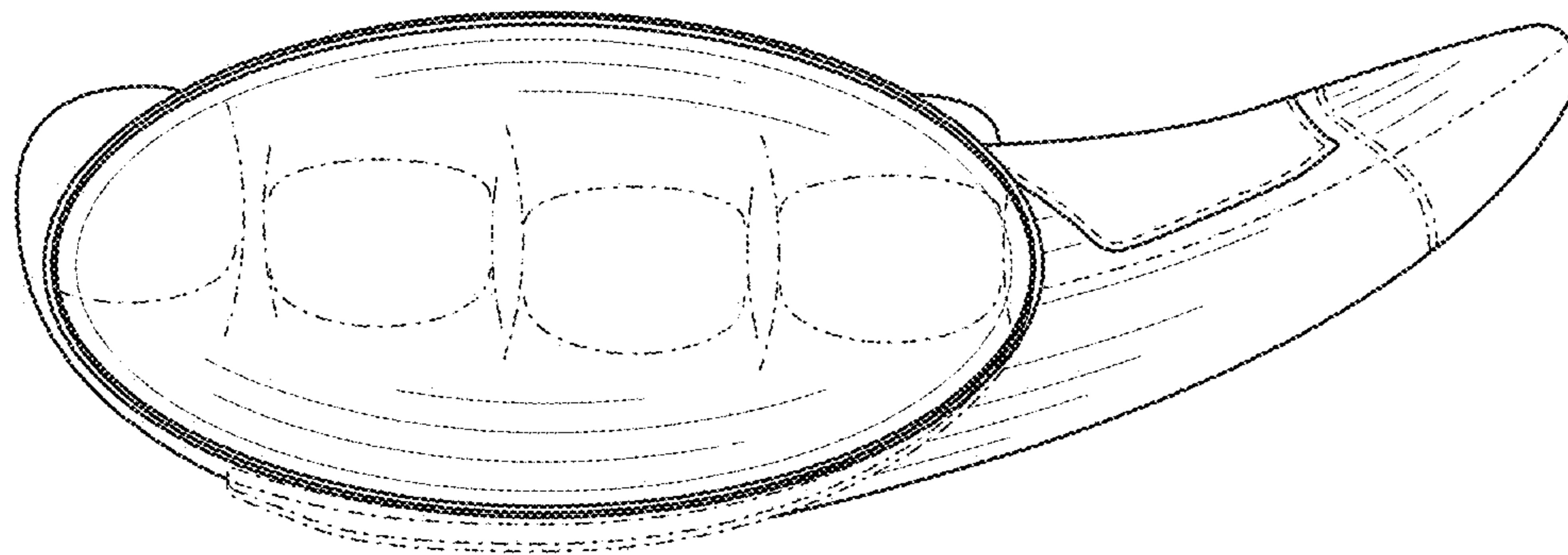
