(57) **CLAIM**

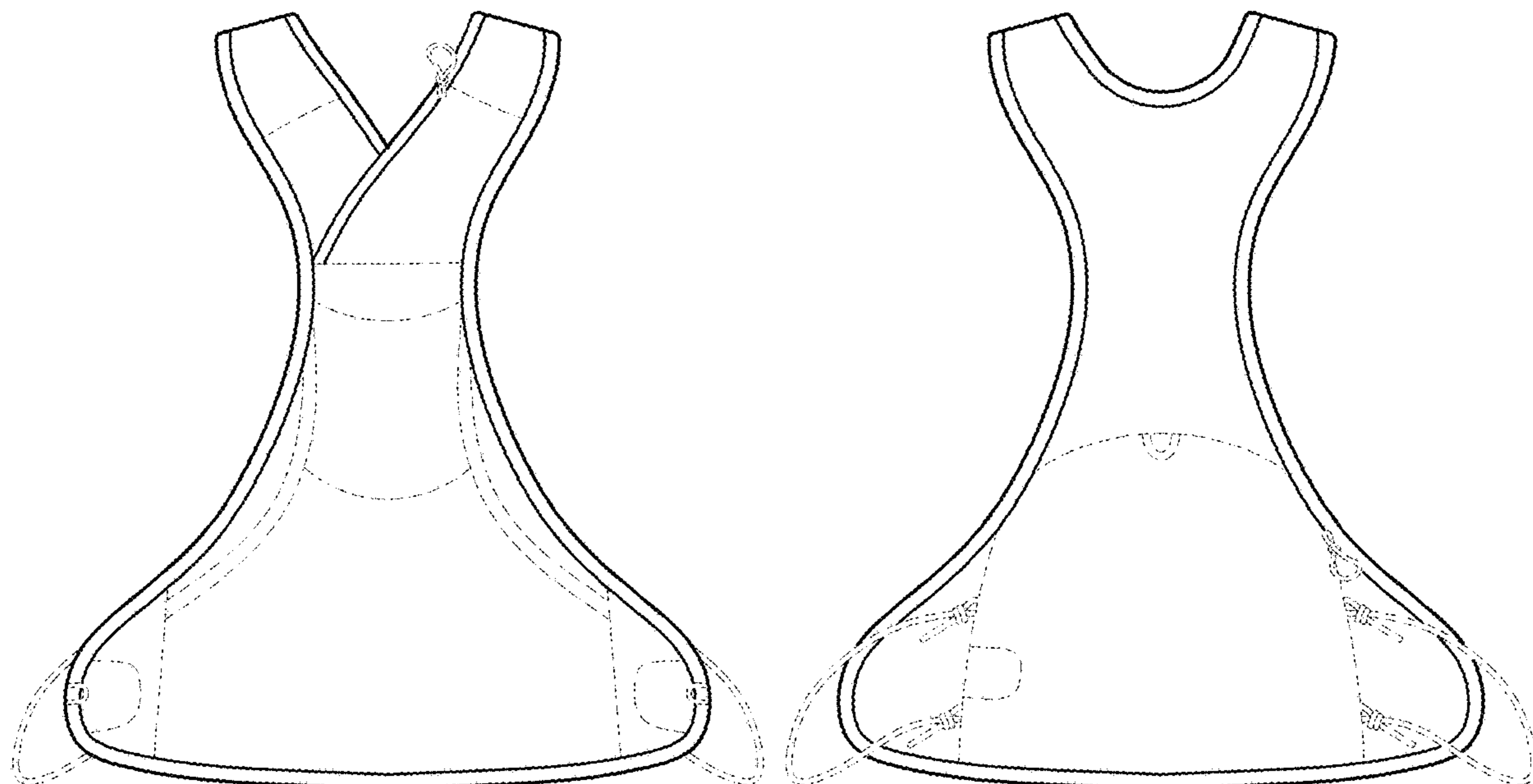
The ornamental design for a race vest, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the race vest;
FIG. 2 is a back elevation view of the race vest;
FIG. 3 is a left side elevation view of the race vest, with the right side being a mirror image;
FIG. 4 is a front perspective view of the race vest shown in use; and,
FIG. 5 is a back perspective view of the race vest shown in use.

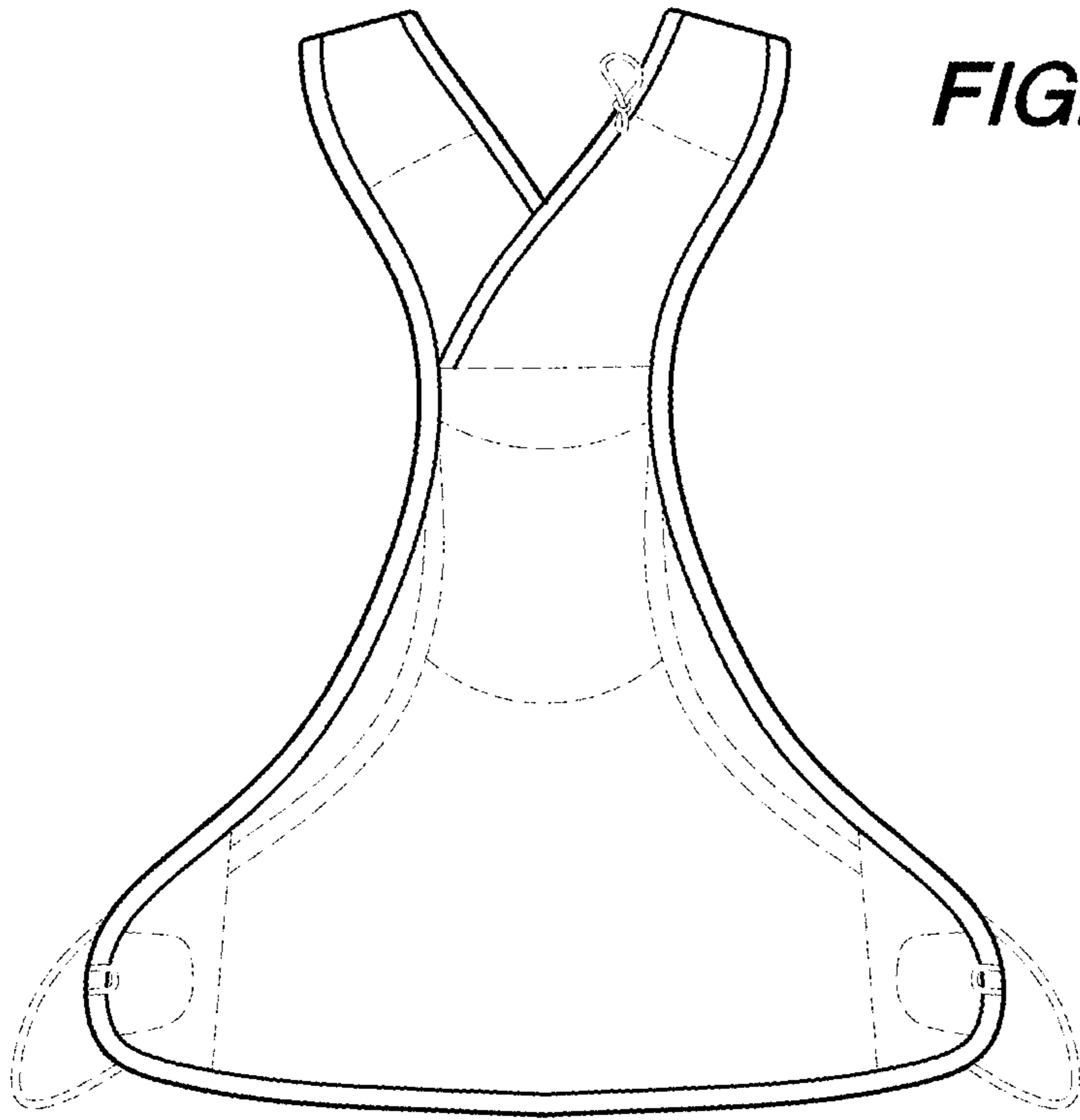

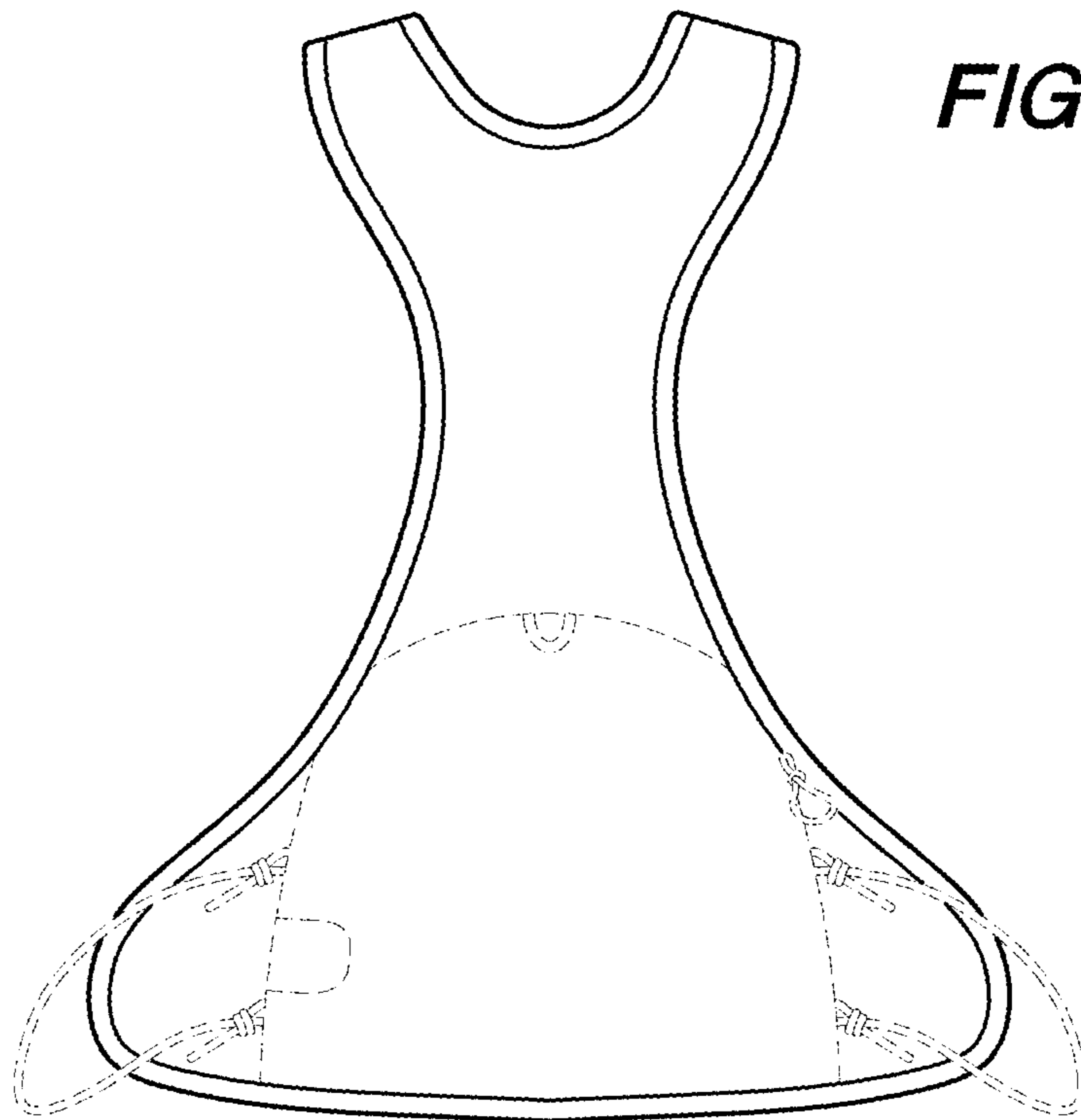

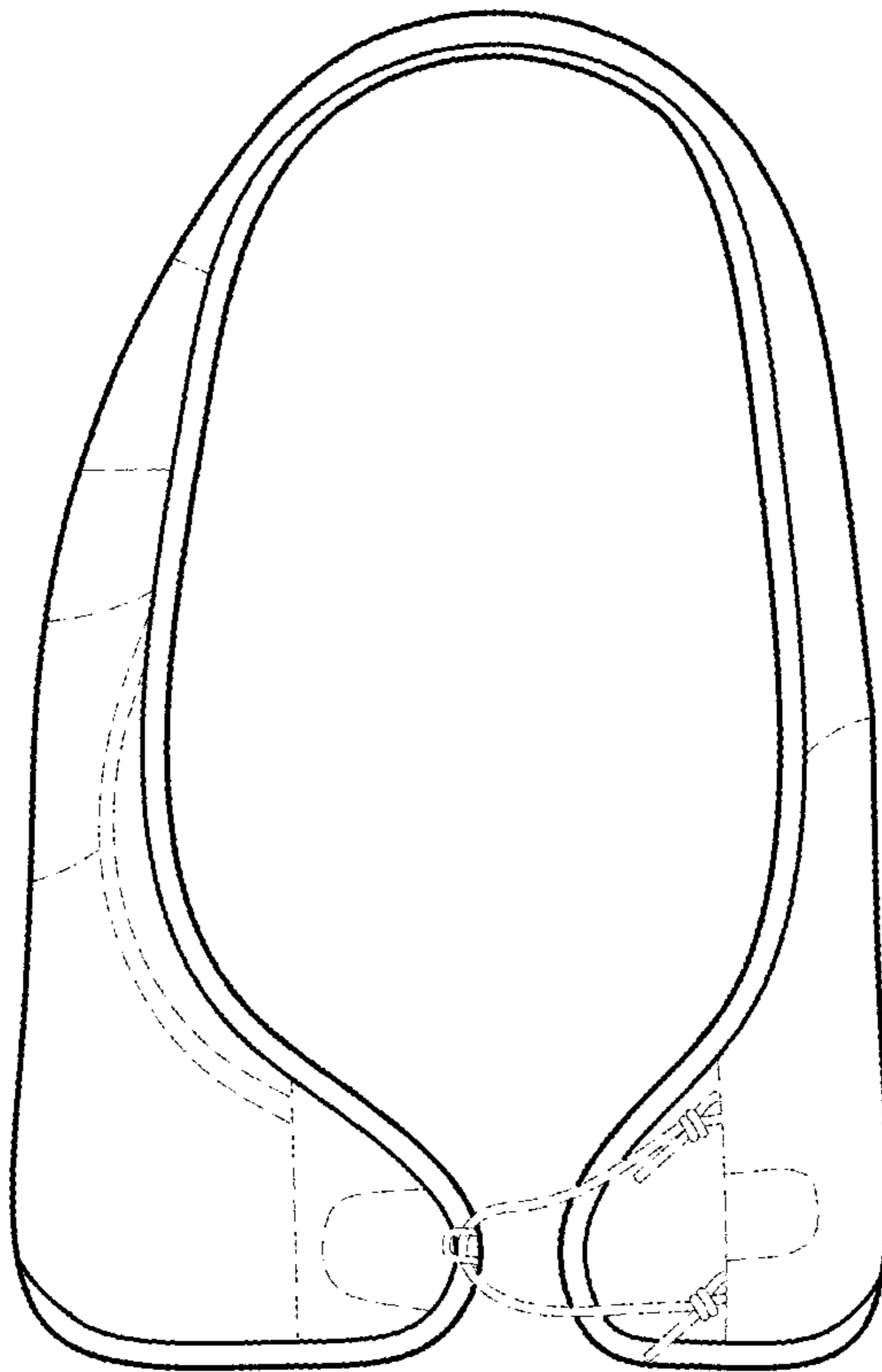

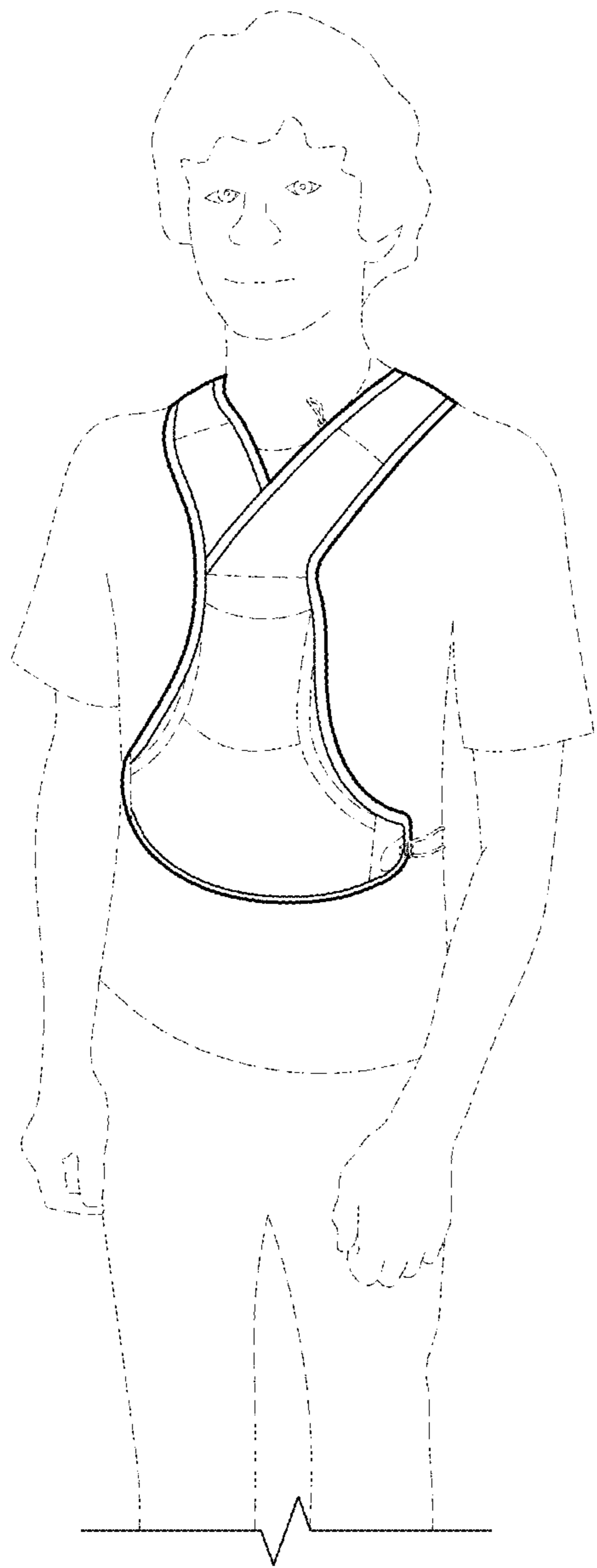
