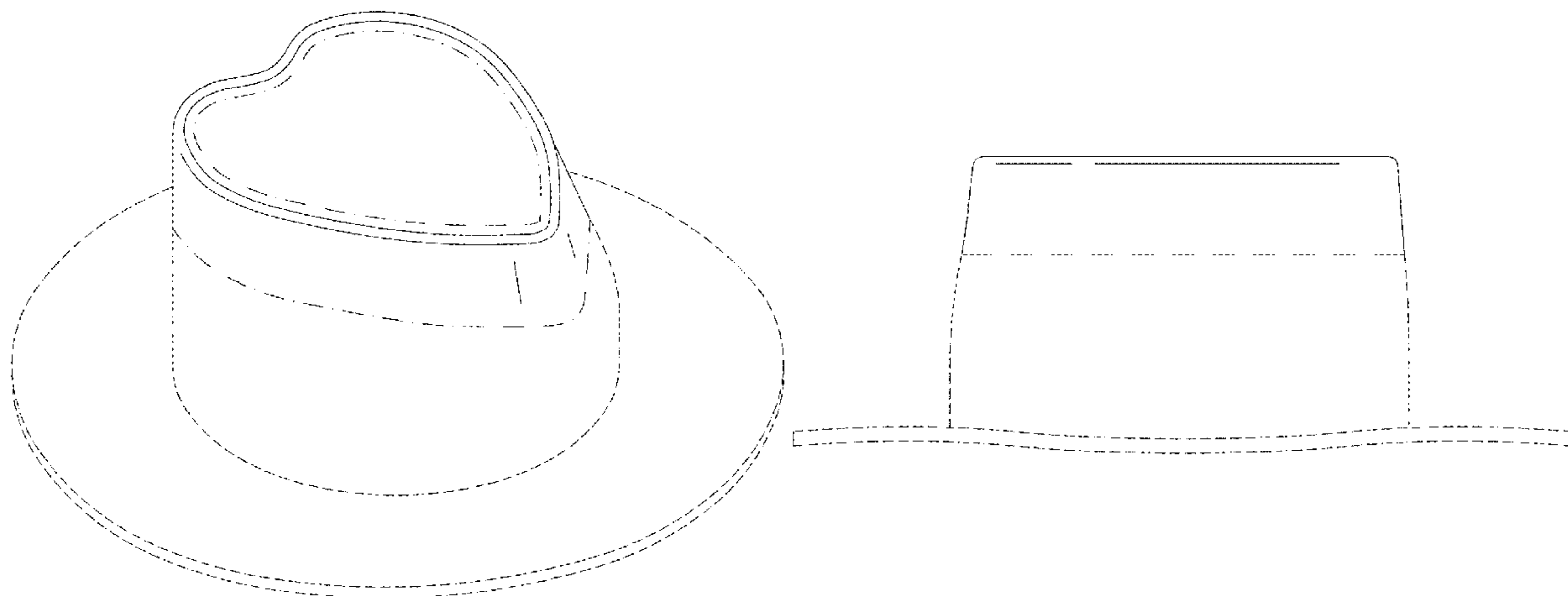
(57) **CLAIM**

The ornamental design for a hat, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hat, showing my new design;  
 FIG. 2 is a right view of FIG. 1, the left view being a mirror image thereof;  
 FIG. 3 is a top plan view of FIG. 1;  
 FIG. 4 is a bottom plan view of FIG. 1;  
 FIG. 5 is a front elevation view of FIG. 1; and,  
 FIG. 6 is a rear elevation view of FIG. 1.  
 The evenly spaced broken lines depict portions of the hat that form no part of the claimed design. The dot-dash-dot broken lines define the bounds of the claim and form no part of the claimed design.

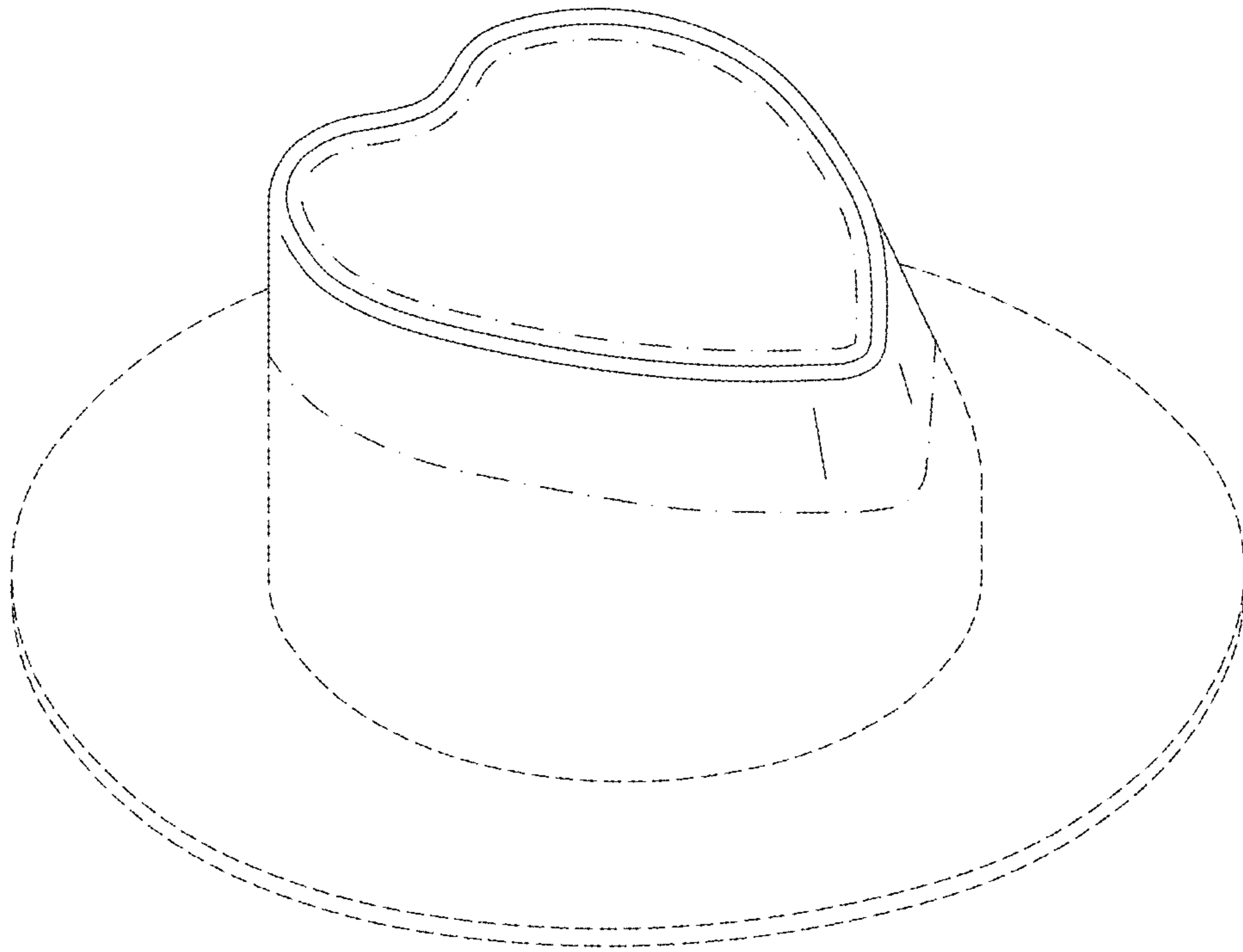

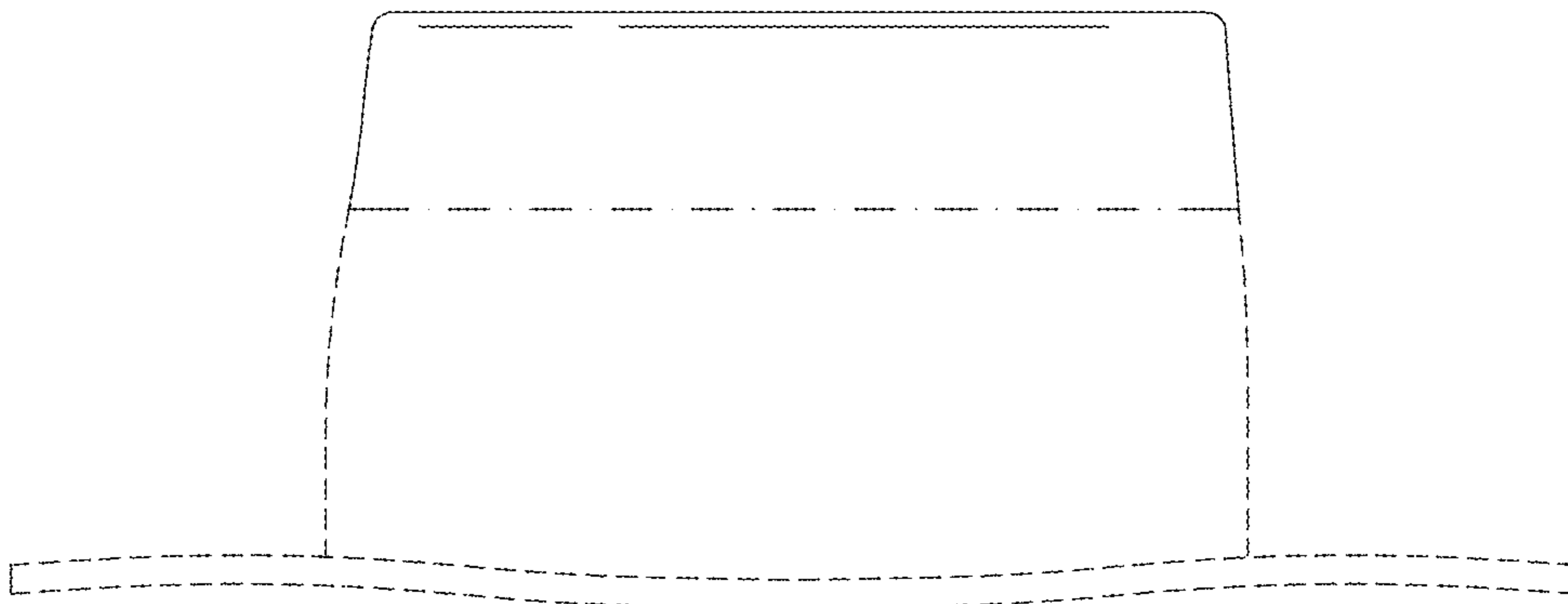

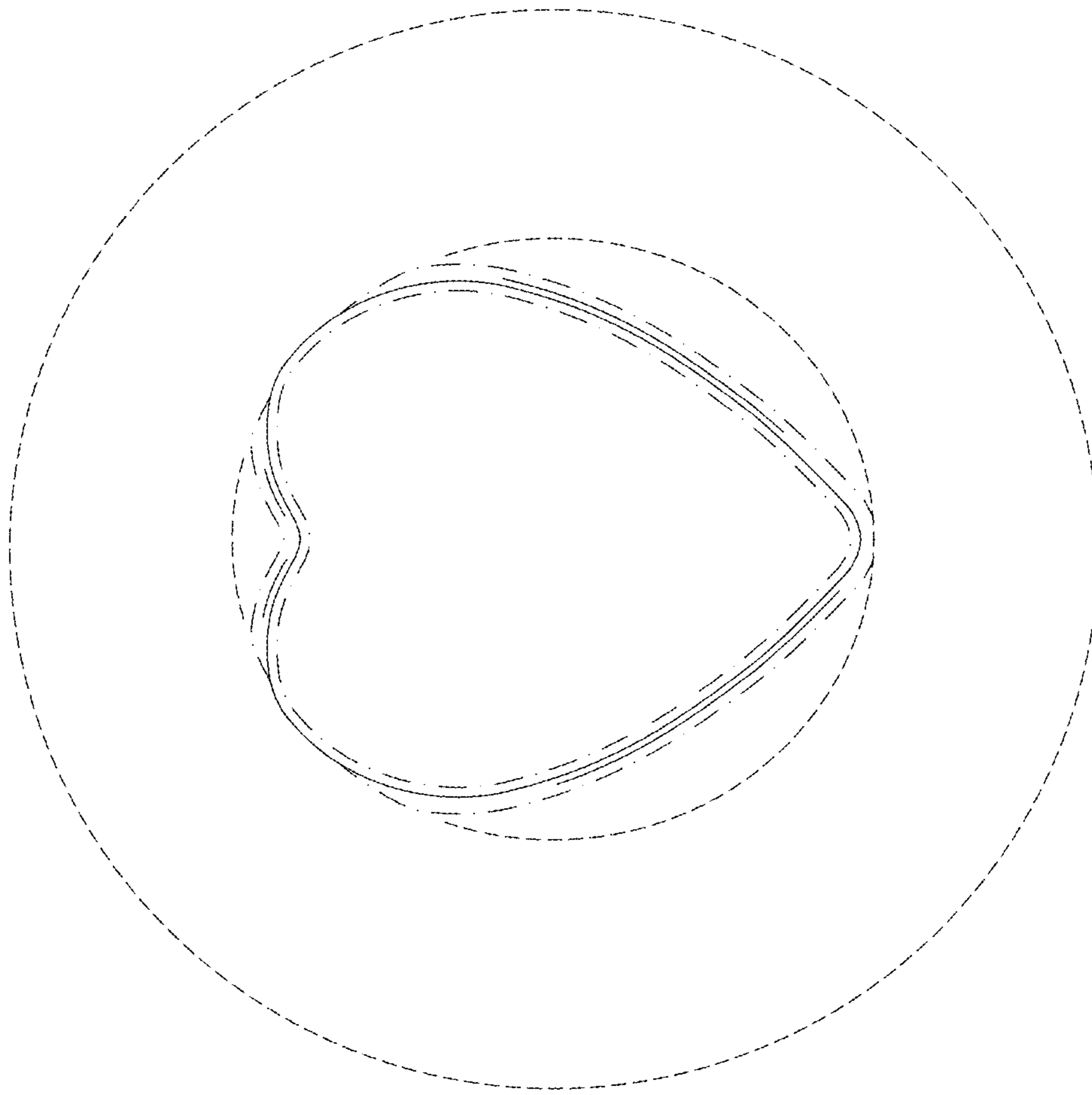

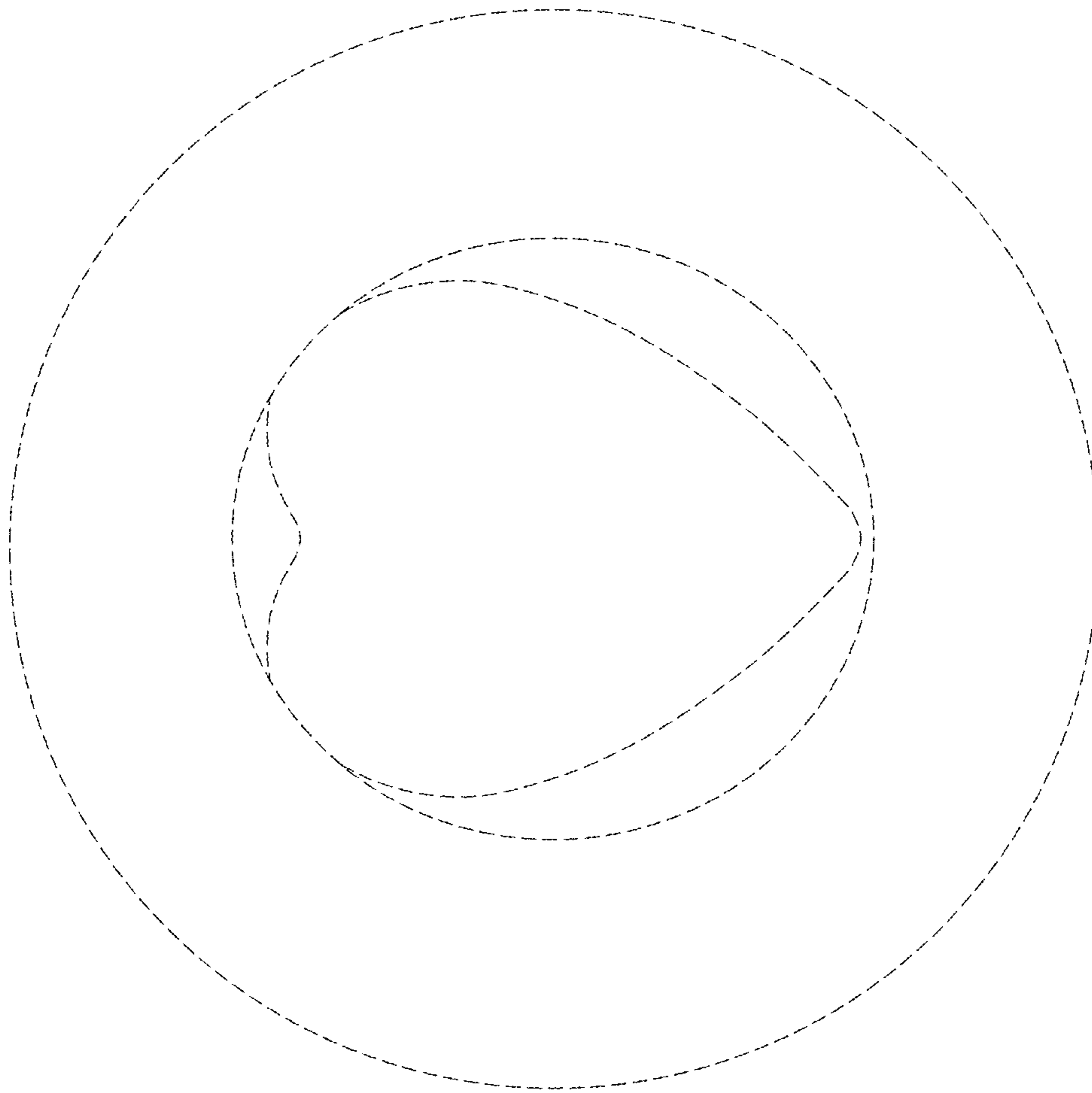

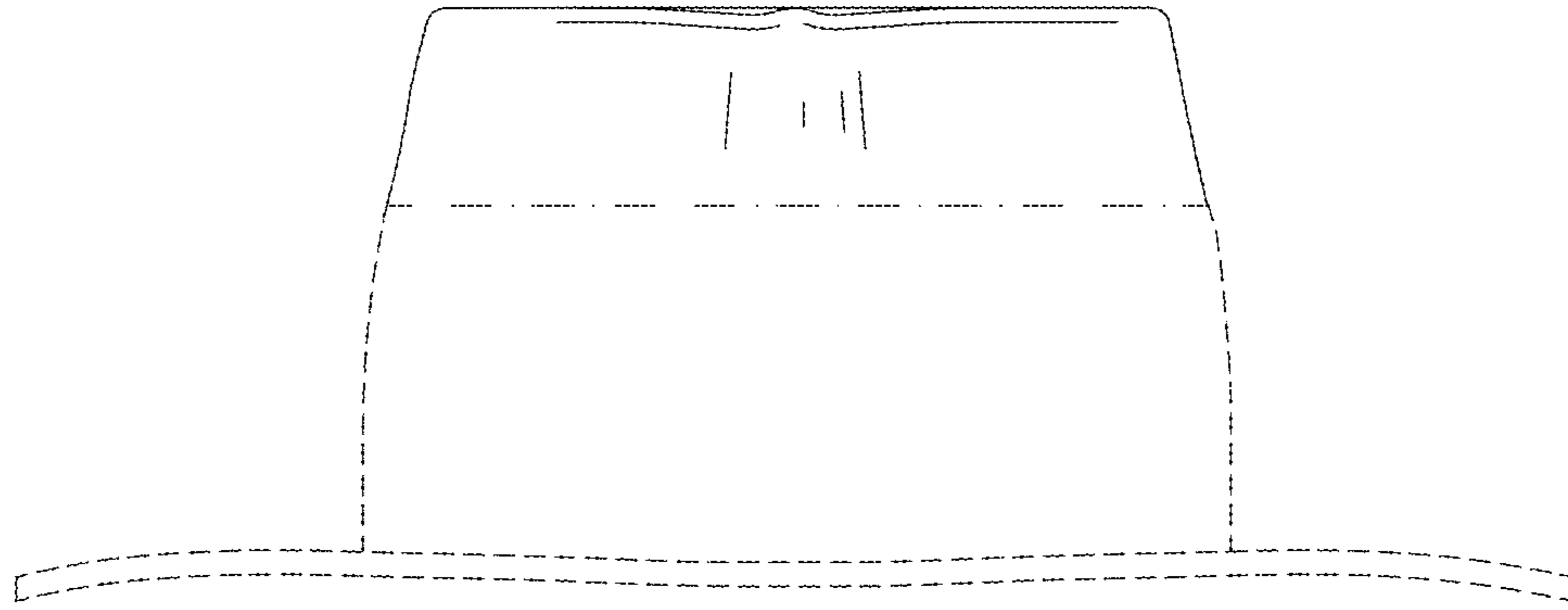

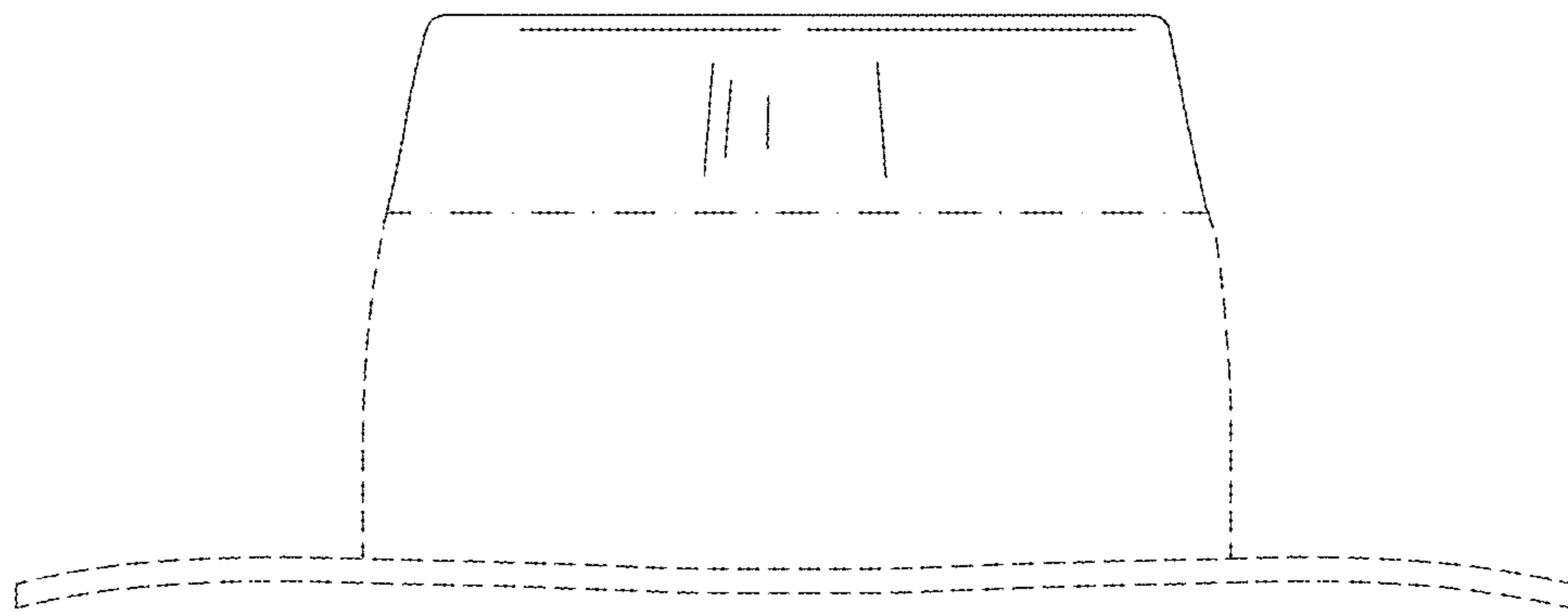
