The ornamental design for a shoe, as shown and described.

DESCRIPTION

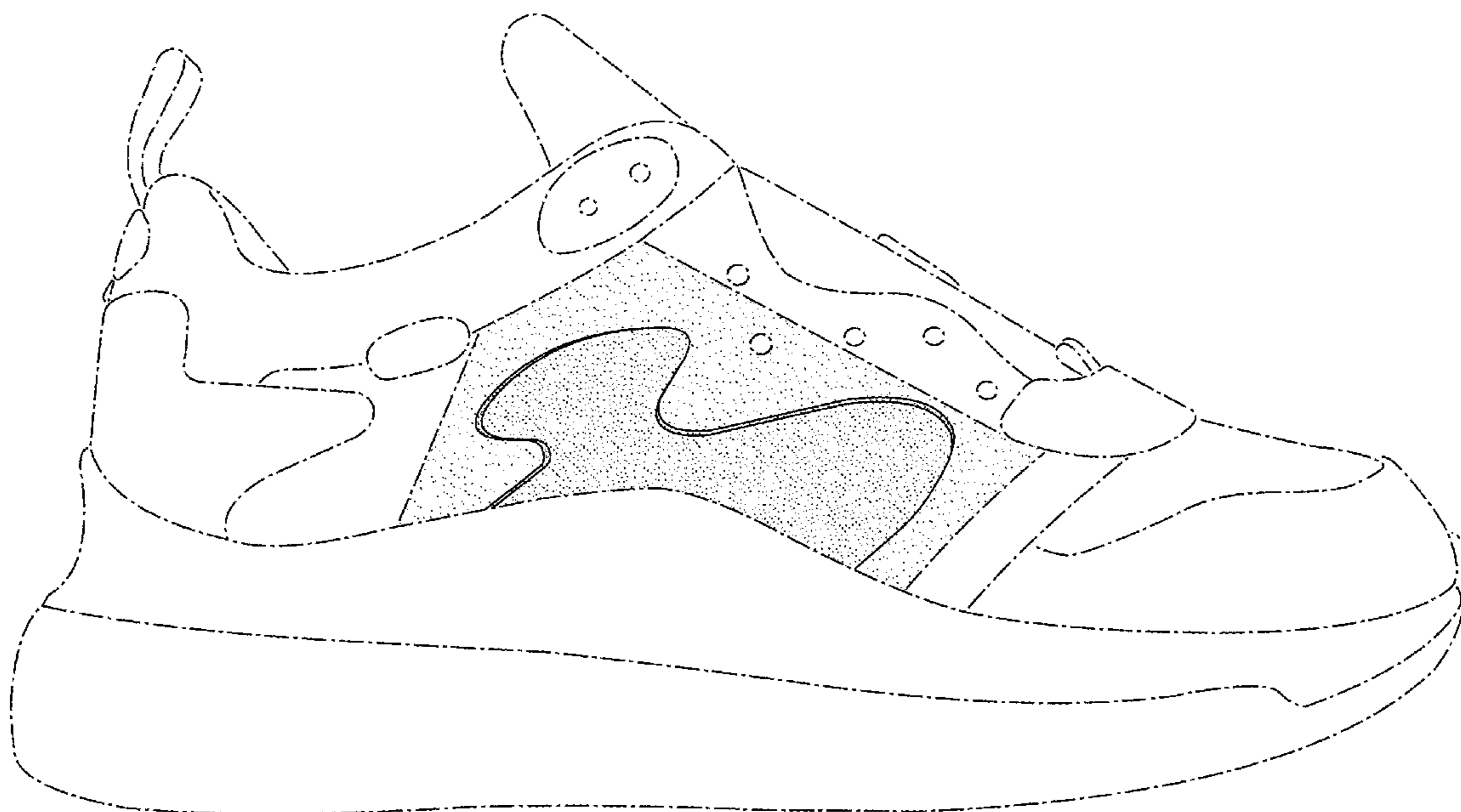
FIG. 1 is a front perspective view of a shoe showing my new design;

FIG. 2 is a side view thereof; and,

FIG. 3 is a rear perspective view thereof.

The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The circular broken line region within the claimed area represents an eyelet hole which forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

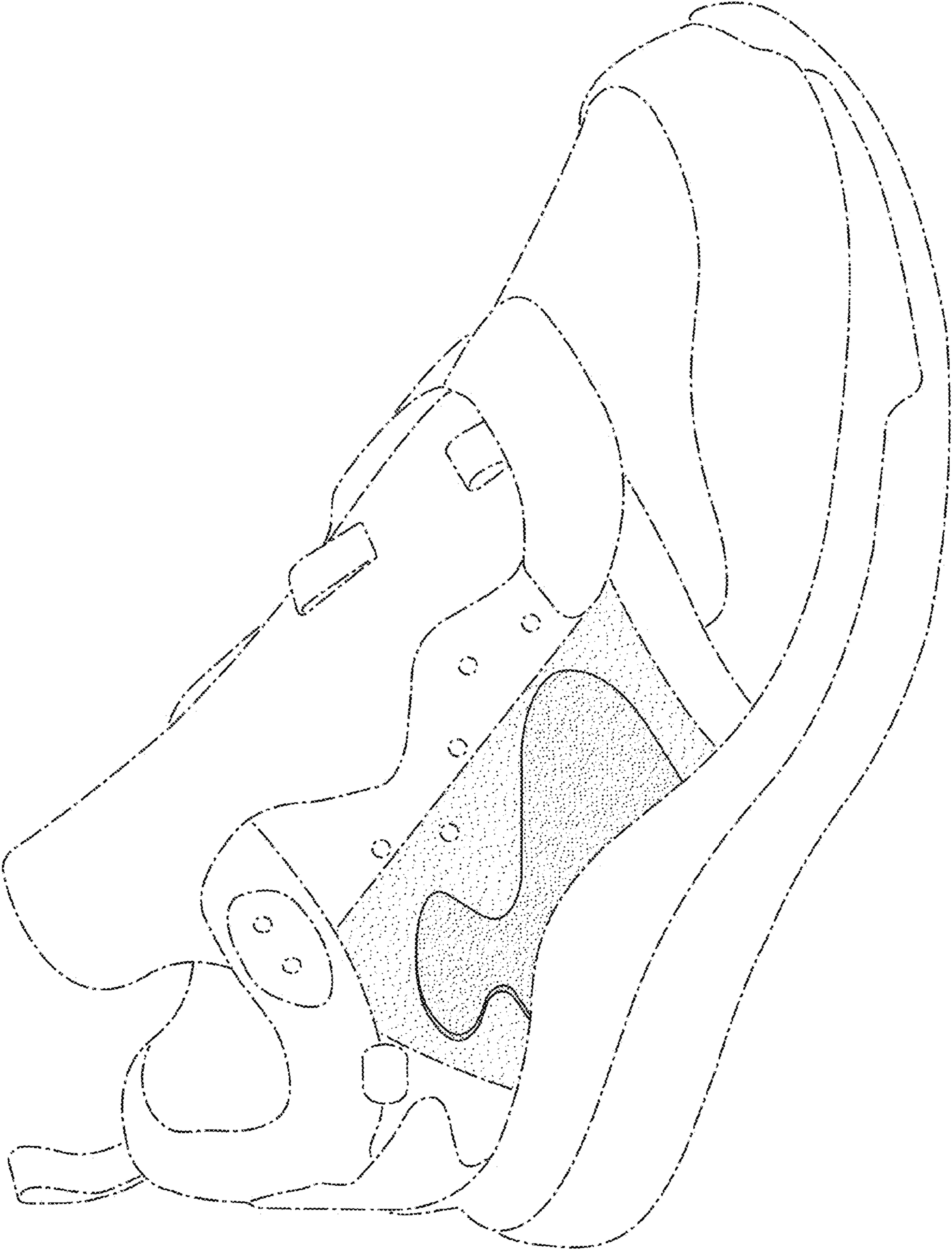

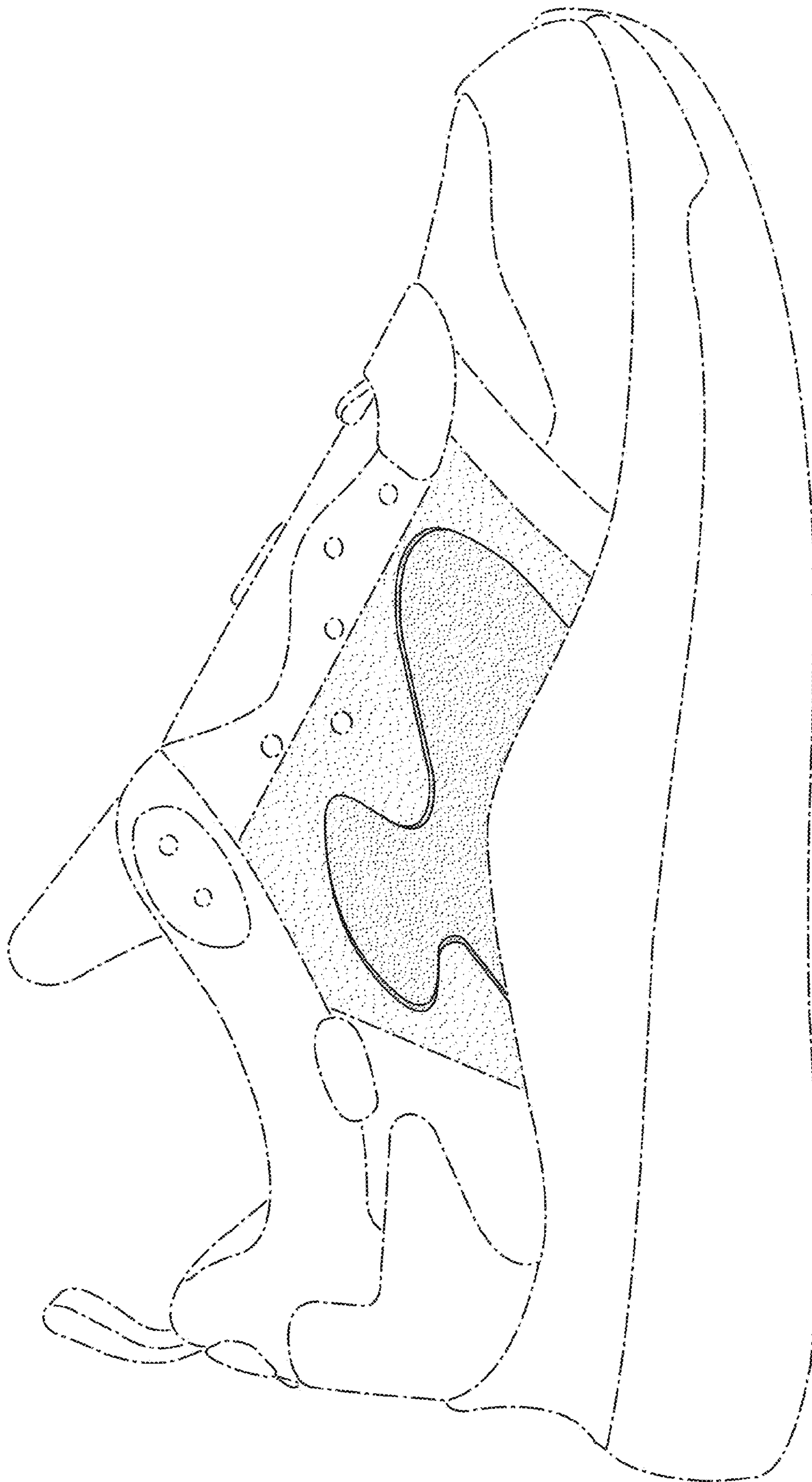

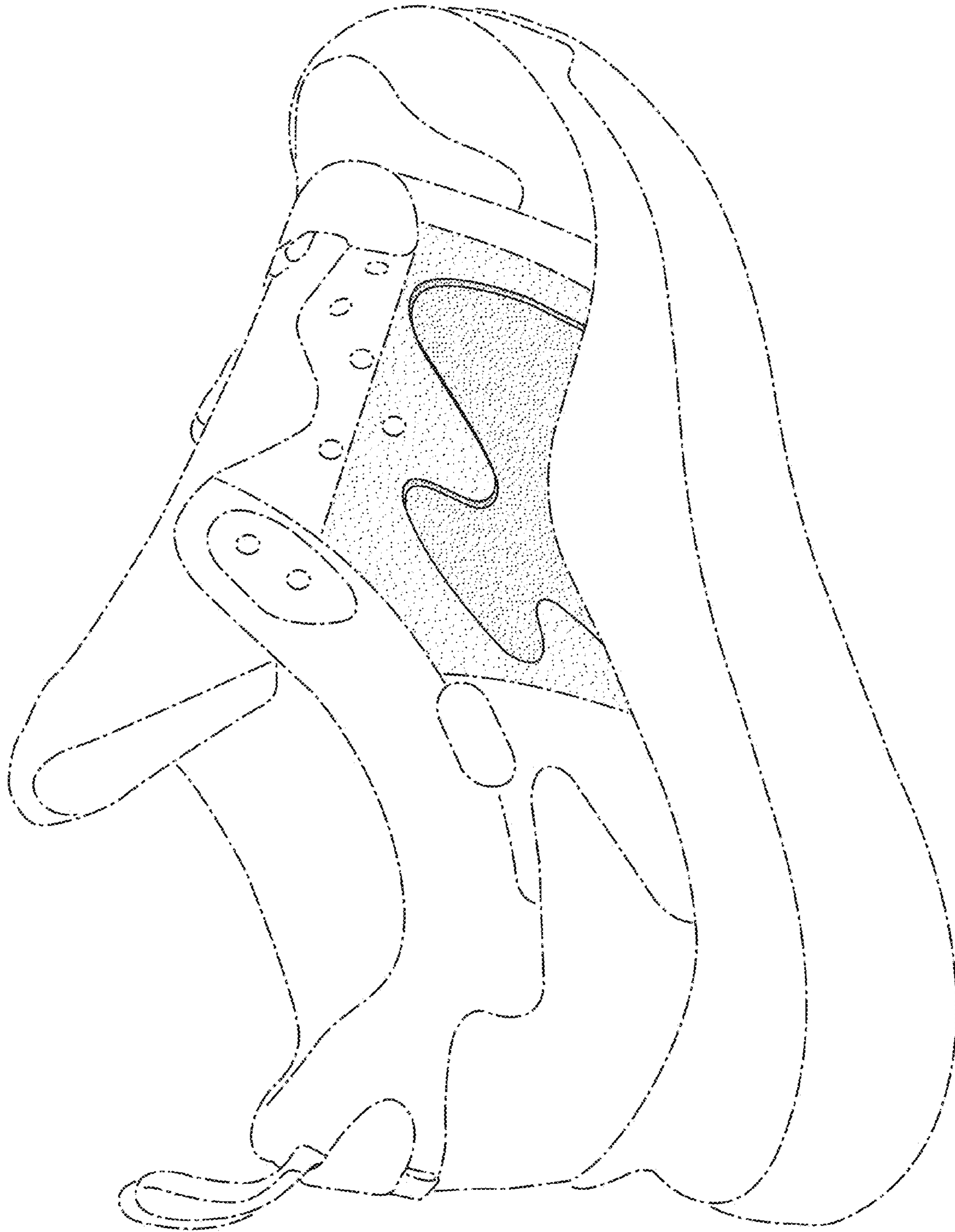
