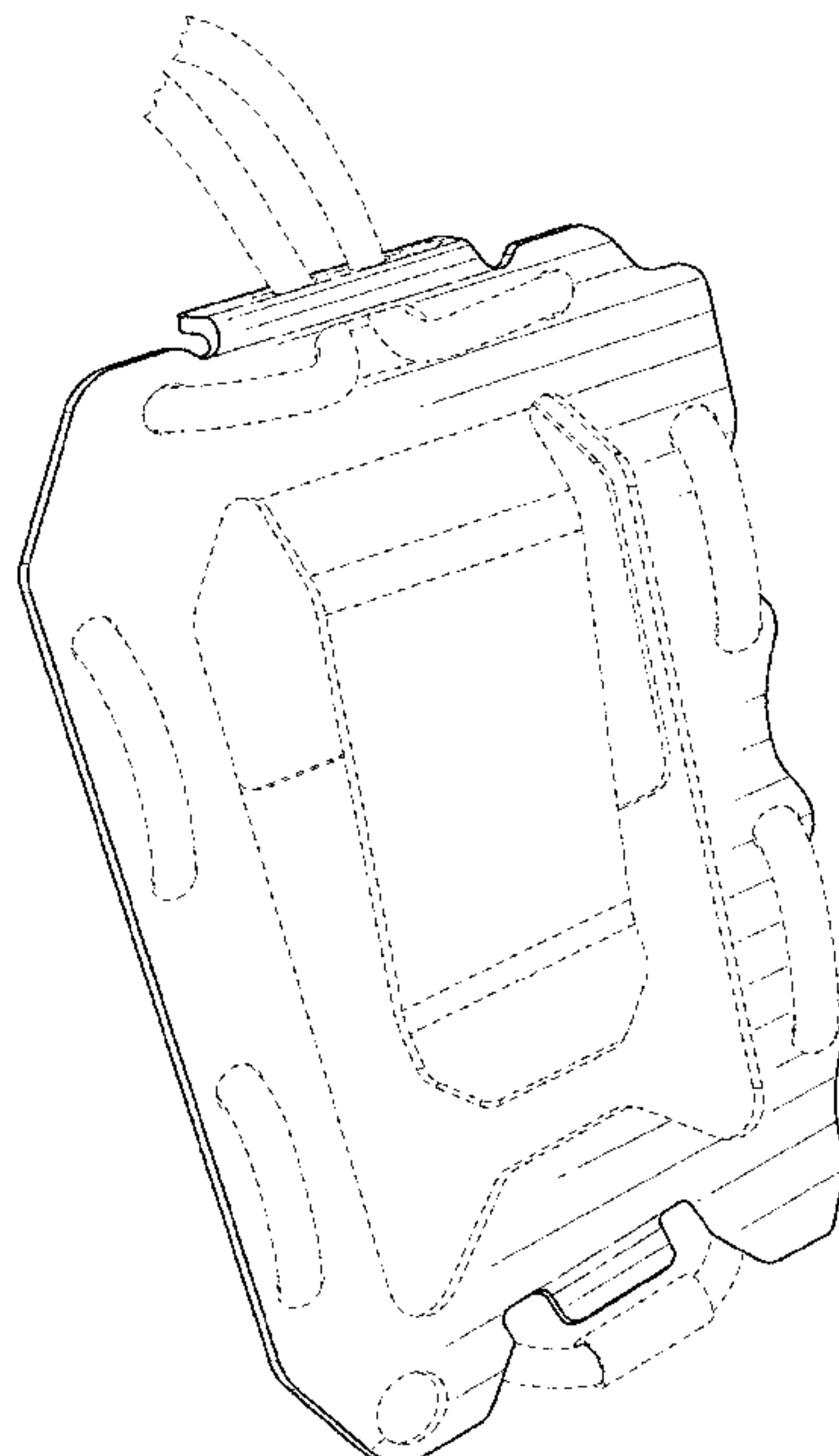
(57) **CLAIM**

I claim the ornamental design for a wallet, as shown and described.

DESCRIPTION

FIG. 1 is a front, perspective view of a wallet;
 FIG. 2 is a front view of the wallet;
 FIG. 3 is a rear view of the wallet;
 FIG. 4 is a rear perspective view of the wallet;
 FIG. 5 is a left side view of the wallet;
 FIG. 6 is a right side view of the wallet;
 FIG. 7 is a top view of the wallet; and,
 FIG. 8 is a bottom view of the wallet.
 The broken lines shown in the drawings illustrate portions of the wallet that form no part of the claimed design.

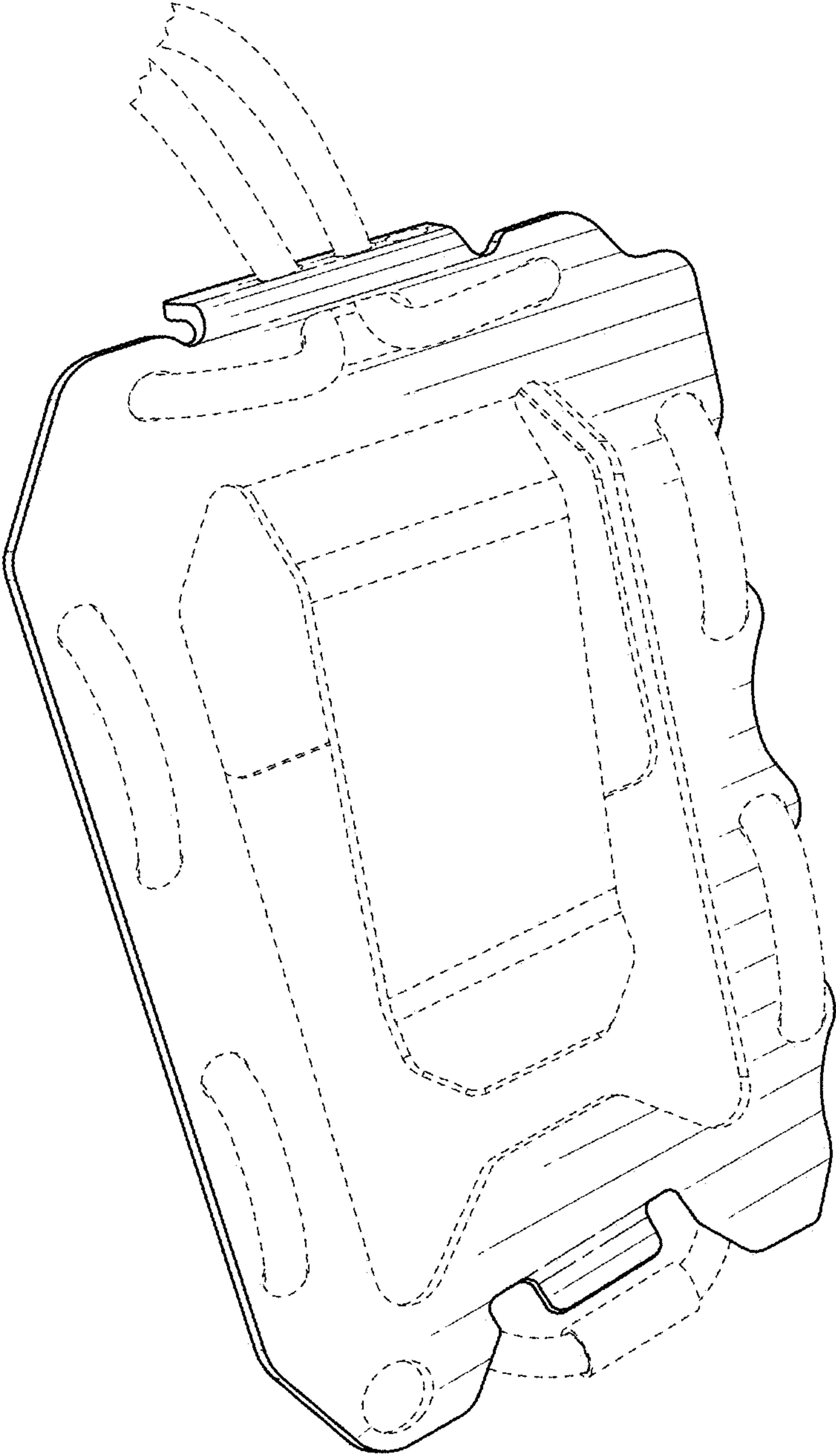

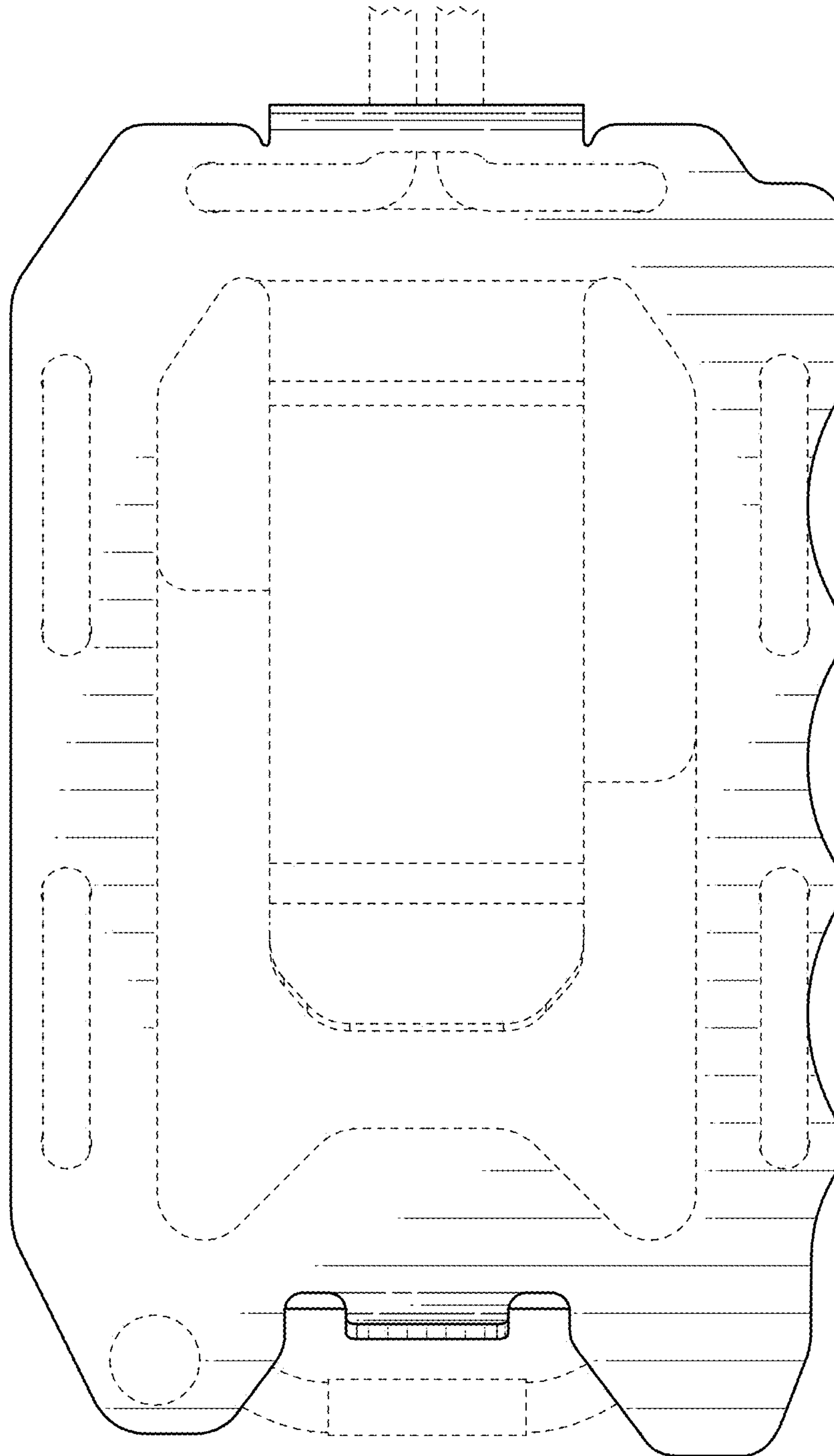

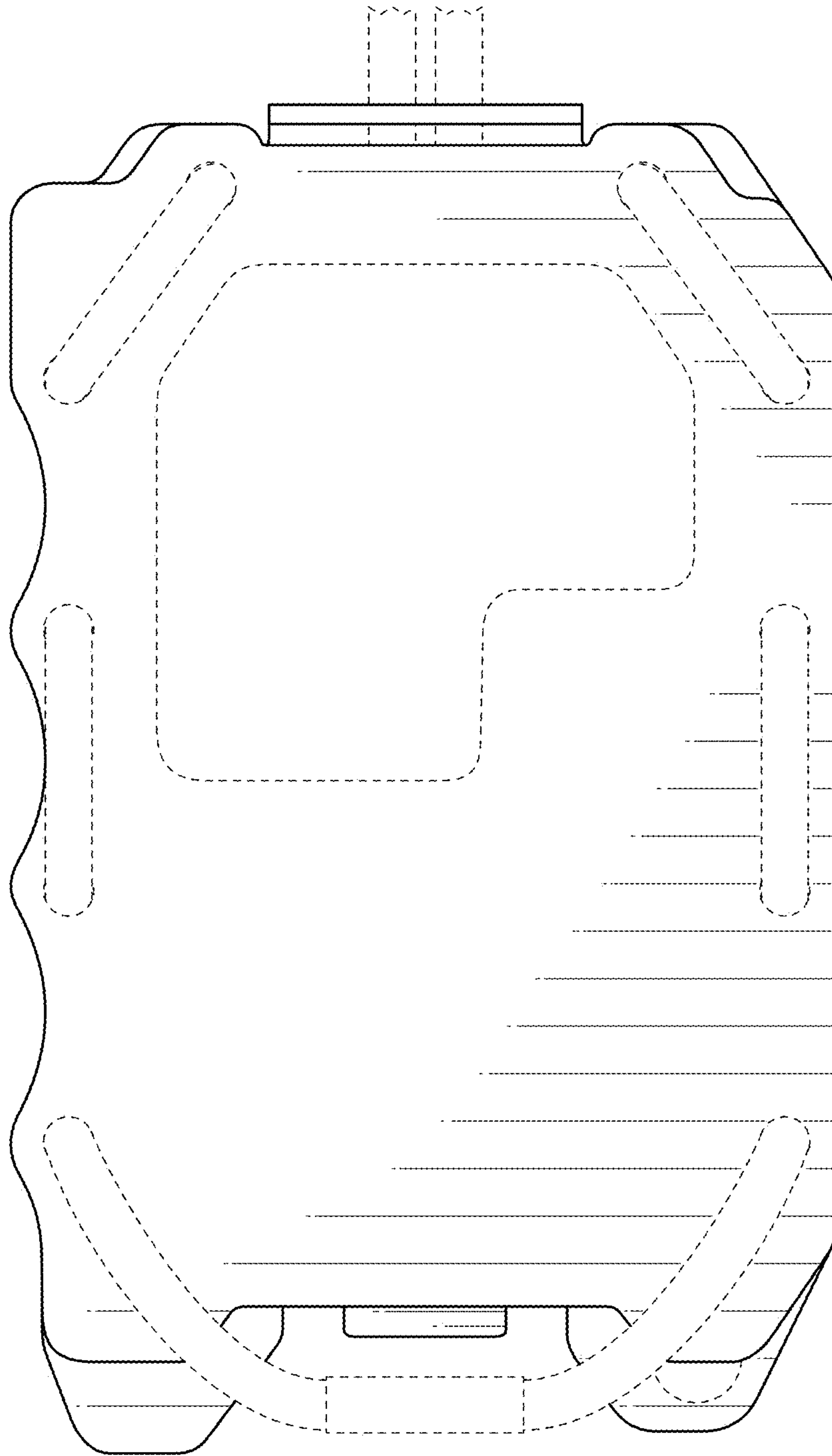

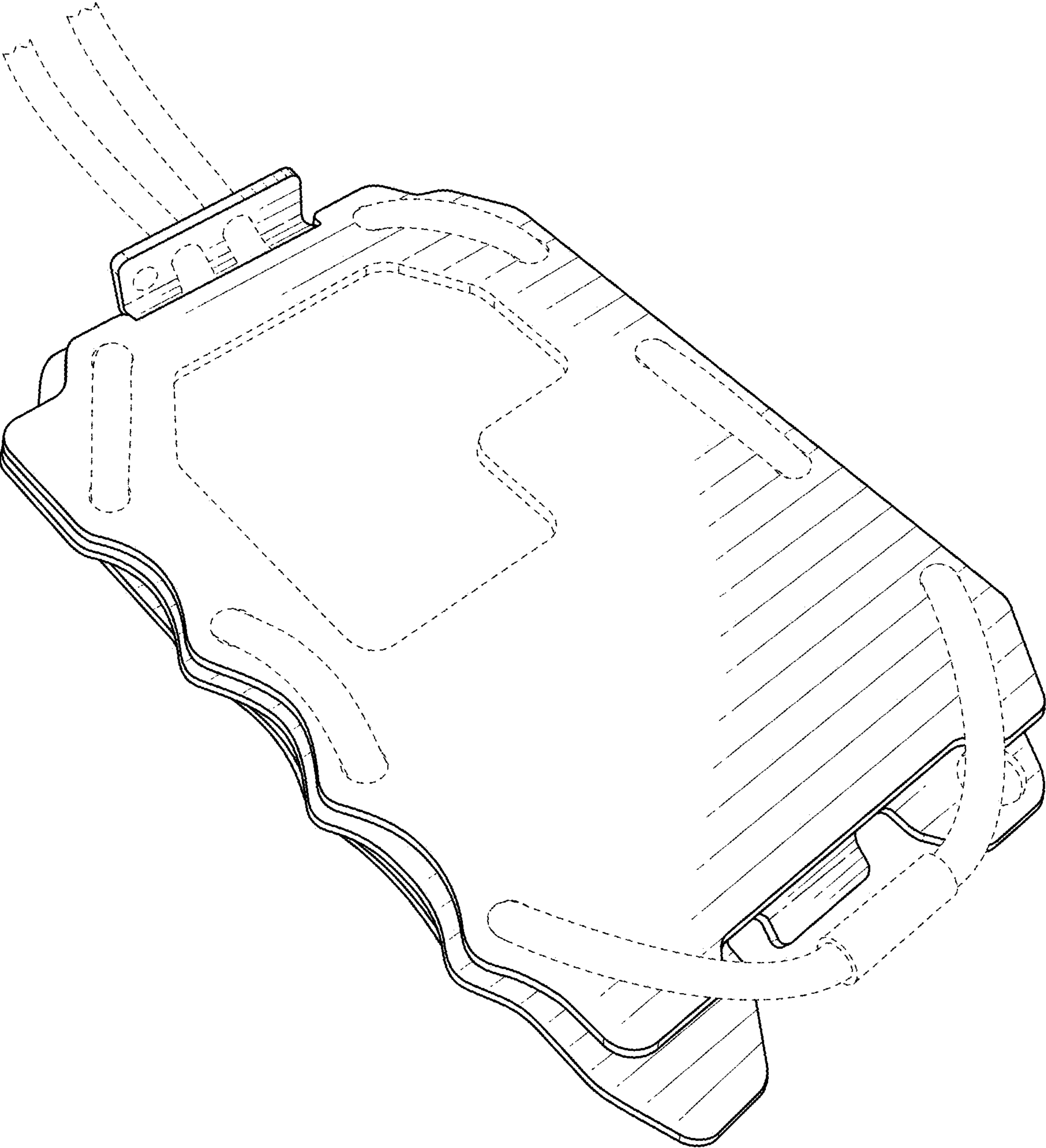

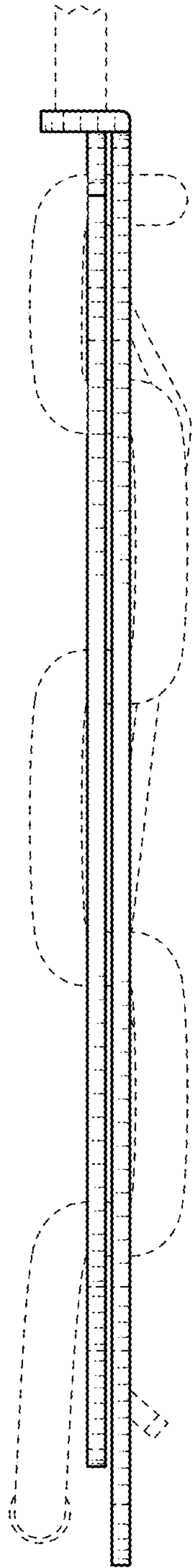

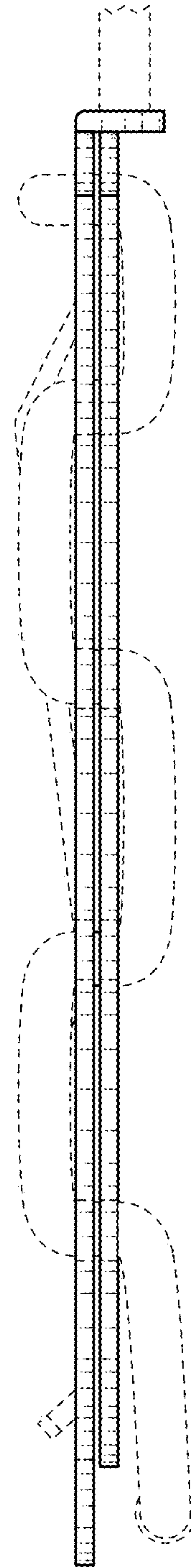

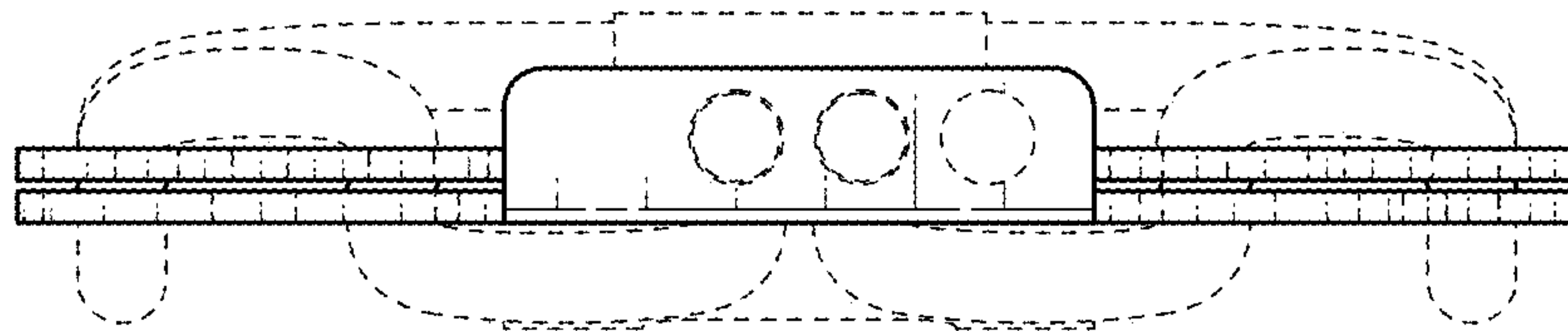

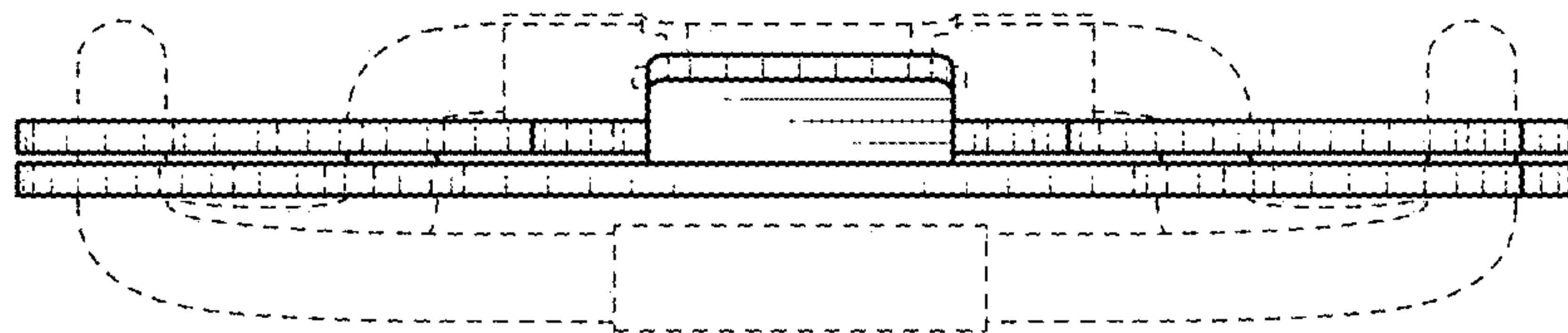
