DESCRIPTION

FIG. 1 is a perspective view of a sofa, showing my new design;
FIG. 2 is a front elevation view thereof;

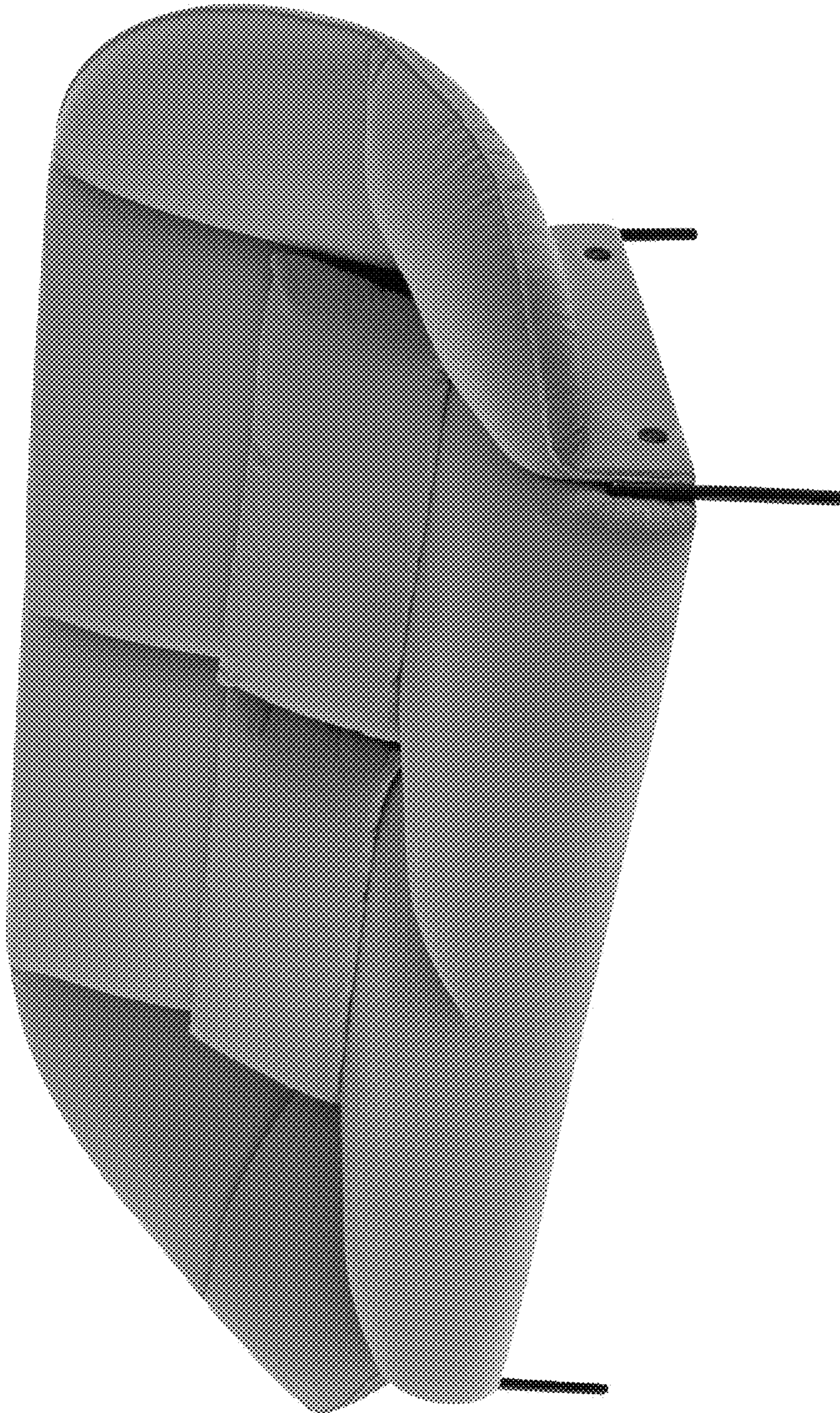

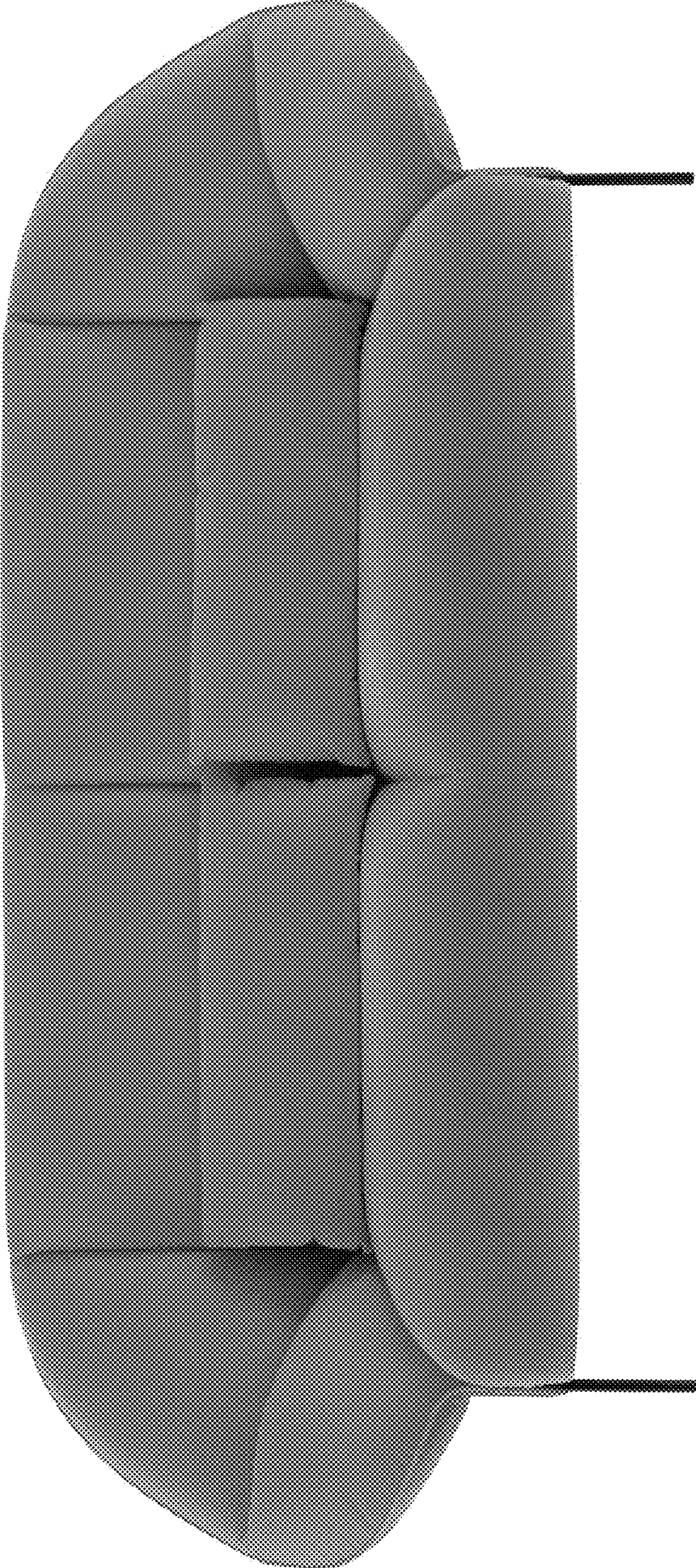

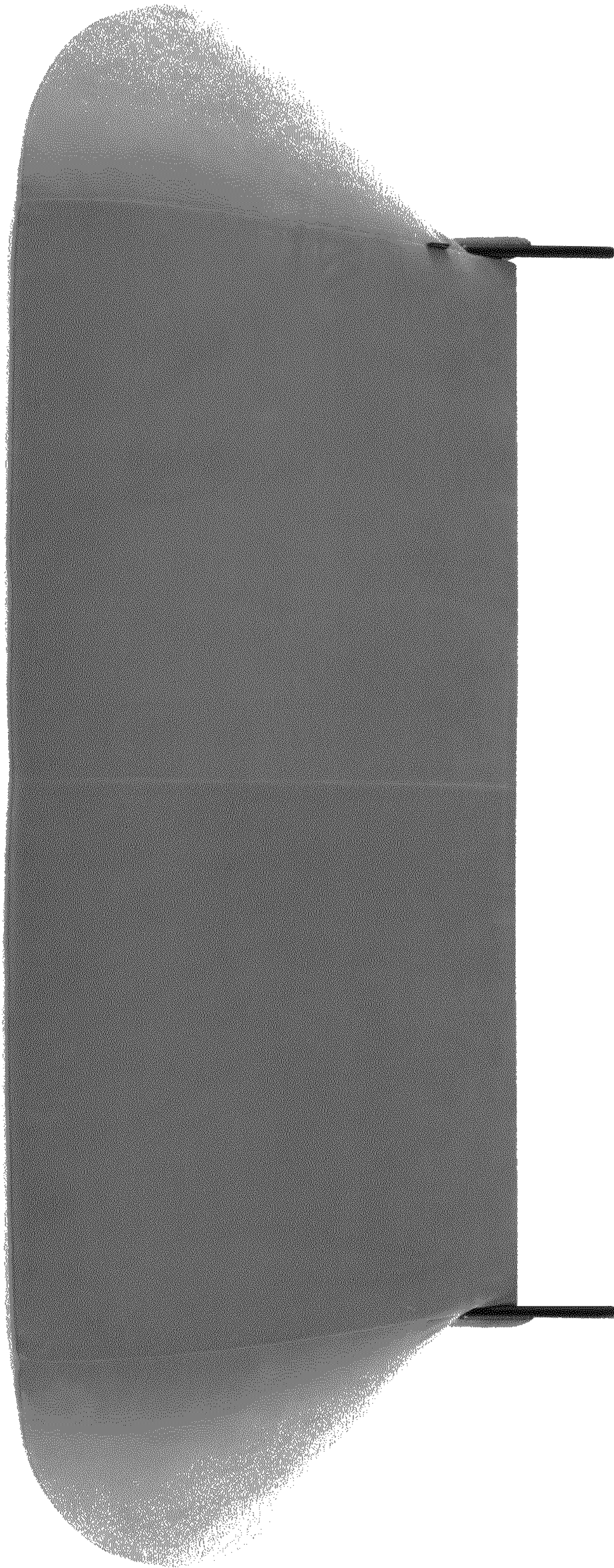

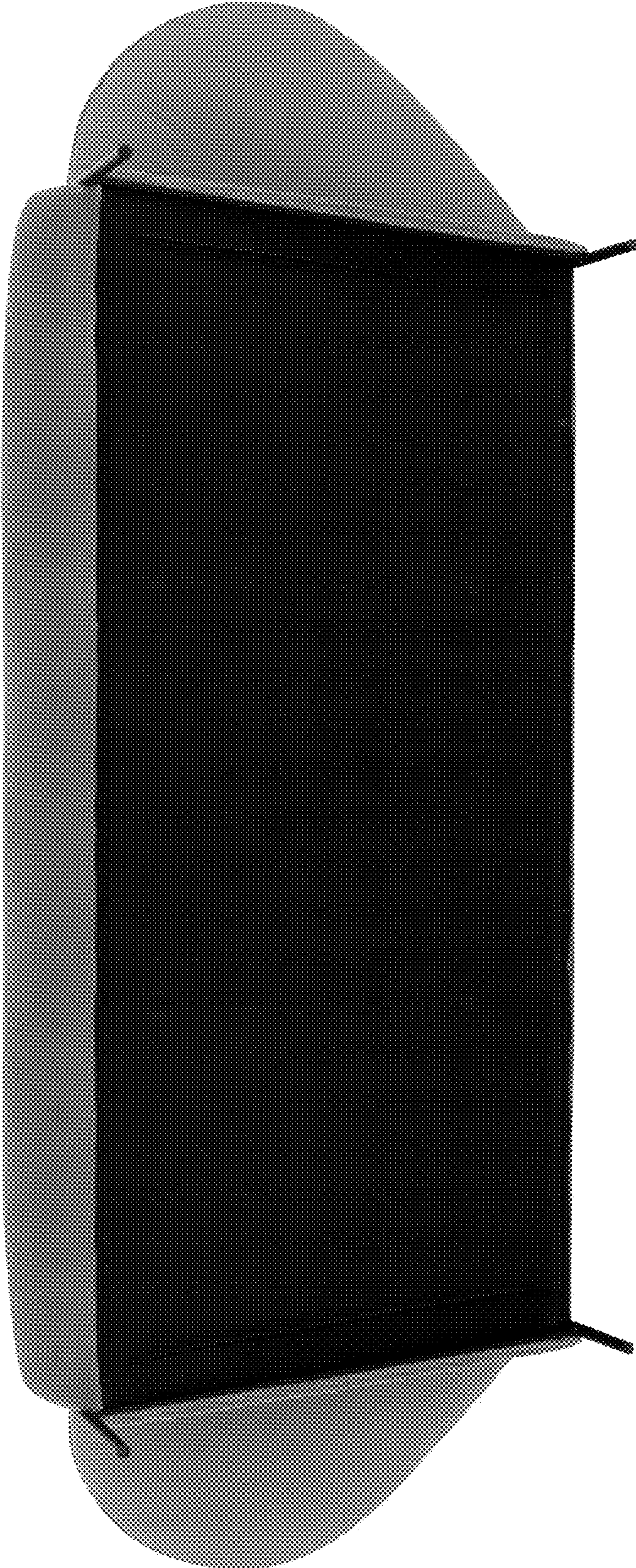

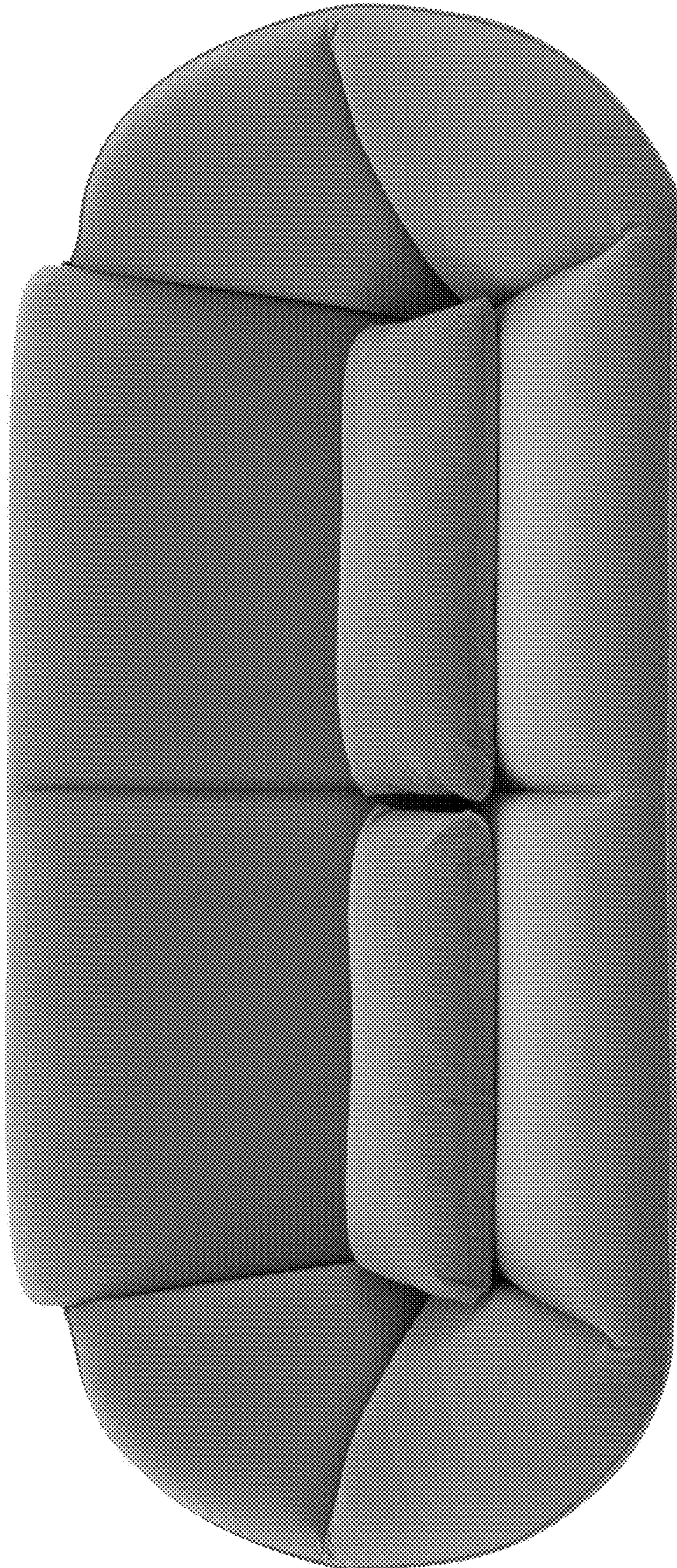
