DESCRIPTION

FIG. 1 is a perspective view of a MIG pliers showing the front, top, and right side of my new design with the jaws opened;

FIG. 2 is a perspective view of a MIG pliers showing the rear, bottom and left side of my new design with the jaws closed;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

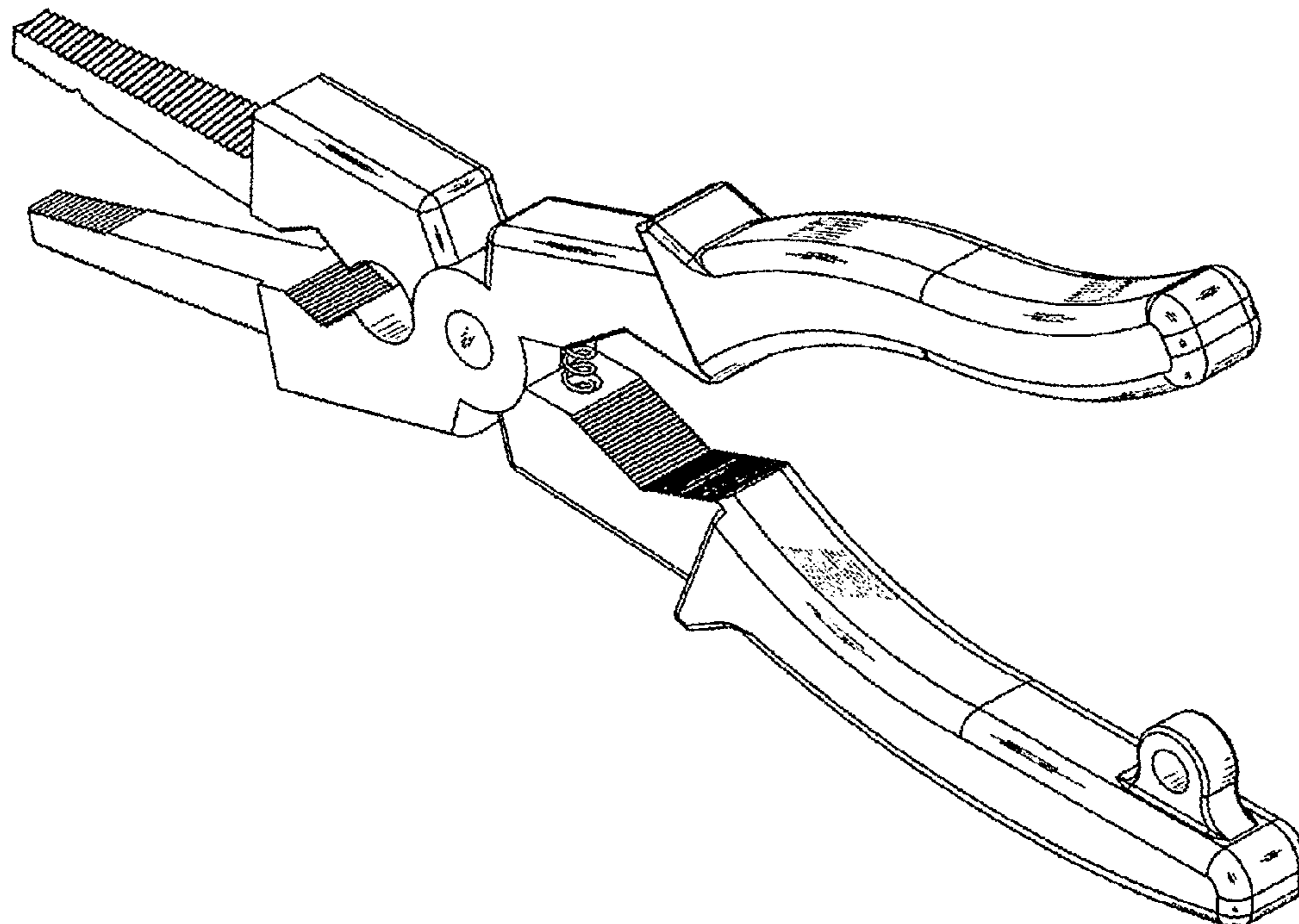
FIG. 5 is an enlarged left side elevation view thereof;

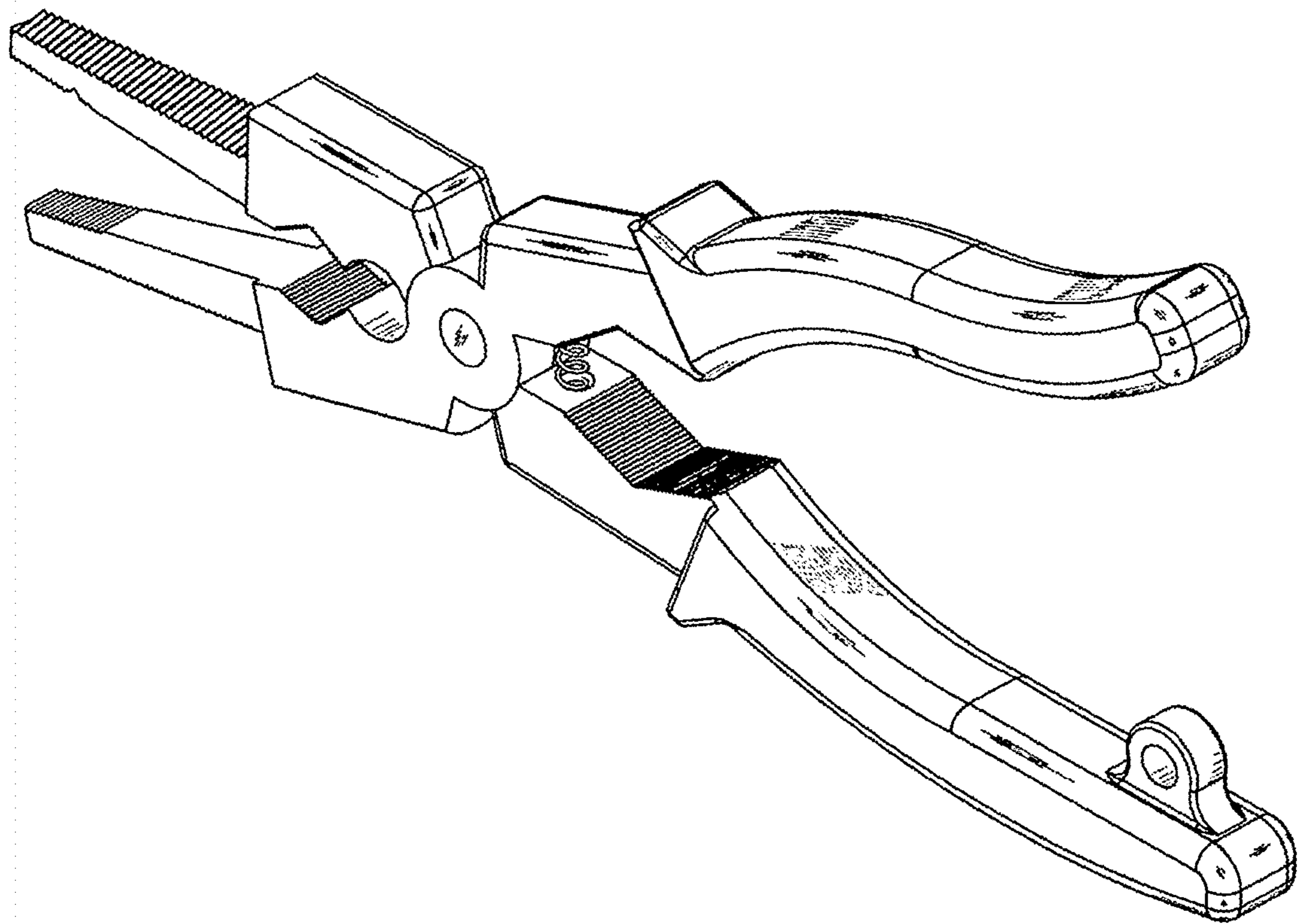

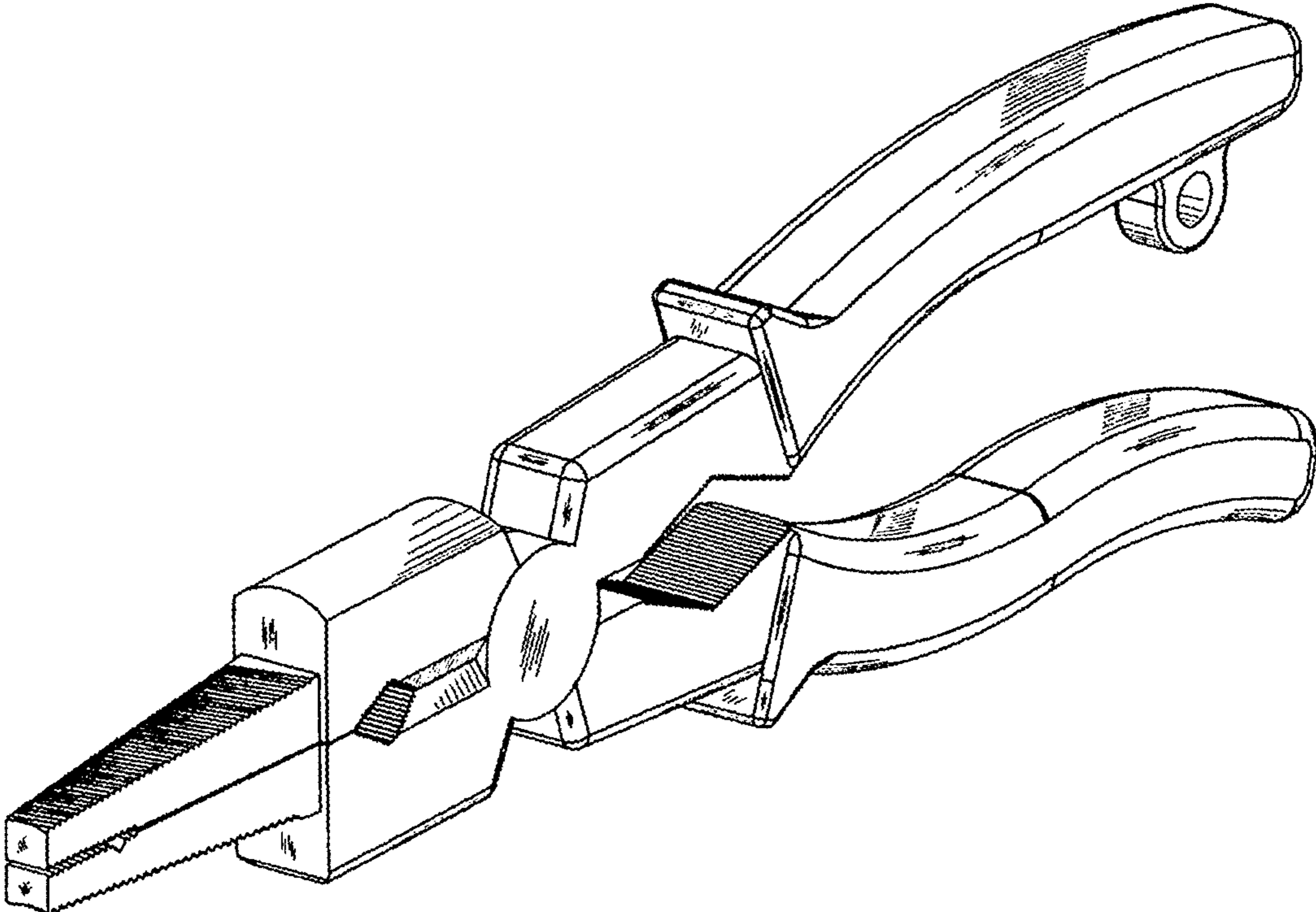

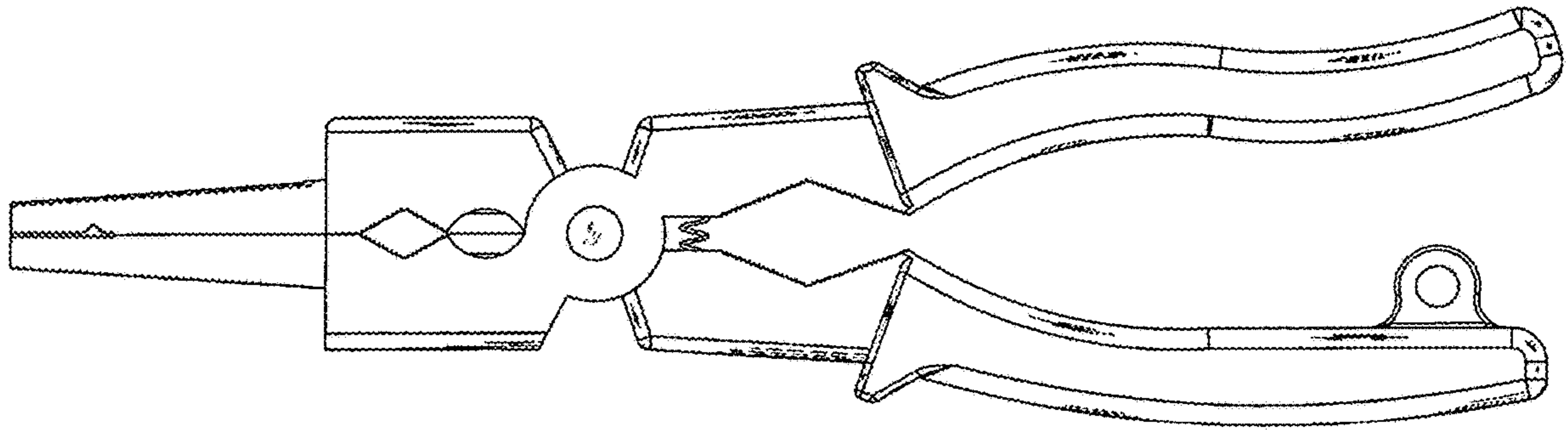

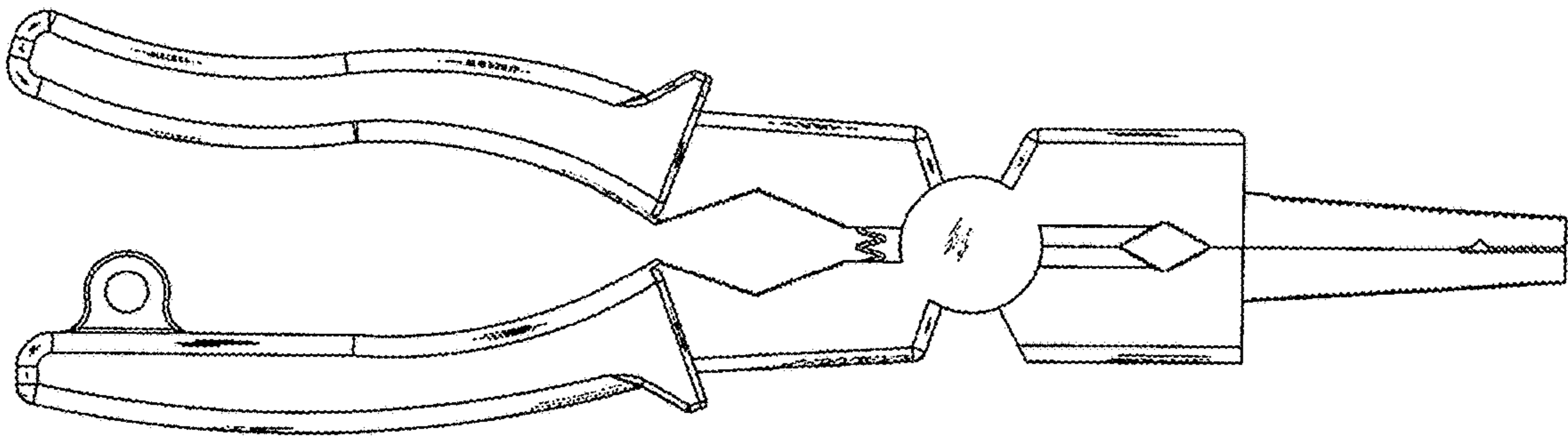

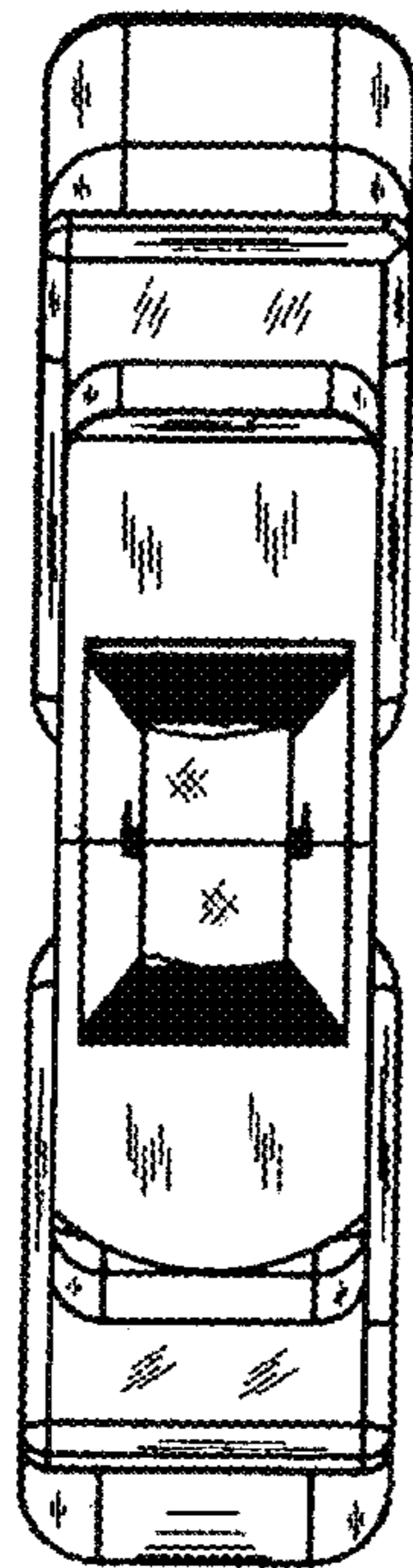

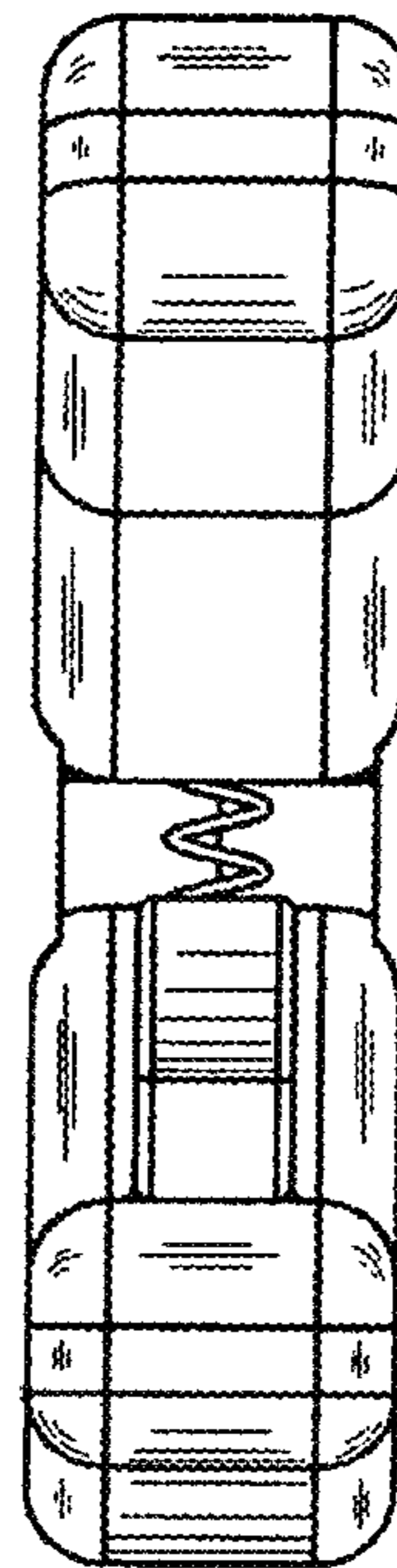

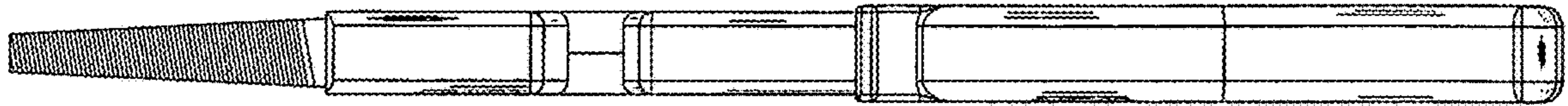
