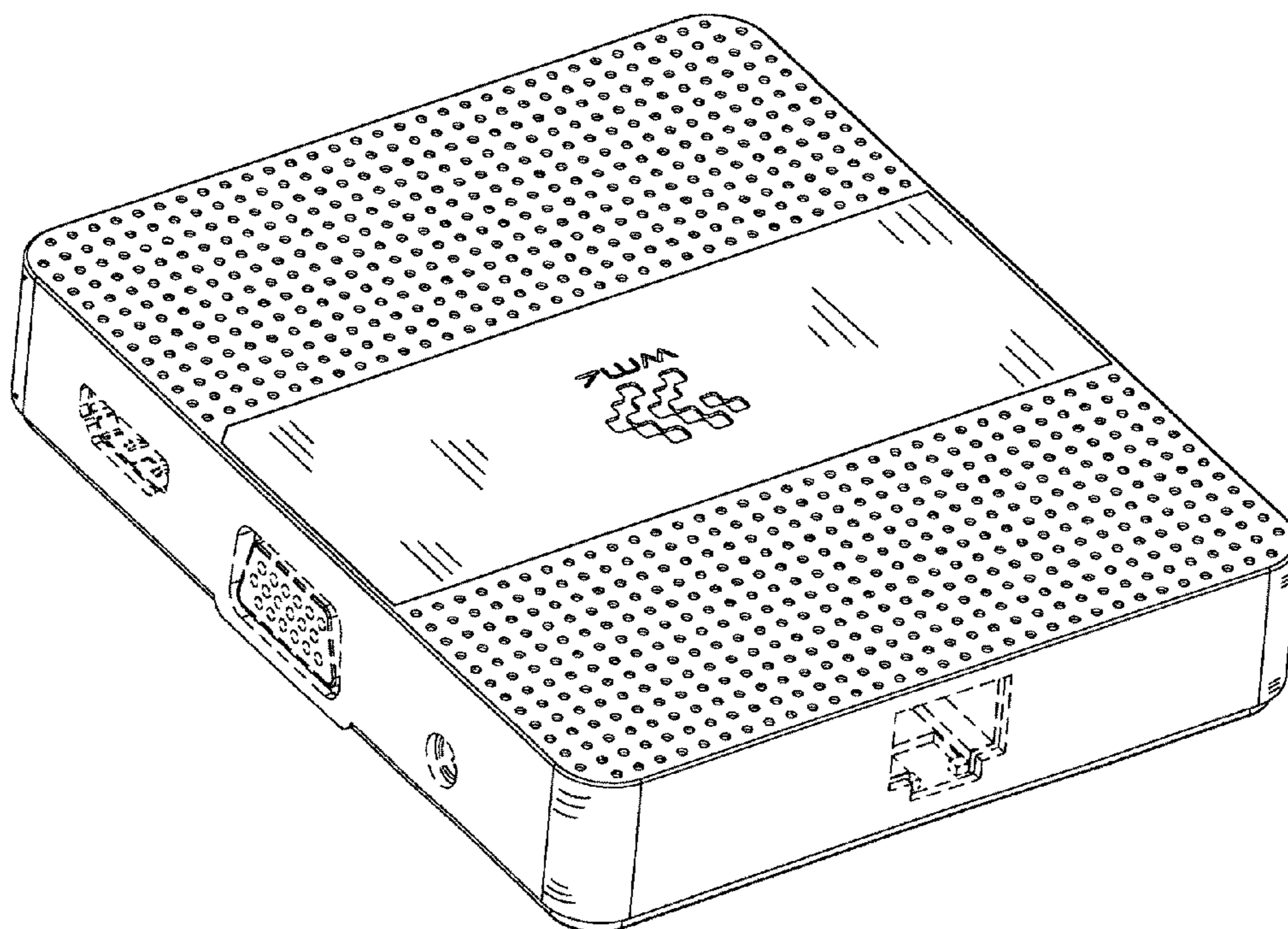
(57) **CLAIM**

The ornamental design for a multi-function wireless charger, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a multi-function wireless charger showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a perspective view thereof; and, FIG. 8 is a bottom right rear perspective view thereof. 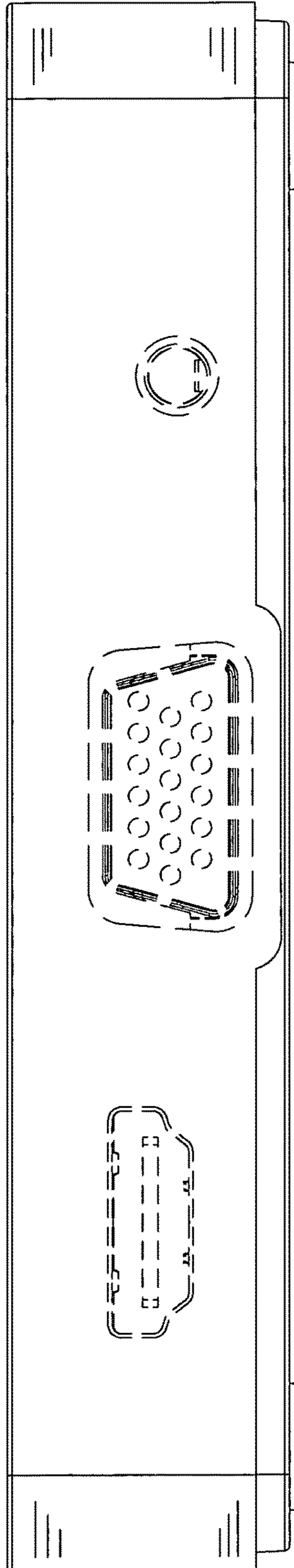

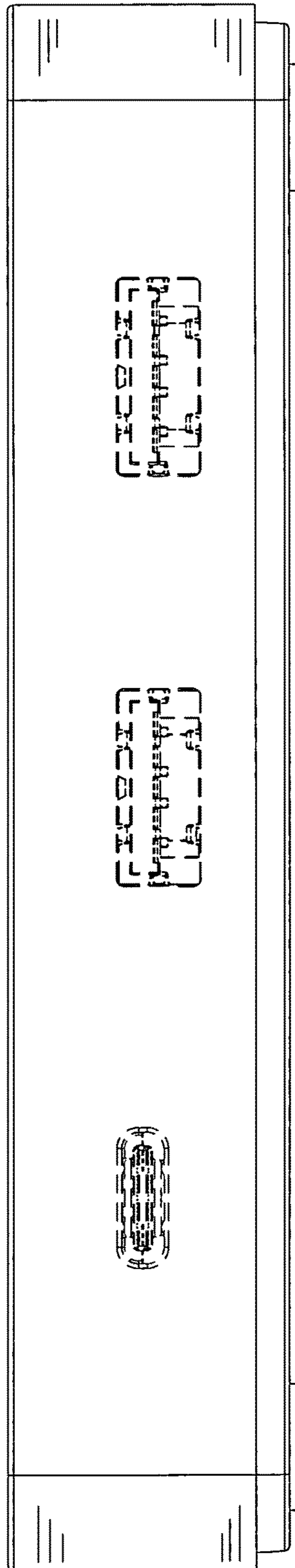

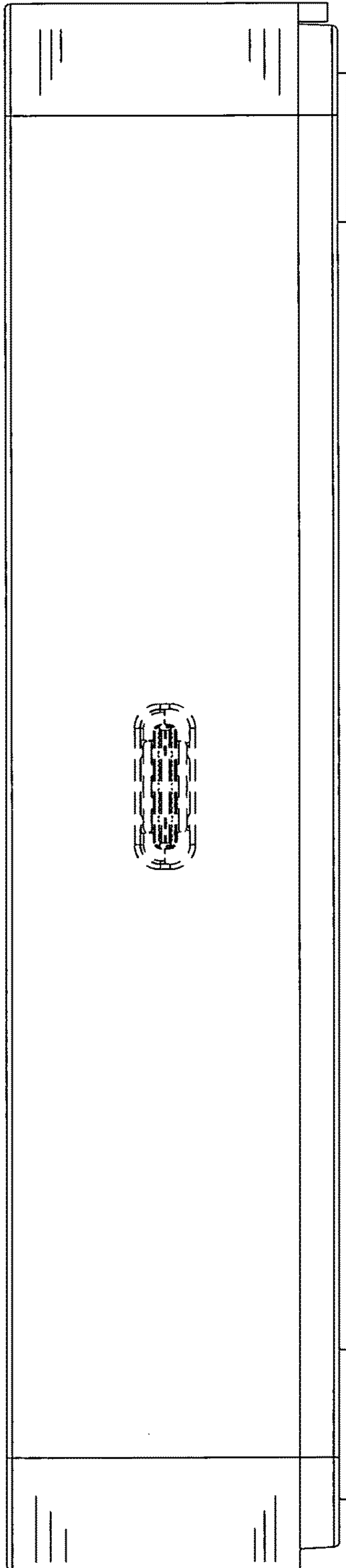

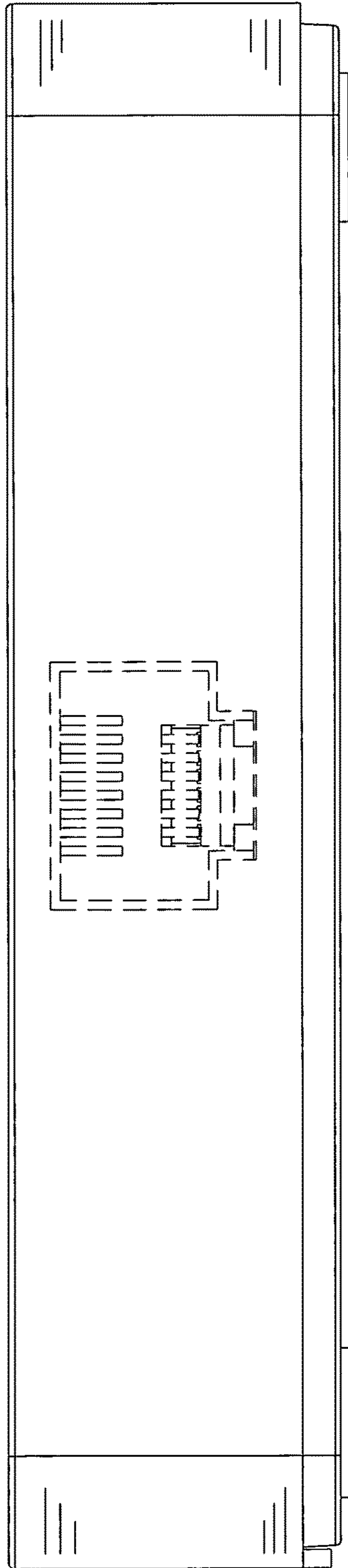

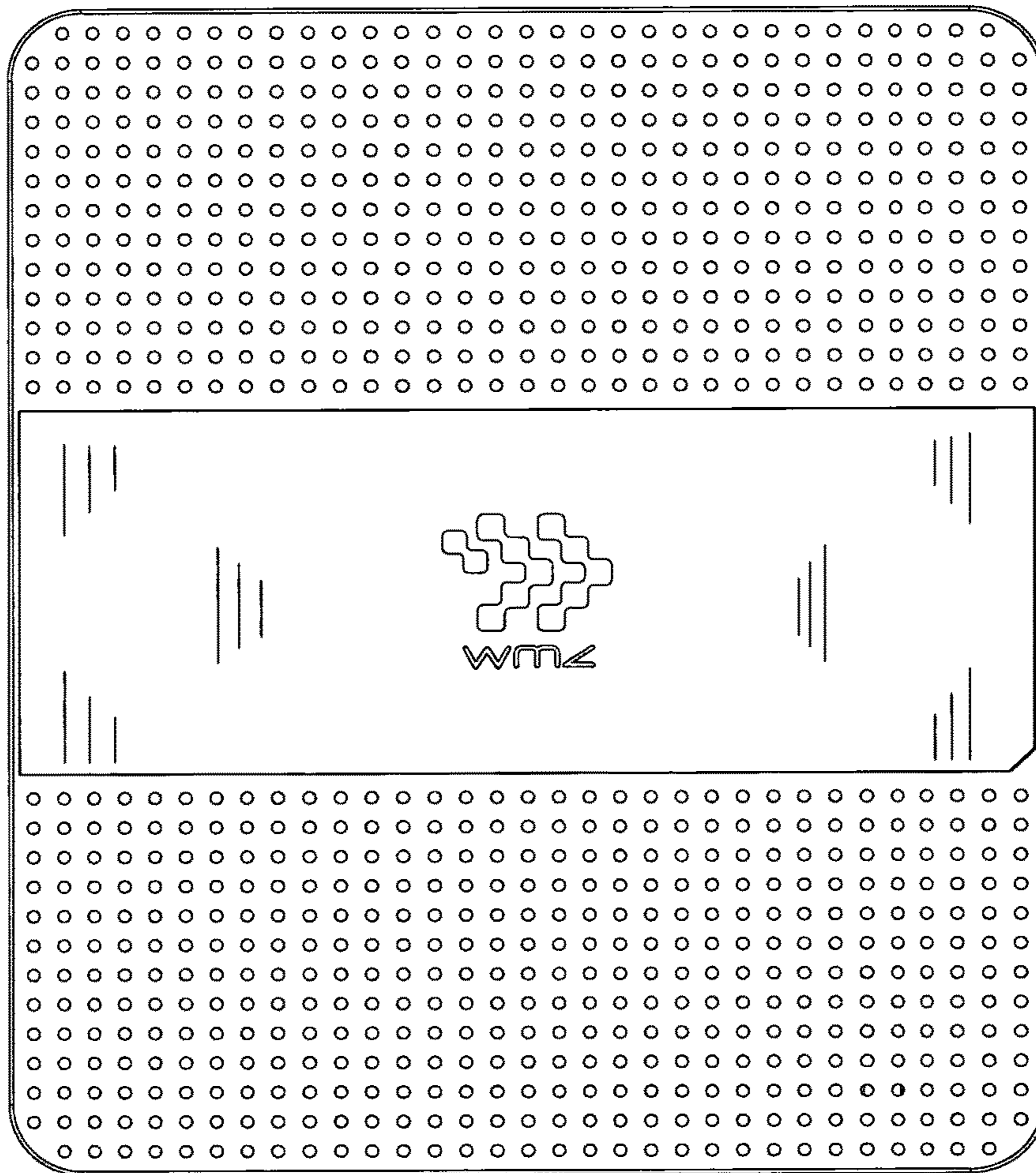

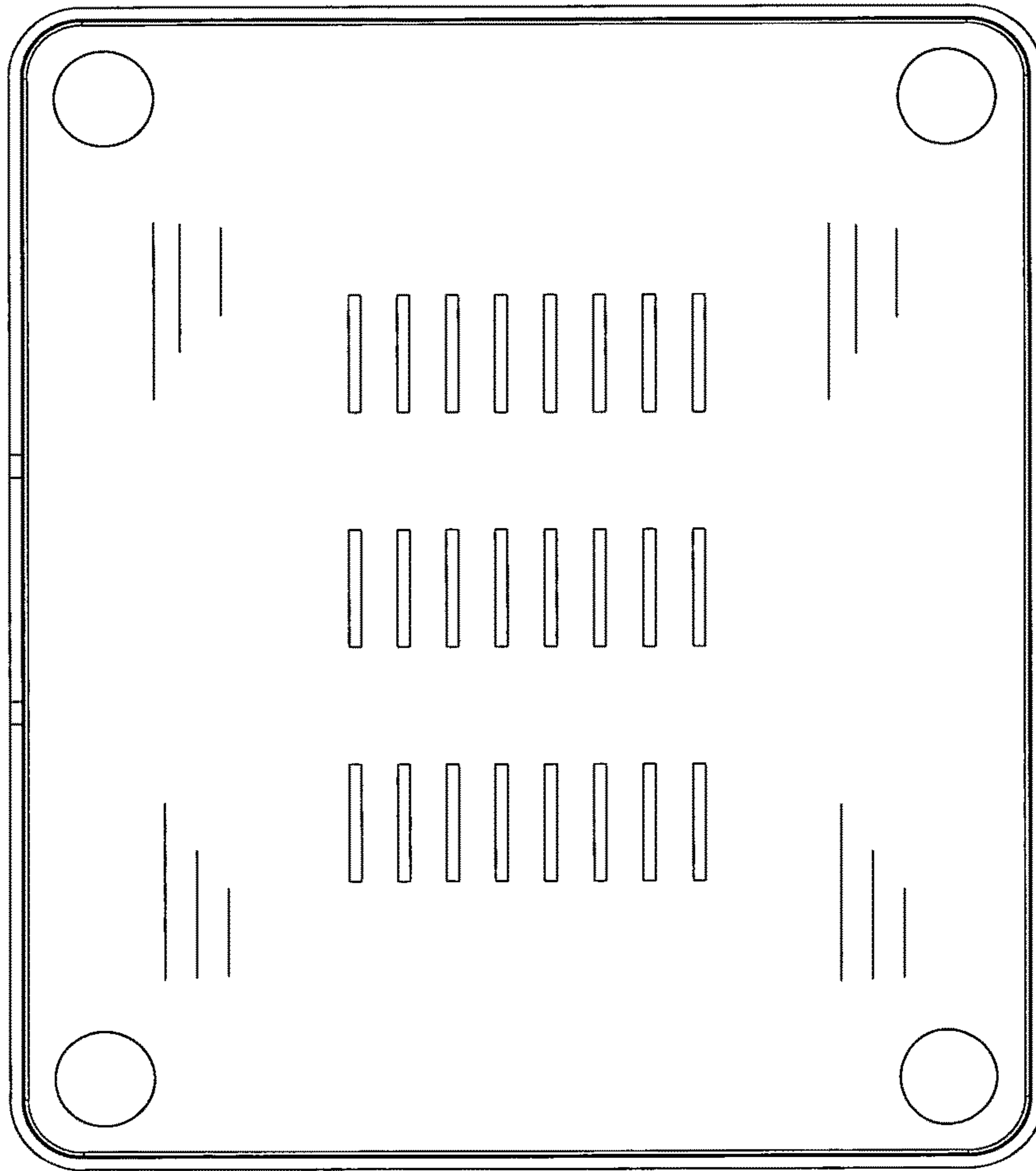

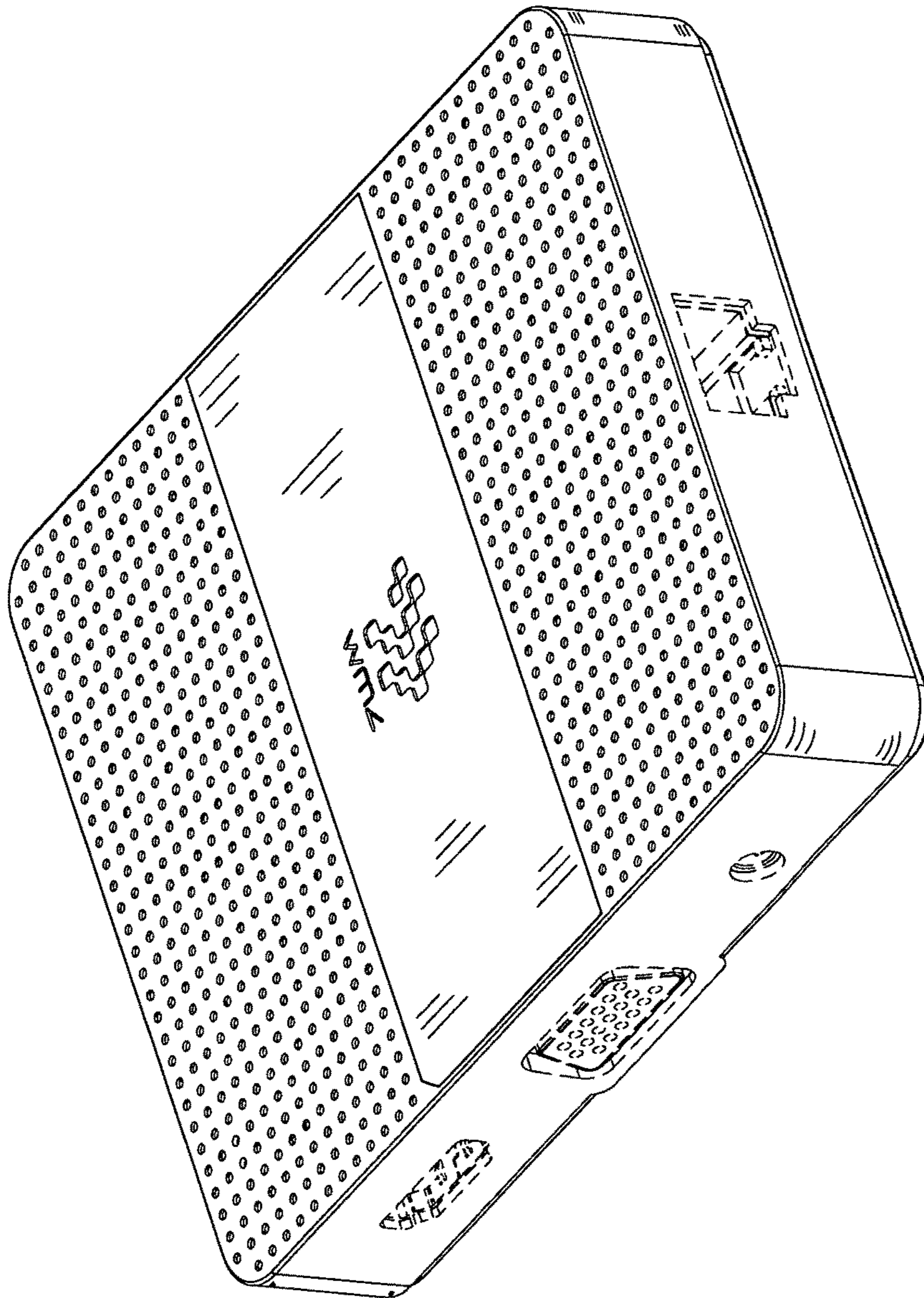

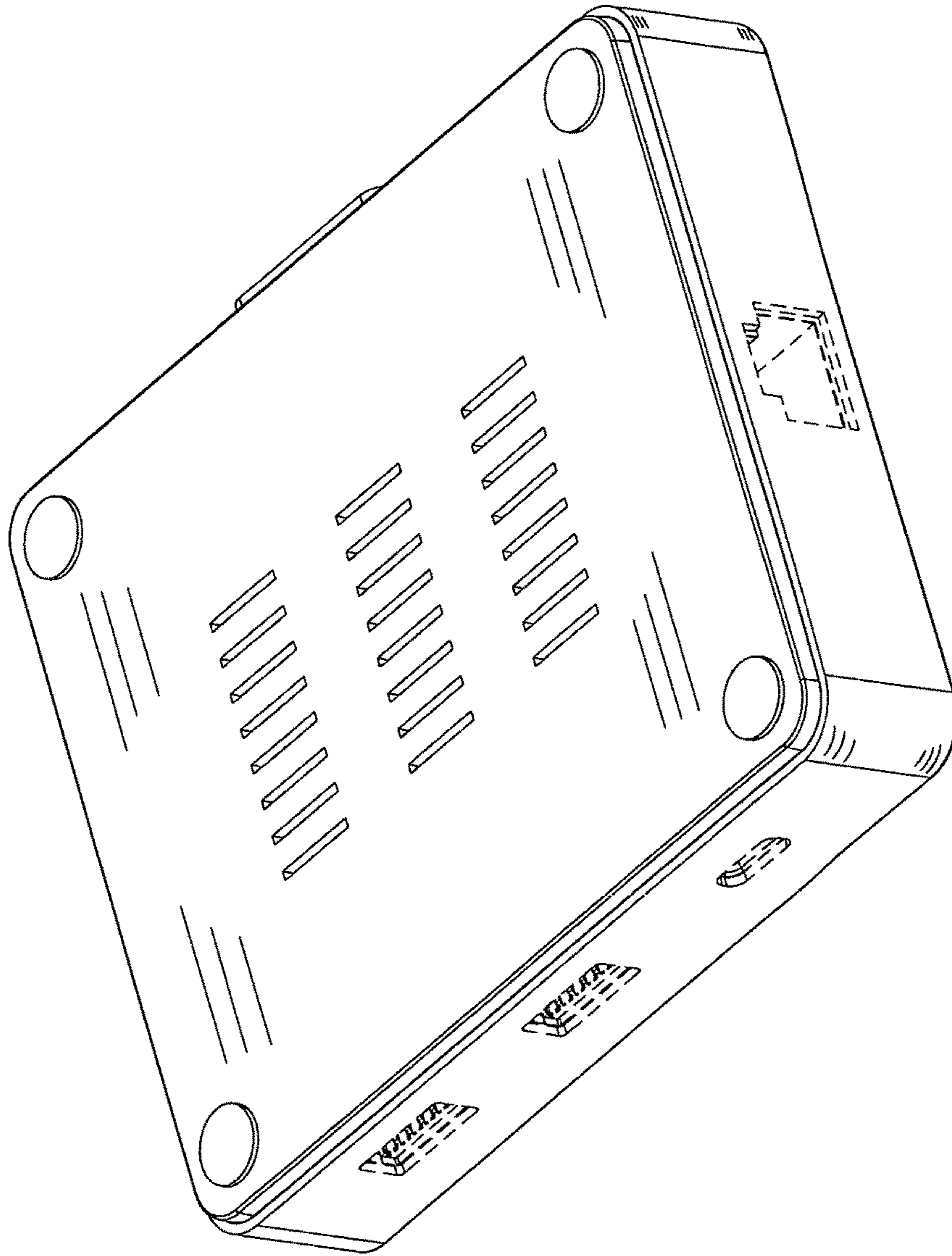
