**CLAIM**

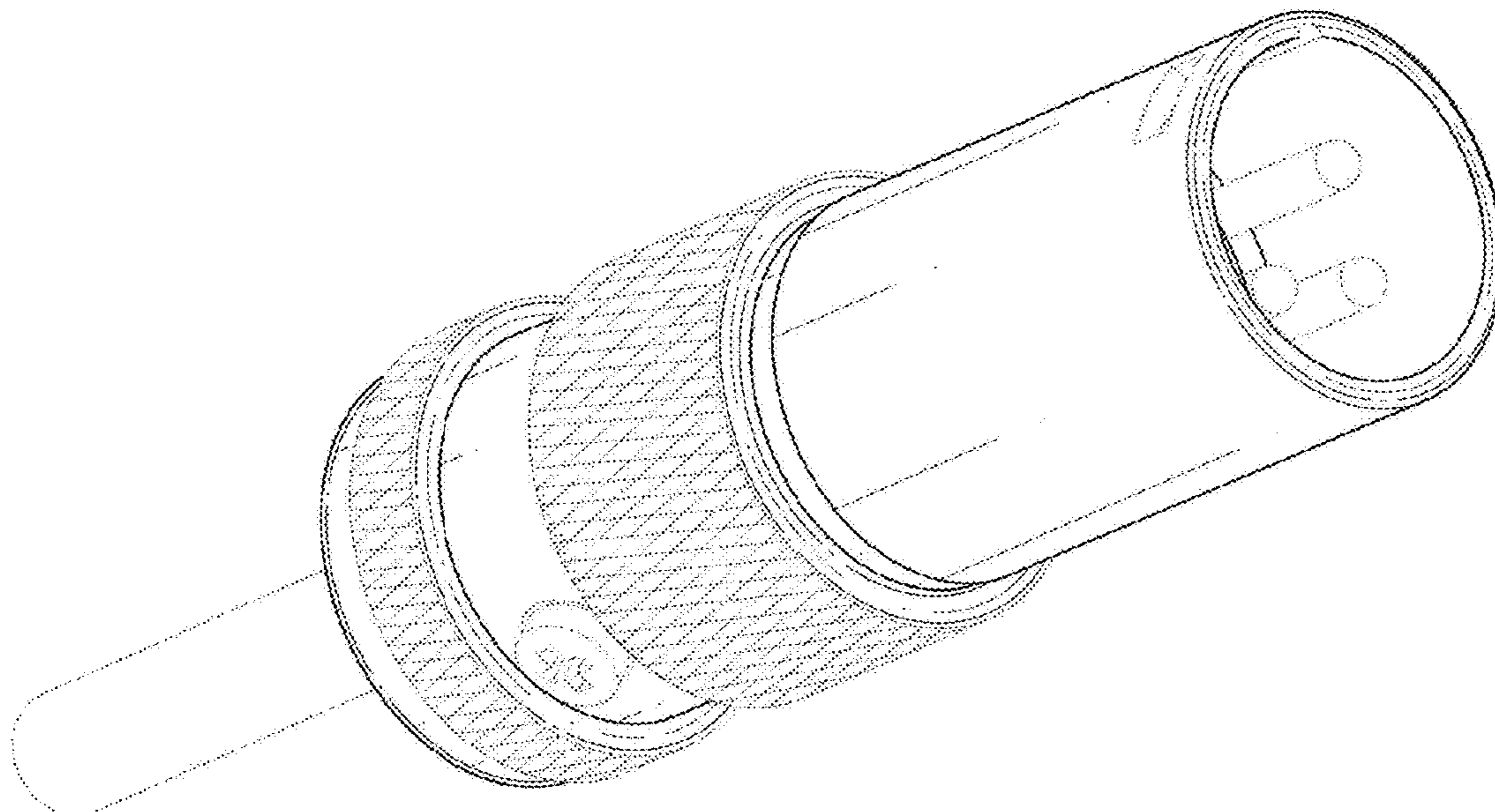
The ornamental design for a male connector, as shown and described.

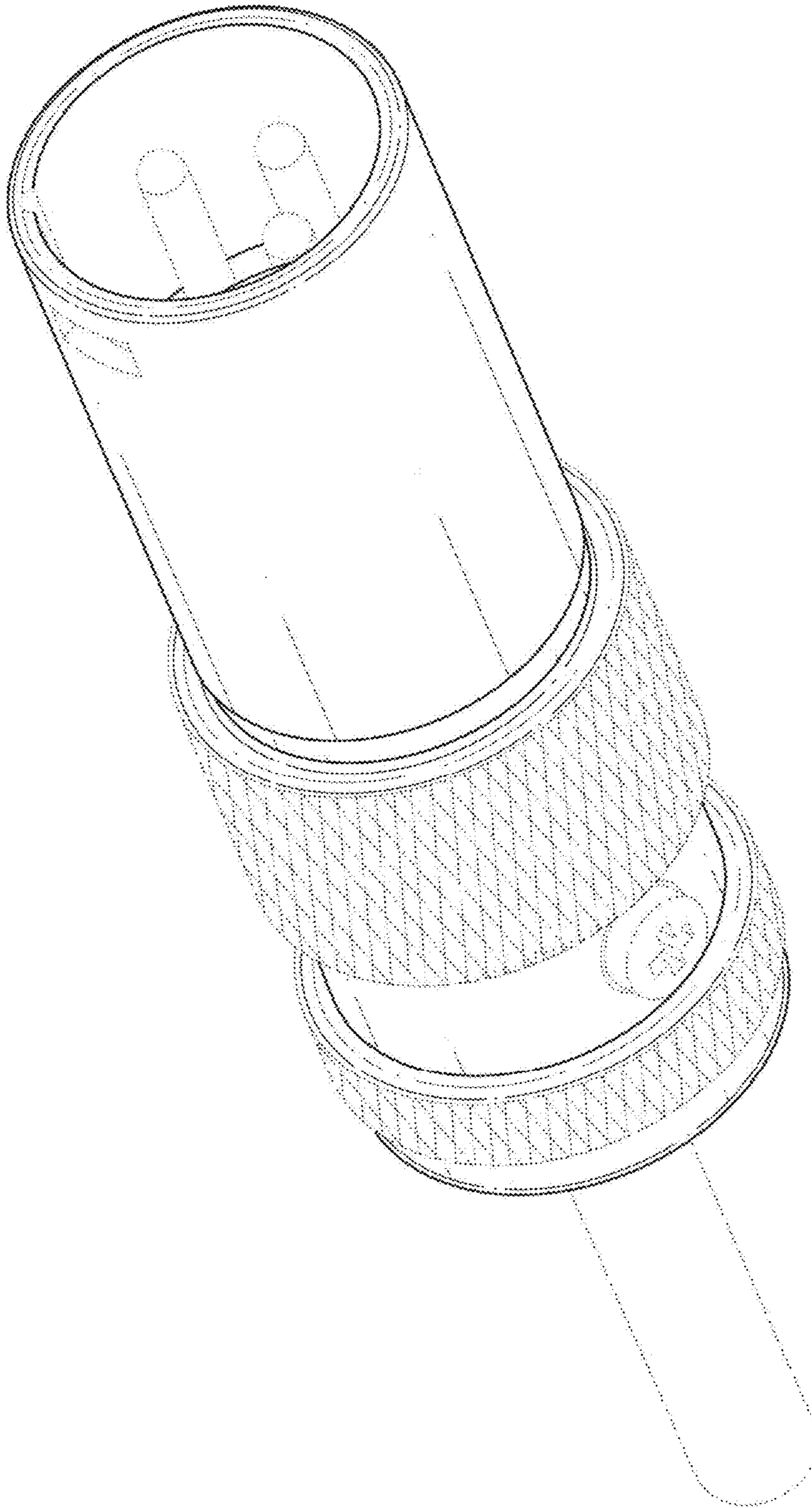

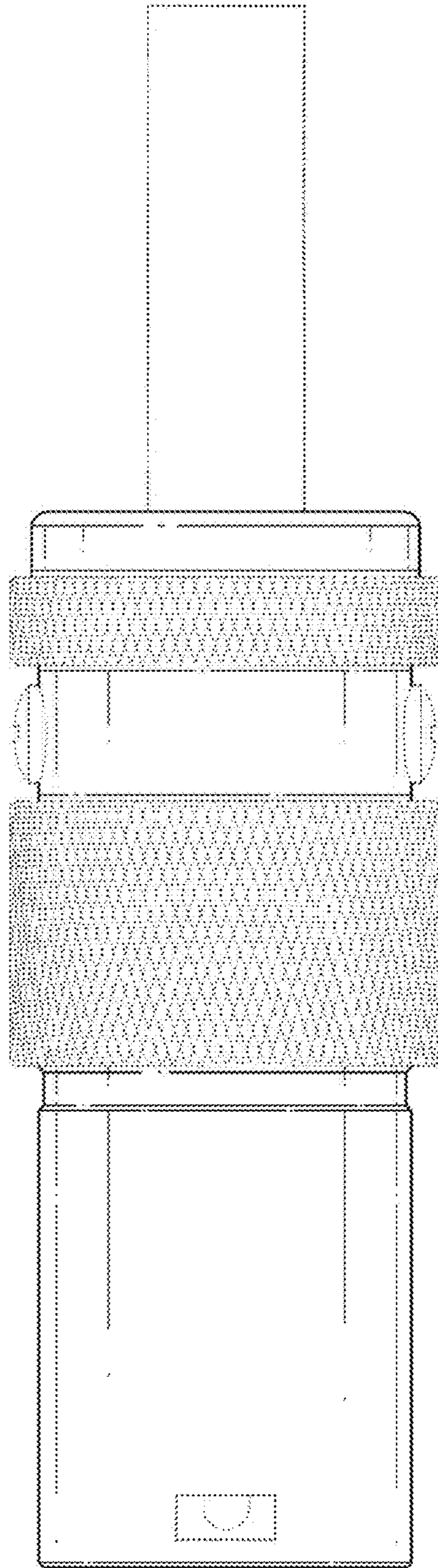

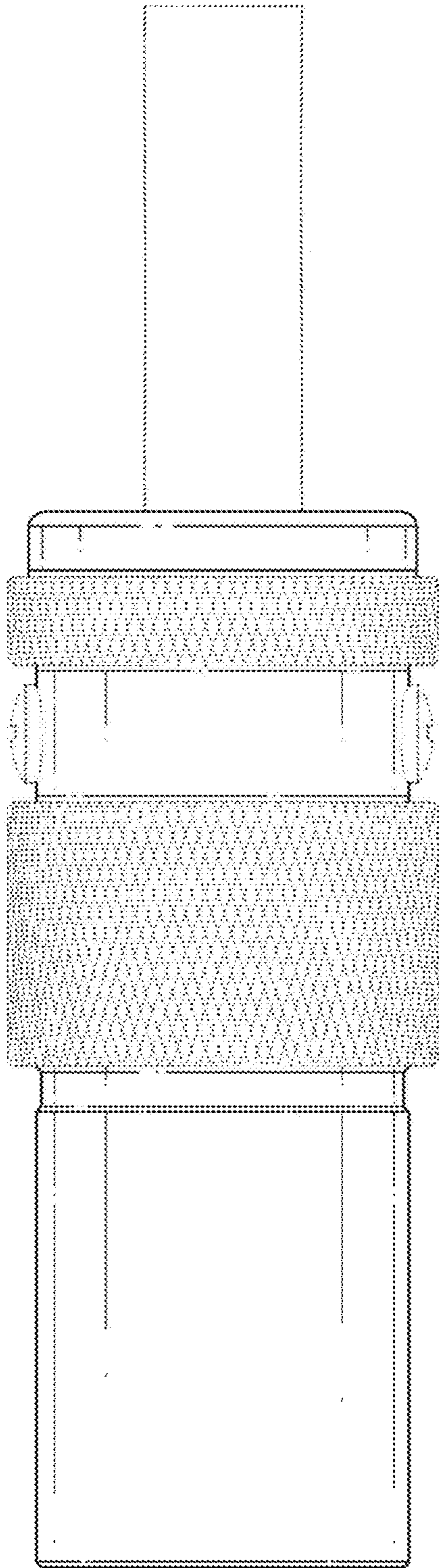

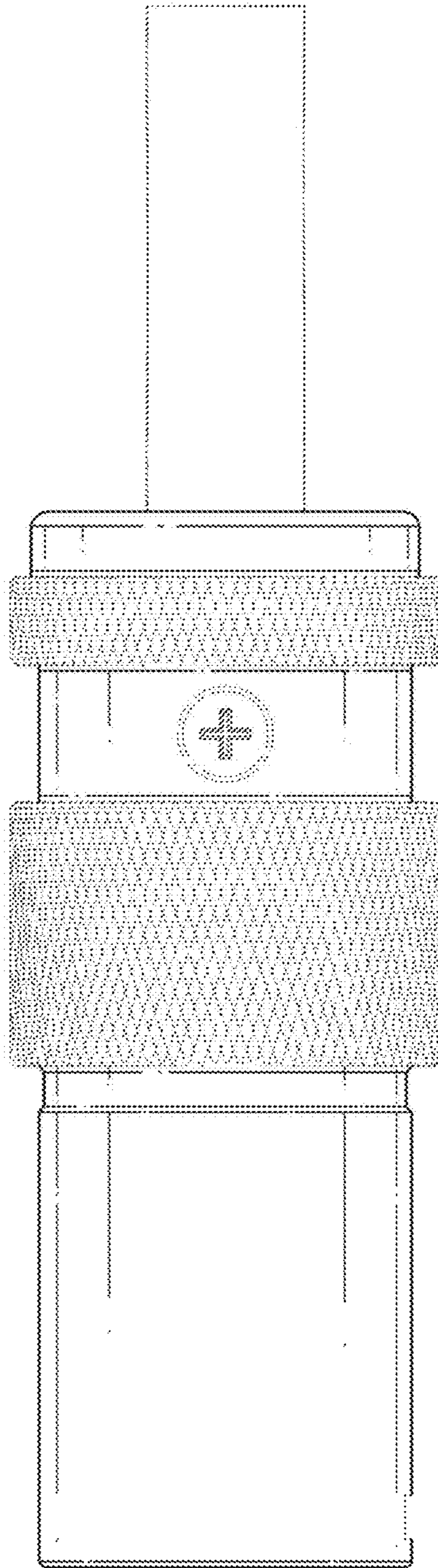

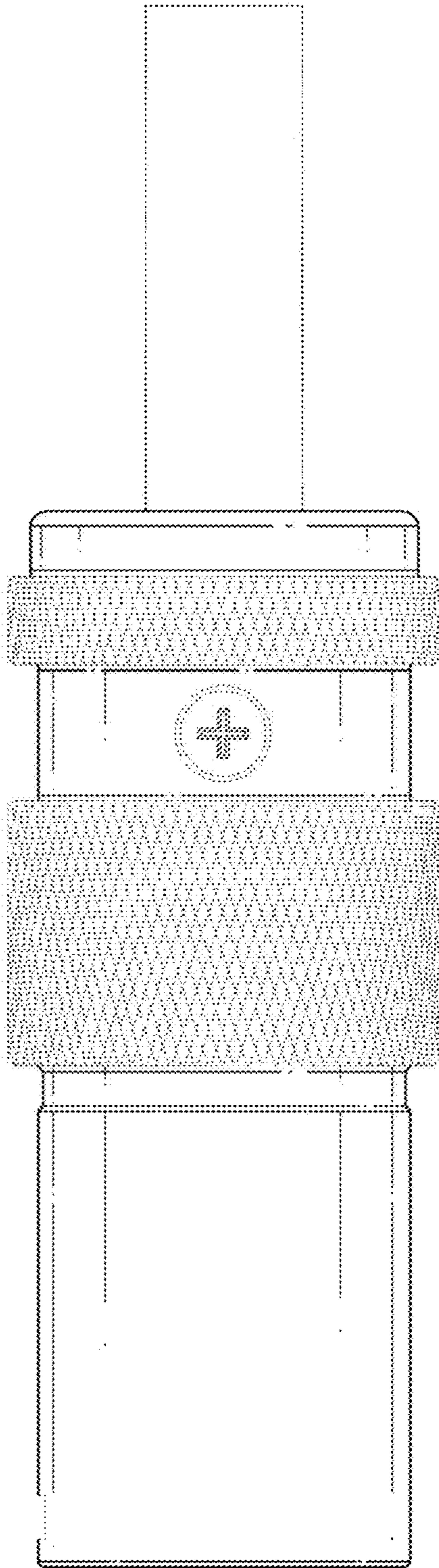

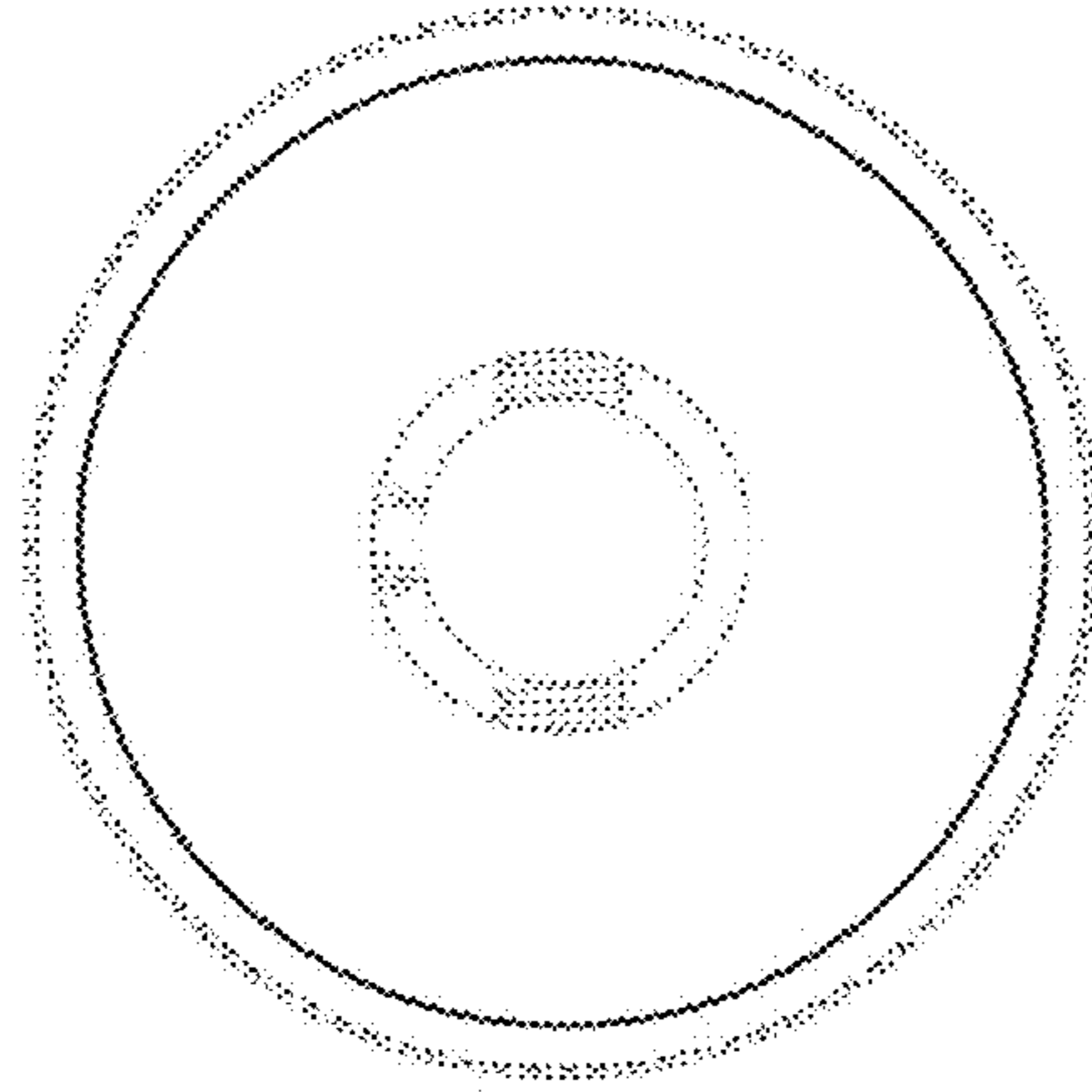

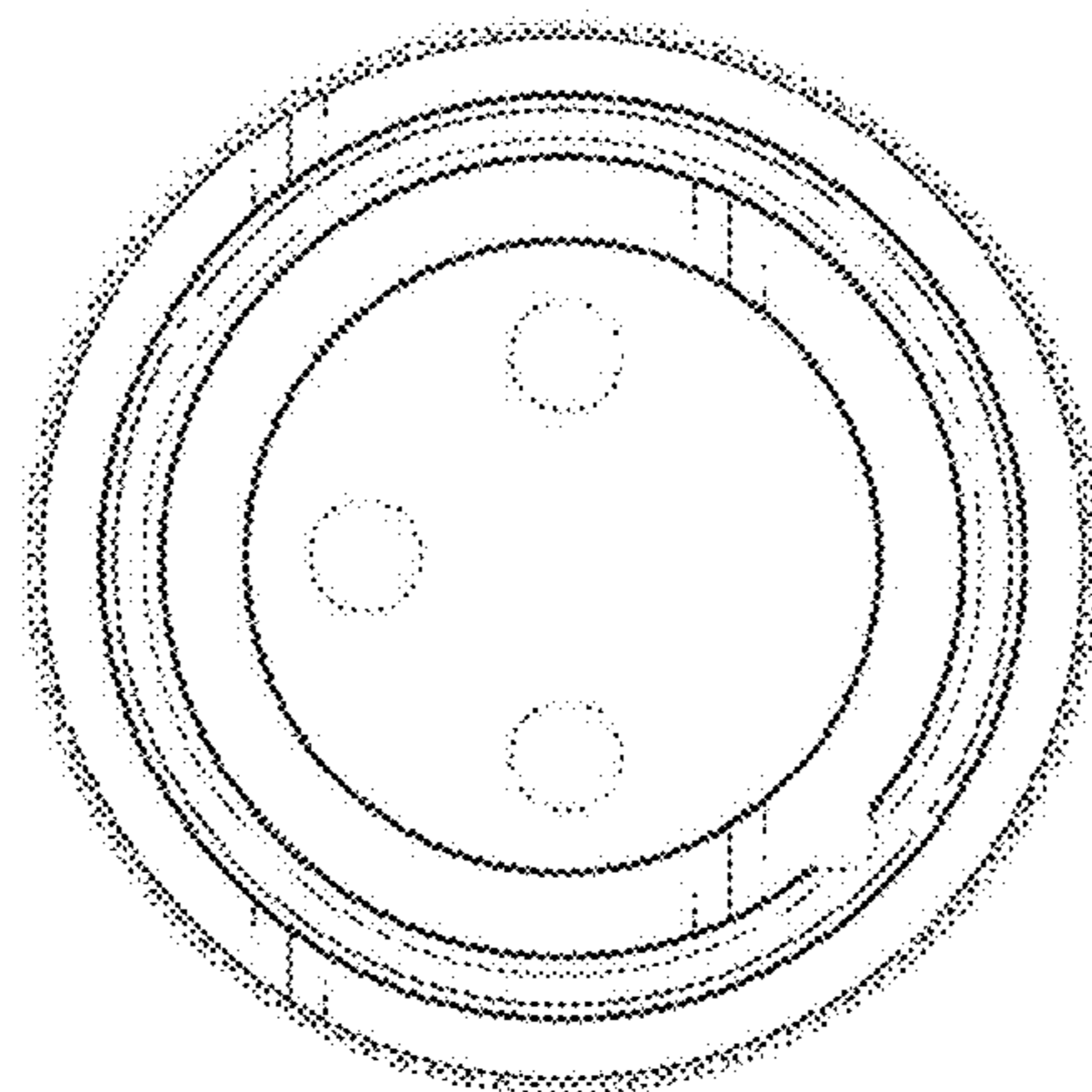
