The ornamental design for a display screen or portion thereof with a graphical user interface for an on-board computer, as shown and described.

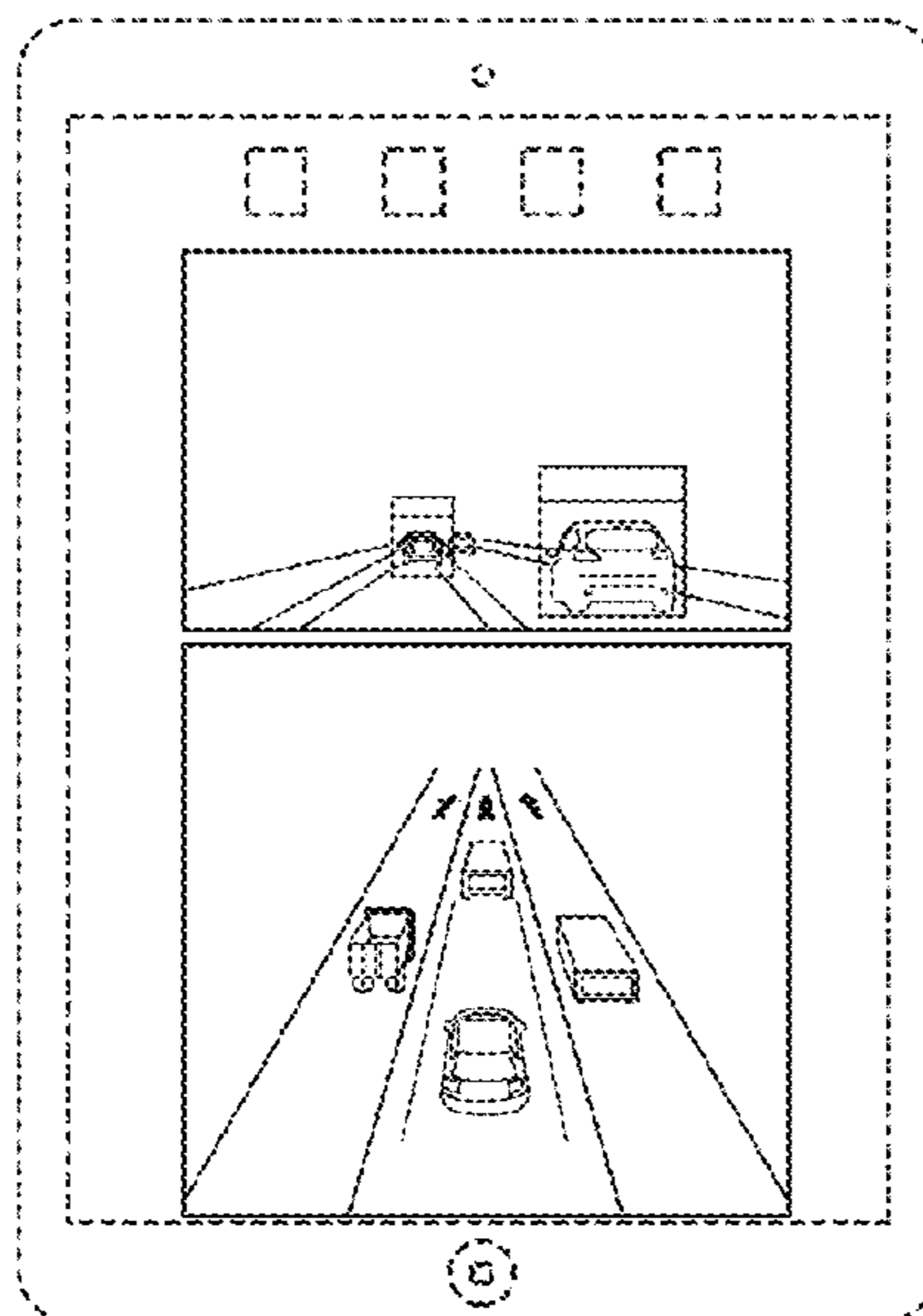
**DESCRIPTION**

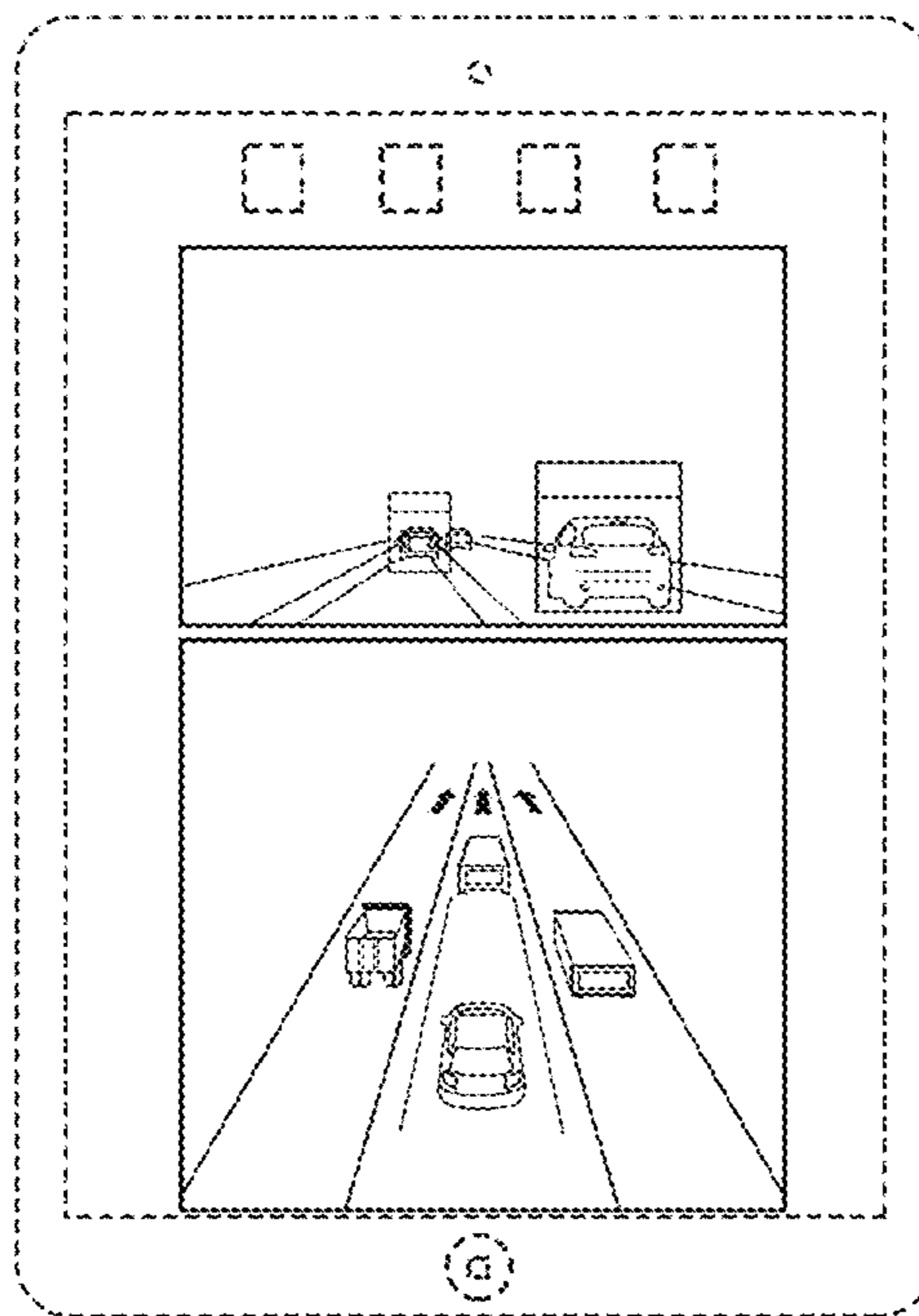

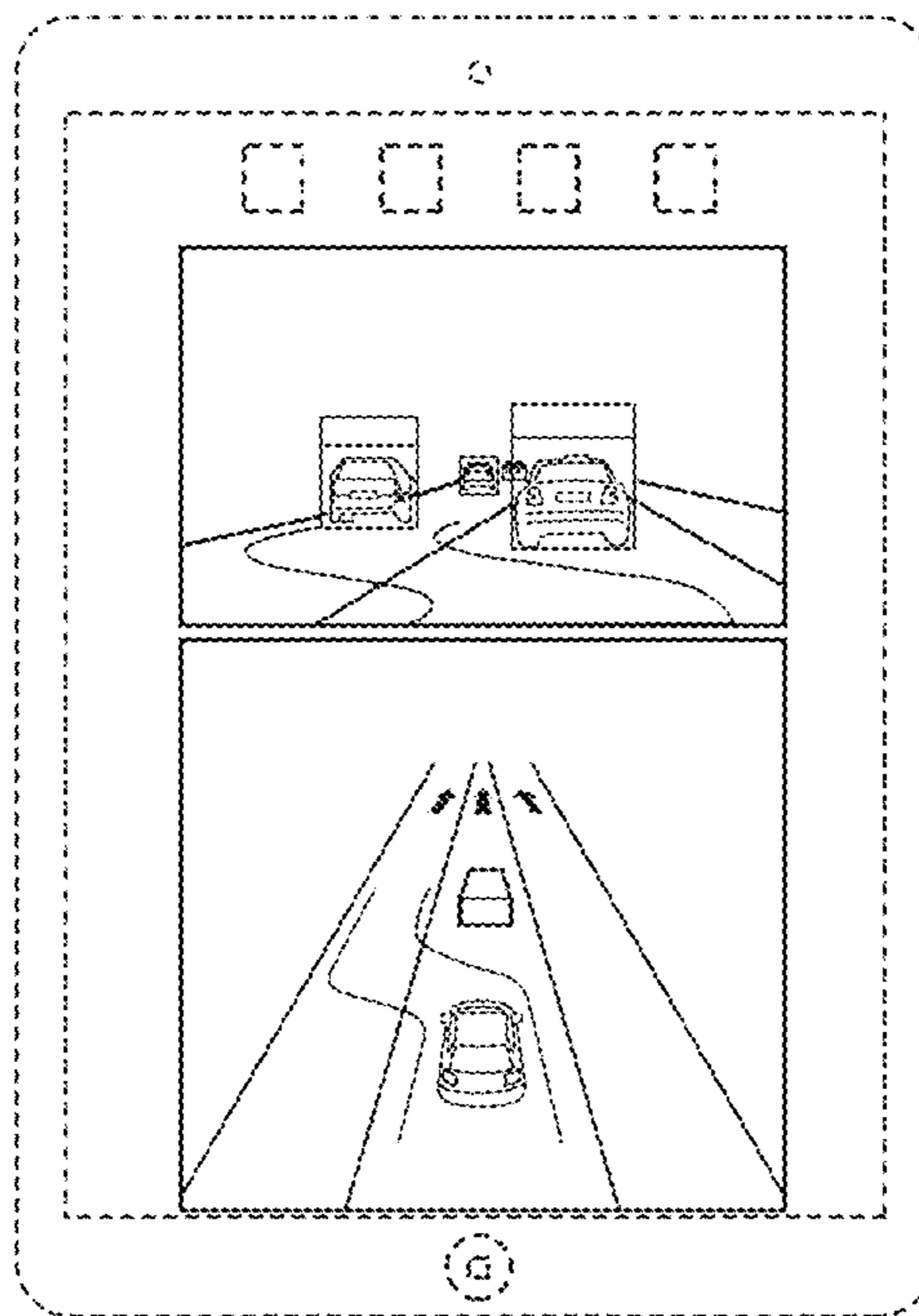
