(57) **CLAIM**

The ornamental design for a camera, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, right perspective view of a camera showing the new design.

FIG. 2 is a front elevation view of the camera shown in FIG. 1.

FIG. 3 is a rear elevation view of the camera shown in FIG. 1.

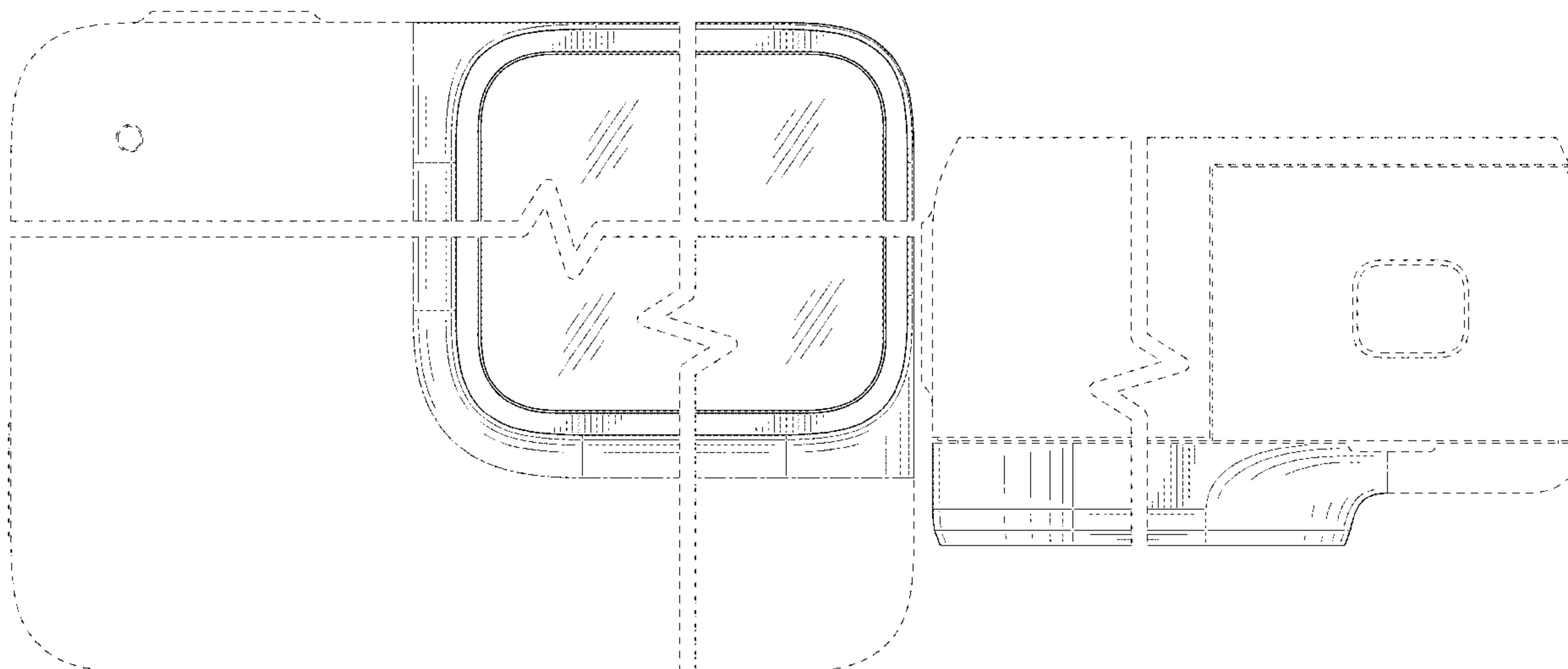
FIG. 4 is a right elevation view of the camera shown in FIG. 1.

FIG. 5 is a left elevation view of the camera shown in FIG. 1.

FIG. 6 is a top plan view of the camera shown in FIG. 1; and, FIG. 7 is a bottom plan view of the camera shown in FIG. 1.

The broken lines formed by equal length dashes (i.e., dash-dash) depict portions of the camera that form no part of the claimed design. The broken lines formed by unequal length dashes (i.e., dash-dot) define the bounds of the claim and form no part of the claimed design. The camera is shown with symbolic breaks. The appearance of any portion of the camera between the broken away symbols forms no part of the claimed design.

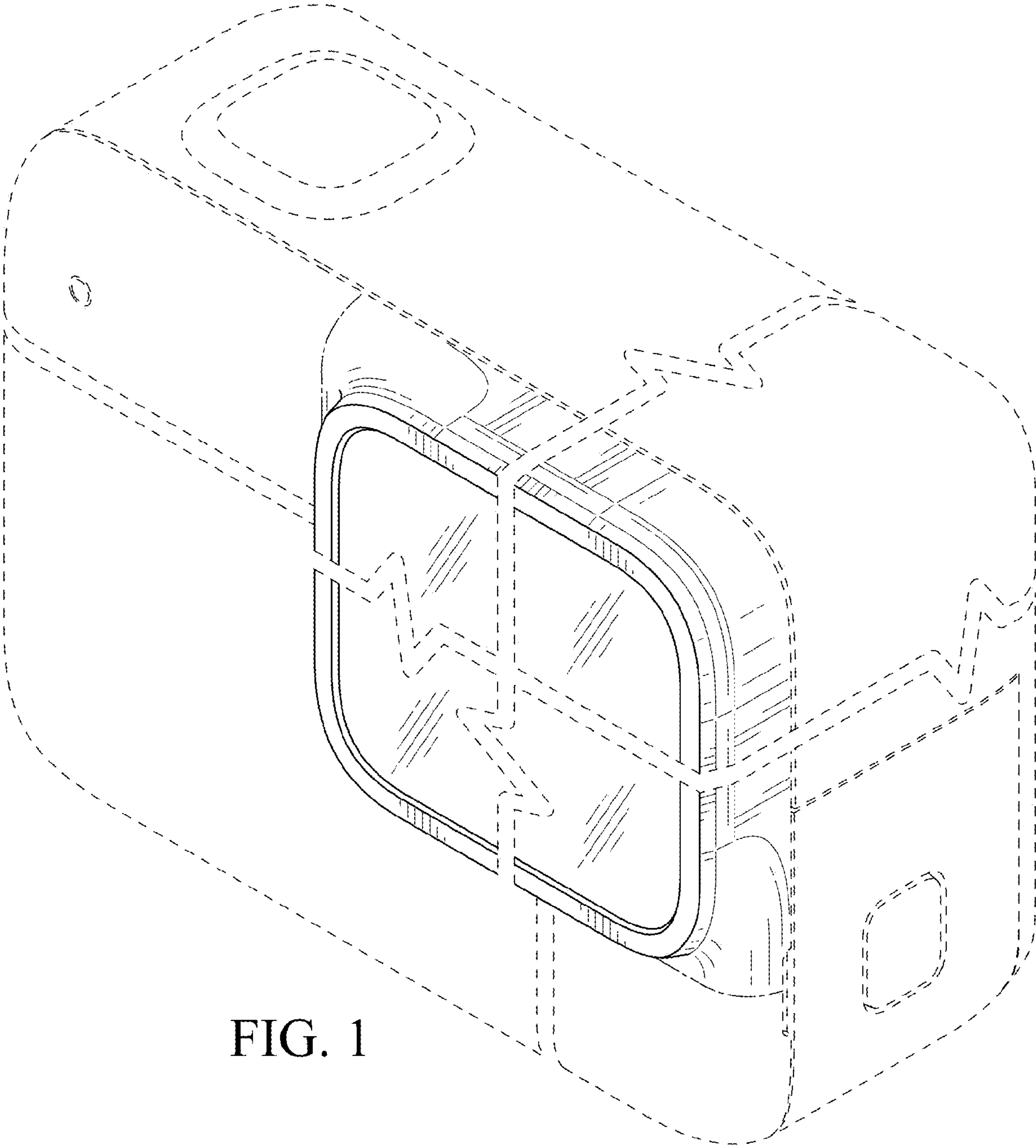

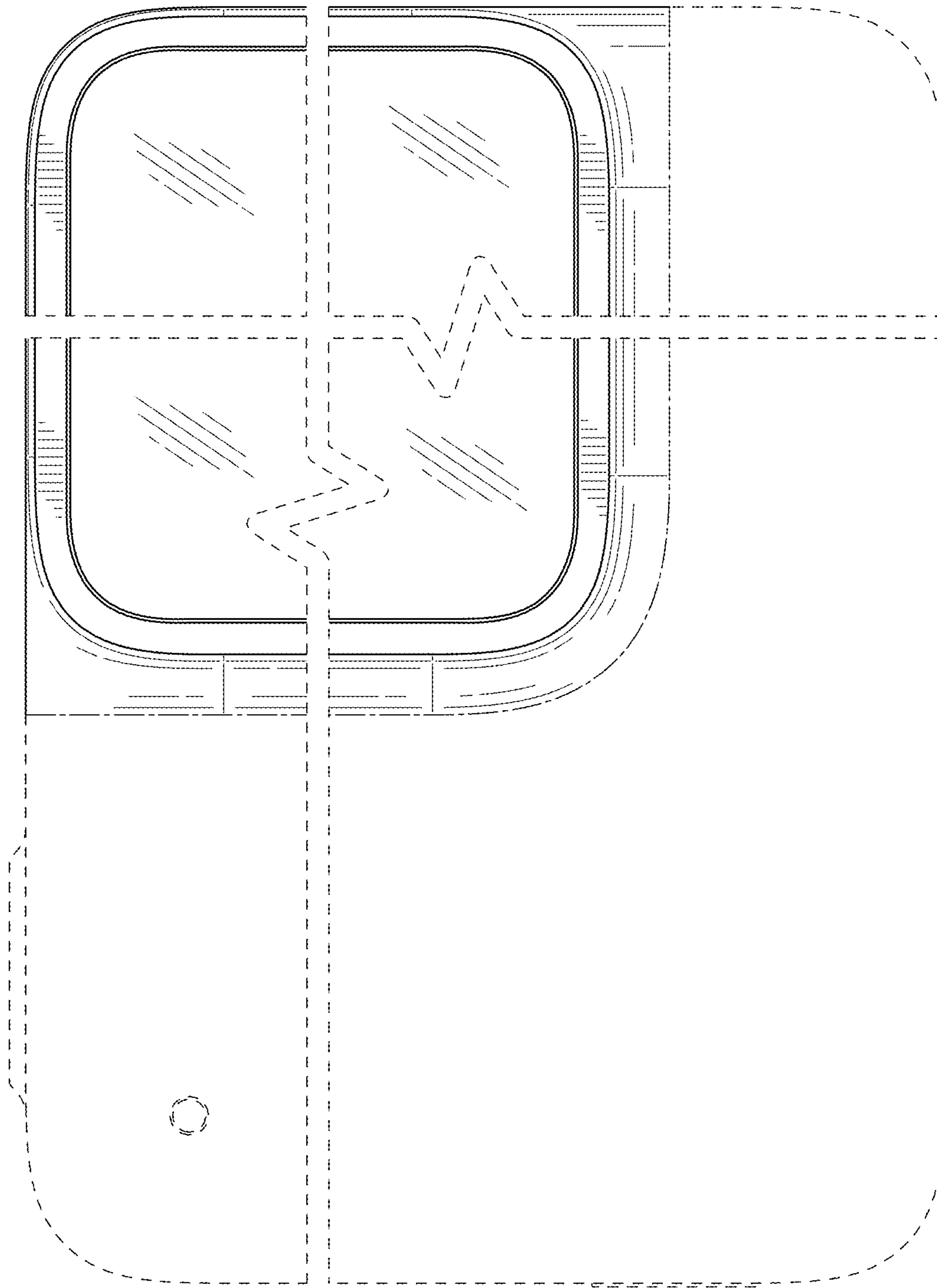

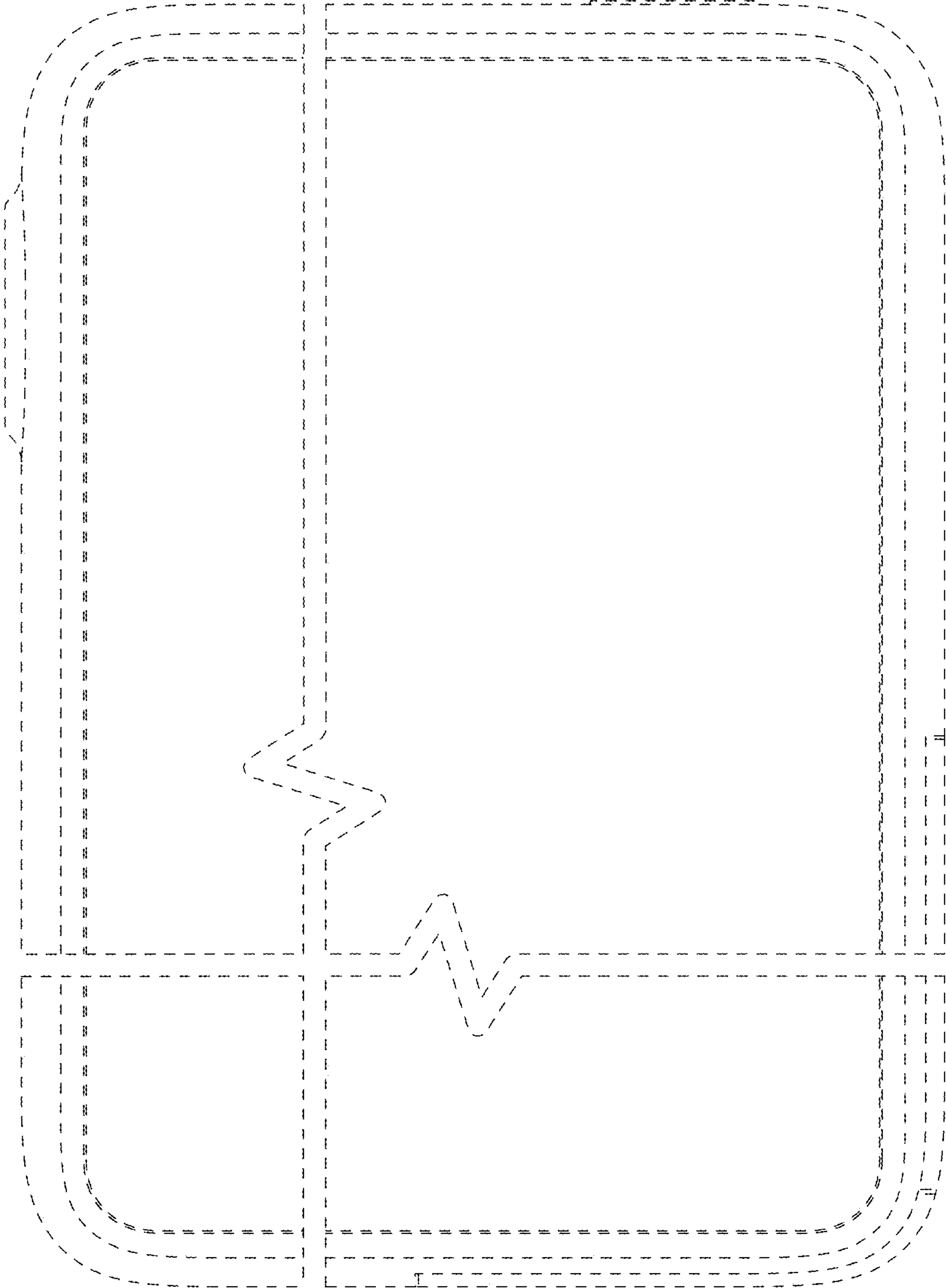

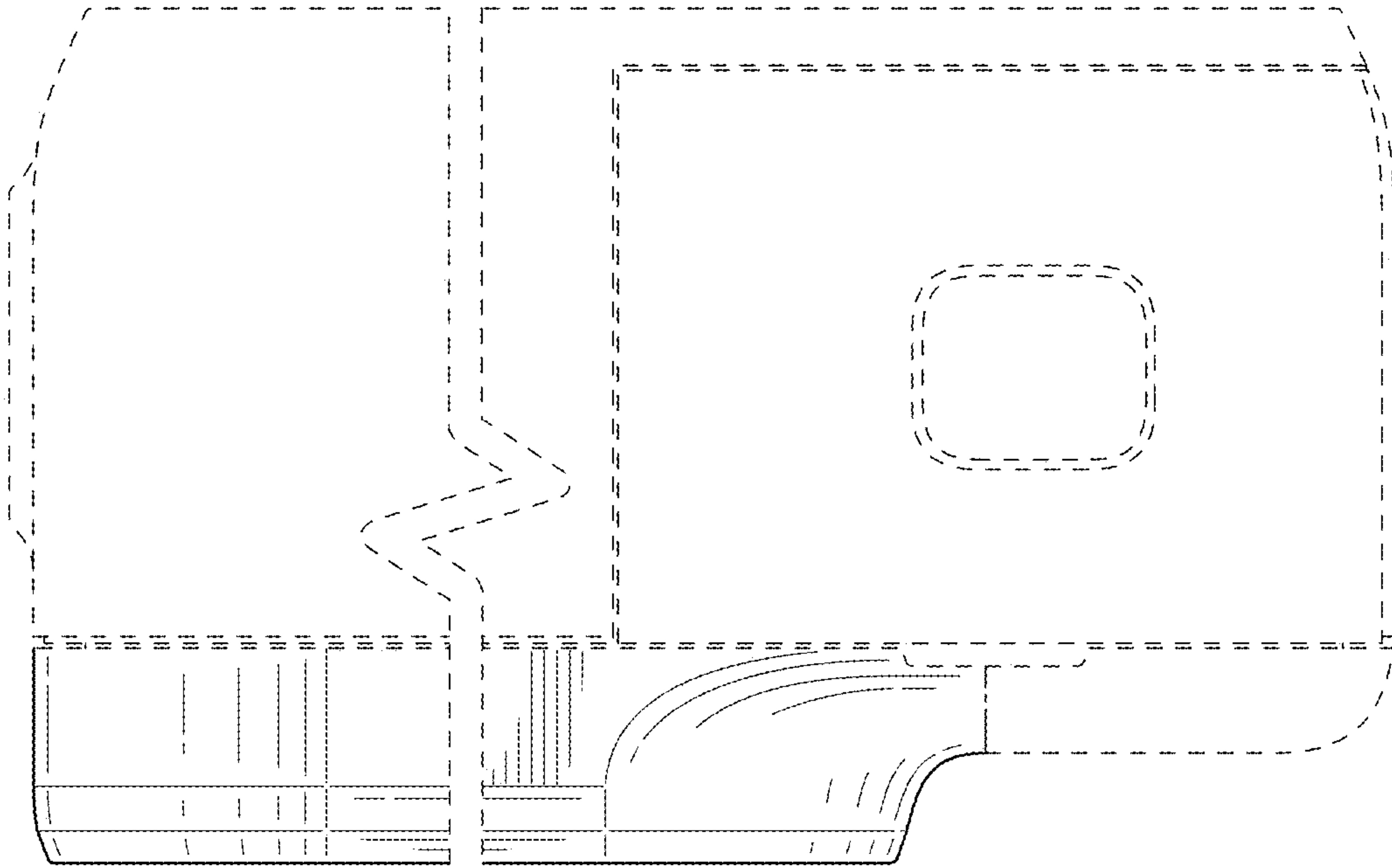

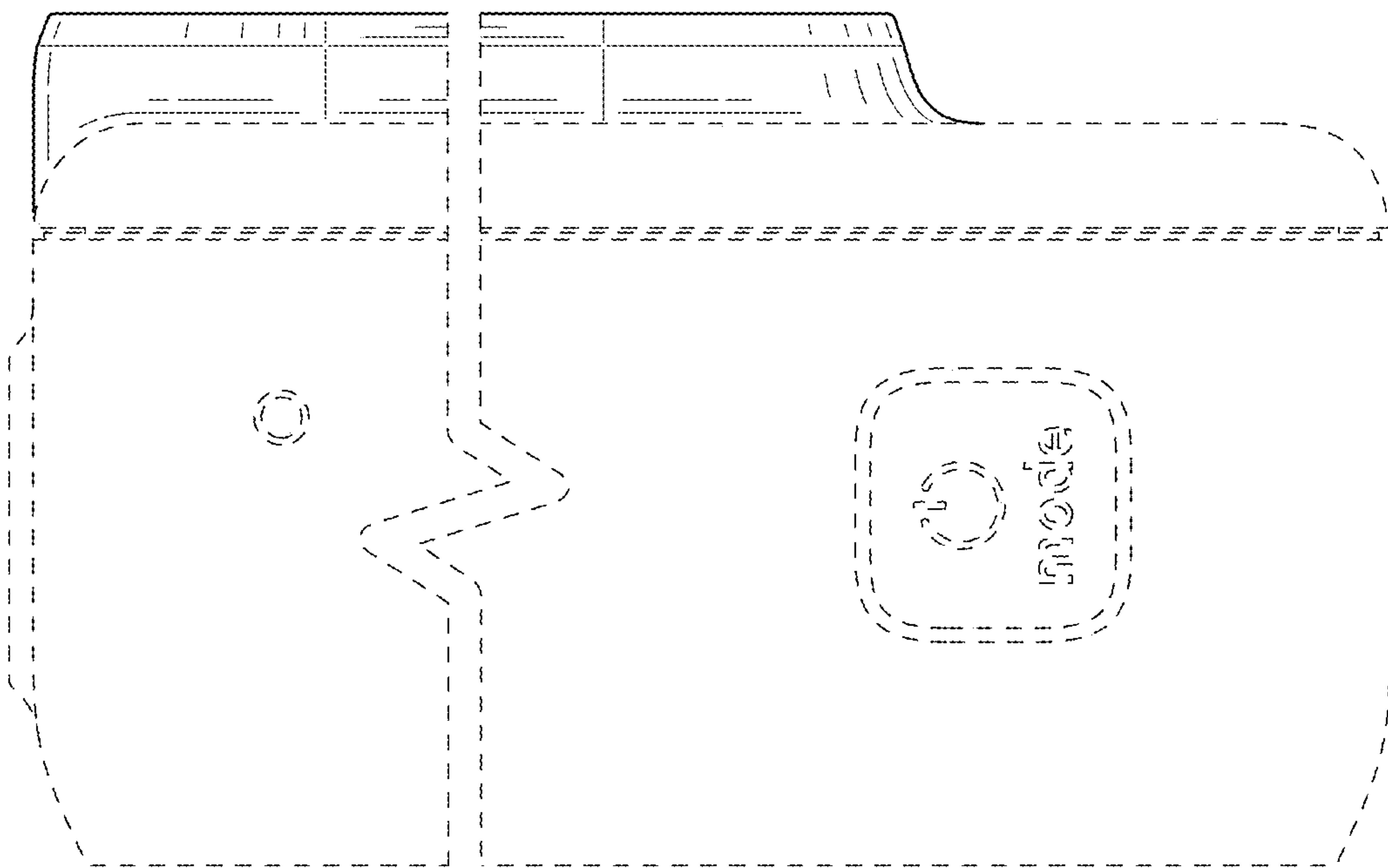

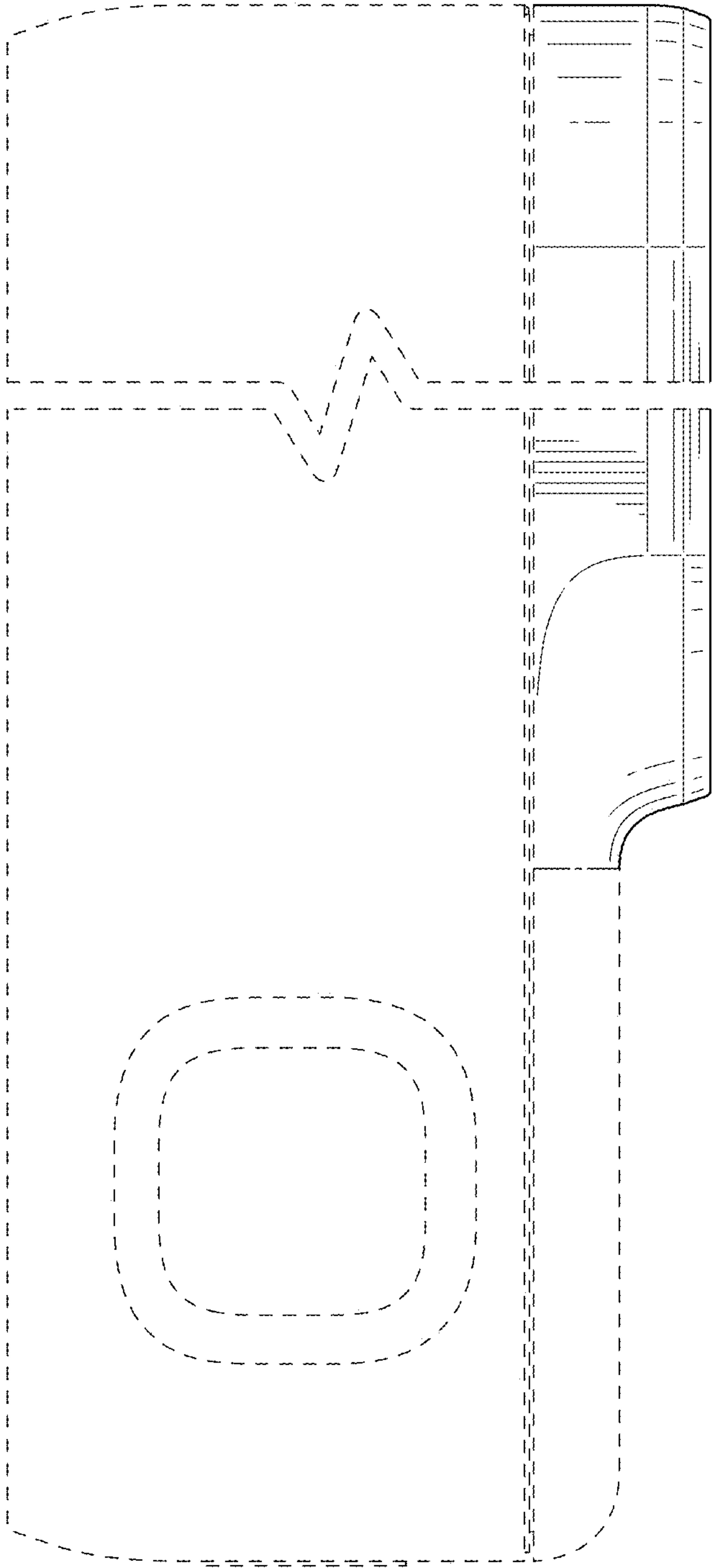

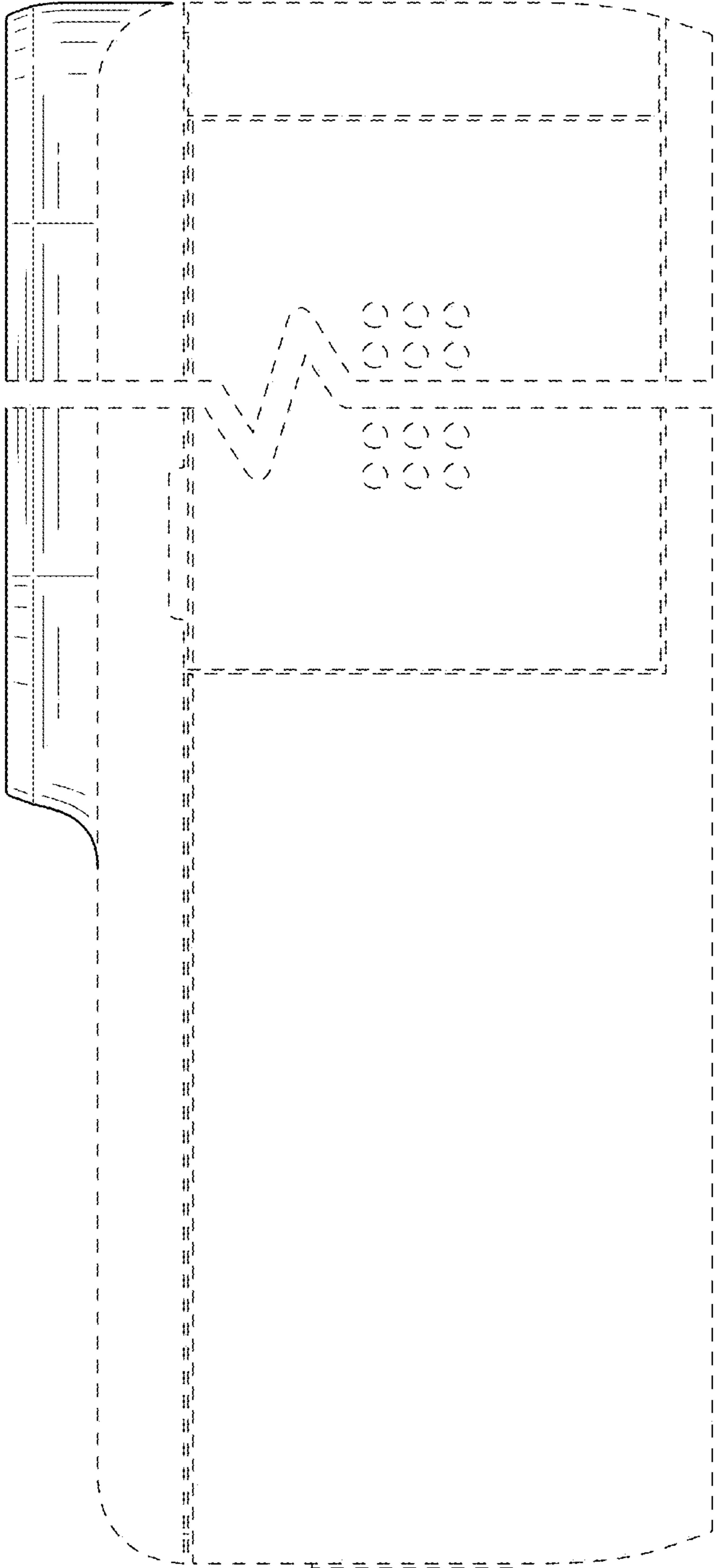
