DESCRIPTION

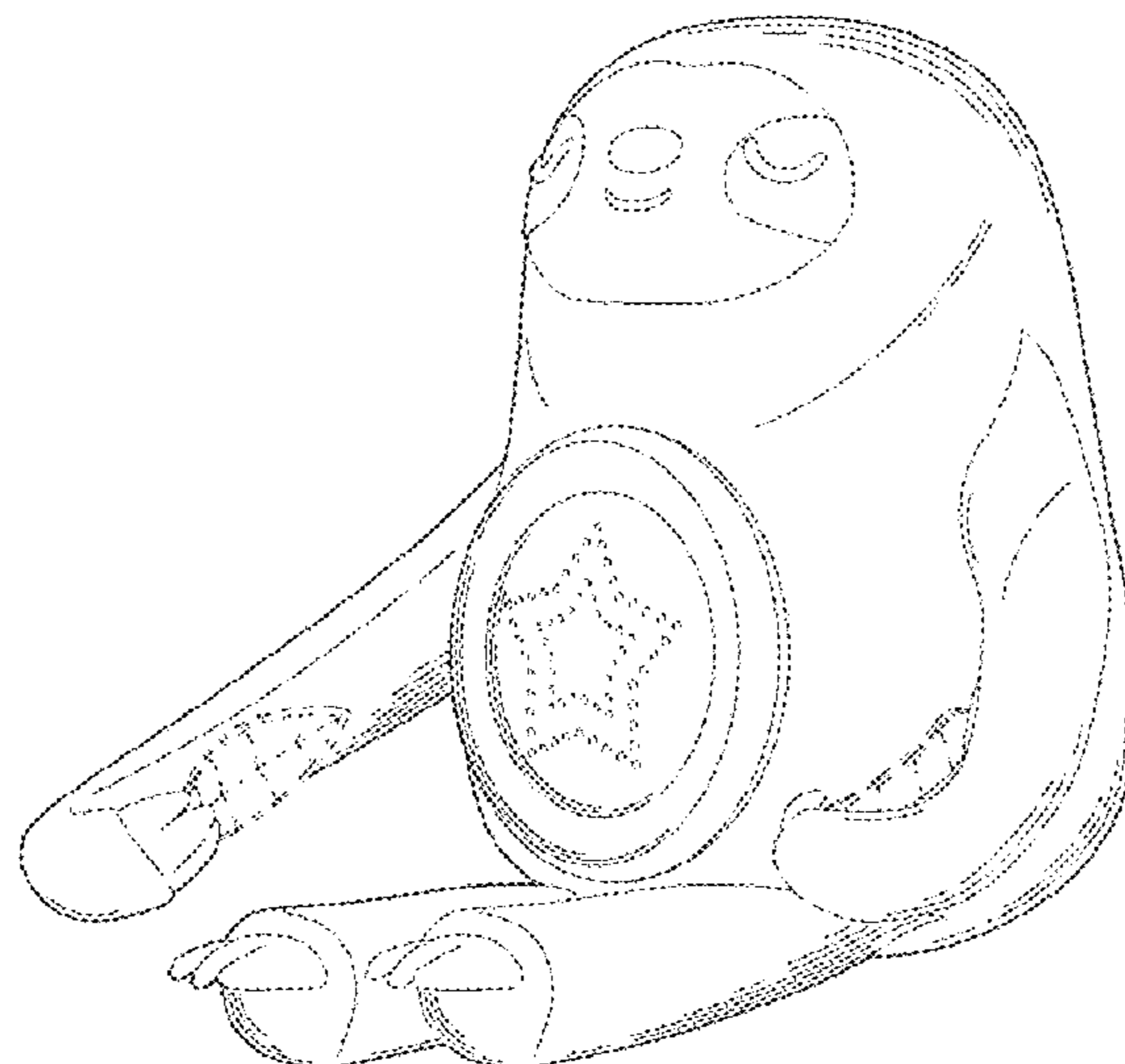
FIG. 1 is a front elevation view of an infant sleeping aid;

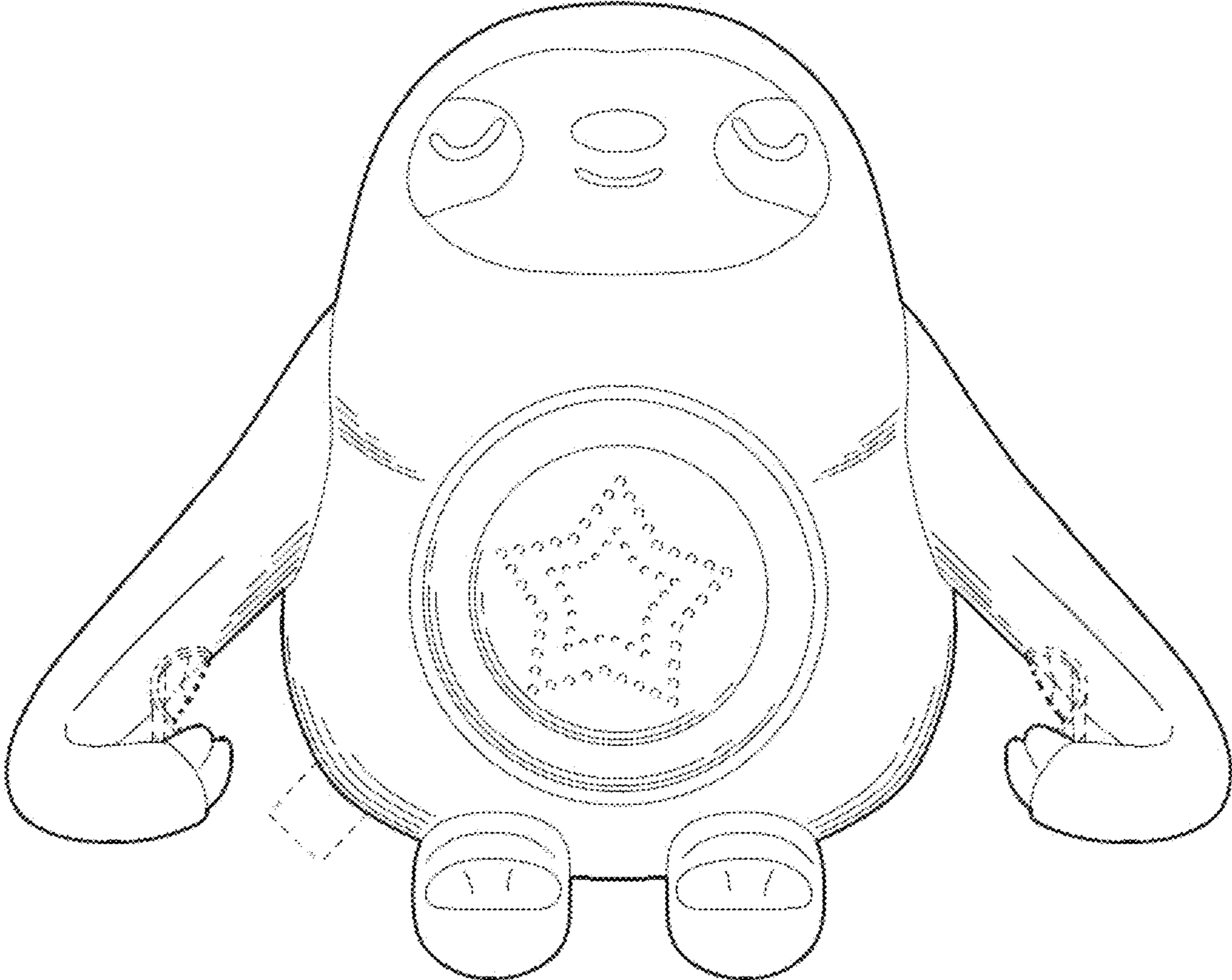

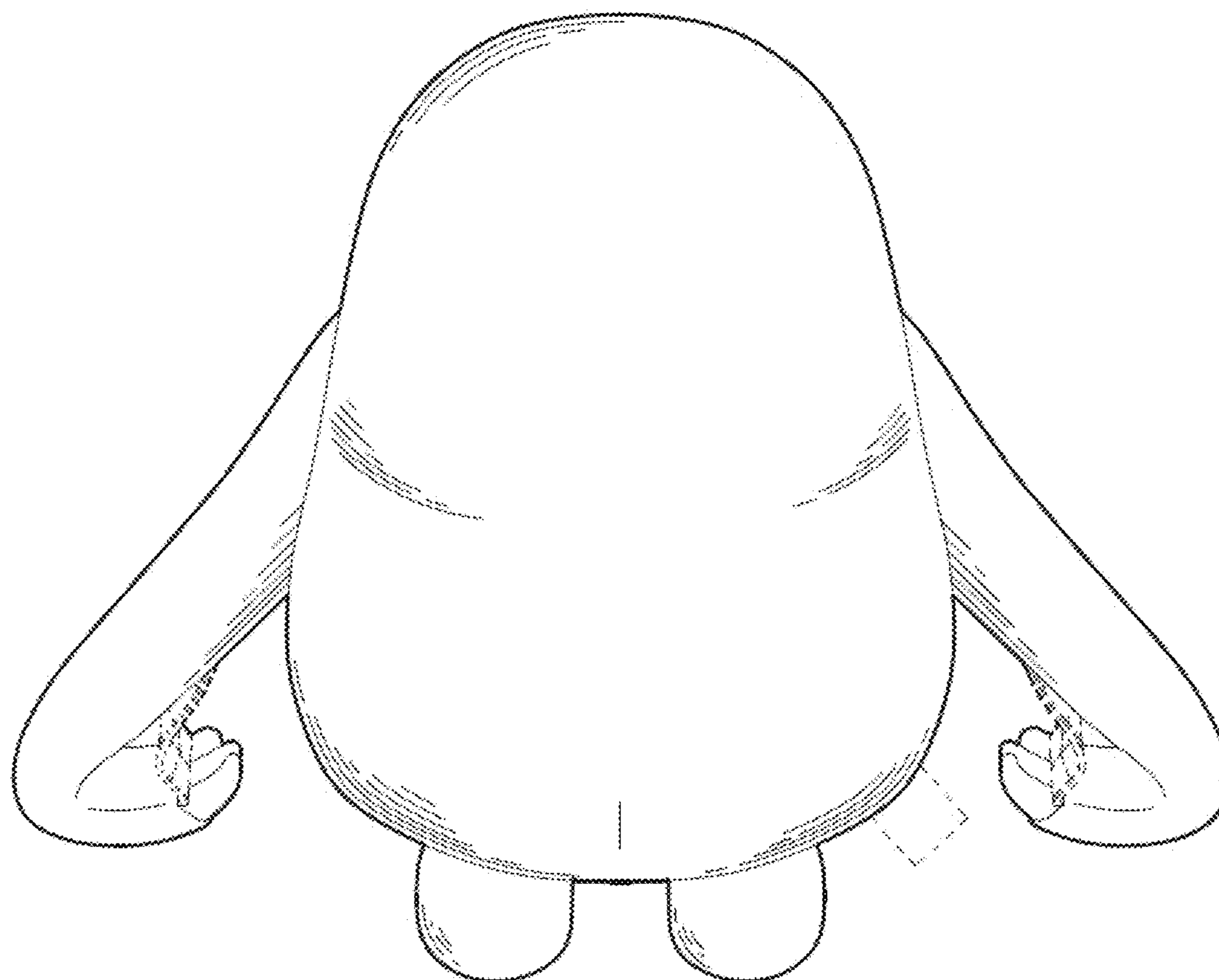

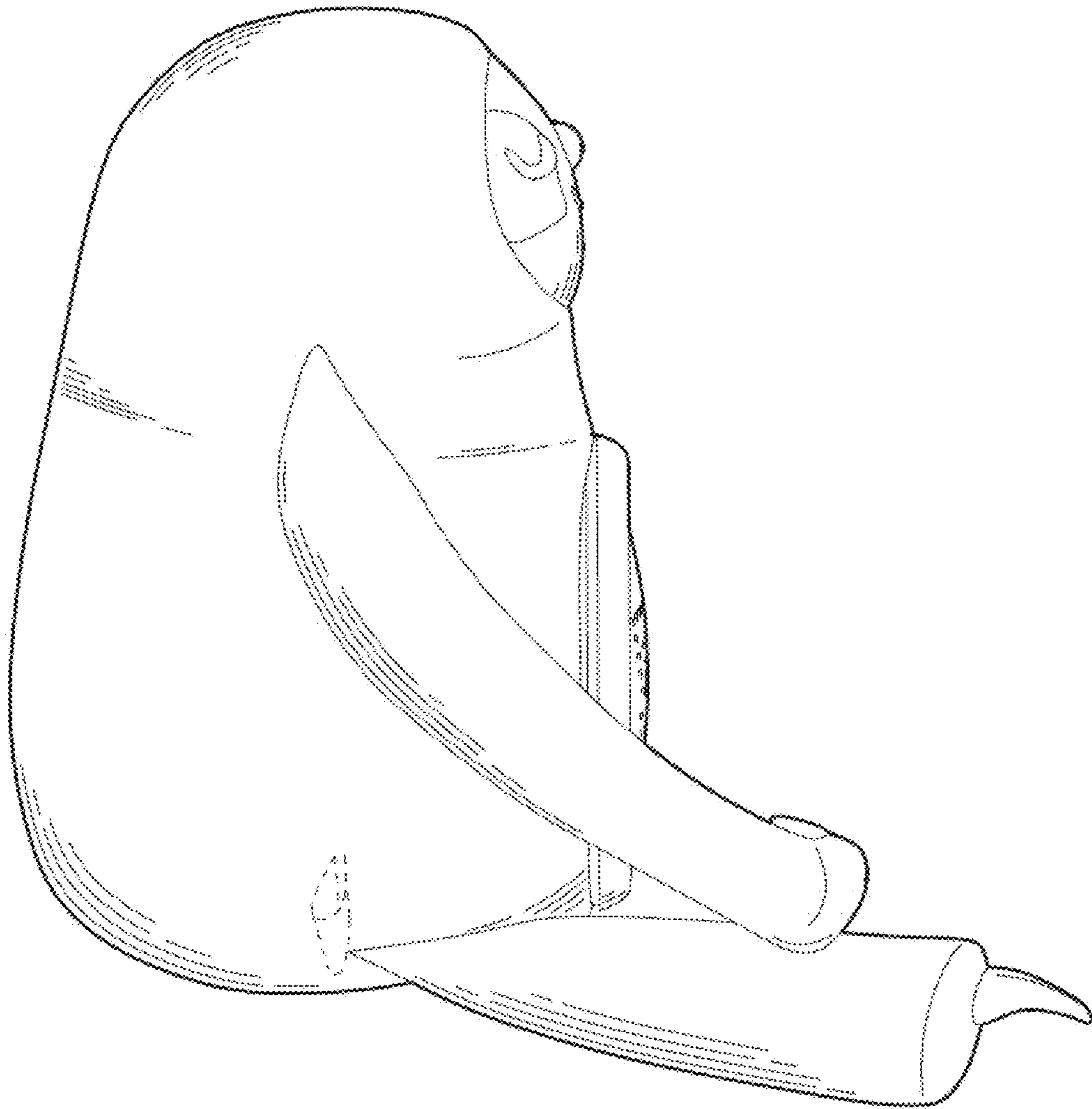

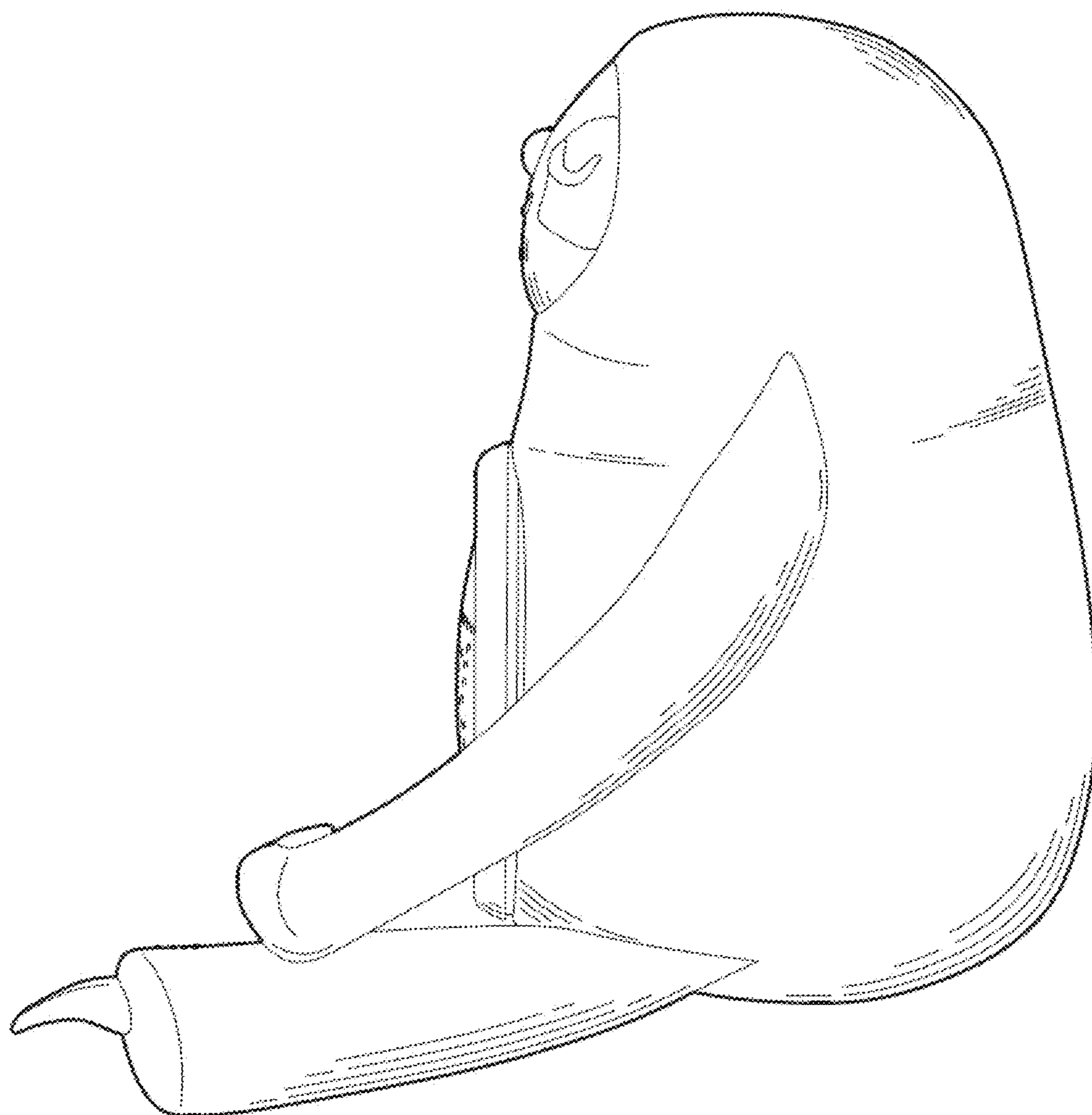

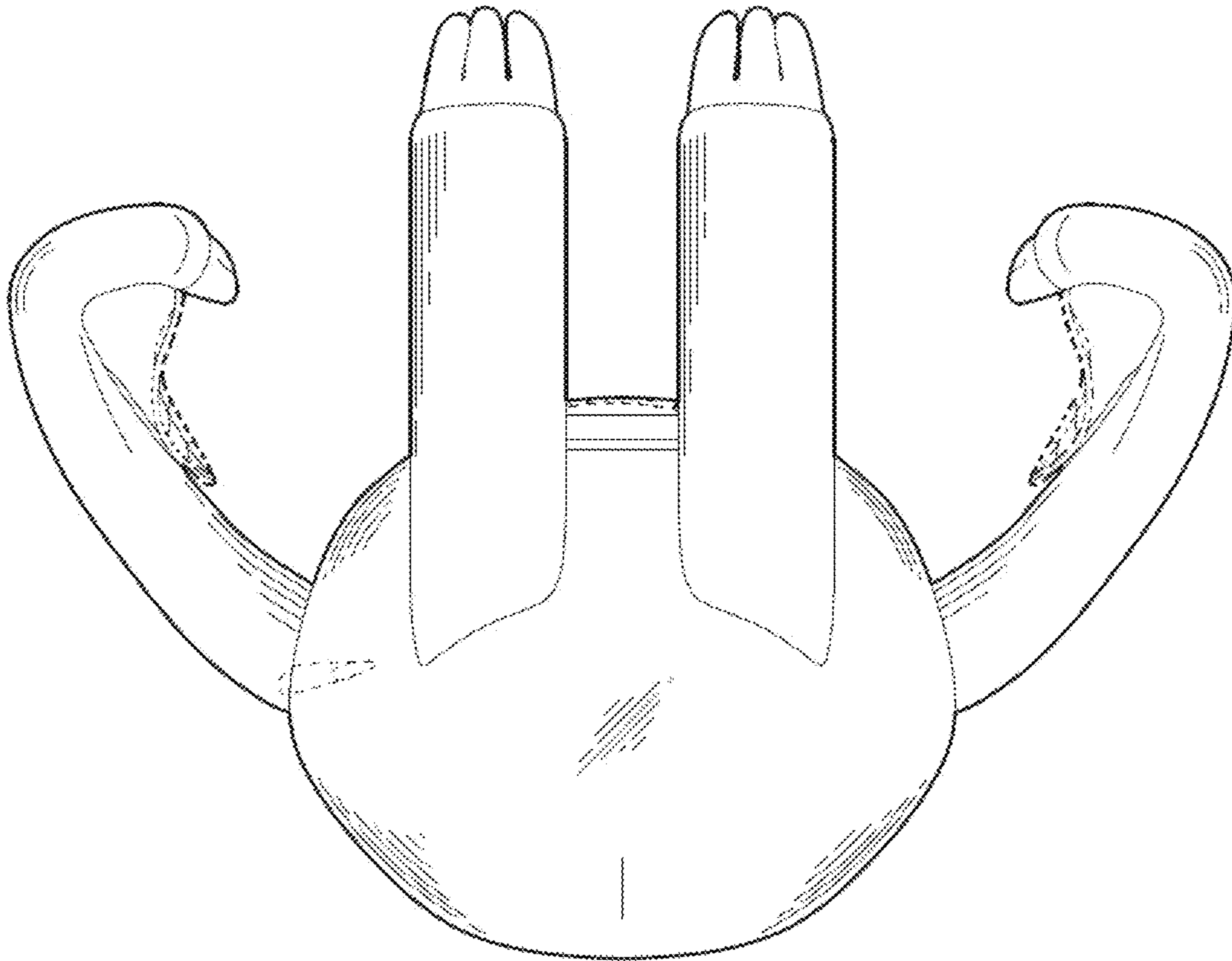

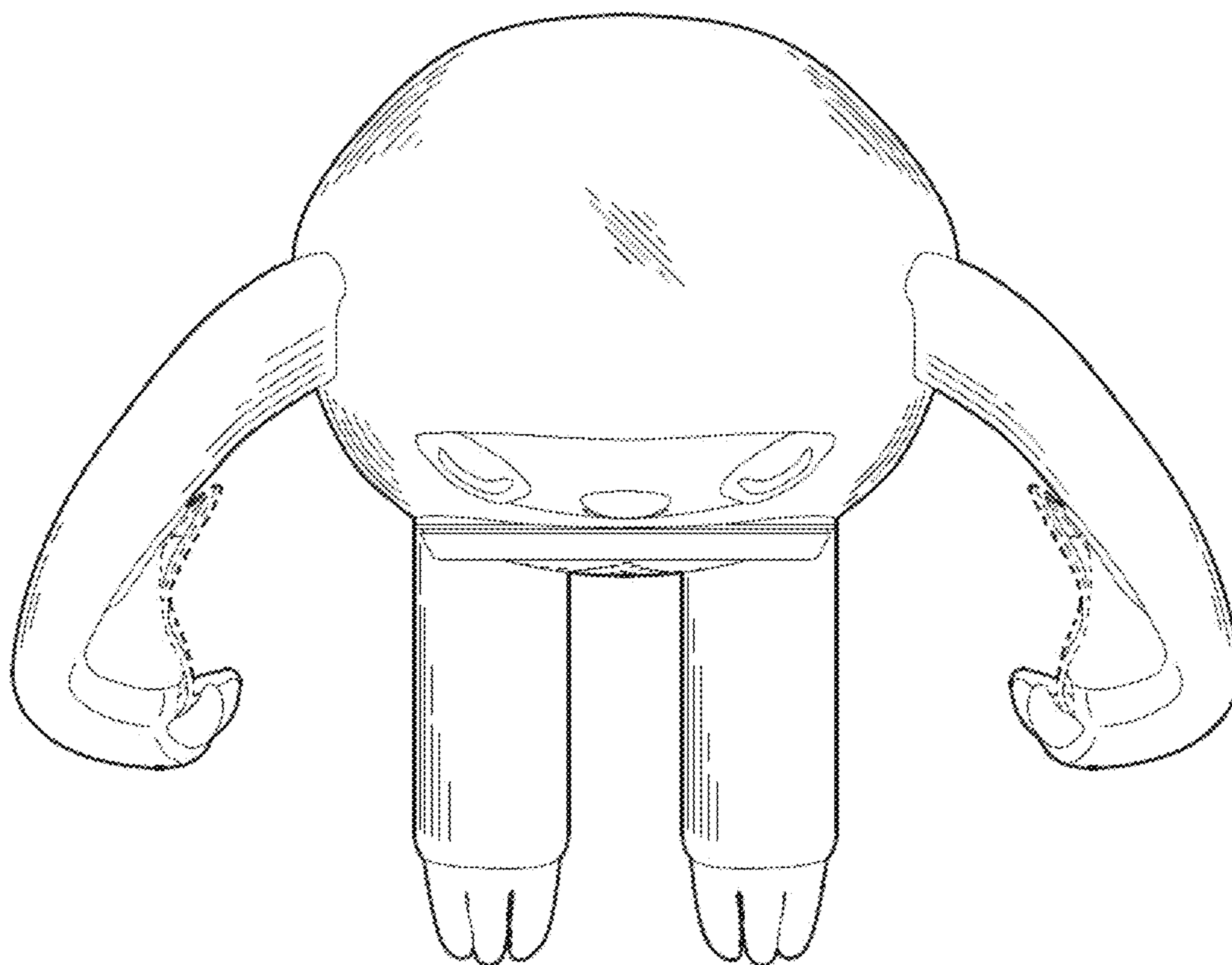

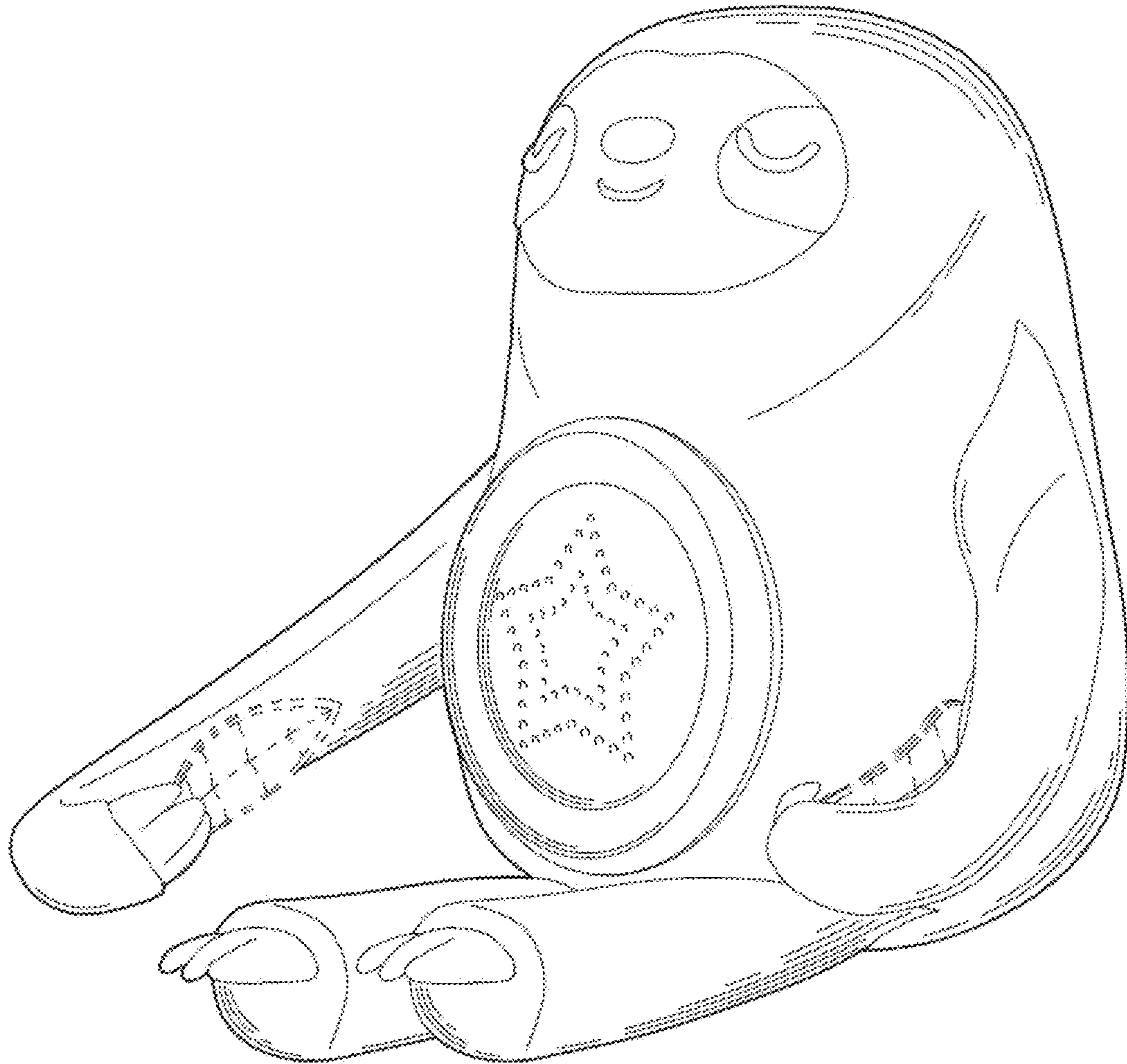
