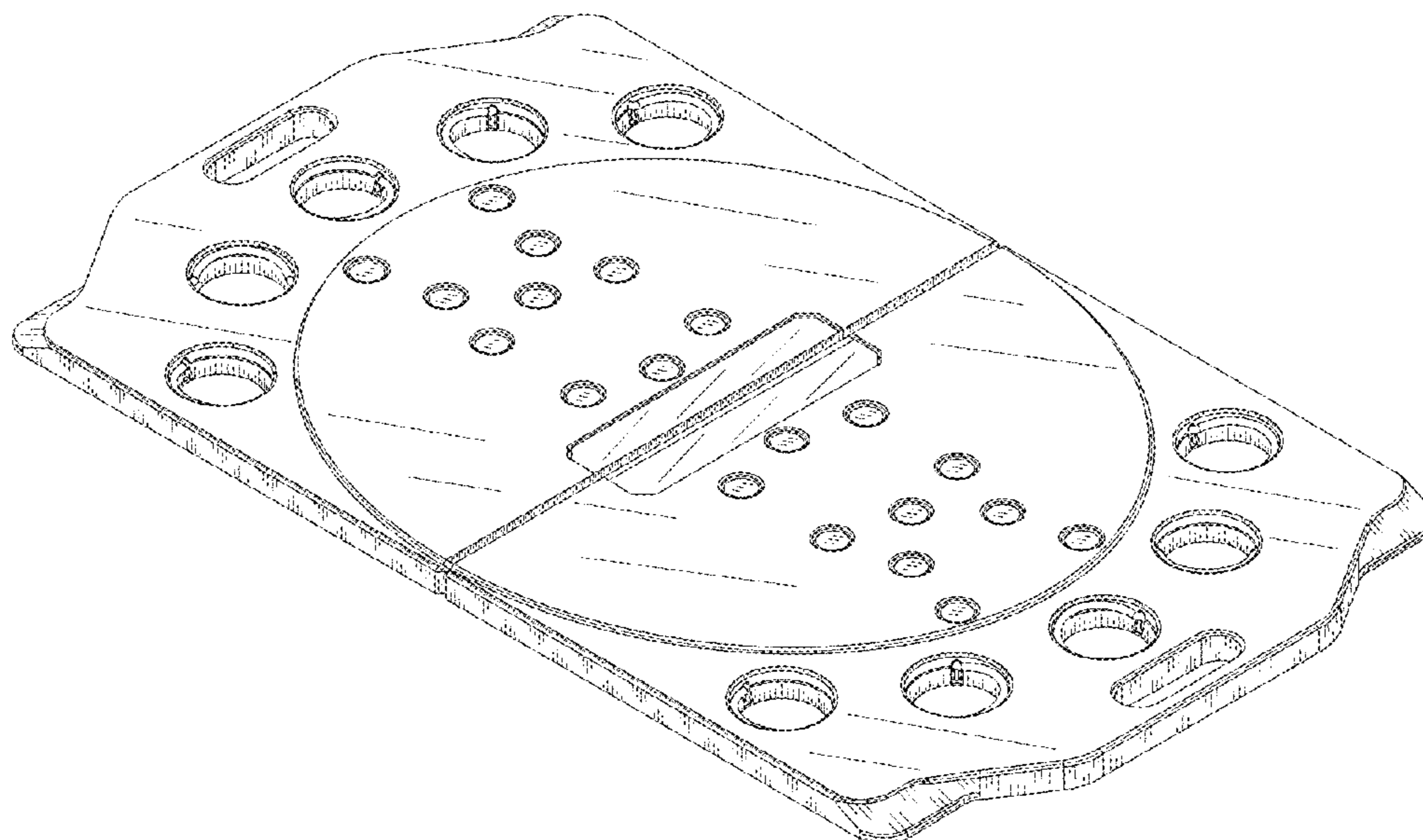
The ornamental design for a portable multifunctional fitness board, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portable multifunctional fitness board showing the new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

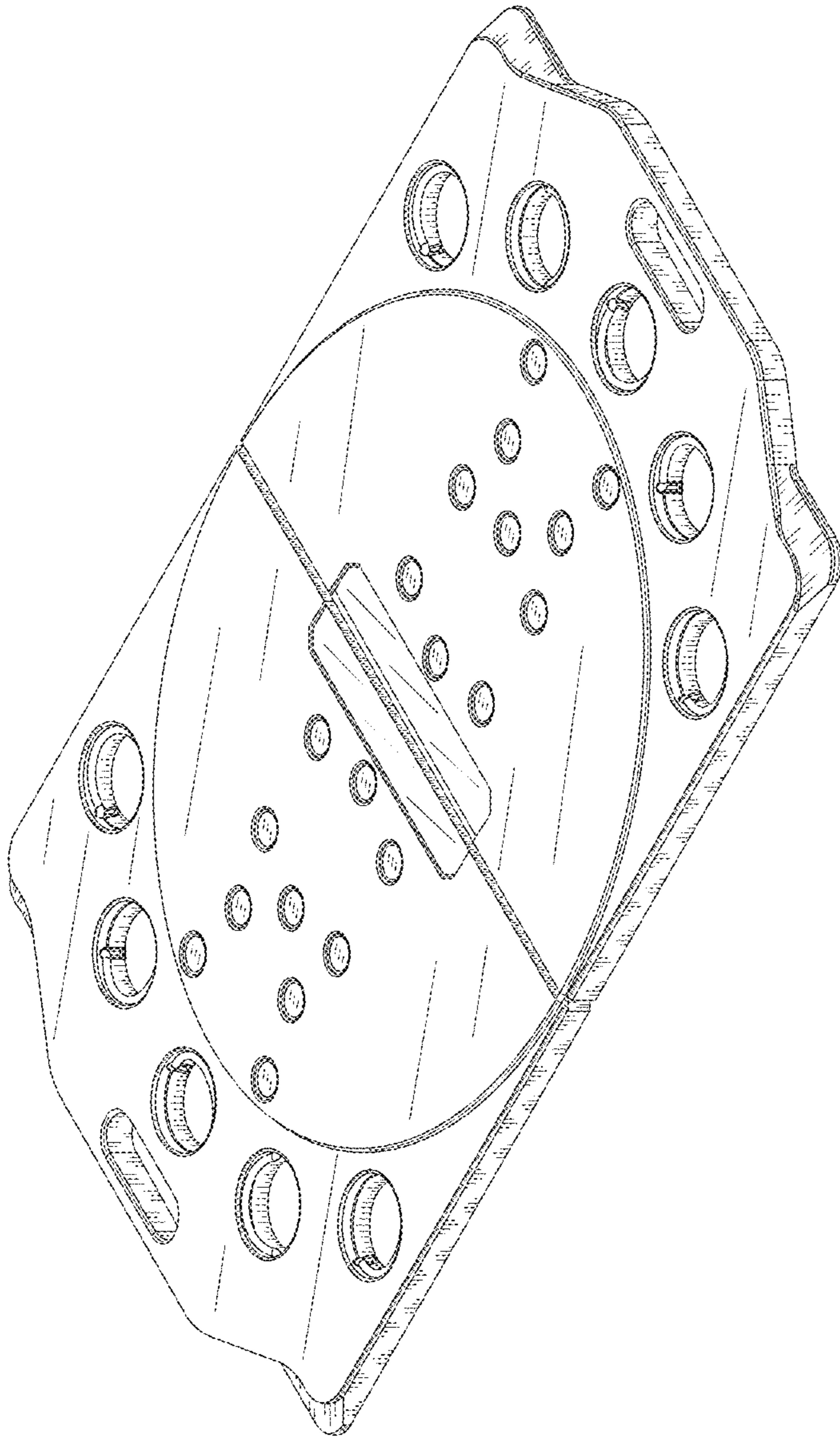

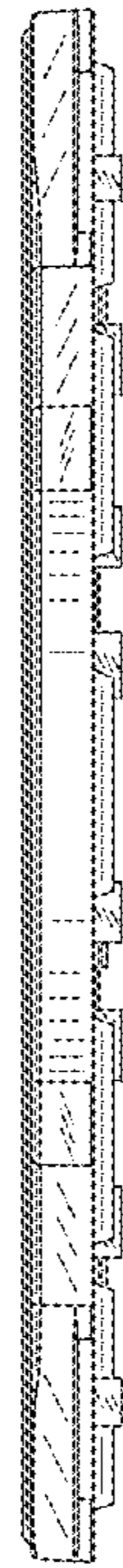

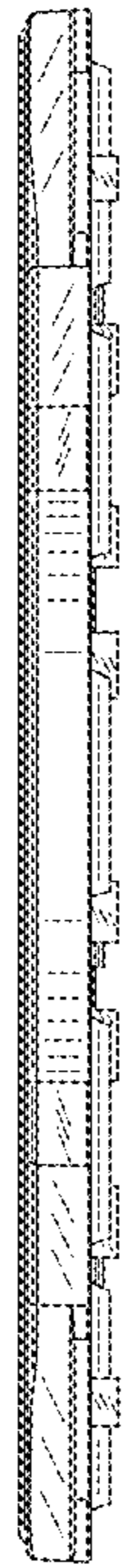

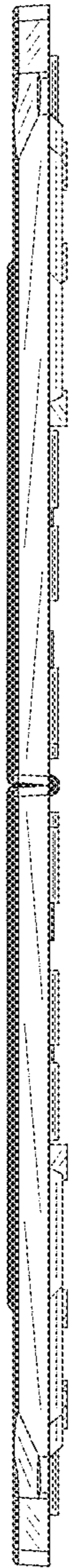

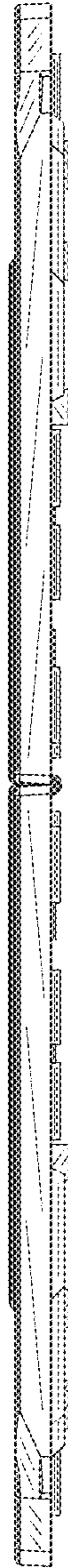

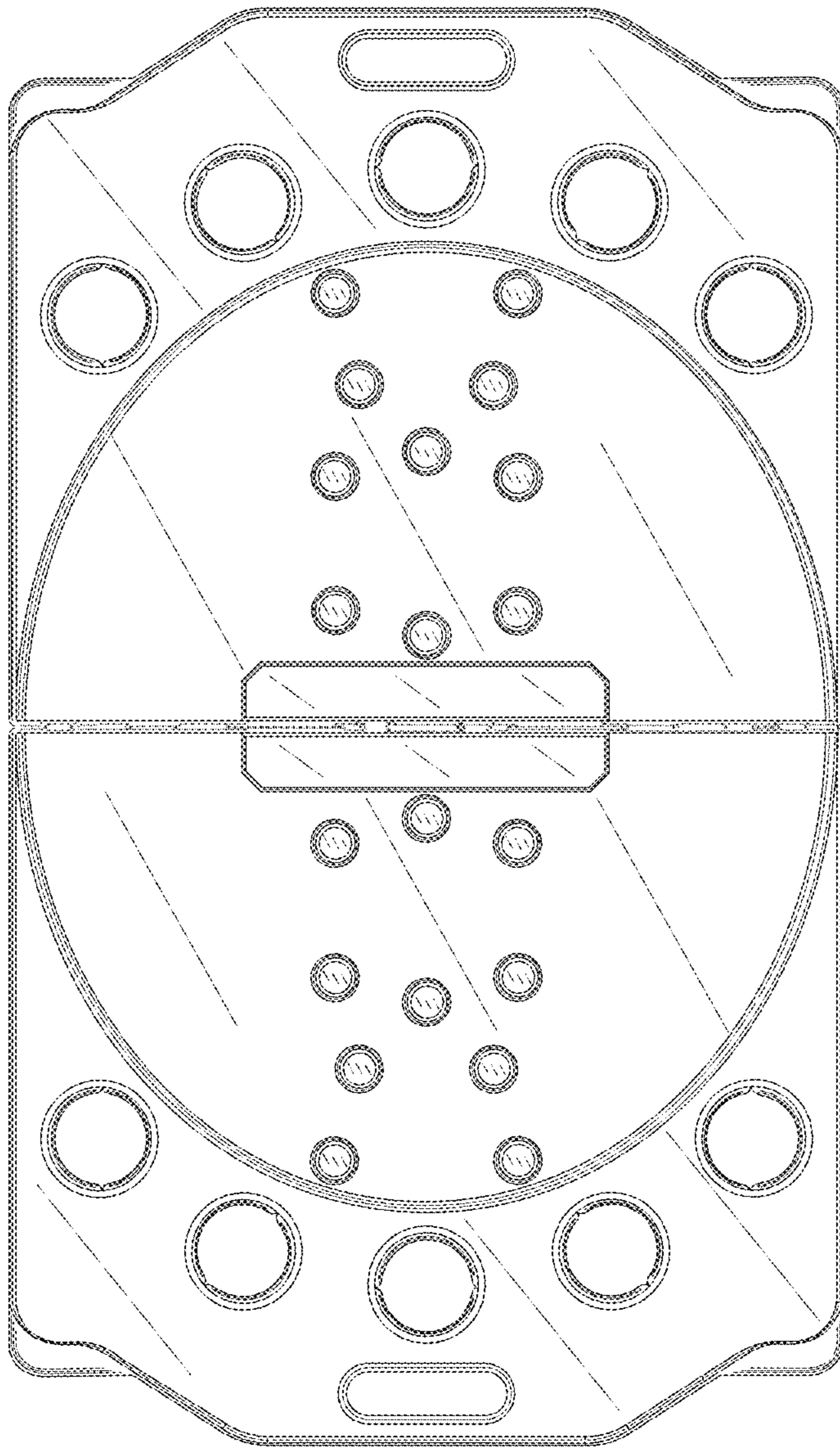

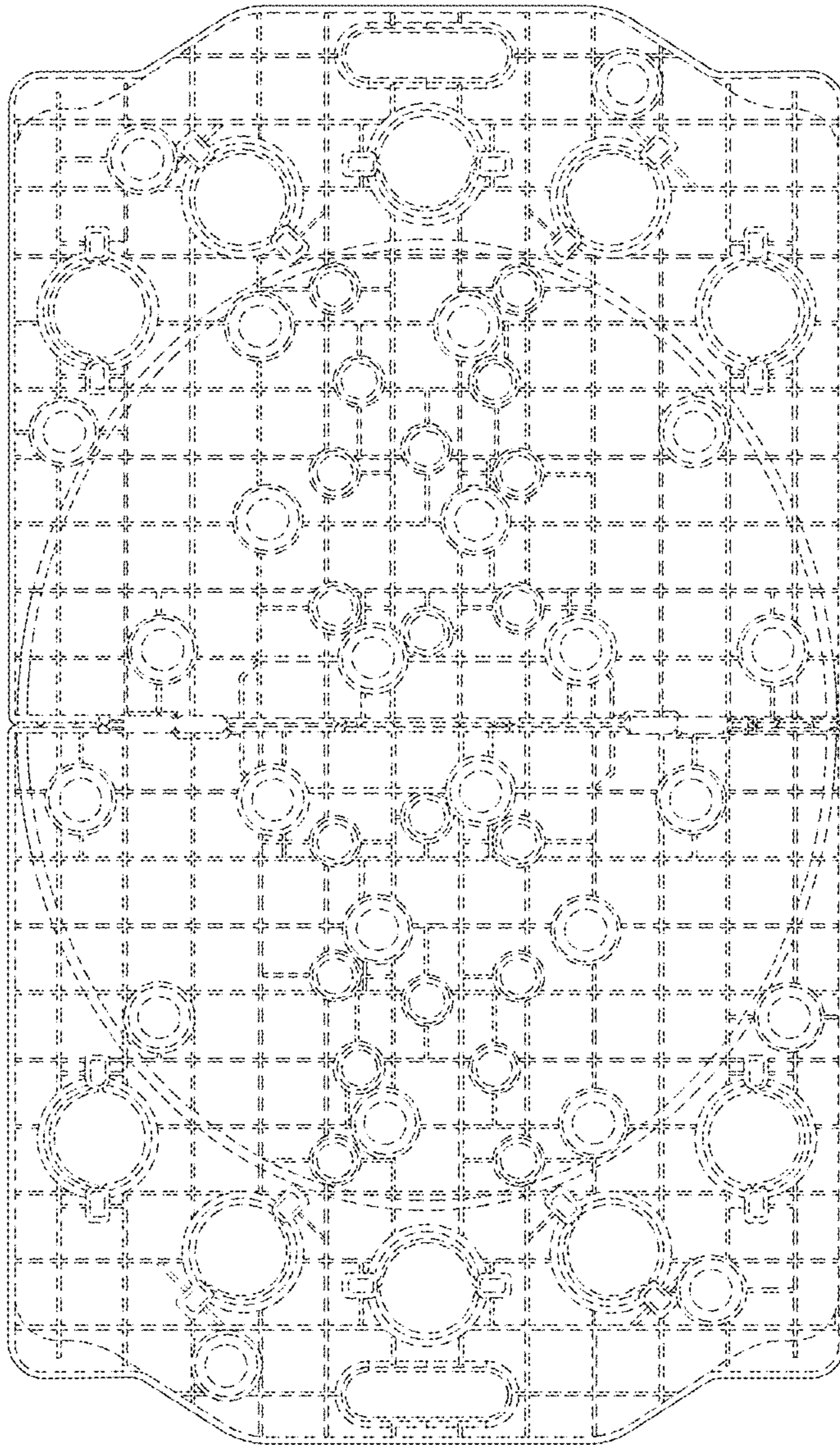
