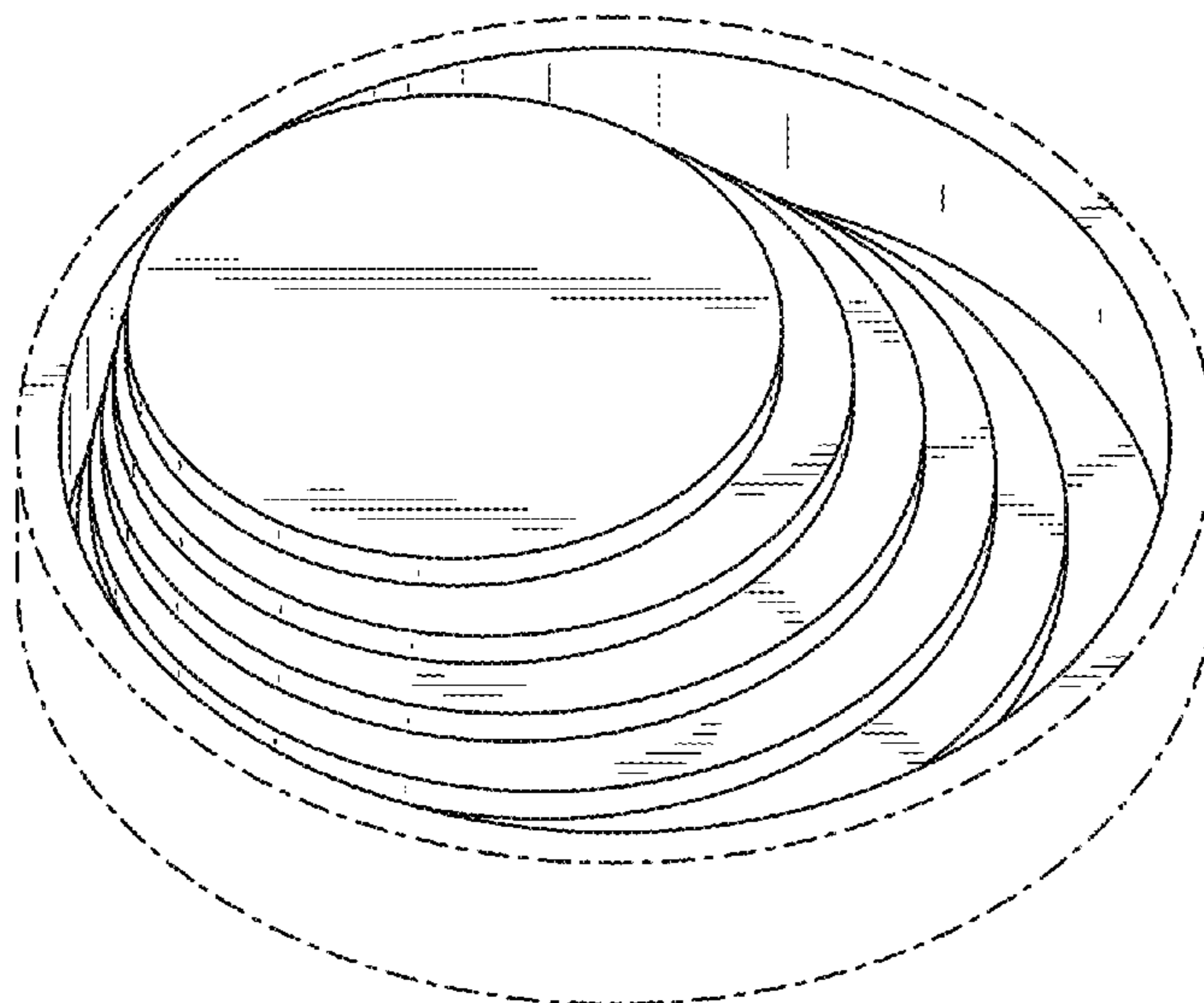

**DESCRIPTION**

FIG. 1 is a top perspective view of a first embodiment of the water feature showing my new design;  
FIG. 2 is a front elevation view thereof, the left side elevation view, right side elevation view and rear elevation view being an identical image thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a top perspective view thereof, similar to FIG. 1, showing the invention filled with water; and,  
FIG. 6 is a top perspective view thereof, similar to FIG. 5, showing the invention partially filled with water.  
The dash-dot-dash lines shown in the drawings illustrate a boundary that forms no part of the claimed design.

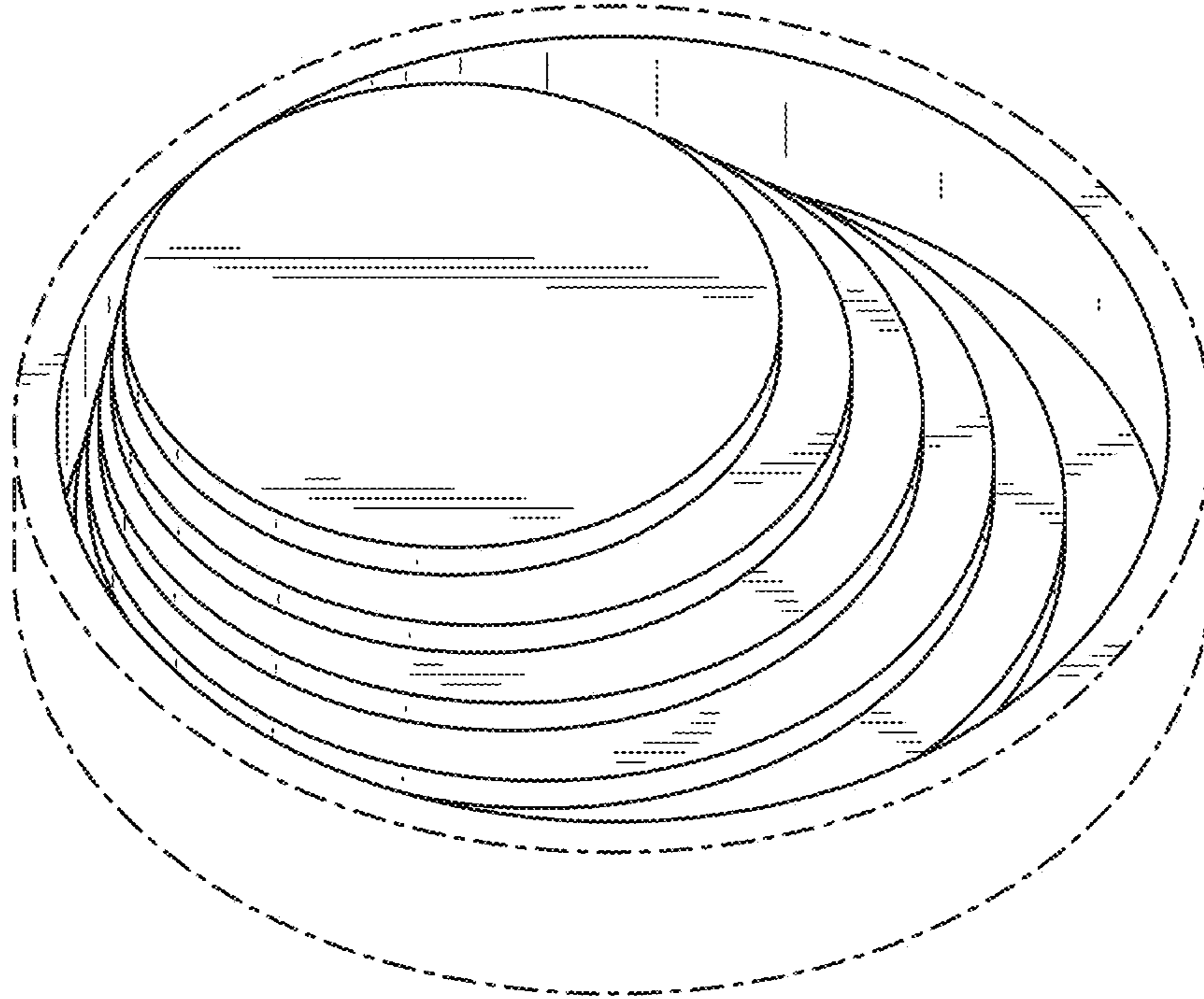

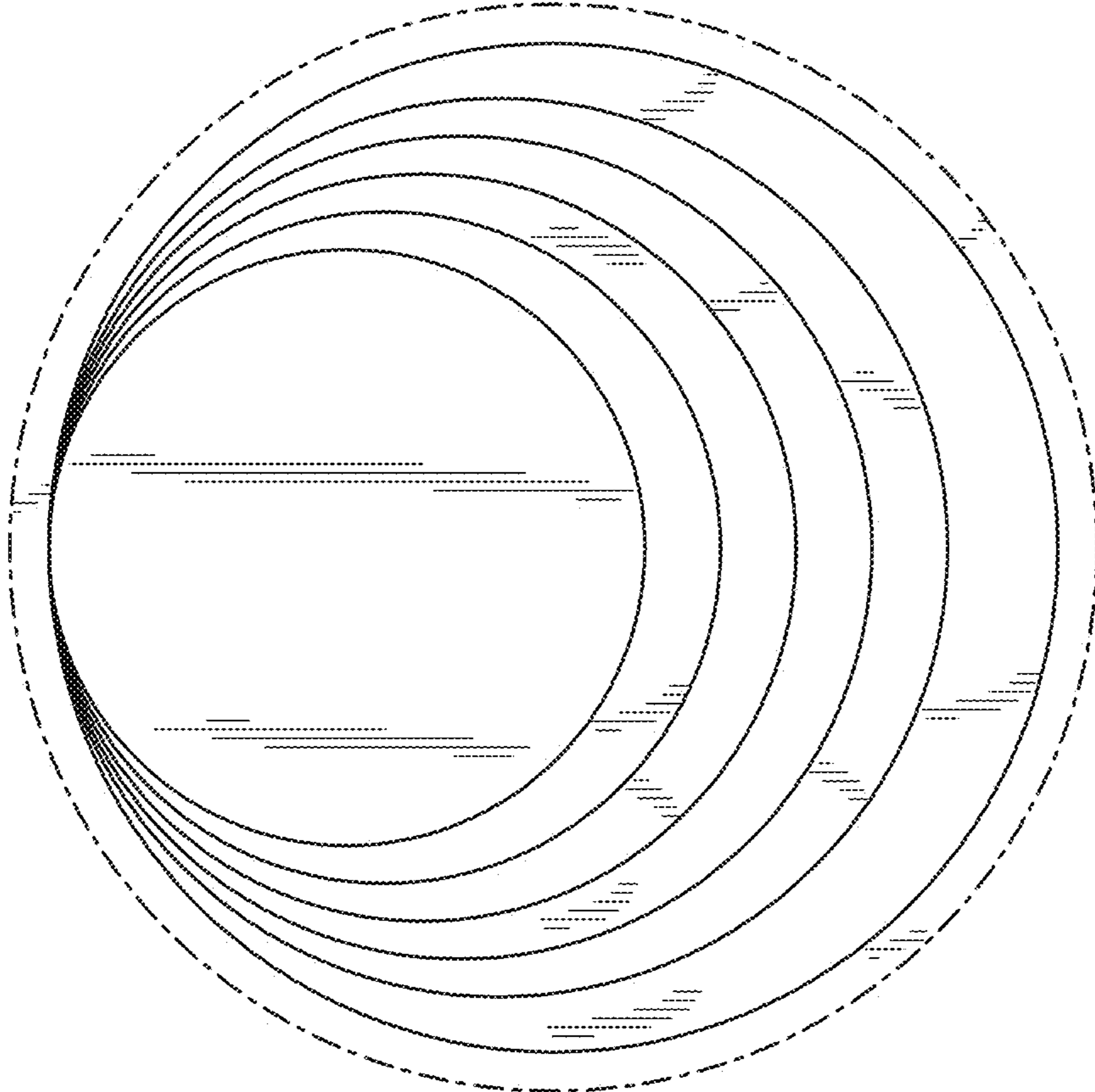

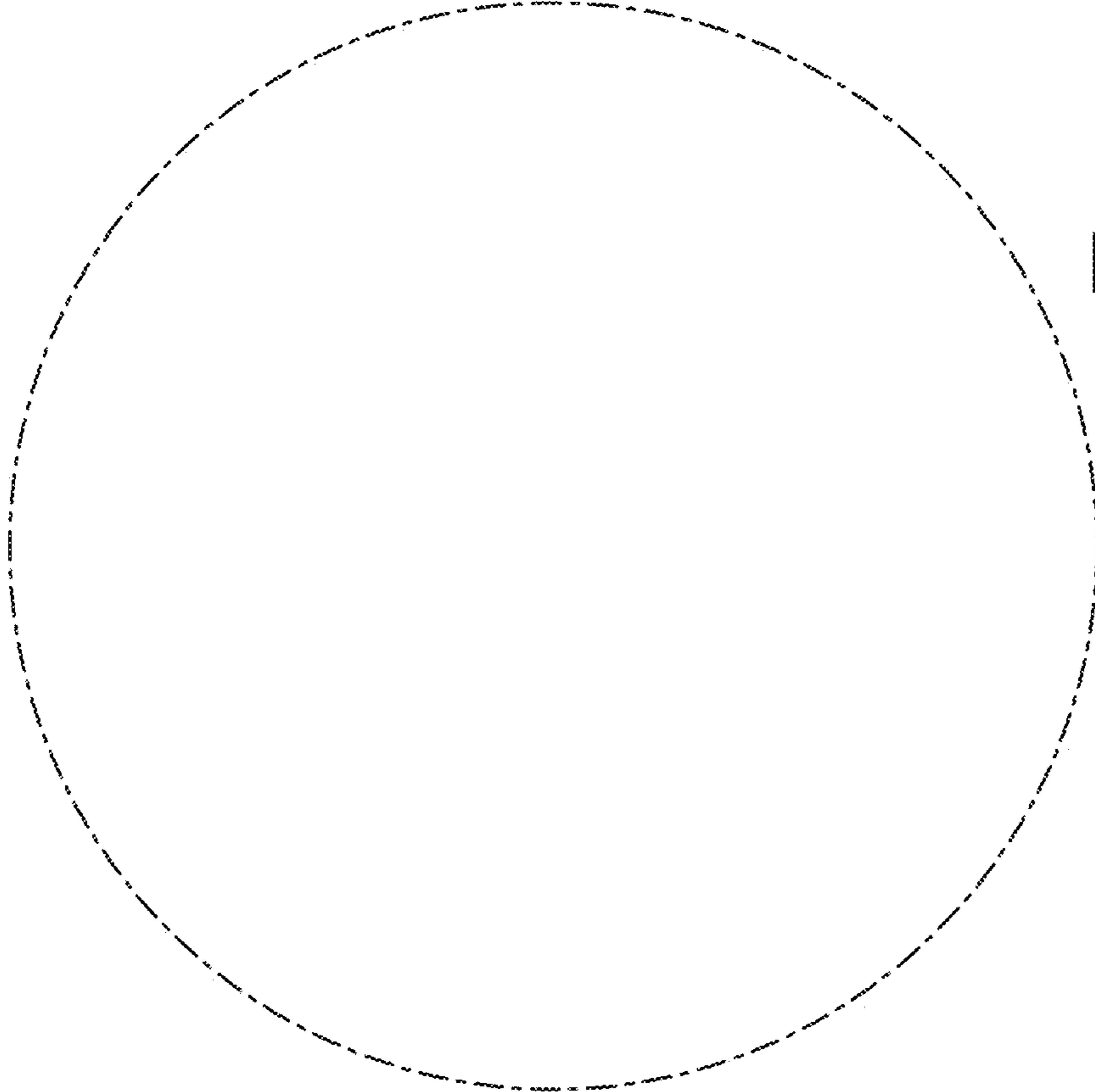

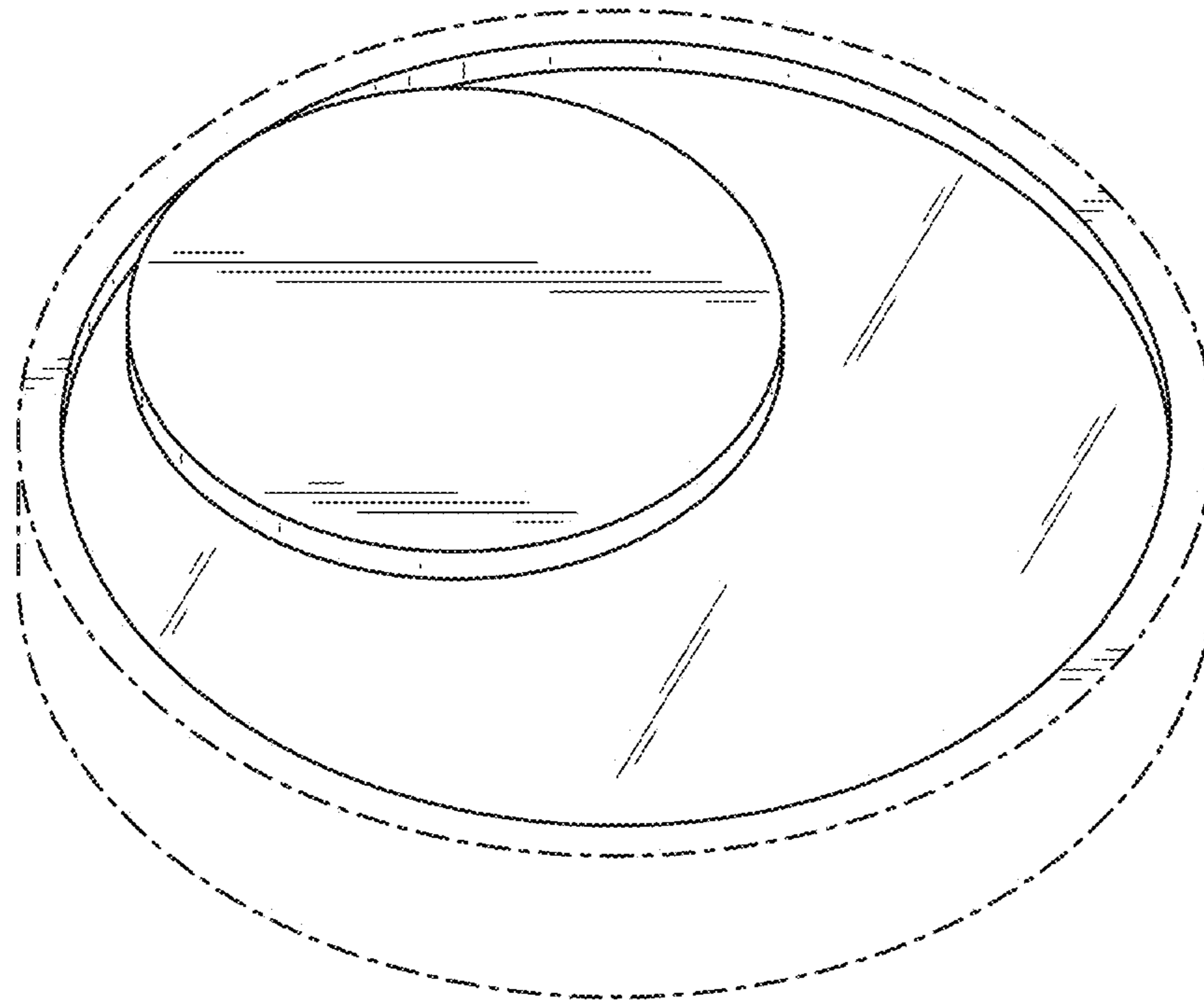

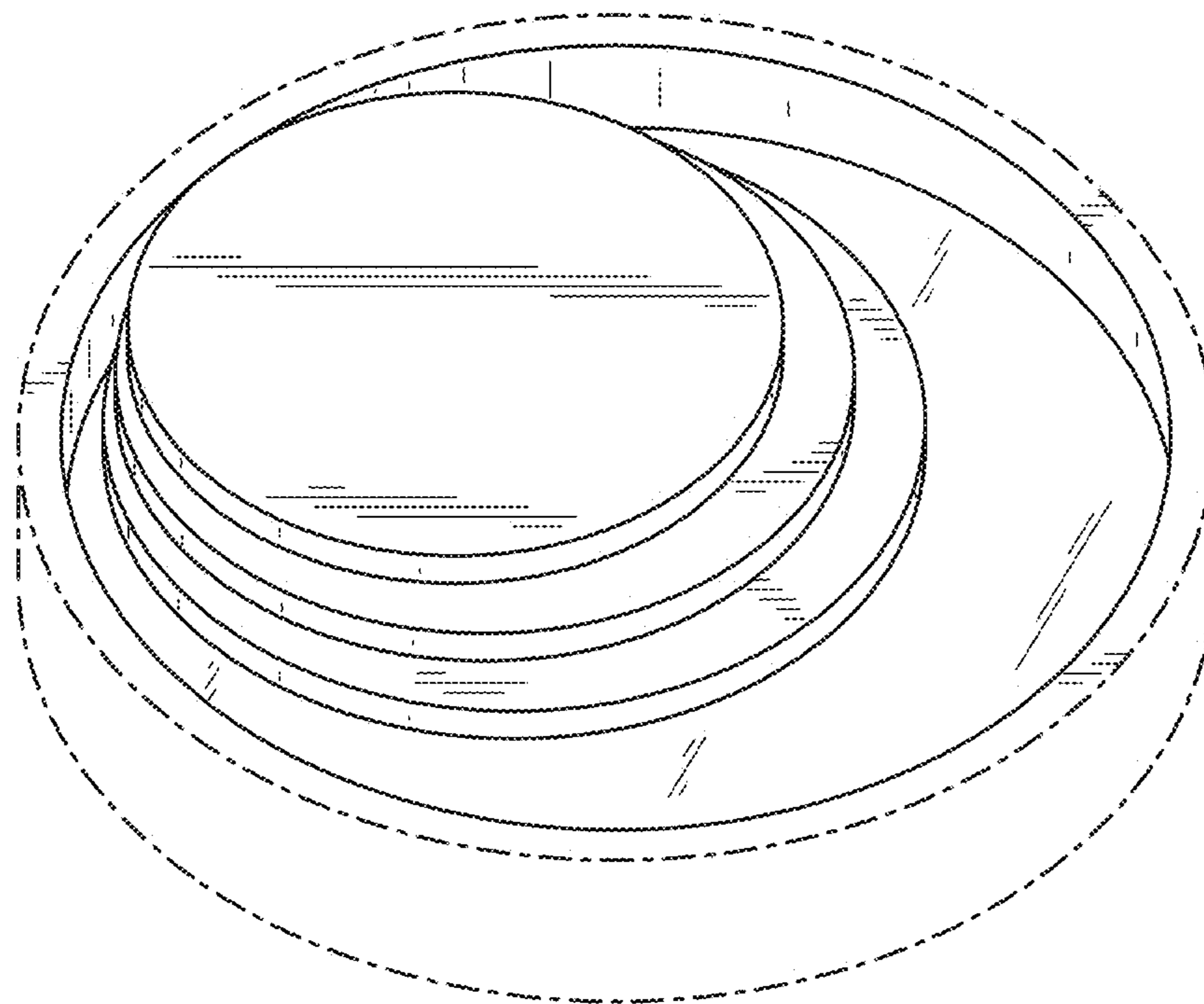
