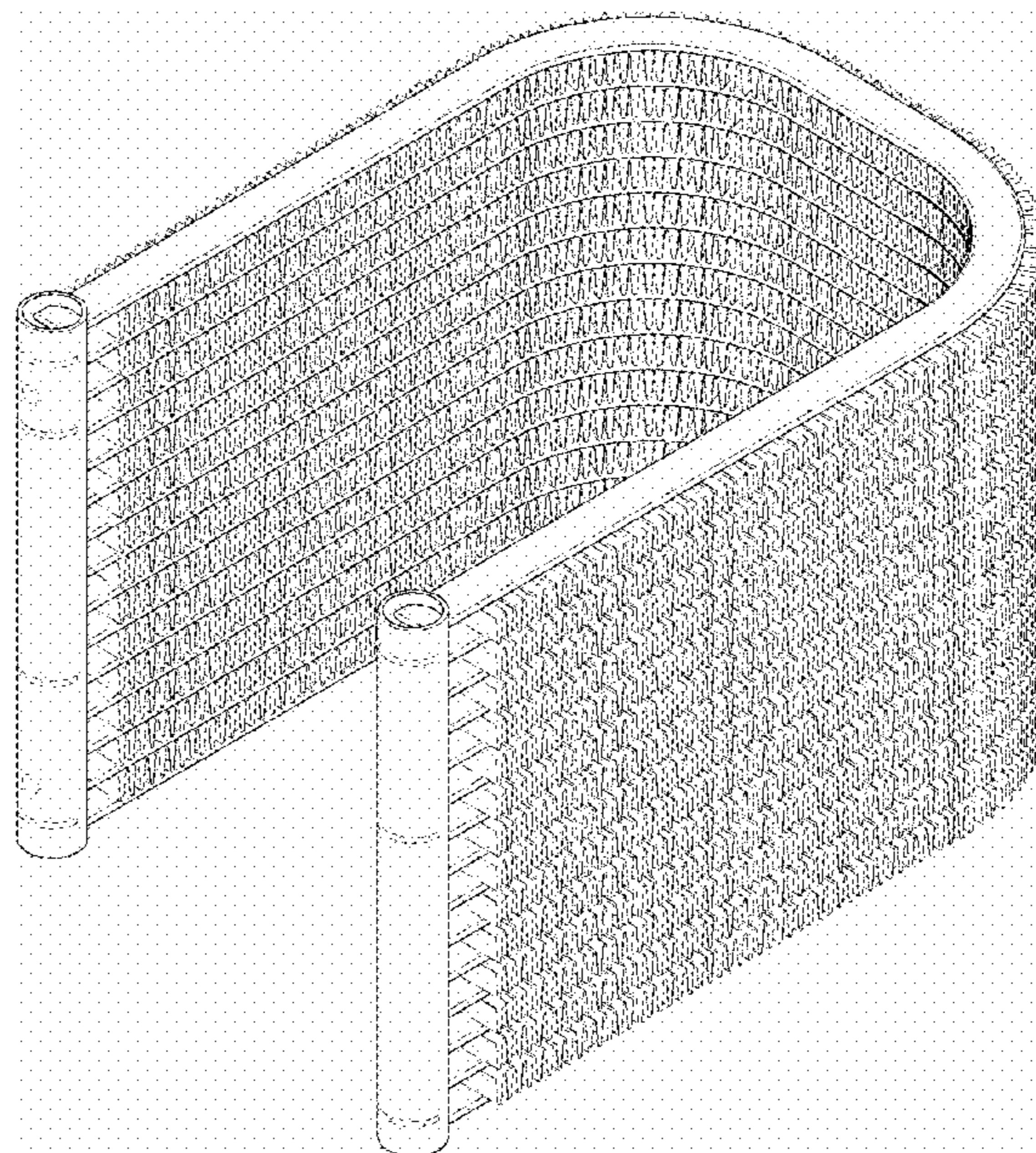
The ornamental design for a condenser for heat exchanger,

DESCRIPTION

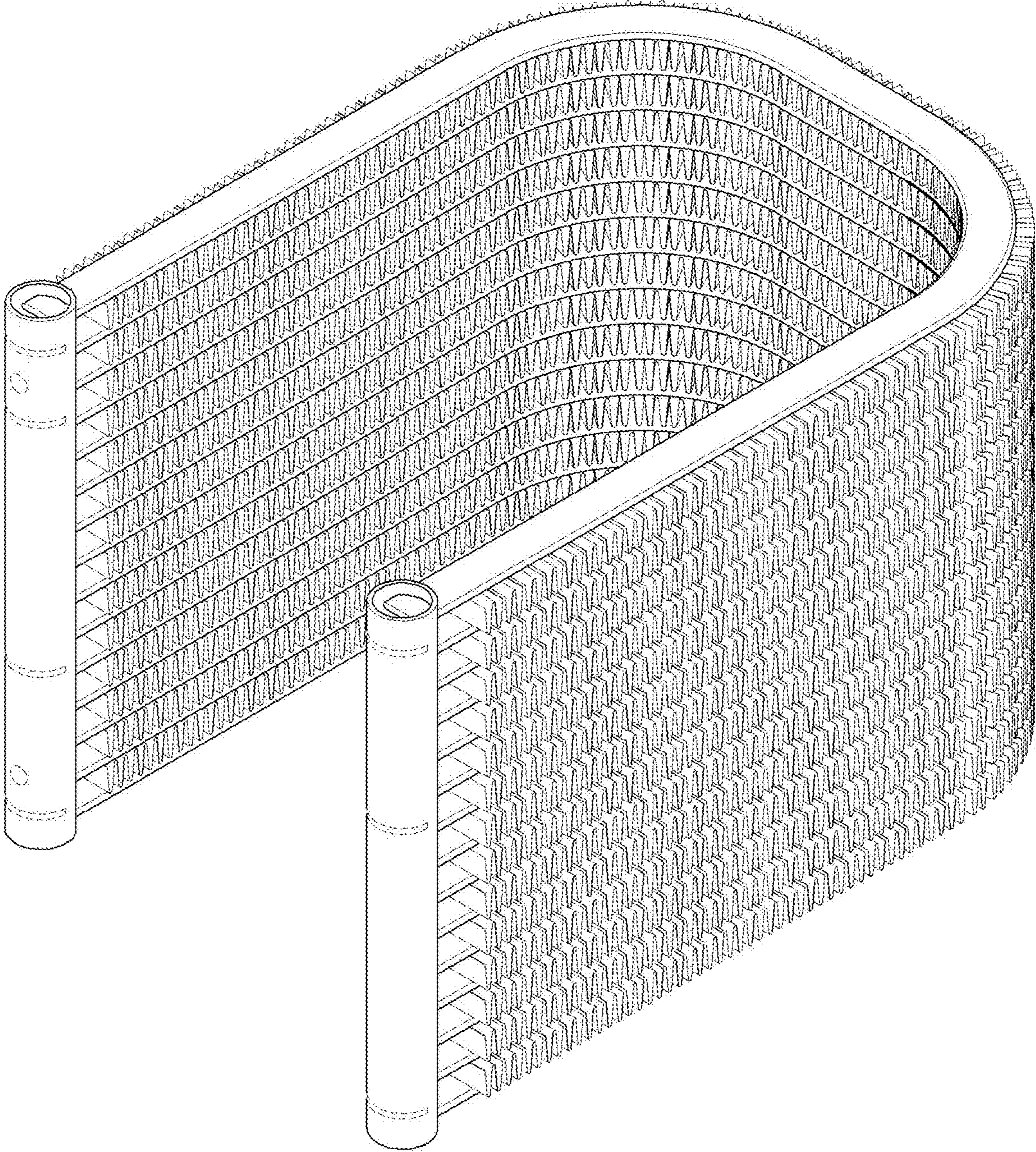
1. Condenser for heat exchanger

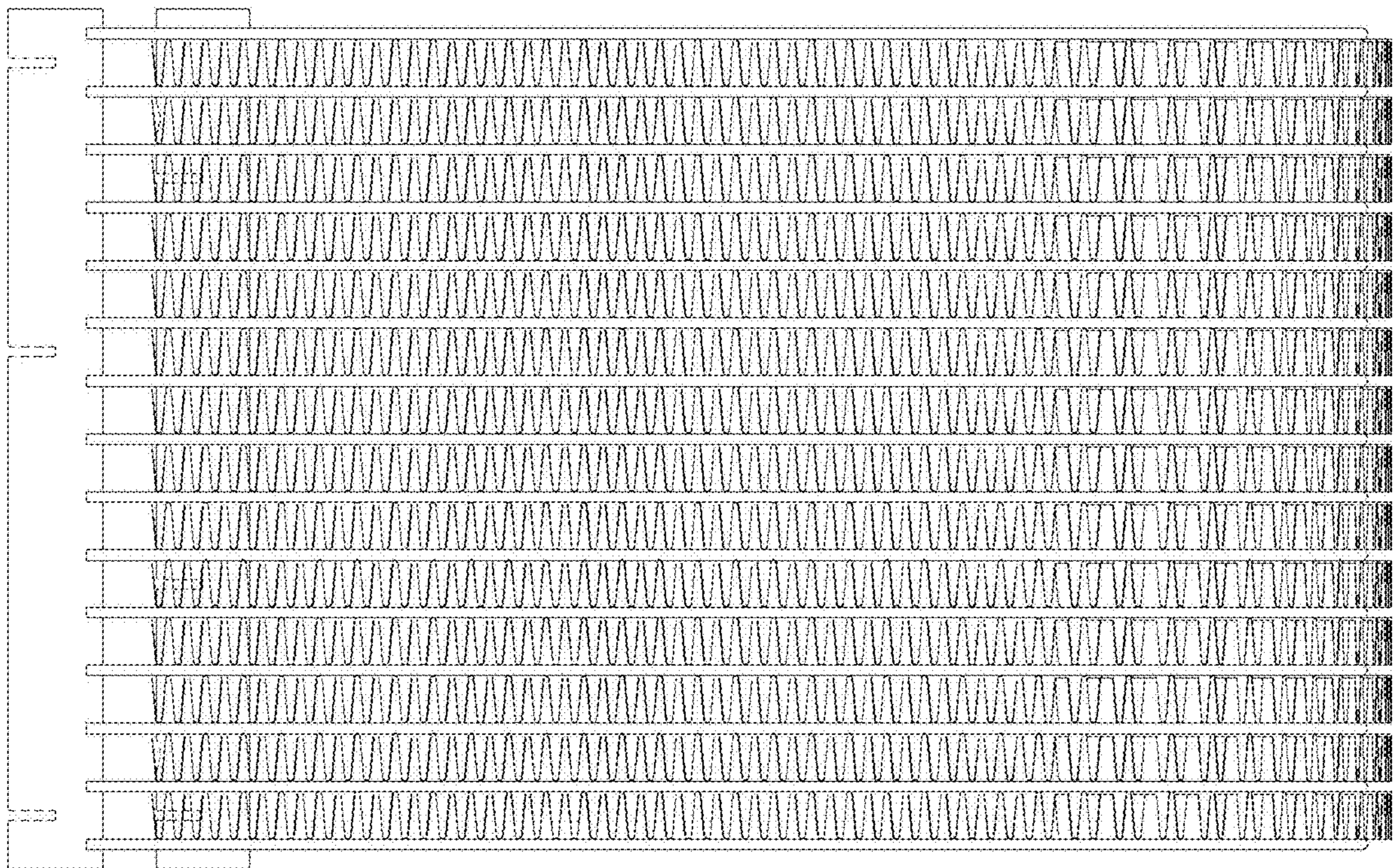

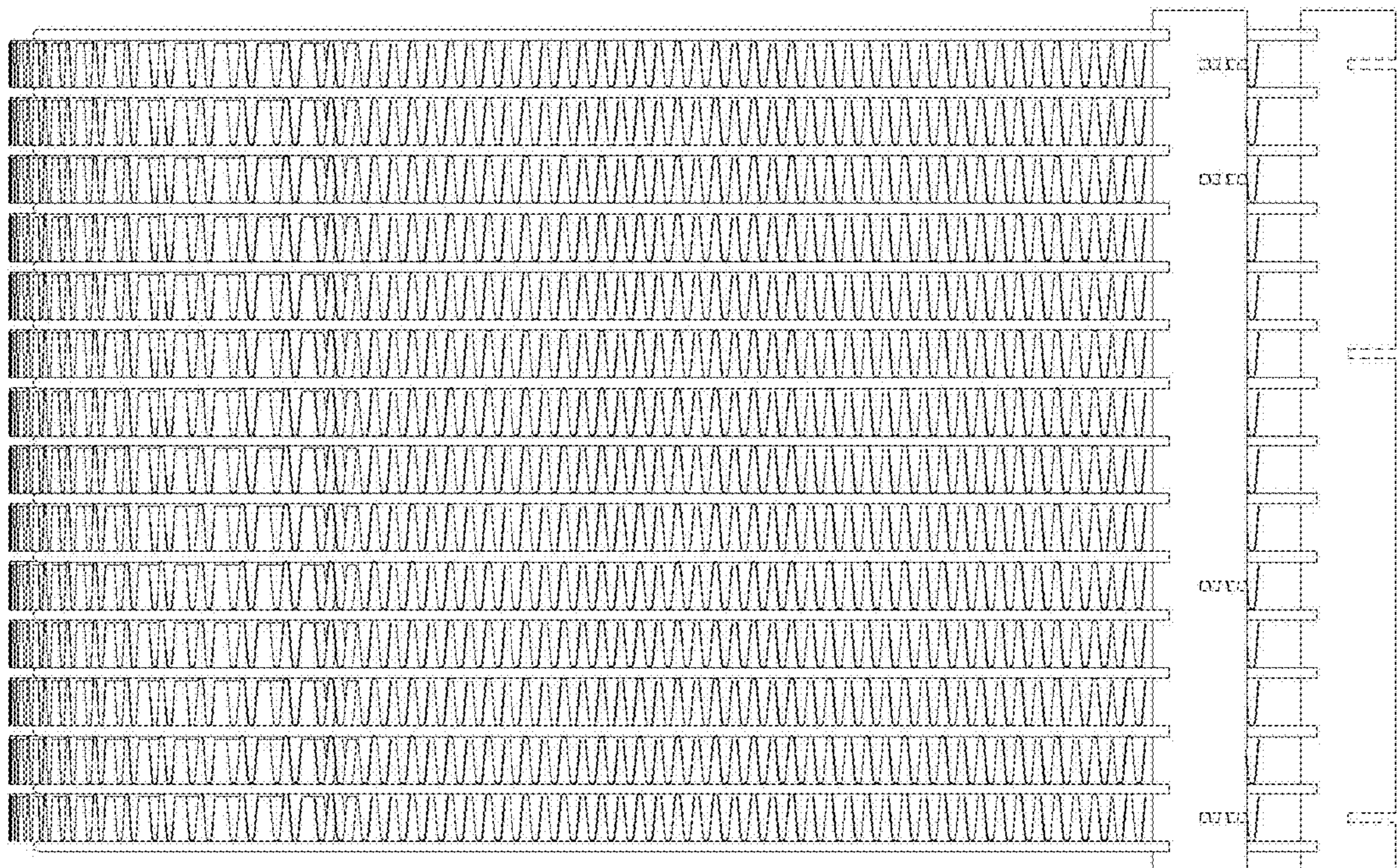

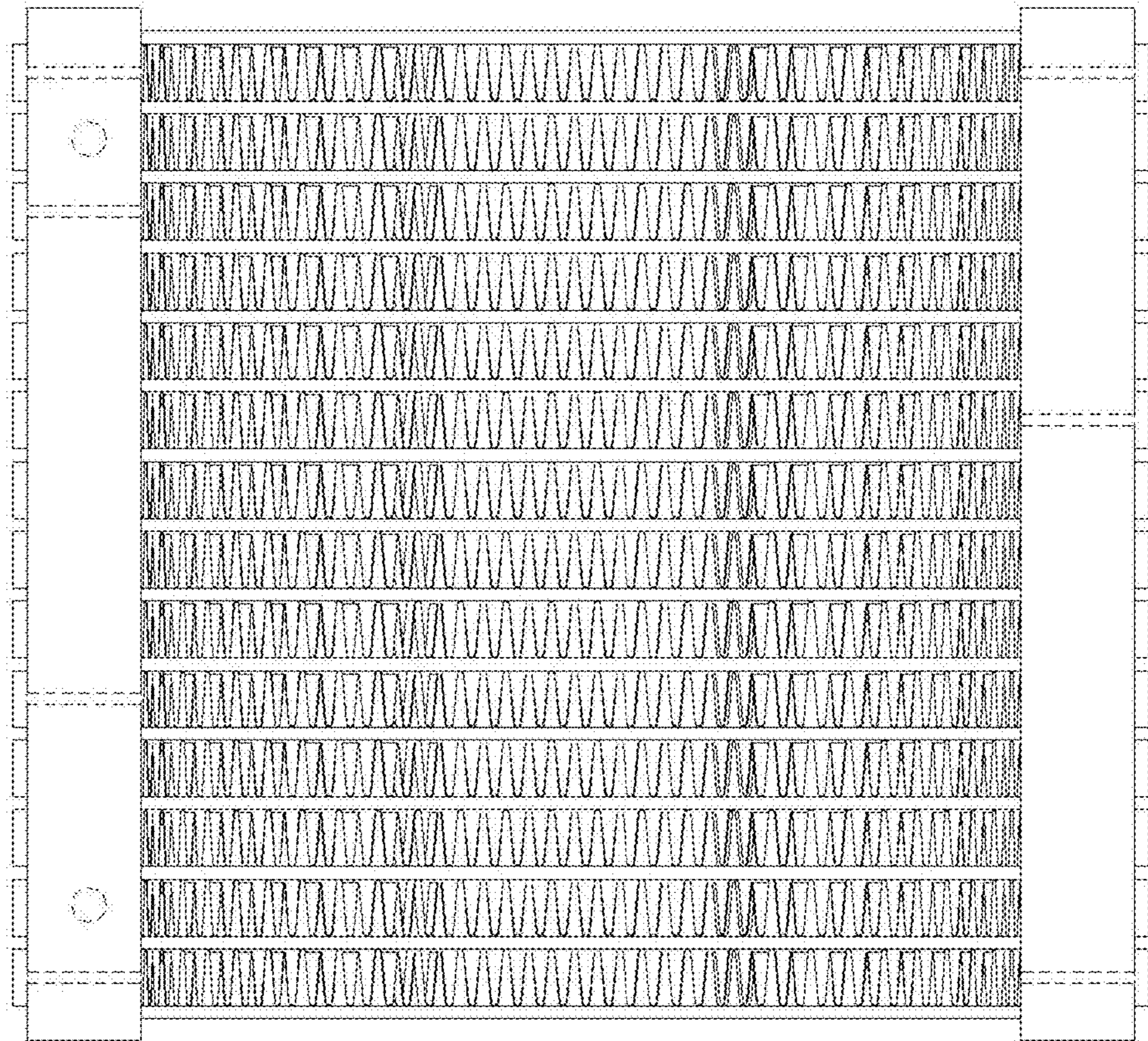

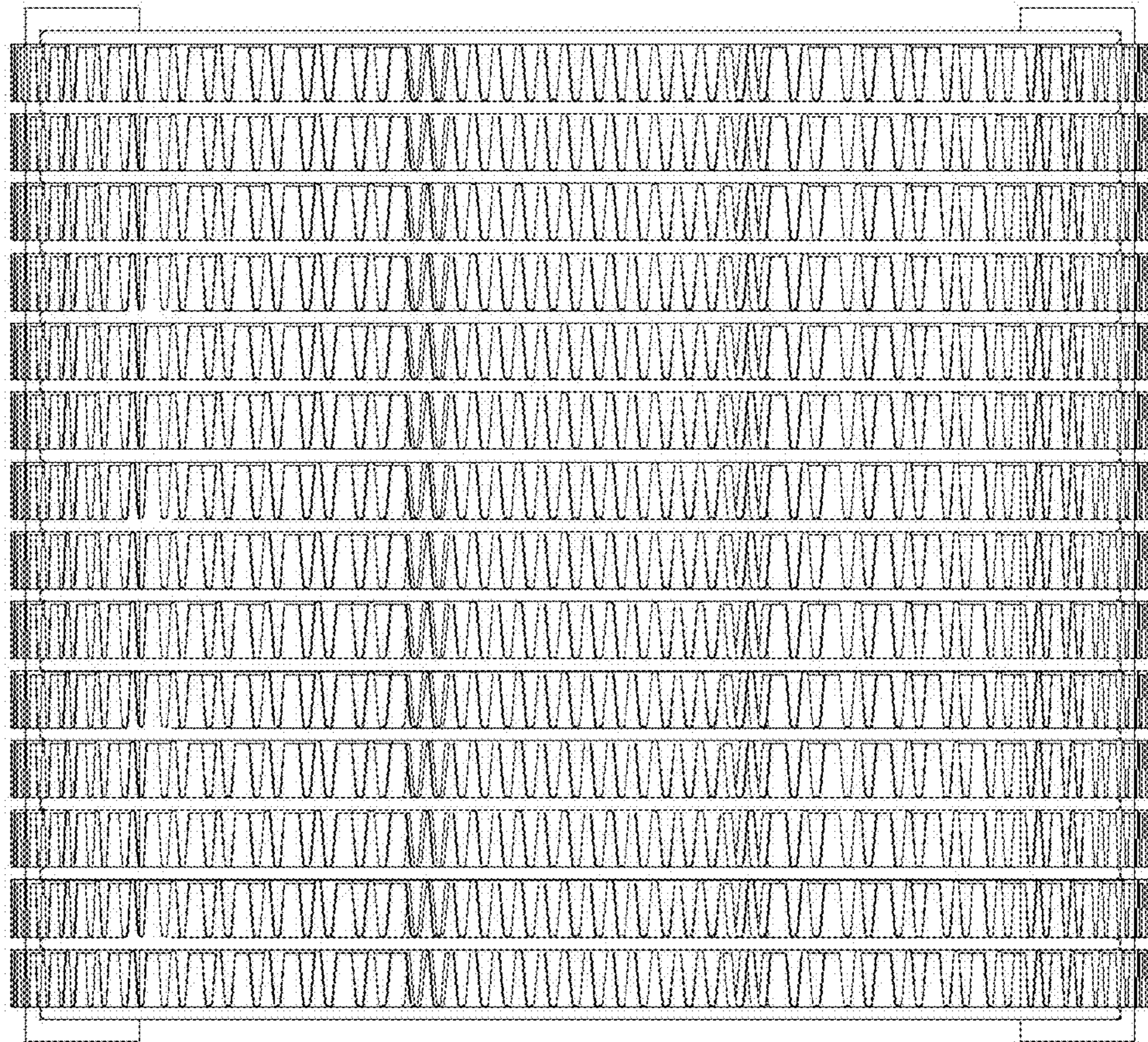
