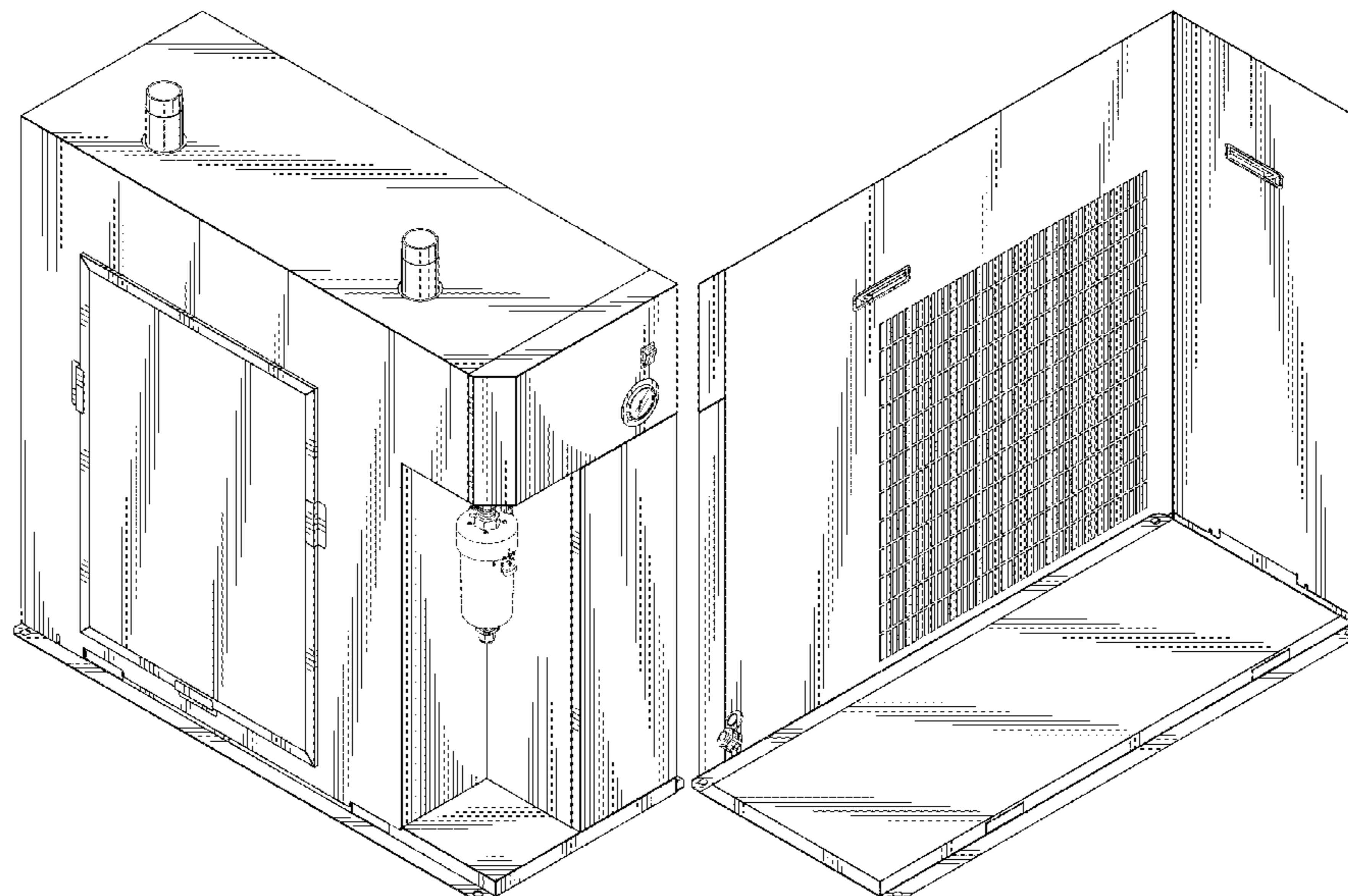
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top, and left side perspective view of an air dryer;

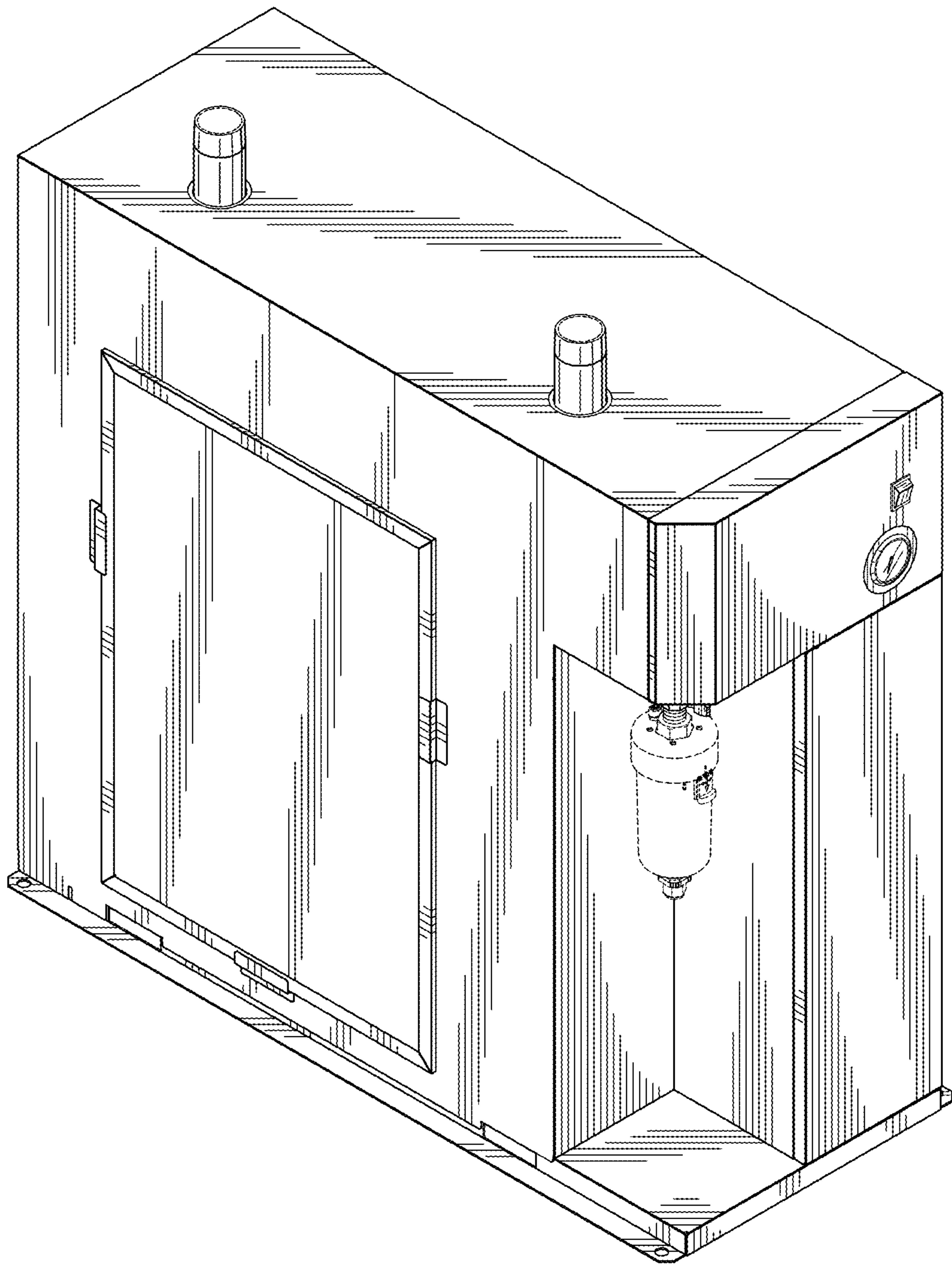

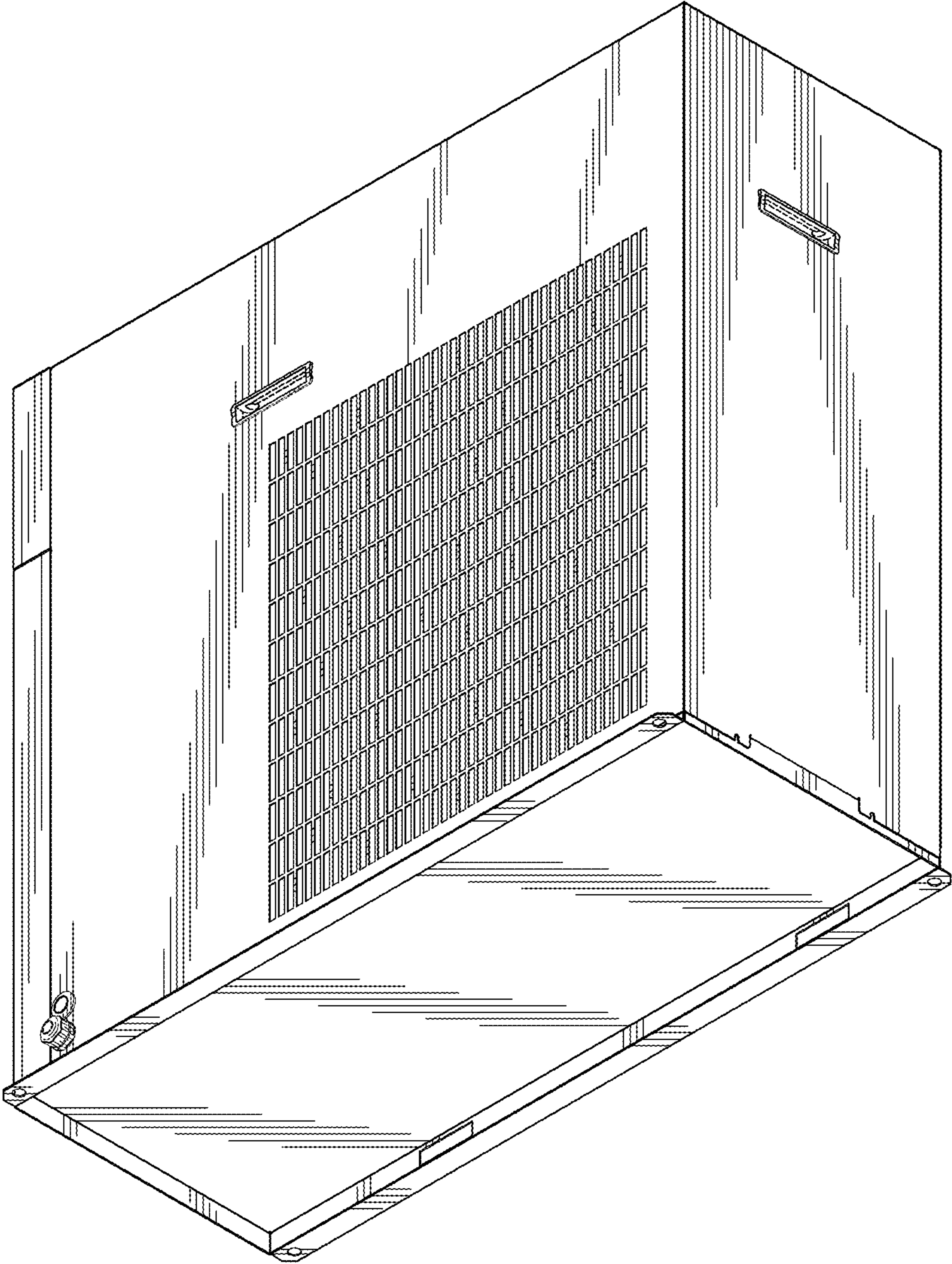

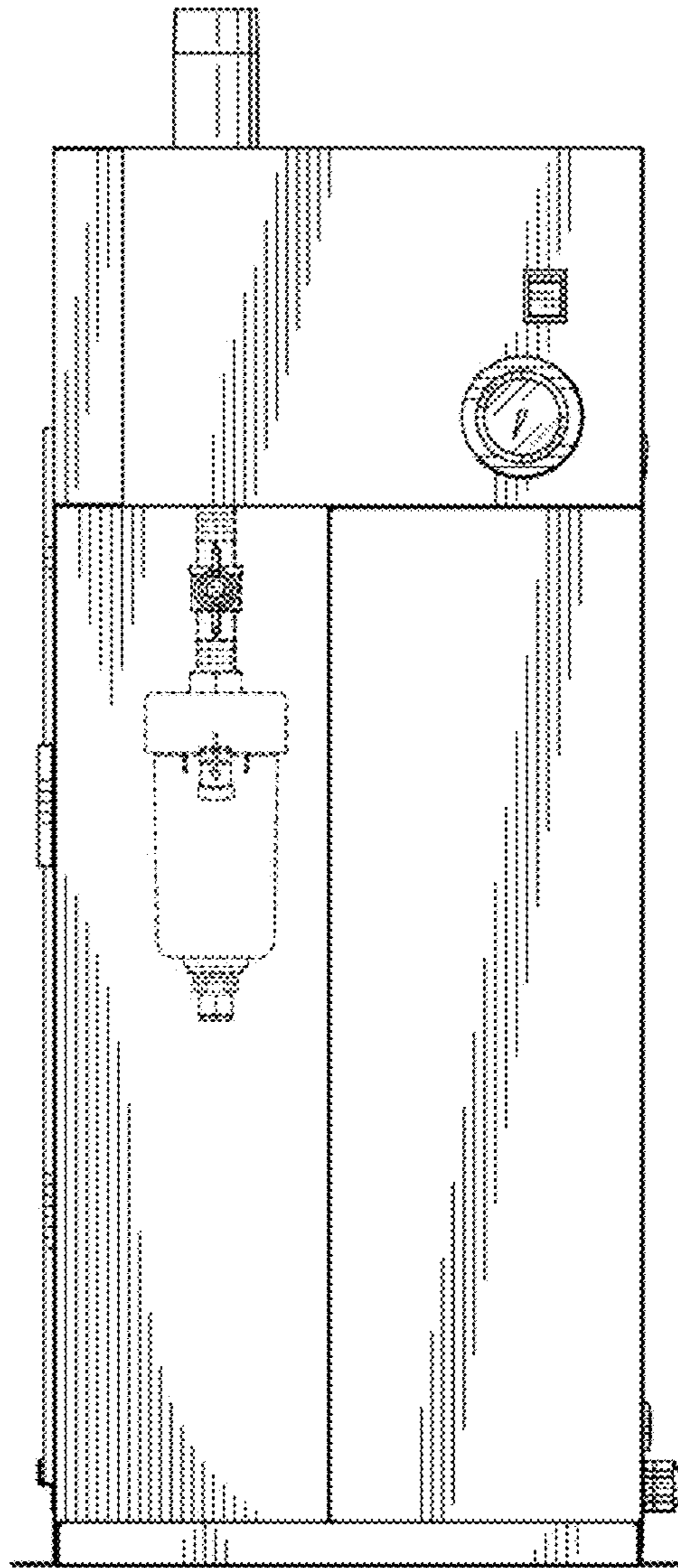

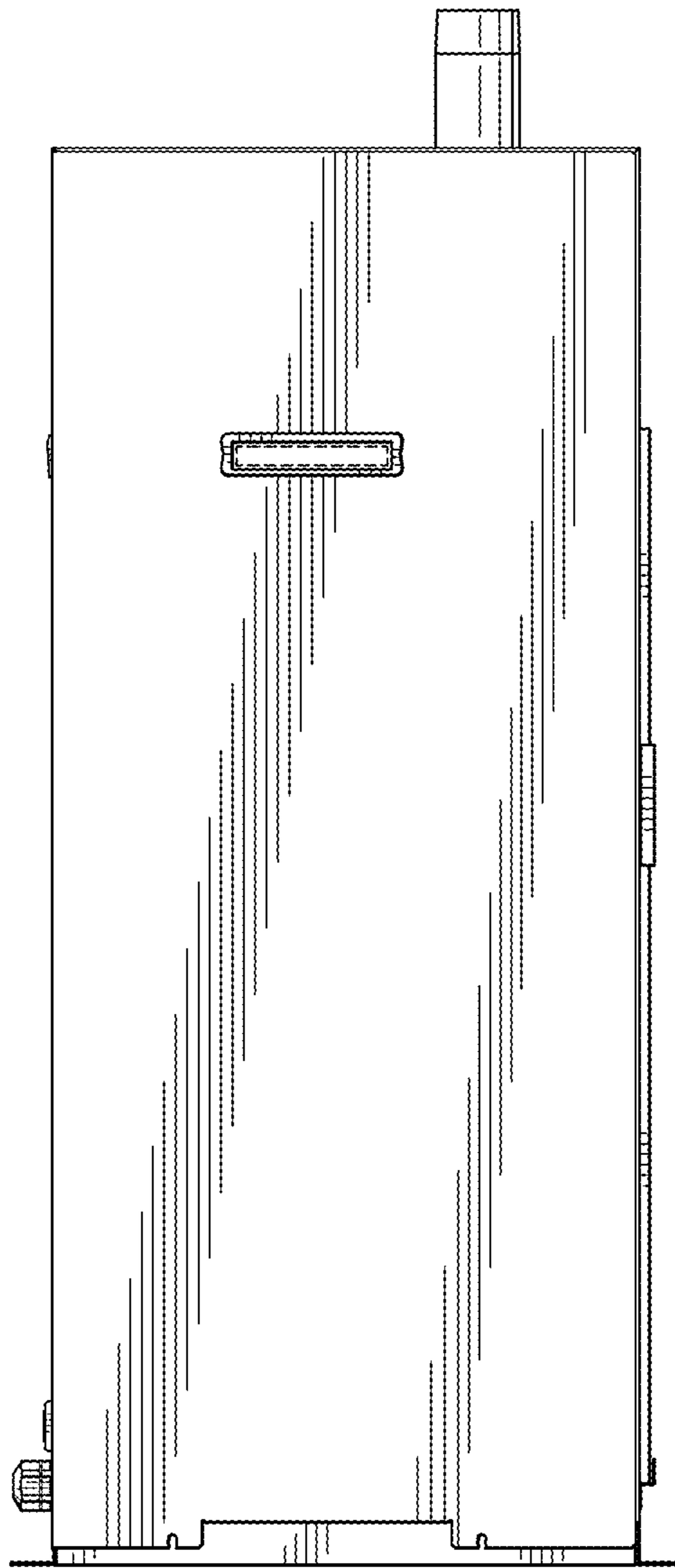

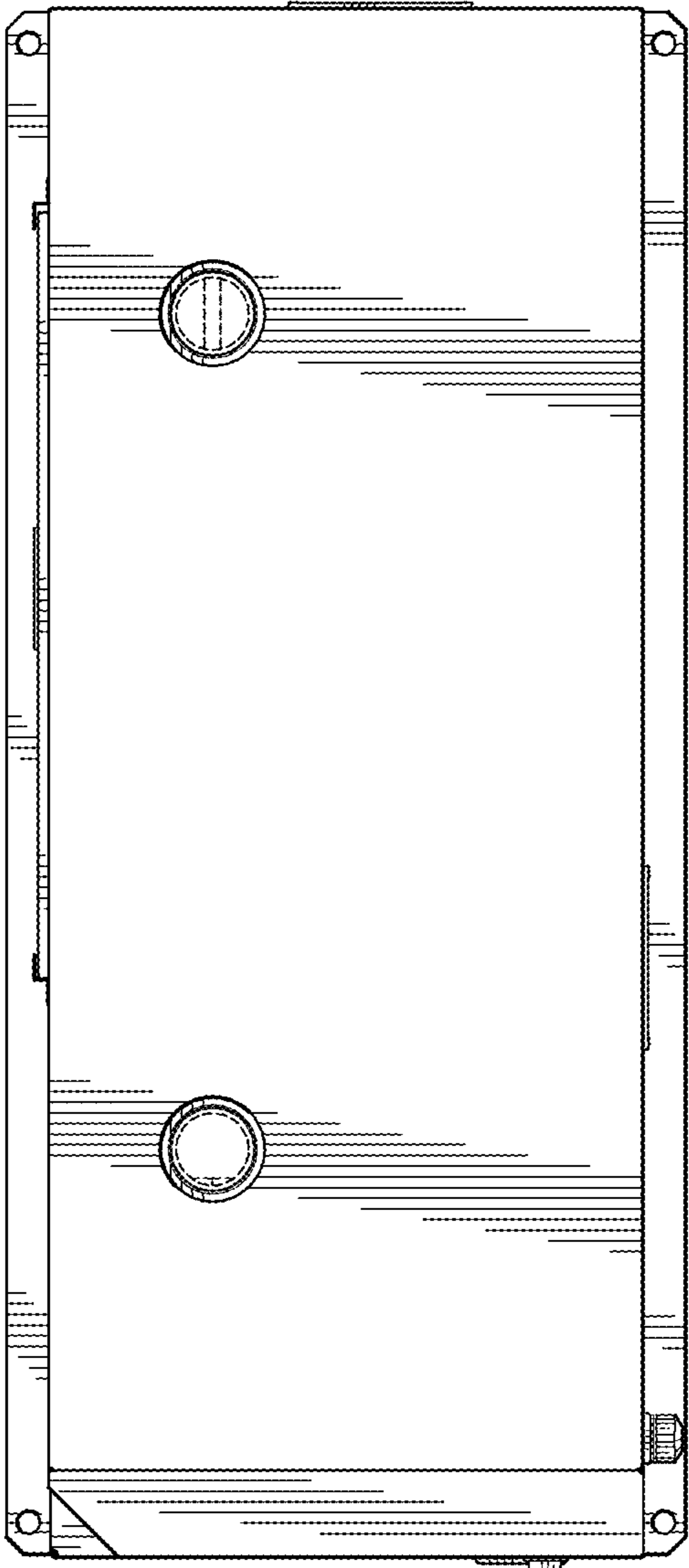

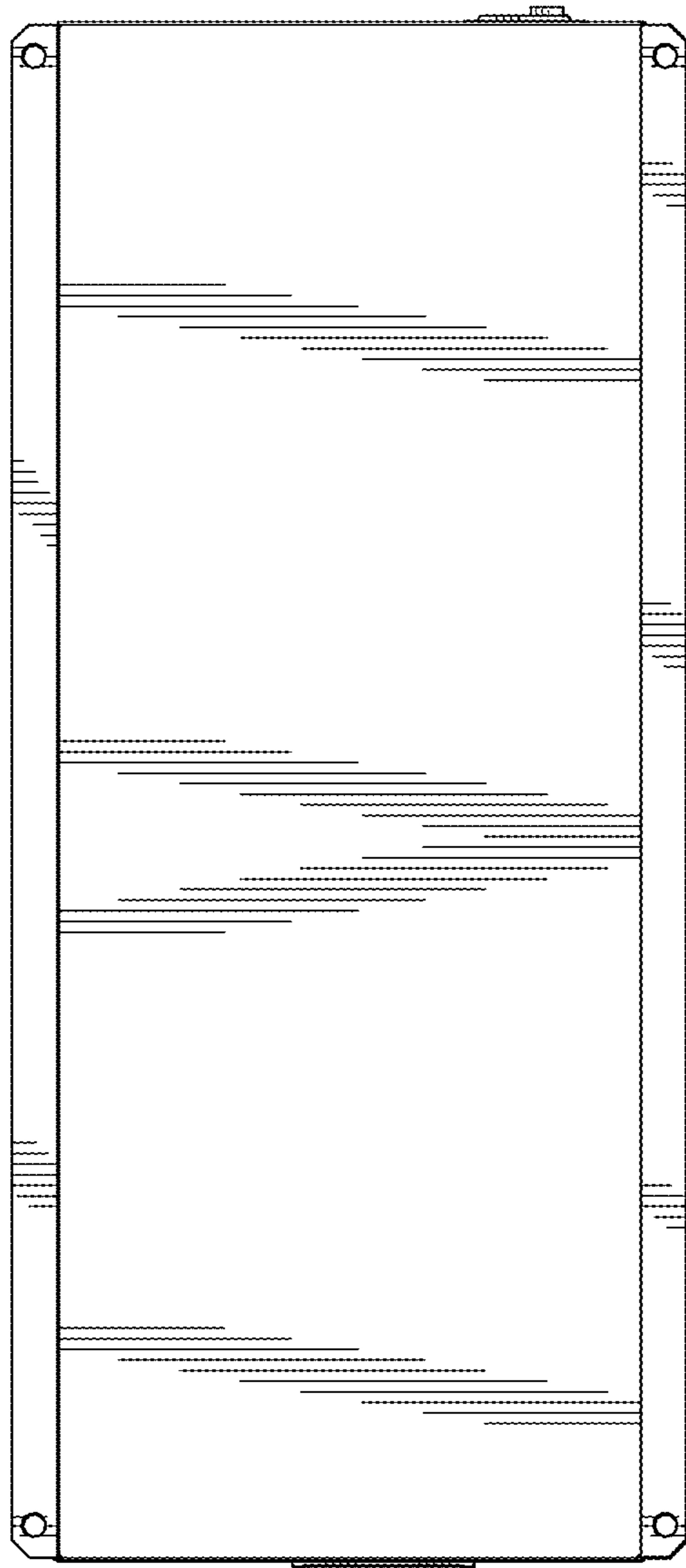

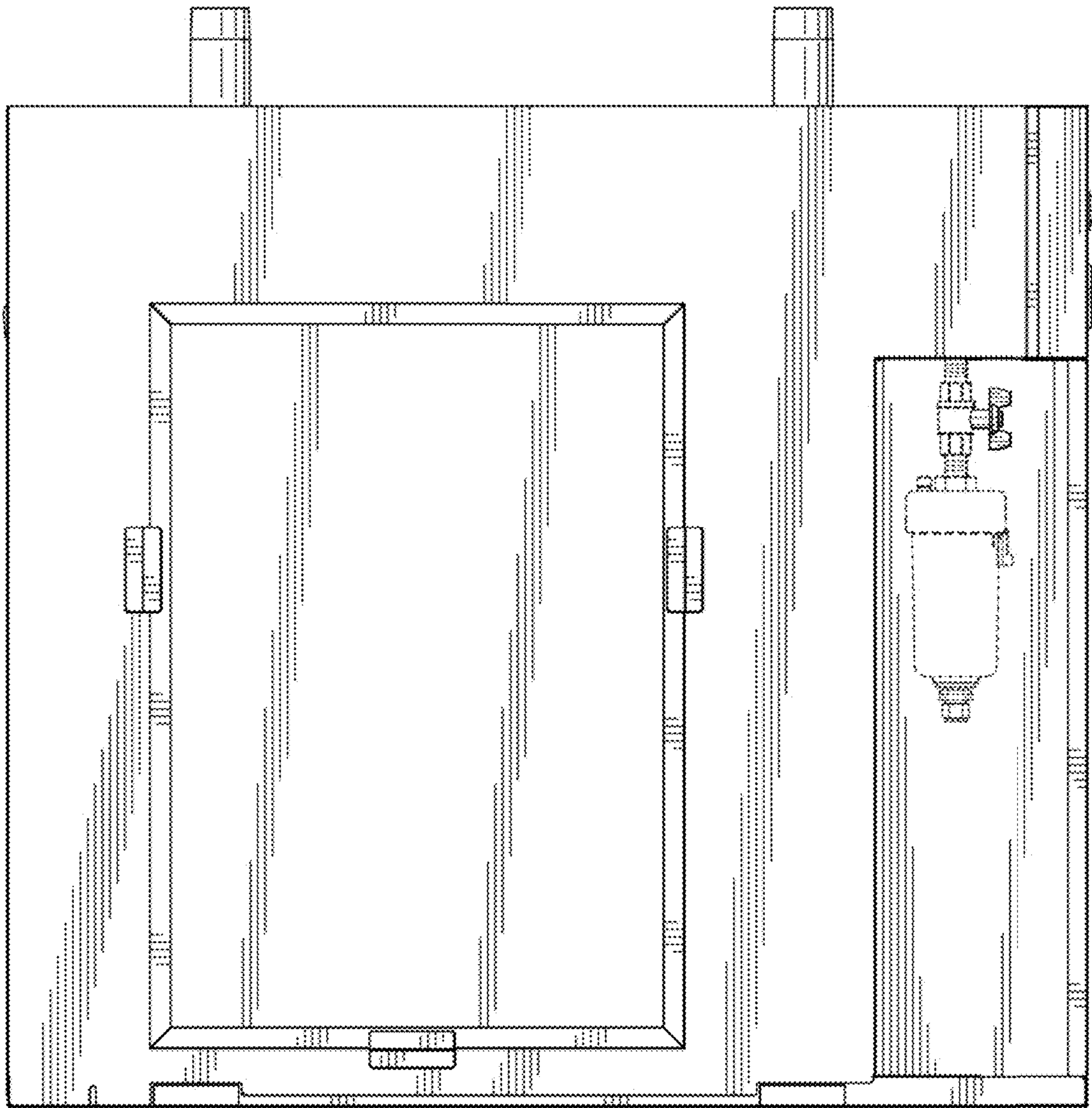

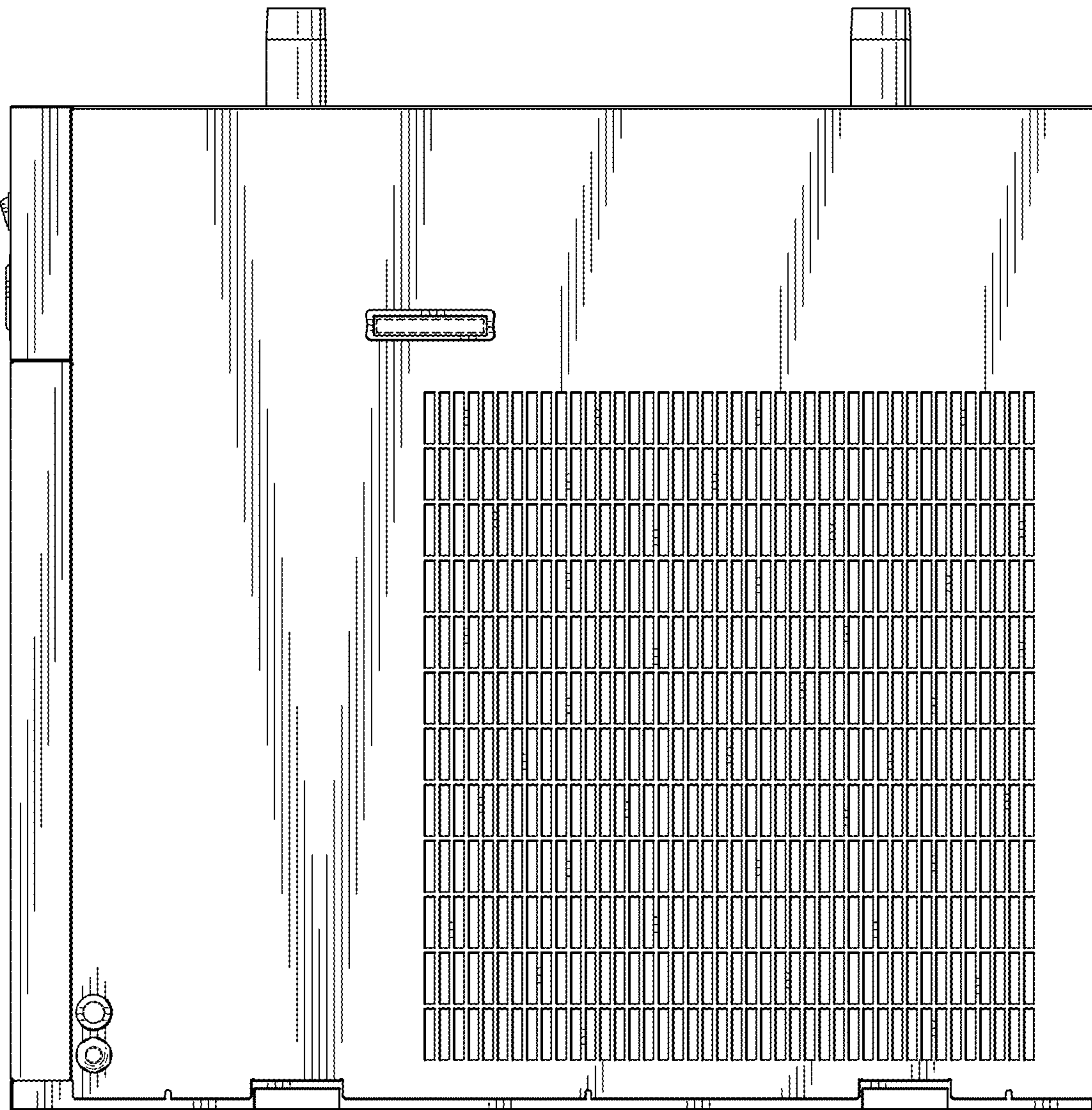
