**DESCRIPTION**

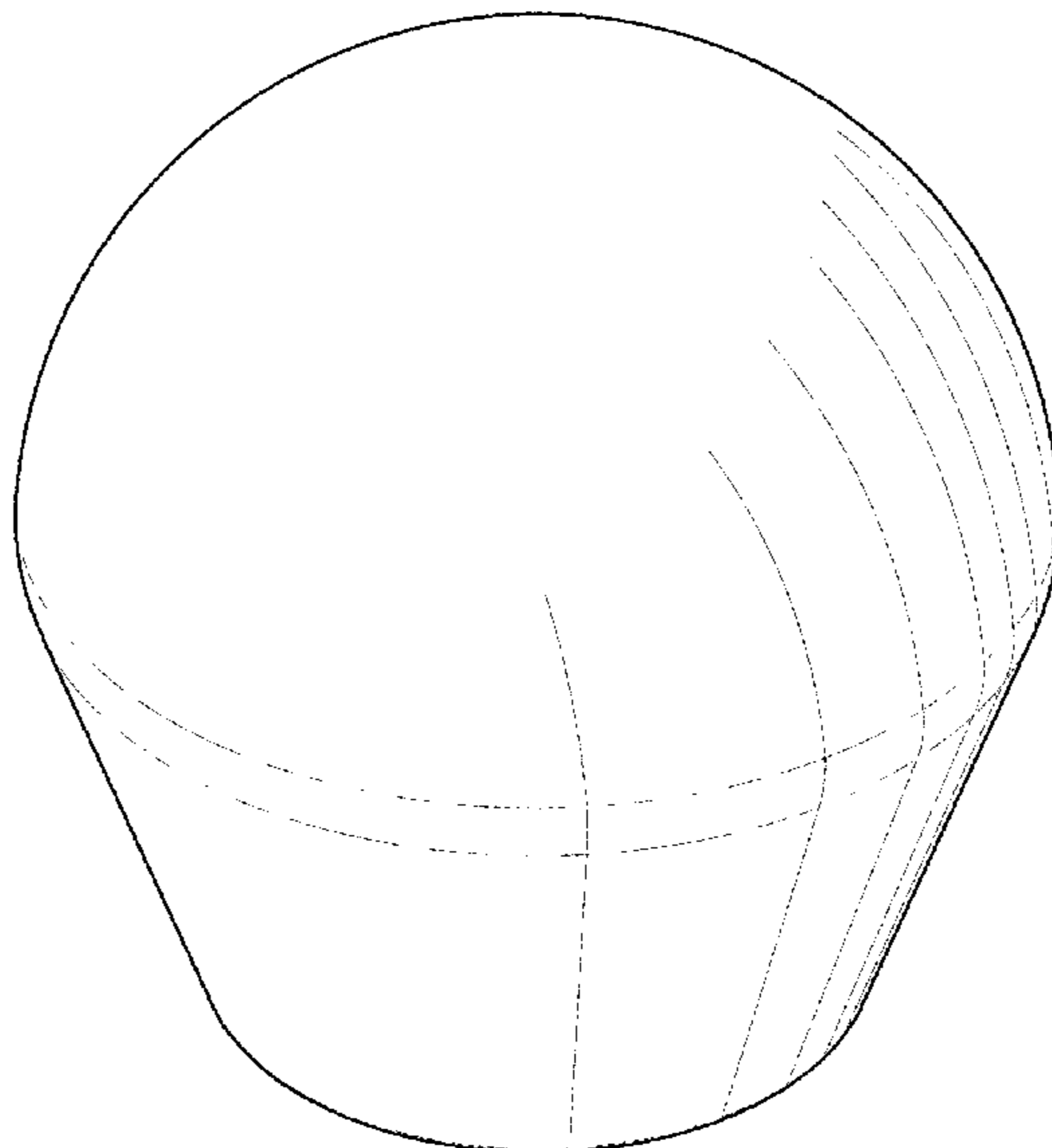
FIG. 1 is a top perspective view of a massage element, showing our new design;

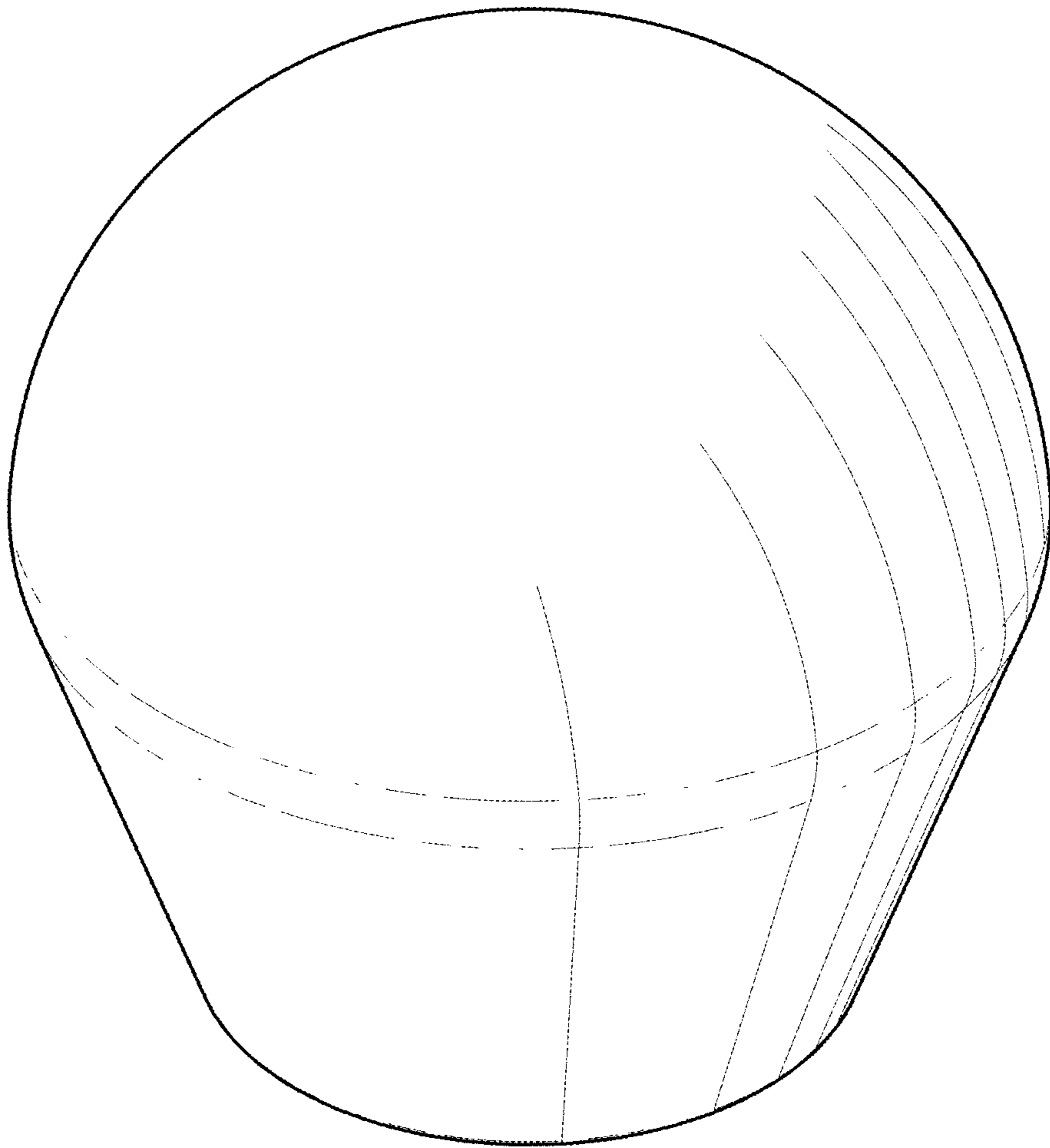

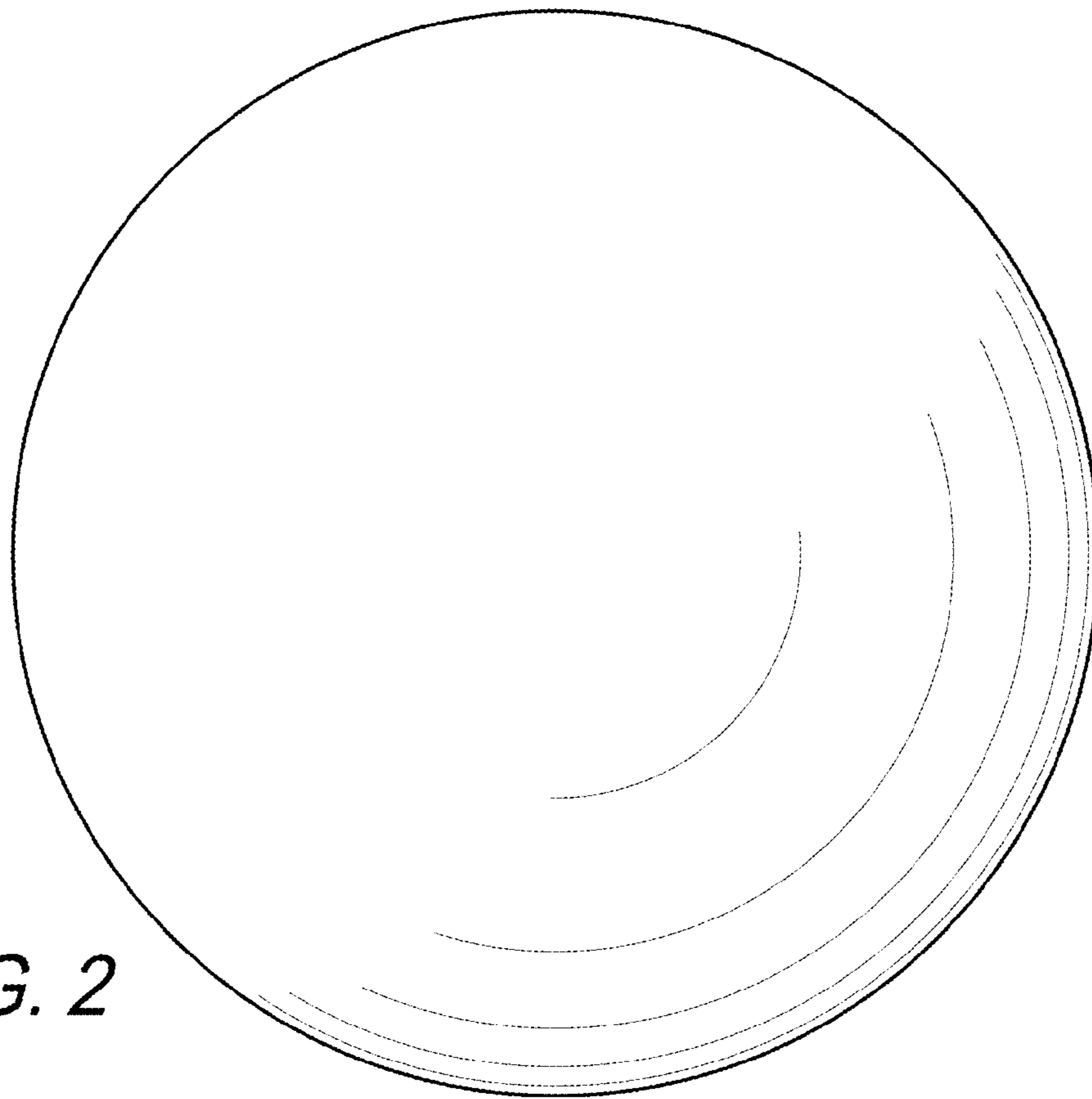

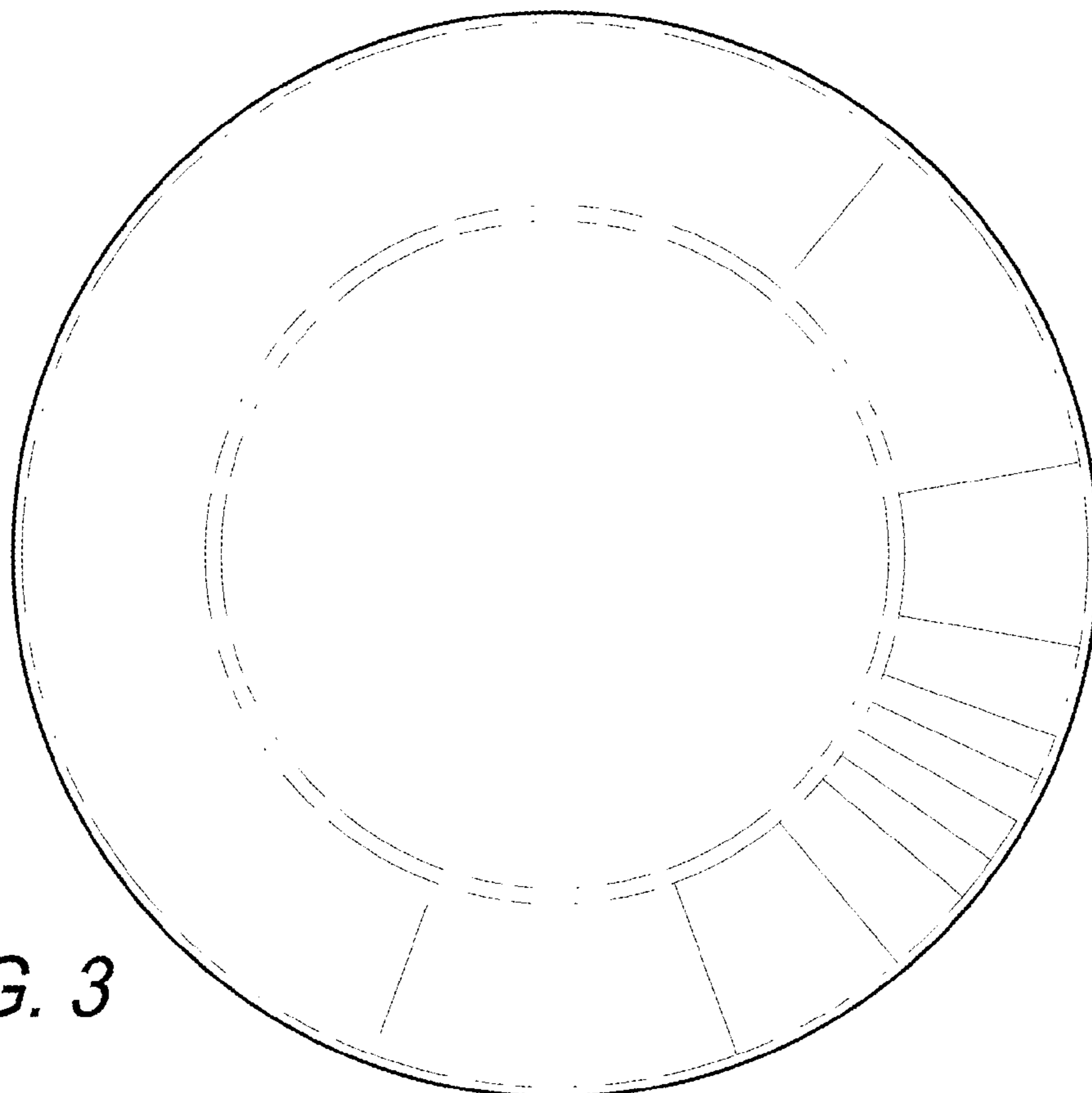

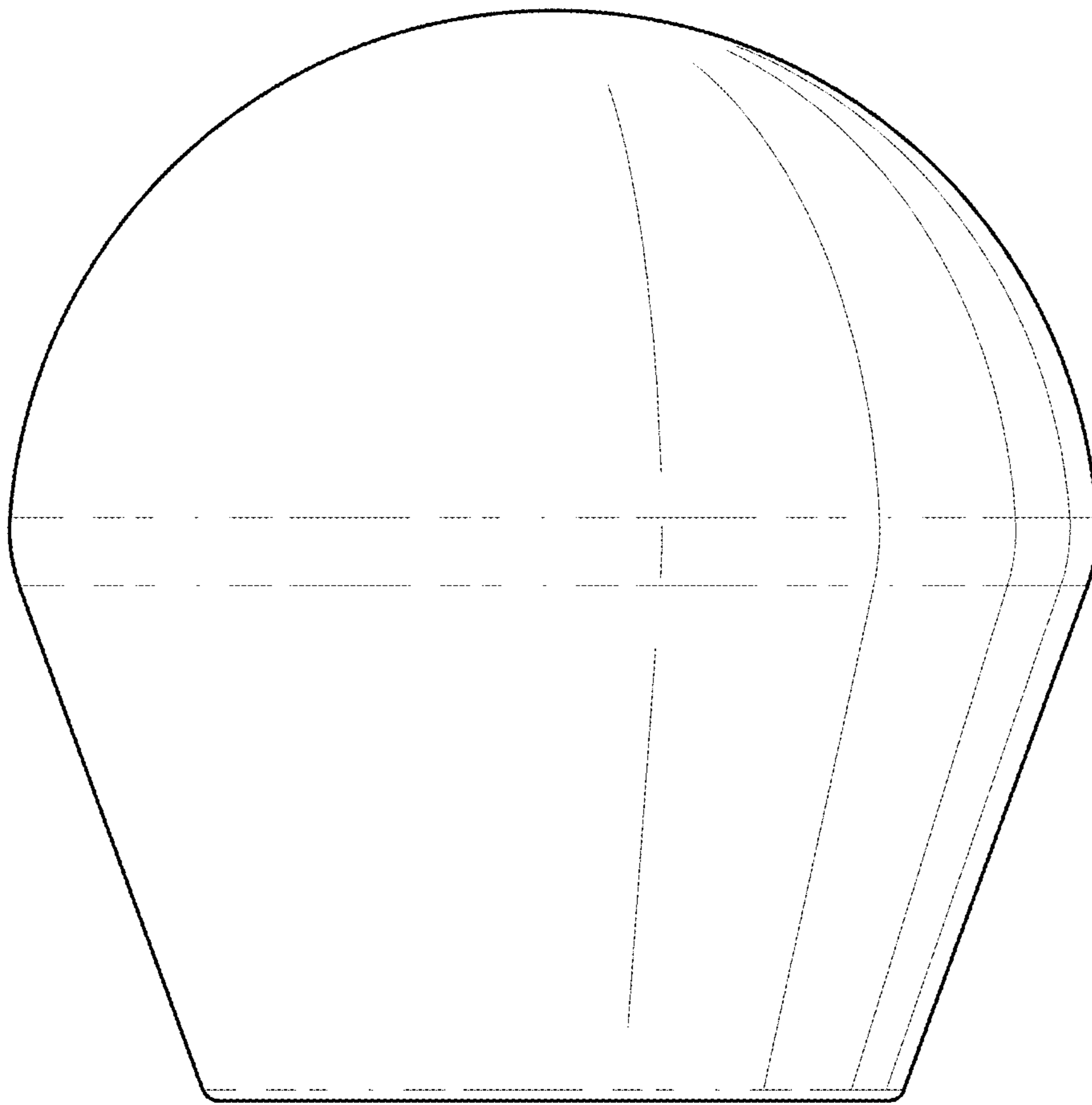

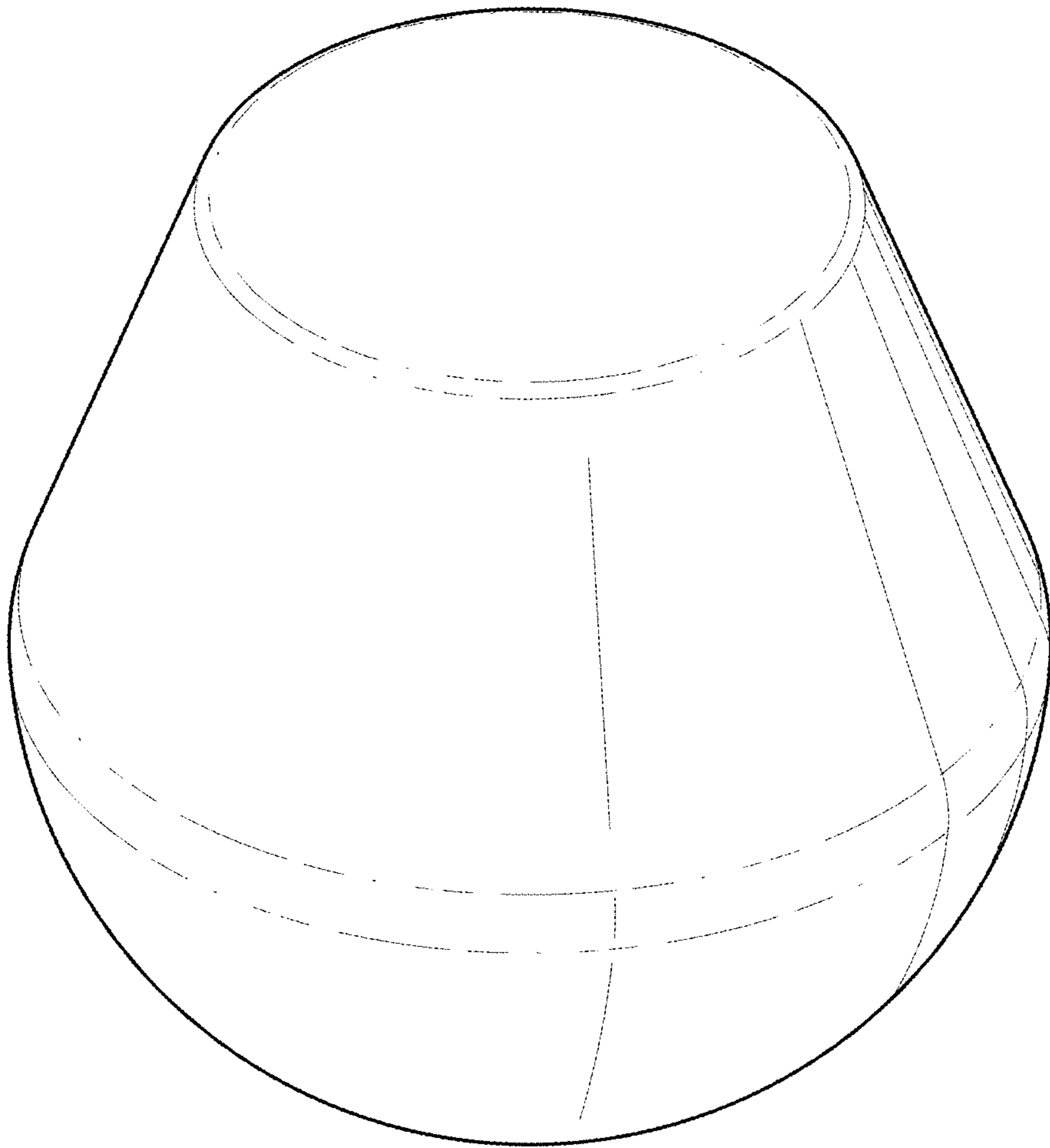
