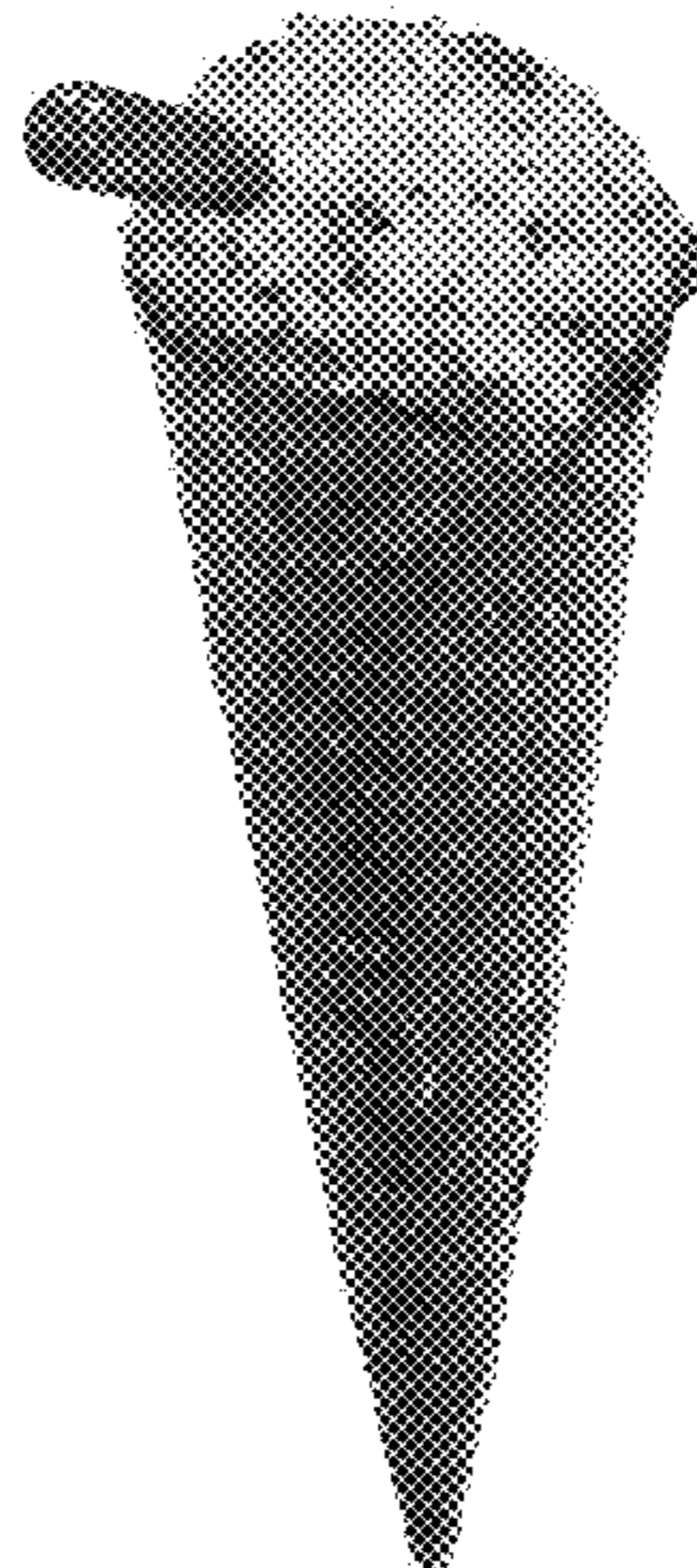
The ornamental design for a cooked rice in edible cone with flavor infuser, as shown and described.

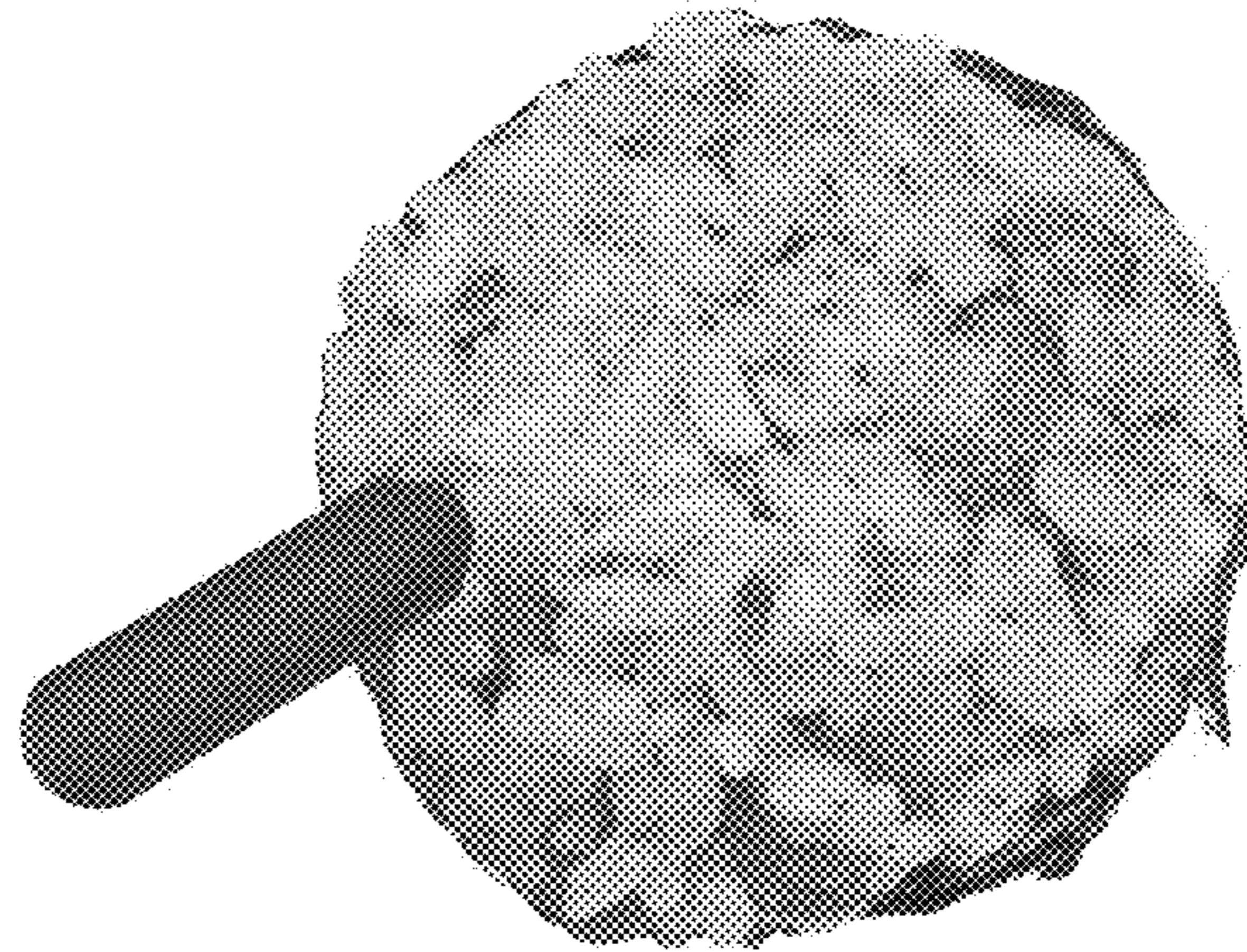
