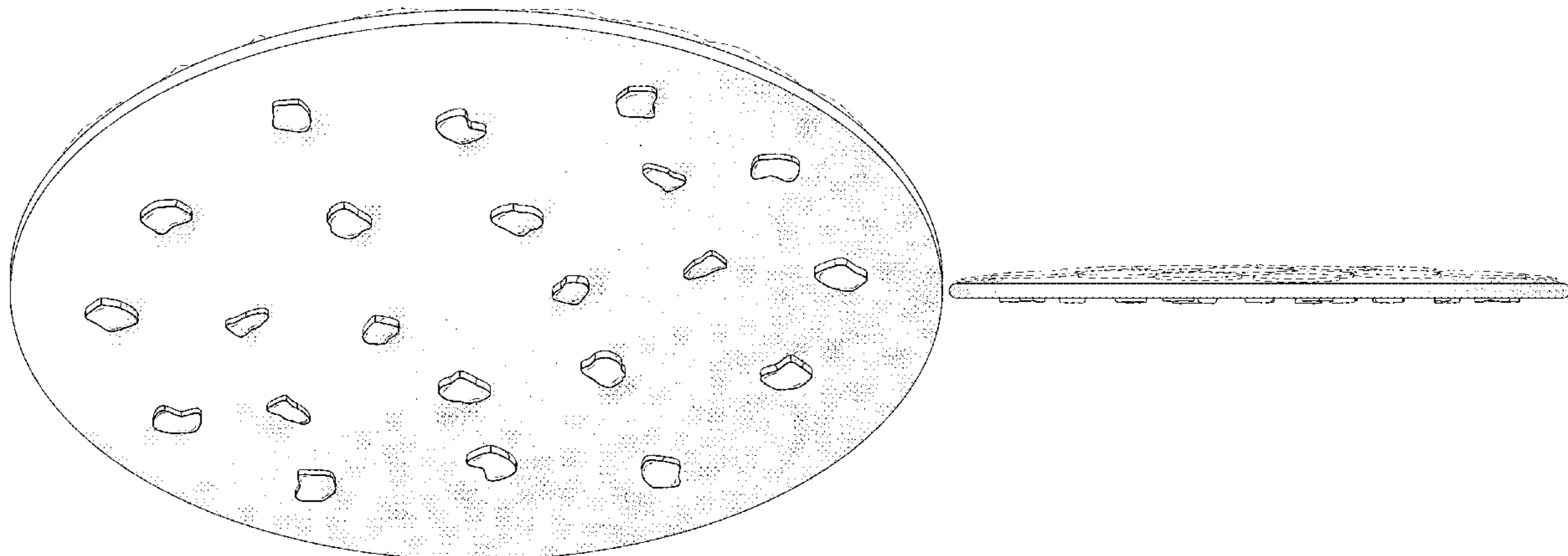
(57) **CLAIM**

The ornamental design for a pizza product, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a pizza product showing my new design;
FIG. 2 is a top plan view of the pizza product of FIG. 1;
FIG. 3 is a front elevational view of the pizza product of FIG. 1;
FIG. 4 is a left side elevational view of the pizza product of FIG. 1;
FIG. 5 is a right side elevational view of the pizza product of FIG. 1;
FIG. 6 is a rear elevational view of the pizza product of FIG. 1; and,
FIG. 7 is a bottom plan view of the pizza product of FIG. 1. The broken lines in FIGS. 1-6 illustrate portions of the pizza product that form no part of the claimed design.

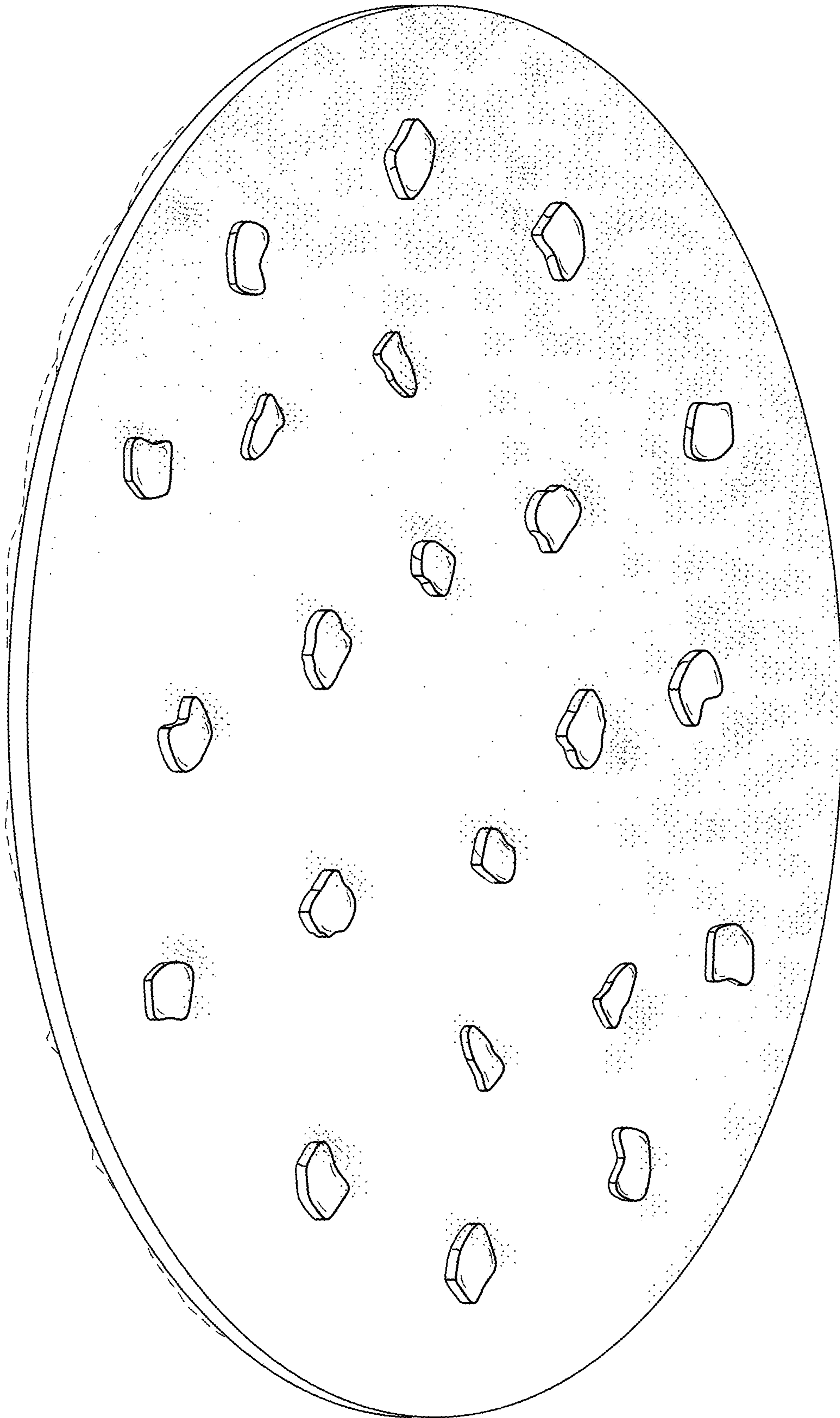

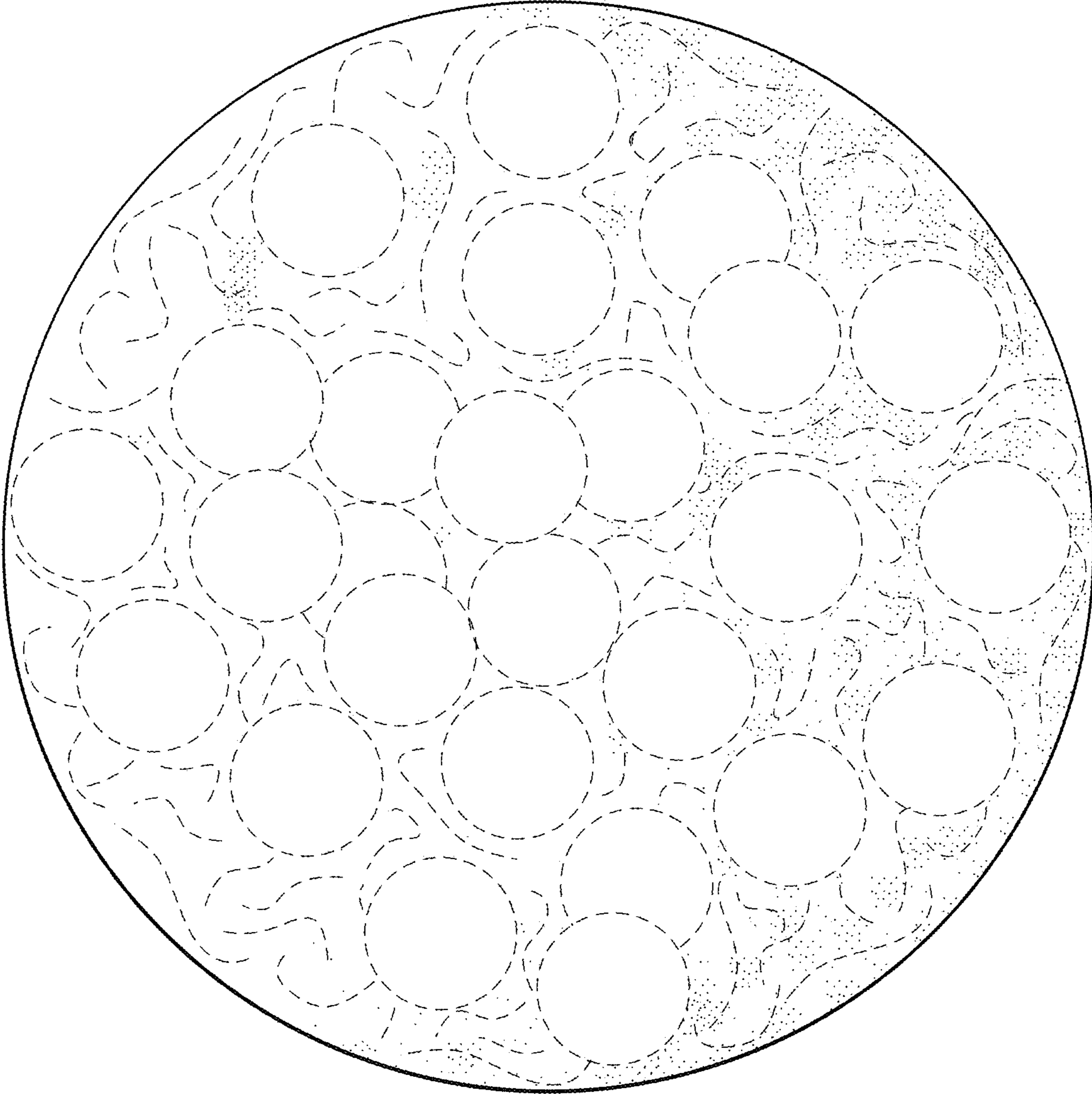

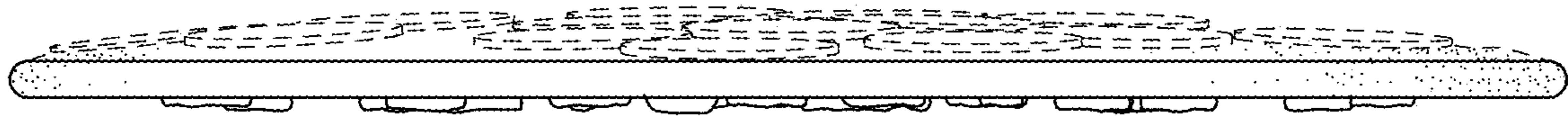

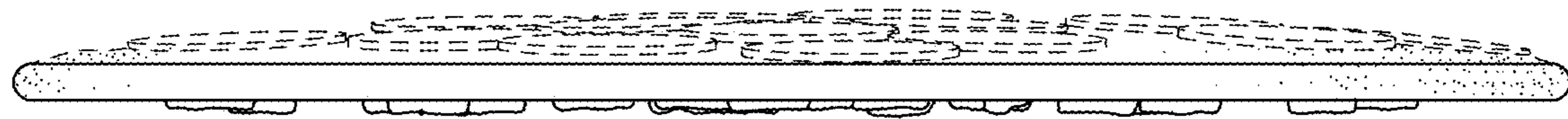

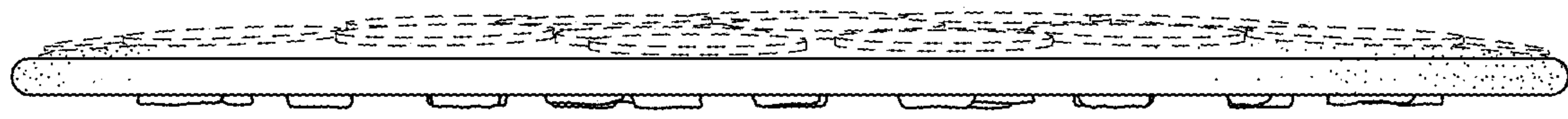

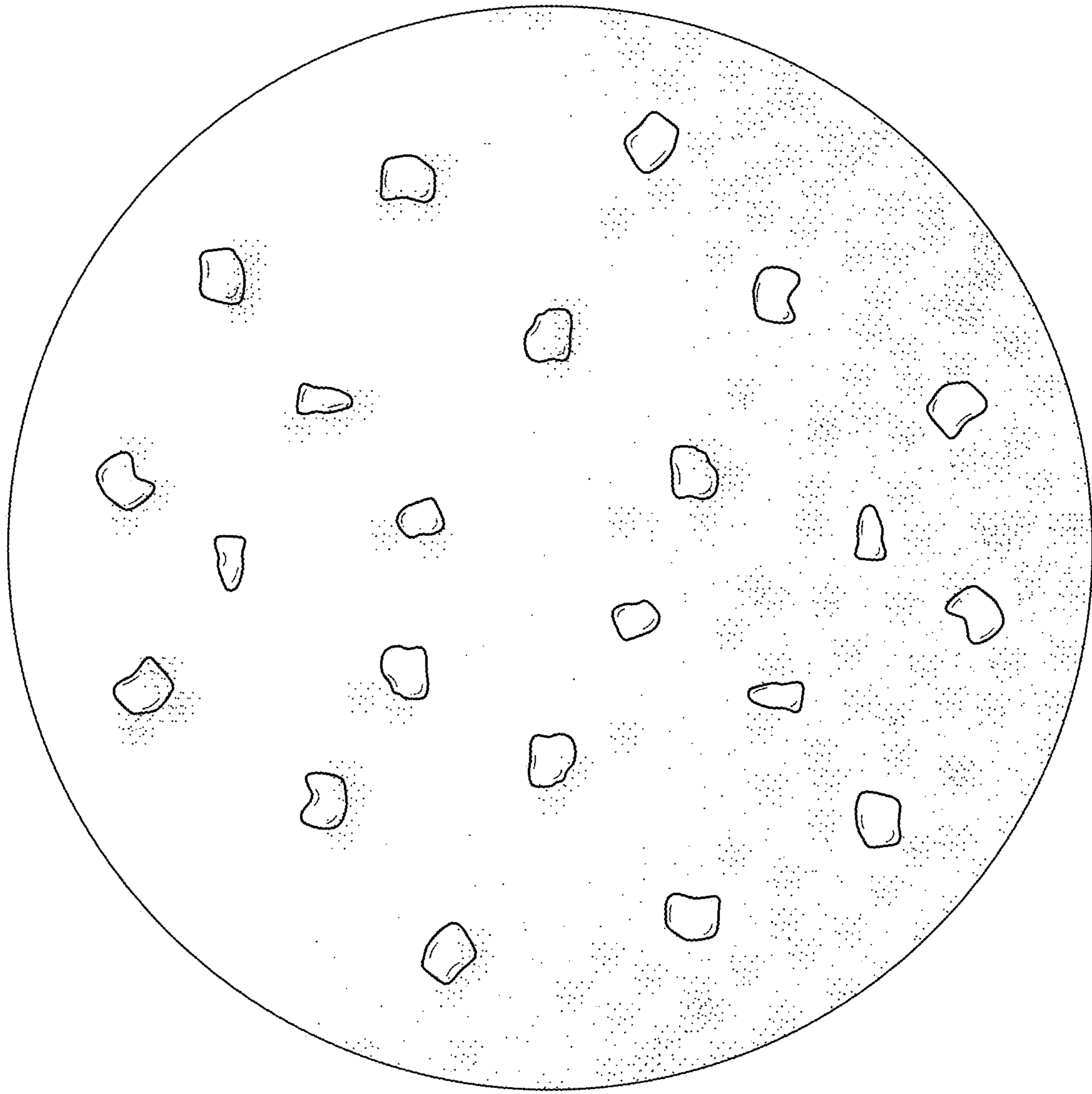
