(57) **CLAIM**

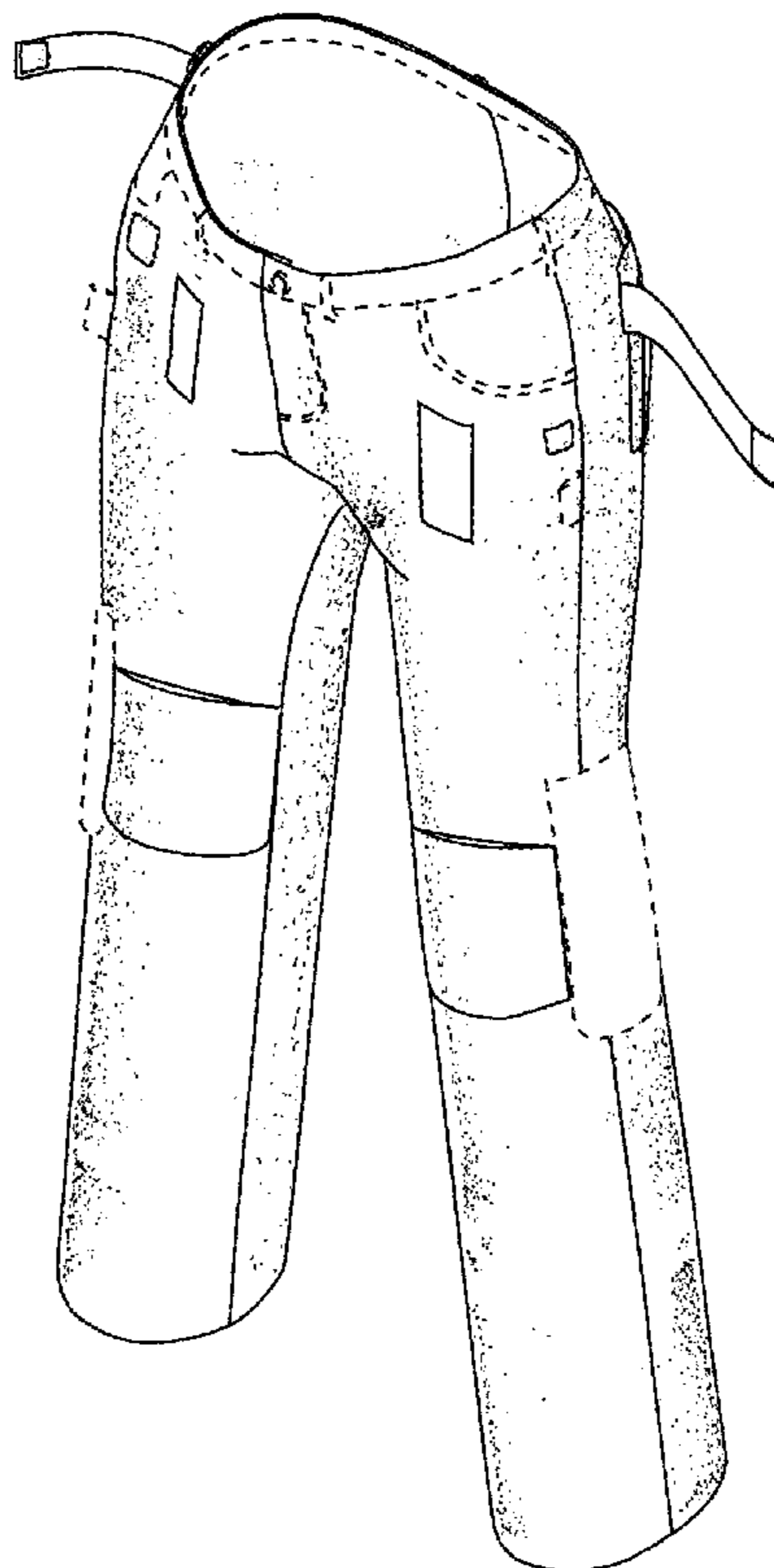
The ornamental design for a multi-functional utility pants, as shown and described.

DESCRIPTION

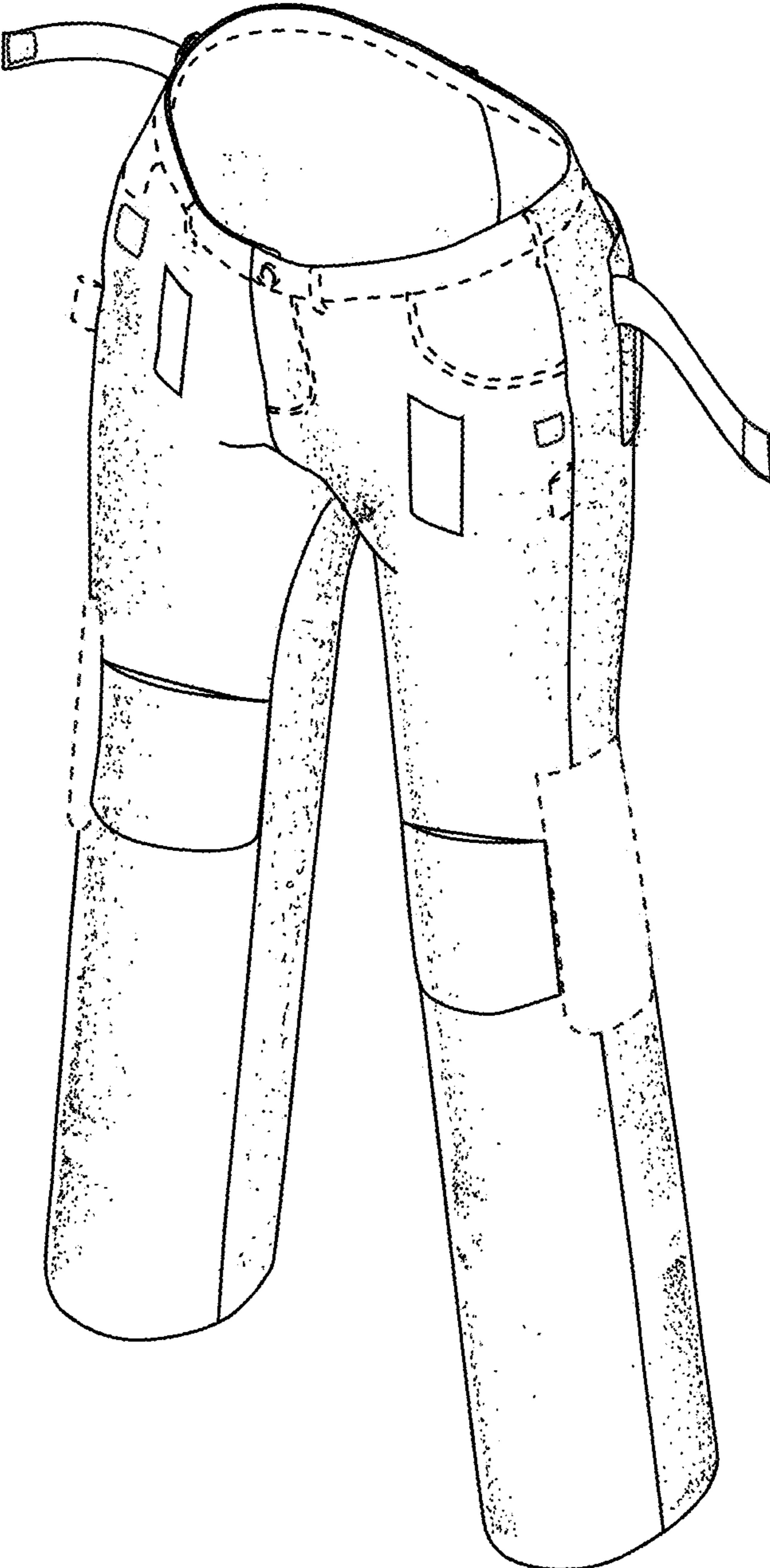

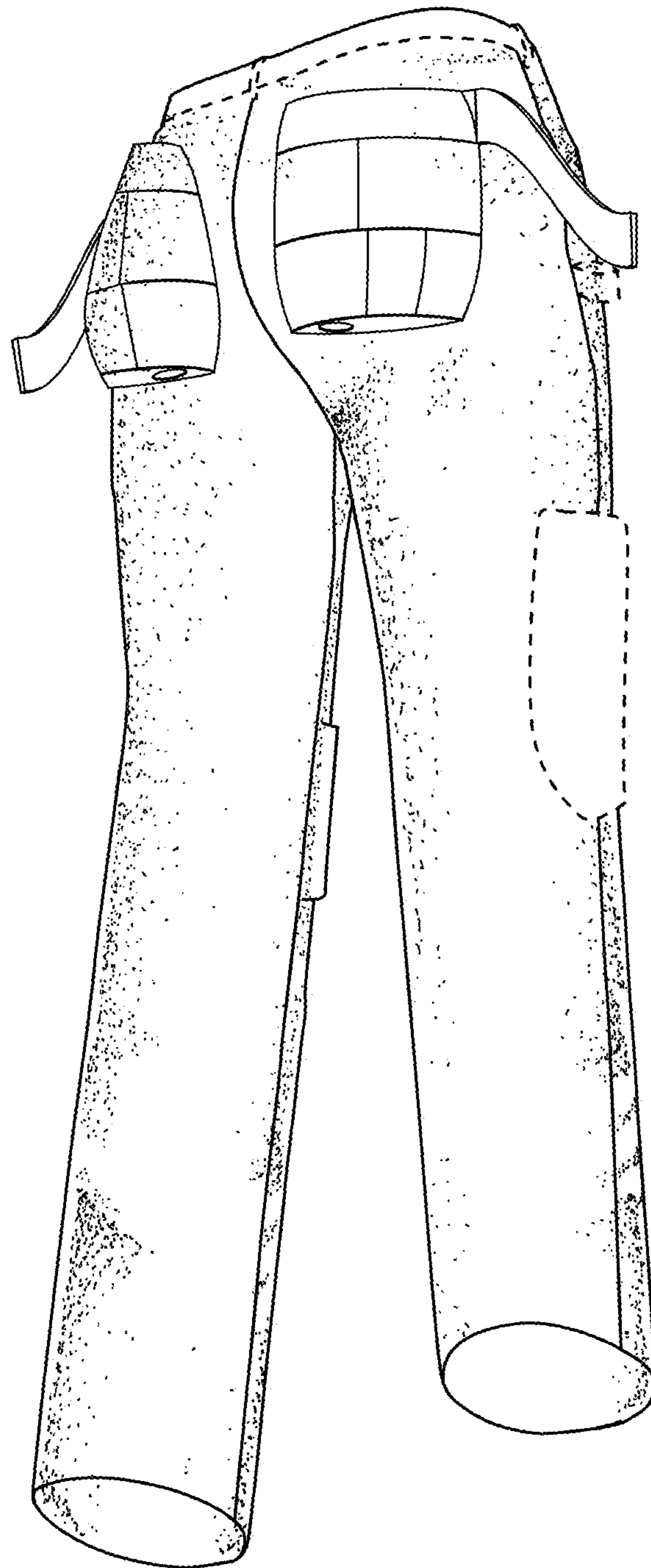

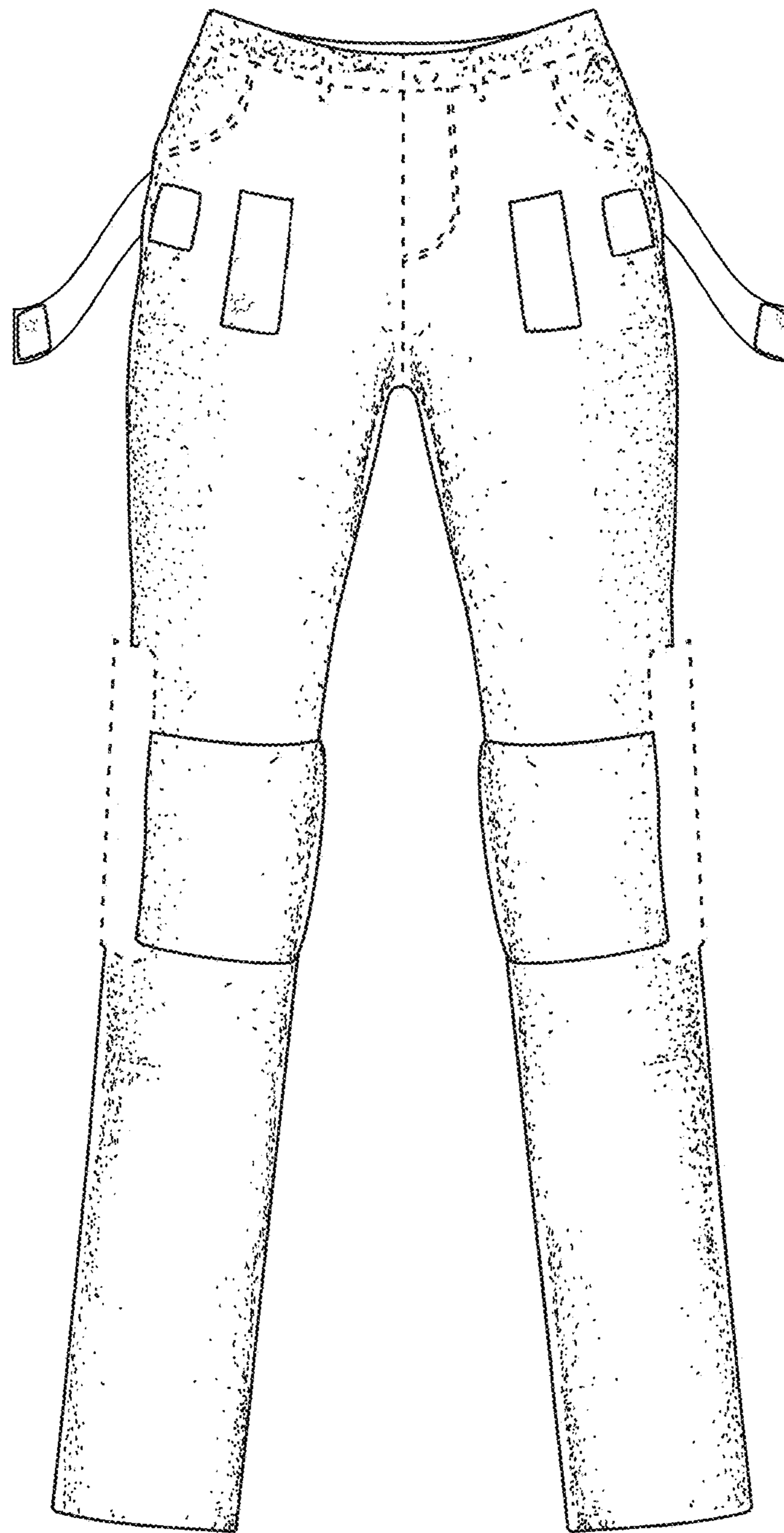

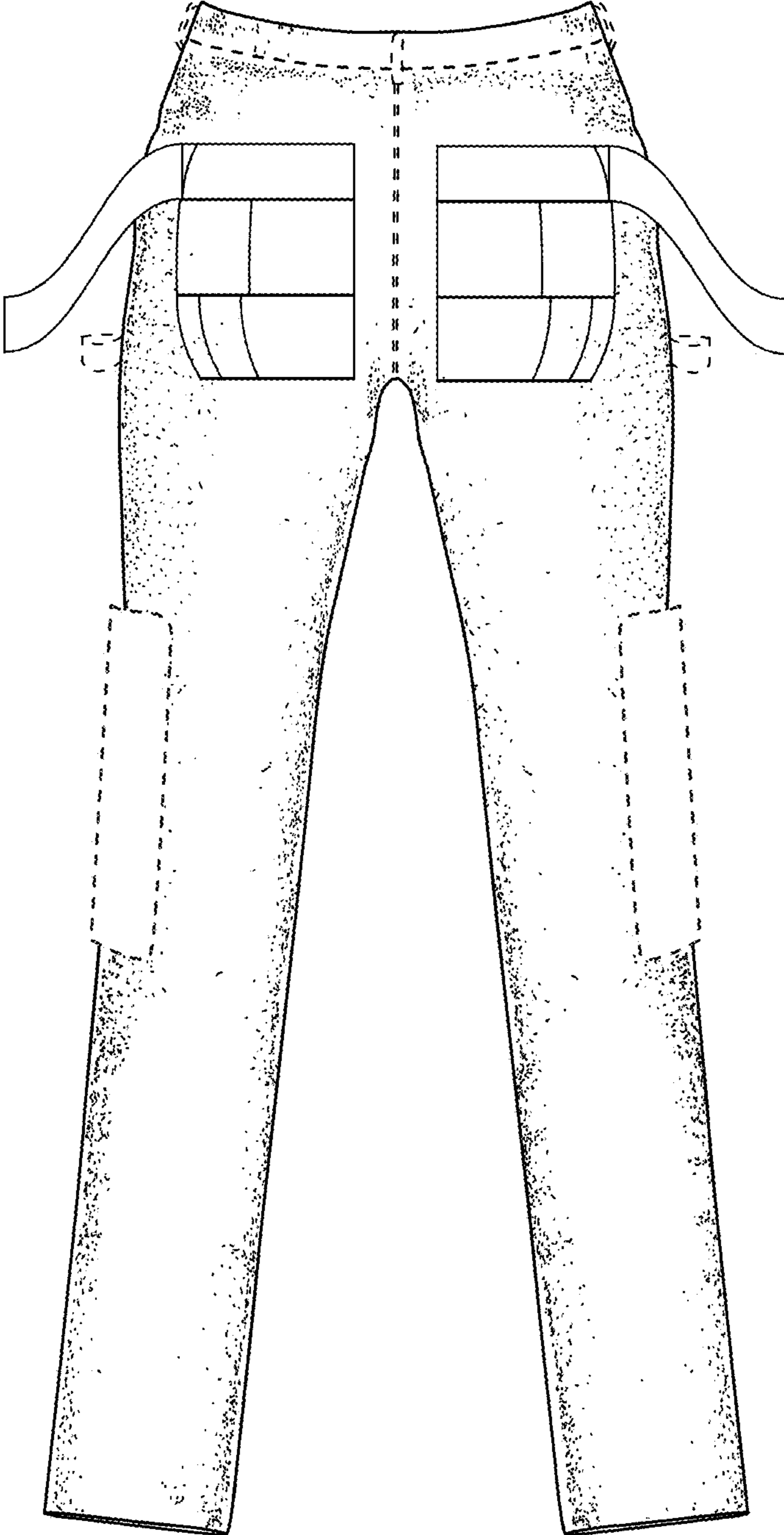

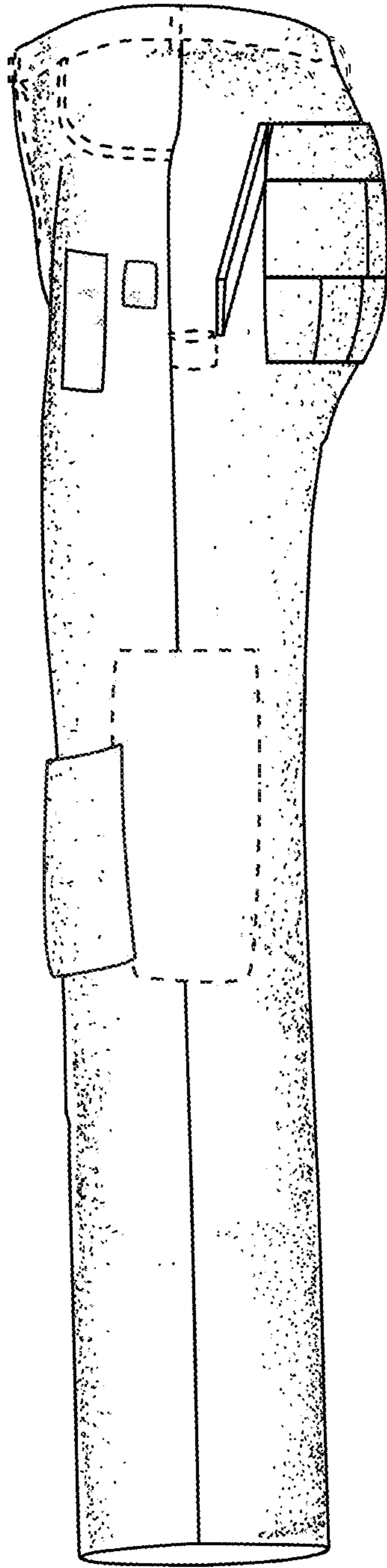

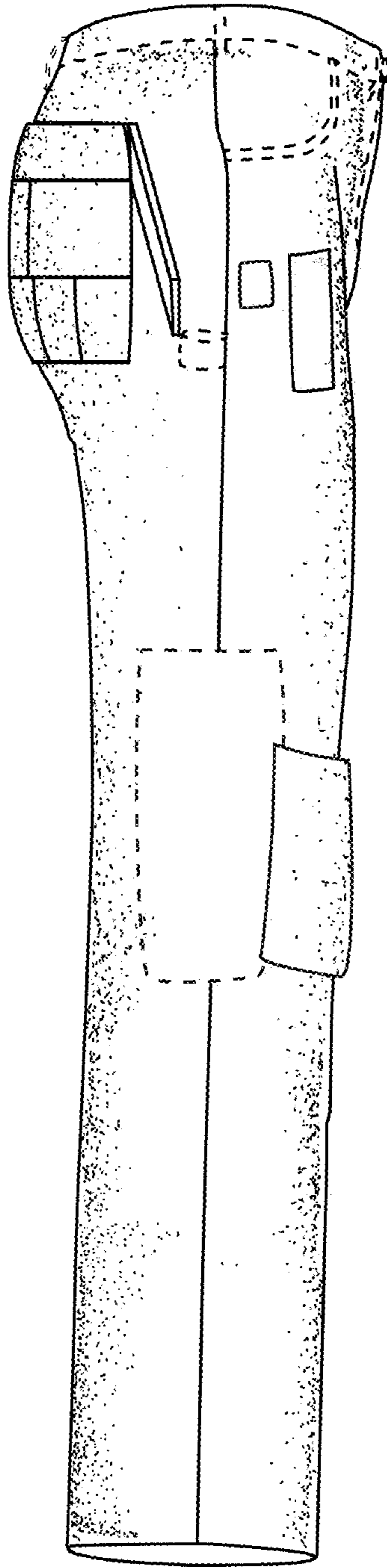

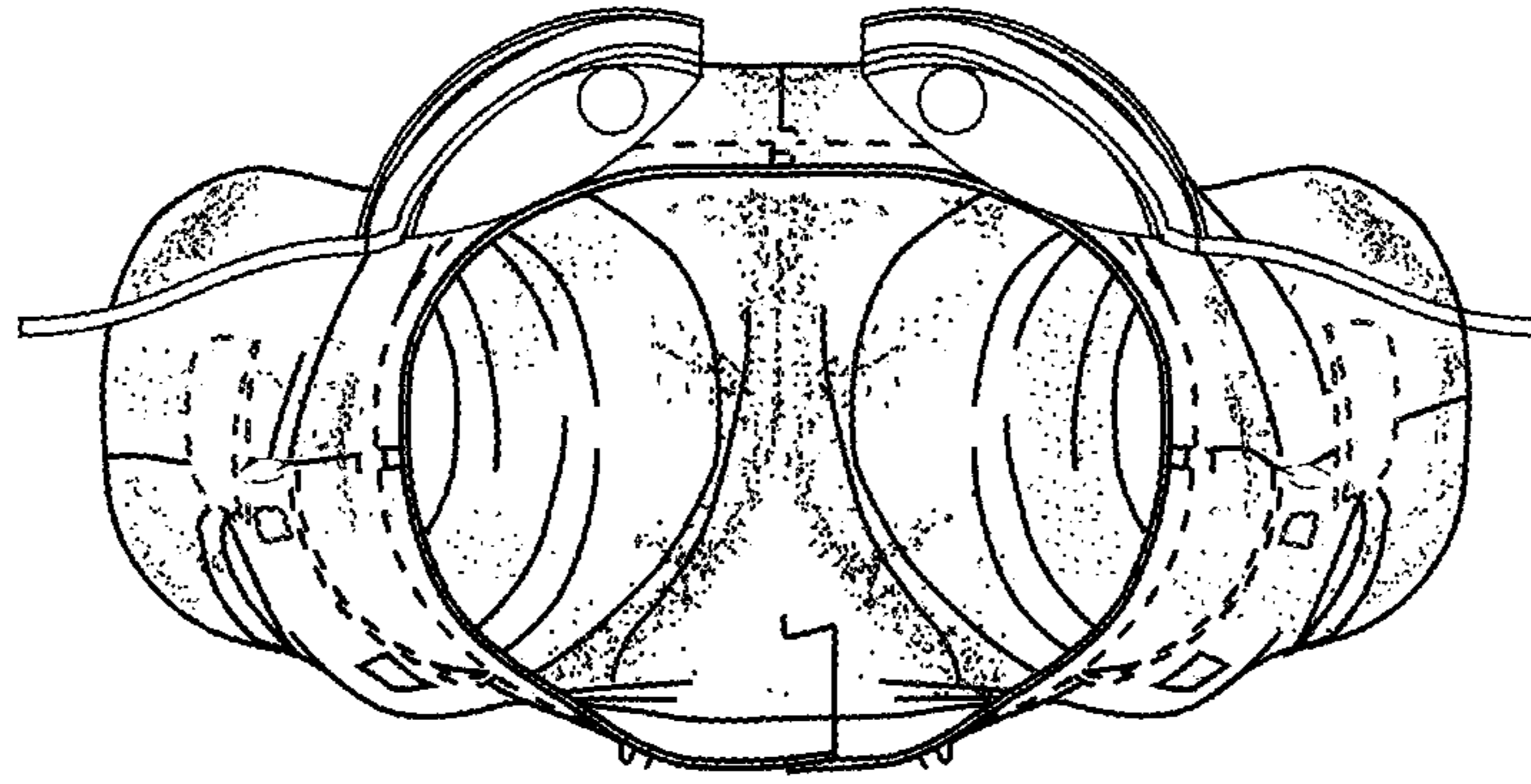

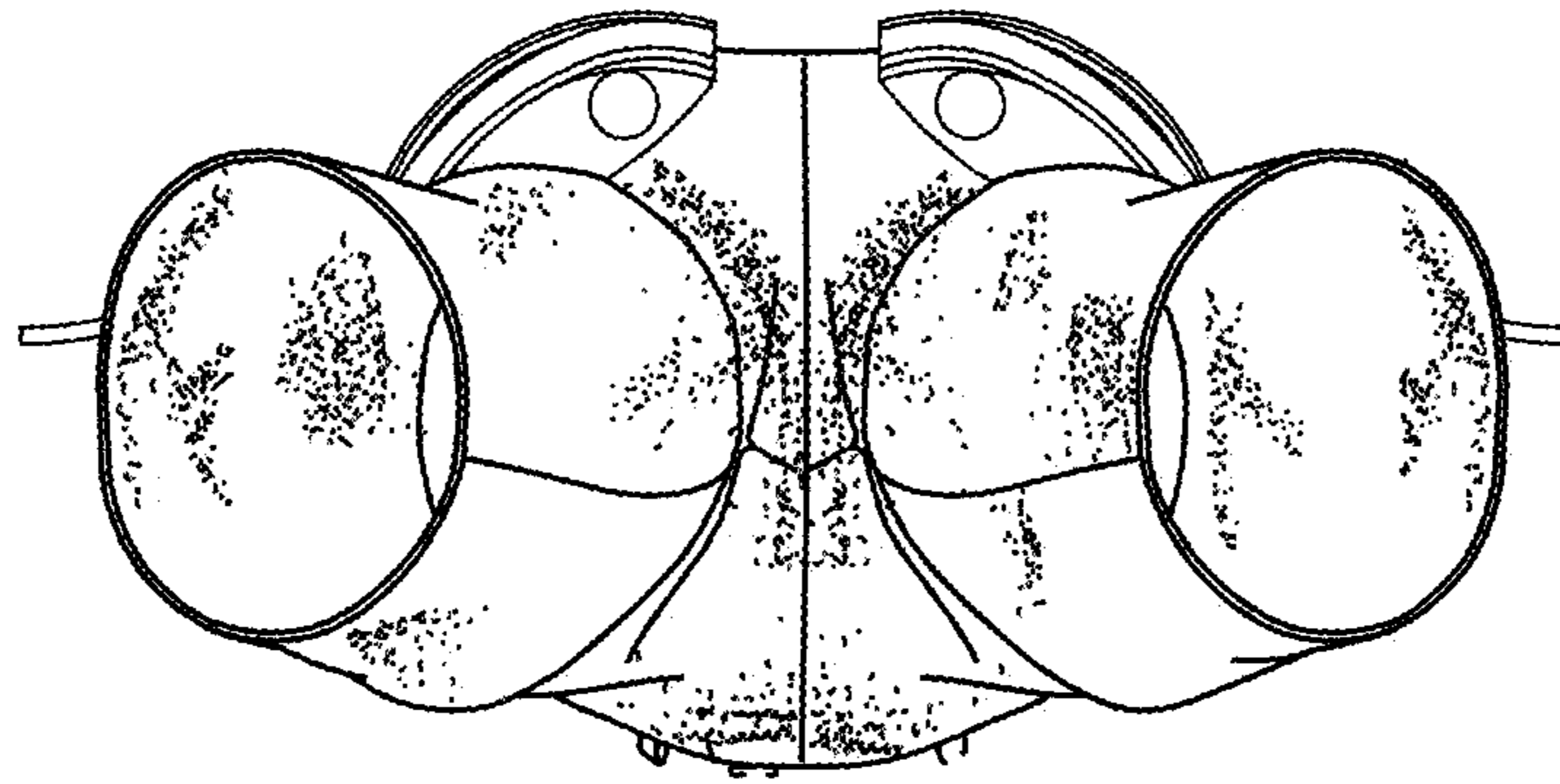
