DESCRIPTION

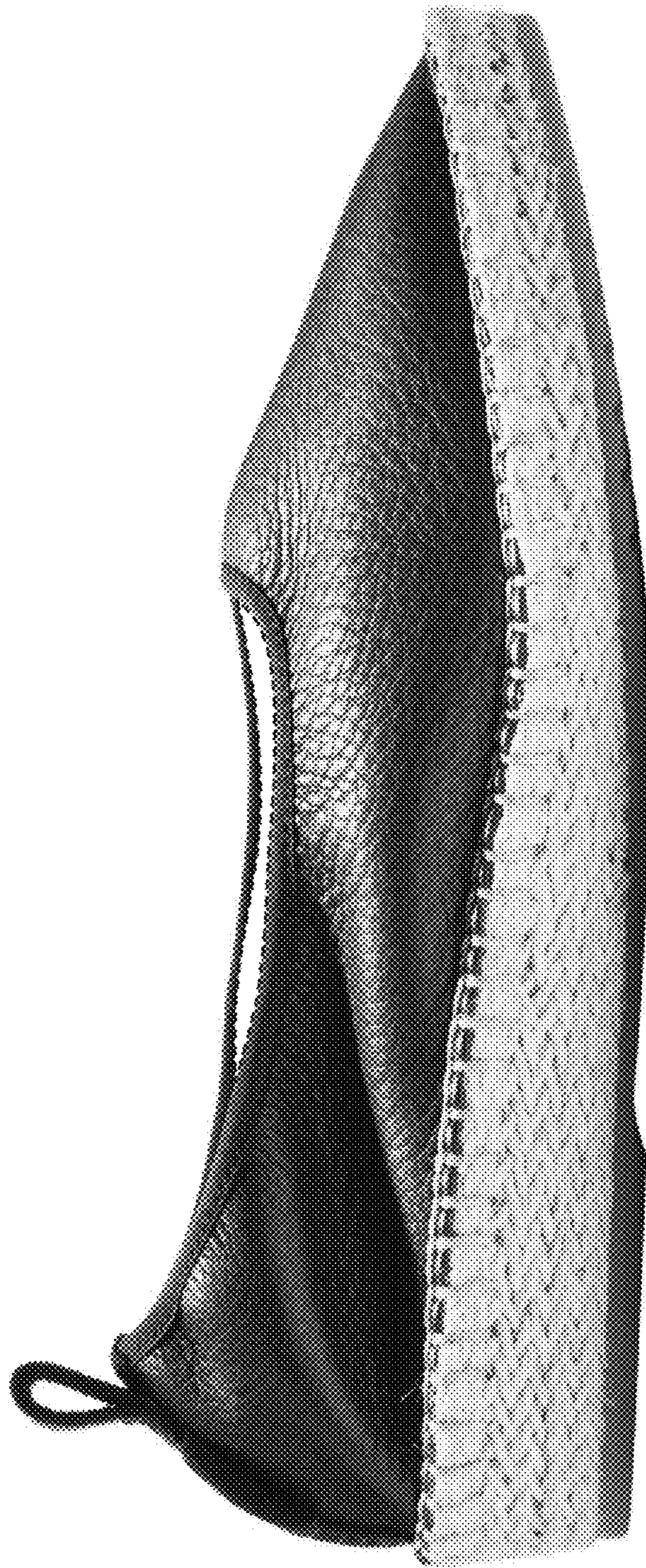

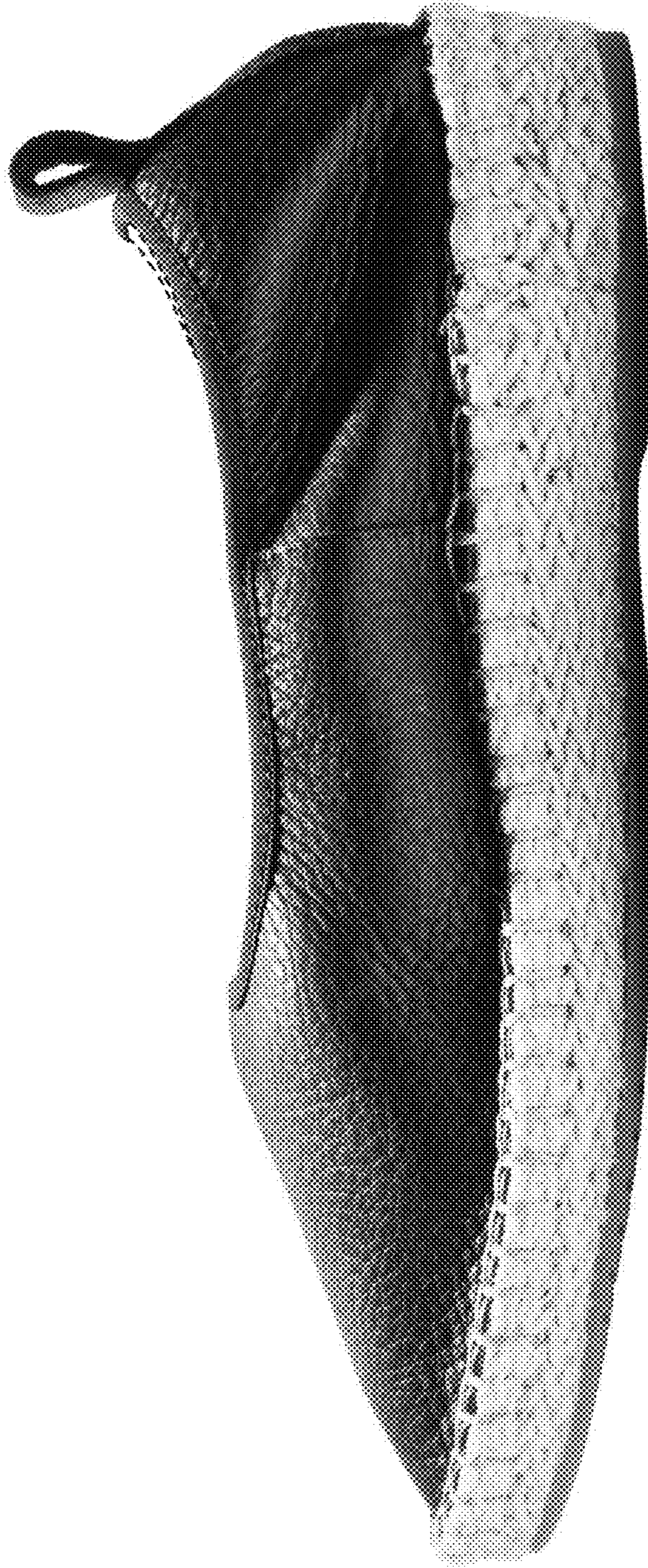

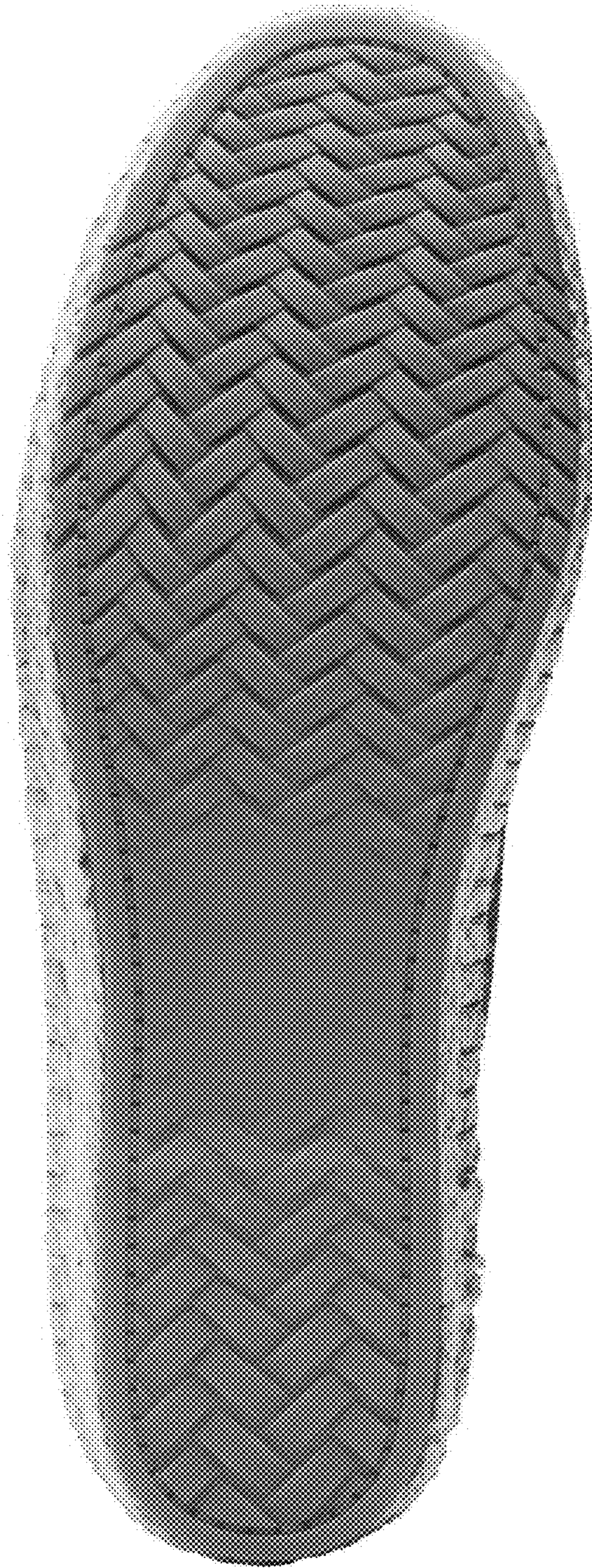

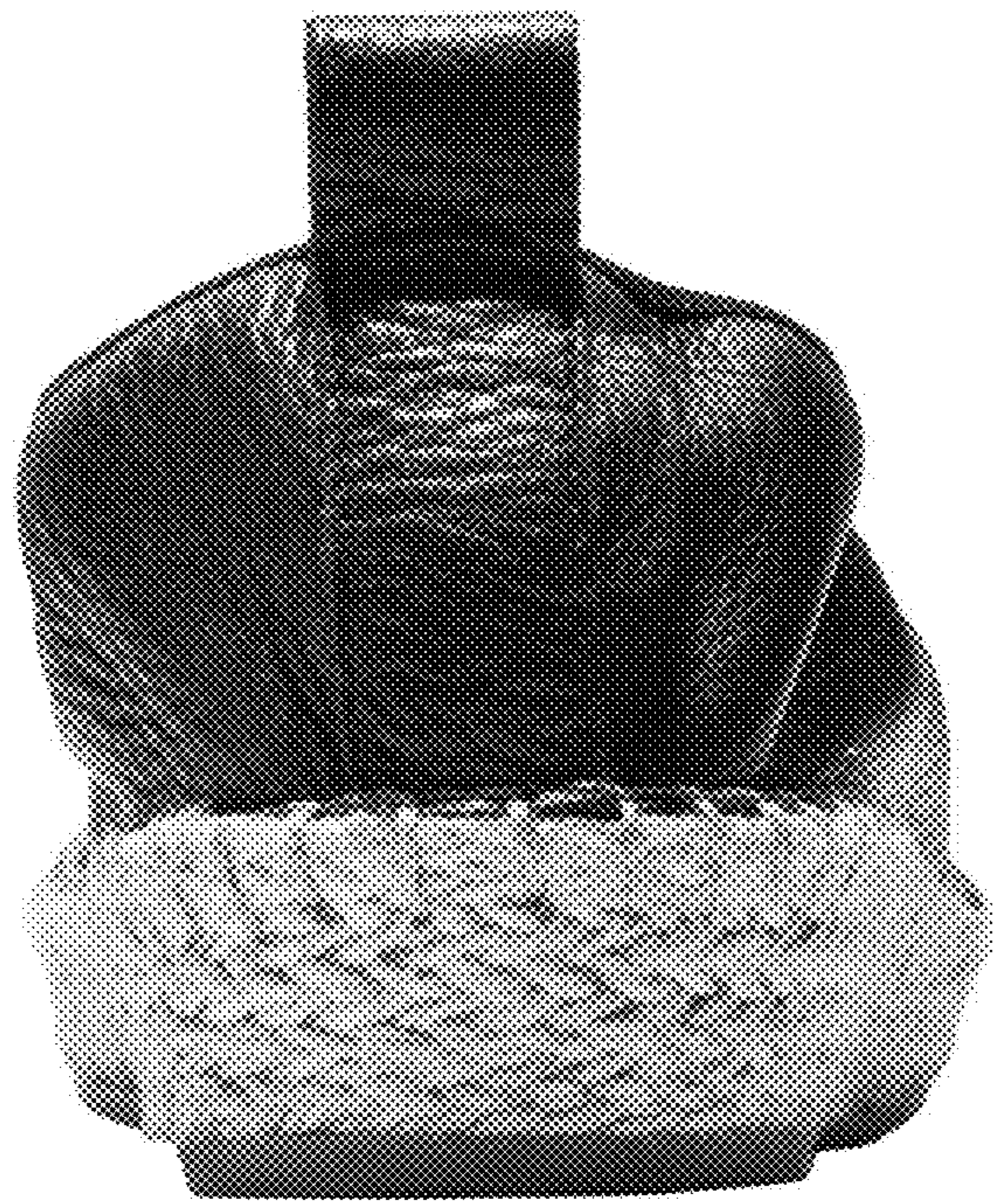
