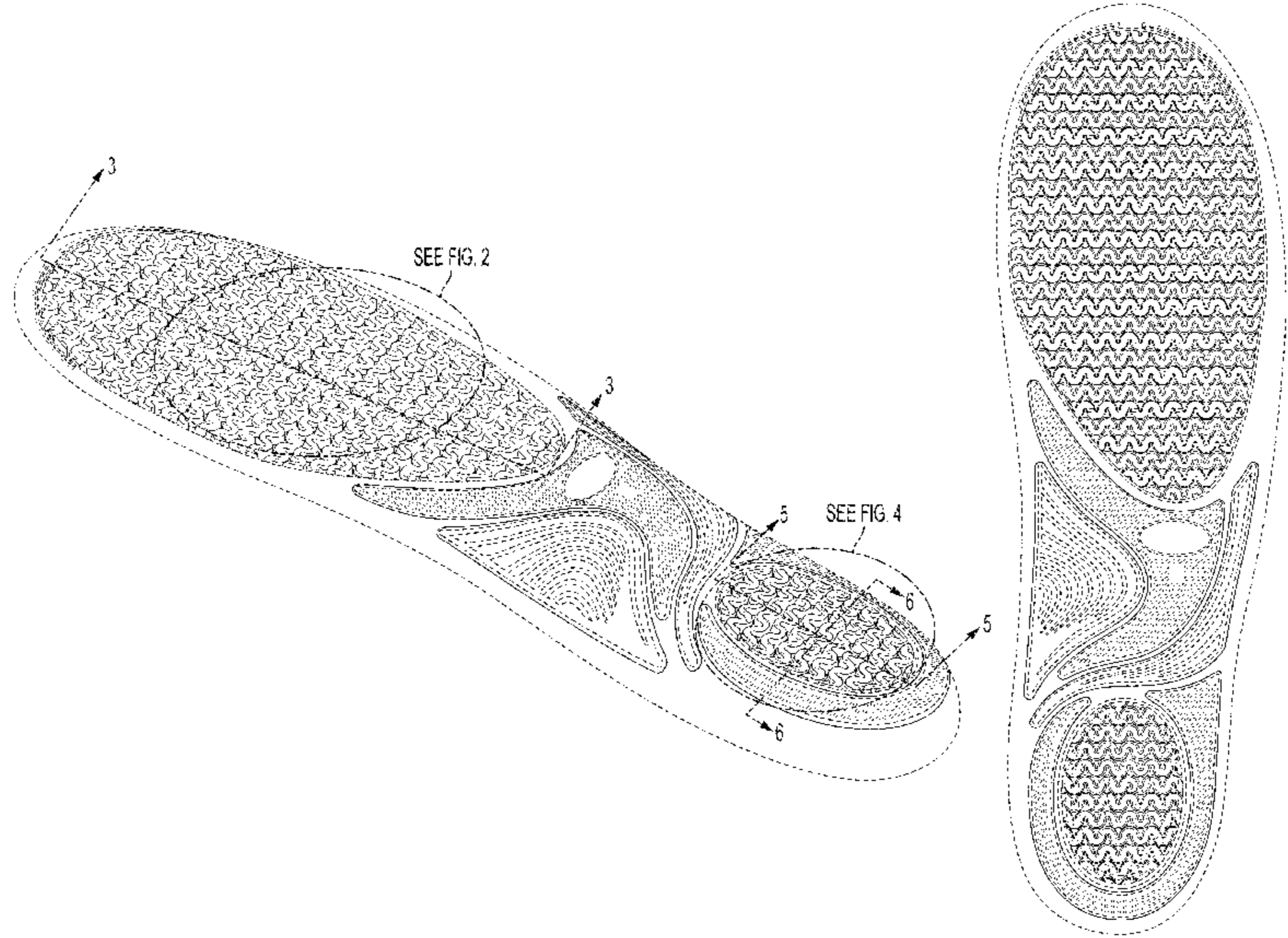

The ornamental design for a portion of an insole, as shown
and described.

DESCRIPTION
FIG. 1 is a perspective view of a portion of an insole
showing our new design;
FIG. 2 is a perspective view of an enlarged portion labeled,
"FIG. 2," in FIG. 1;
FIG. 3 is an enlarged cross-section view taken along line 3-3
of FIG. 1;
FIG. 4 is a perspective view of an enlarged portion labeled,
"FIG. 4," in FIG. 1;
FIG. 5 is an enlarged cross-section view taken along line 5-5
of FIG. 1;
FIG. 6 is an enlarged cross-section view taken along line 6-6
of FIG. 1;
FIG. 7 is a bottom view thereof;
FIG. 8 is a side view thereof;
FIG. 9 is an opposite side view thereof;
FIG. 10 is a front view thereof; and,
FIG. 11 is a rear view thereof.
The dash-dot lines in the drawings represent the boundary

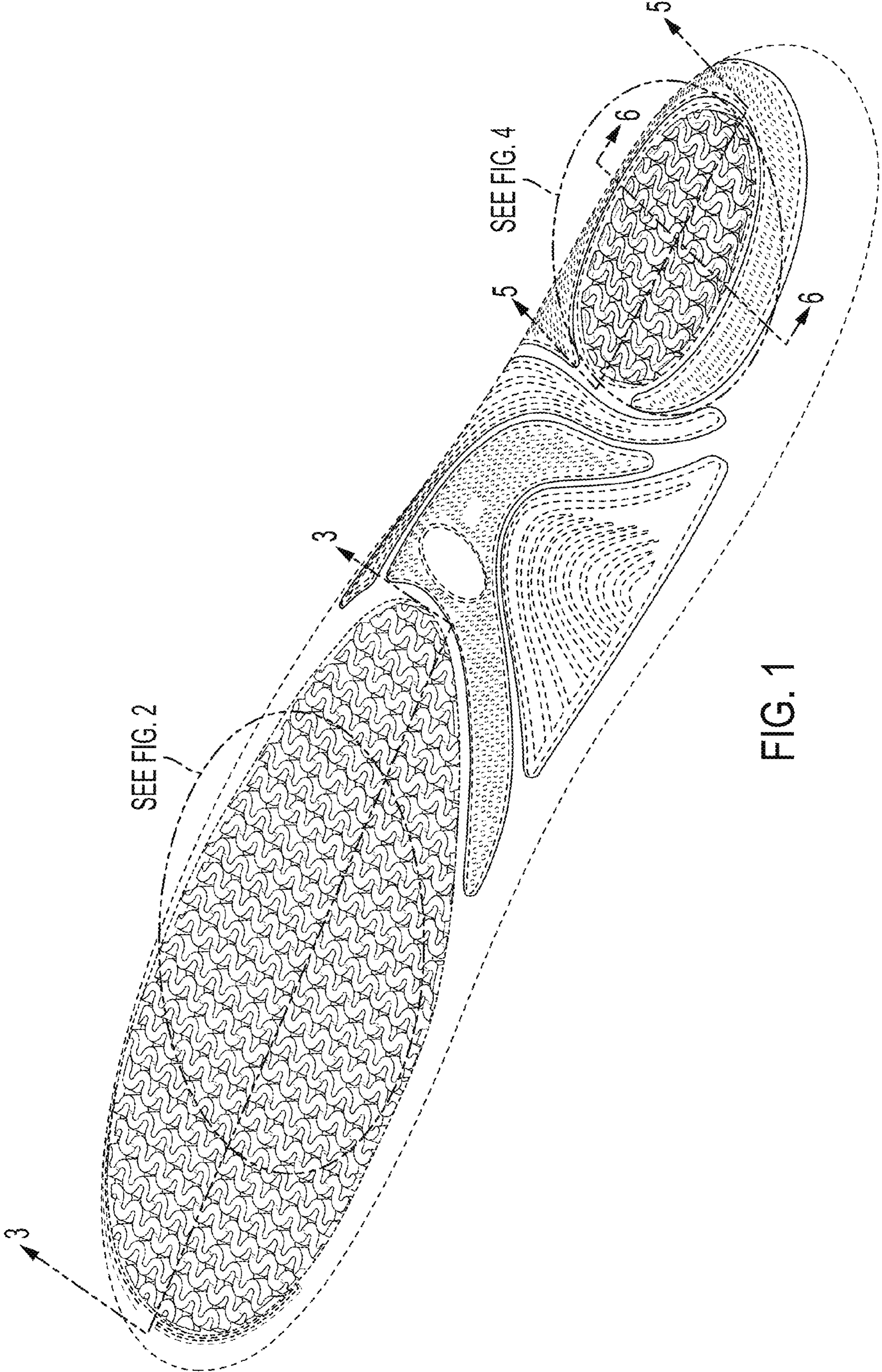

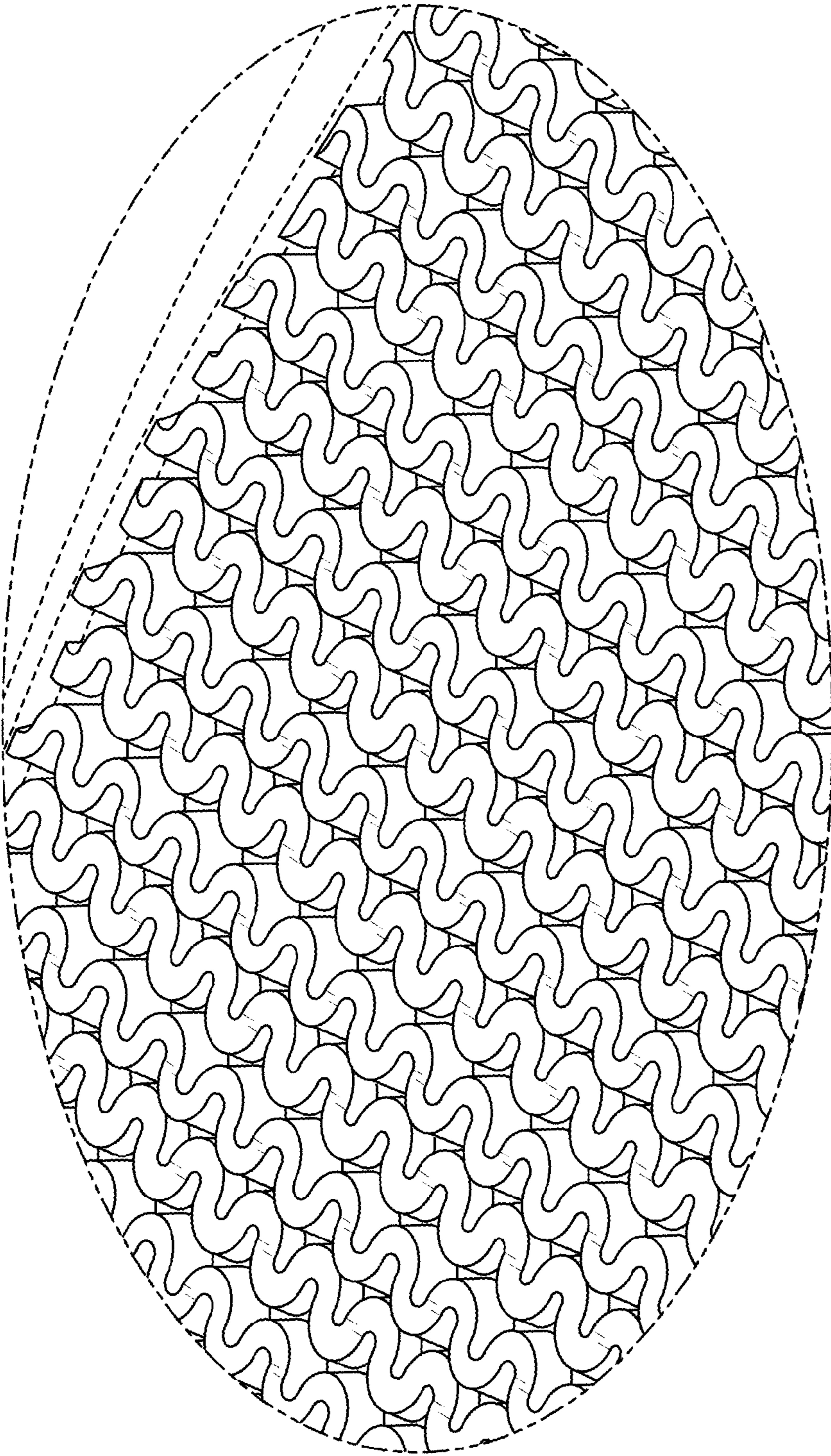

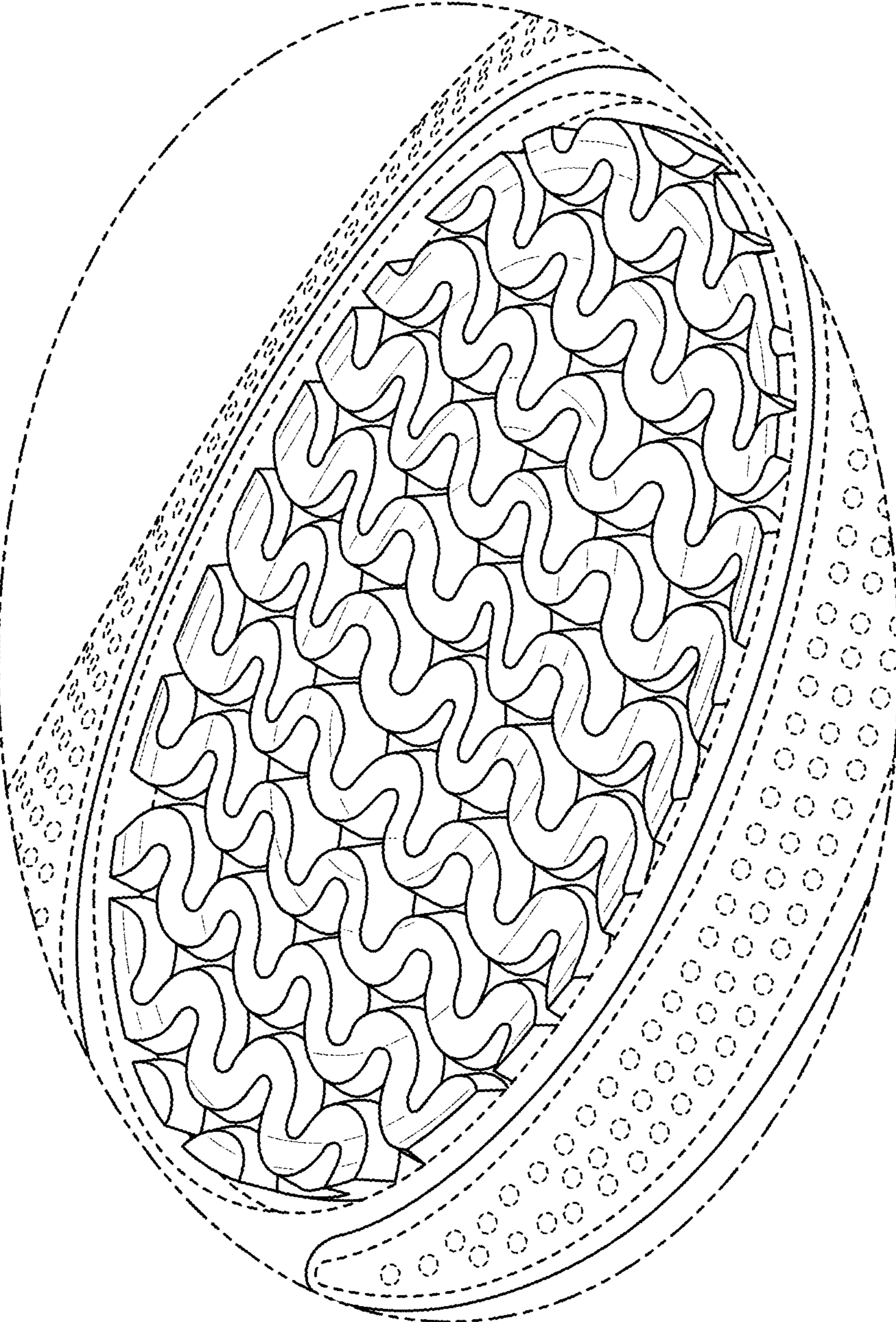

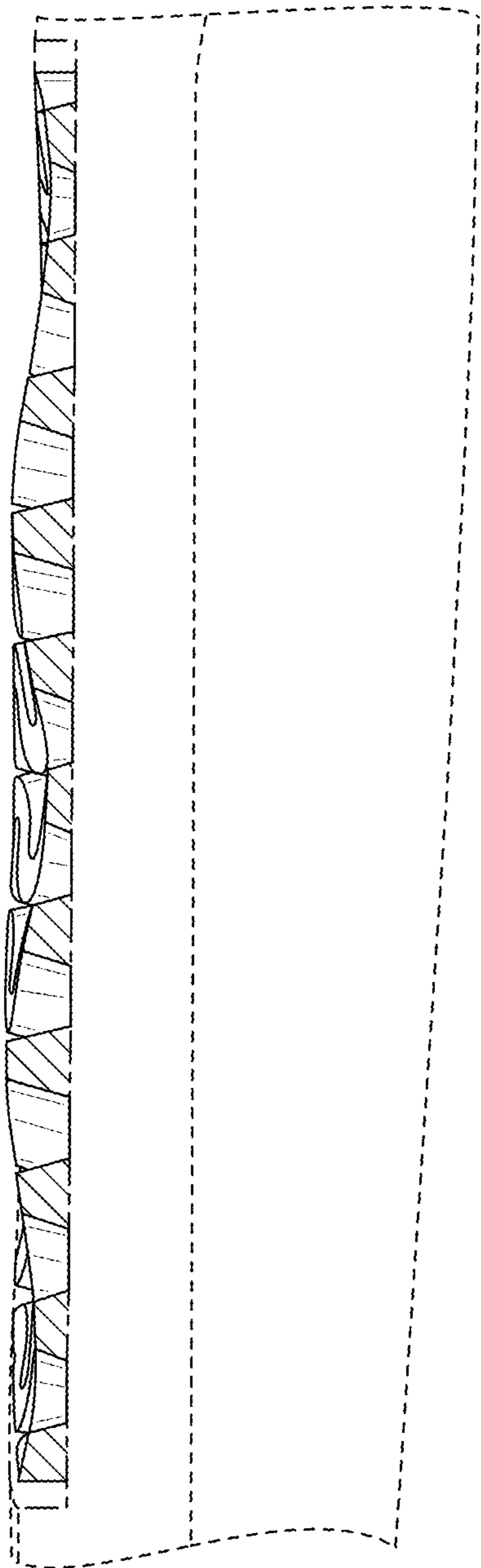

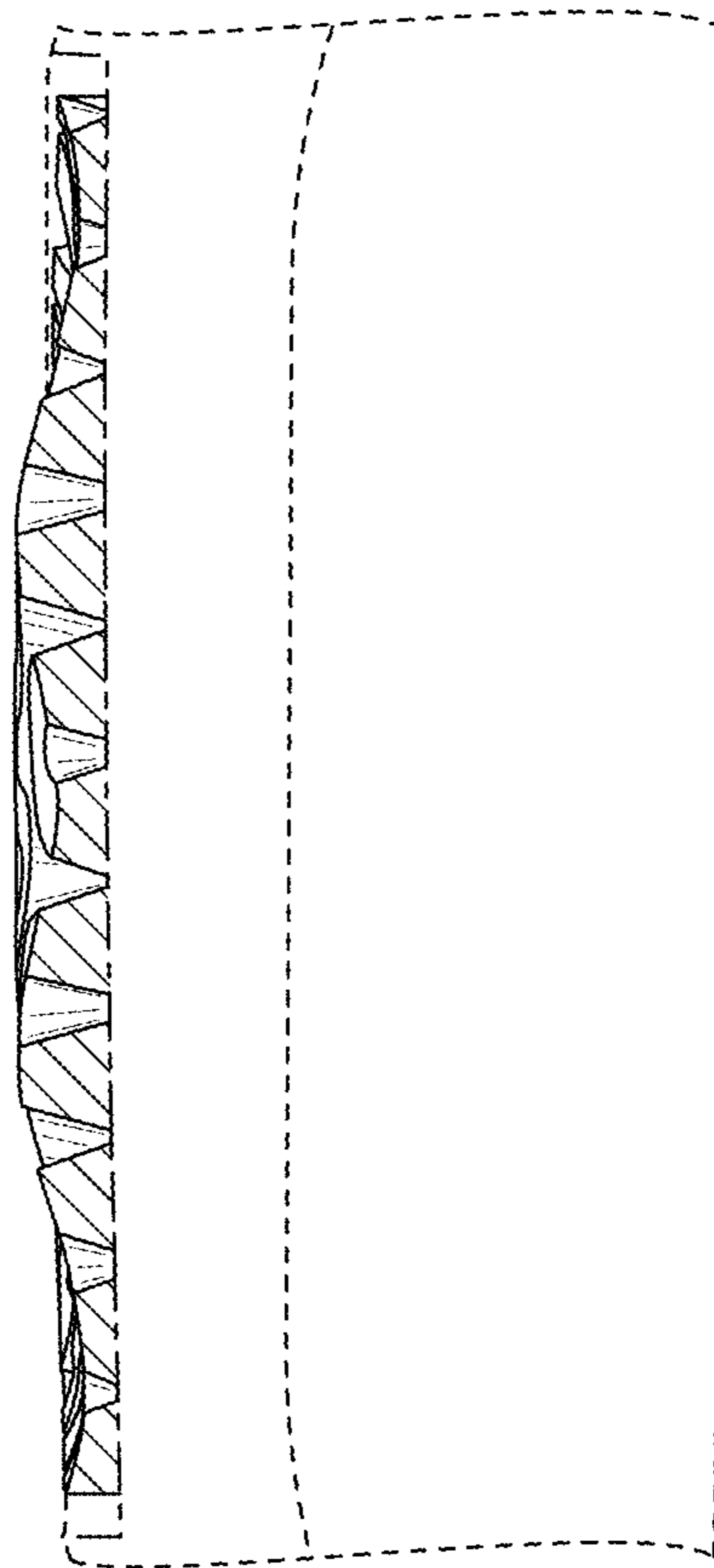

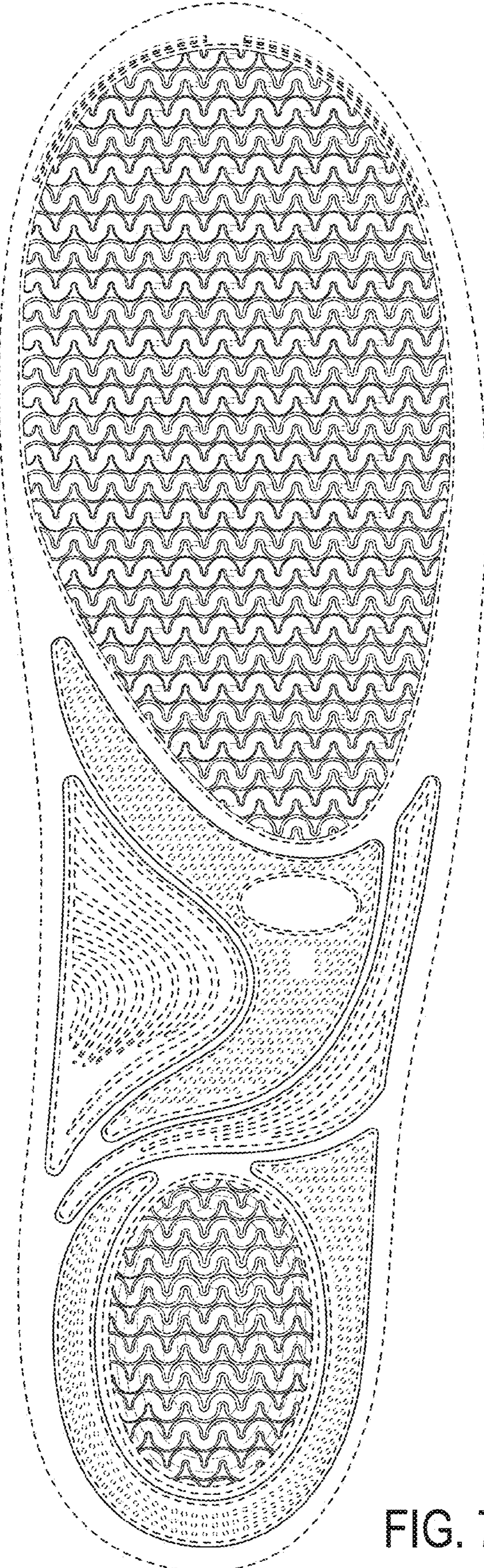

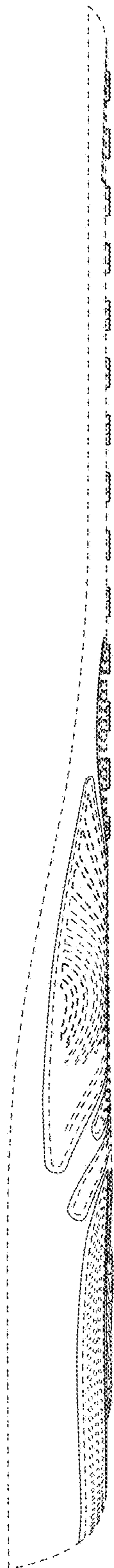

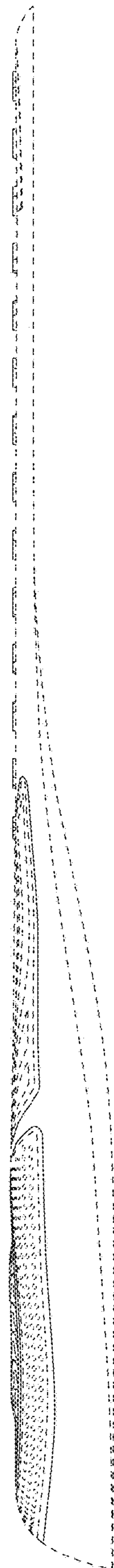

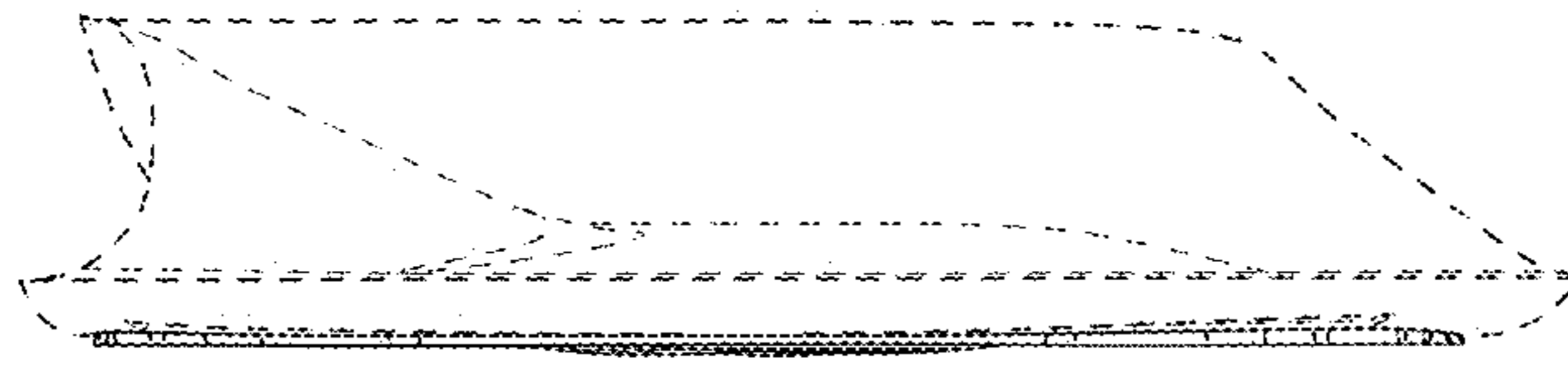

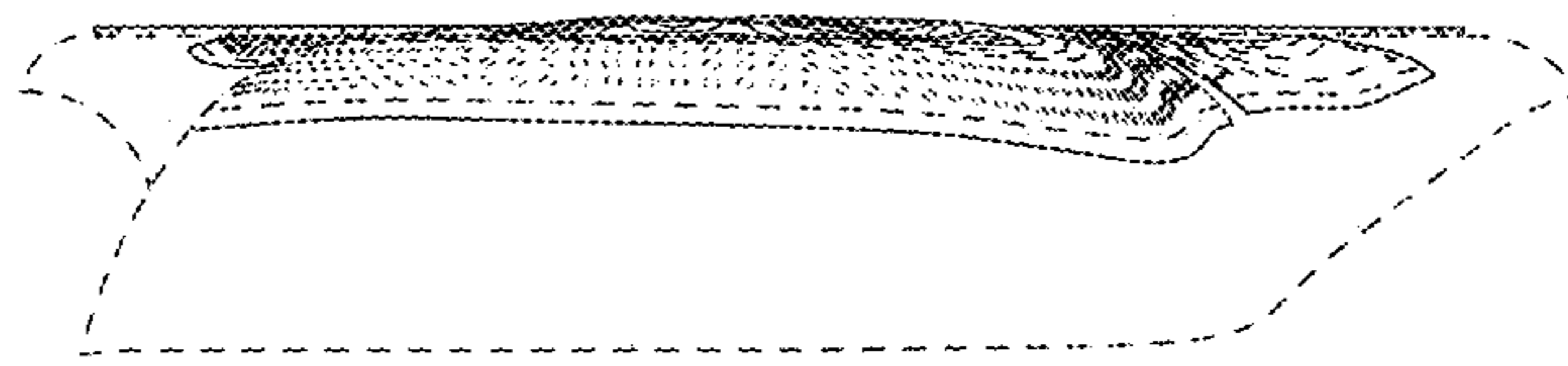
