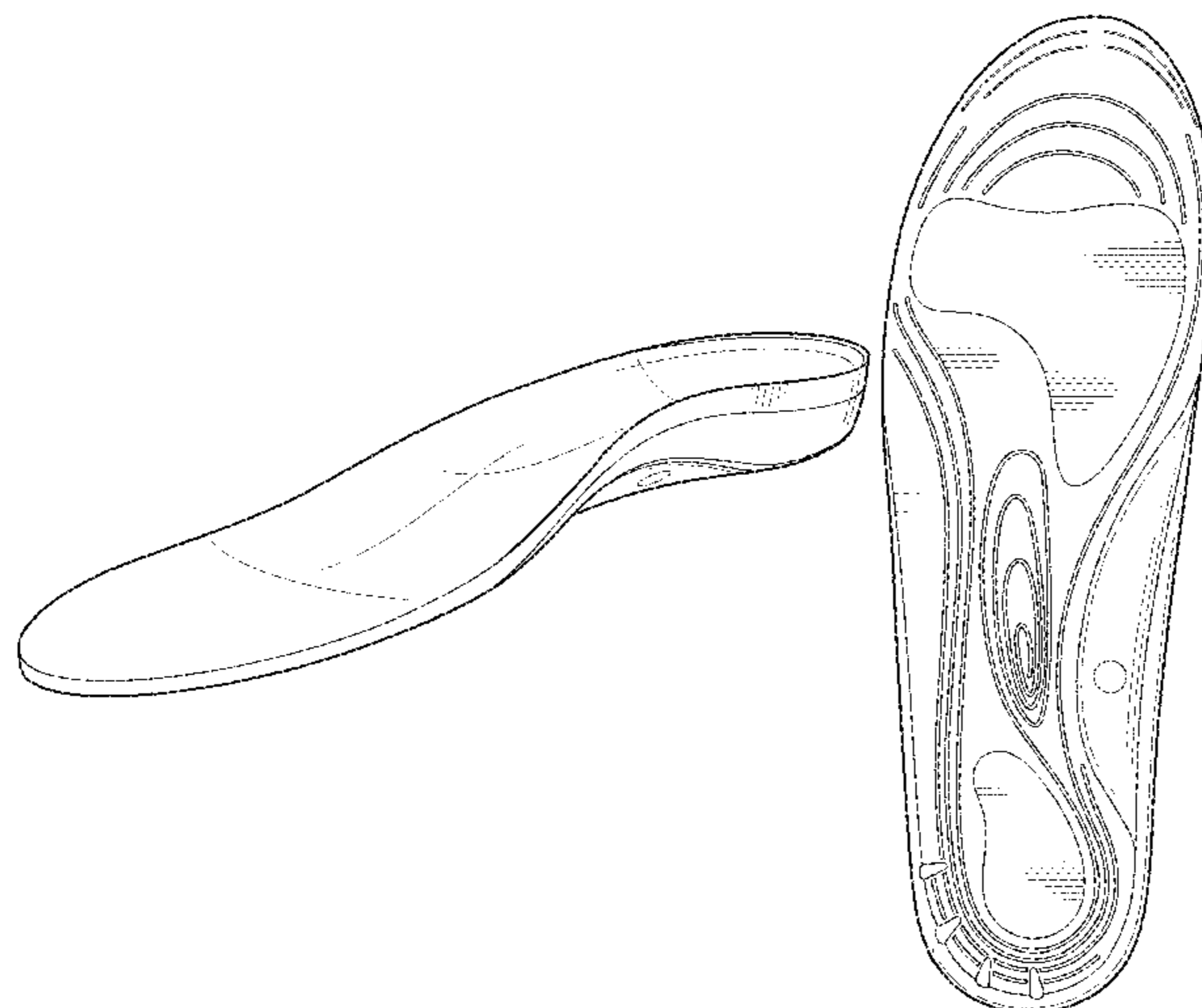

**DESCRIPTION**  
FIG. 1 is a perspective view of an insole, showing our new design;  
FIG. 2 is a bottom plan view thereof;  
FIG. 3 is a side elevation view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is an opposite side elevation view thereof;  
FIG. 6 is a front elevation view thereof; and,  
FIG. 7 is a rear elevation view thereof.

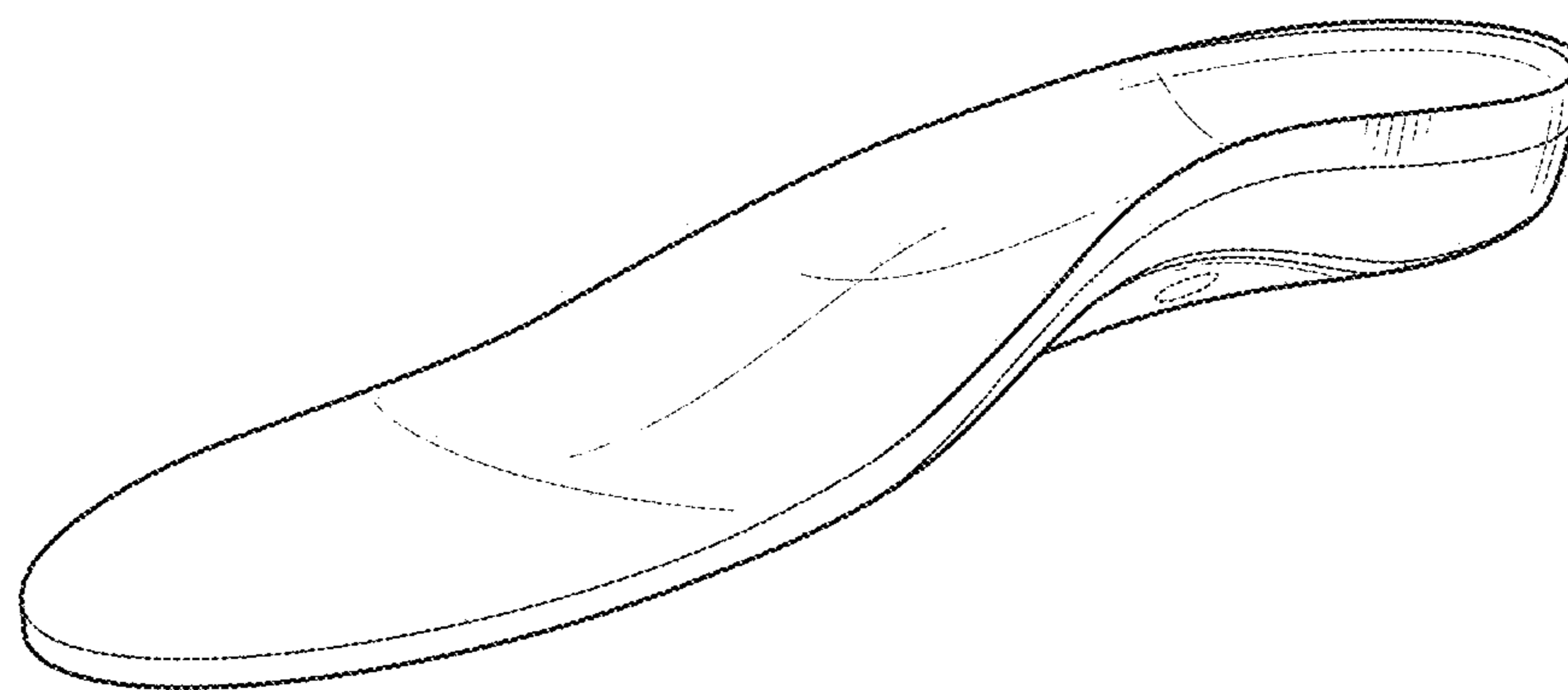

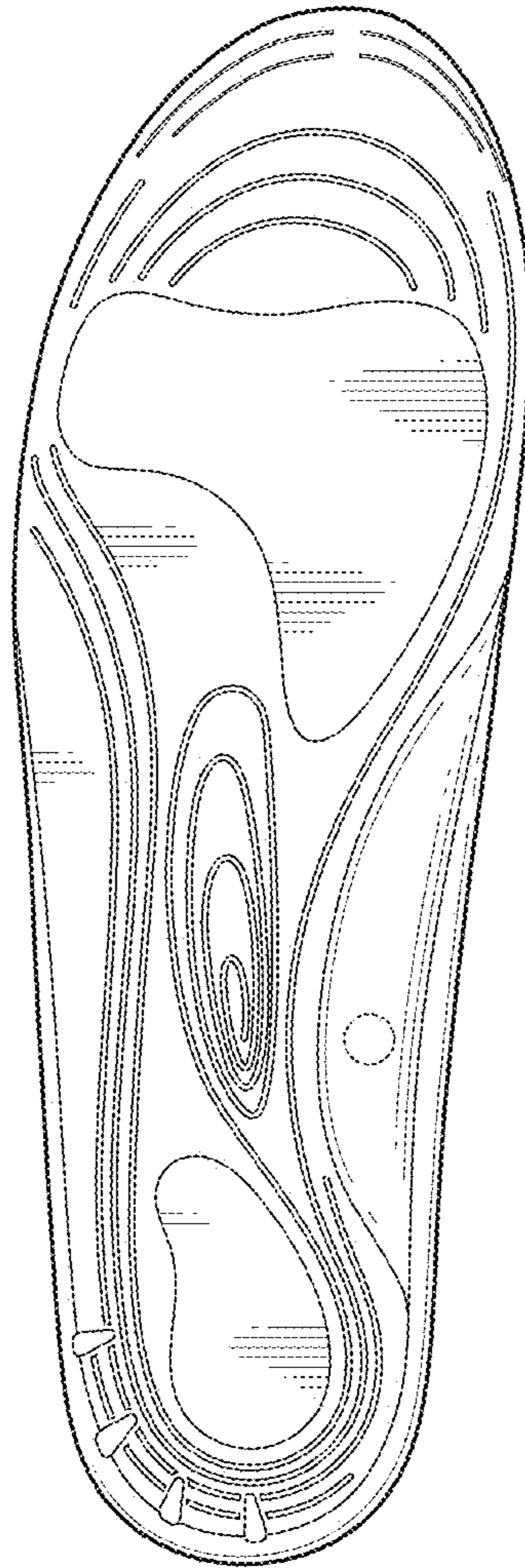

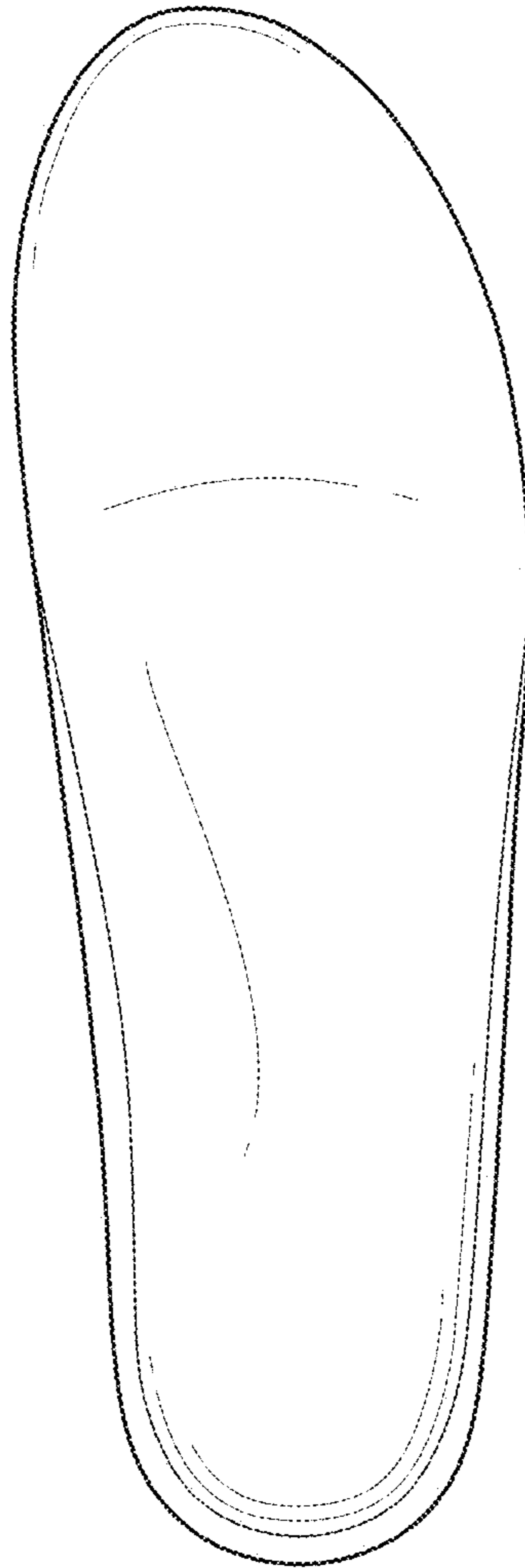

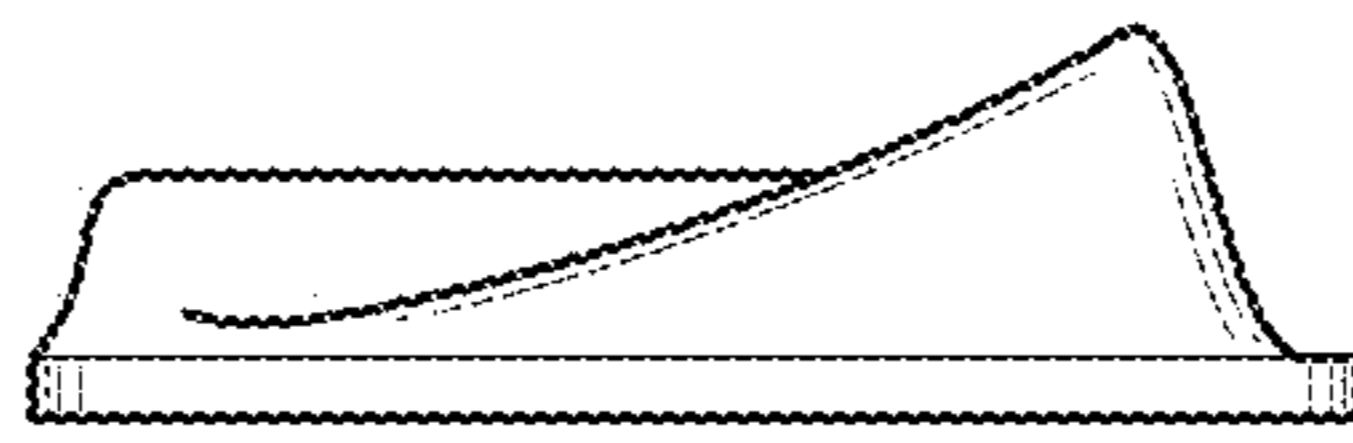

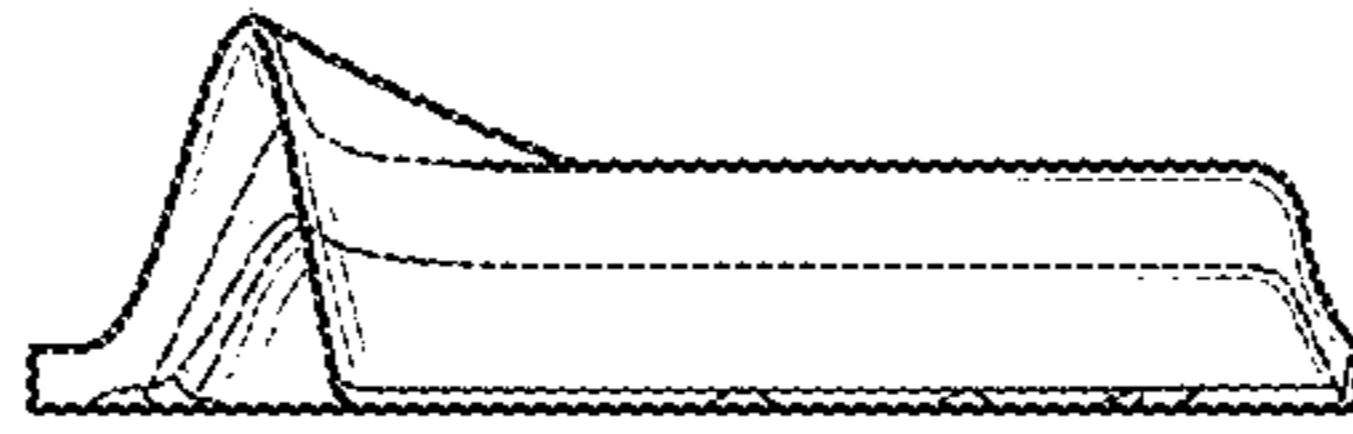
