DESCRIPTION

FIG. 1 is a first perspective view of a shoe showing our new design;
FIG. 2 is a right side view thereof;

FIG. 5 is a bottom view thereof;

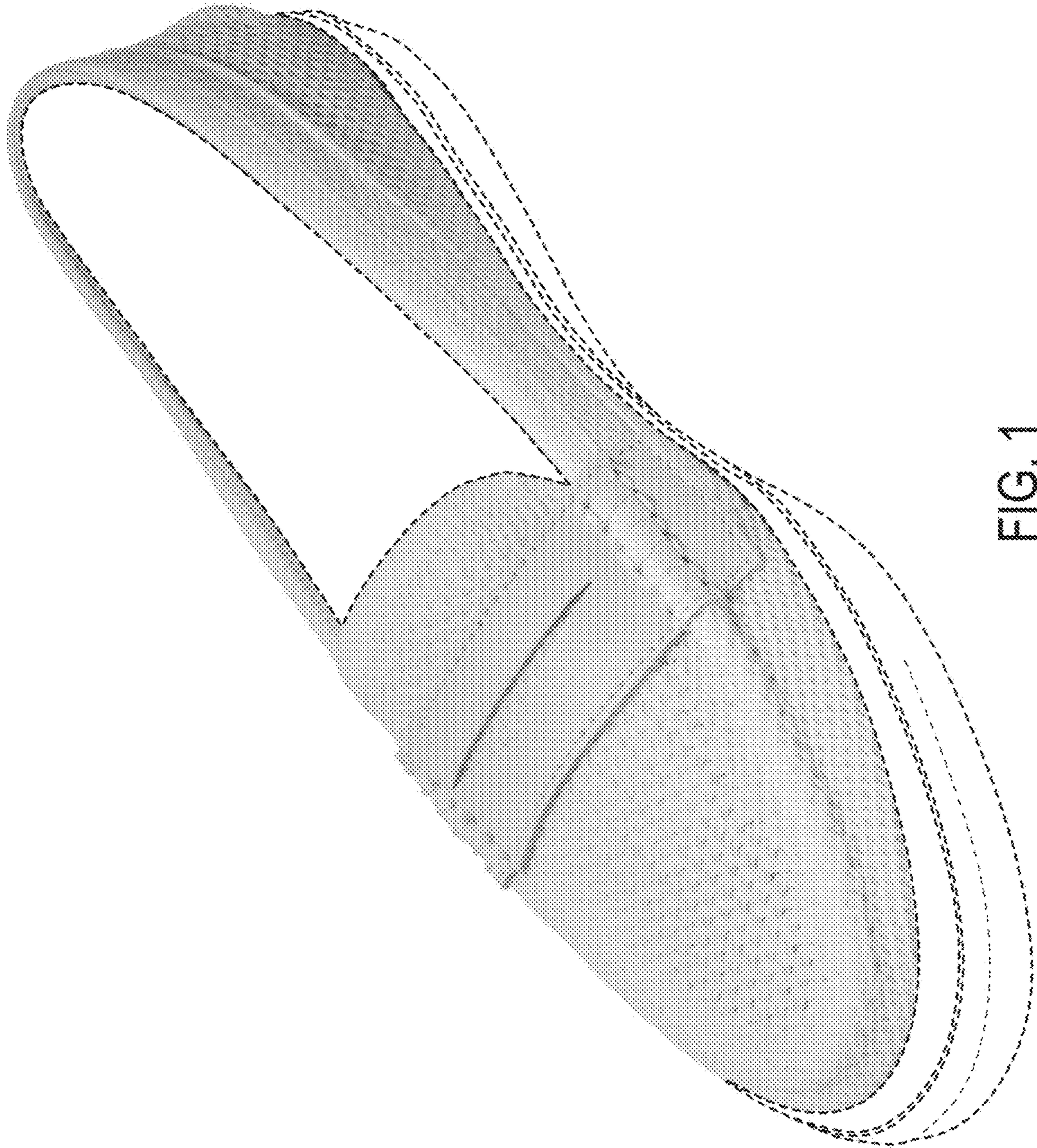

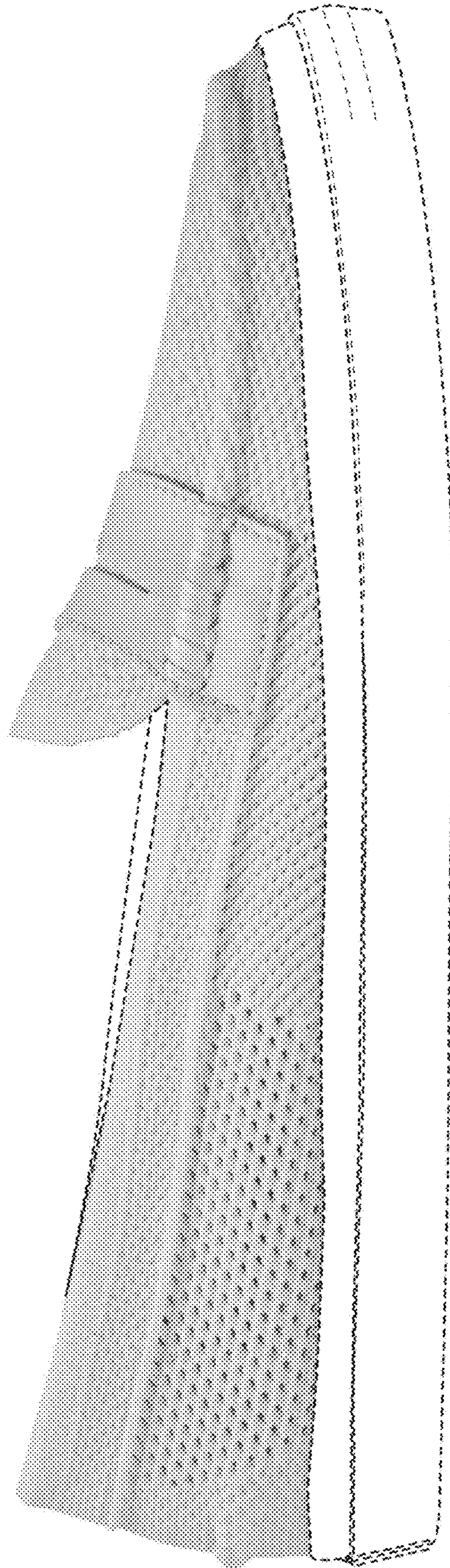

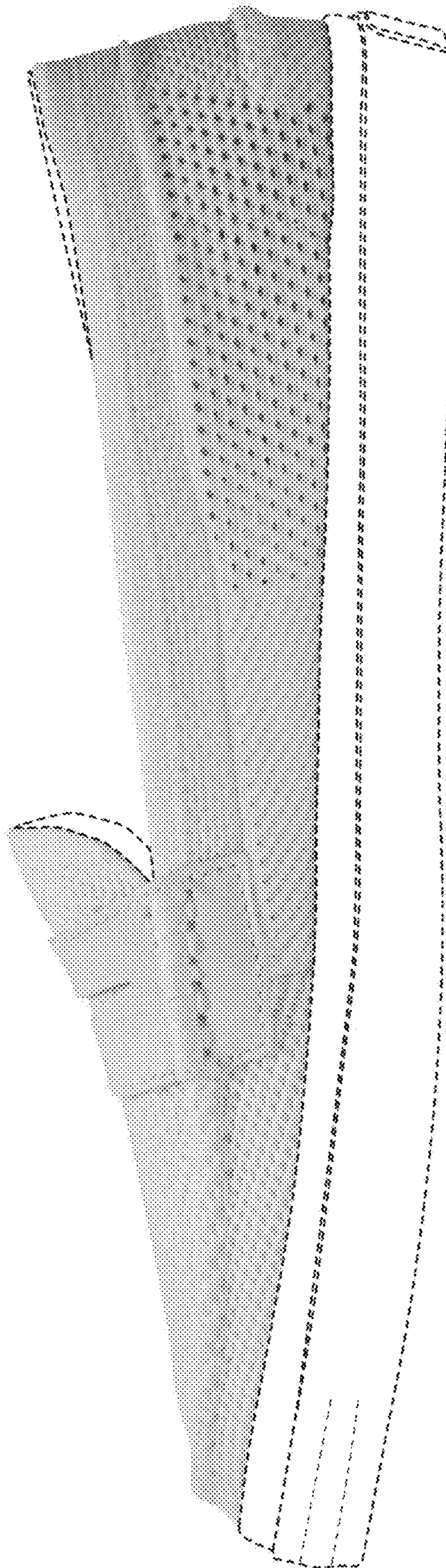

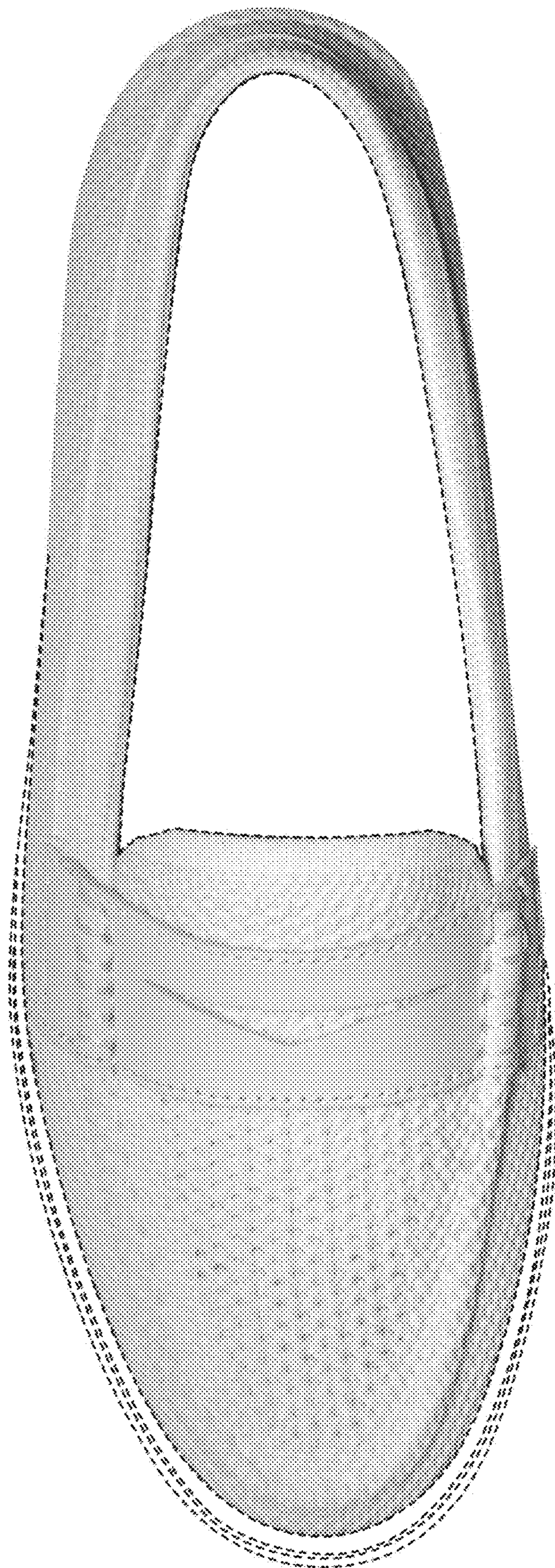

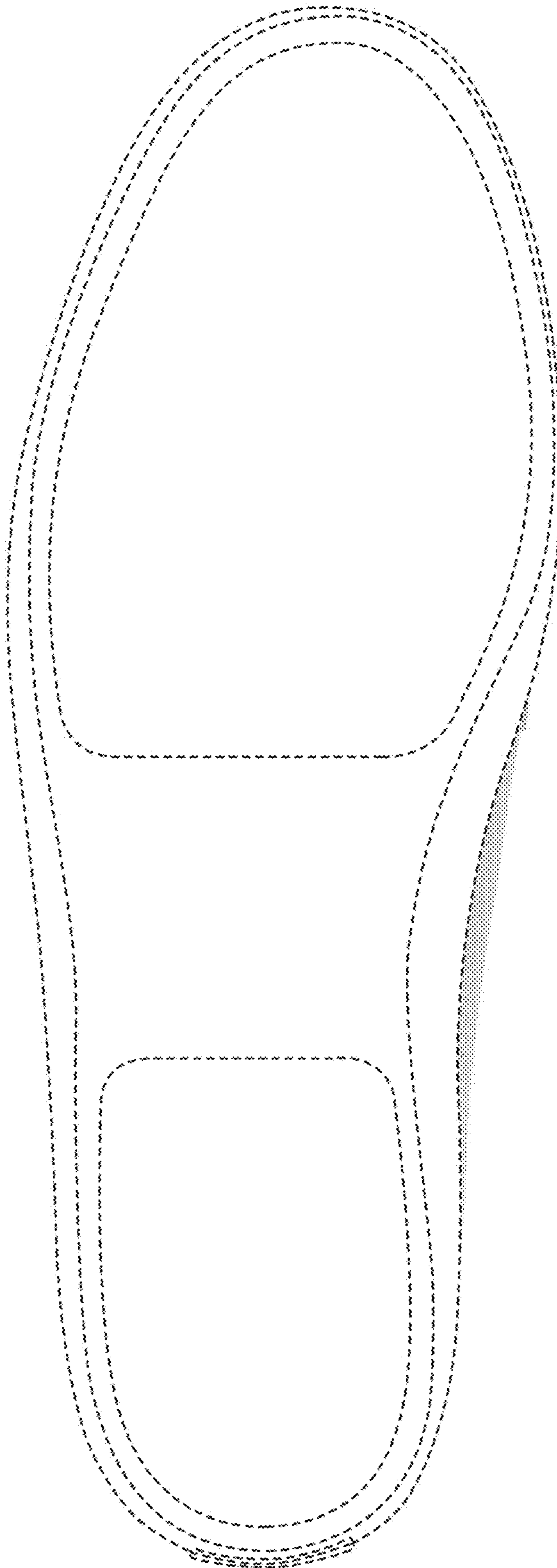

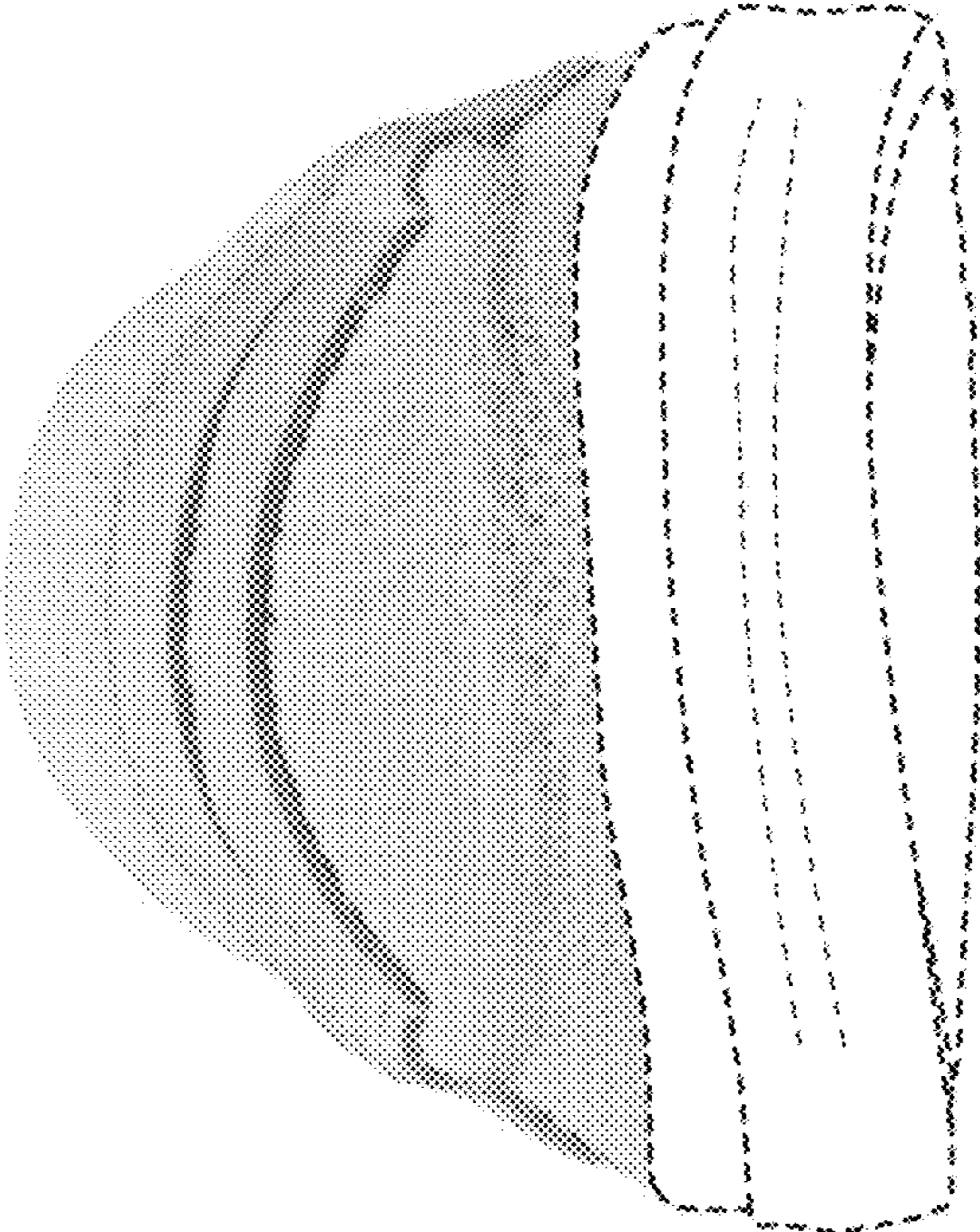

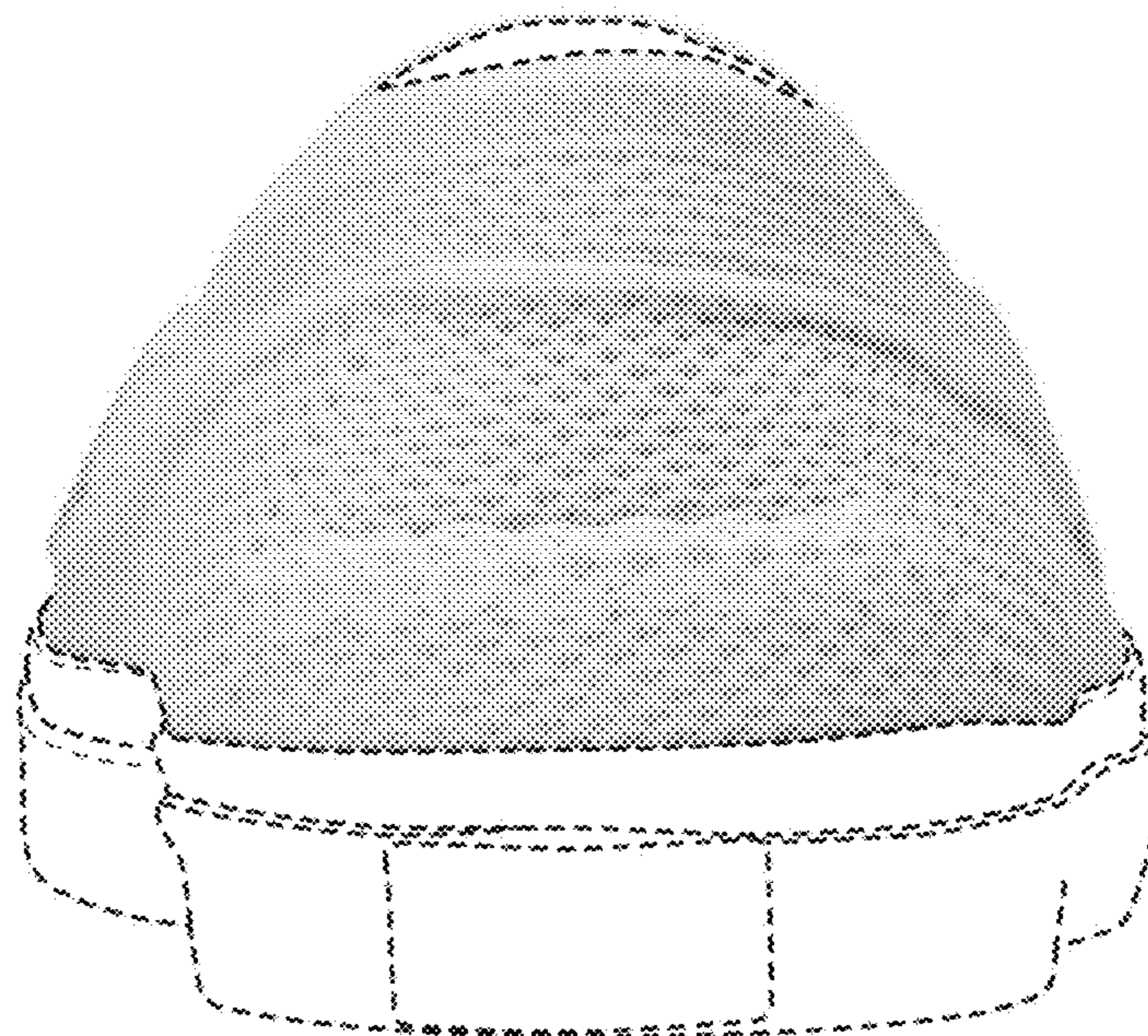
