DESCRIPTION

FIG. 5 is an opposite side view thereof;

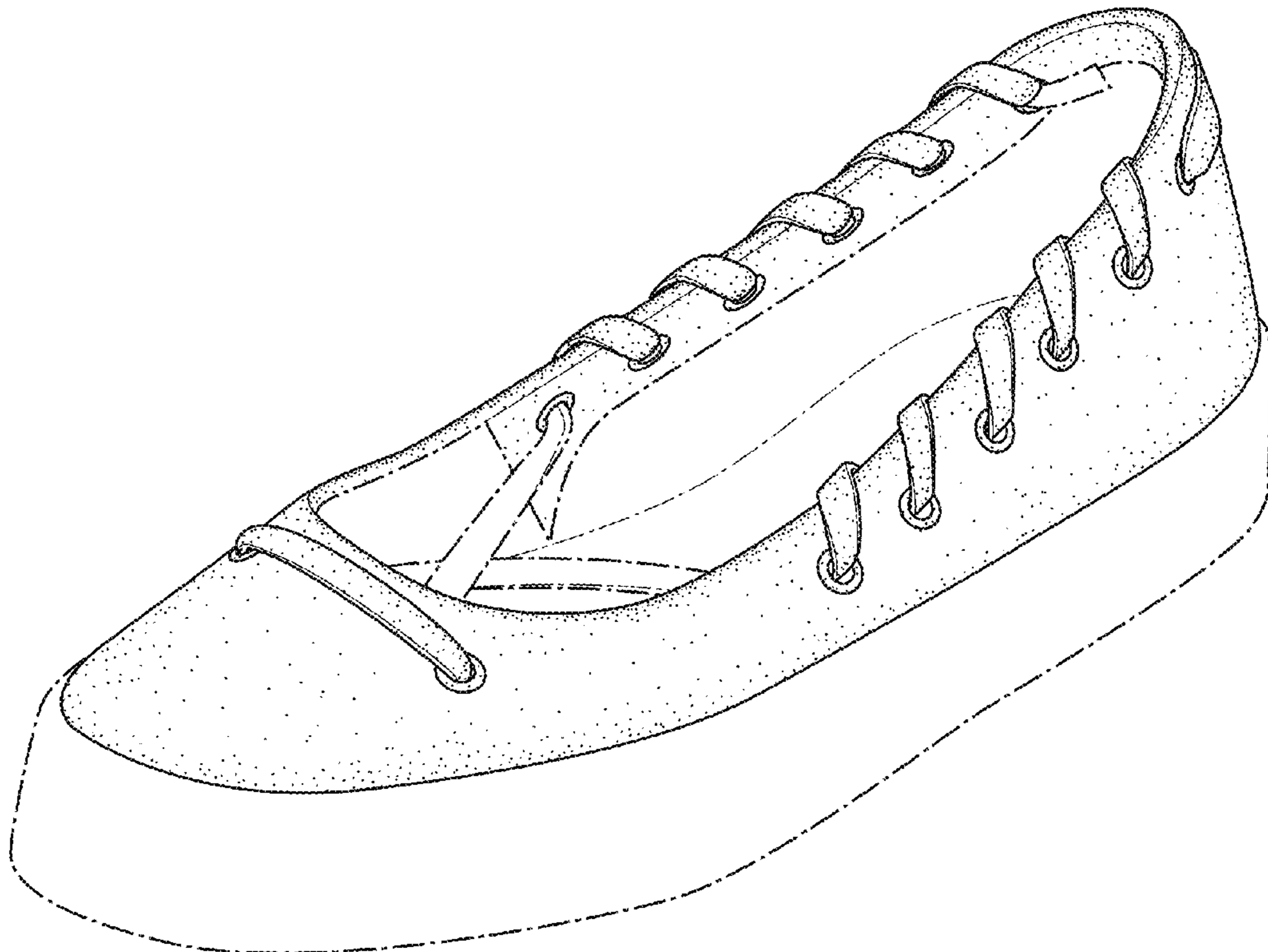
FIG. 6 is an opposite front perspective view thereof;

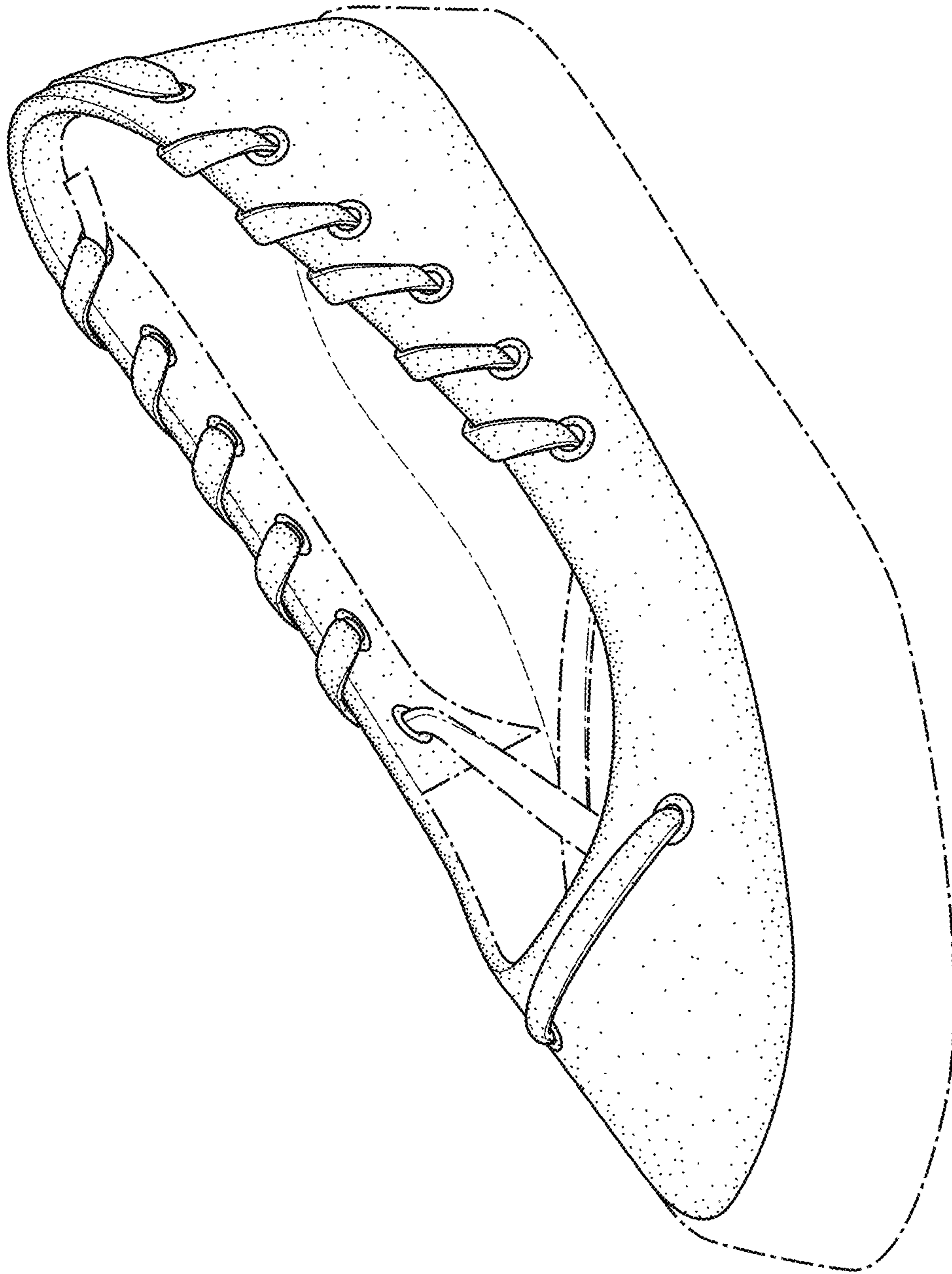

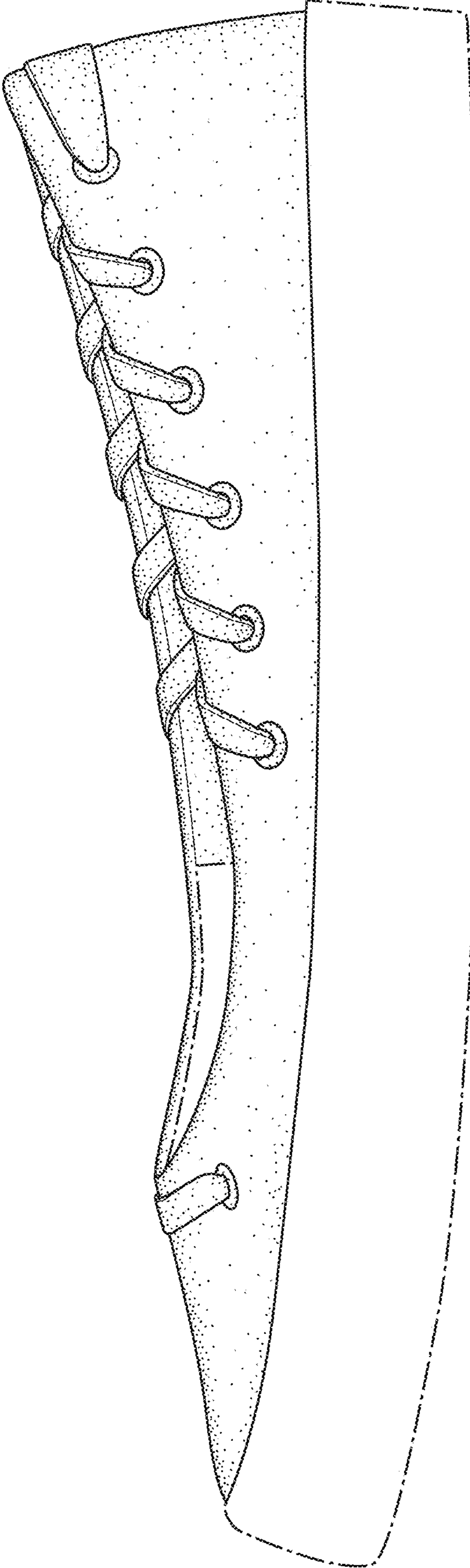

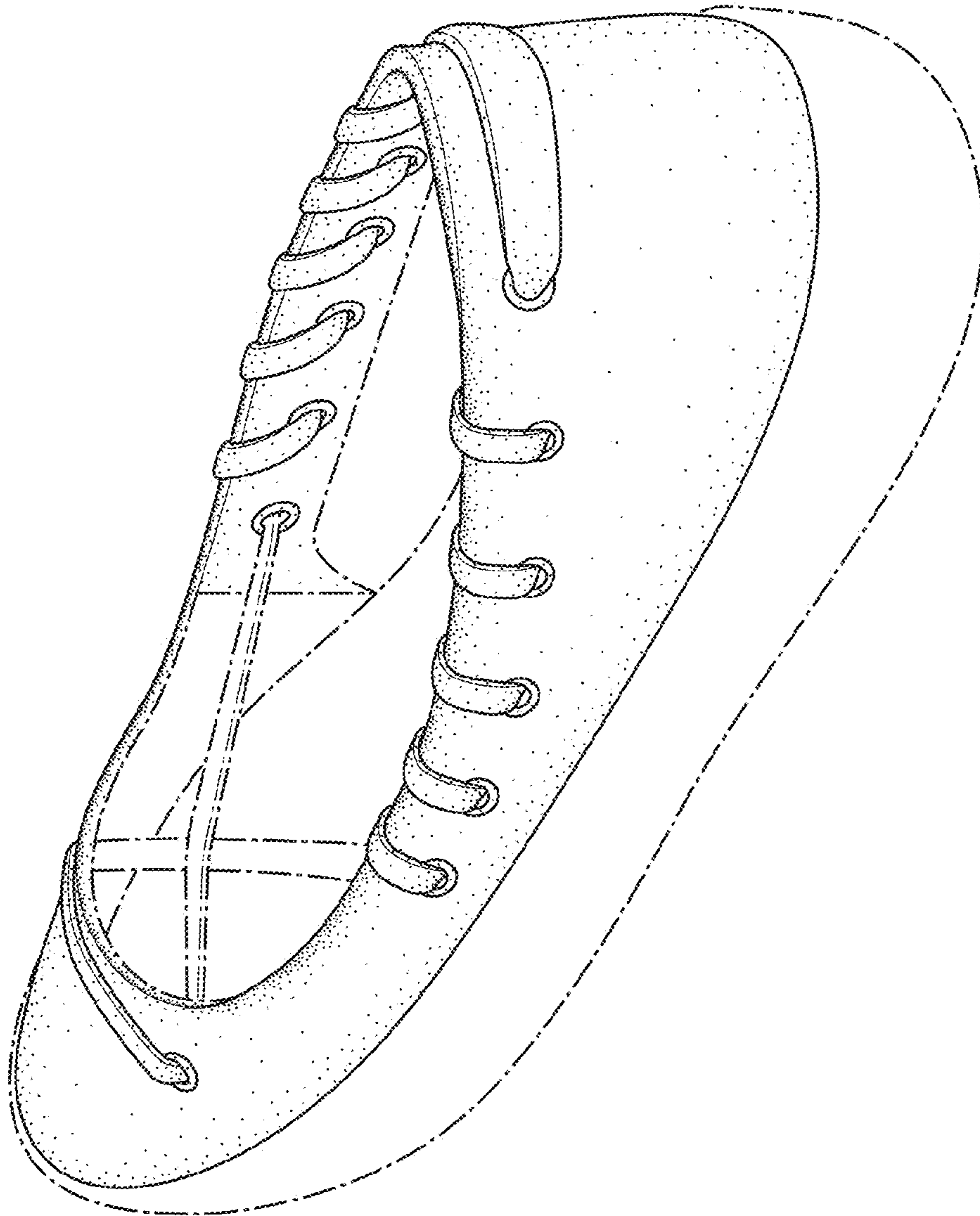

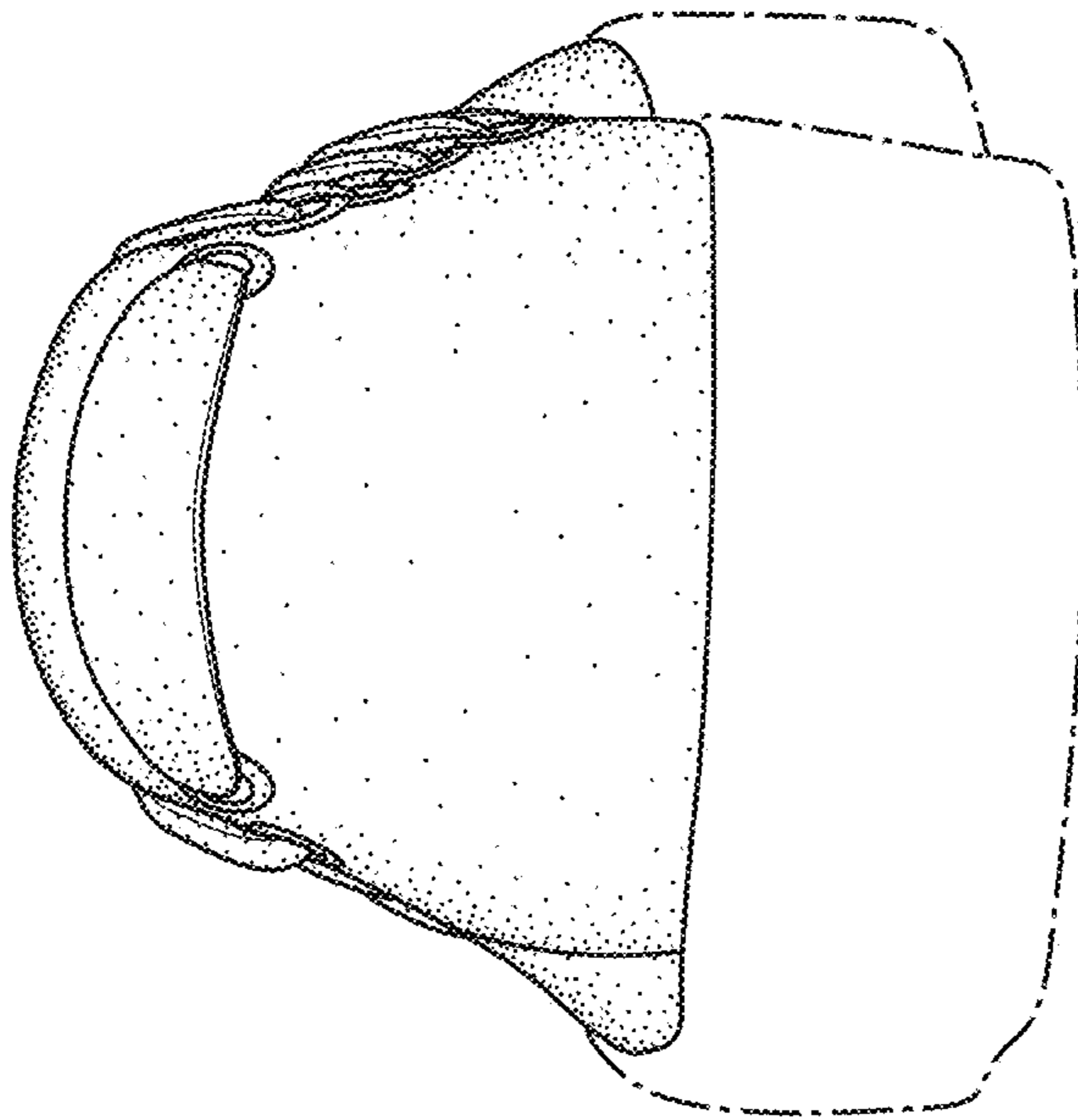

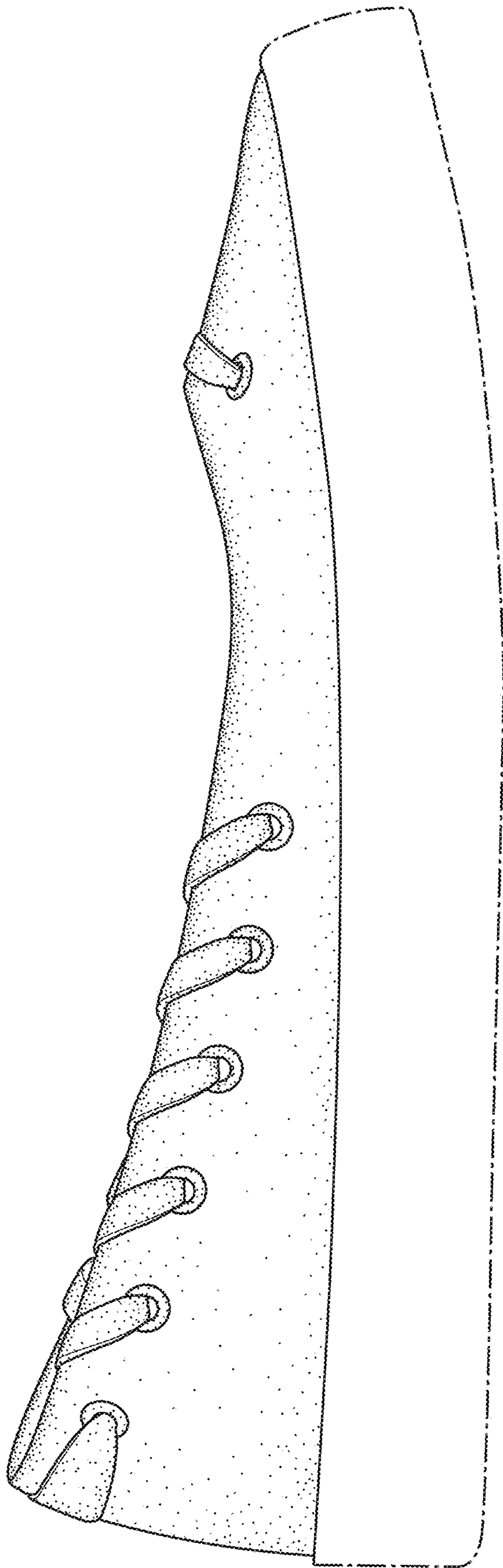

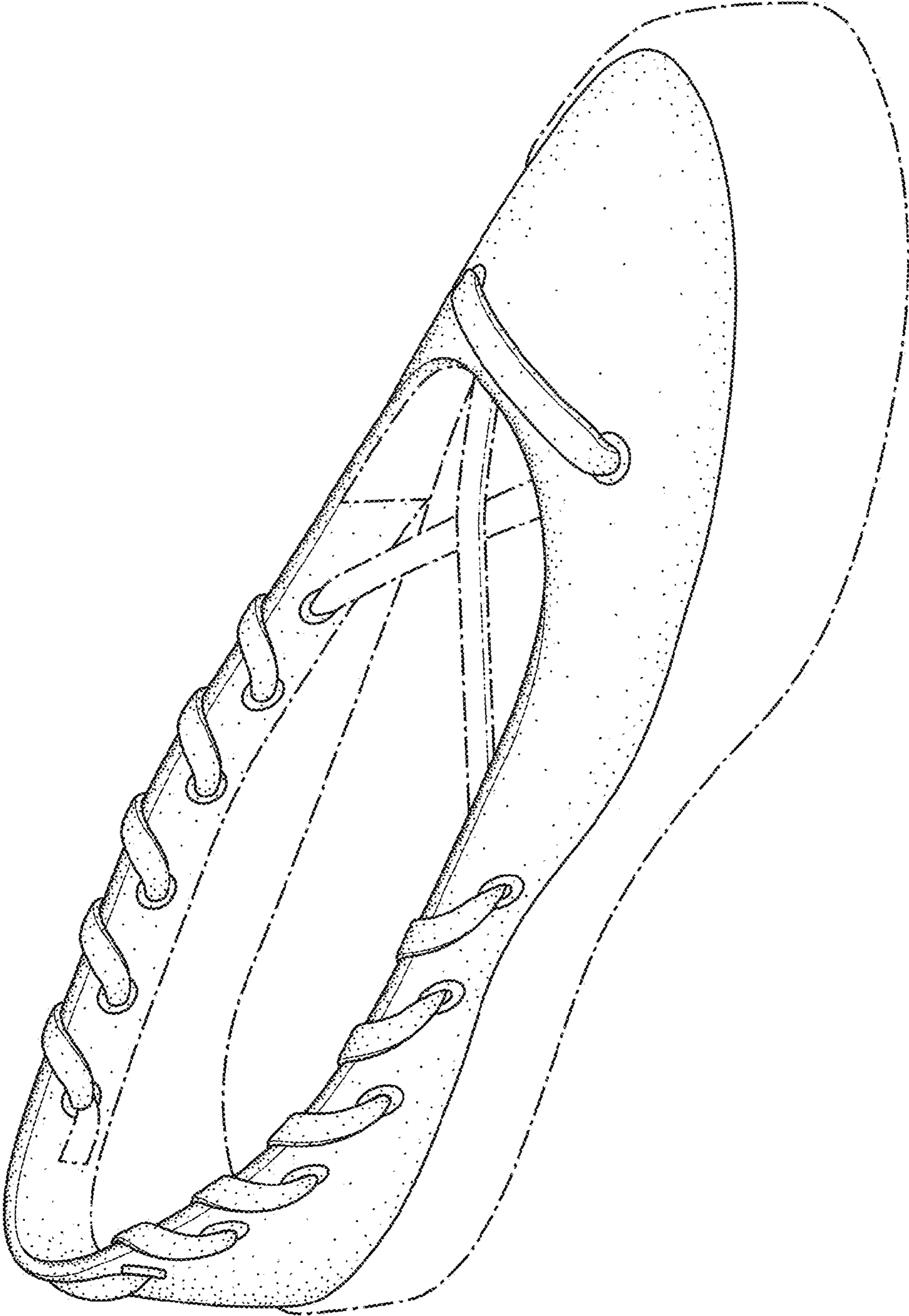

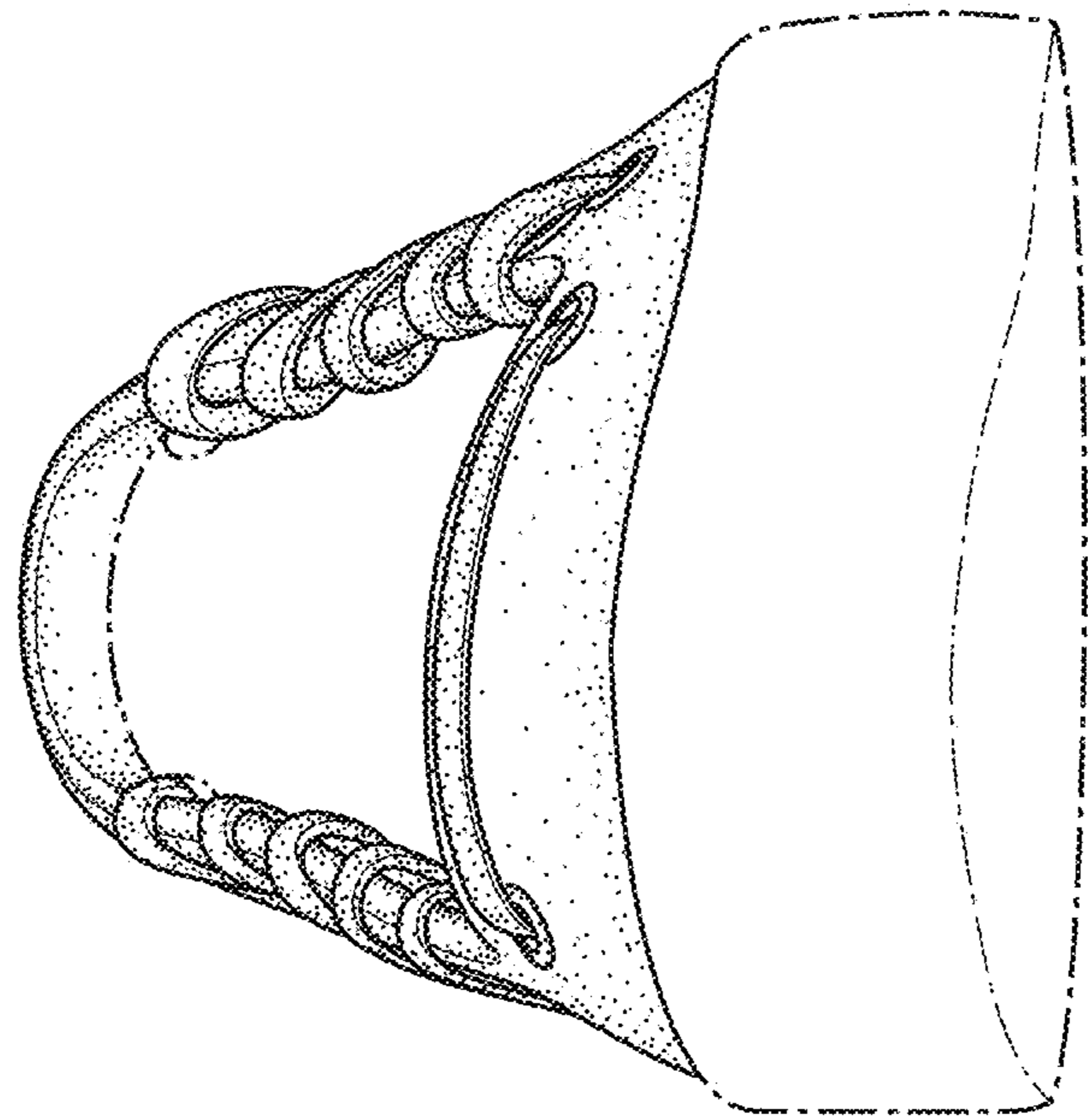

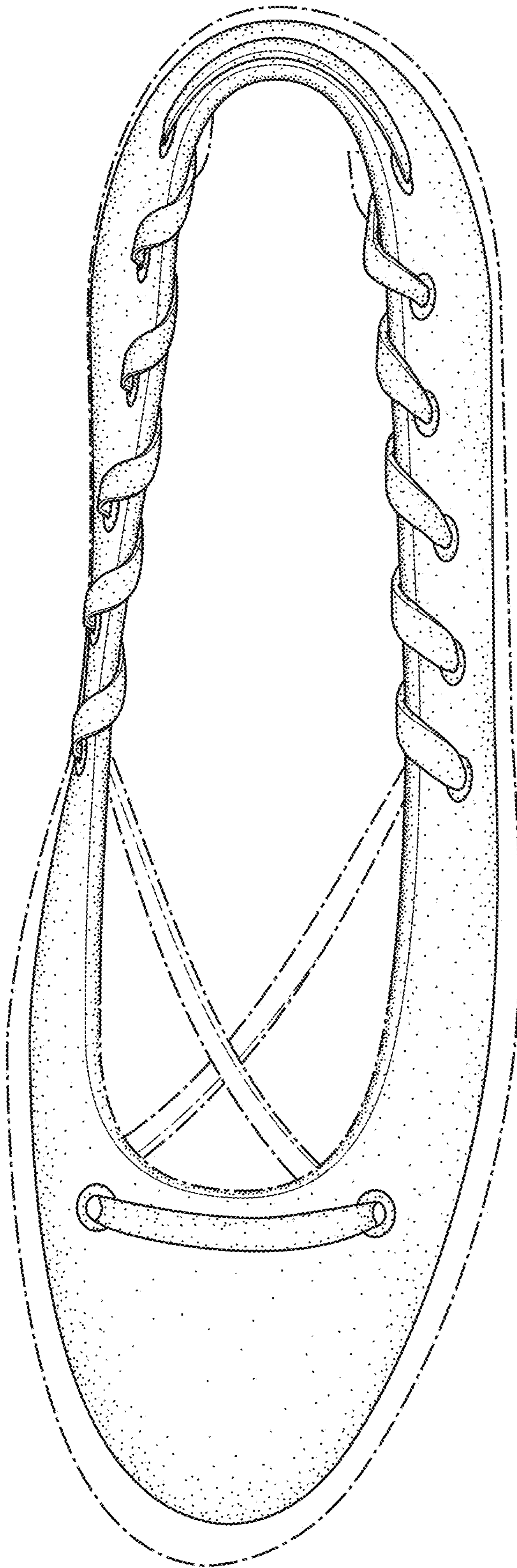
