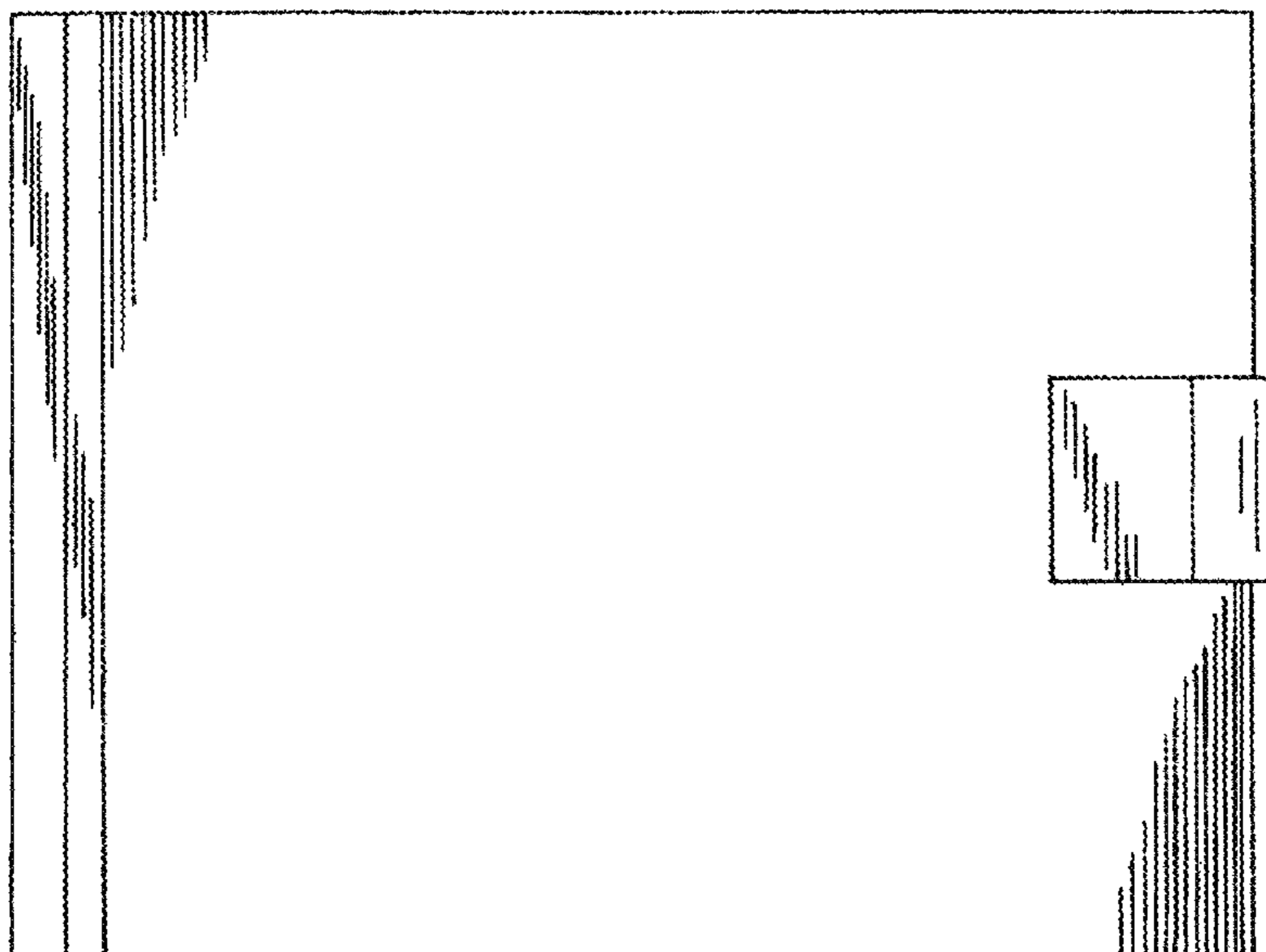
(57) **CLAIM**

The ornamental design for a waterproof document wallet with transparent document sleeves, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a waterproof document wallet with transparent document sleeves;  
FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image of FIG. 2;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a rear elevation view thereof; and,  
FIG. 6 is a perspective view thereof, shown in a partially open configuration, with one of the interior transparent document sleeves opened.

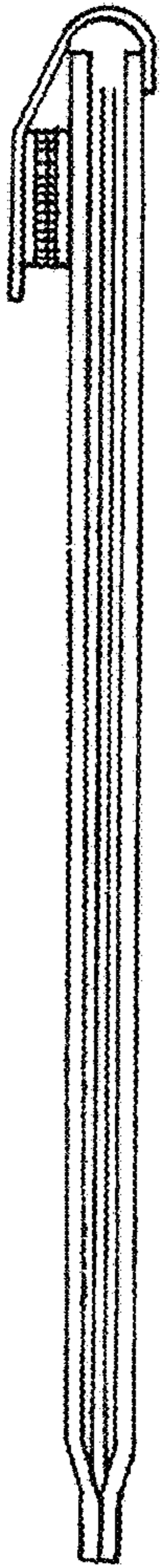

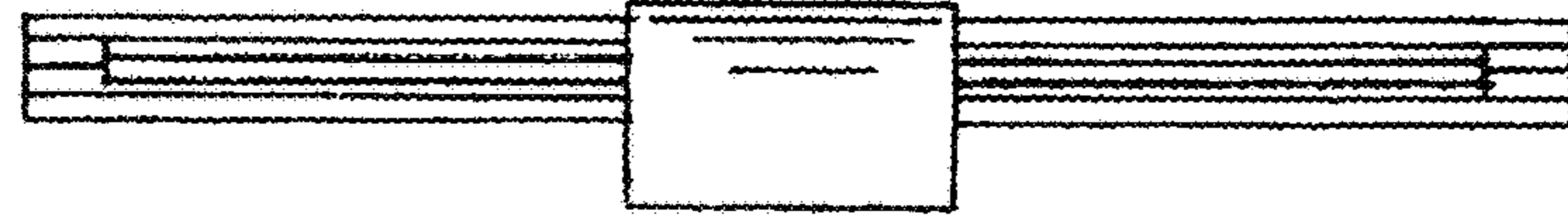

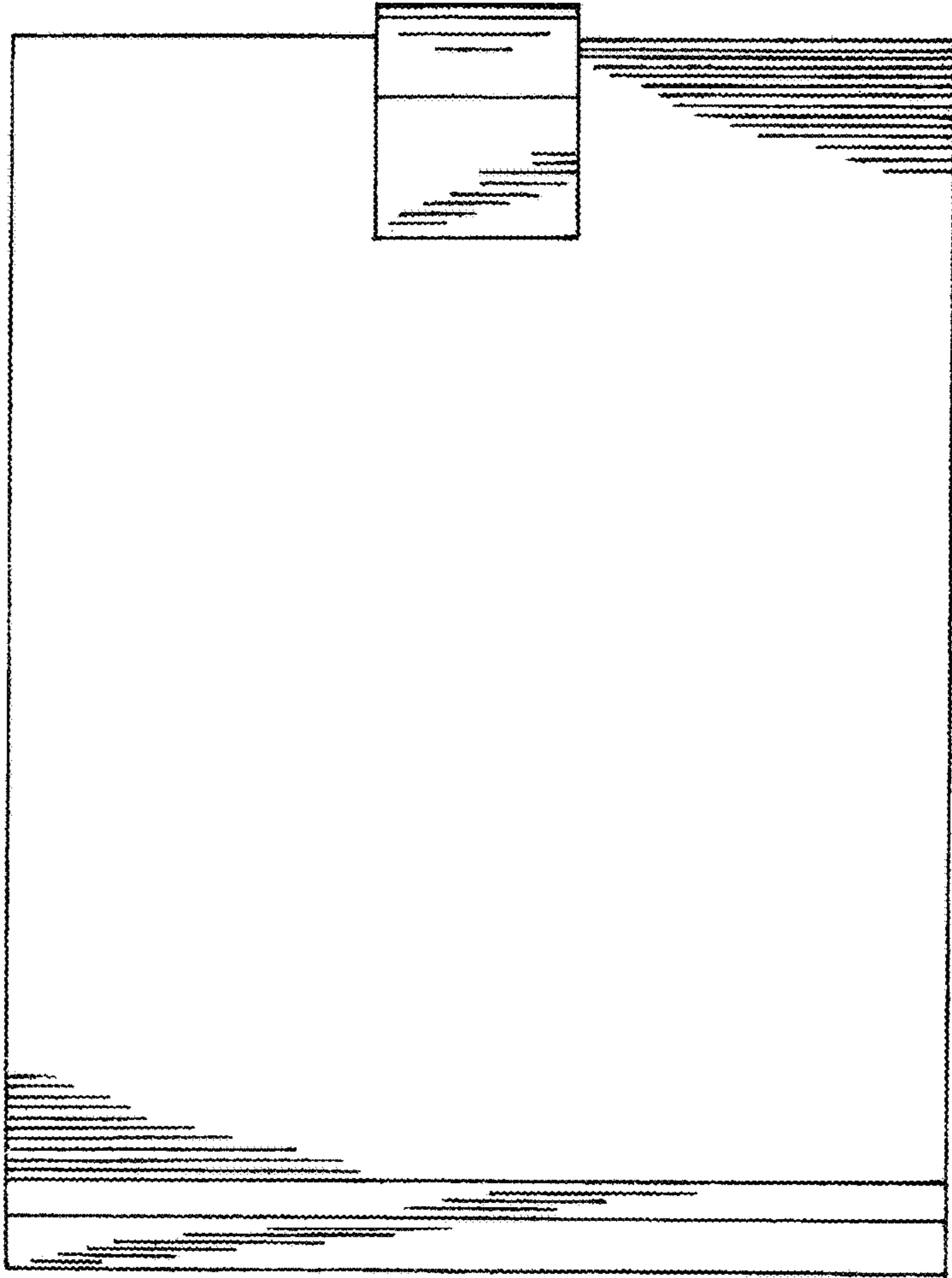

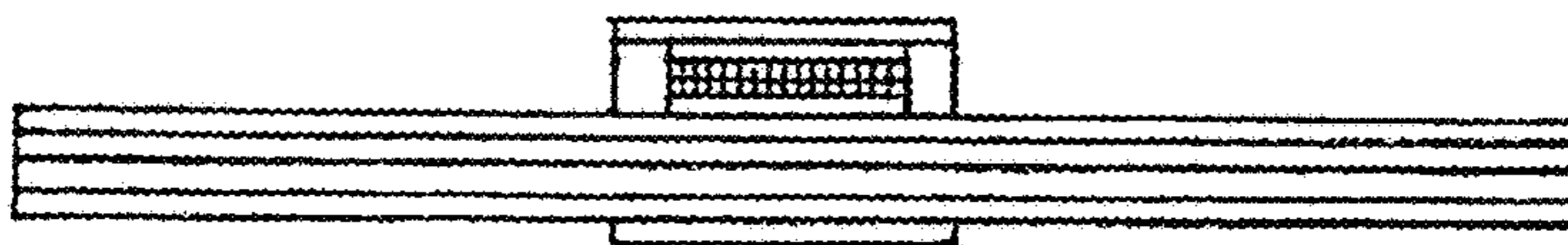

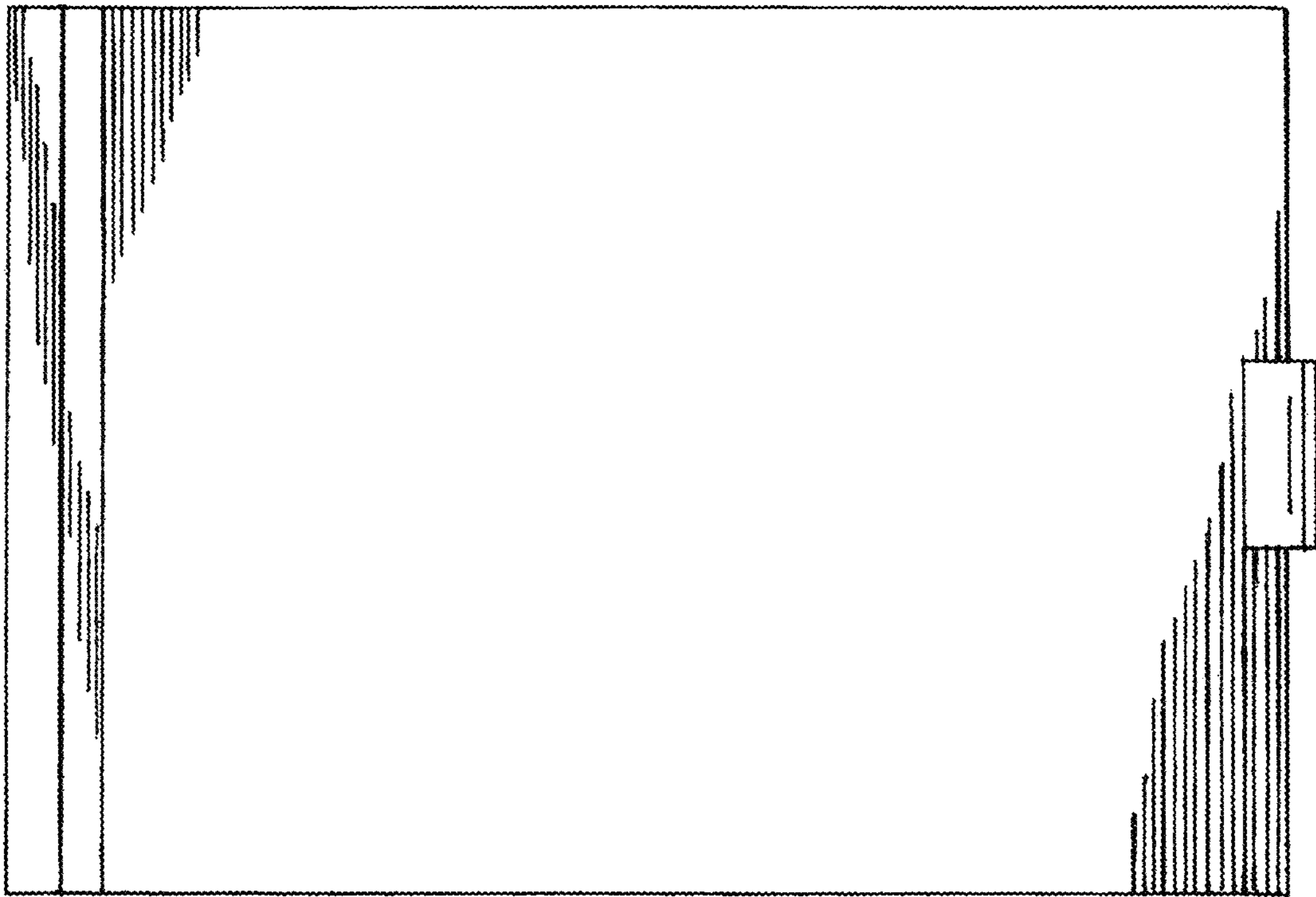

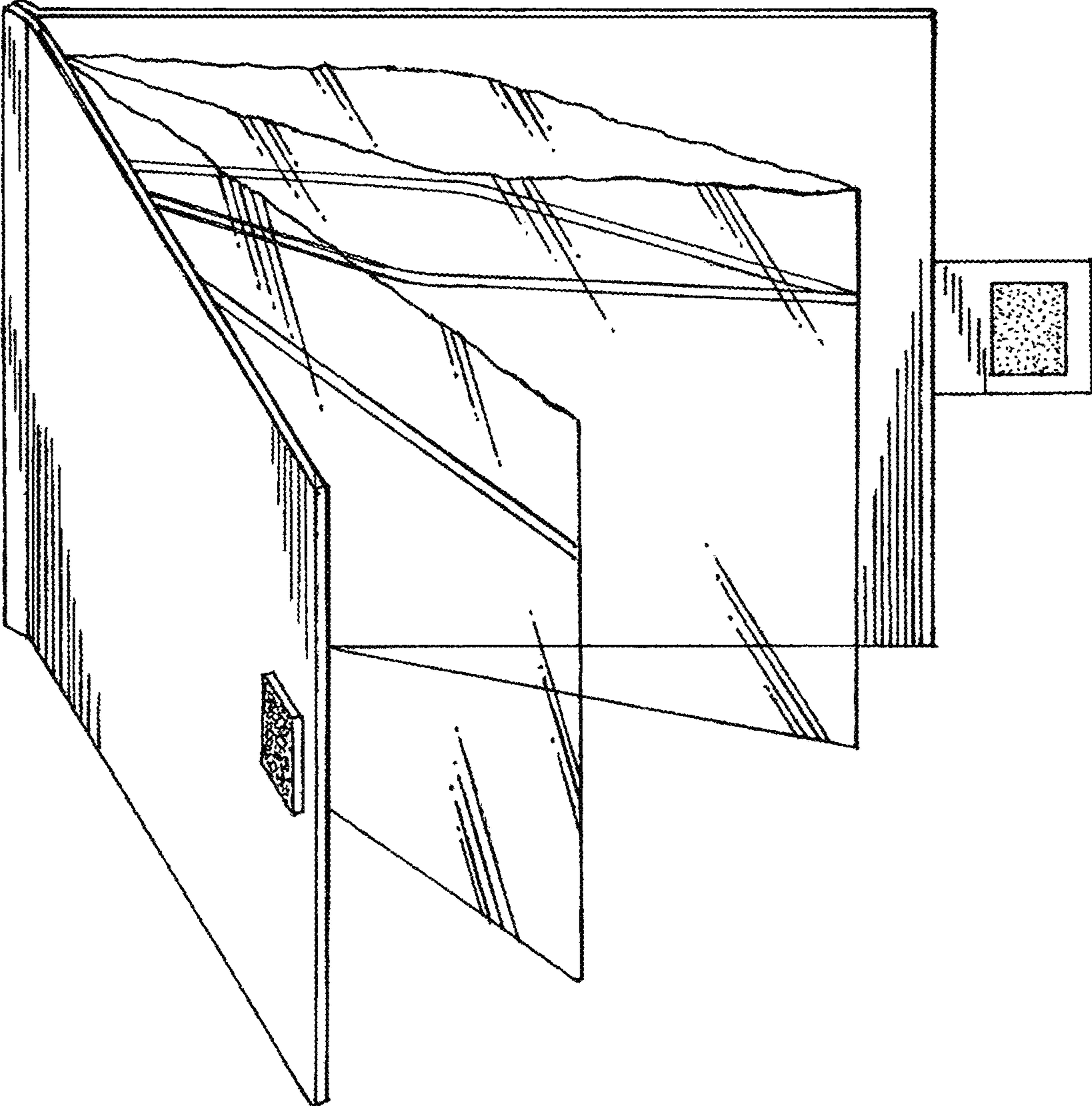
