(57) **CLAIM**

I claim the ornamental design for a wallet, as shown and described.

DESCRIPTION

FIG. 1 is a Perspective view of a wallet showing my new design;

FIG. 4 is a Left-side view of the wallet as shown in FIG. 1;

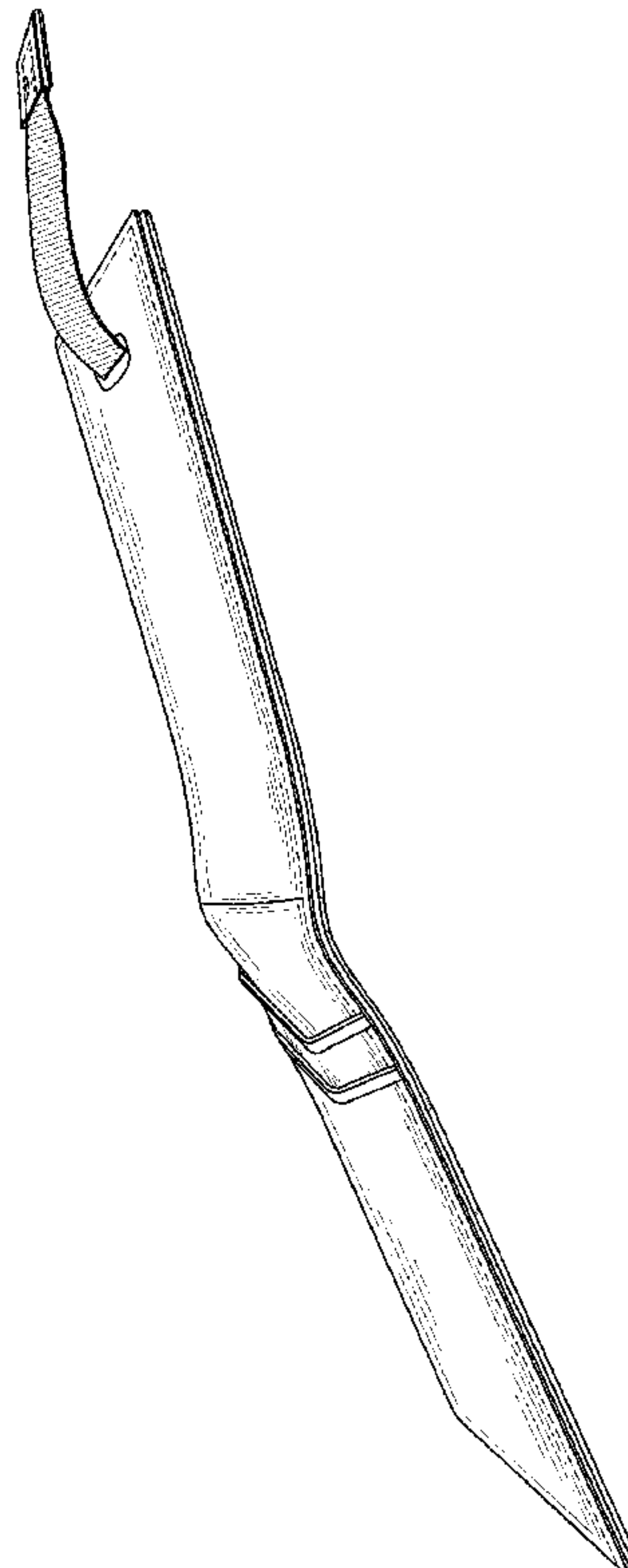
FIG. 5 is a Right-side view of the wallet as shown in FIG. 1;

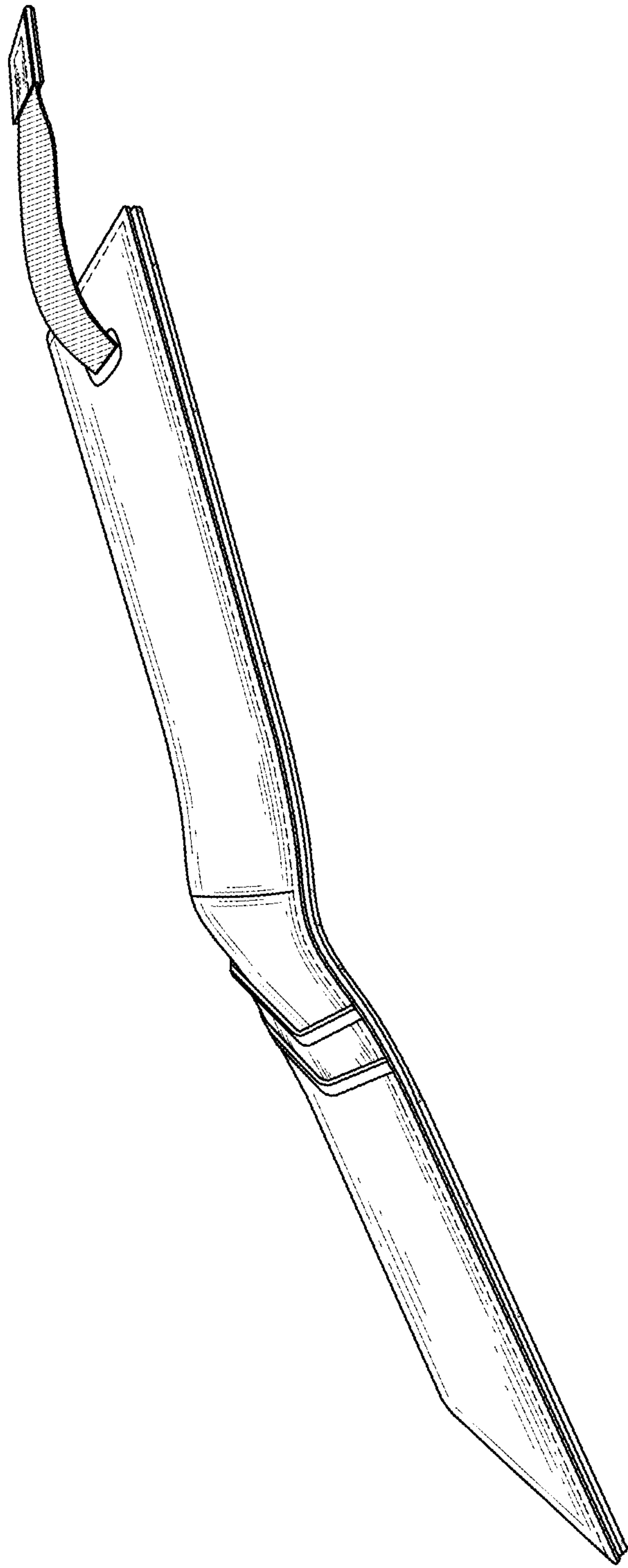

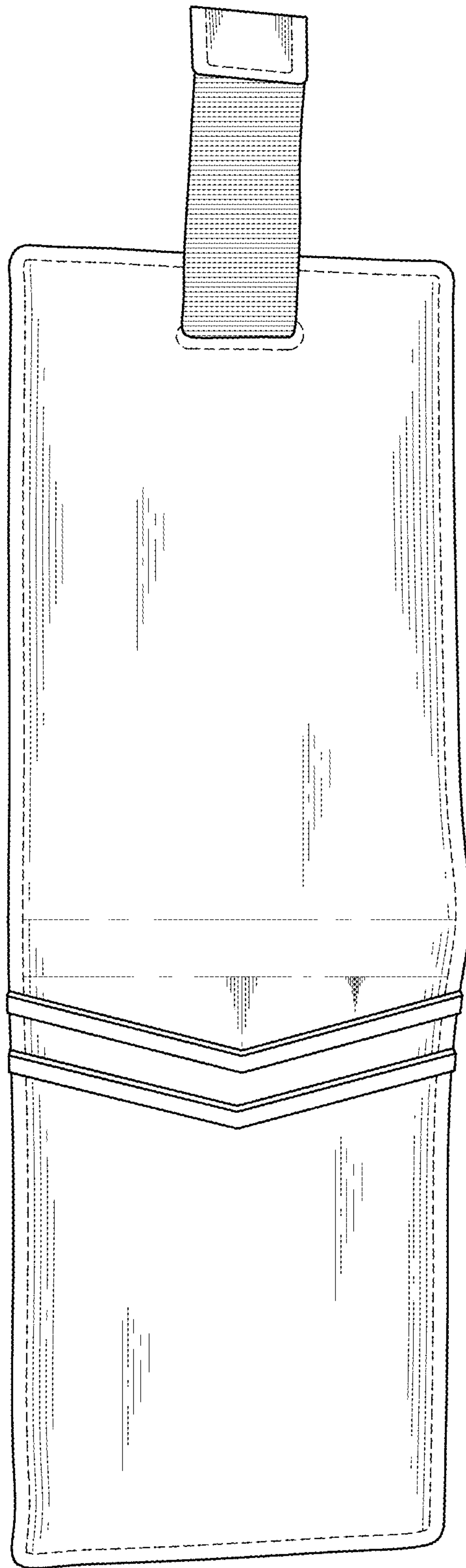

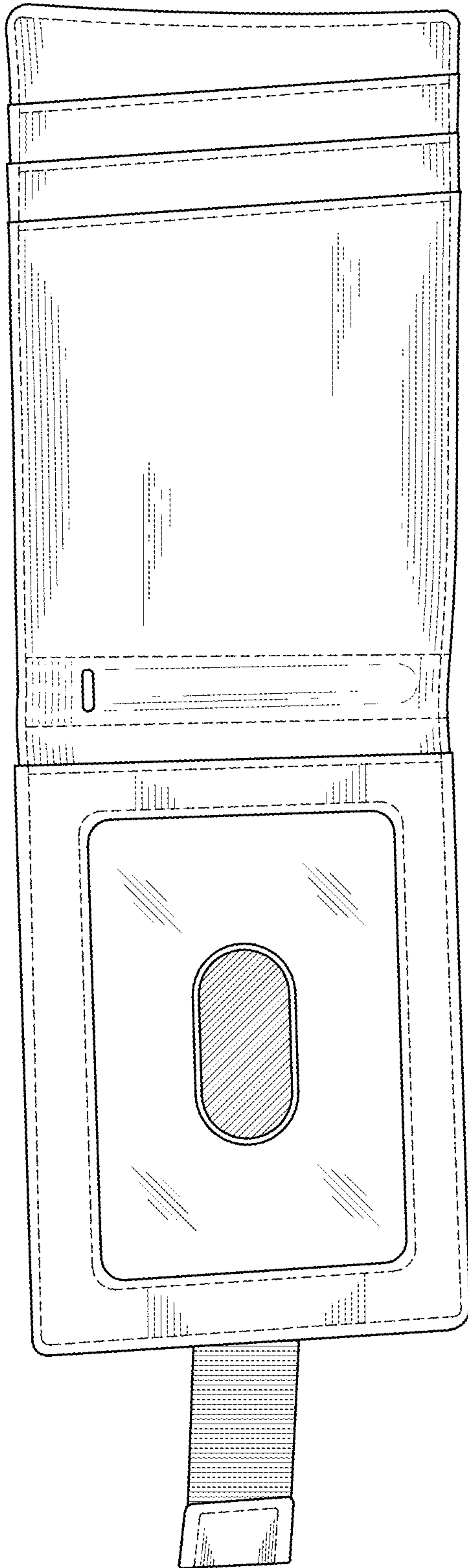

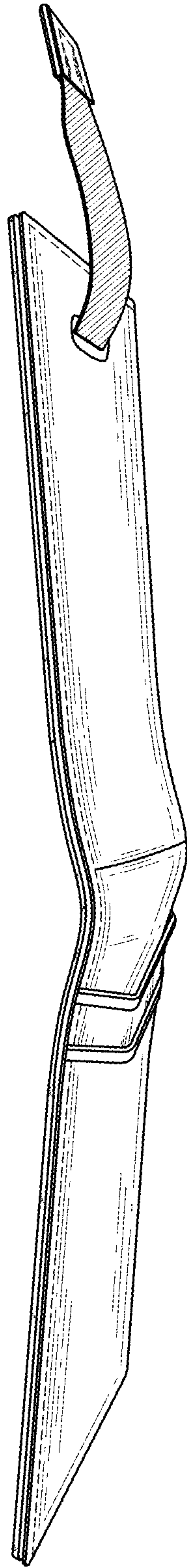

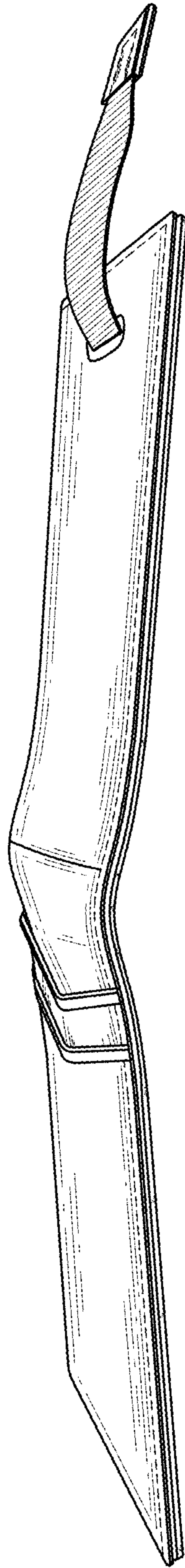

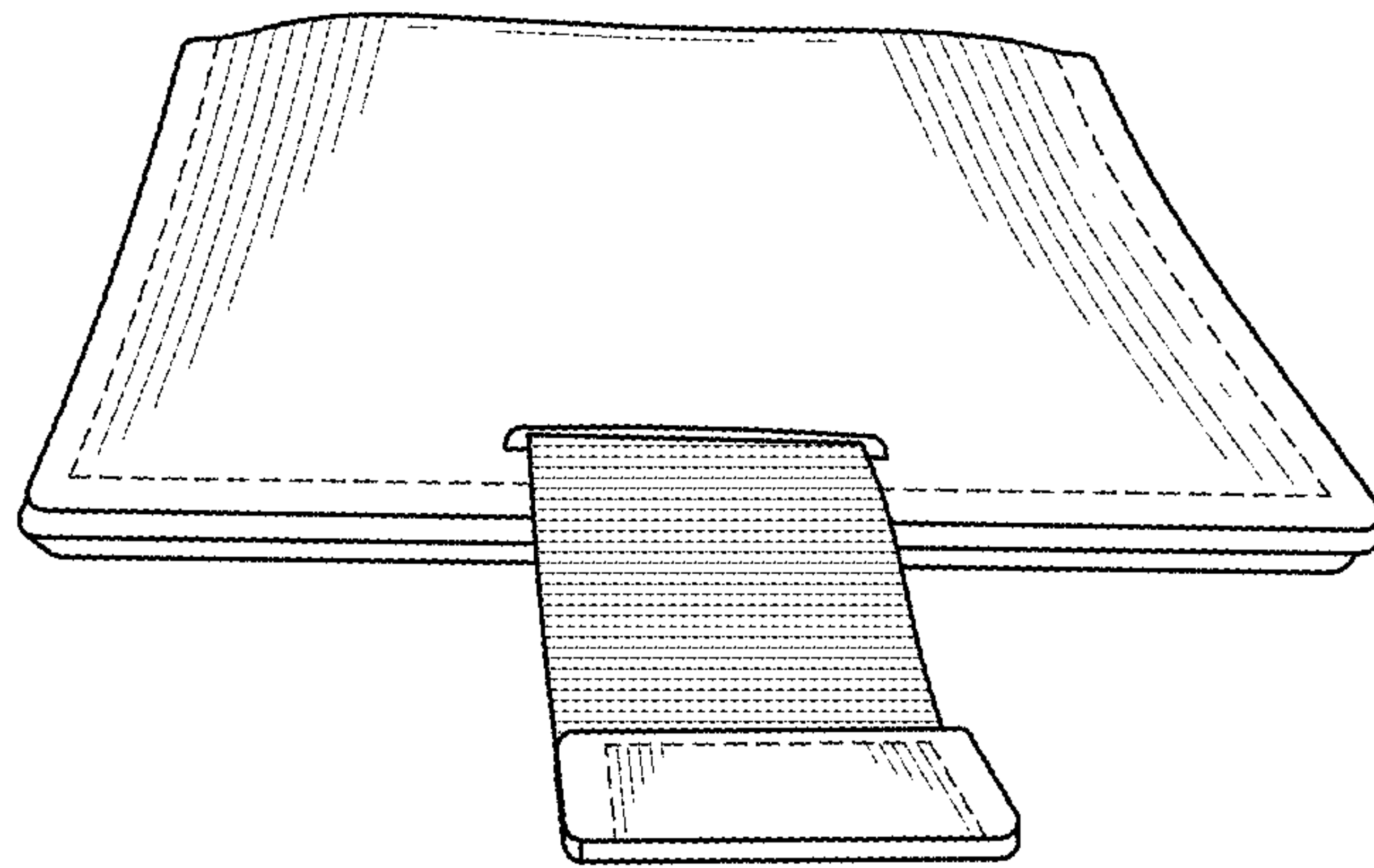

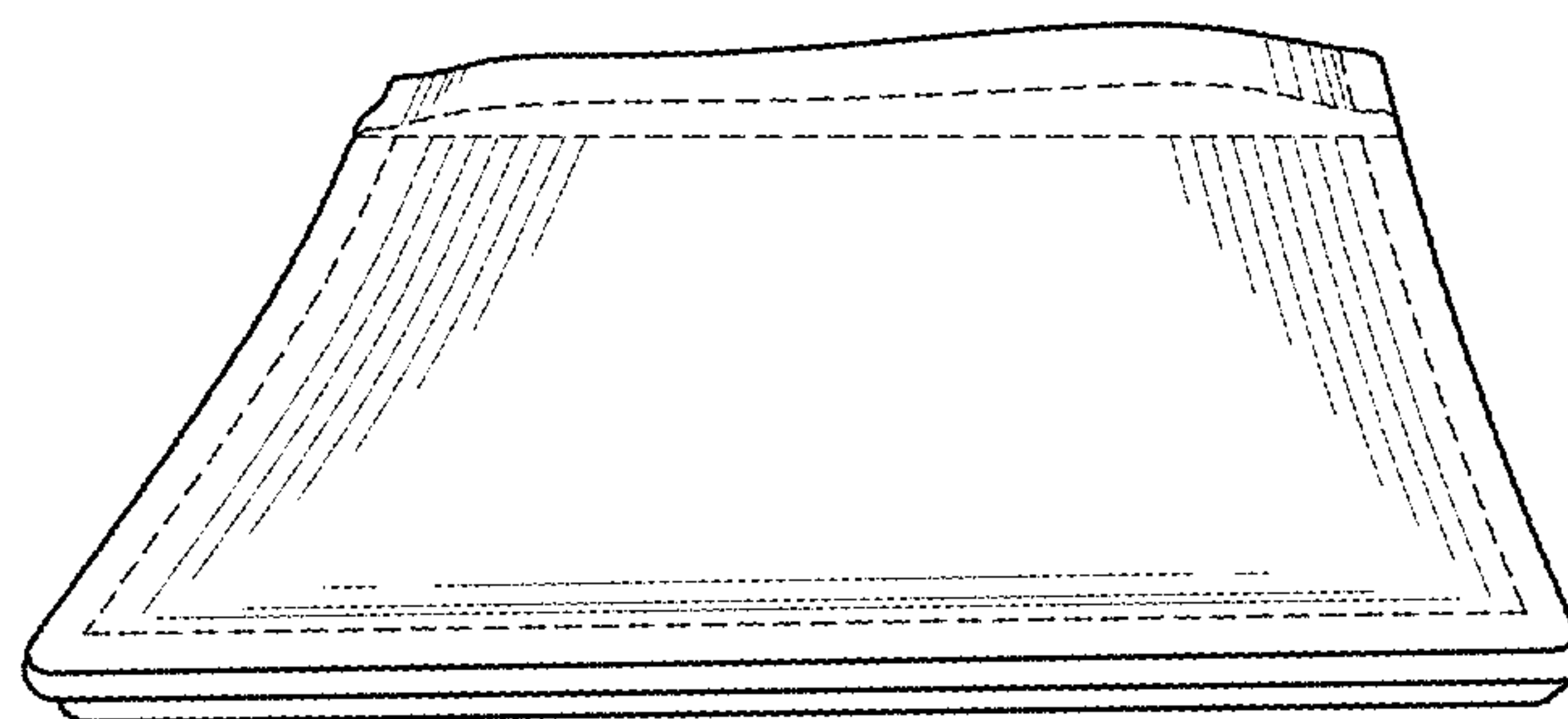
