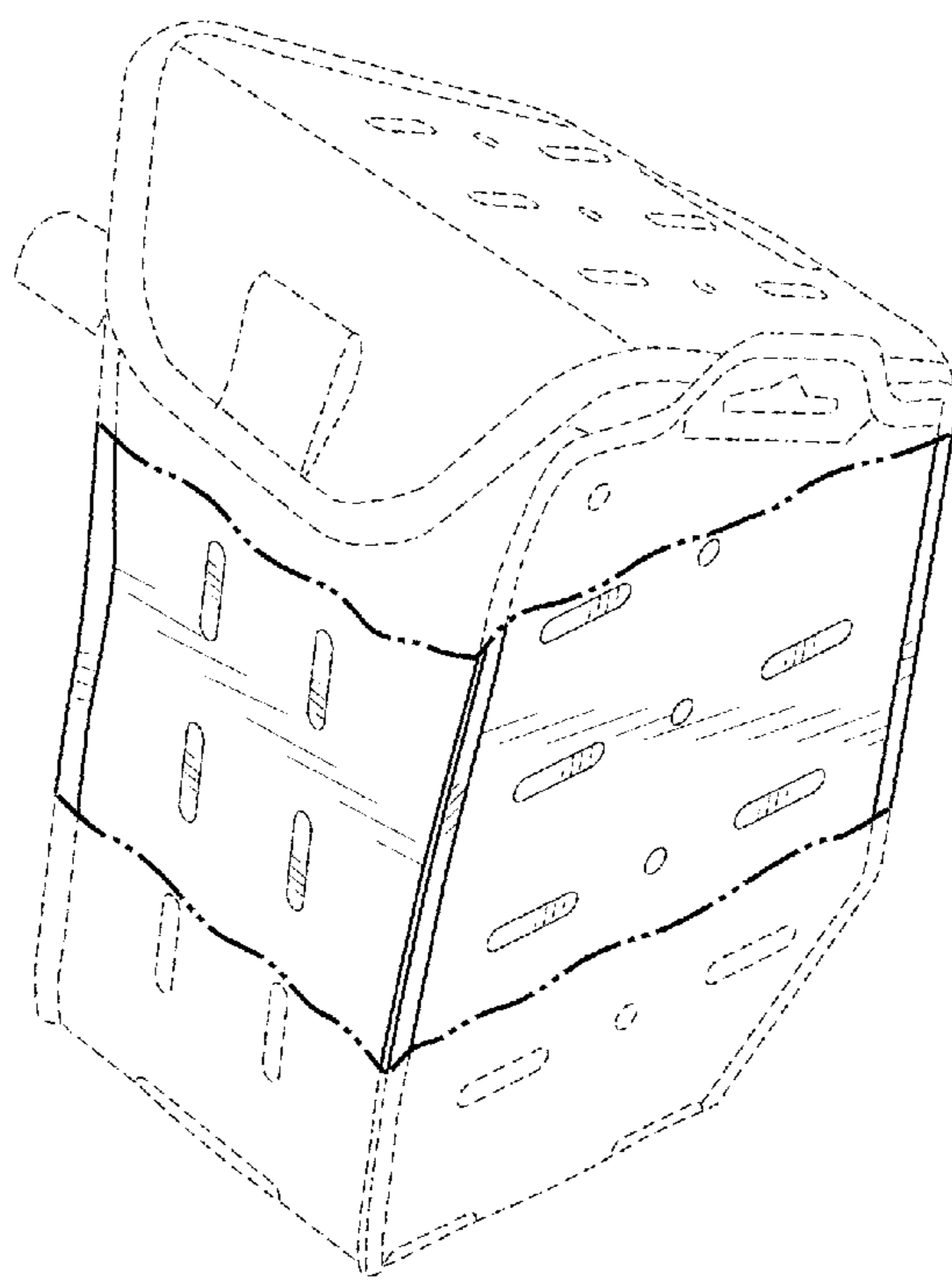

The ornamental design for a protective case, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a design for a protective case for a camera, showing the protective case in an uninflated state;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a first side view thereof;
FIG. 5 is a second side view thereof;
FIG. 6 is a top view thereof; and
FIG. 7 is a bottom view thereof.
FIG. 8 is a frontal perspective view the design for the protective case of FIG. 1, showing the protective case in an inflated state;
FIG. 9 is a front view thereof;
FIG. 10 is a rear view thereof;
FIG. 11 first side view thereof;
FIG. 12 second side view thereof;

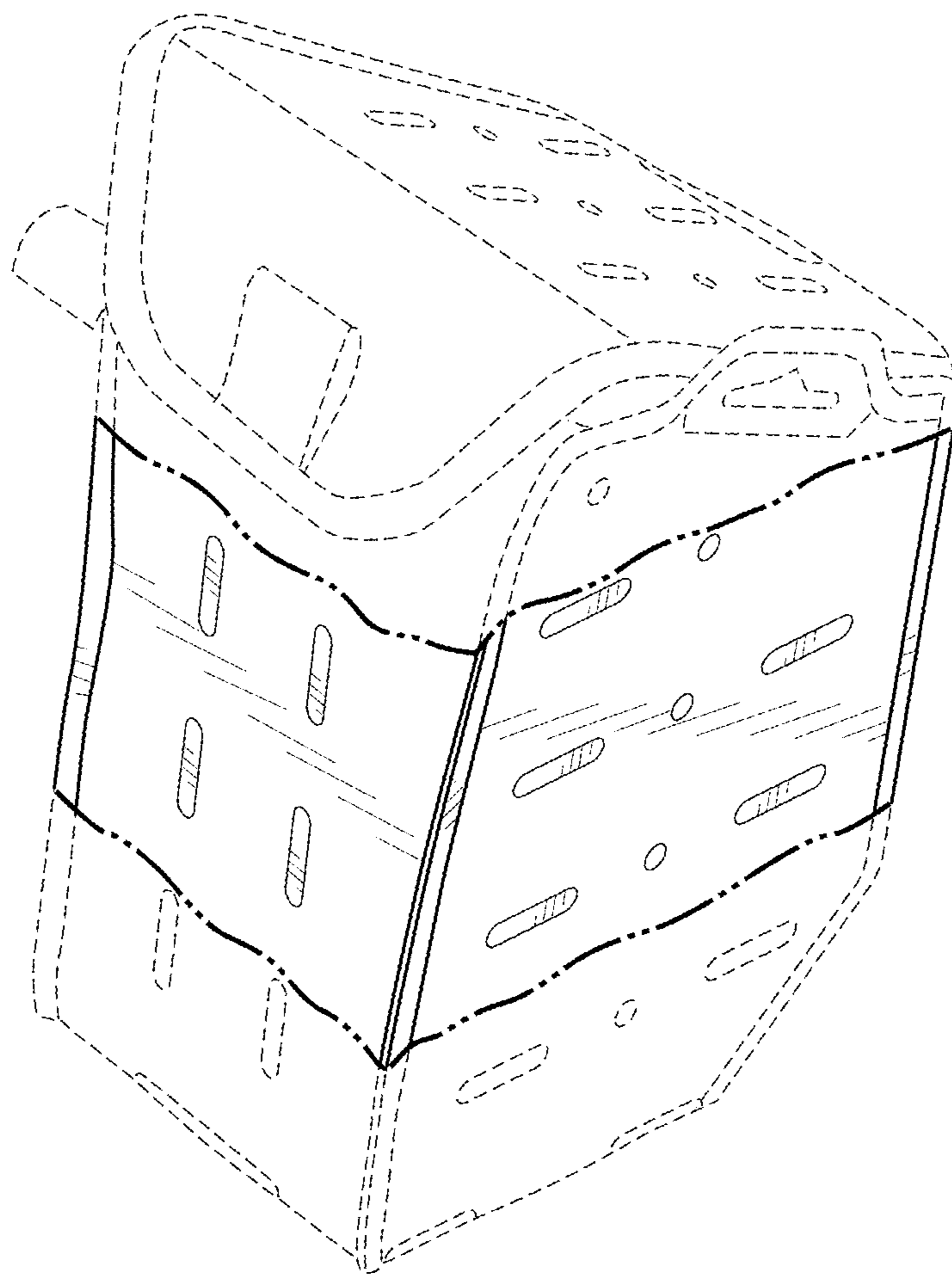

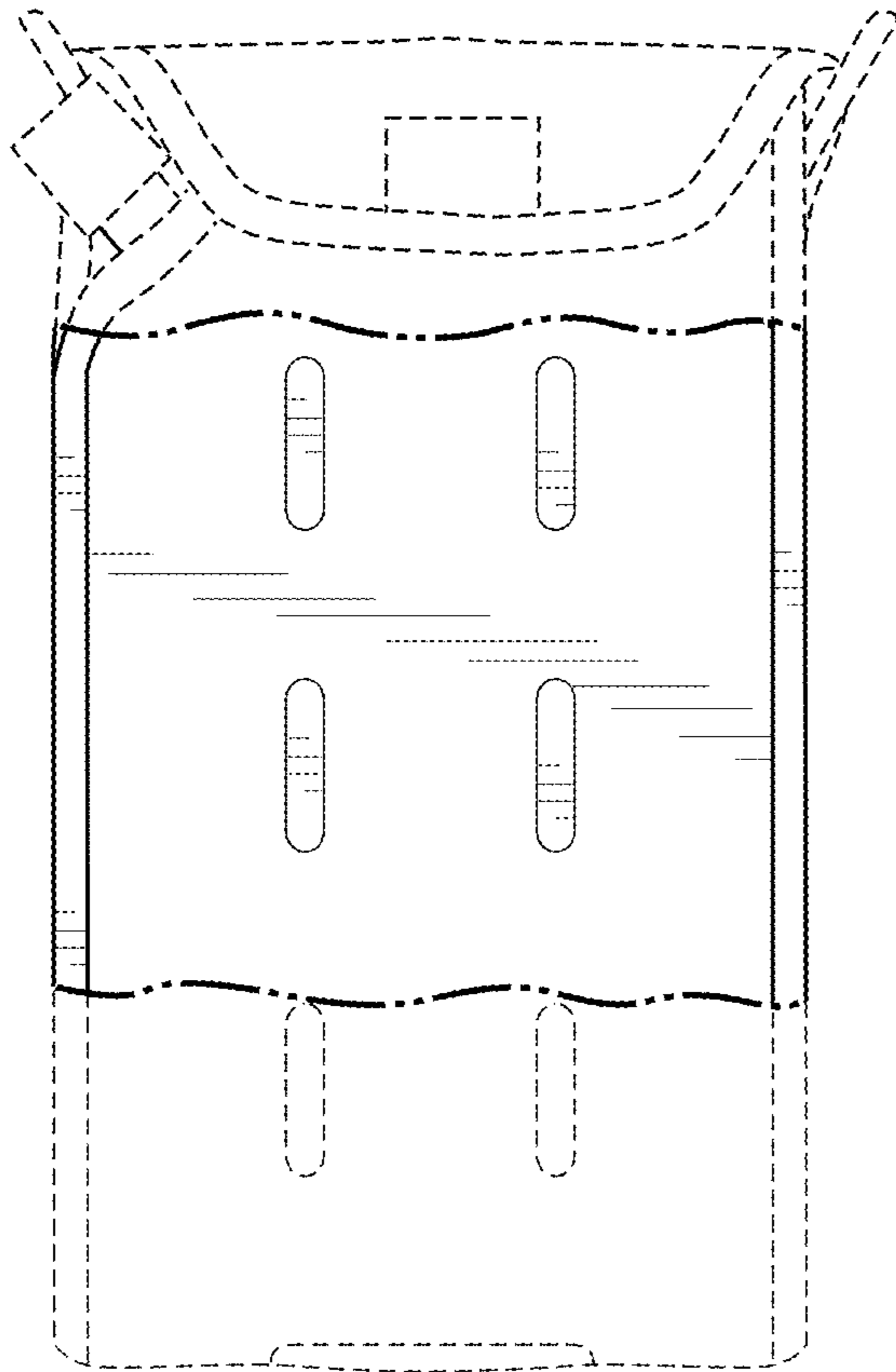

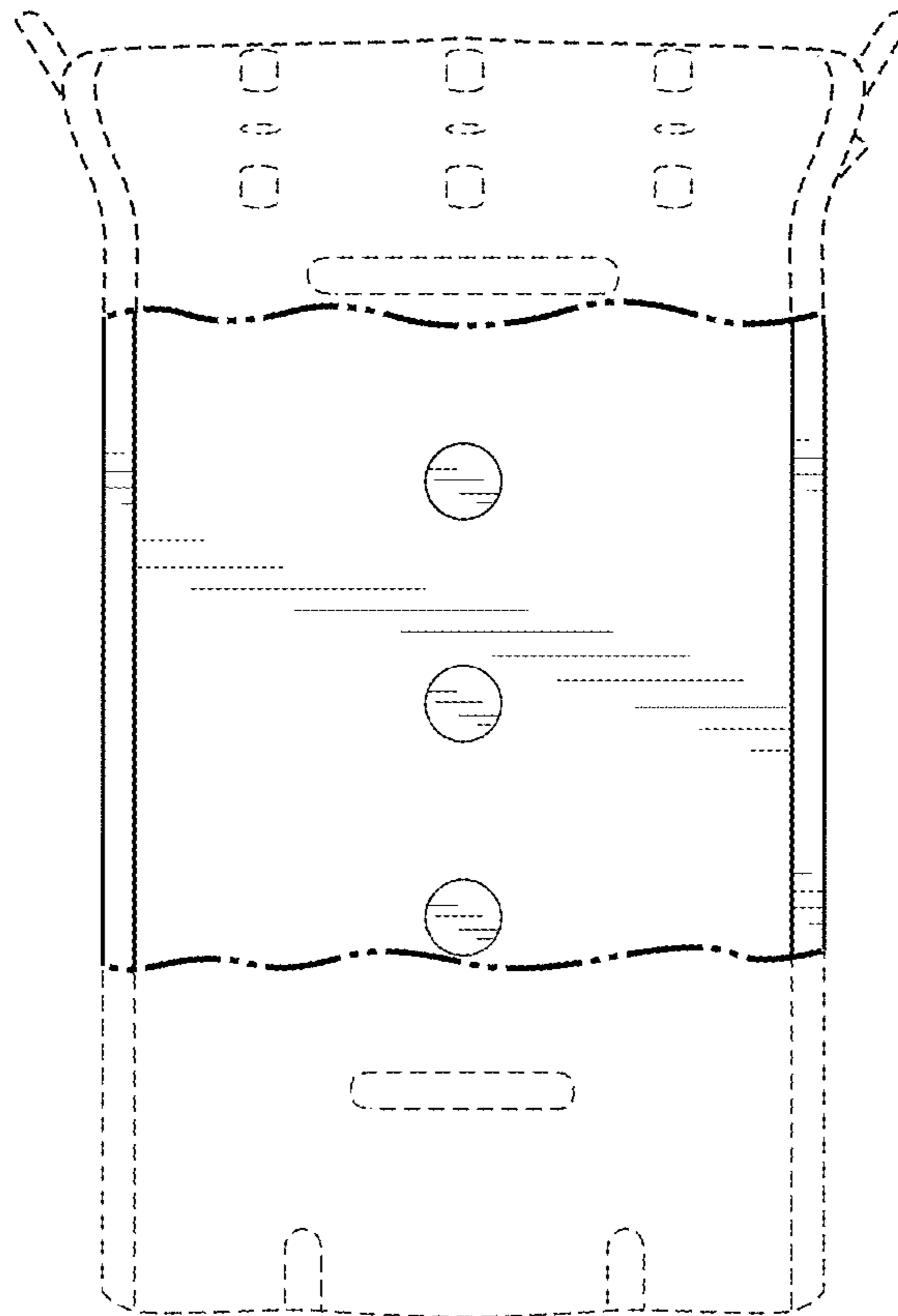

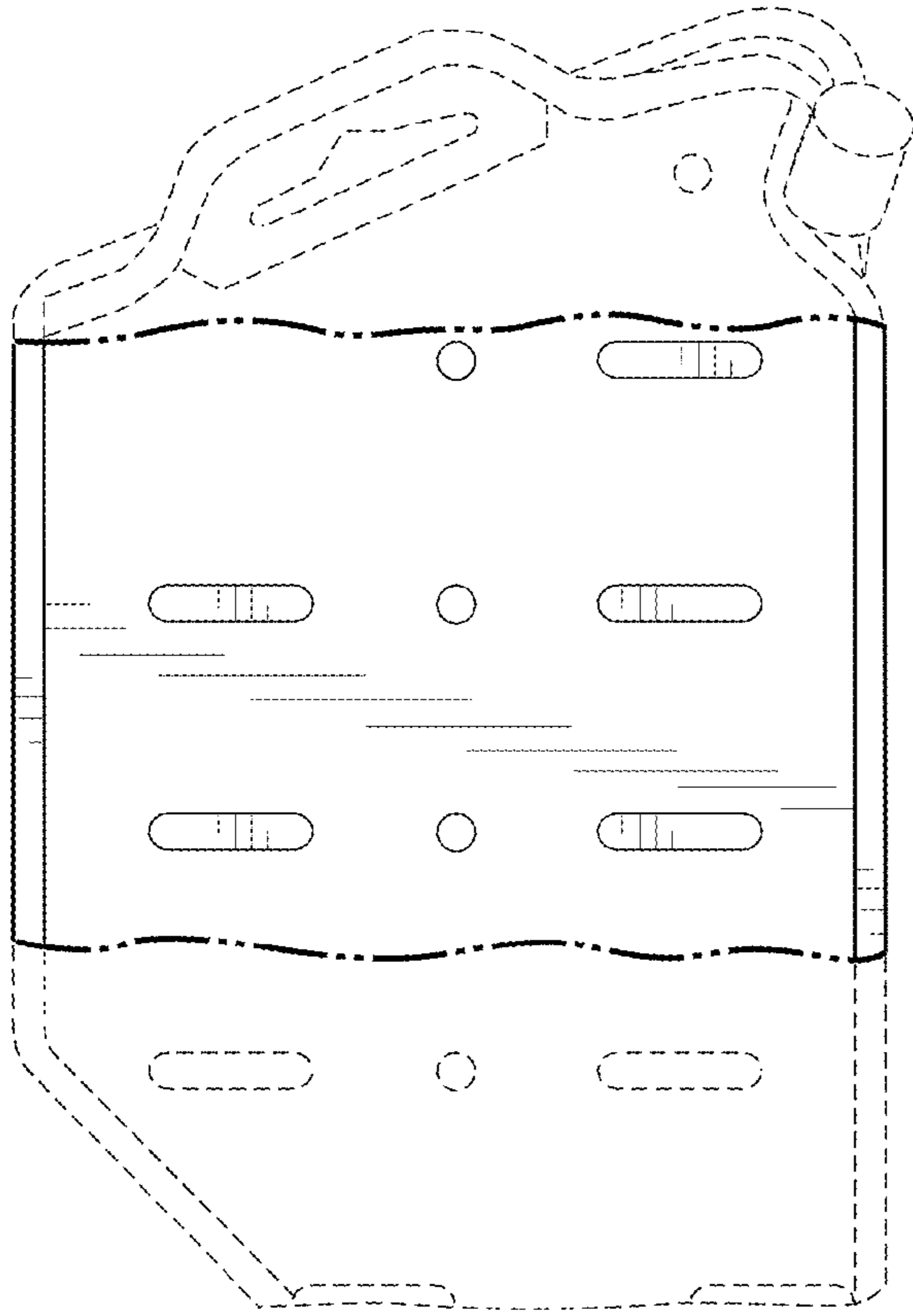

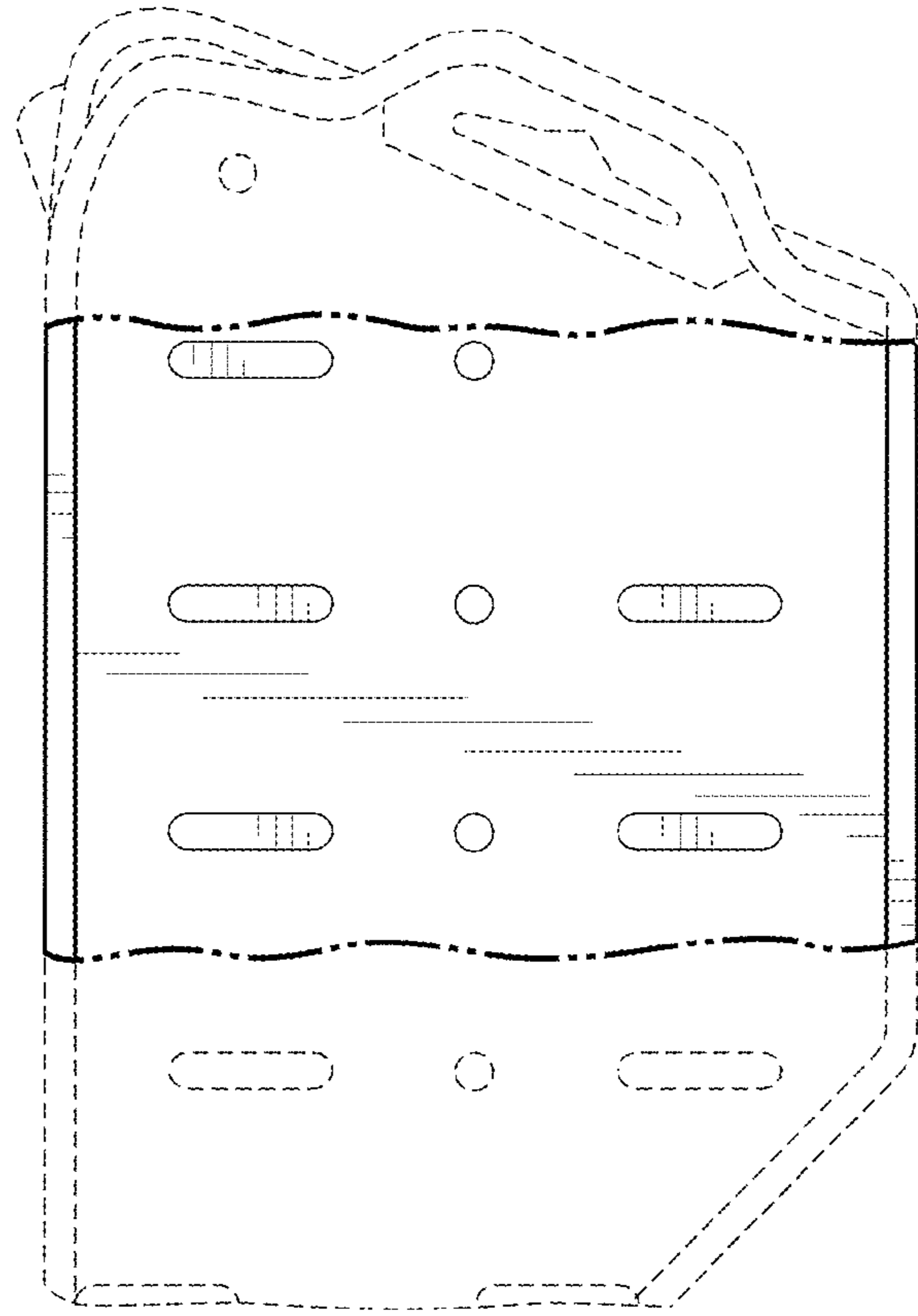

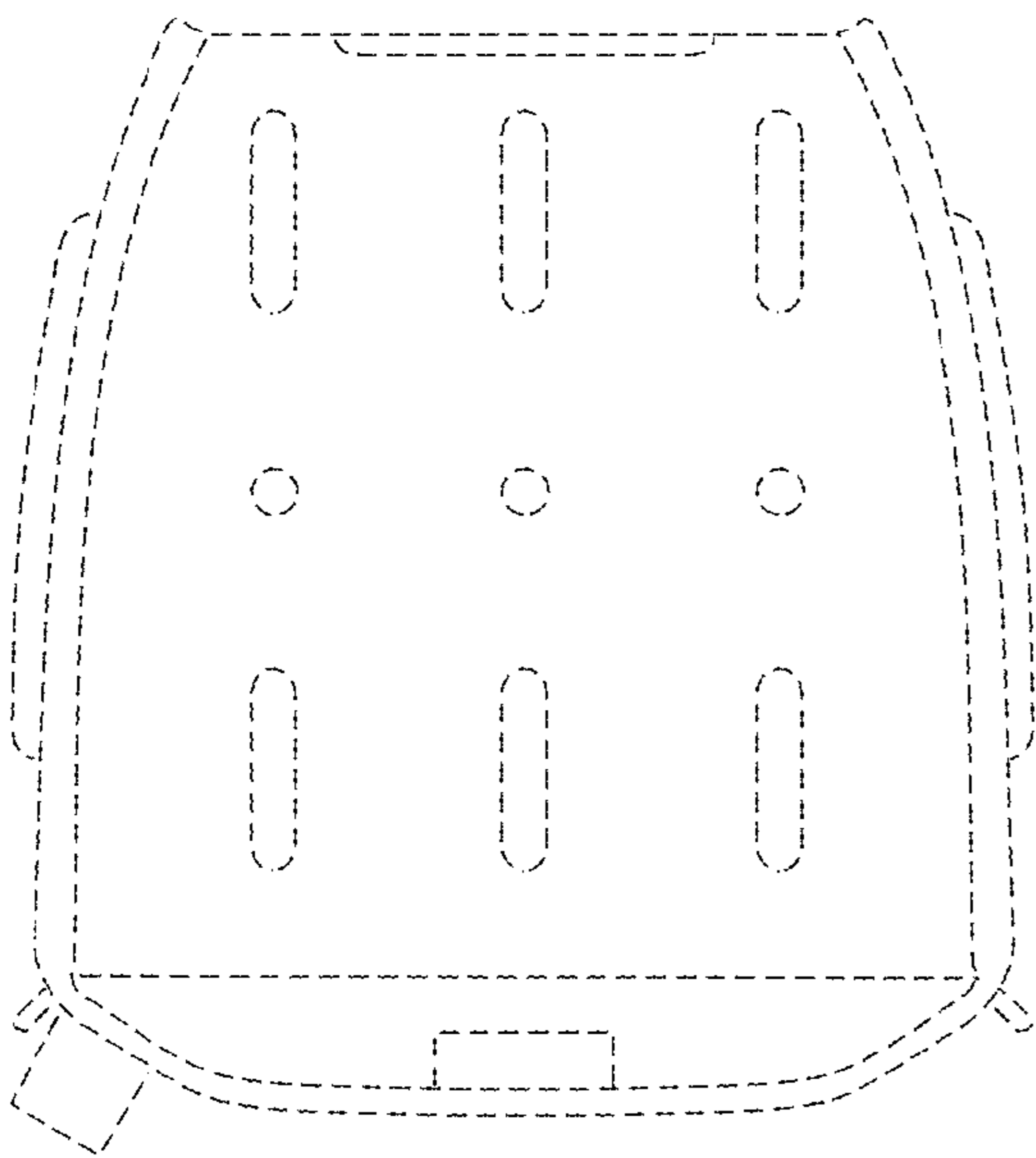

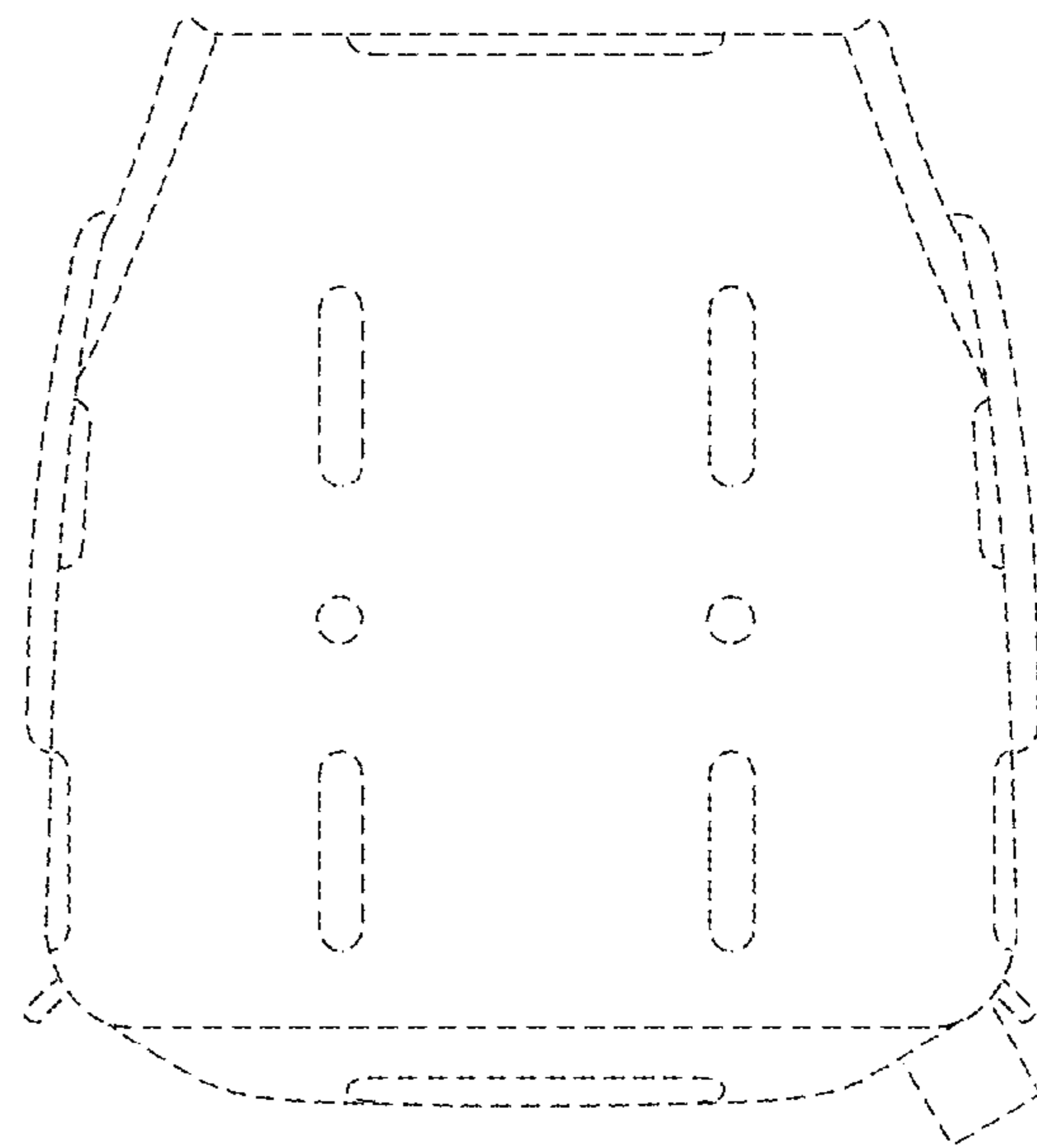

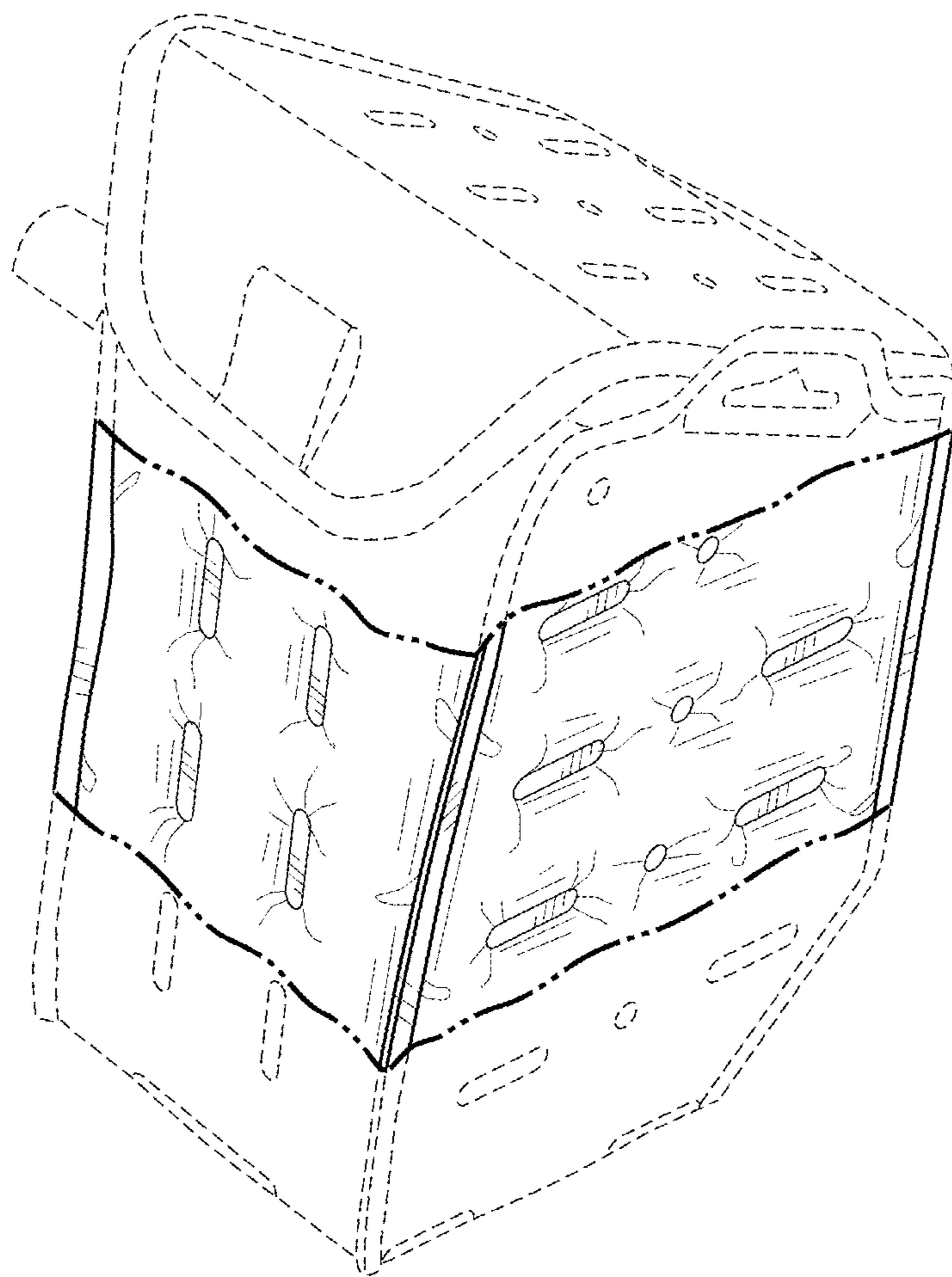

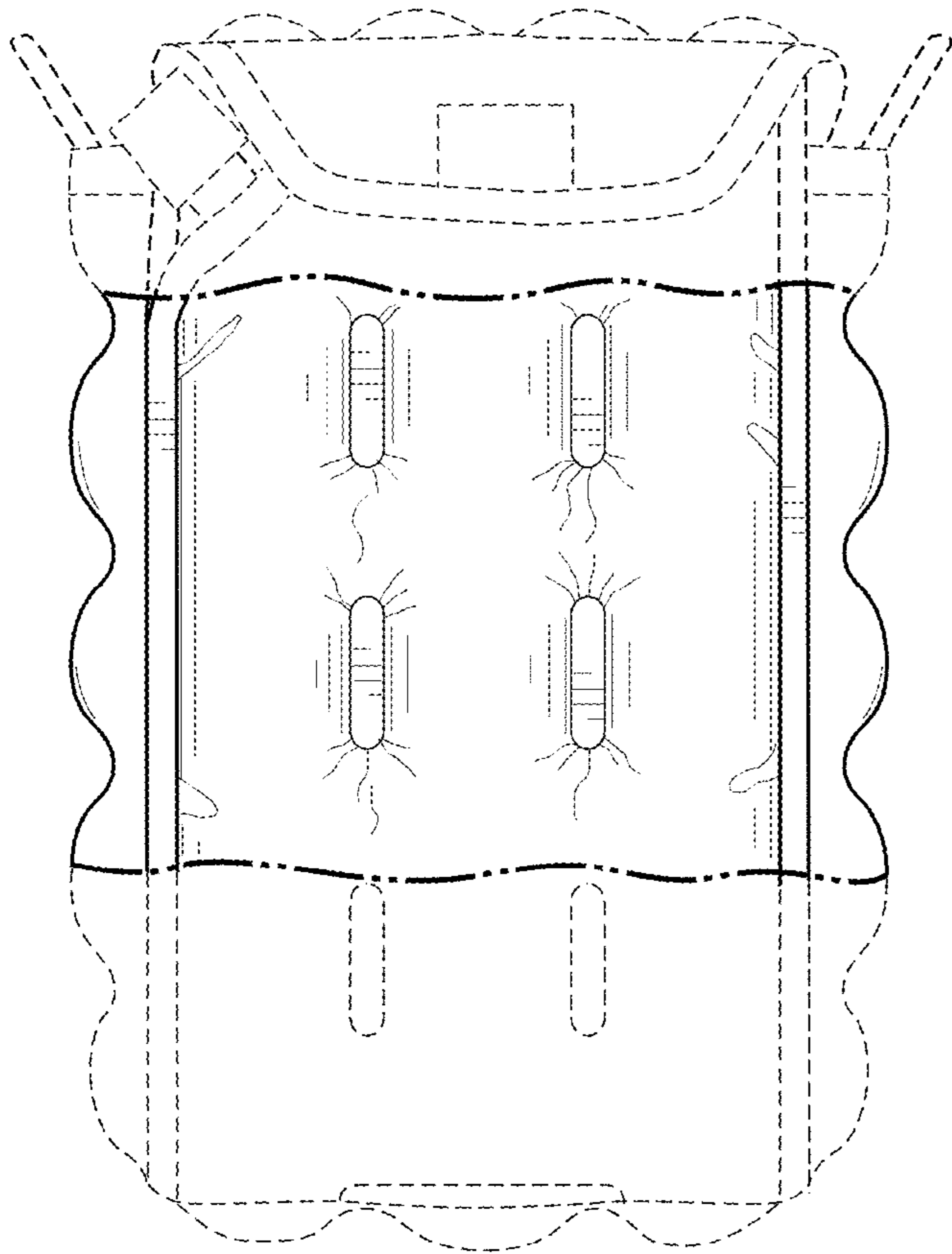

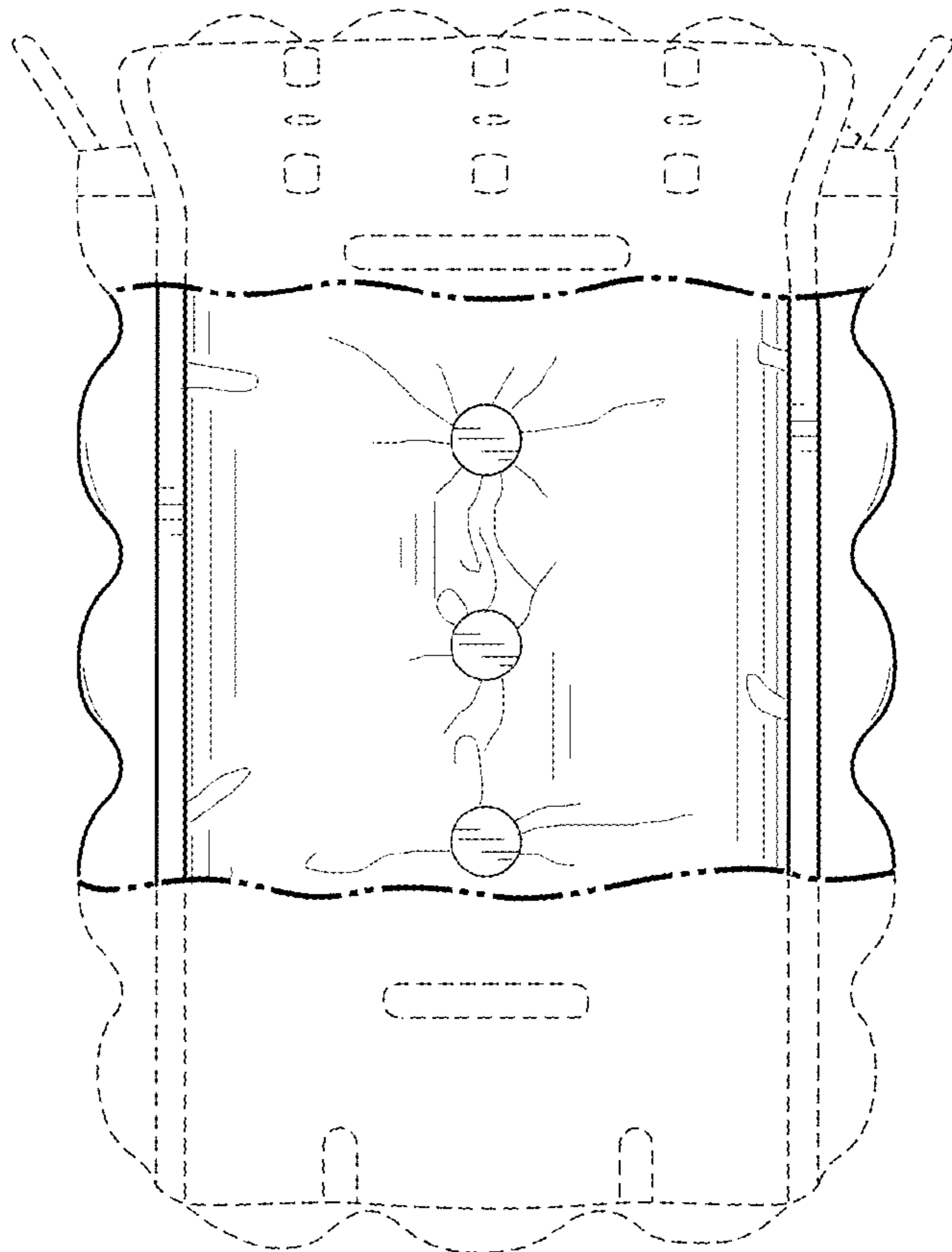

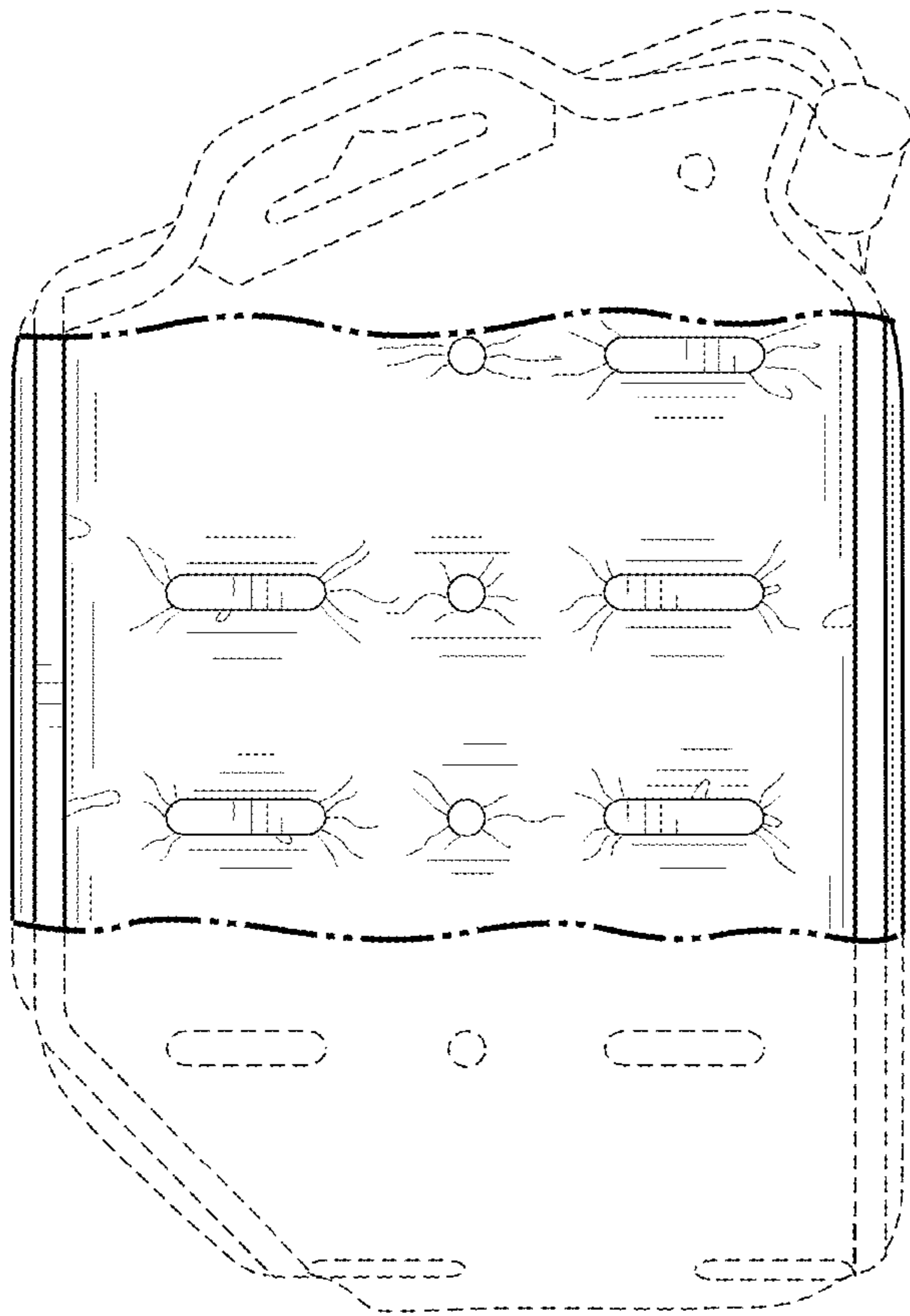

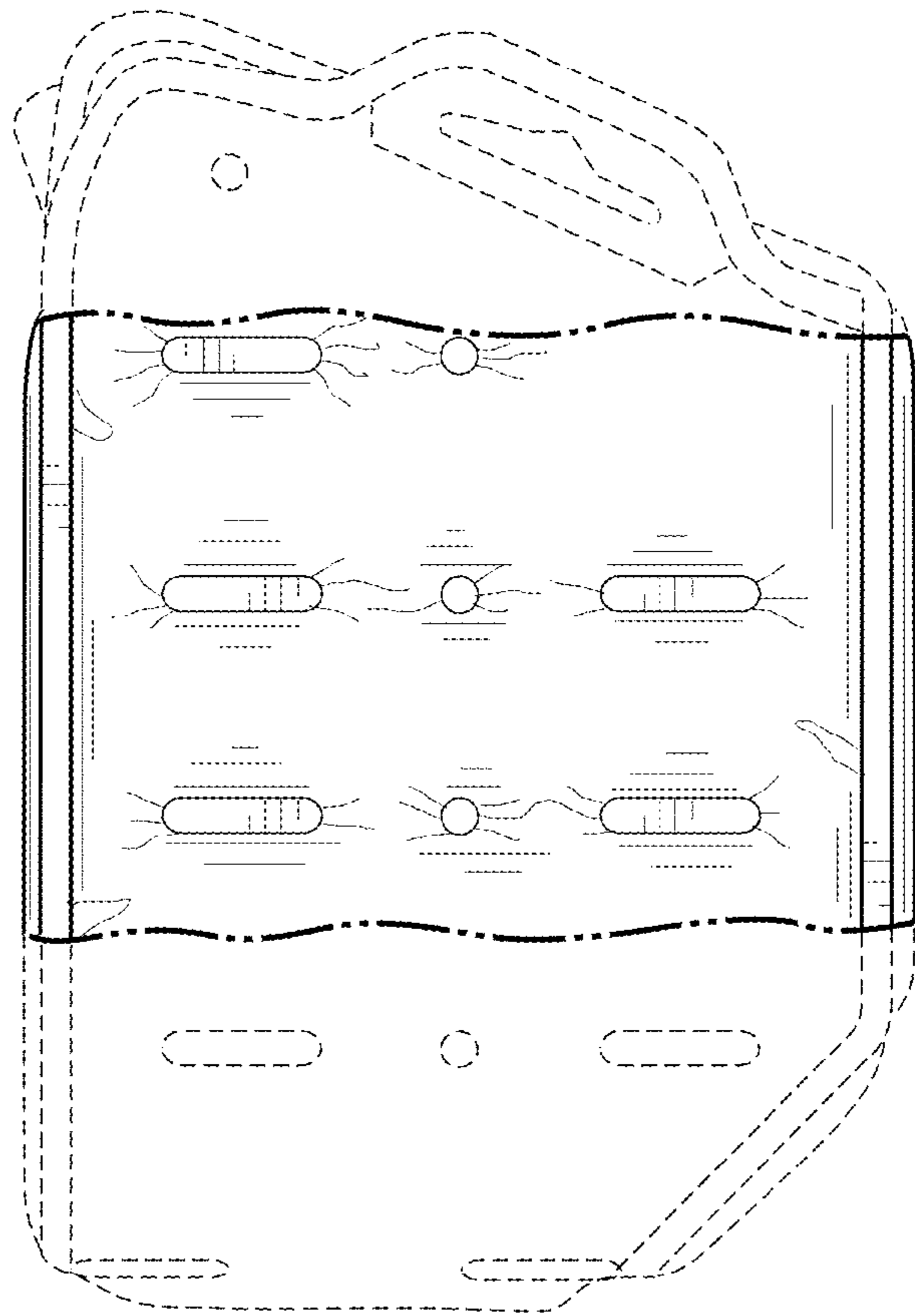

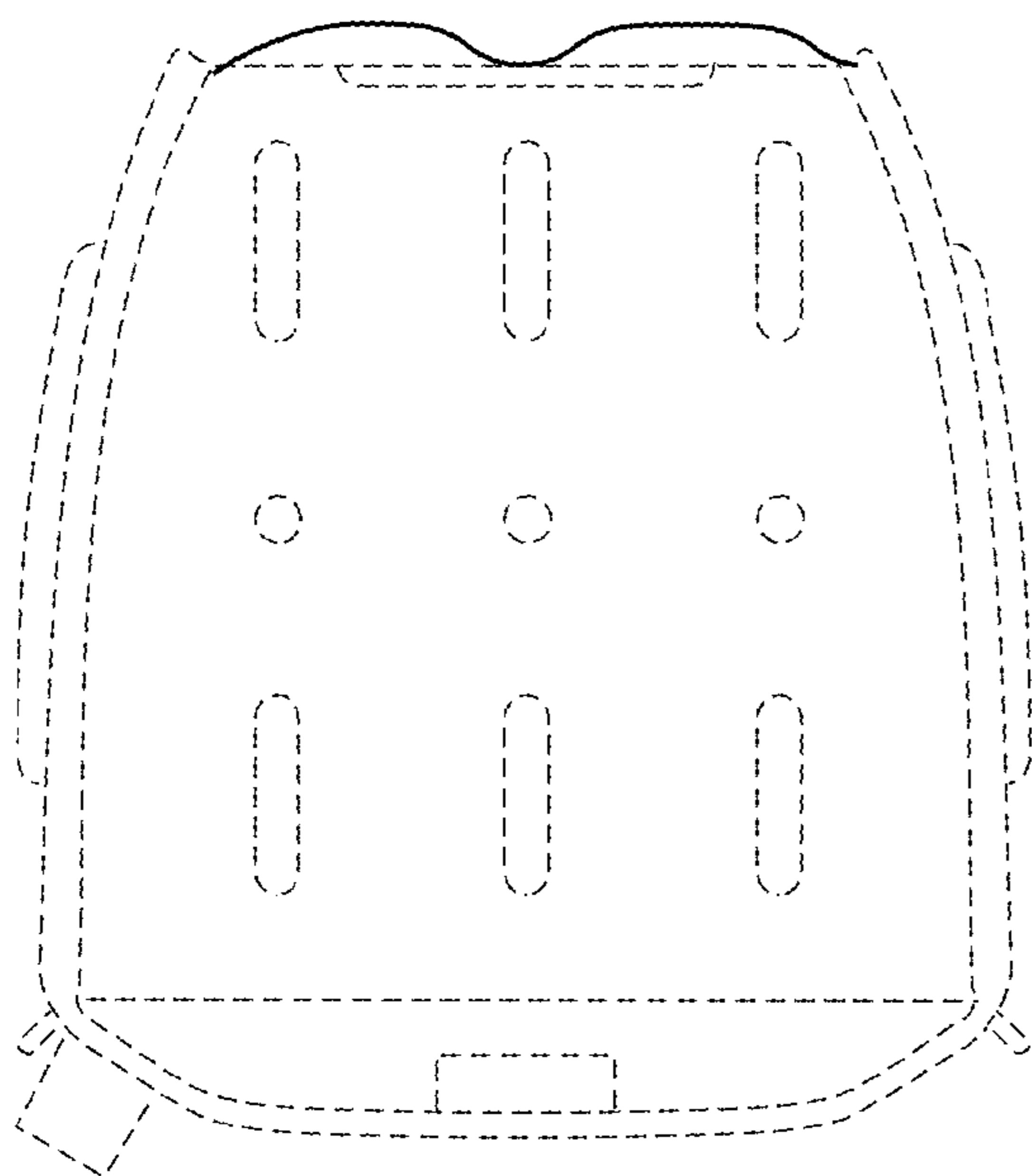

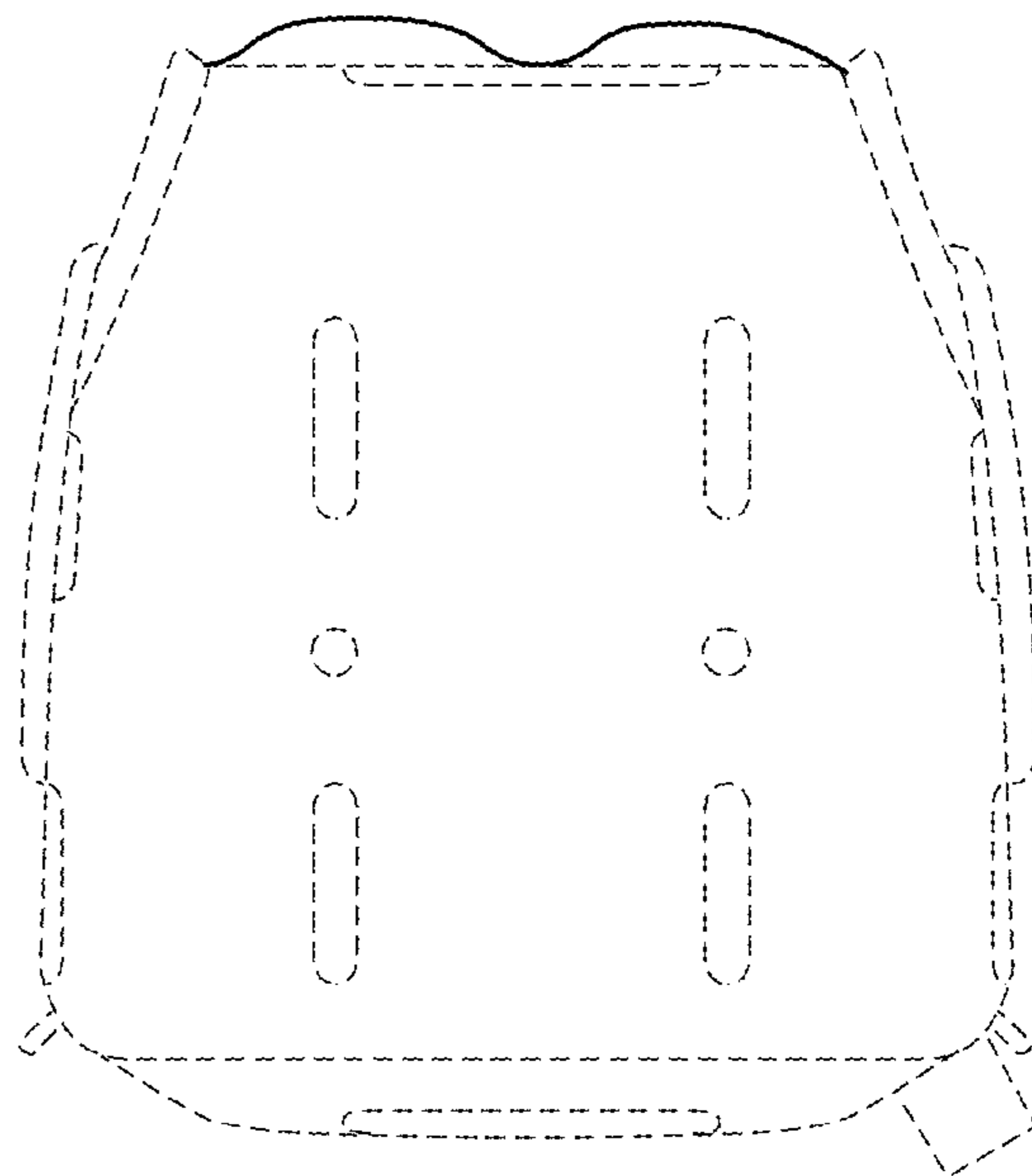
