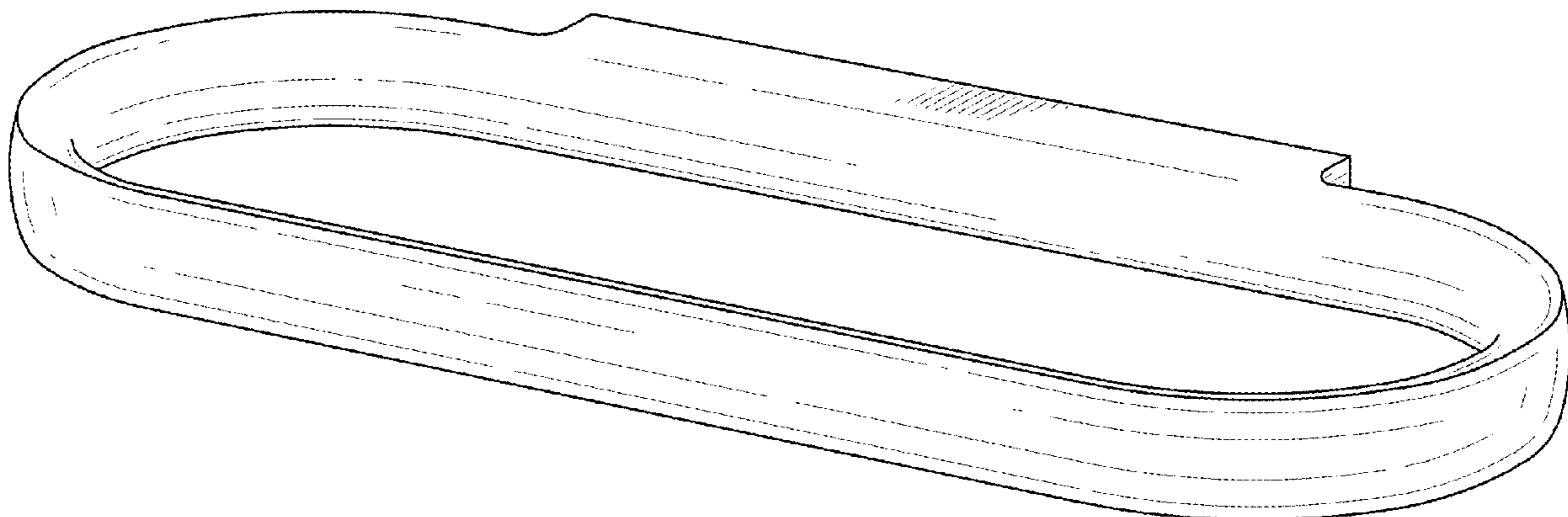
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a towel ring according to the present invention.
FIG. 2 is a front view of the towel ring of FIG. 1.
FIG. 3 is a rear view of the towel ring of FIG. 1.
FIG. 4 is a left side view of the towel ring of FIG. 1.
FIG. 5 is a right side view of the towel ring of FIG. 1.
FIG. 6 is a top view of the towel ring of FIG. 1; and,
FIG. 7 is a bottom view of the towel ring of FIG. 1.

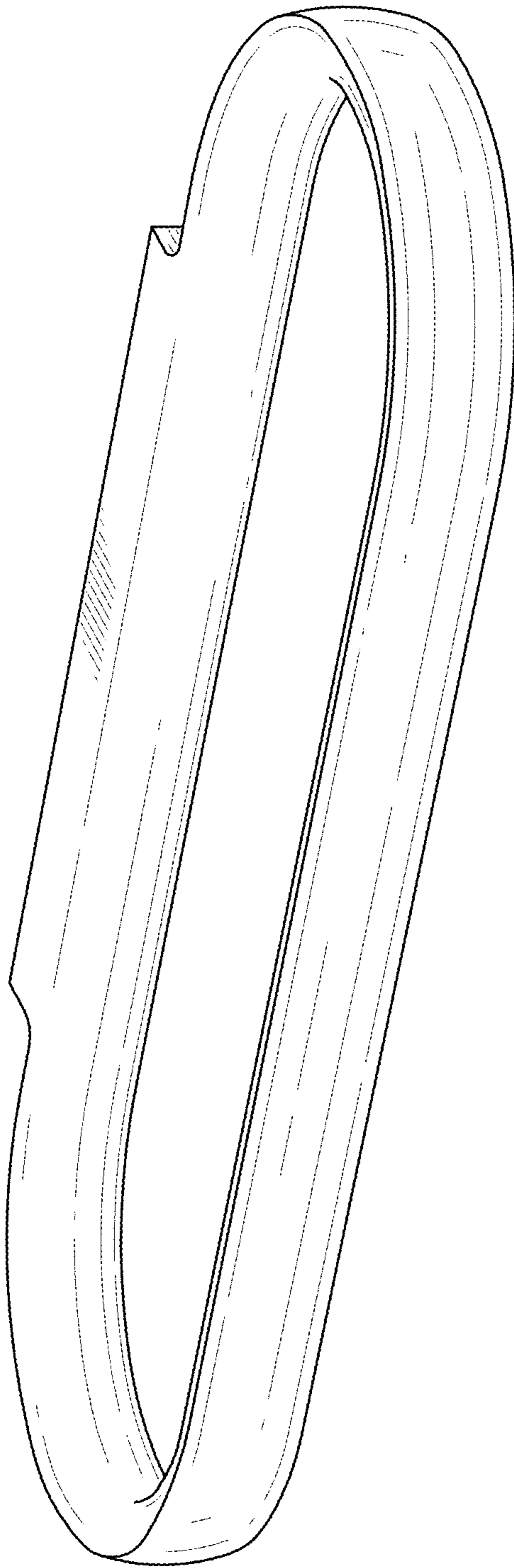

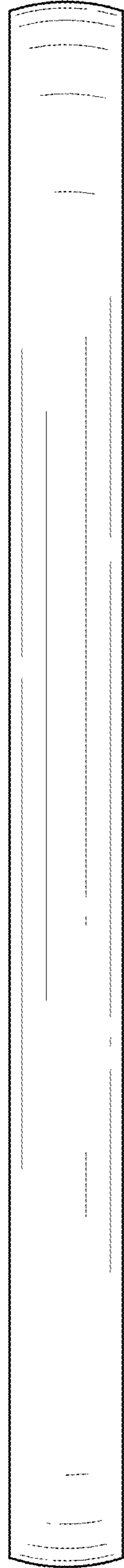

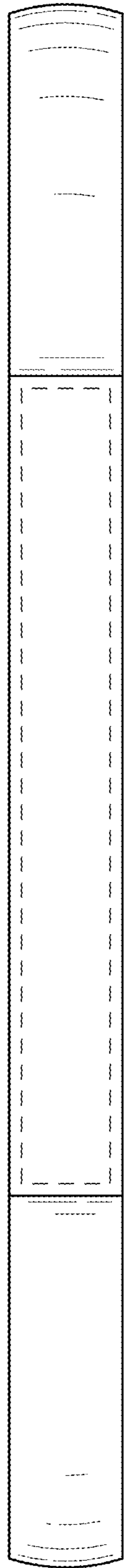

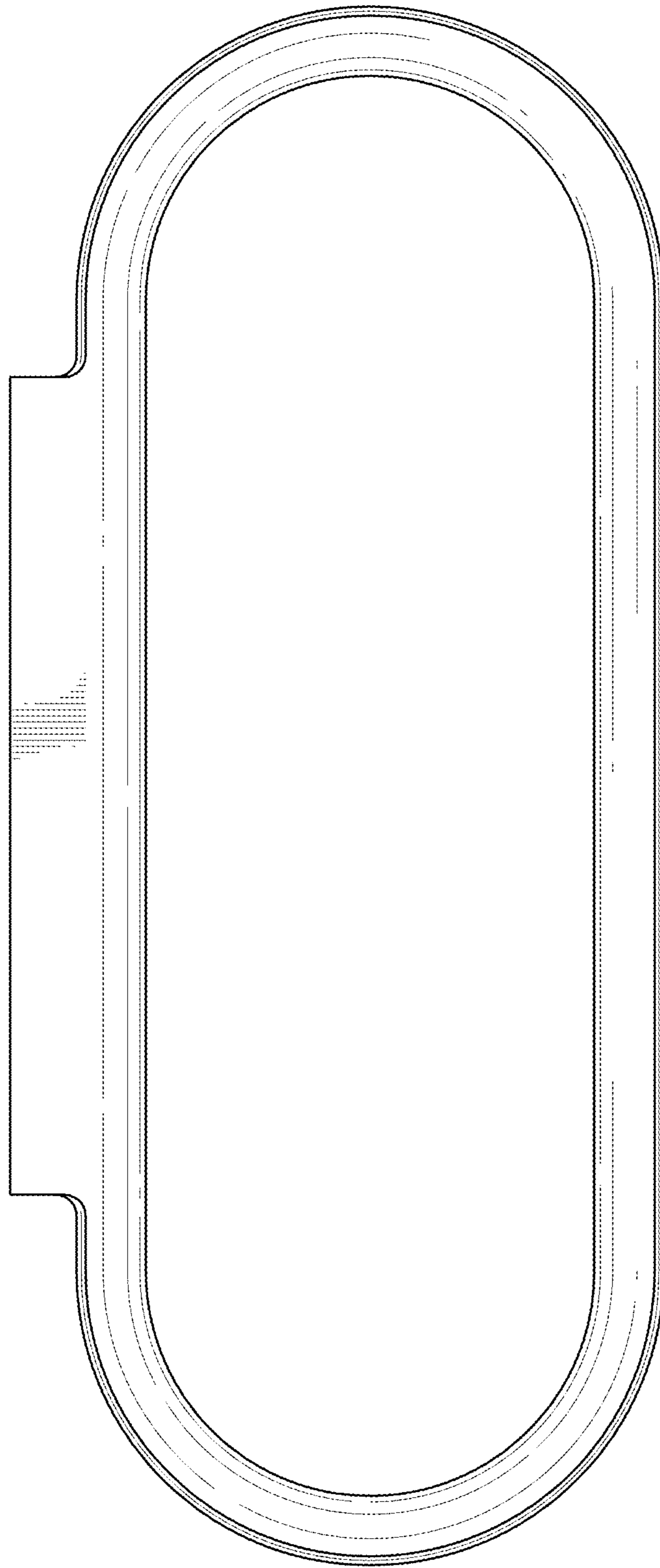

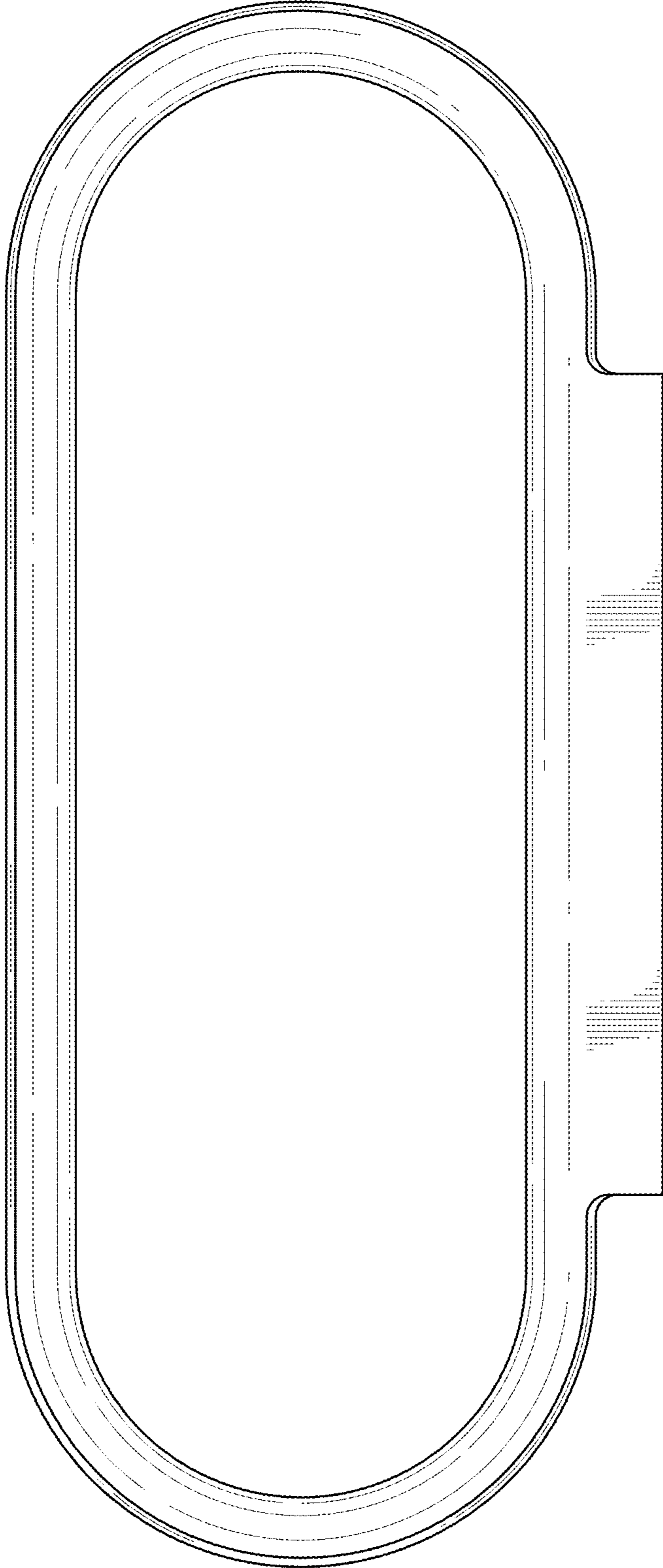
