(57) **CLAIM**

The ornamental design for a pan with handle, as shown and described herein.

DESCRIPTION

FIG. 1 is a top perspective view of a pan and handle in a connected configuration.

FIGS. 2a and 2b are top perspective views of the pan and handle, respectively, in a disconnected configuration.

FIG. 3 is left side elevation view of the pan and handle in the connected configuration, with the right side elevation view being a mirror image.

FIG. 4 is a bottom perspective view of the pan and handle in the connected configuration.

FIGS. 5a and 5b are bottom perspective views of the pan and handle in the disconnected configuration.

FIG. 6 is a top plan view of the pan and handle in the connected configuration.

FIG. 7 is a bottom plan view of the pan and handle in the connected configuration.

FIG. 8 is a magnified top perspective view of the handle in the disconnected configuration.

FIG. 9 is a magnified bottom perspective view of the handle in the disconnected configuration.

FIG. 10 is a magnified front elevation view of the handle in the disconnected configuration.

FIG. 11 is a magnified rear elevation view of the handle in the disconnected configuration.

FIG. 12 is a magnified left side elevation view of the handle in the disconnected configuration, with the right side elevation view being a mirror image.

FIG. 13 is a magnified top plan view of the handle in the disconnected configuration.

FIG. 14 is a magnified bottom plan view of the handle in the disconnected configuration.

FIG. 15 is a top perspective view of the pan in the disconnected configuration.

FIG. 16 is a front elevation view of the pan in the disconnected configuration, with the rear elevation view being identical.

FIG. 17 is right side elevation view of the pan in the disconnected configuration, with the left side elevation view being identical.

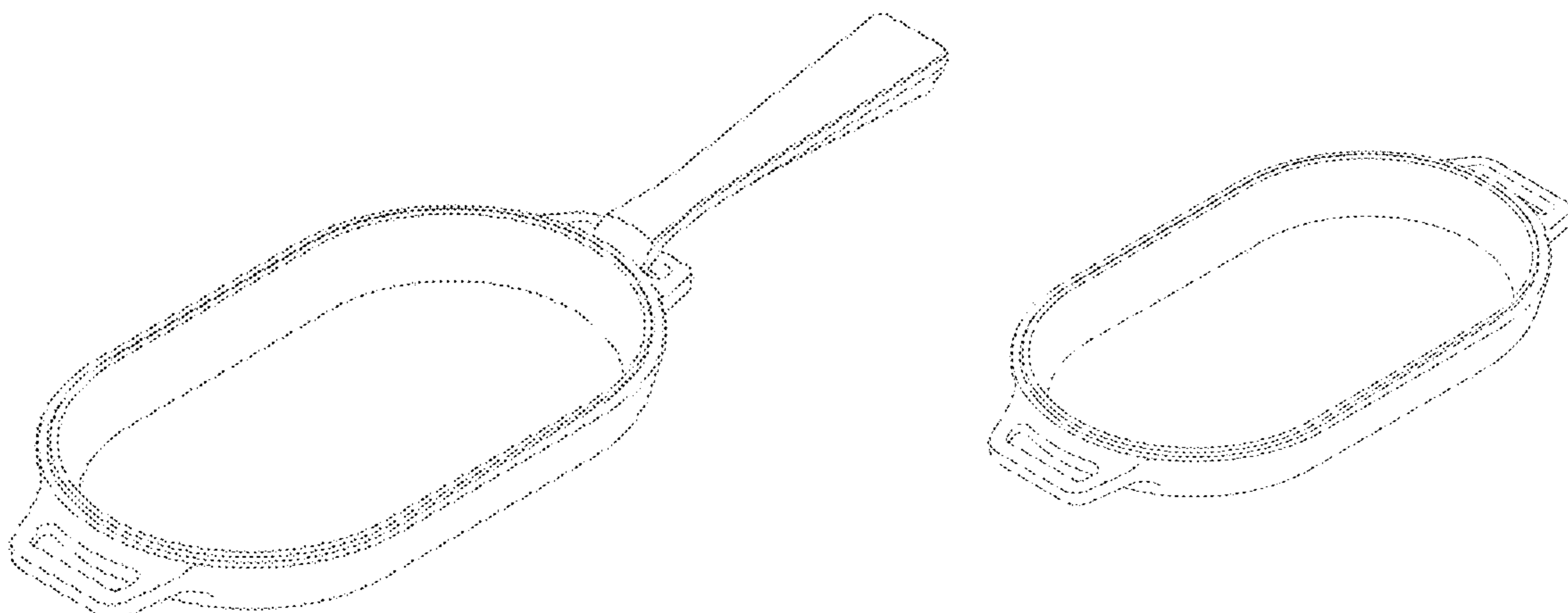


FIG. 18 is a top plan view of the pan in the disconnected configuration.

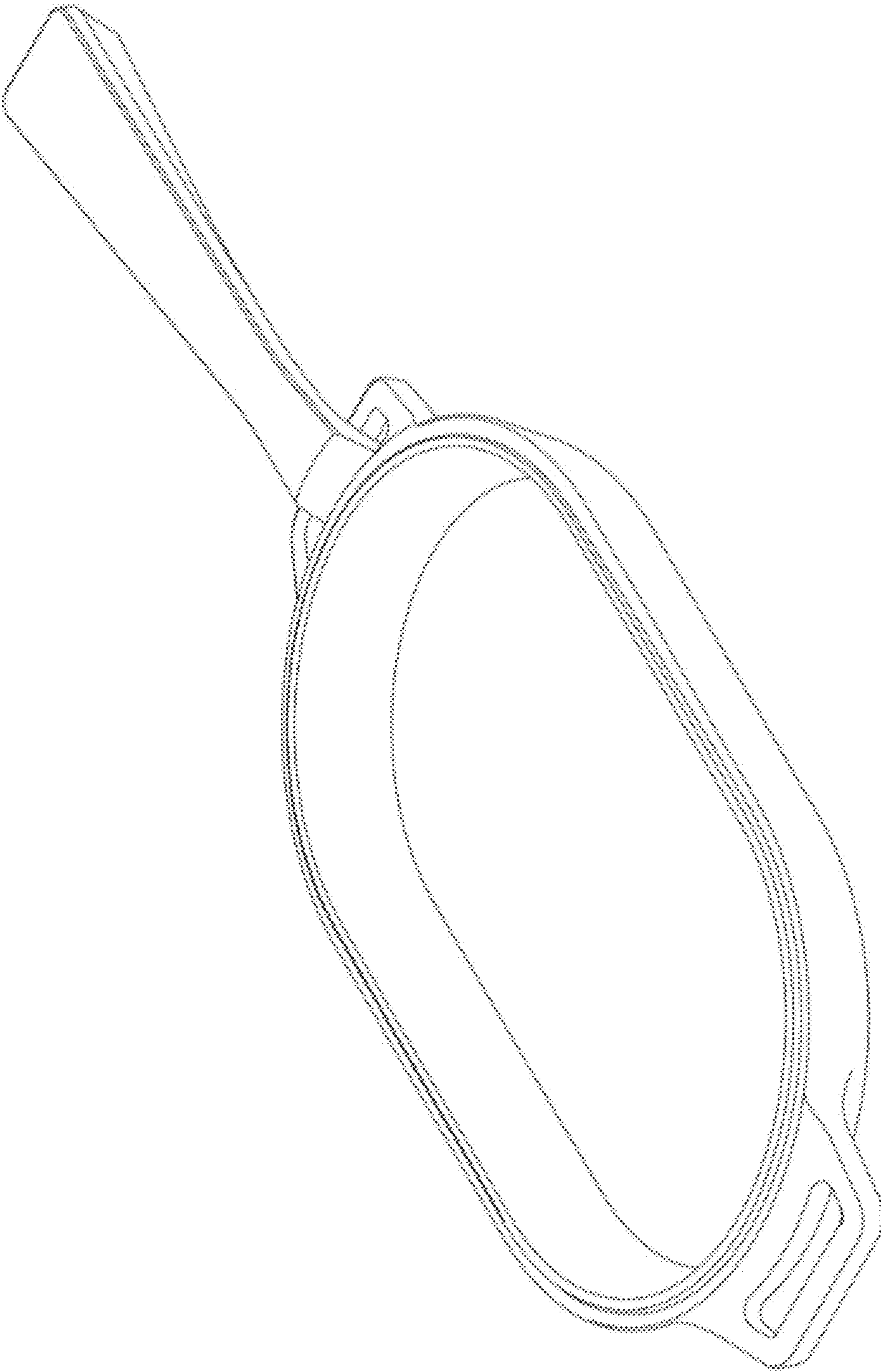

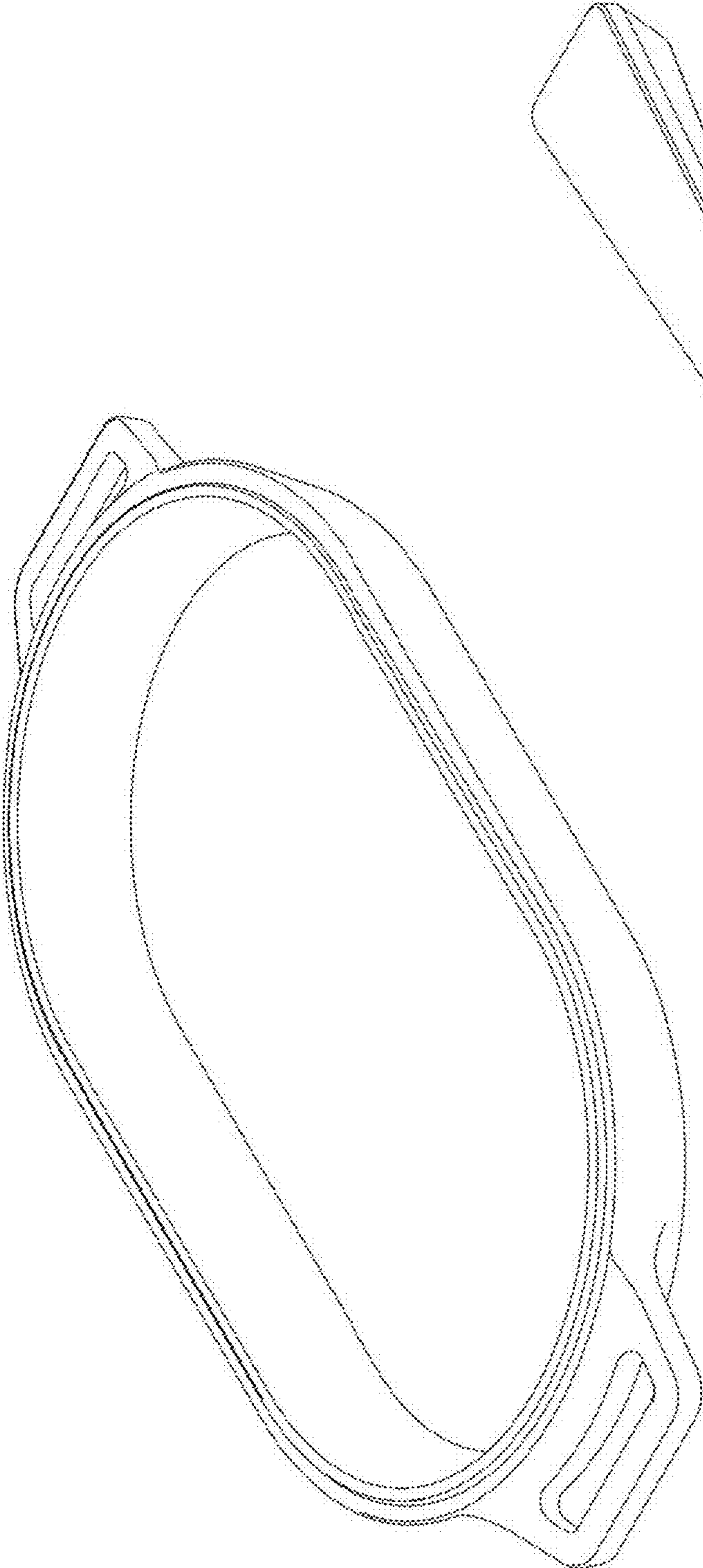

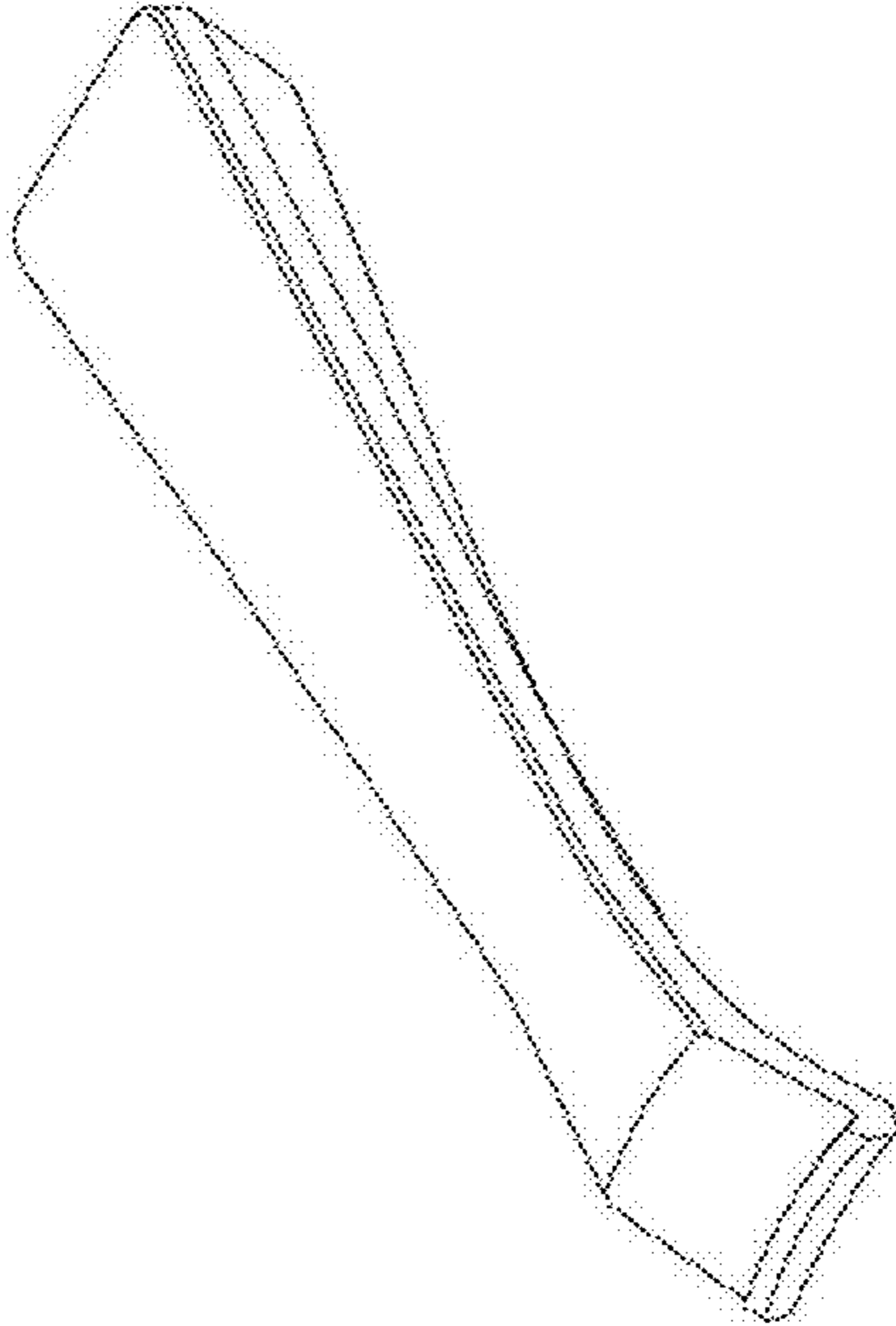

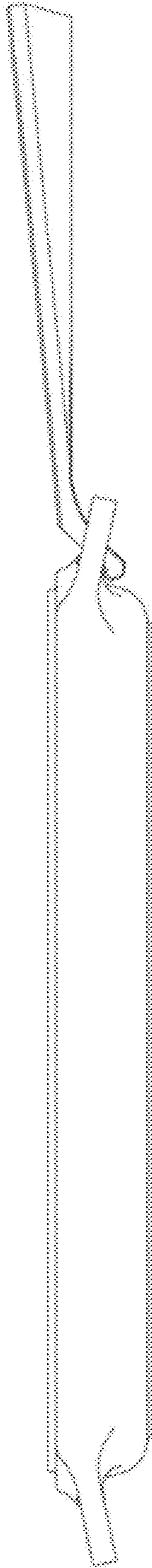

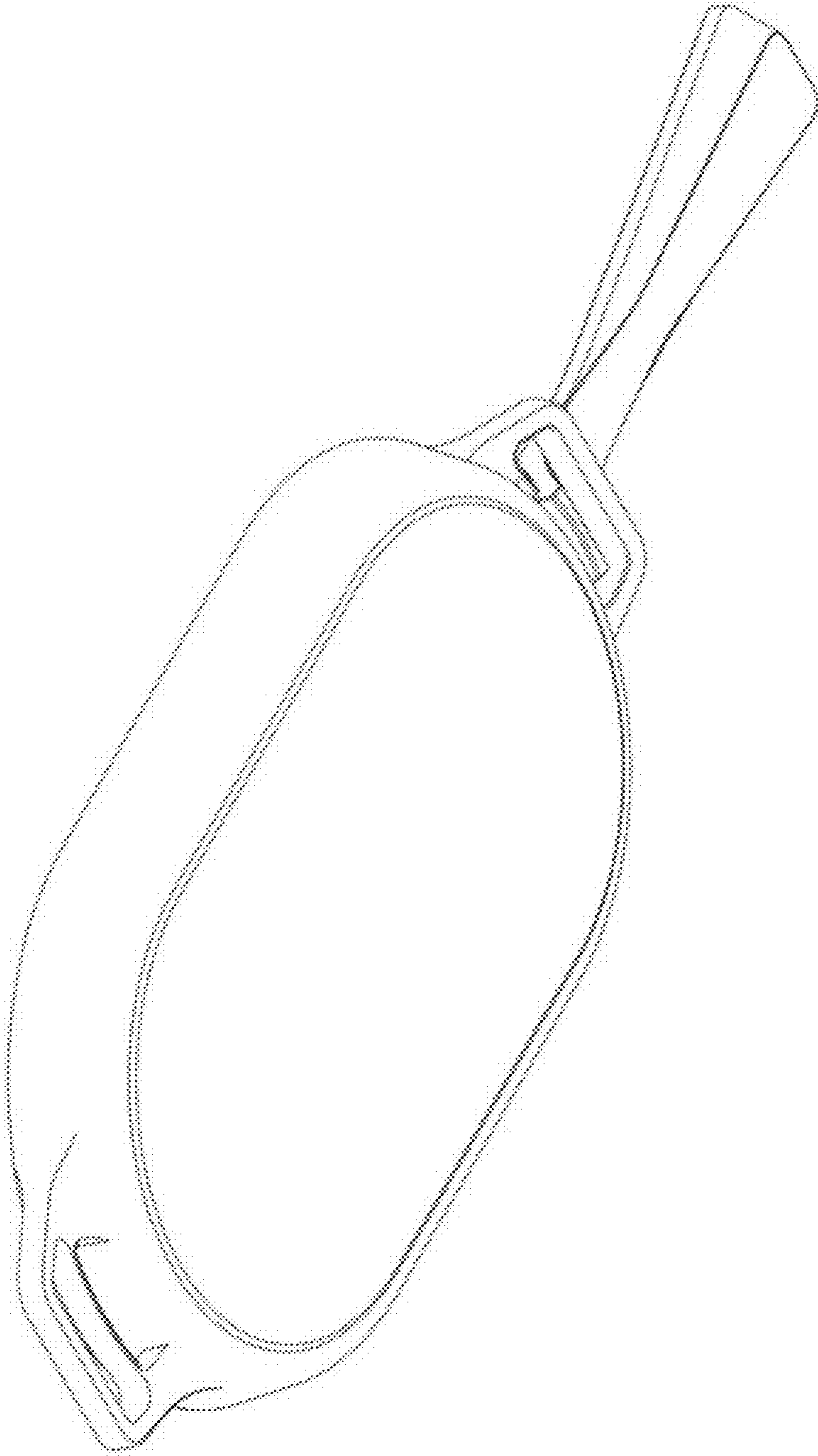

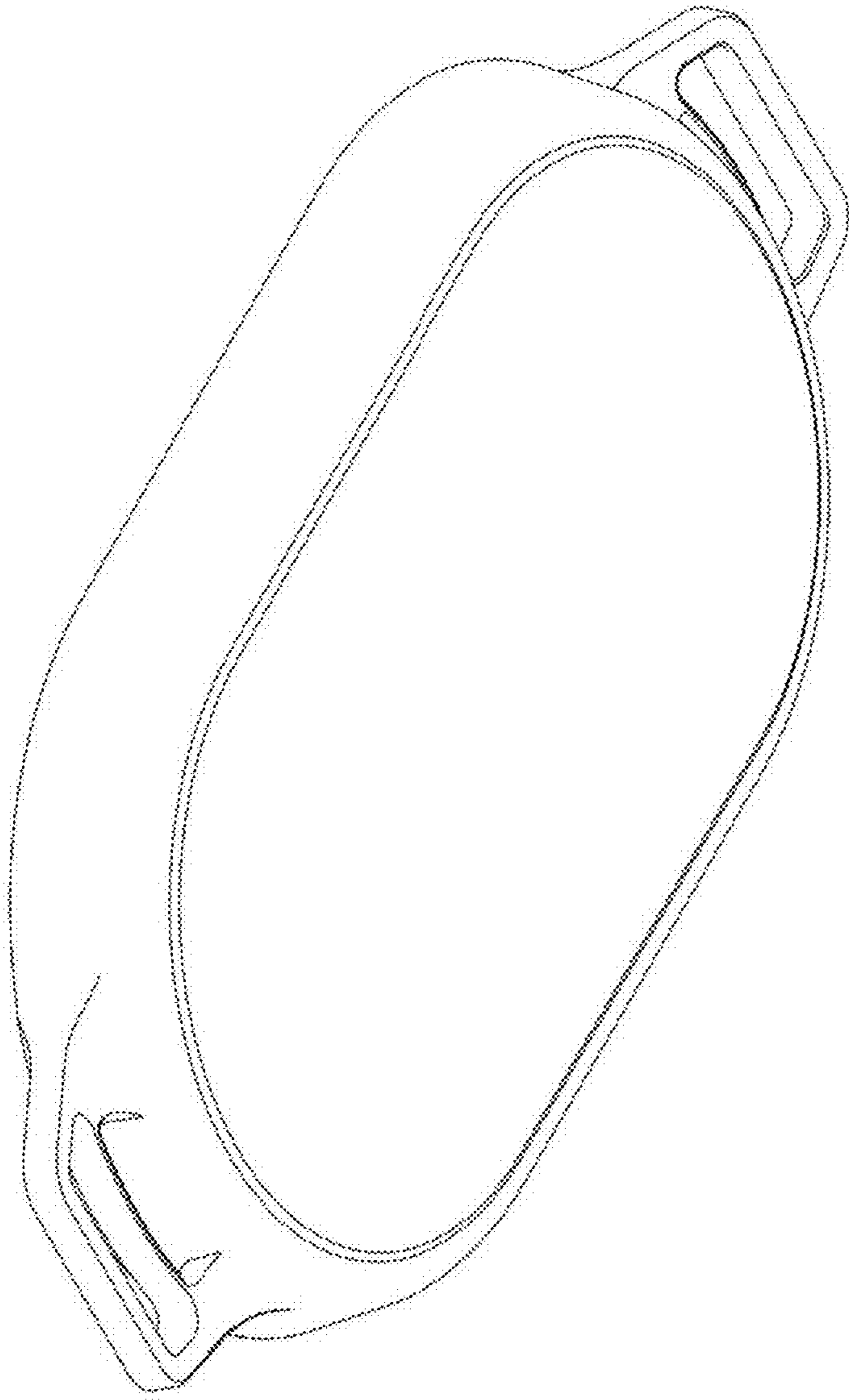

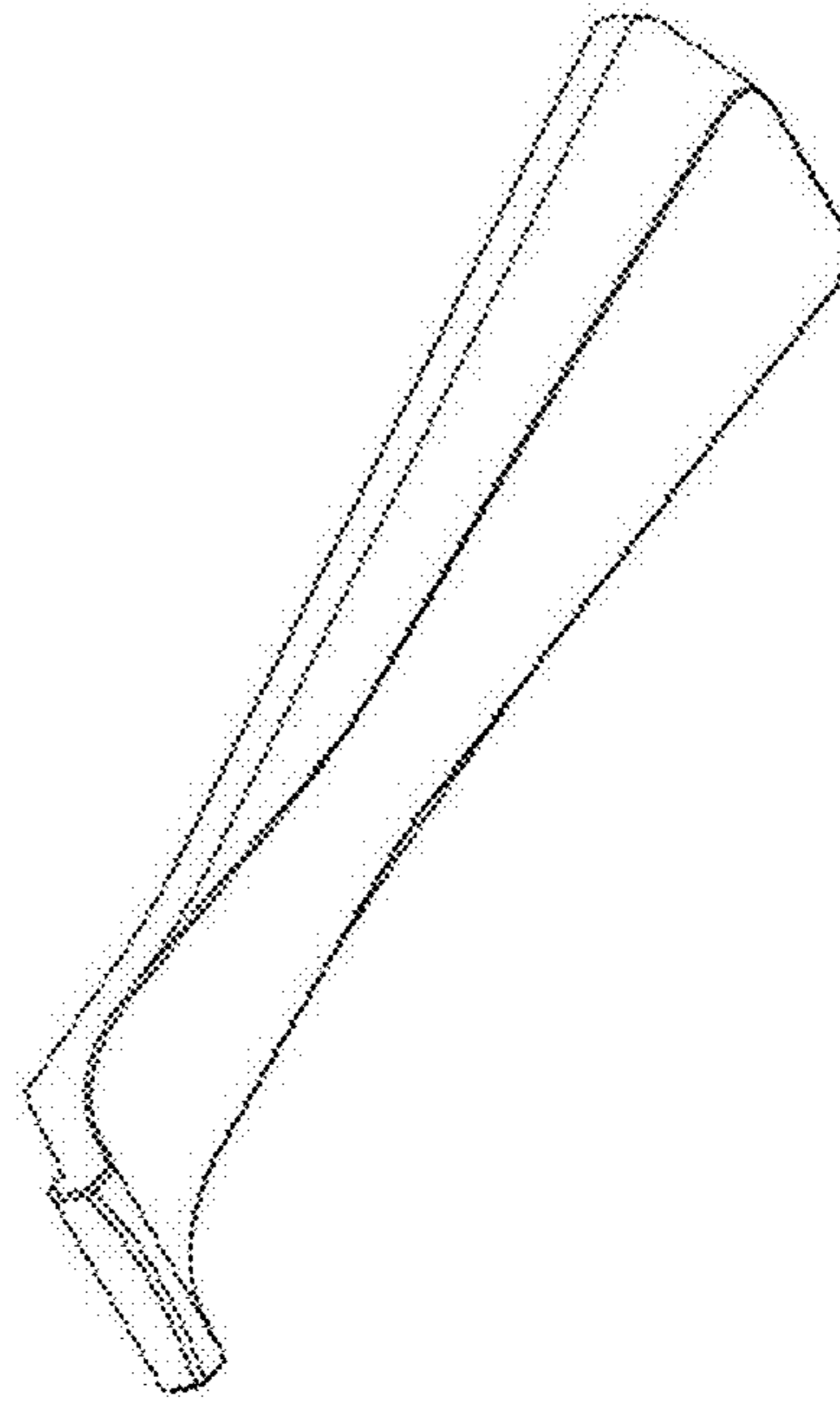

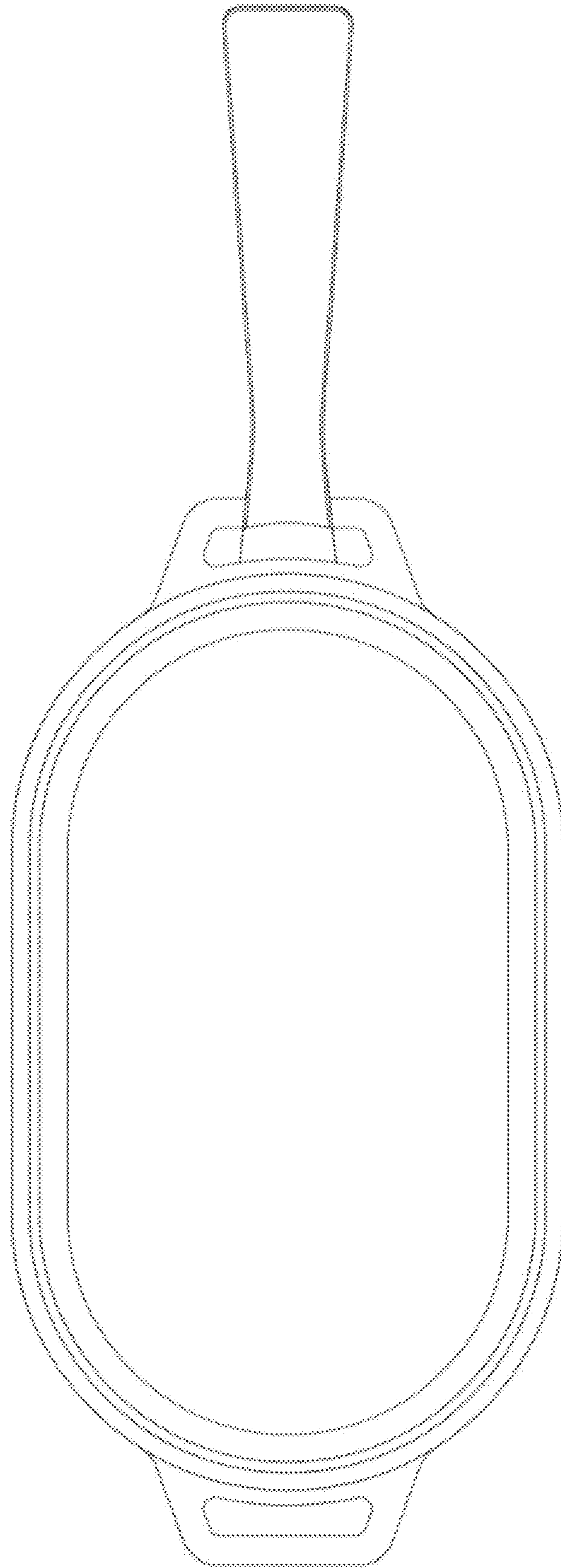

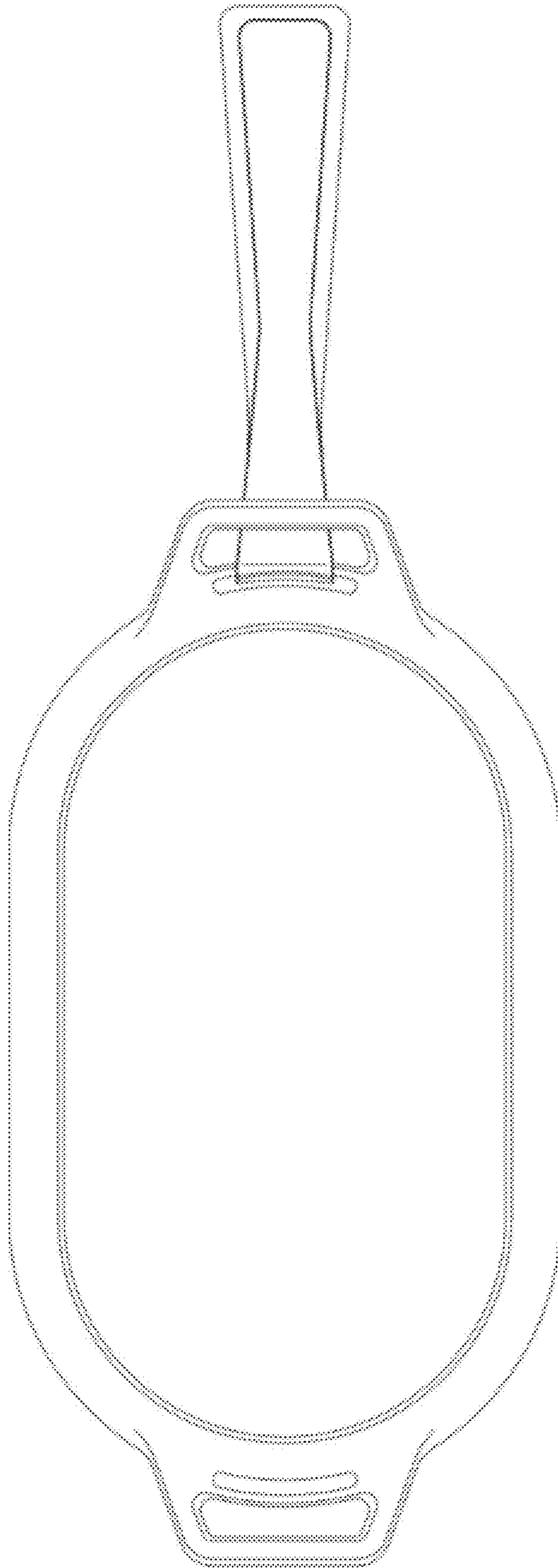

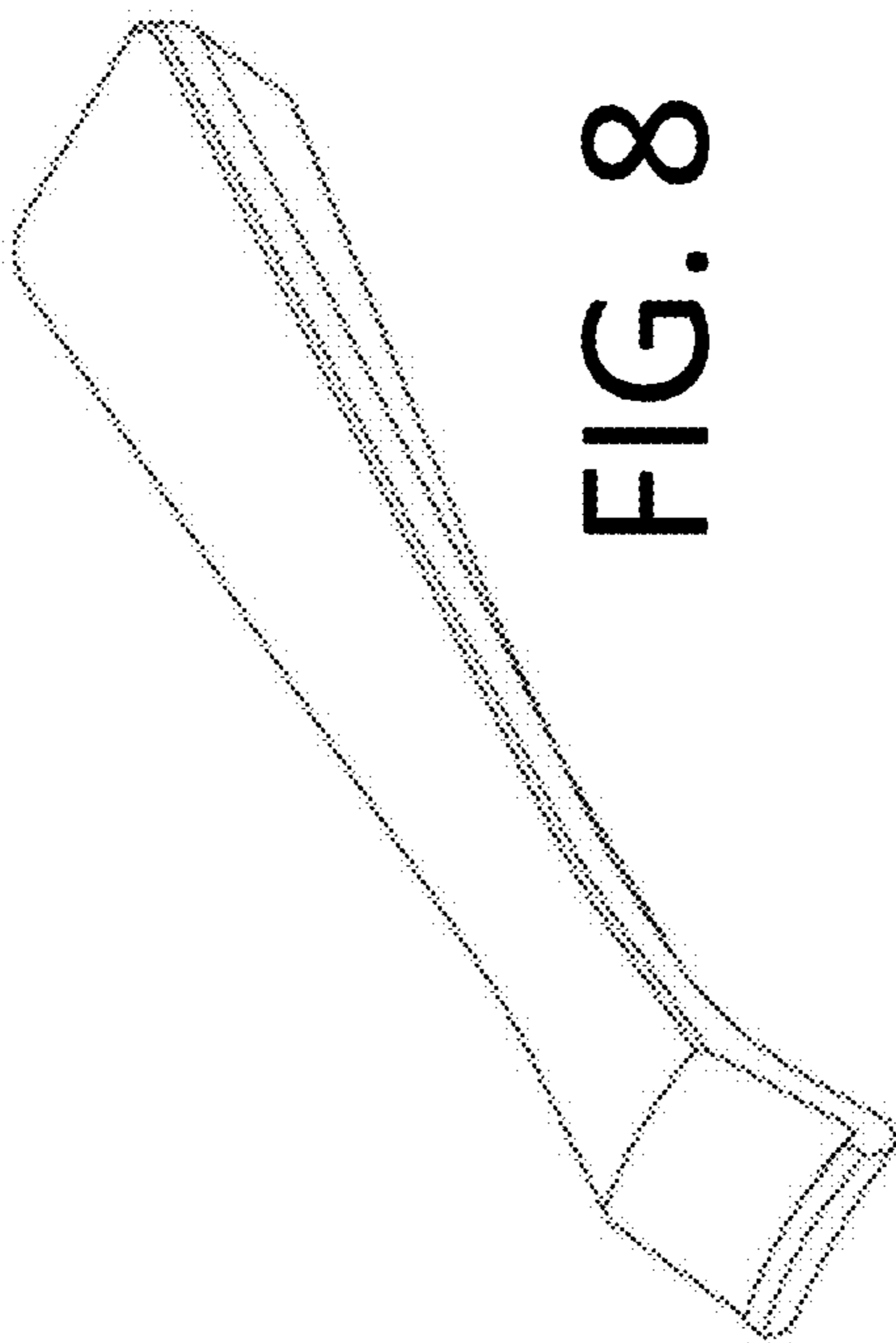

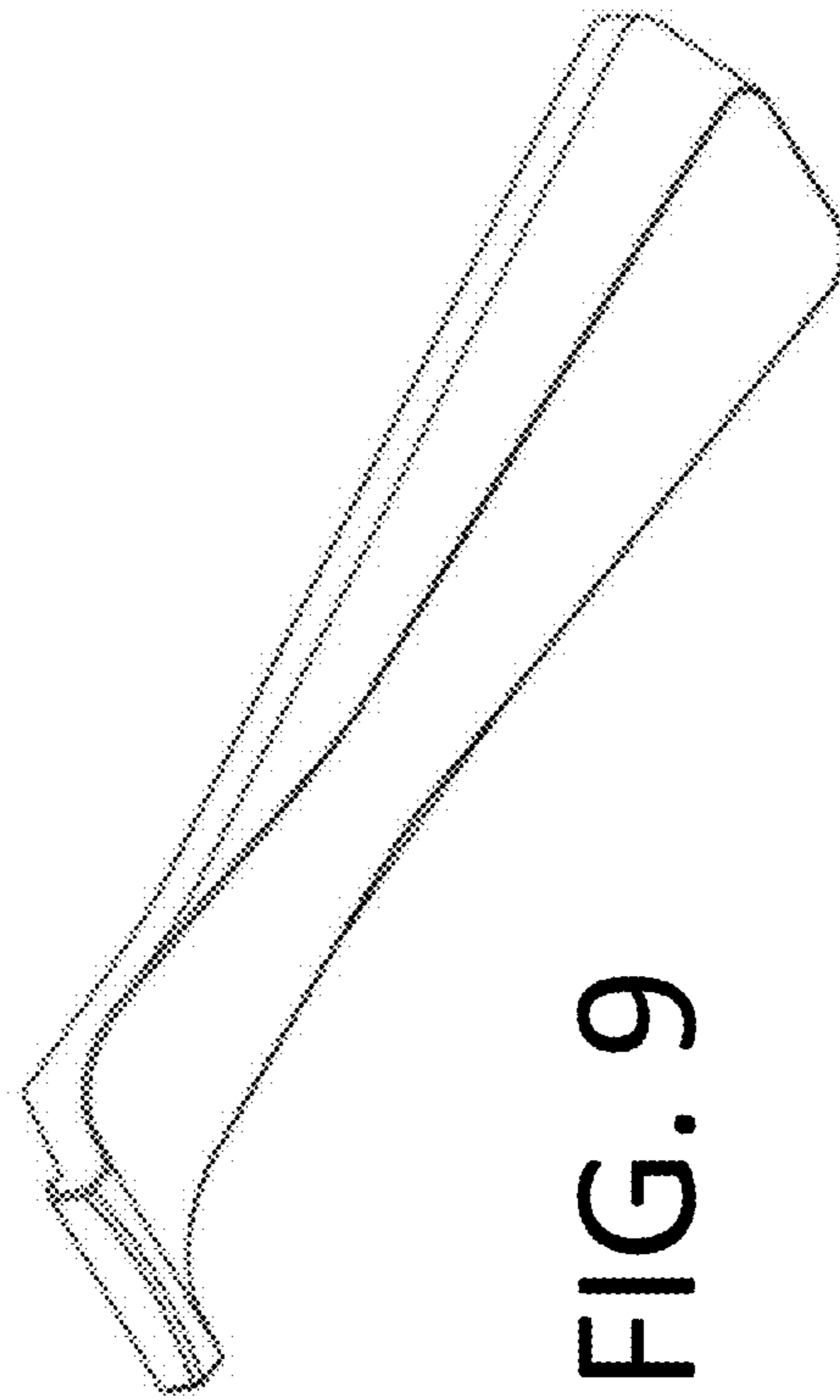

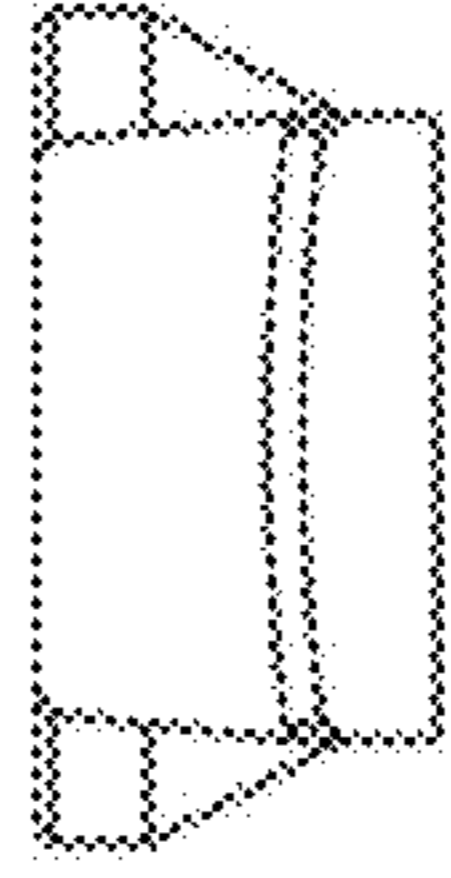

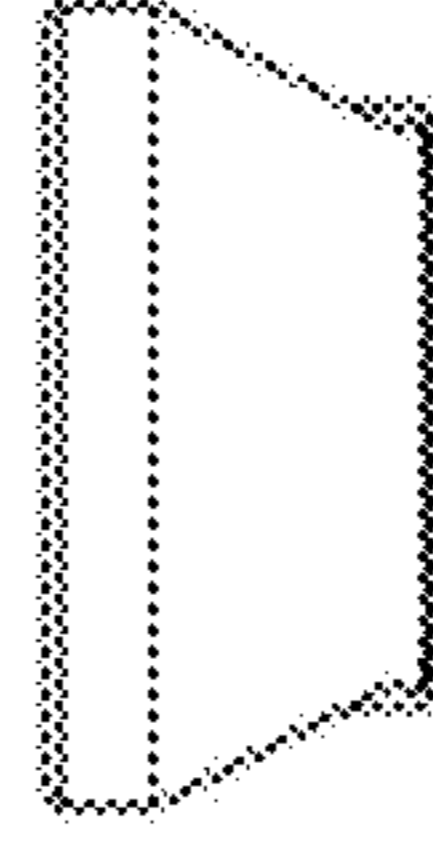

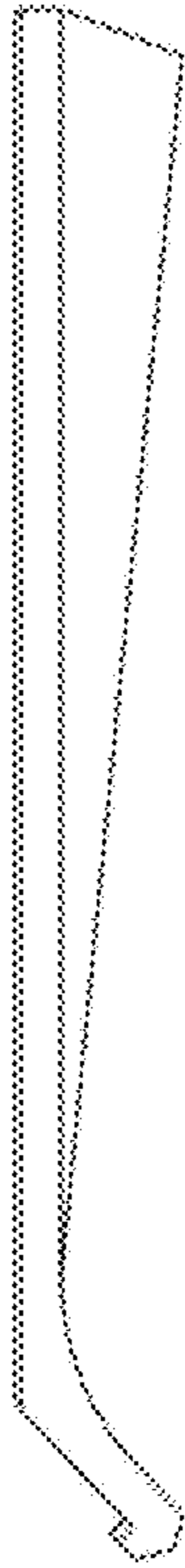

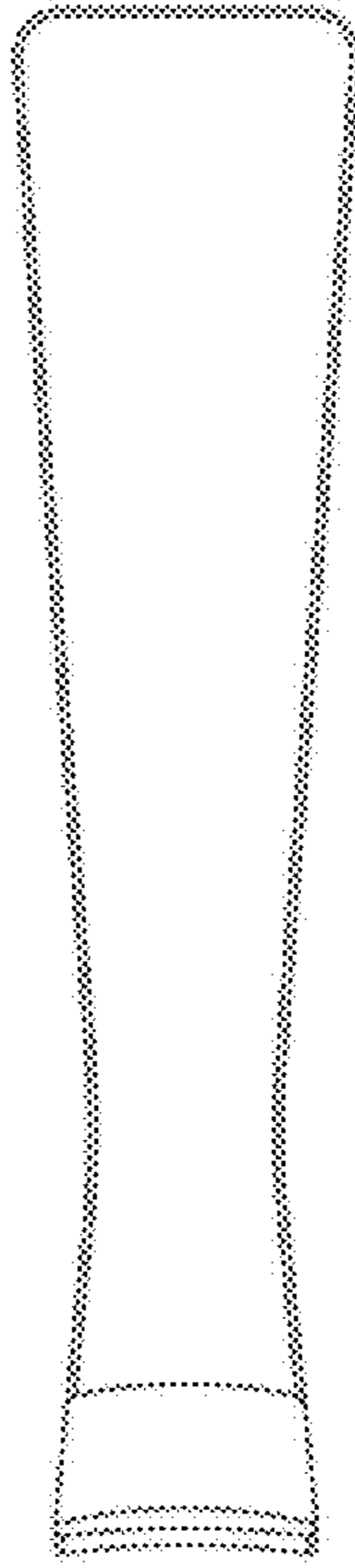
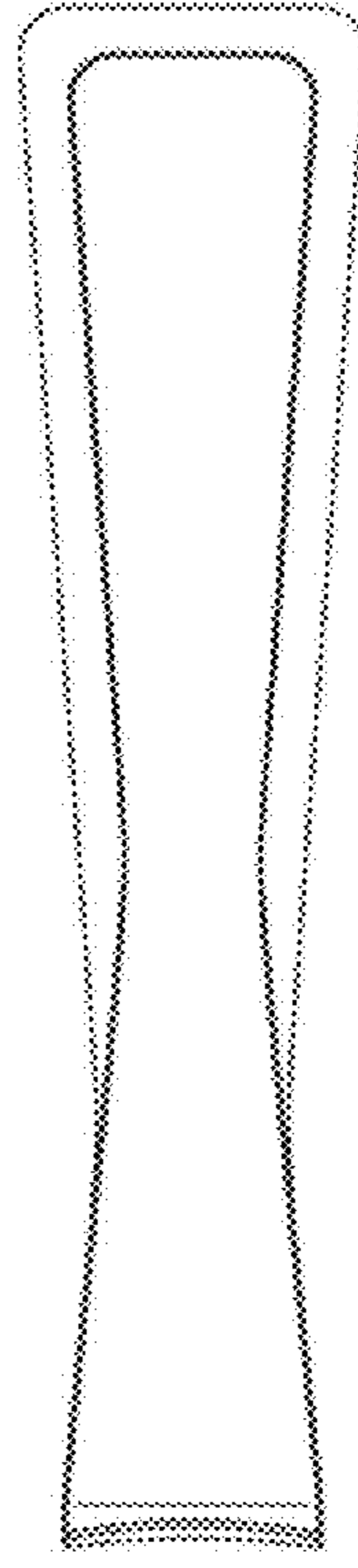

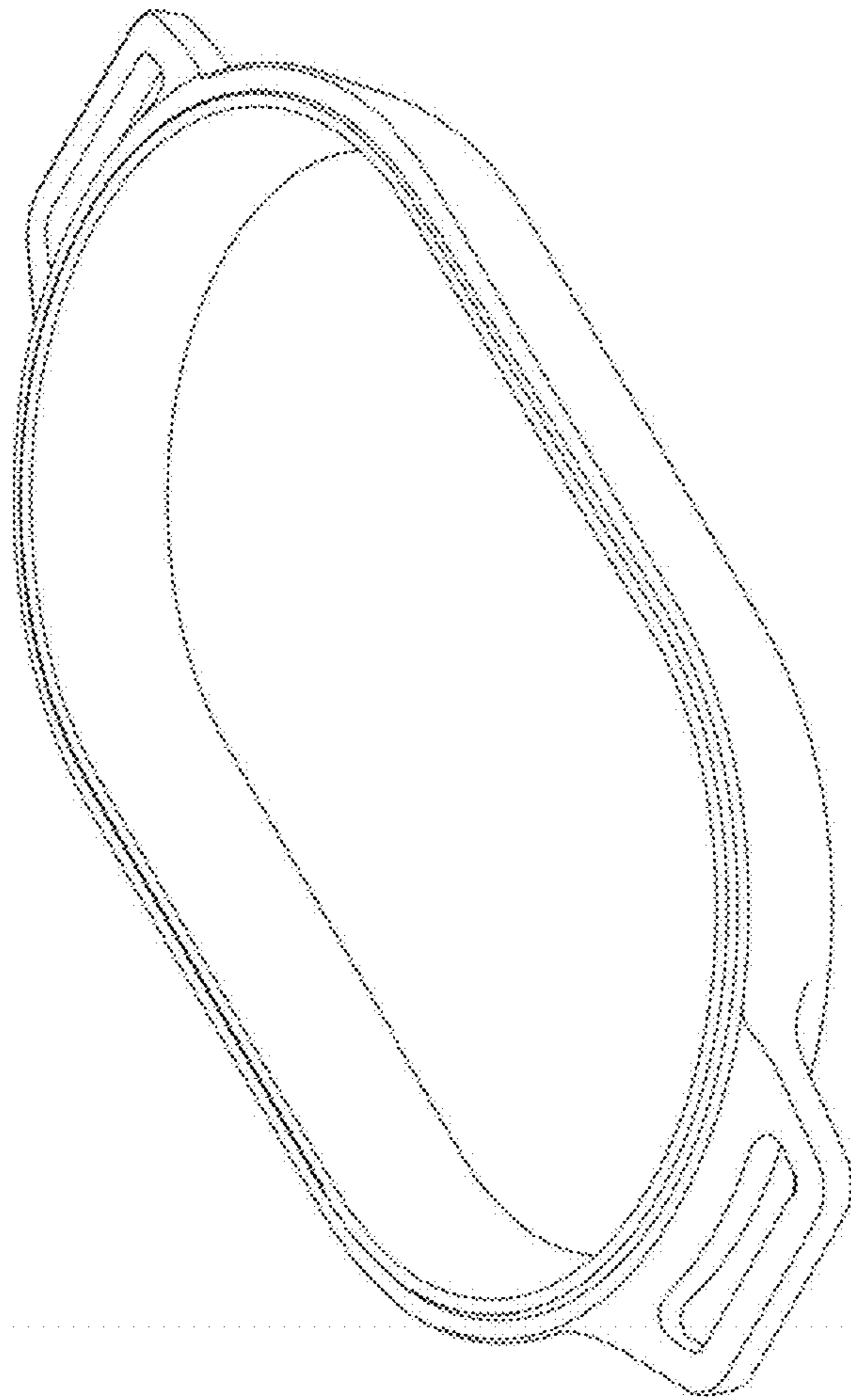

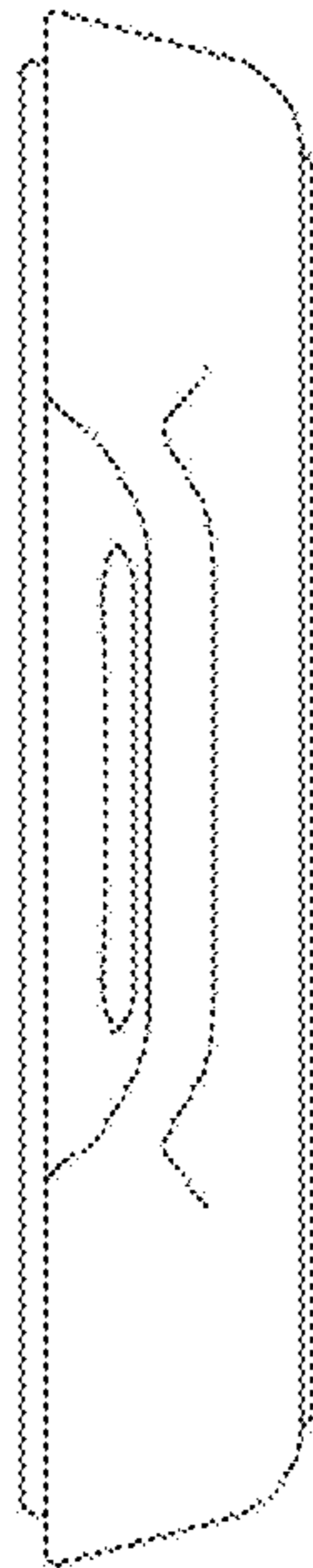

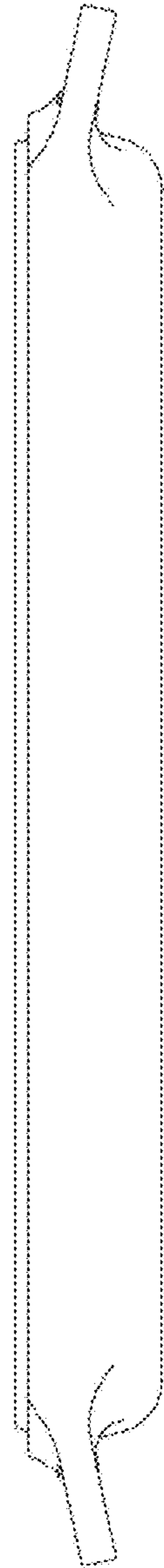

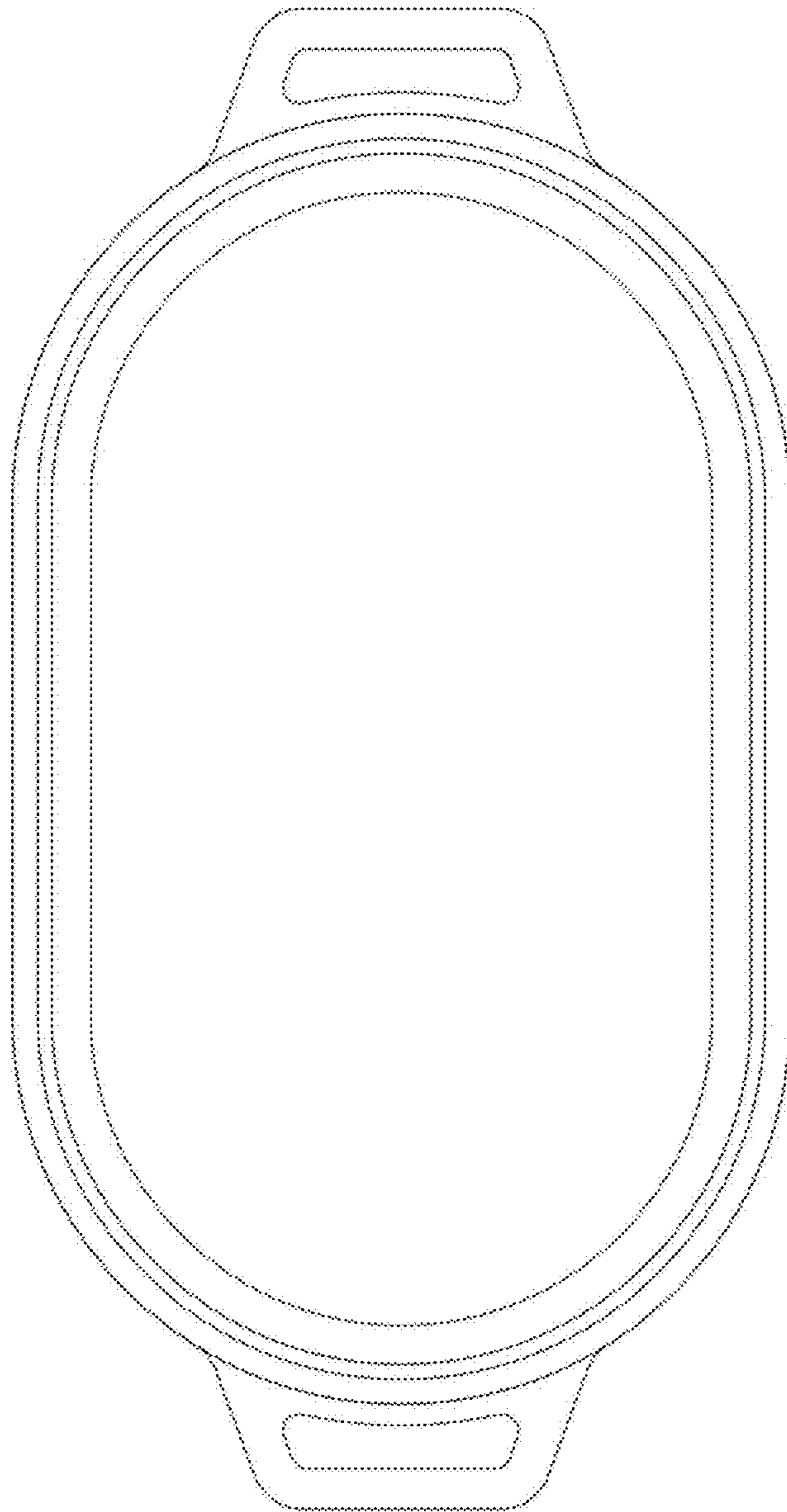

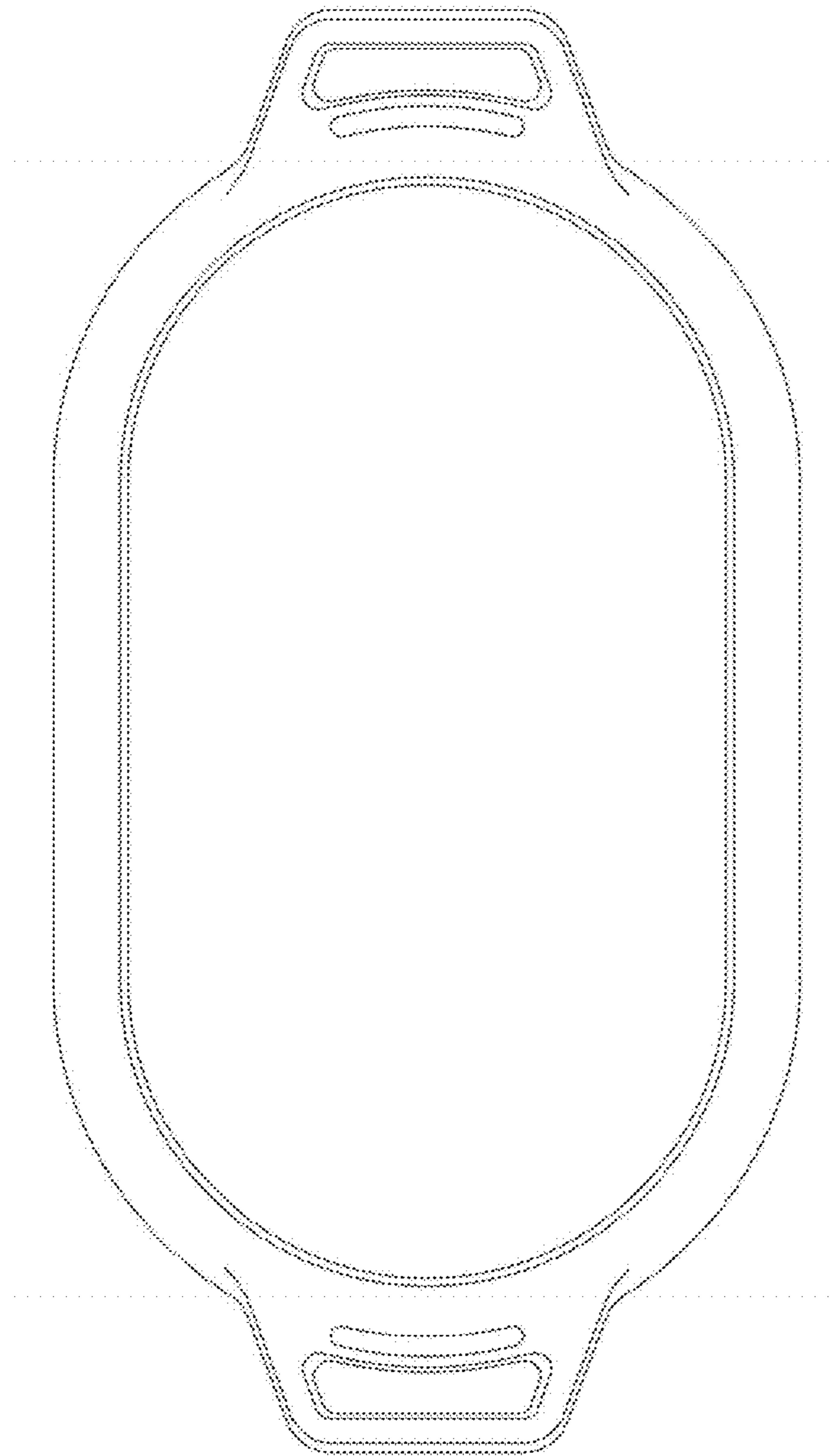

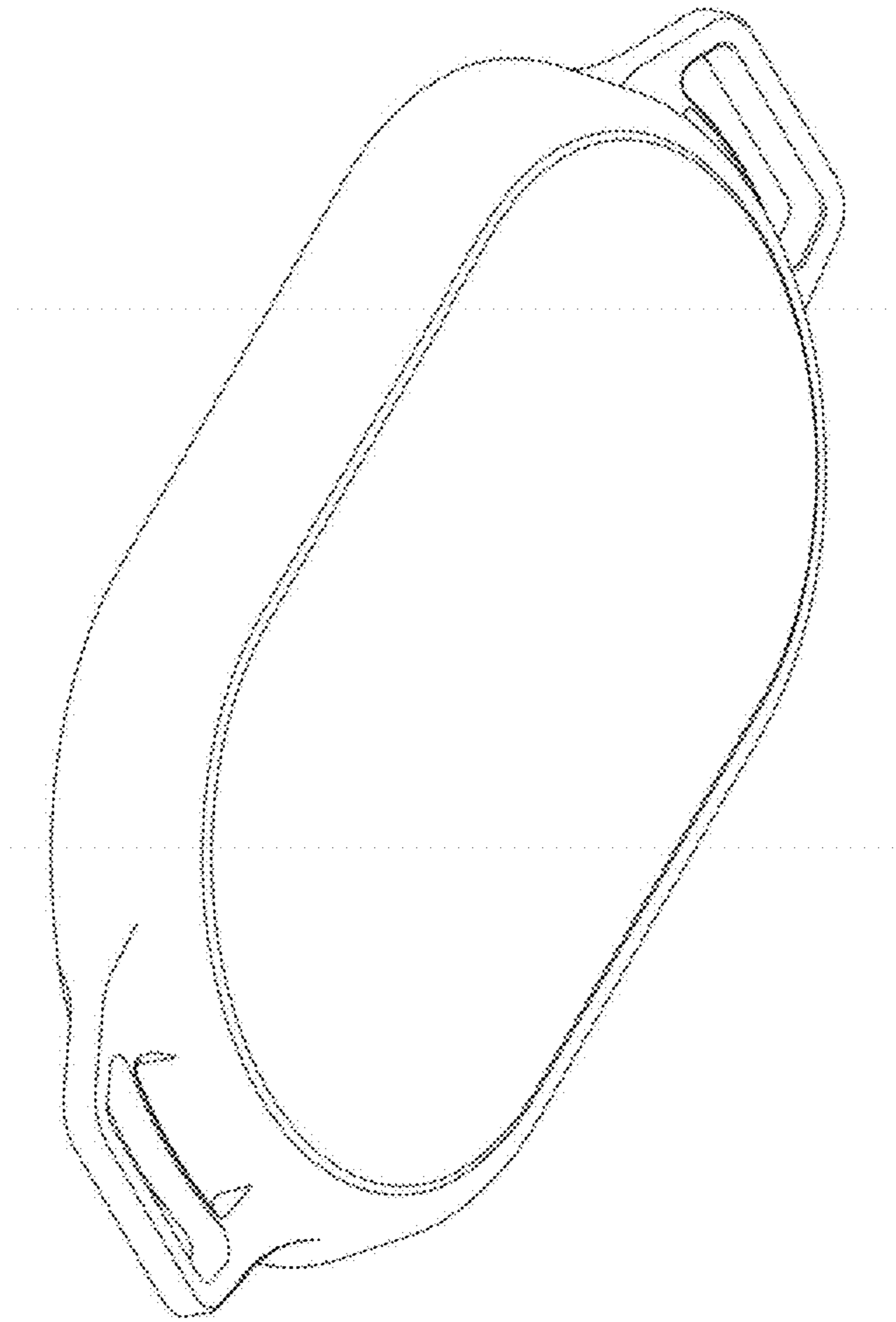
