(57) **CLAIM**

The ornamental design for a concrete forming stake, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a concrete forming stake according to the present design;  
 FIG. 2 is a bottom perspective view thereof;  
 FIG. 3 is a front view thereof;  
 FIG. 4 is a back view thereof;  
 FIG. 5 is a left-side view thereof;  
 FIG. 6 is a right-side view thereof;  
 FIG. 7 is a top view thereof; and,  
 FIG. 8 is a bottom view thereof.  
 The dashed broken lines depict portions of the concrete forming stake that form no part of the claimed design. The dot-dashed broken lines represent boundaries of the claimed concrete forming stake and form no part of the claimed design.

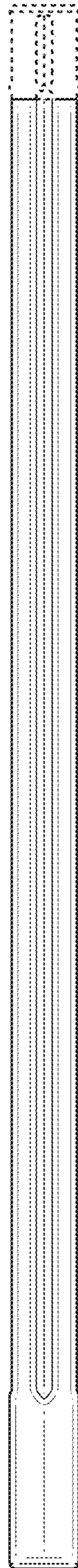

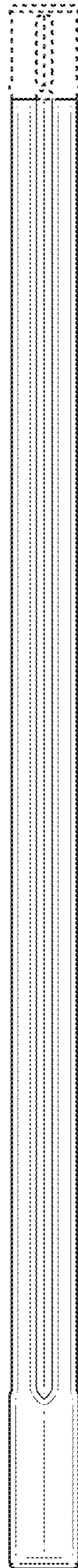

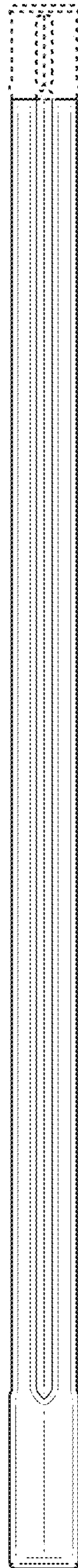

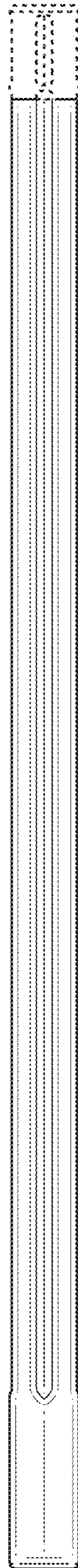

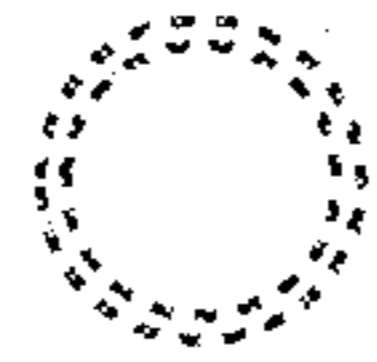
