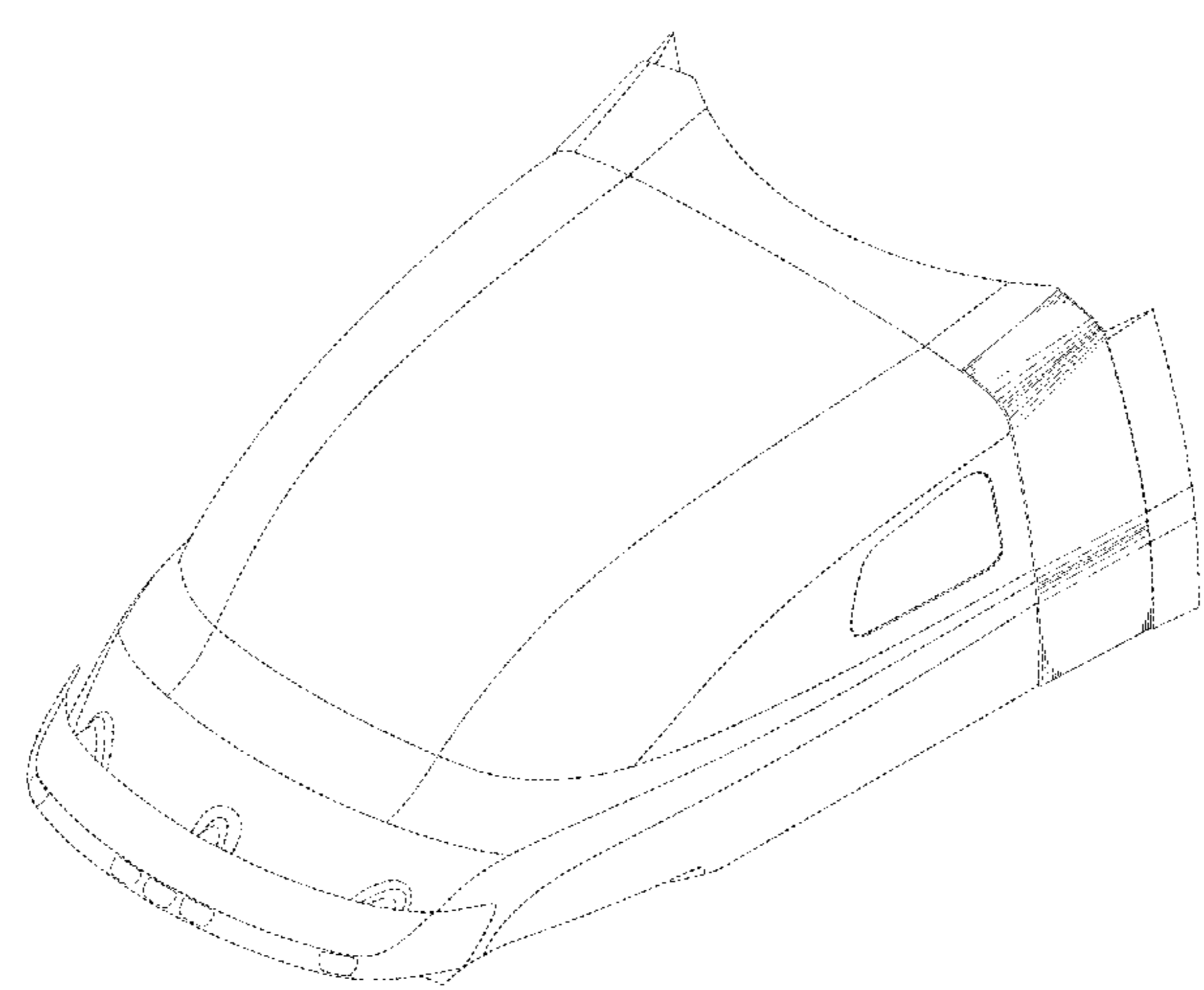

(57) **CLAIM**

The ornamental design for a vehicle roof fairing, as shown and described.

DESCRIPTION

FIG. 1 is an environmental view of a first embodiment of a vehicle roof fairing according to our new design, wherein the vehicle roof fairing is located on a left side of the vehicle roof;

FIG. 2 is a front perspective view of the vehicle roof fairing shown in FIG. 1;
 FIG. 3 is a rear perspective view of the vehicle roof fairing shown in FIG. 1;
 FIG. 4 is a right side elevational view of the vehicle roof fairing shown in FIG. 1;
 FIG. 5 is a front elevational view of the vehicle roof fairing shown in FIG. 1;
 FIG. 6 is a rear elevational view of the vehicle roof fairing shown in FIG. 1;
 FIG. 7 is a top plan view of the vehicle roof fairing shown in FIG. 1;
 FIG. 8 is a bottom plan view of the vehicle roof fairing shown in FIG. 1;
 FIG. 9 is an environmental view of a second embodiment of a vehicle roof fairing according to our new design, wherein the vehicle roof fairing is located on a right side of the vehicle roof;

 FIG. 11 is a rear perspective view of the vehicle roof fairing shown in FIG. 9;
 FIG. 12 is a left side elevational view of the vehicle roof fairing shown in FIG. 9;
 FIG. 13 is a front elevational view of the vehicle roof fairing shown in FIG. 9;
 FIG. 14 is a rear elevational view of the vehicle roof fairing shown in FIG. 9;
 FIG. 15 is a top plan view of the vehicle roof fairing shown in FIG. 9; and,
 FIG. 16 is a bottom plan view of the vehicle roof fairing shown in FIG. 9.
 The dashed broken lines in the drawings show portions of the vehicle roof fairing that form no part of the claimed design.

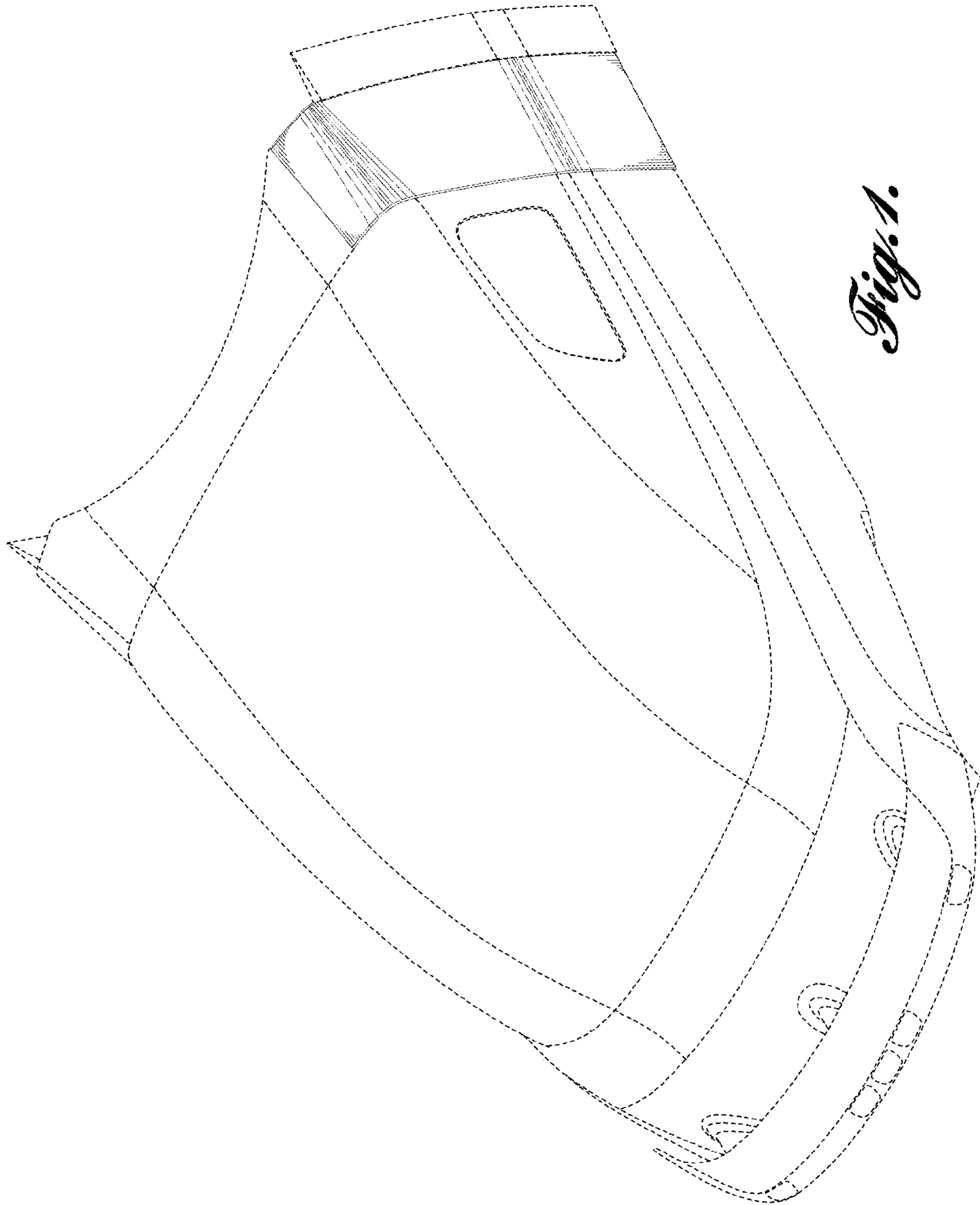

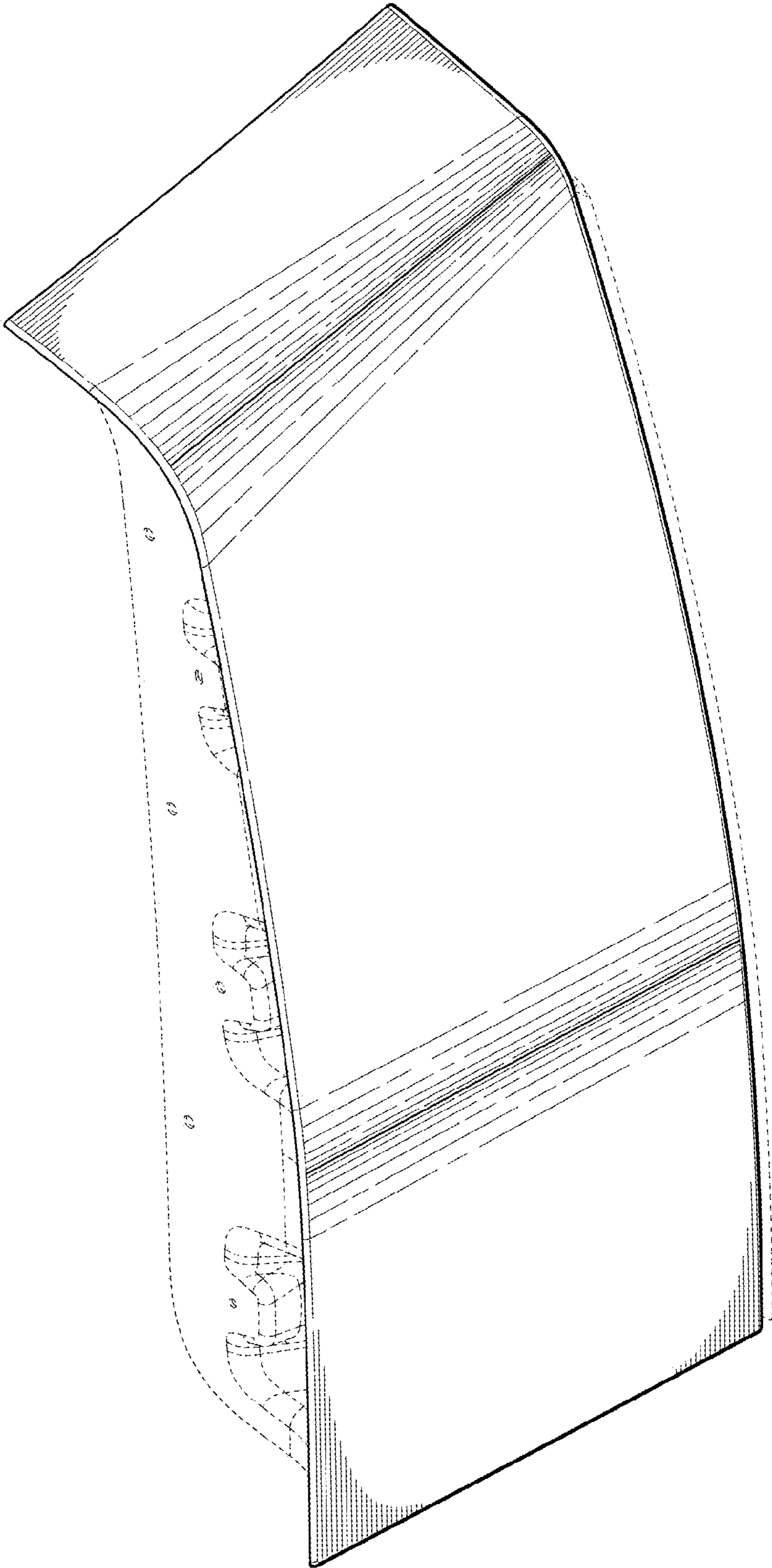

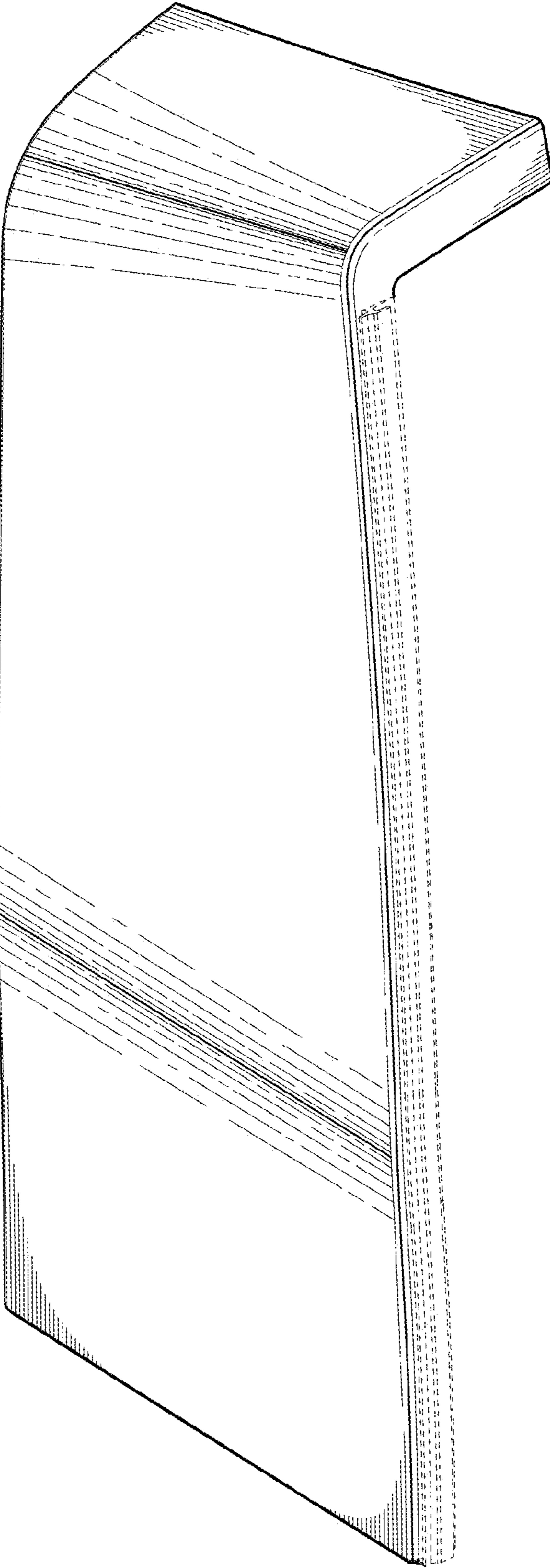

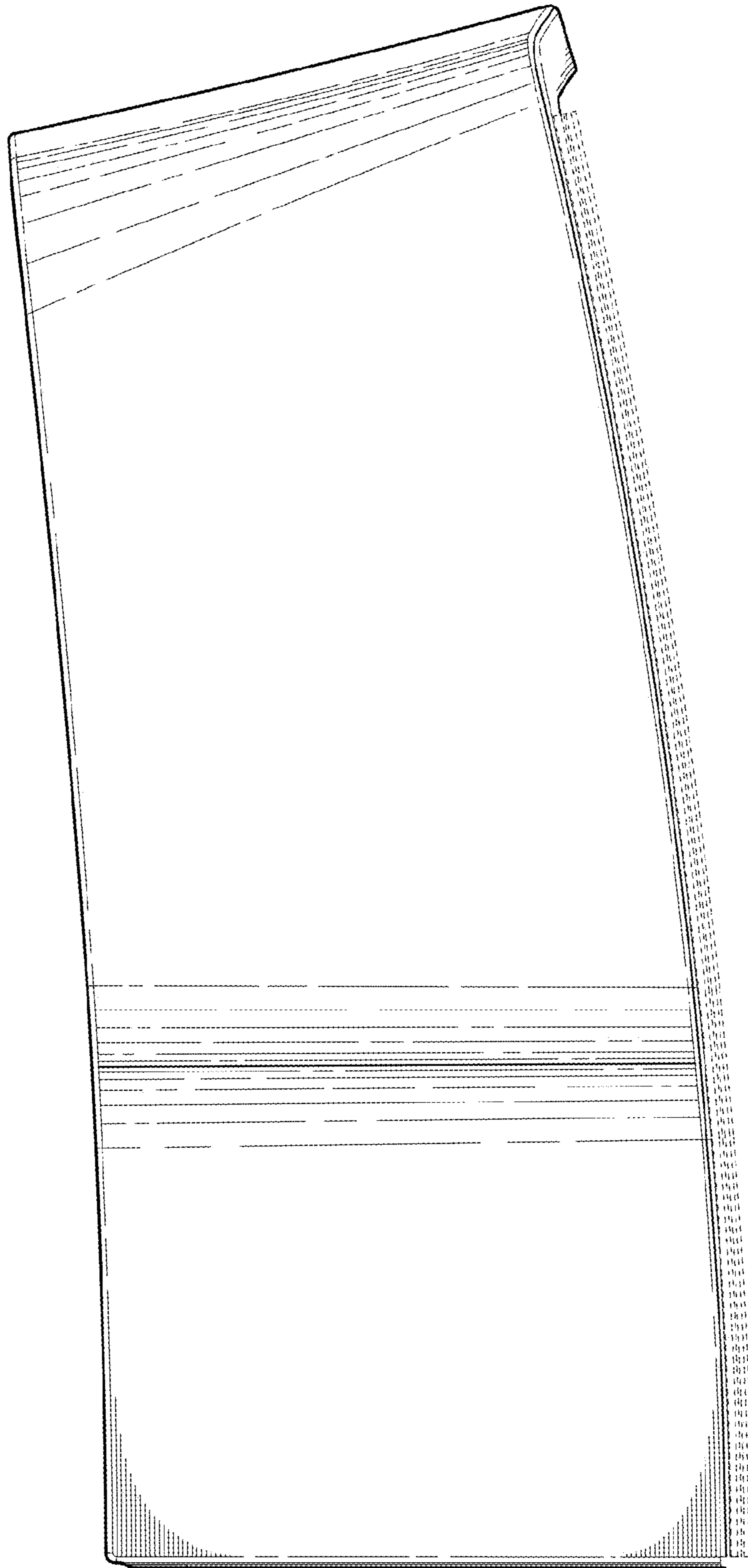

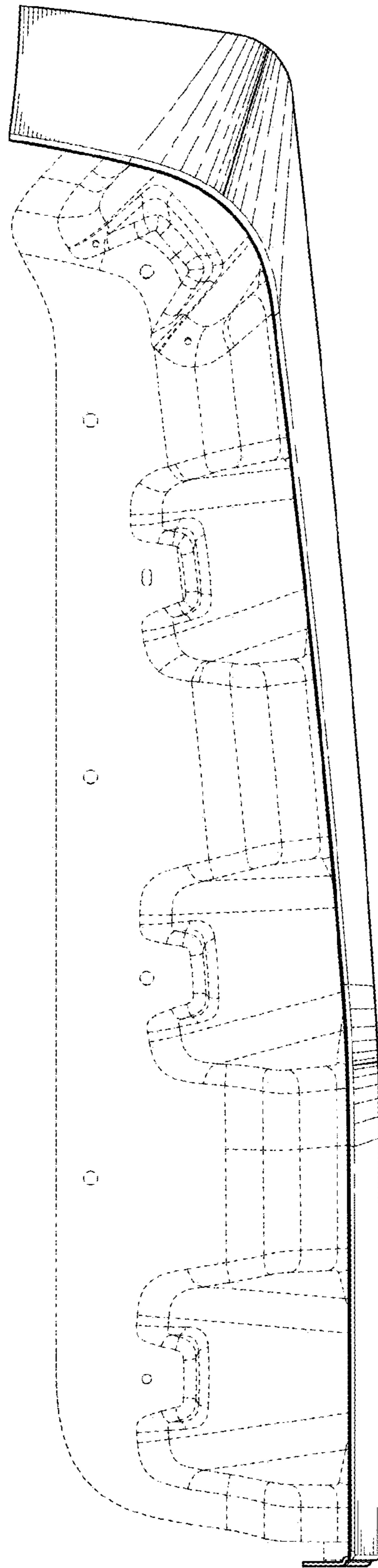

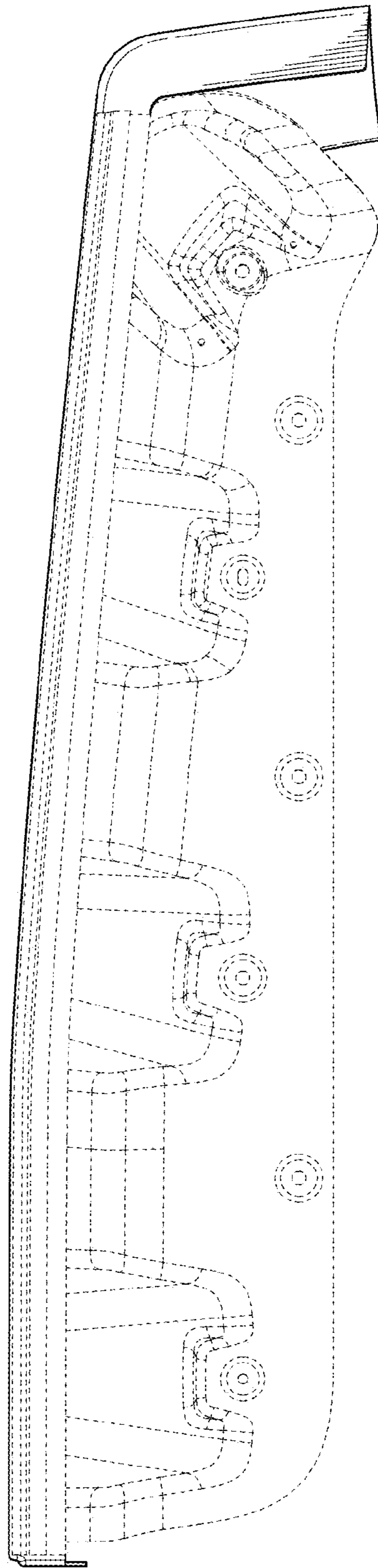

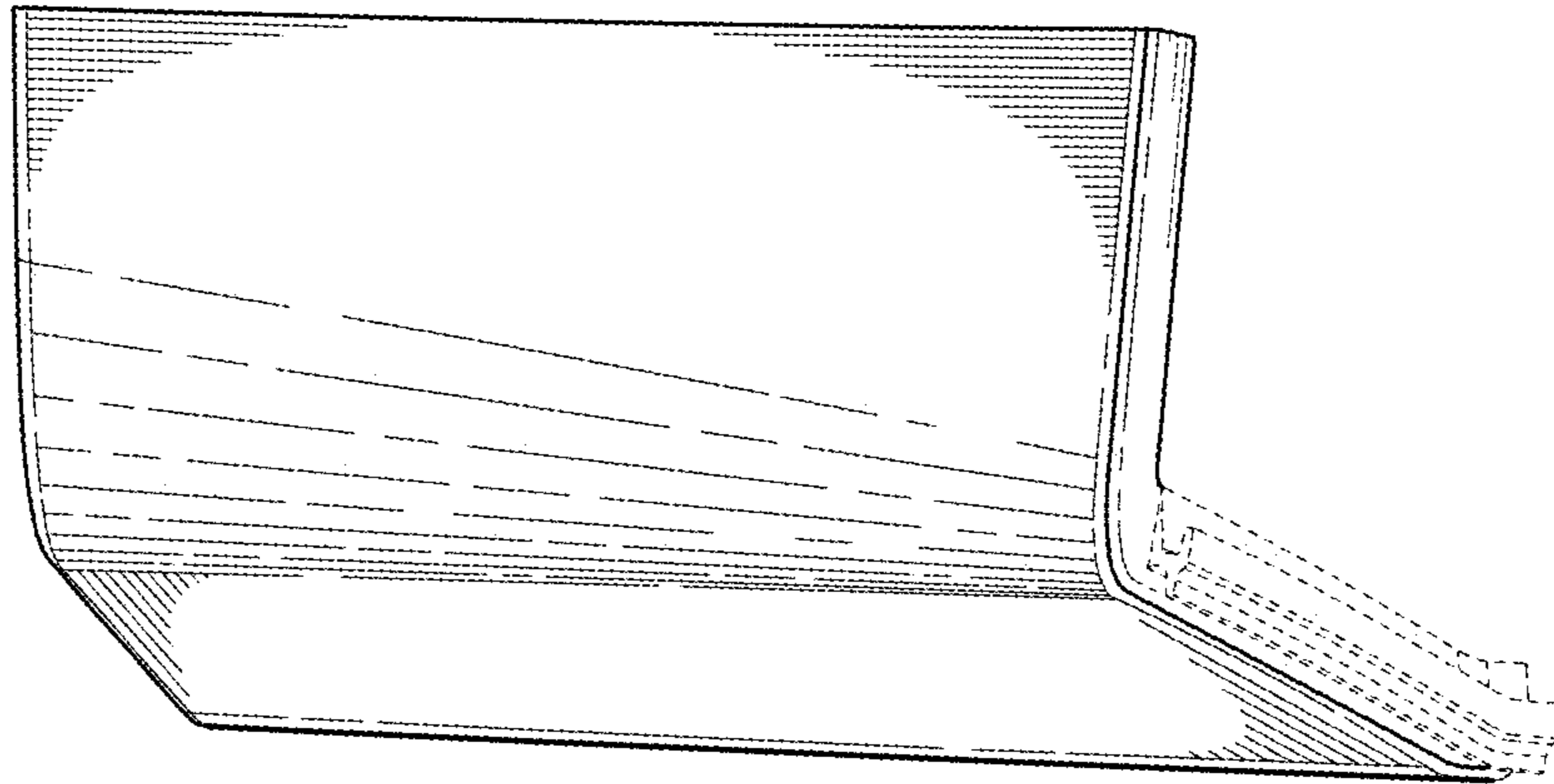

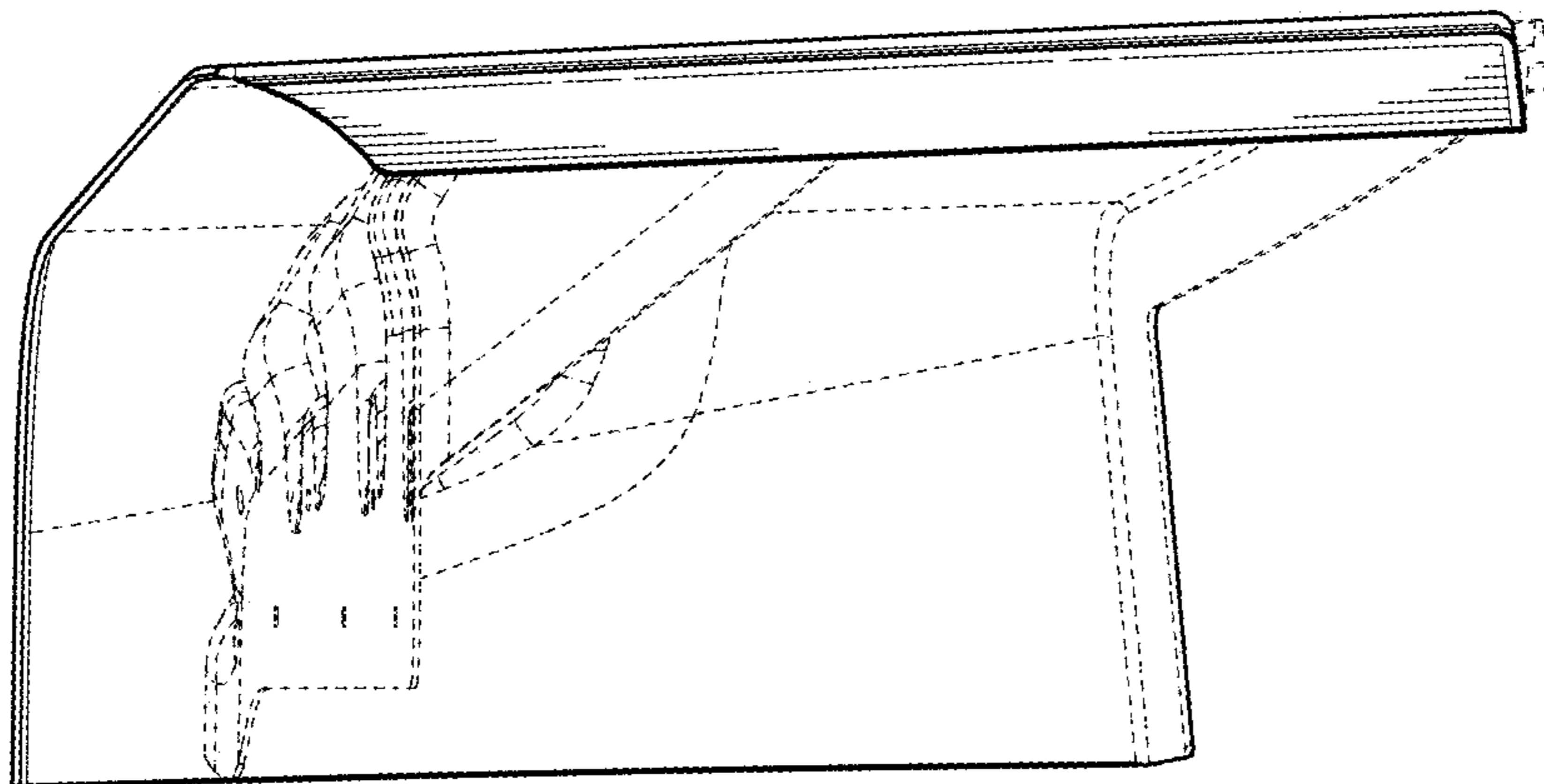

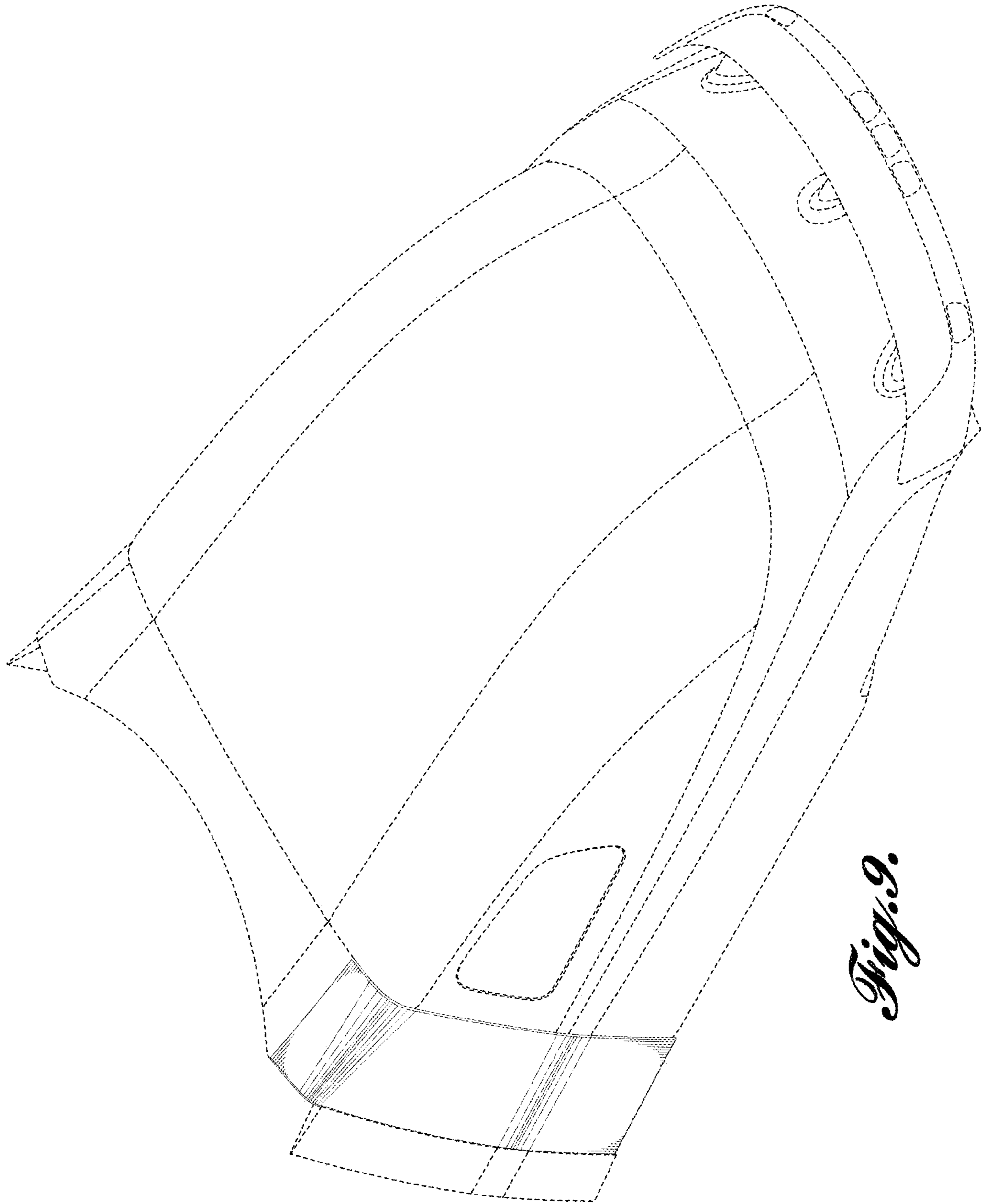

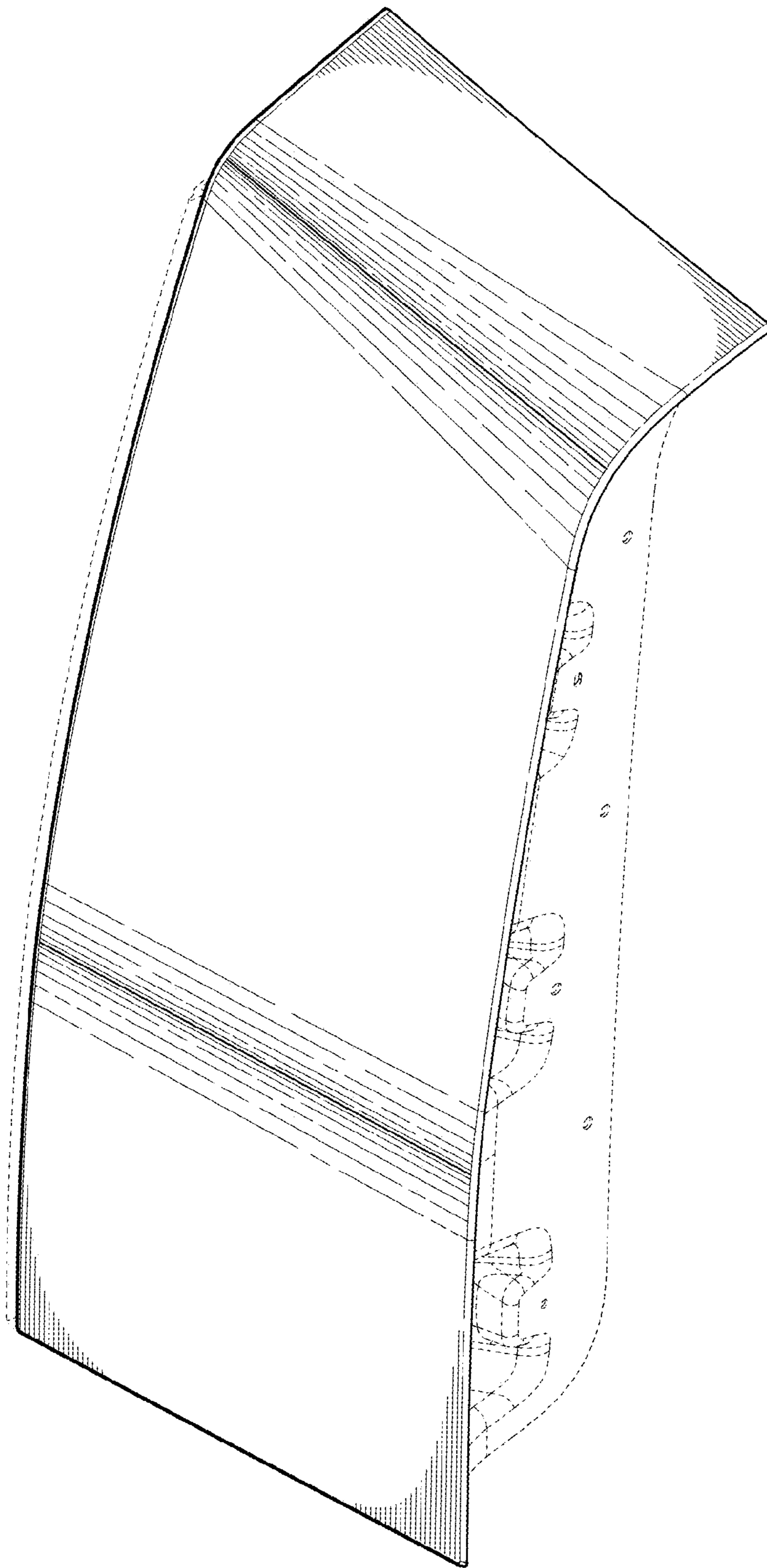

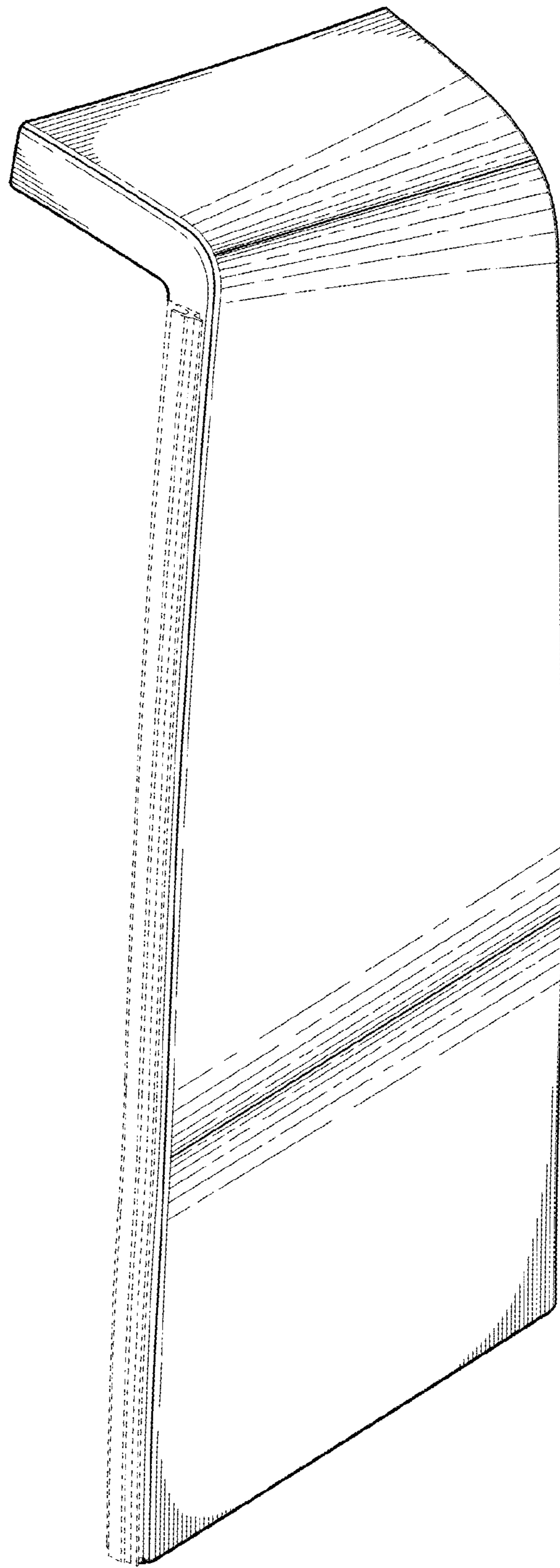

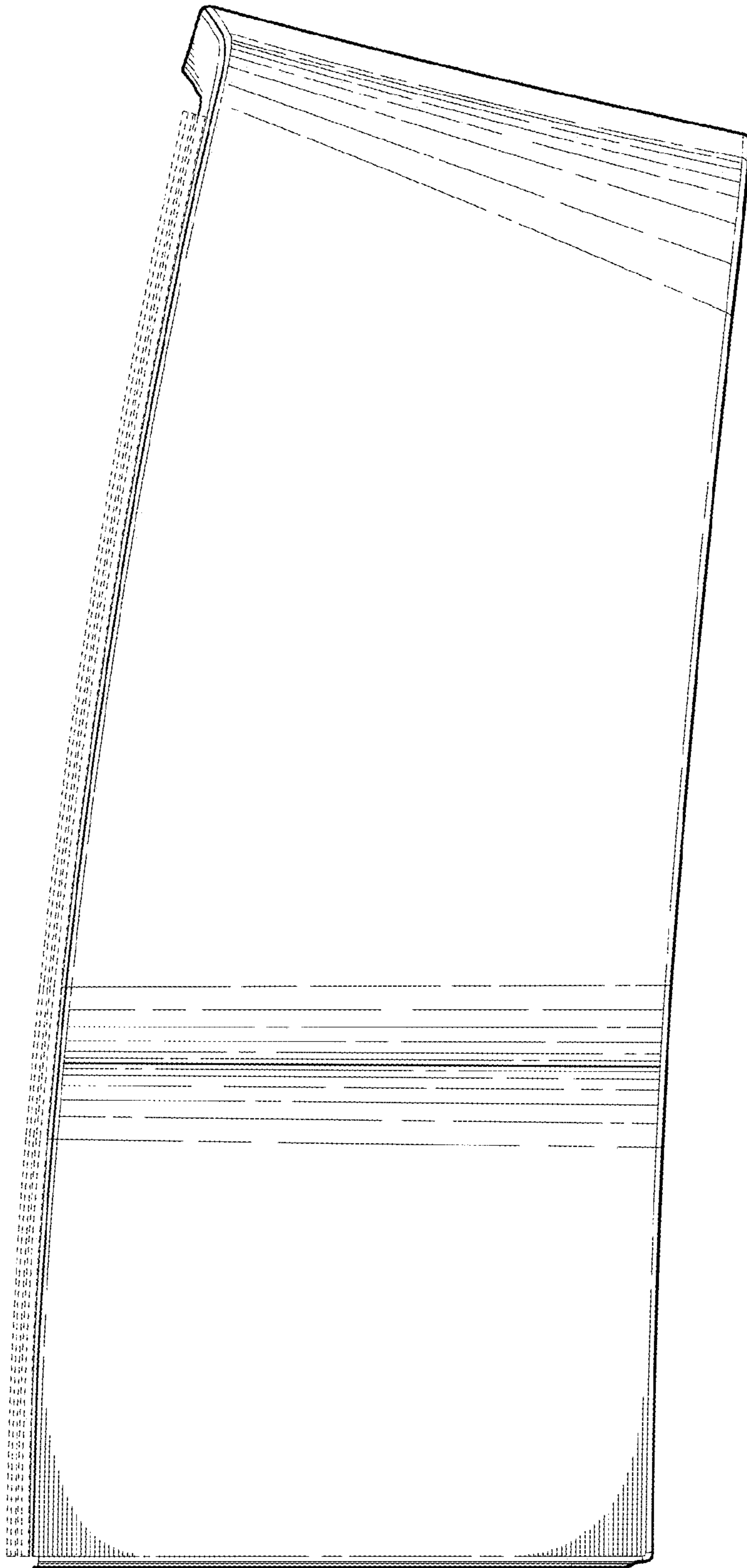

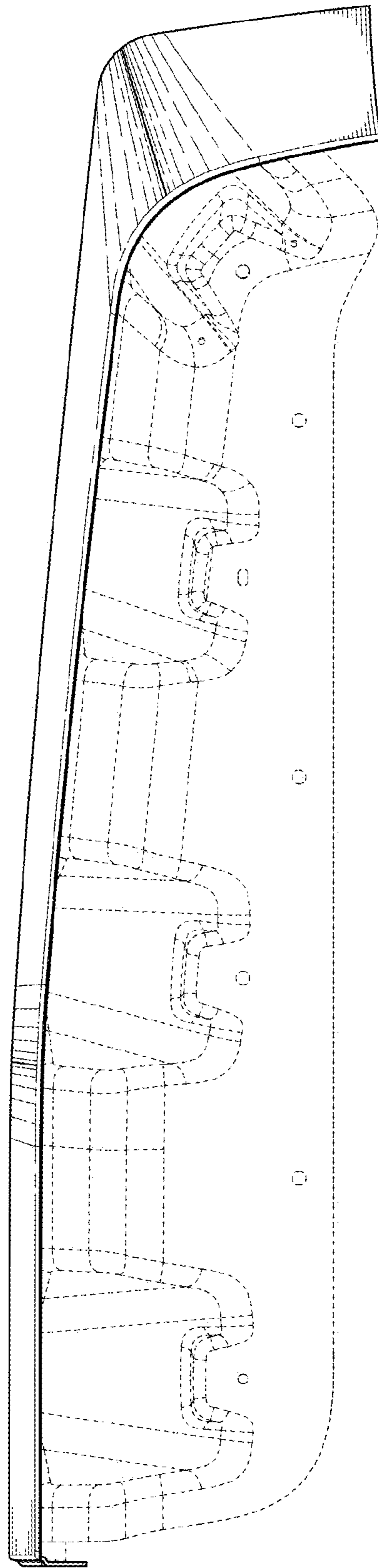

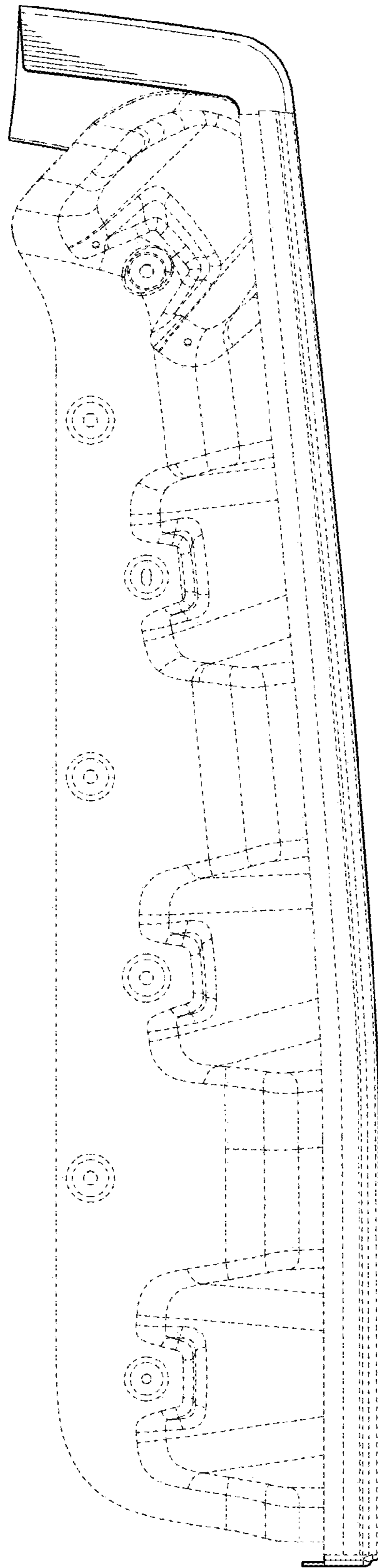

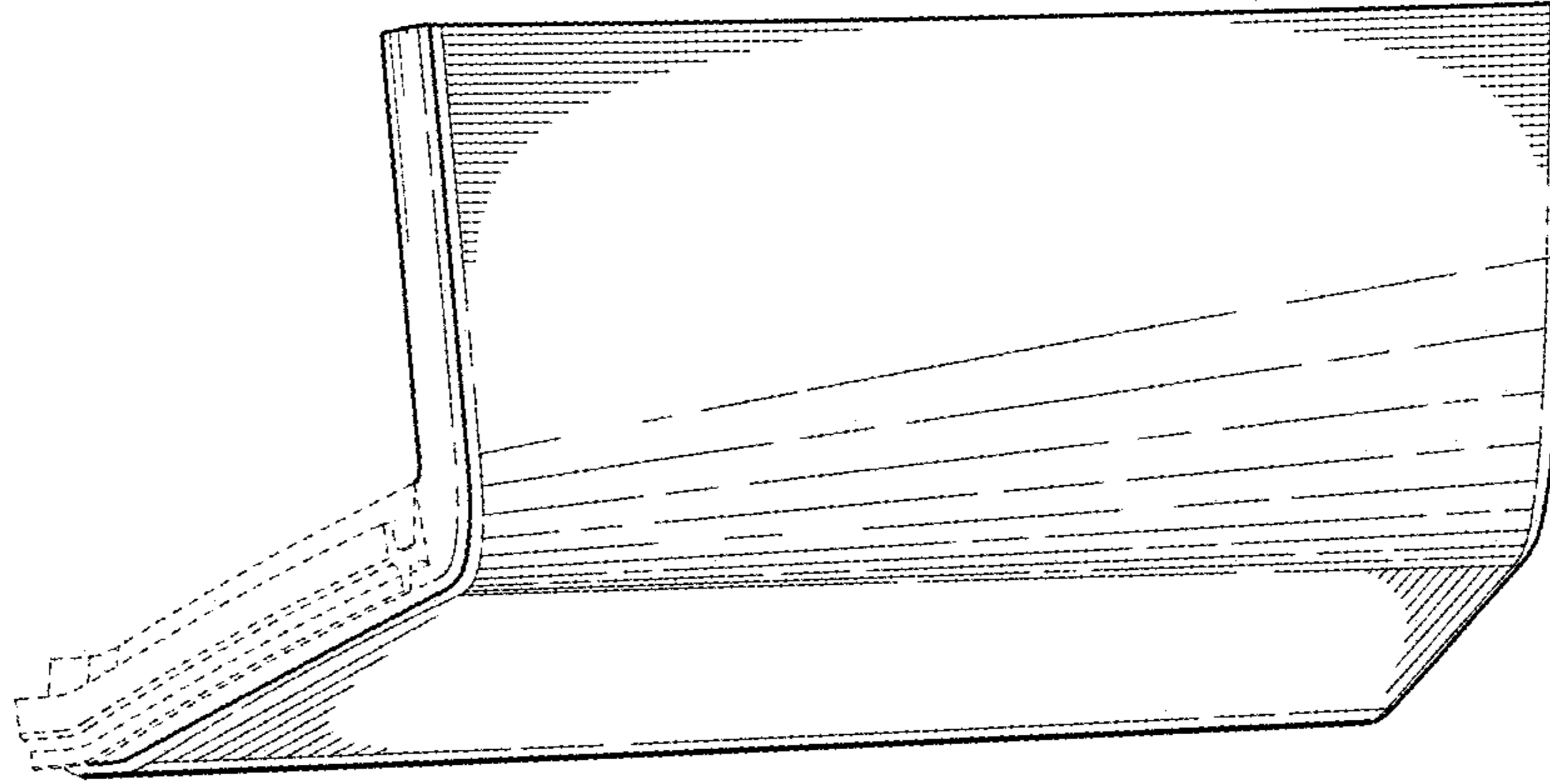

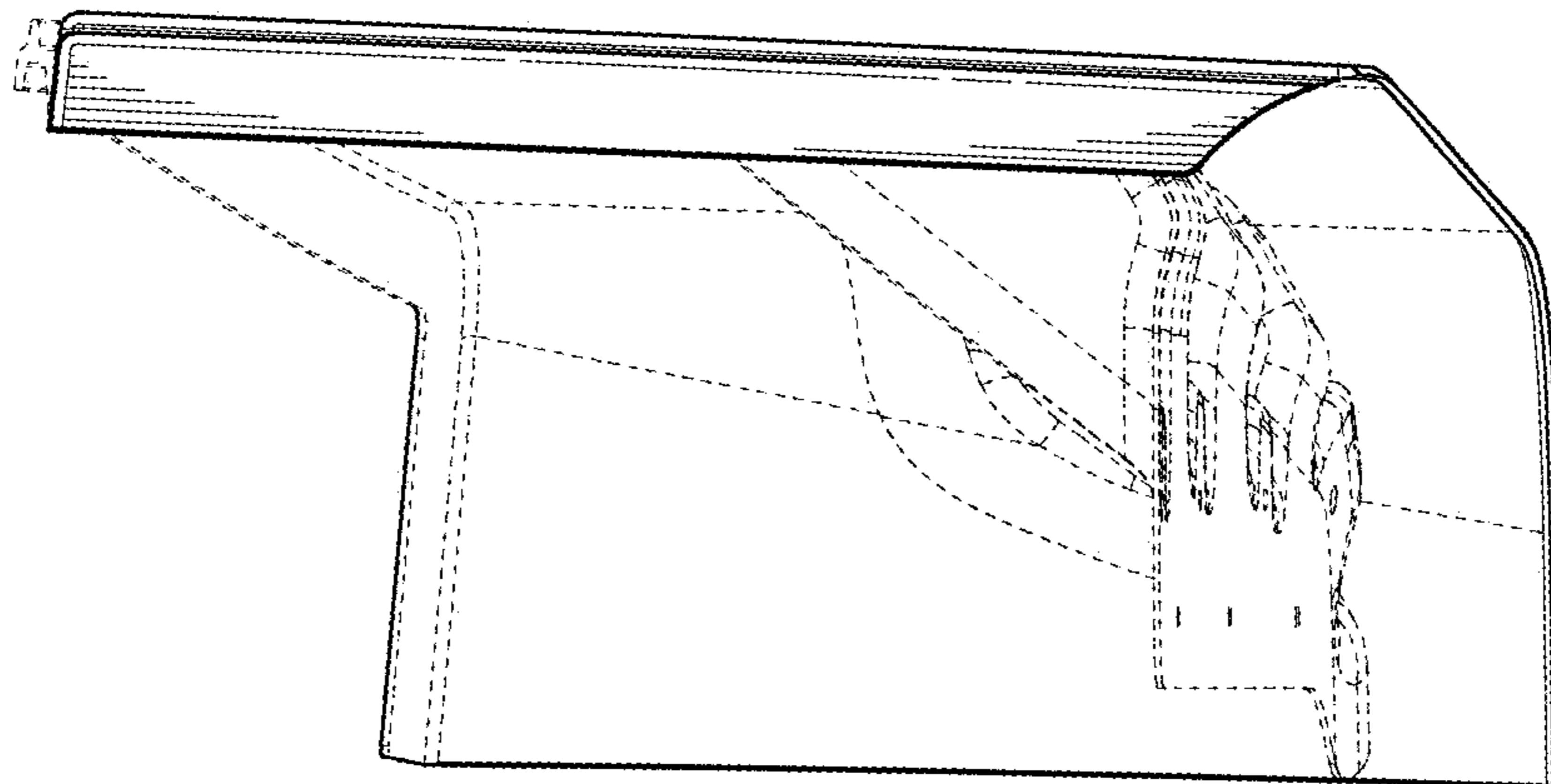
