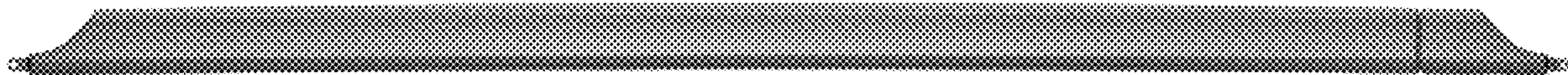
(57) **CLAIM**

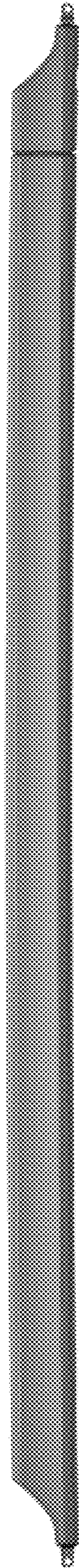
The ornamental design for a vehicle rear bumper cover molding, as shown and described.

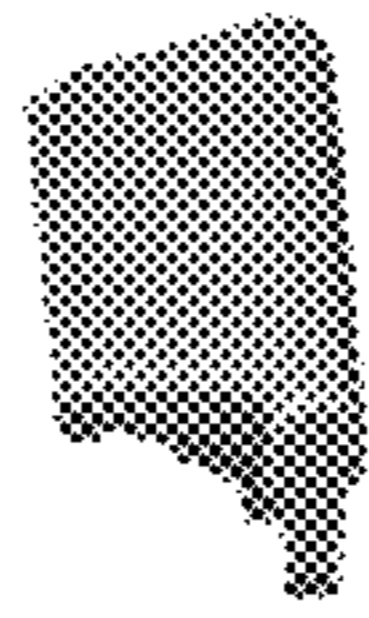

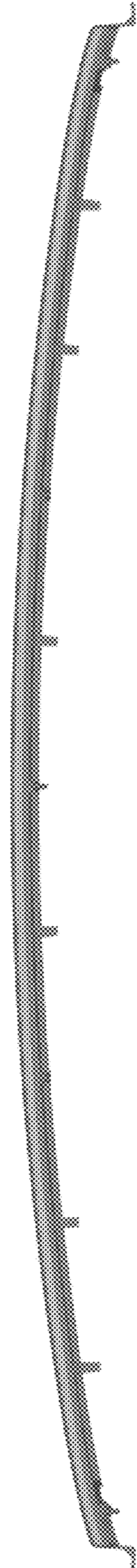

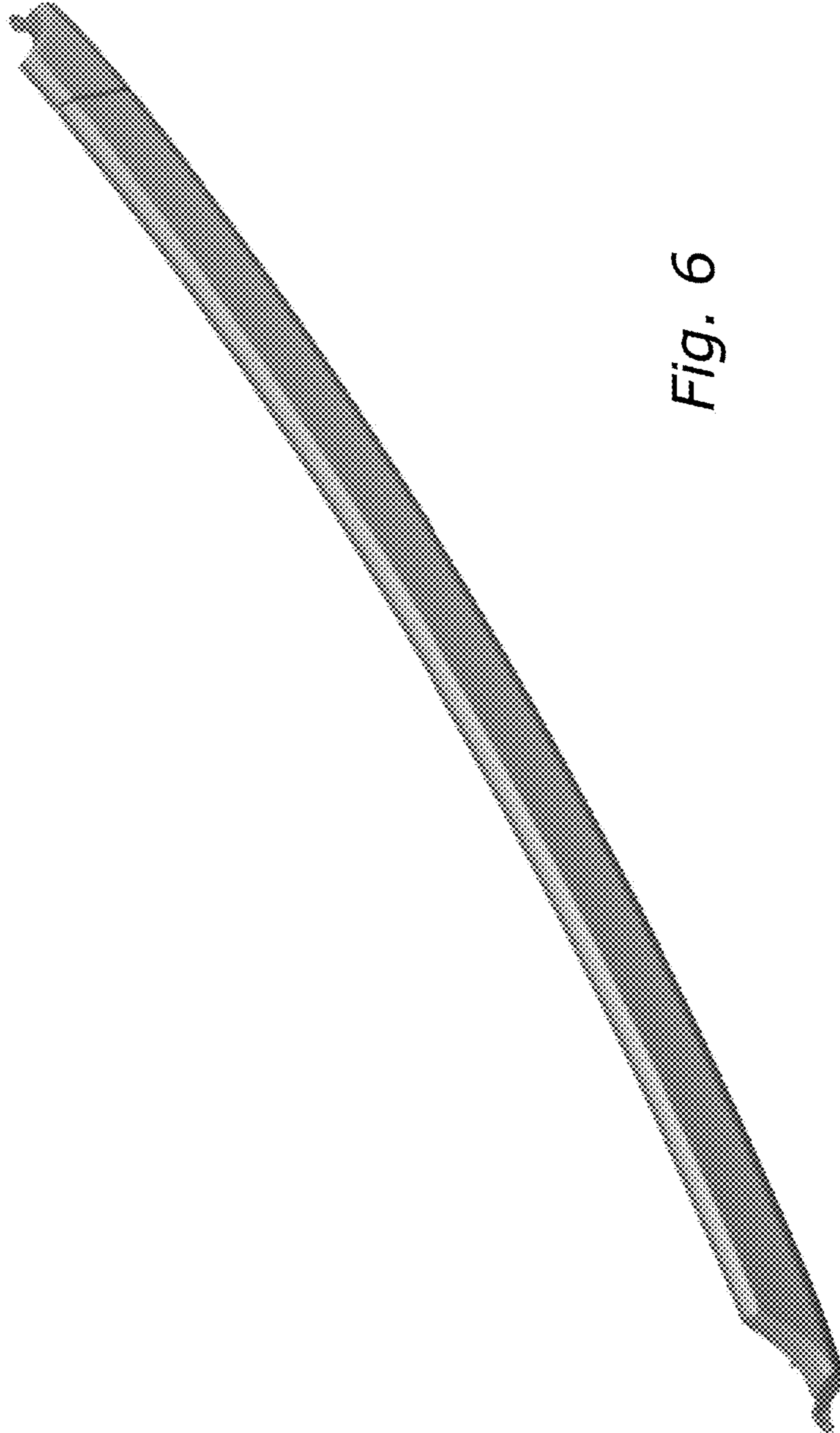

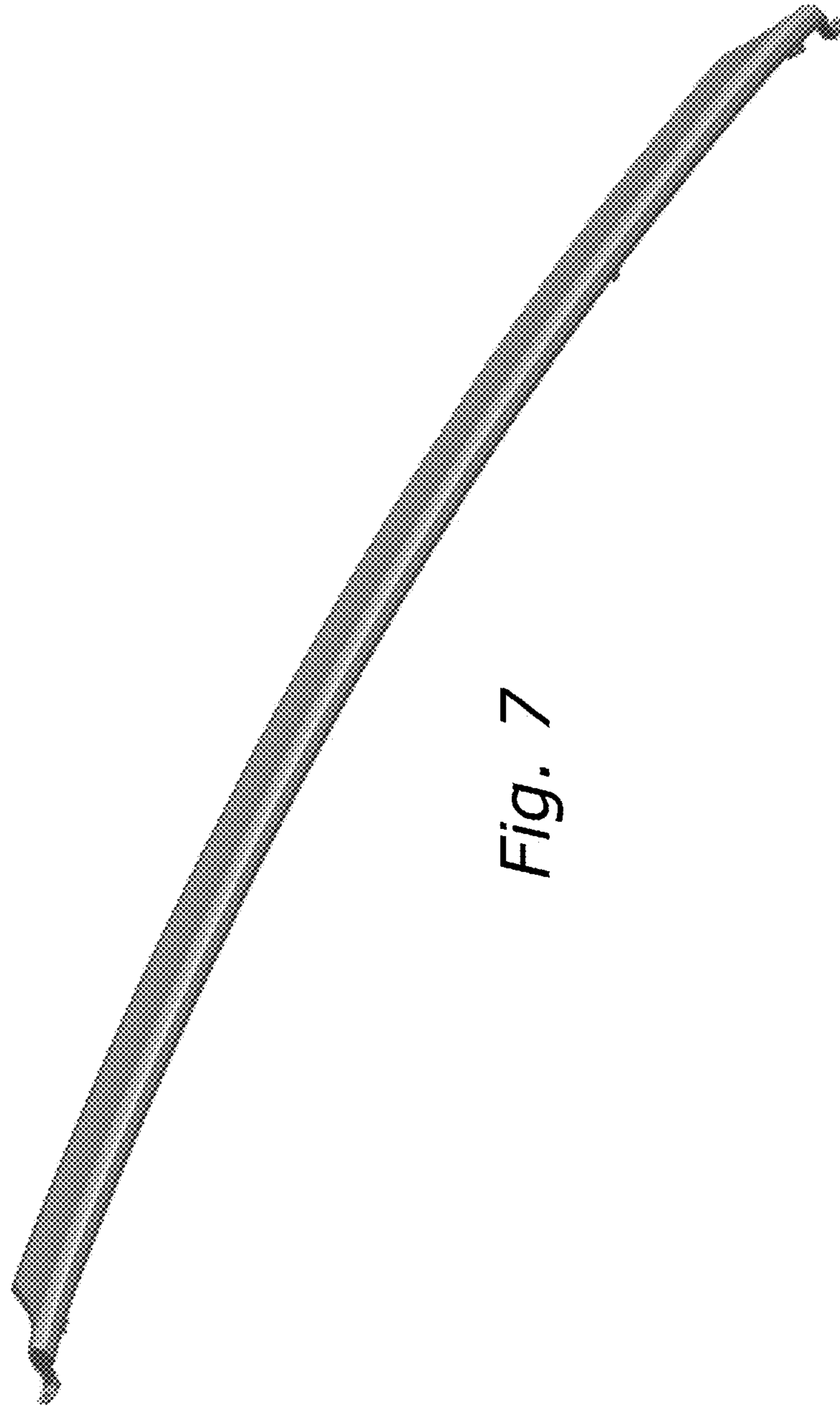
