(57) **CLAIM**

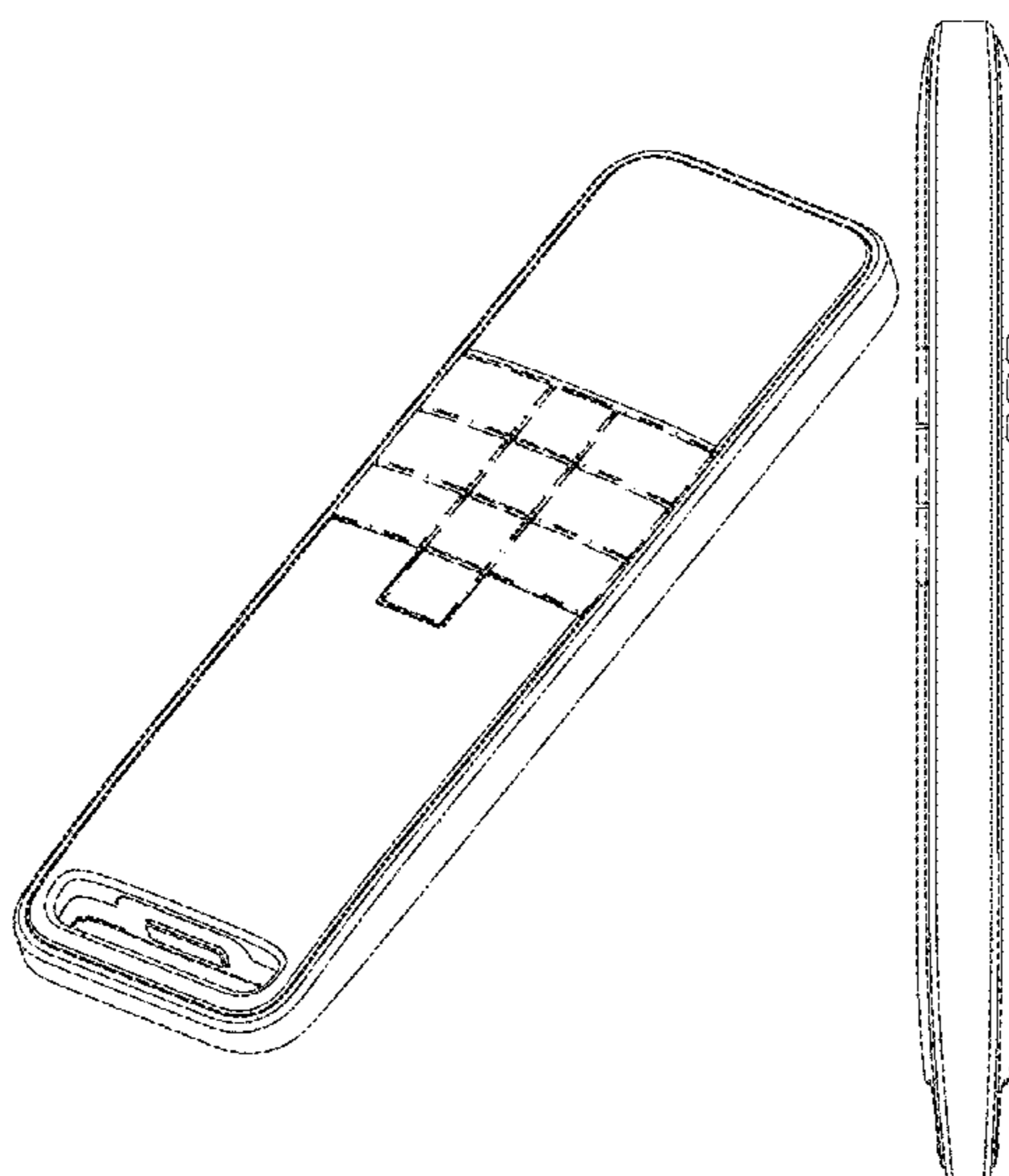
The ornamental design for a hand control, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, bottom perspective view of a first embodiment of a hand control showing my new design; FIG. 2 is a rear, right, bottom perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

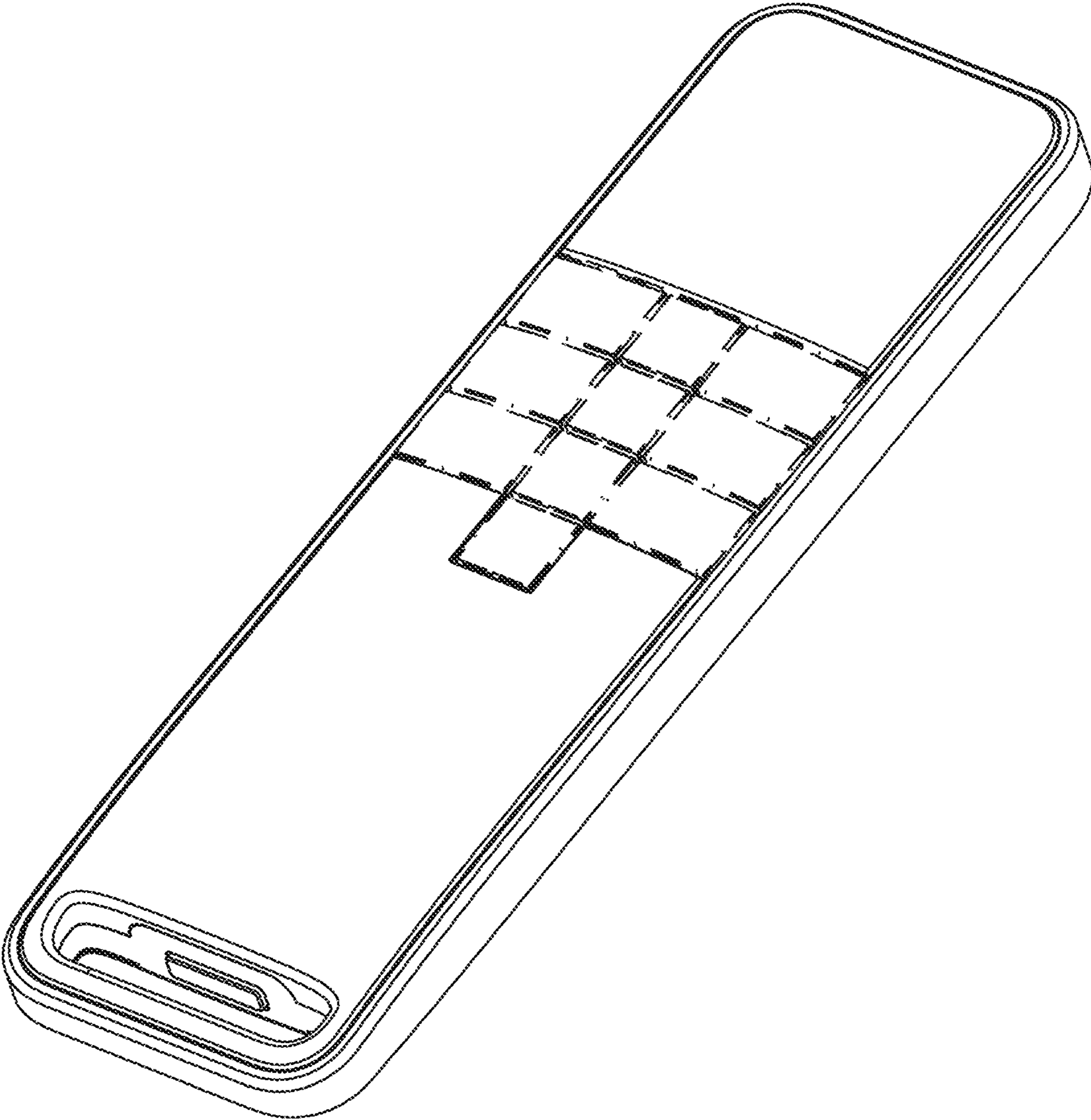

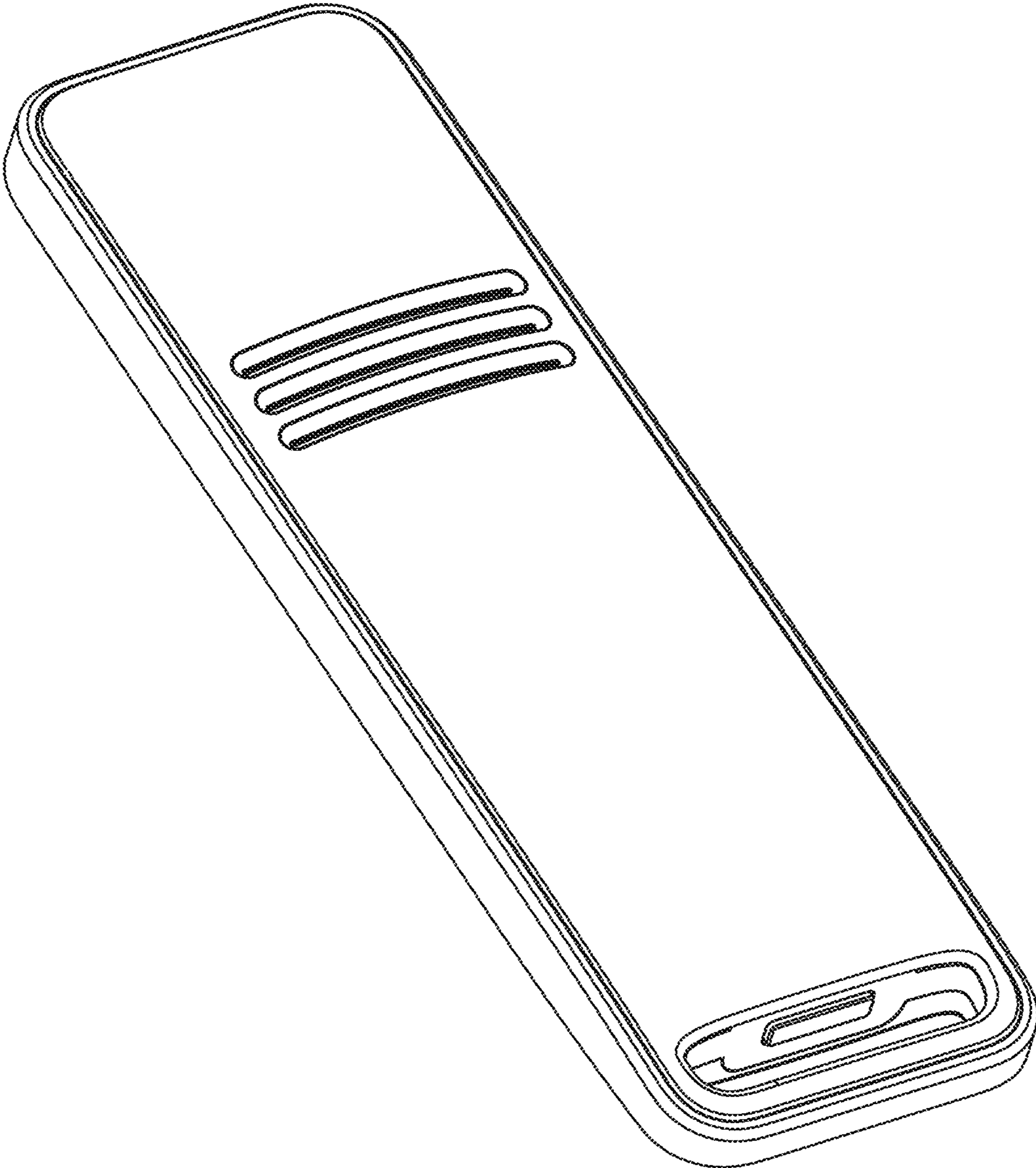

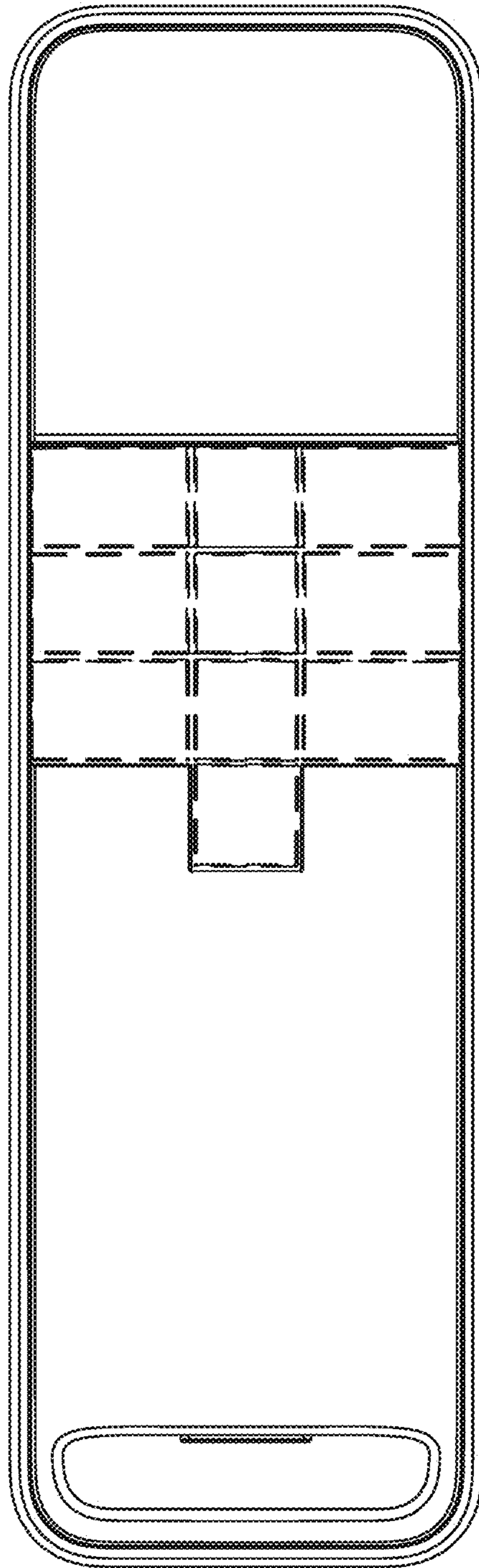

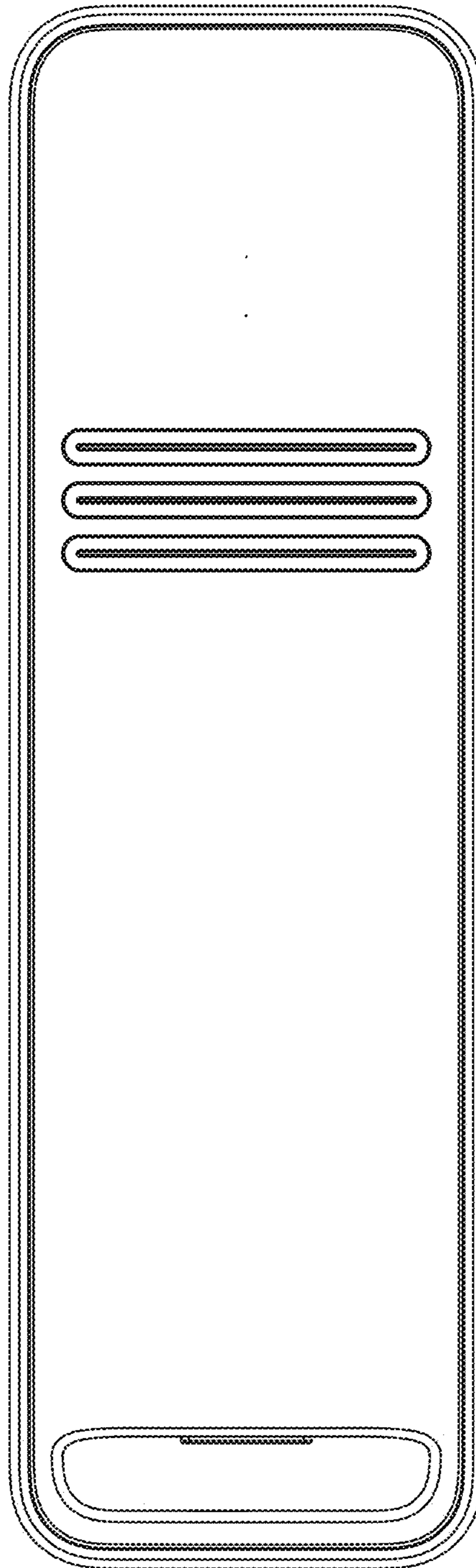

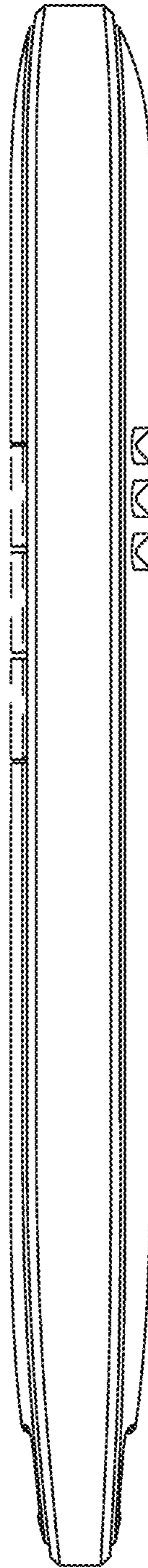

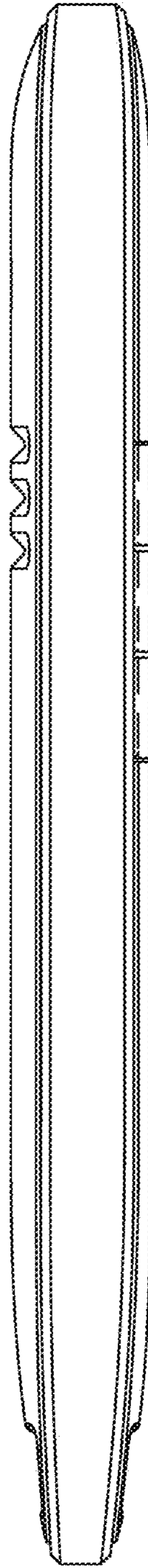

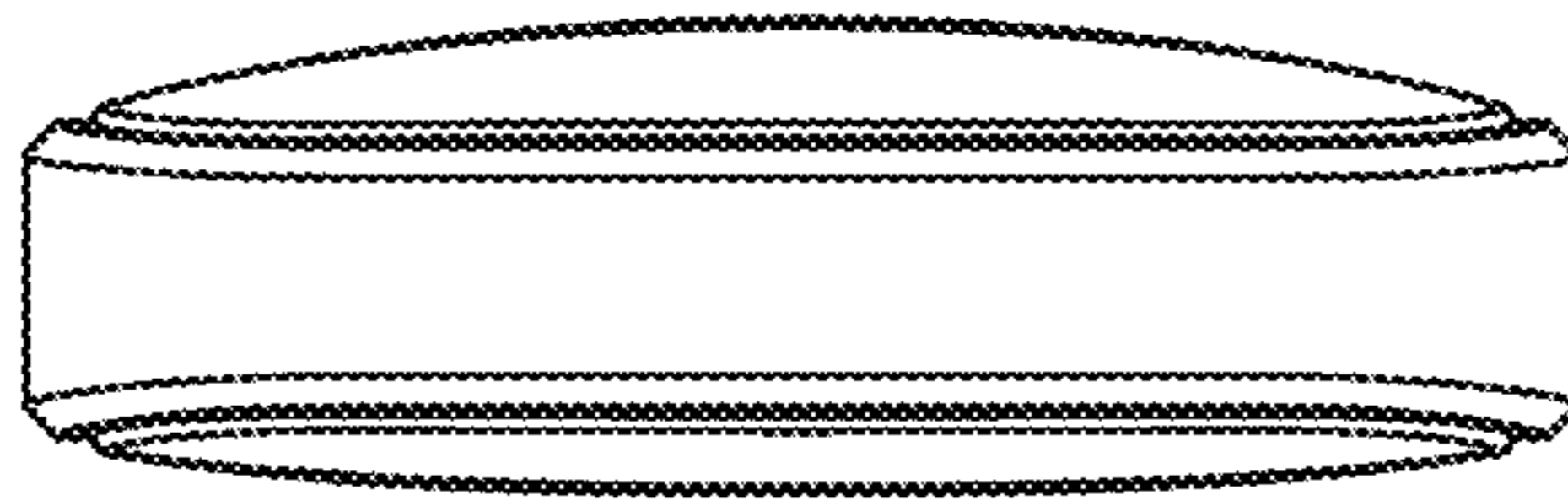

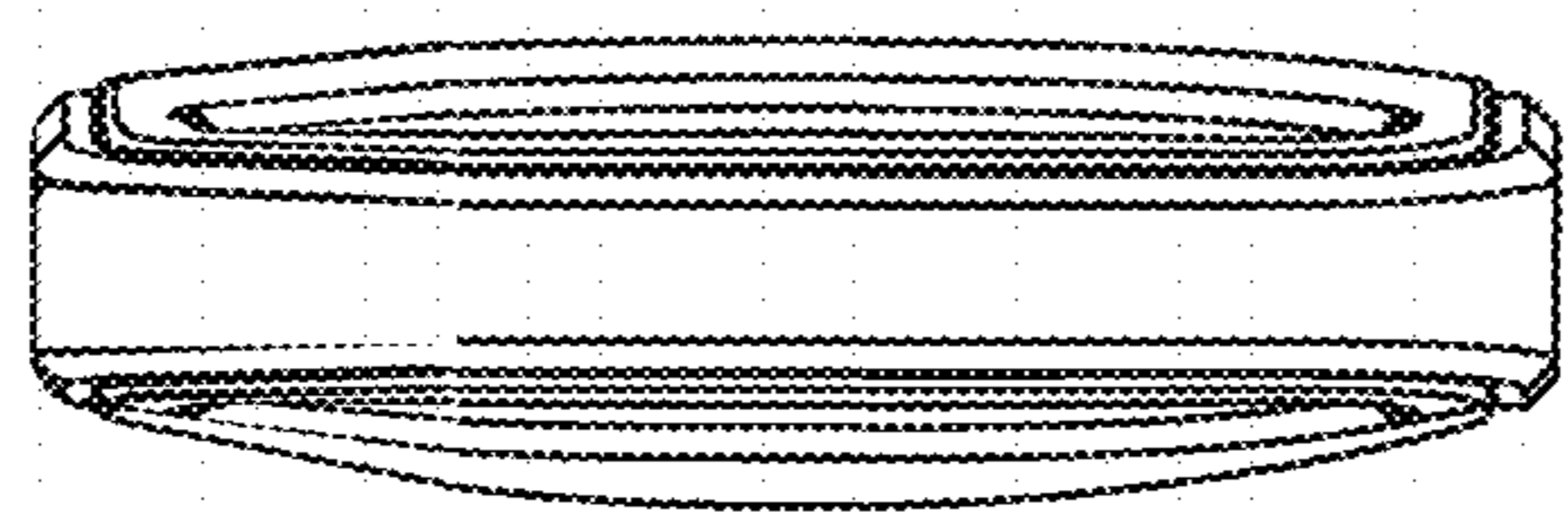
