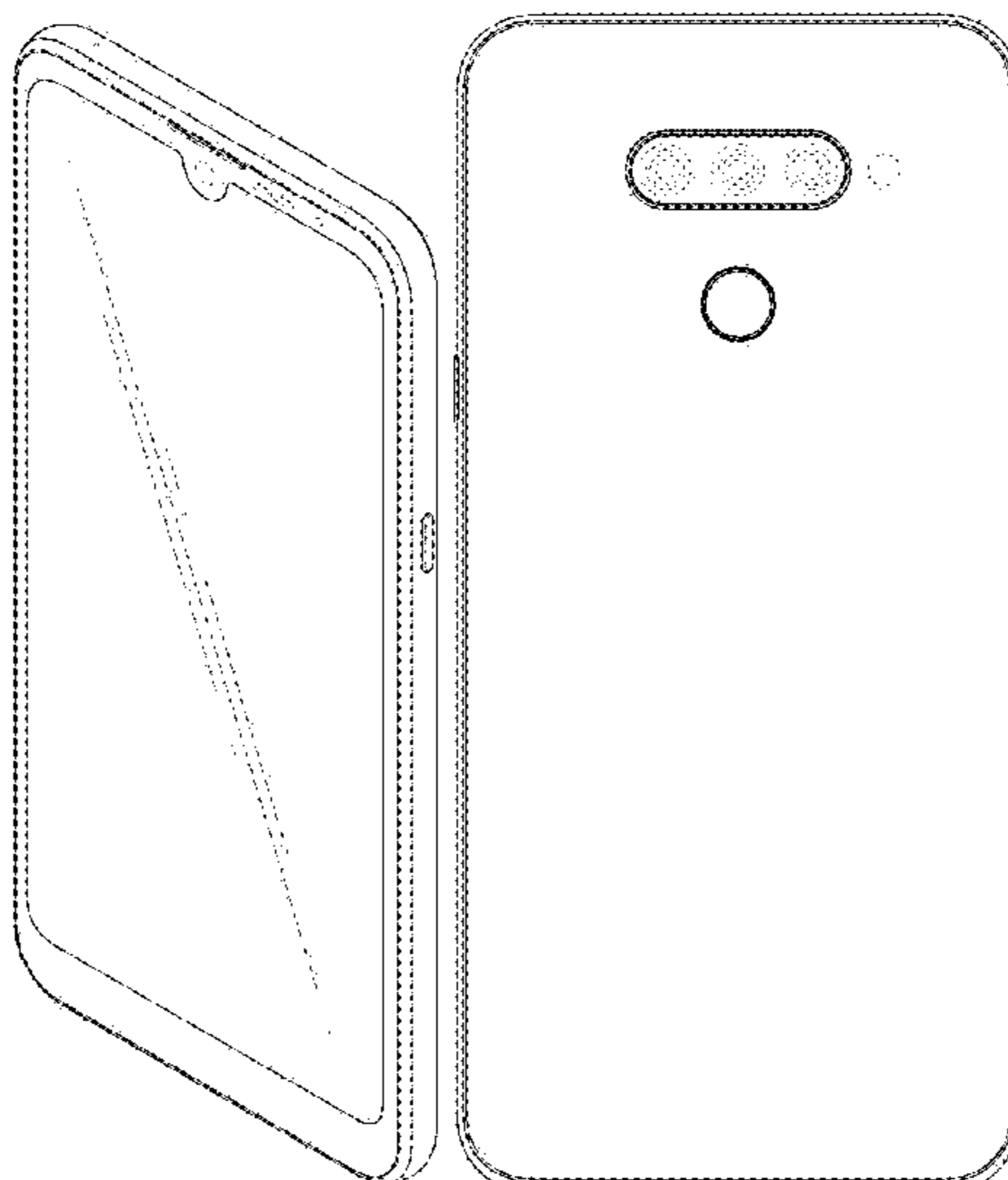

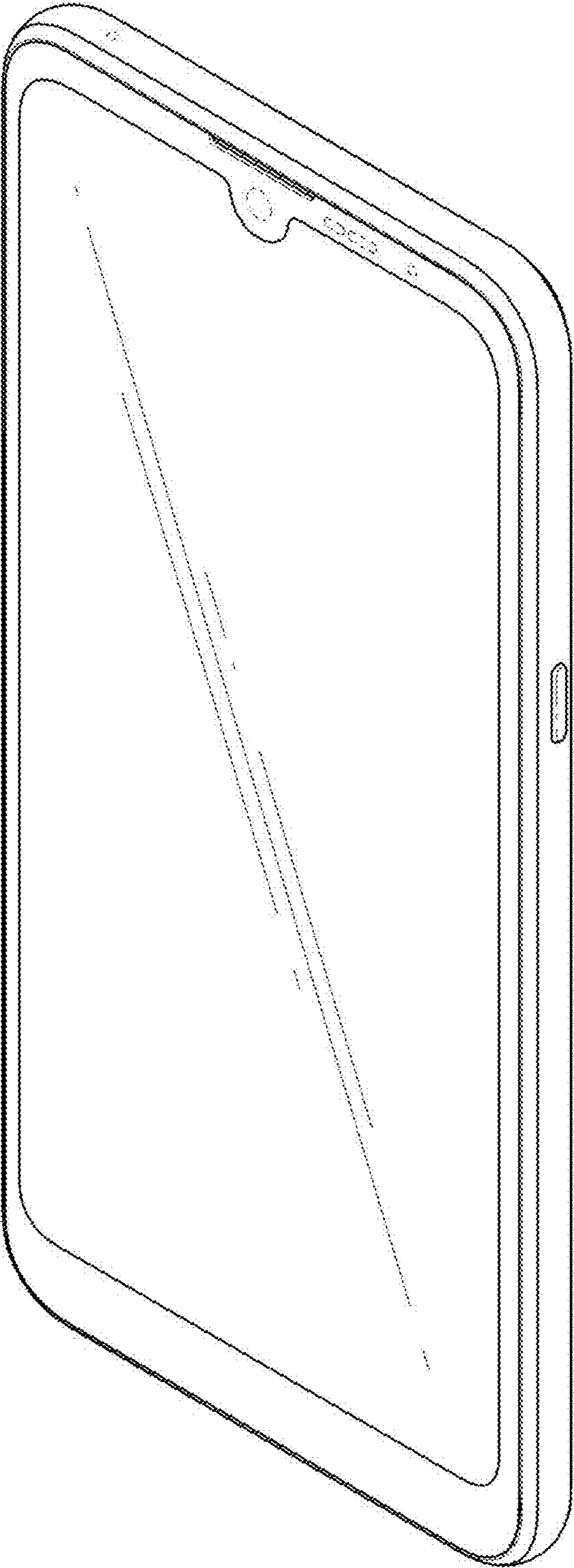

The broken lines indicate portions of the article that form no part of the claimed design.

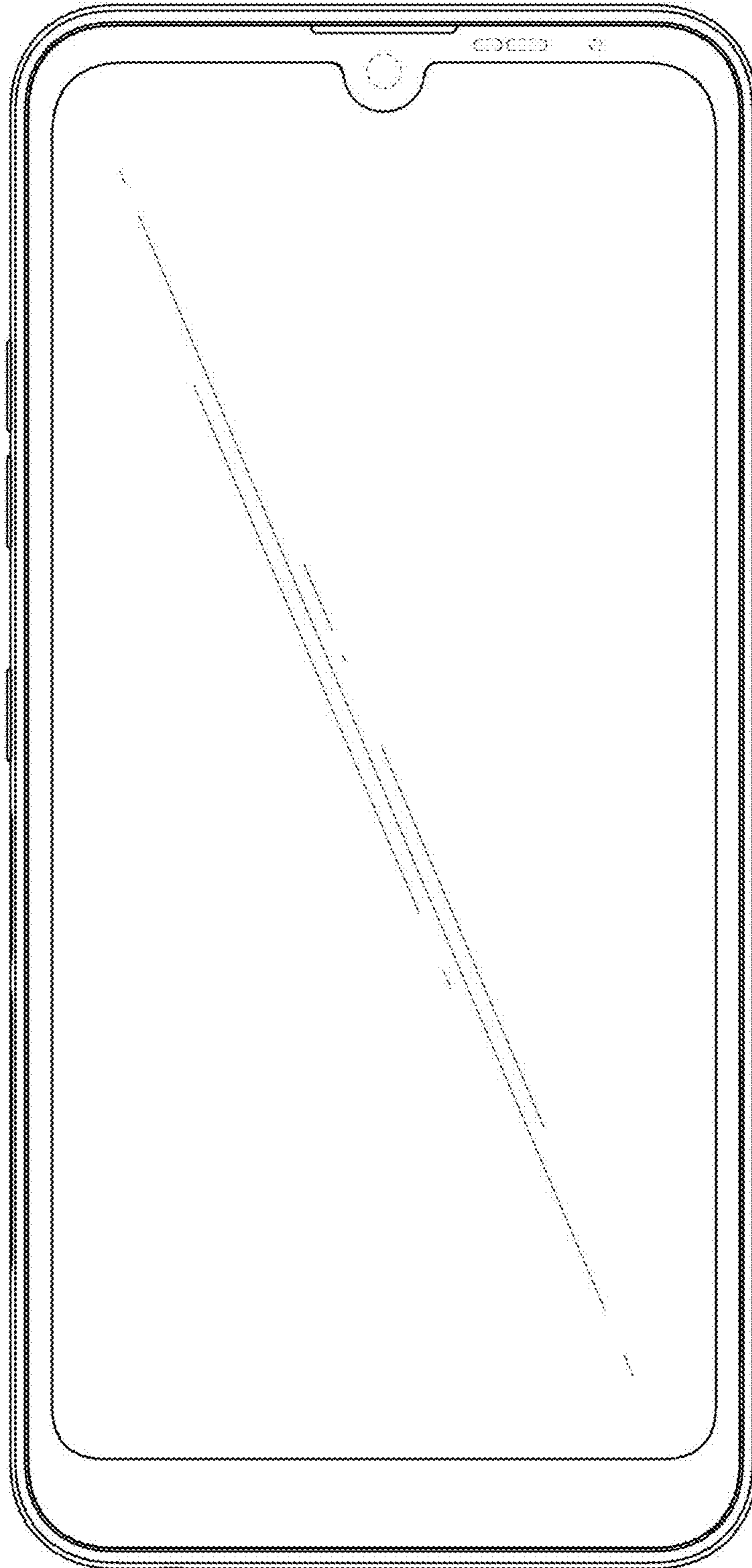

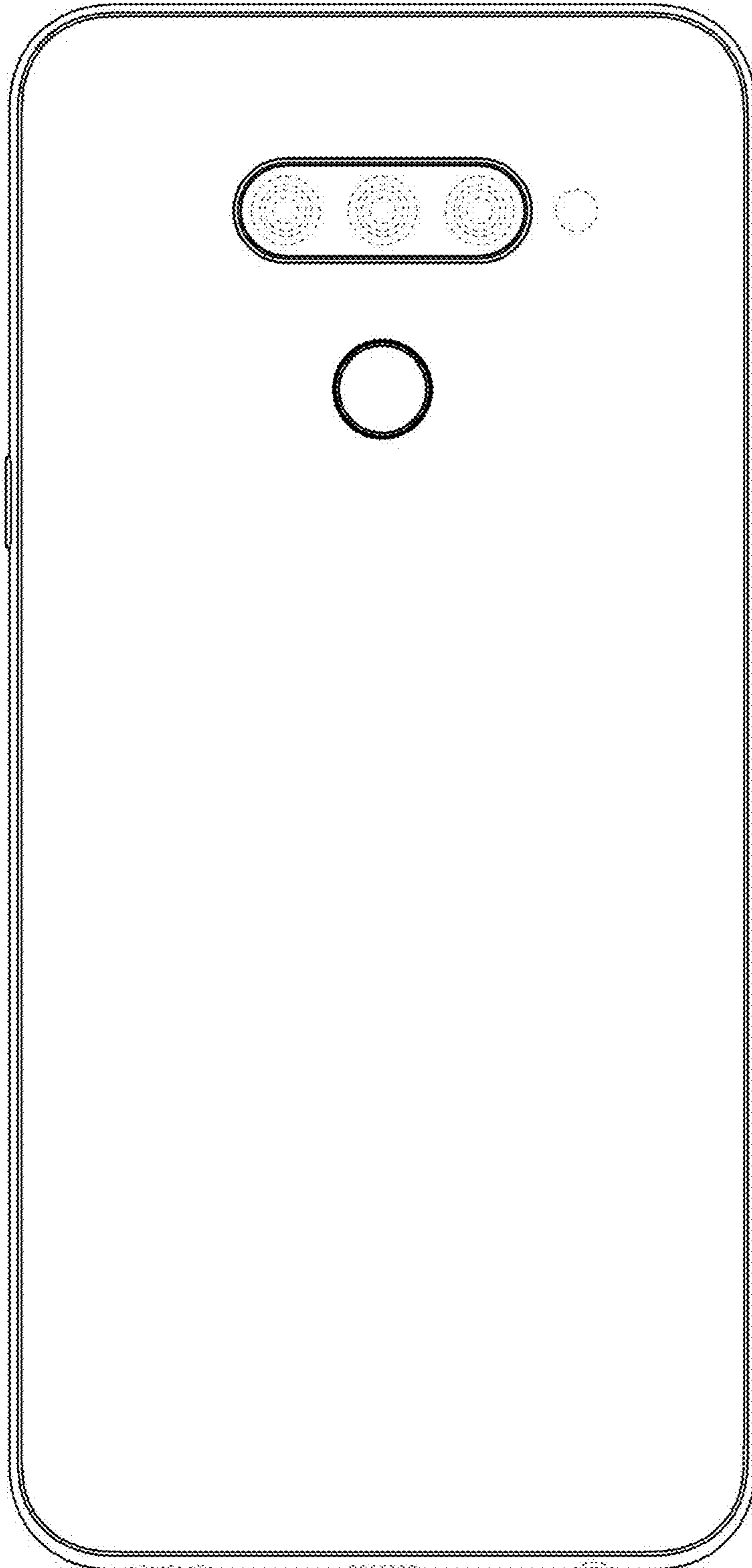

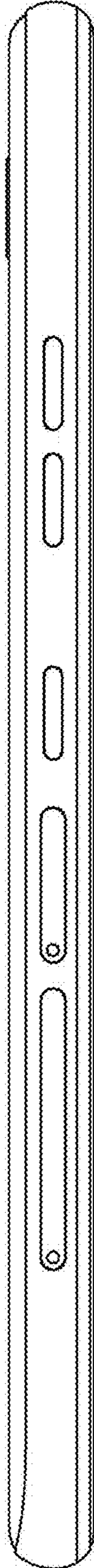

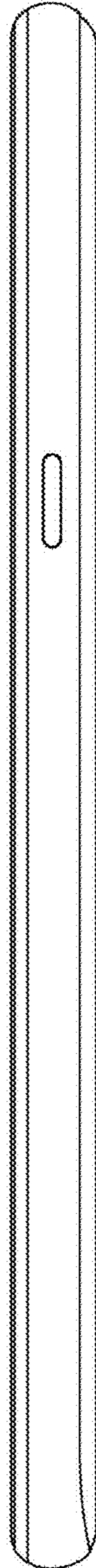

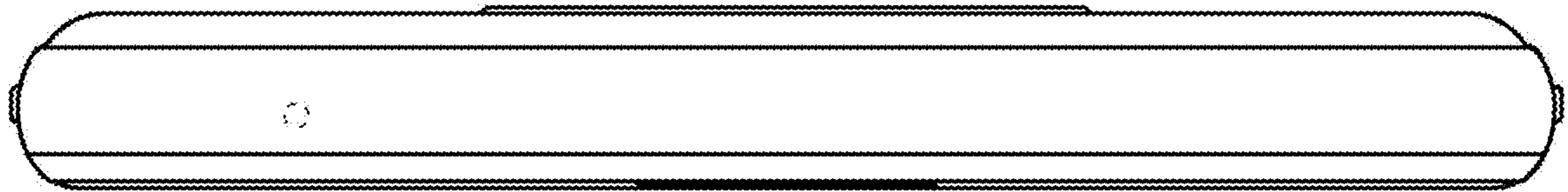
