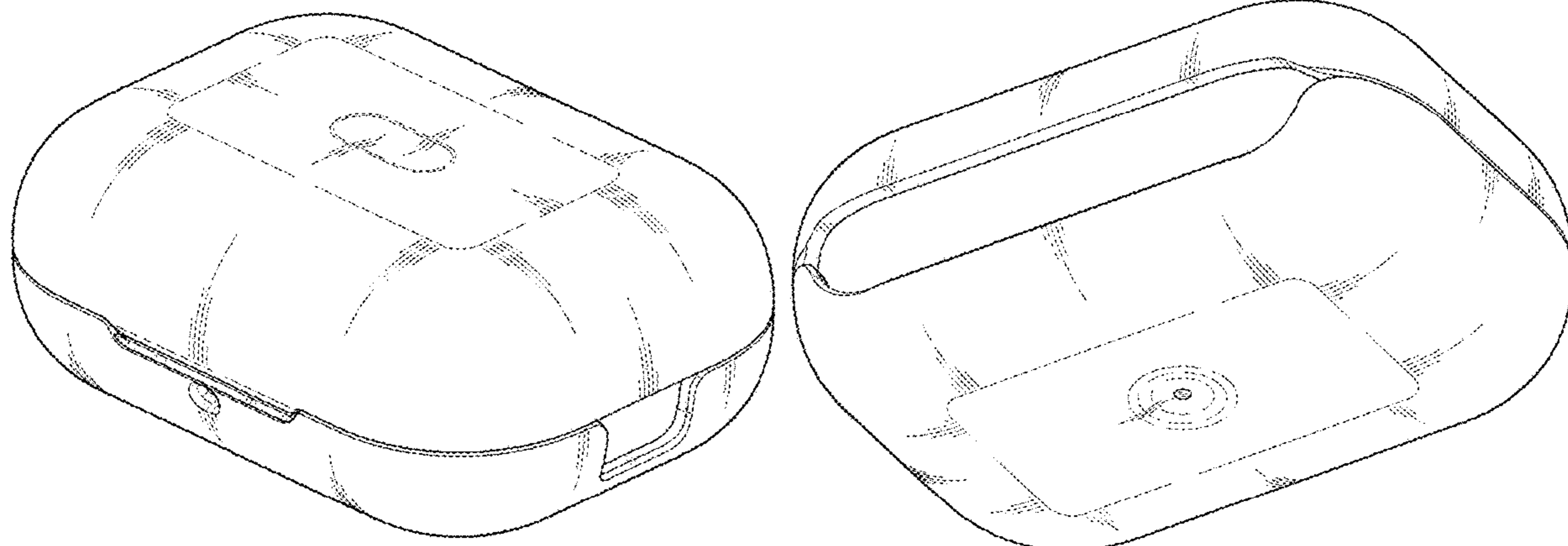
(57) **CLAIM**

The ornamental design for a protective cover skin for electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and right perspective view of a protective cover skin for electronic device, showing the claimed design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a rear, bottom, and left perspective view thereof. The broken lines shown in FIGS. 3 and 5 depict interior parts of the protective cover skin for electronic device, but form no part of the claimed design. The interior parts of the protective cover skin for electronic device, seen through openings in FIGS. 1, 3, 5, 7, and 8, form no part of the claimed design.

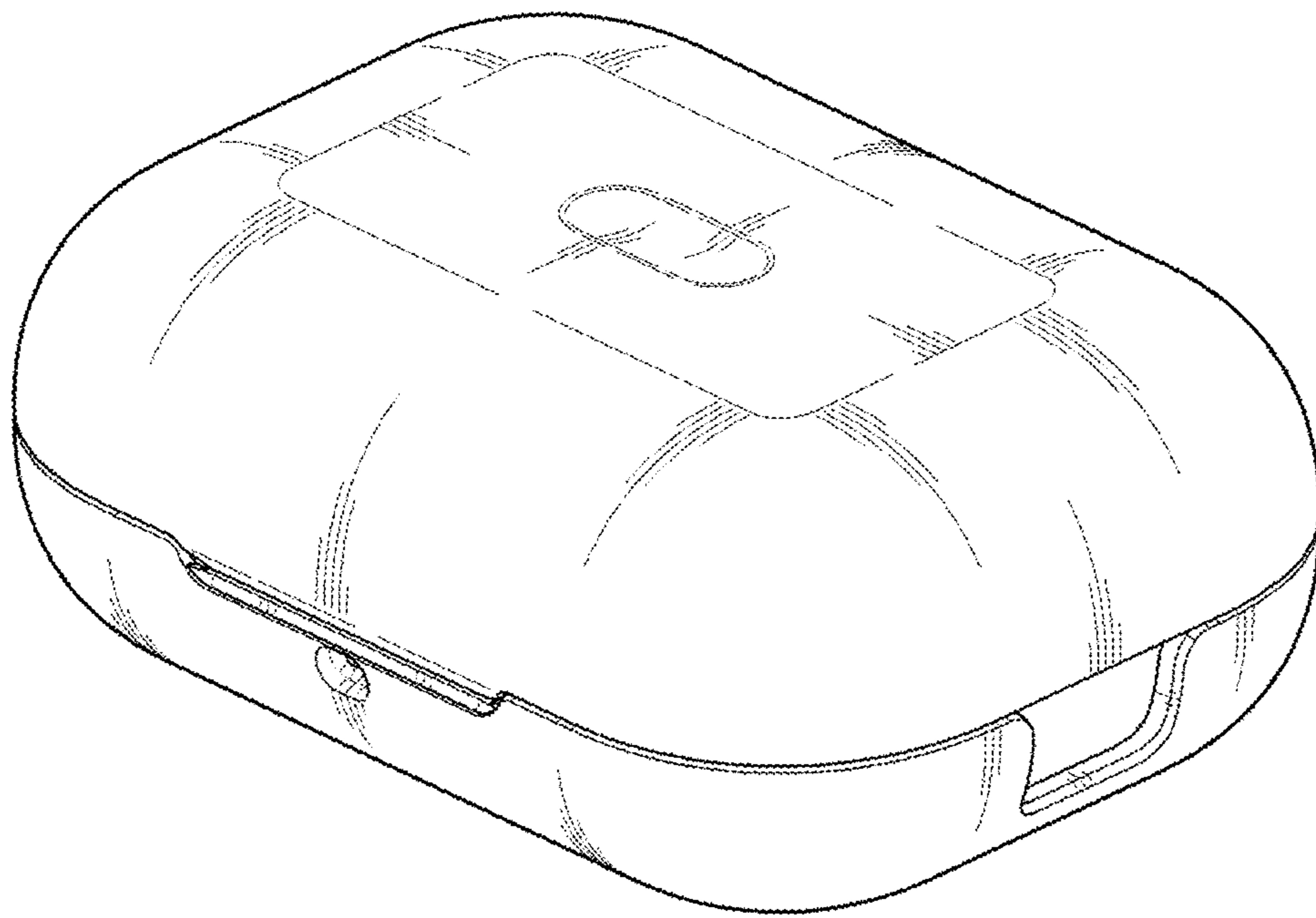

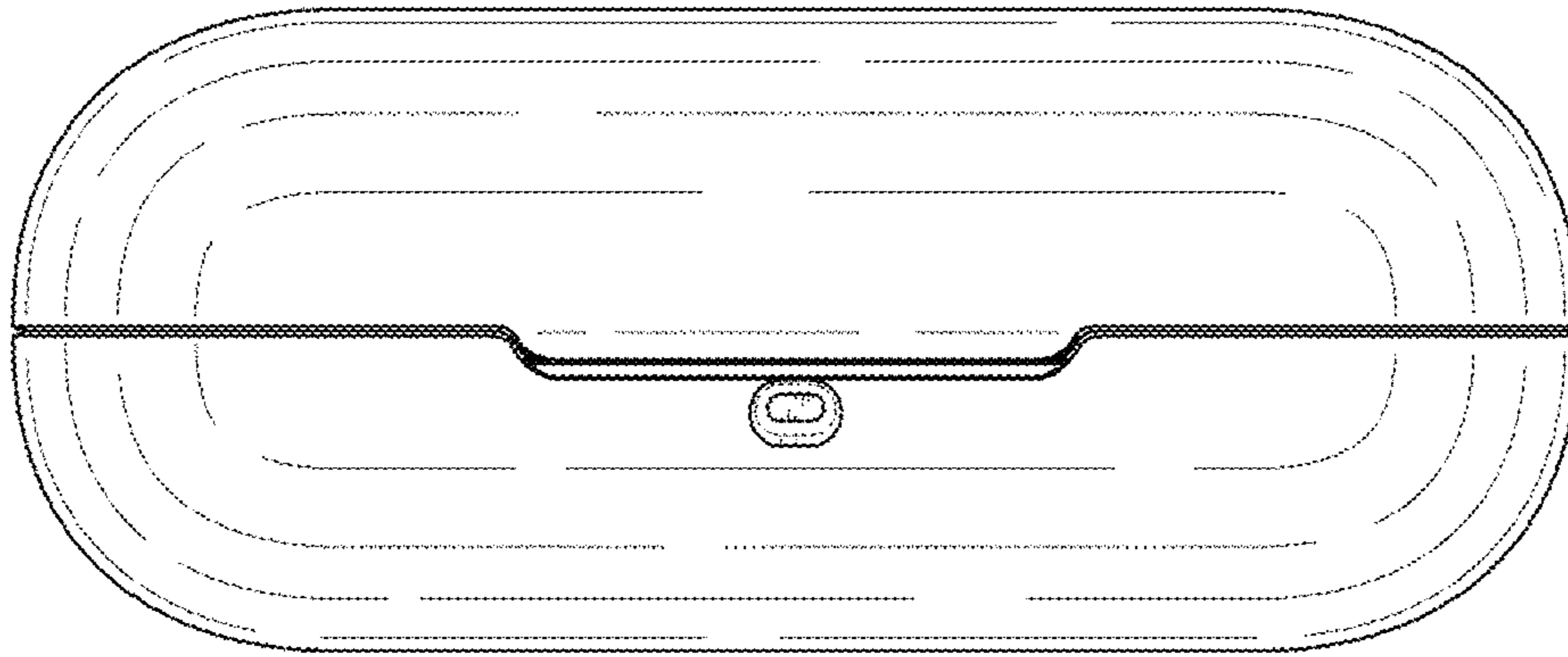

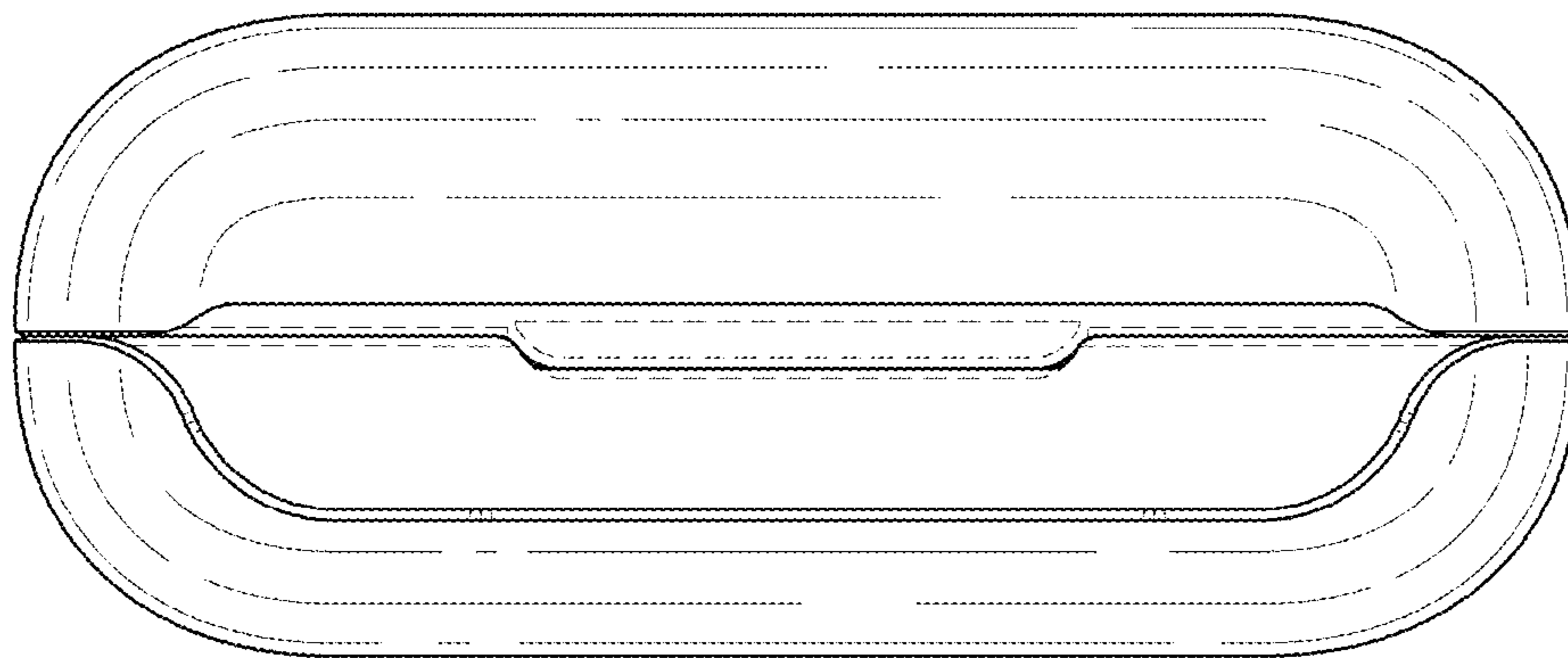

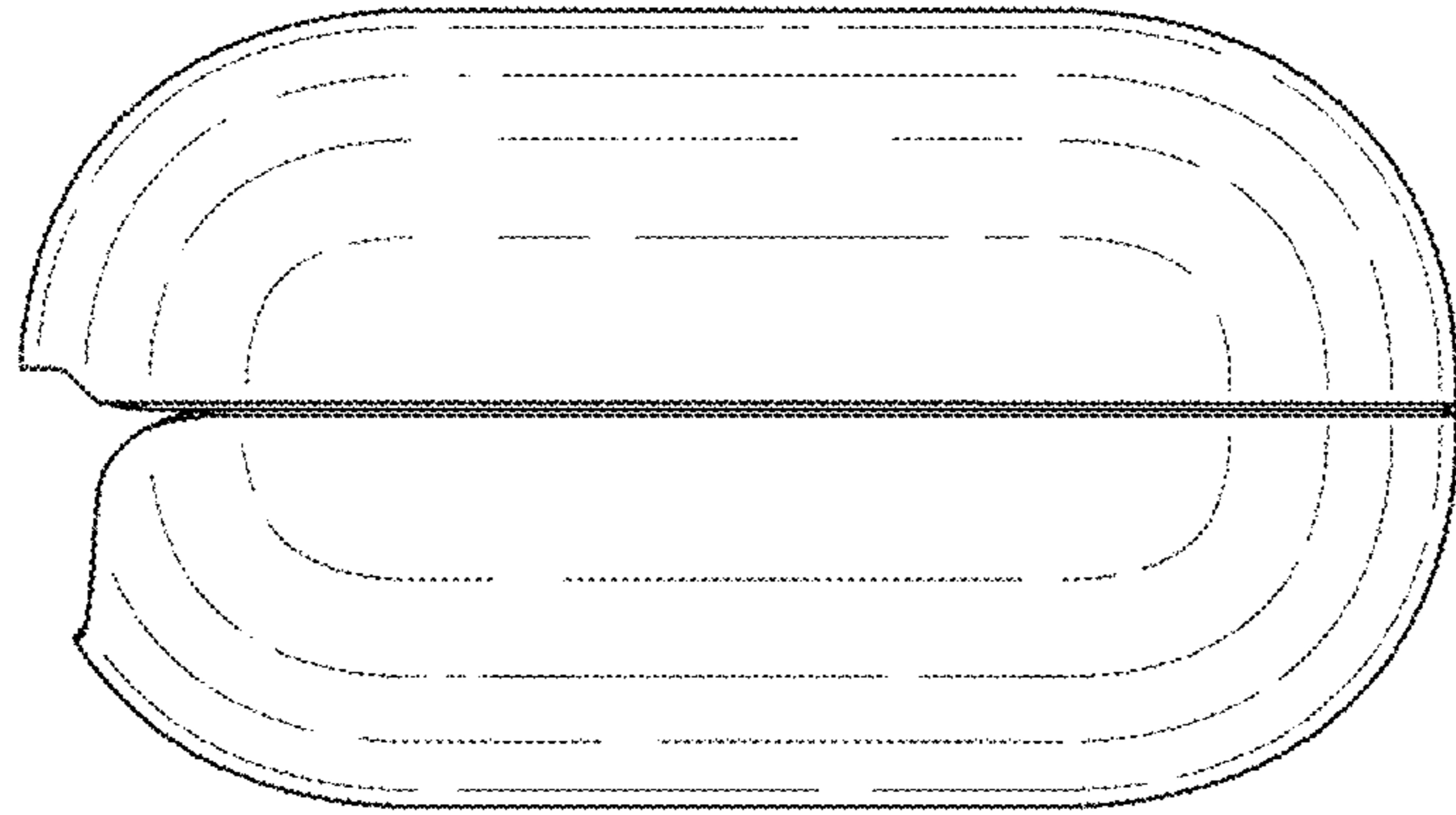

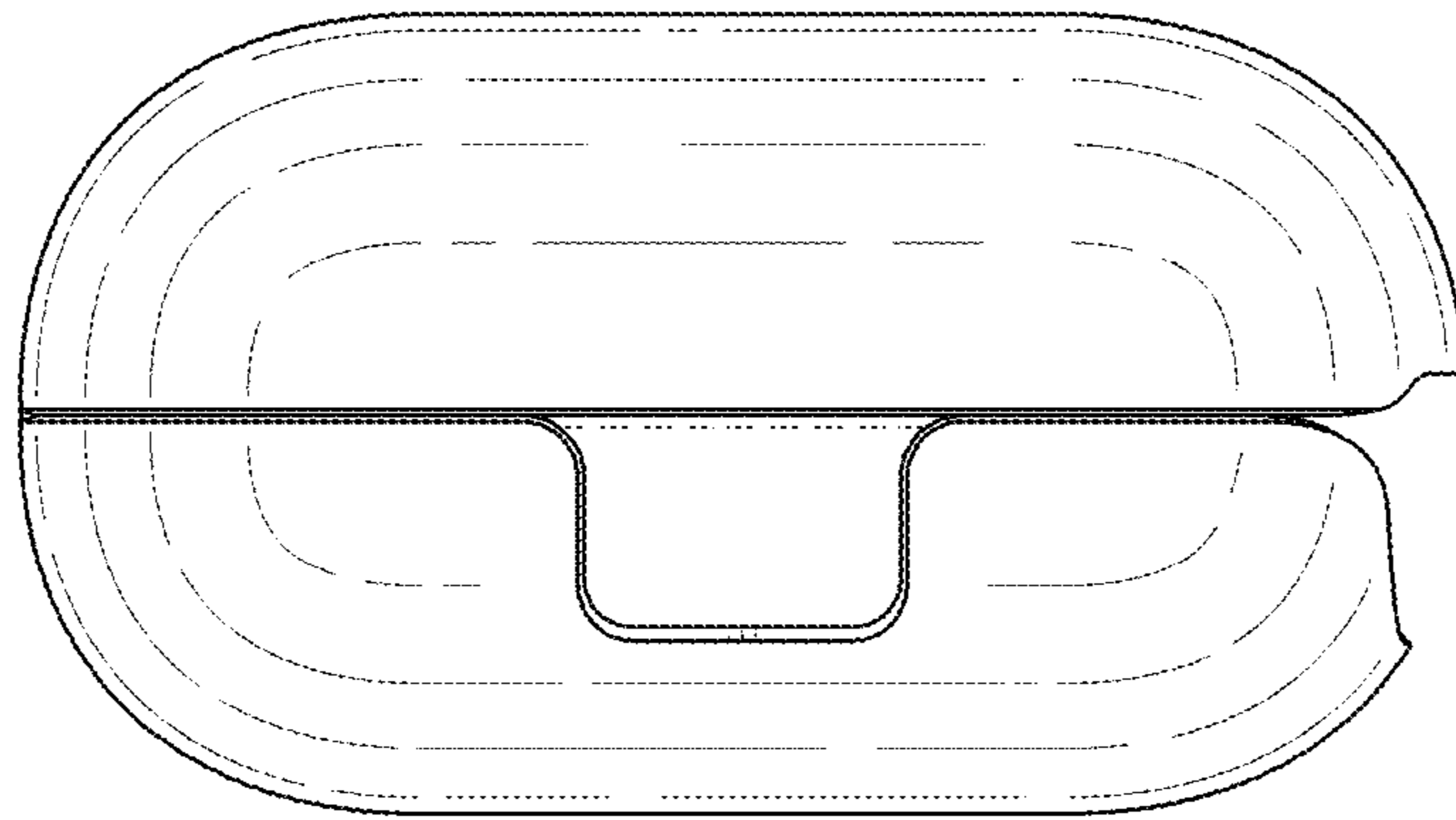

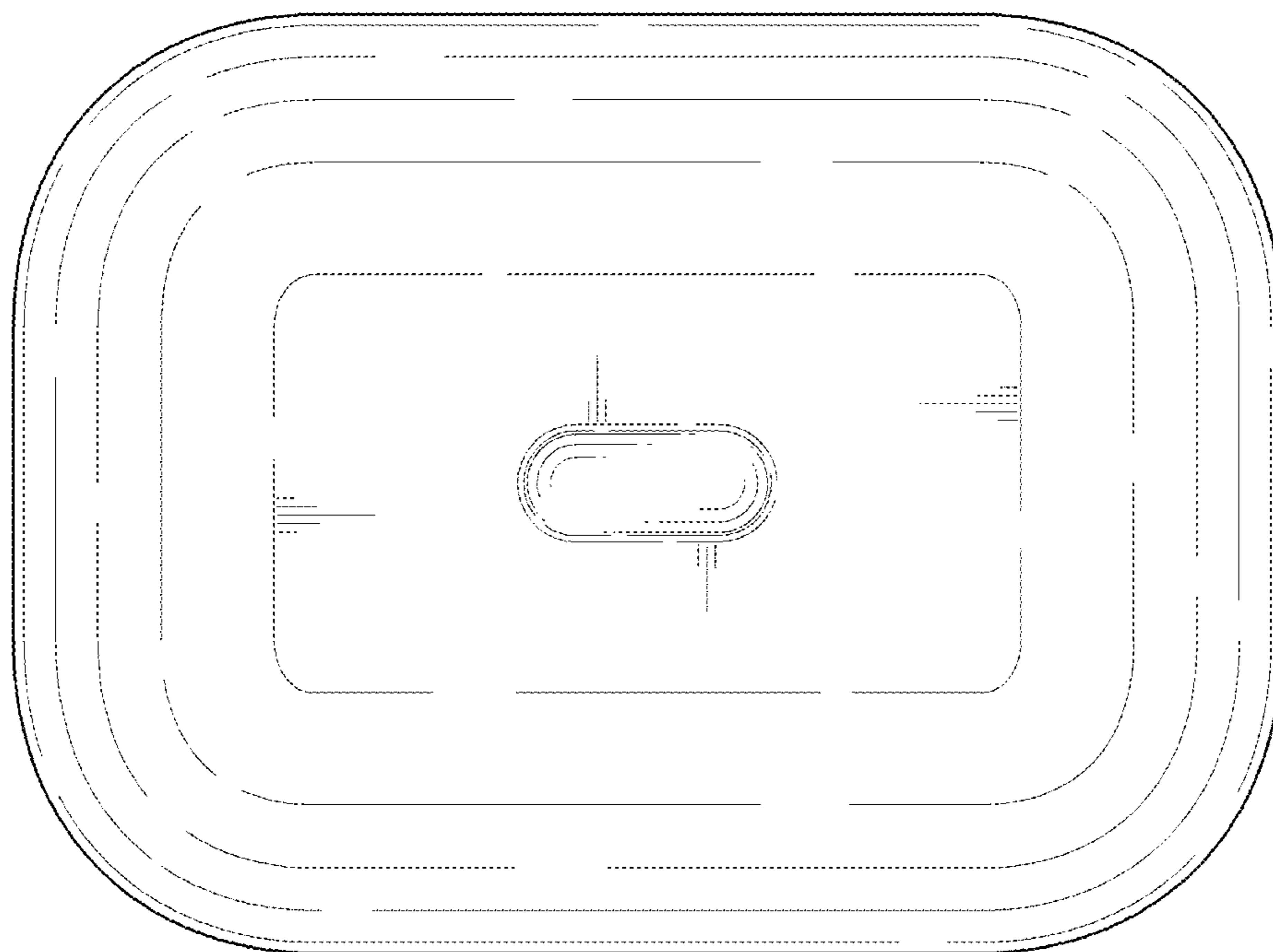

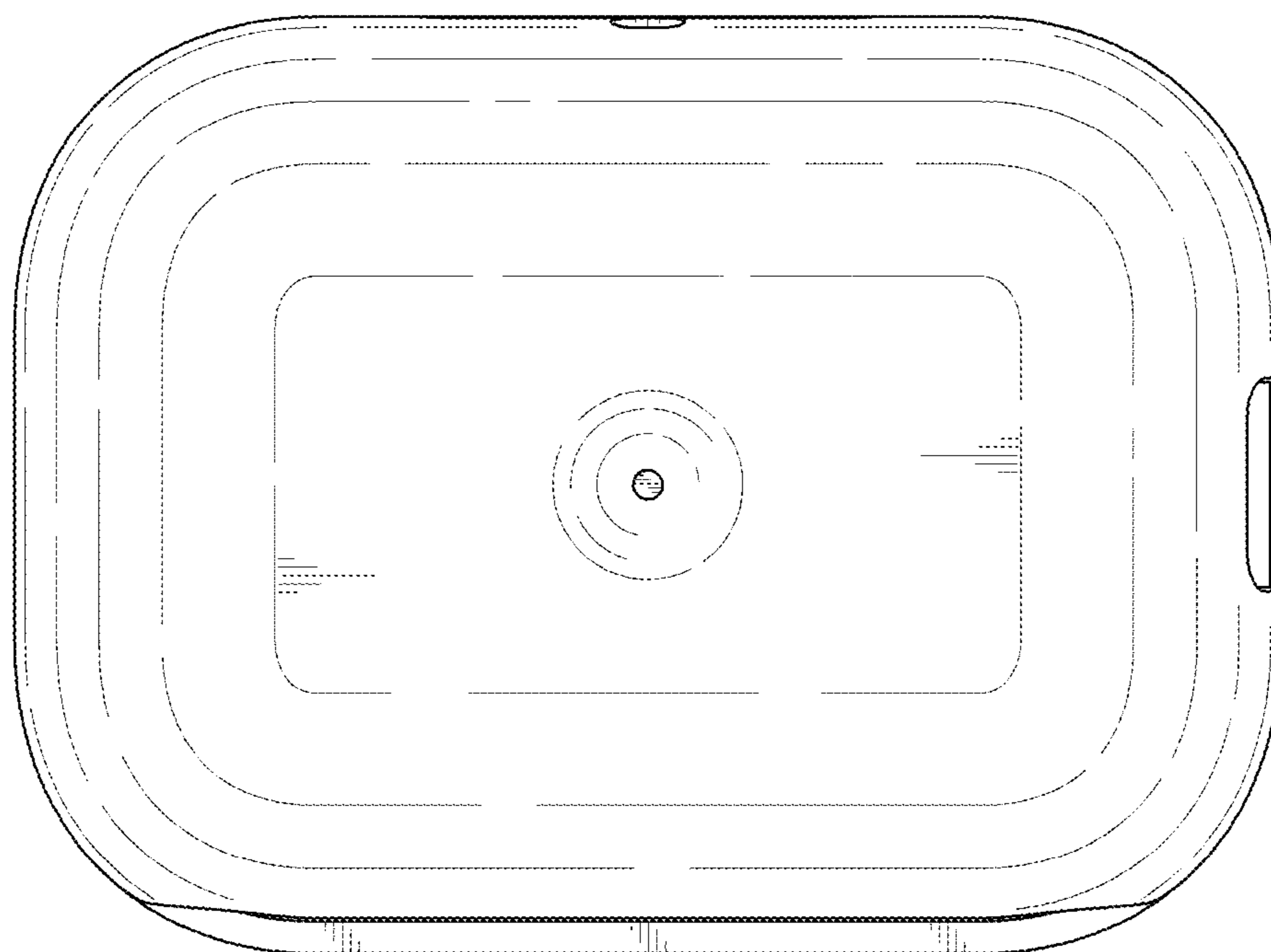
