DESCRIPTION

FIG. 4 is a Right-side view of the whack a frog game as shown in FIG. 1;

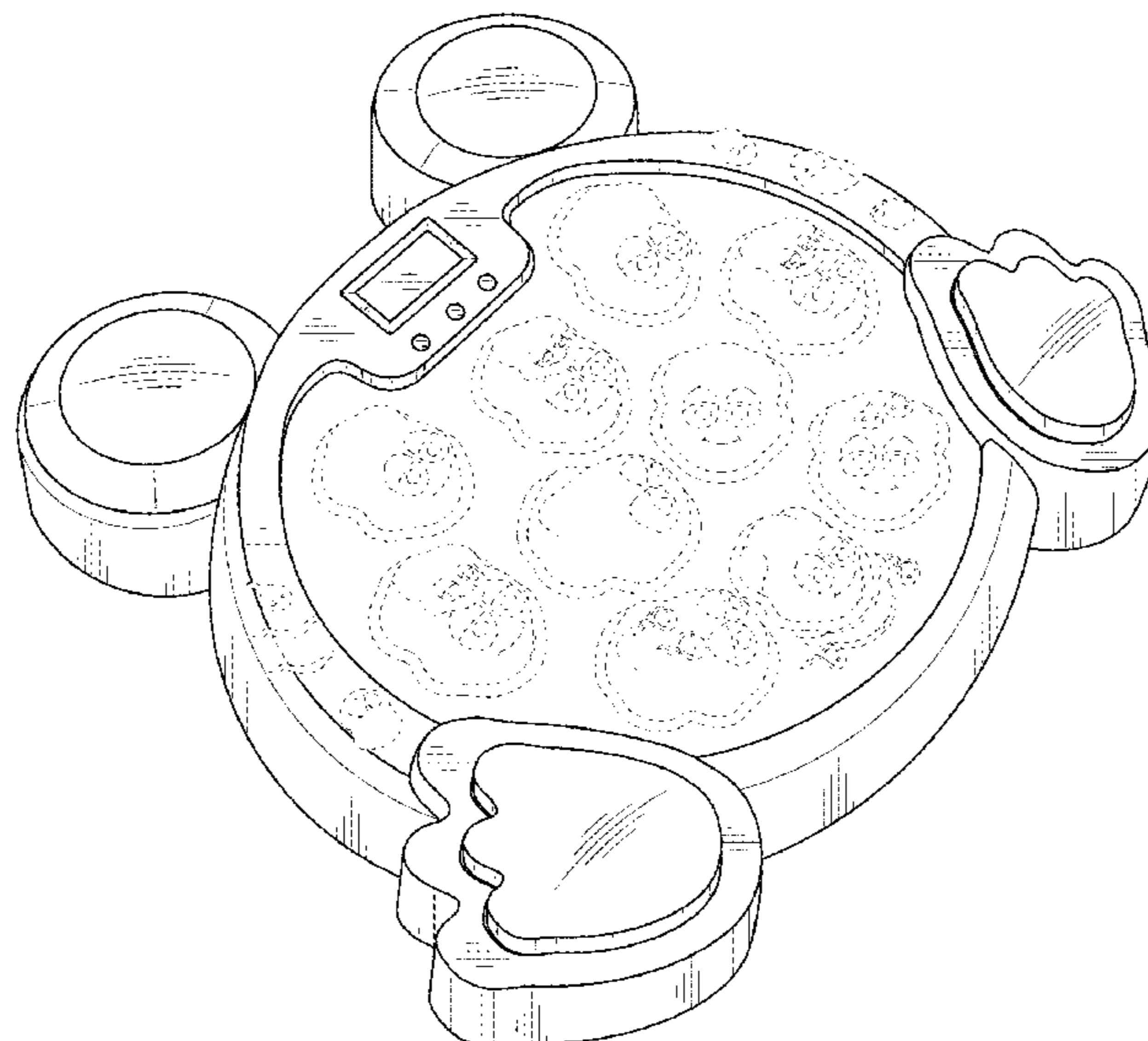
FIG. 5 is a Left-side view of the whack a frog game as shown in FIG. 1;

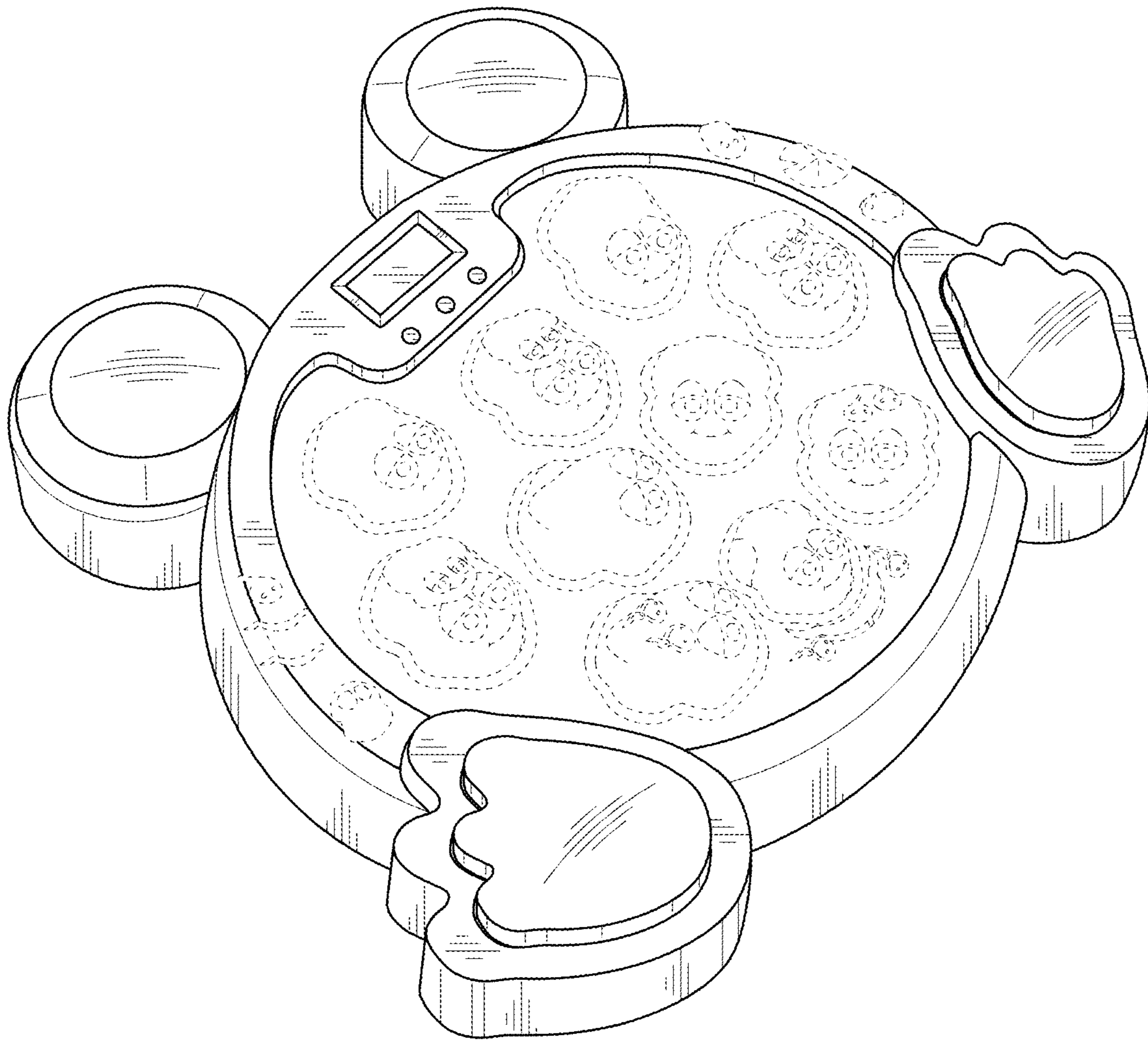

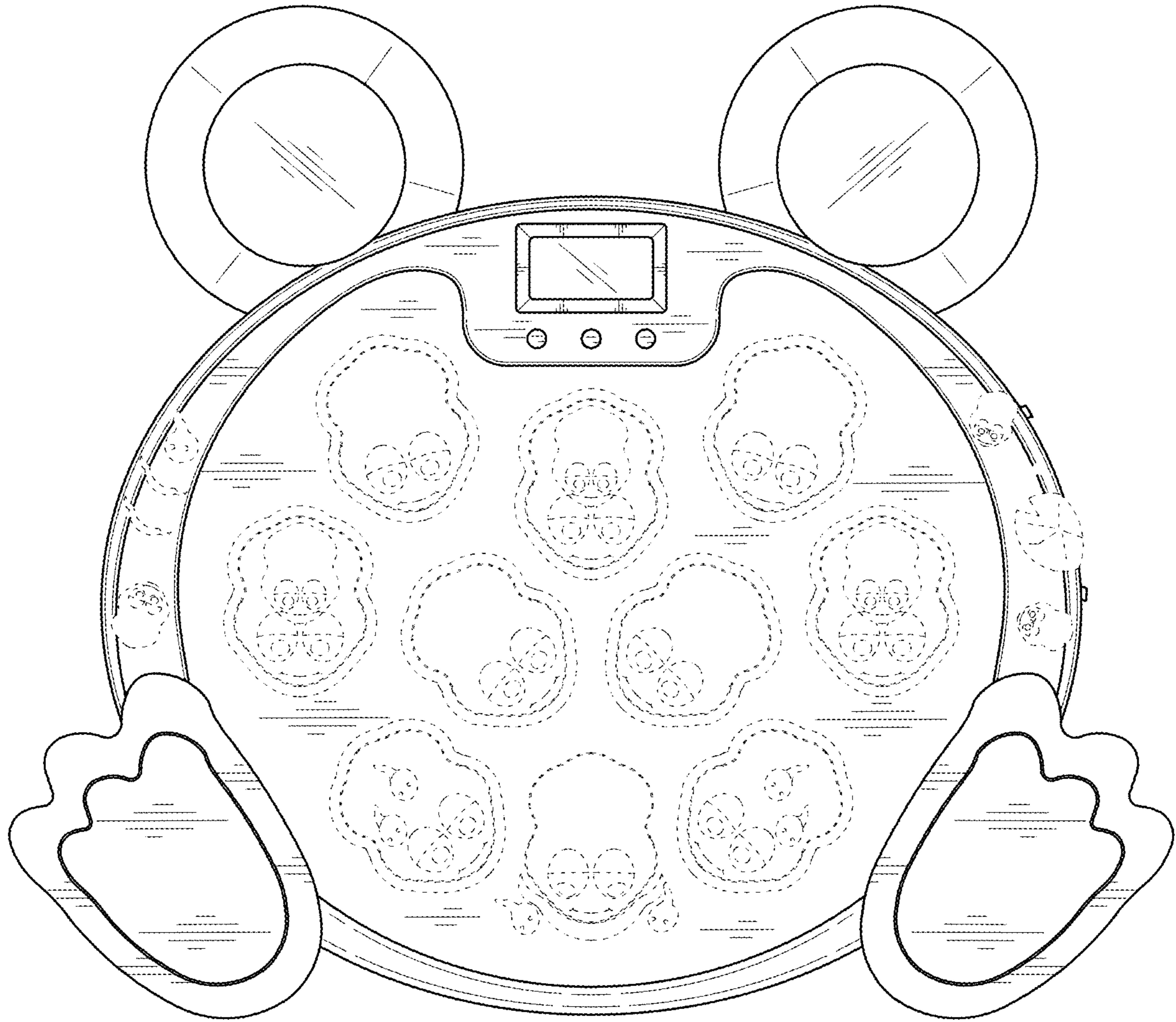

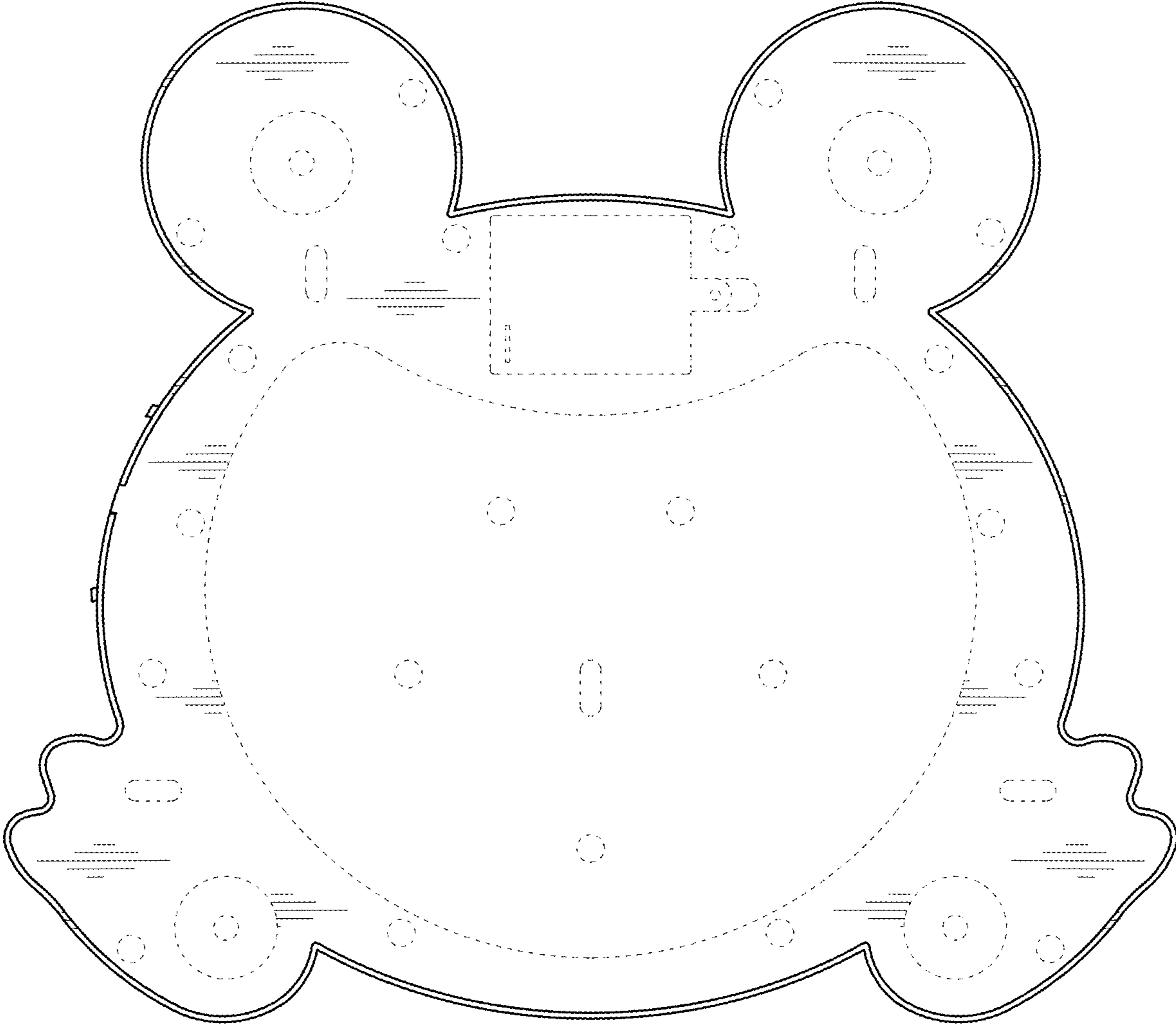

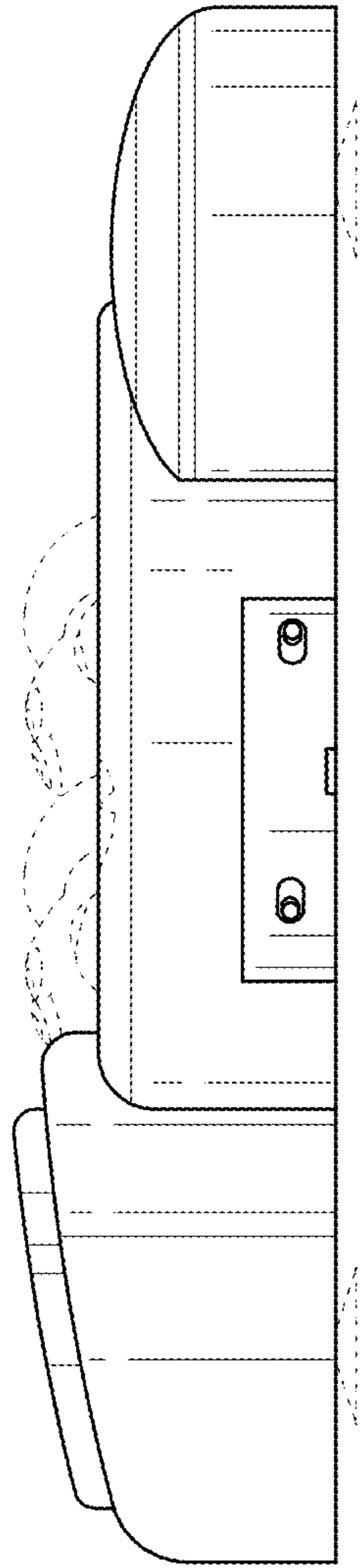

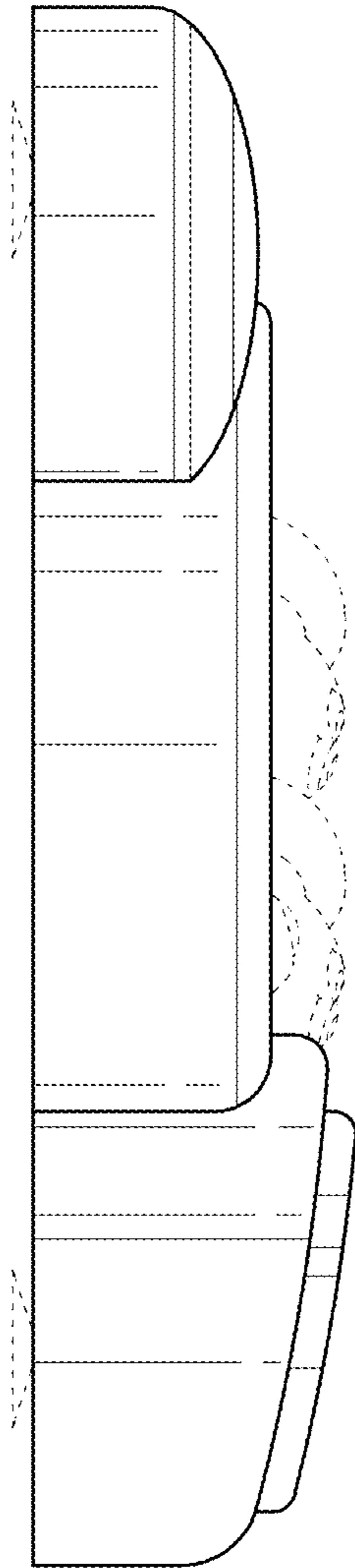

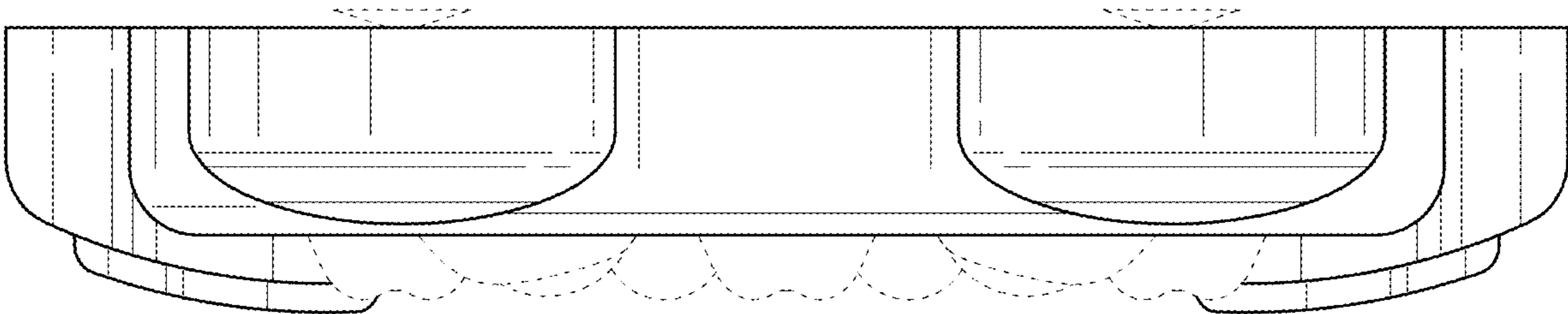

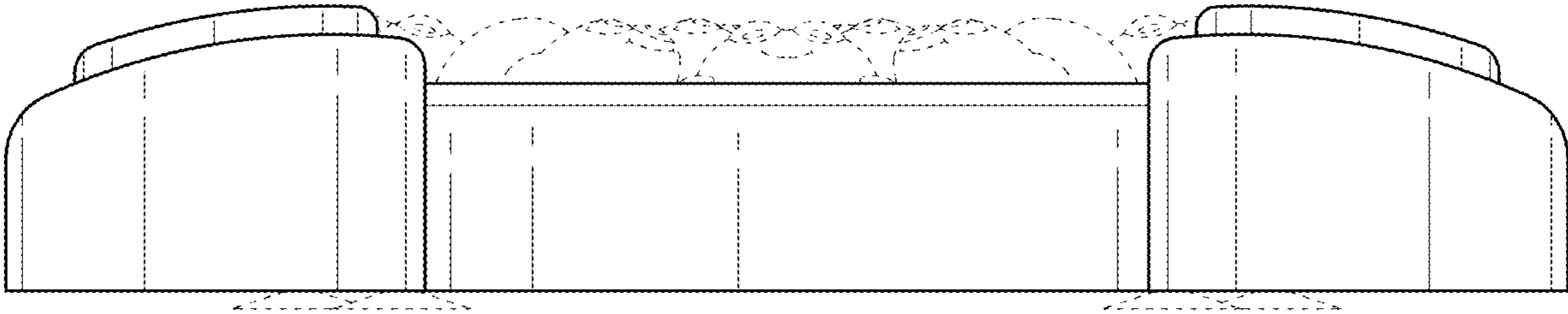
