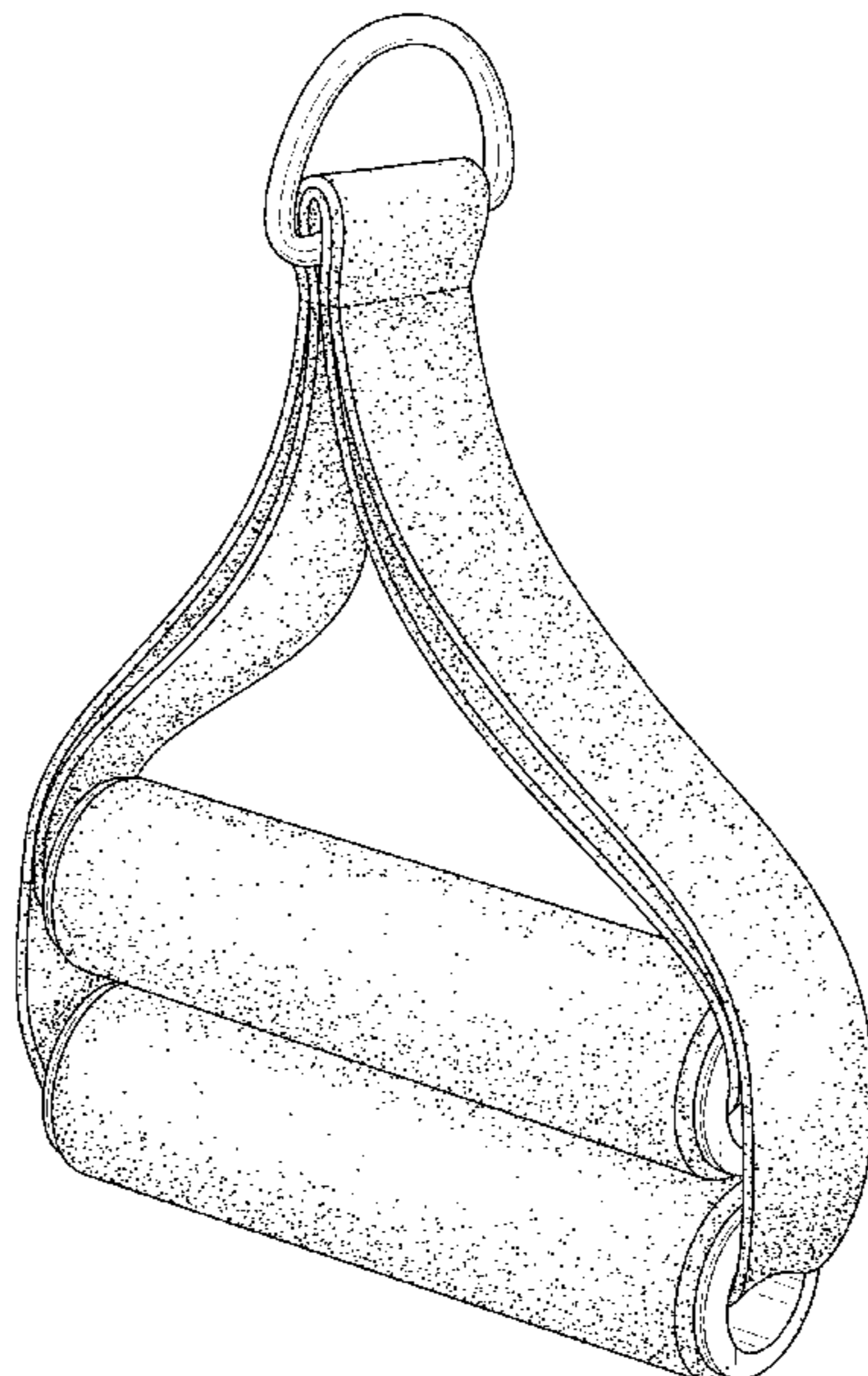
(57) **CLAIM**

The ornamental design for a double handle with clasp for exercise equipment, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of the double handle with clasp for exercise equipment of the present invention; FIG. 2 is a front view of the double handle with clasp for exercise equipment of FIG. 1; FIG. 3 is a rear view of the double handle with clasp for exercise equipment of FIG. 1; FIG. 4 is a left side view of the double handle with clasp for exercise equipment of FIG. 1; FIG. 5 is a right side view of the double handle with clasp for exercise equipment of FIG. 1; FIG. 6 is a top view of the double handle with clasp for exercise equipment of FIG. 1; and, FIG. 7 is a bottom view of the double handle with clasp for exercise equipment of FIG. 1. The broken lines shown in FIGS. 1-5 illustrate stitching which forms part of the claimed design.

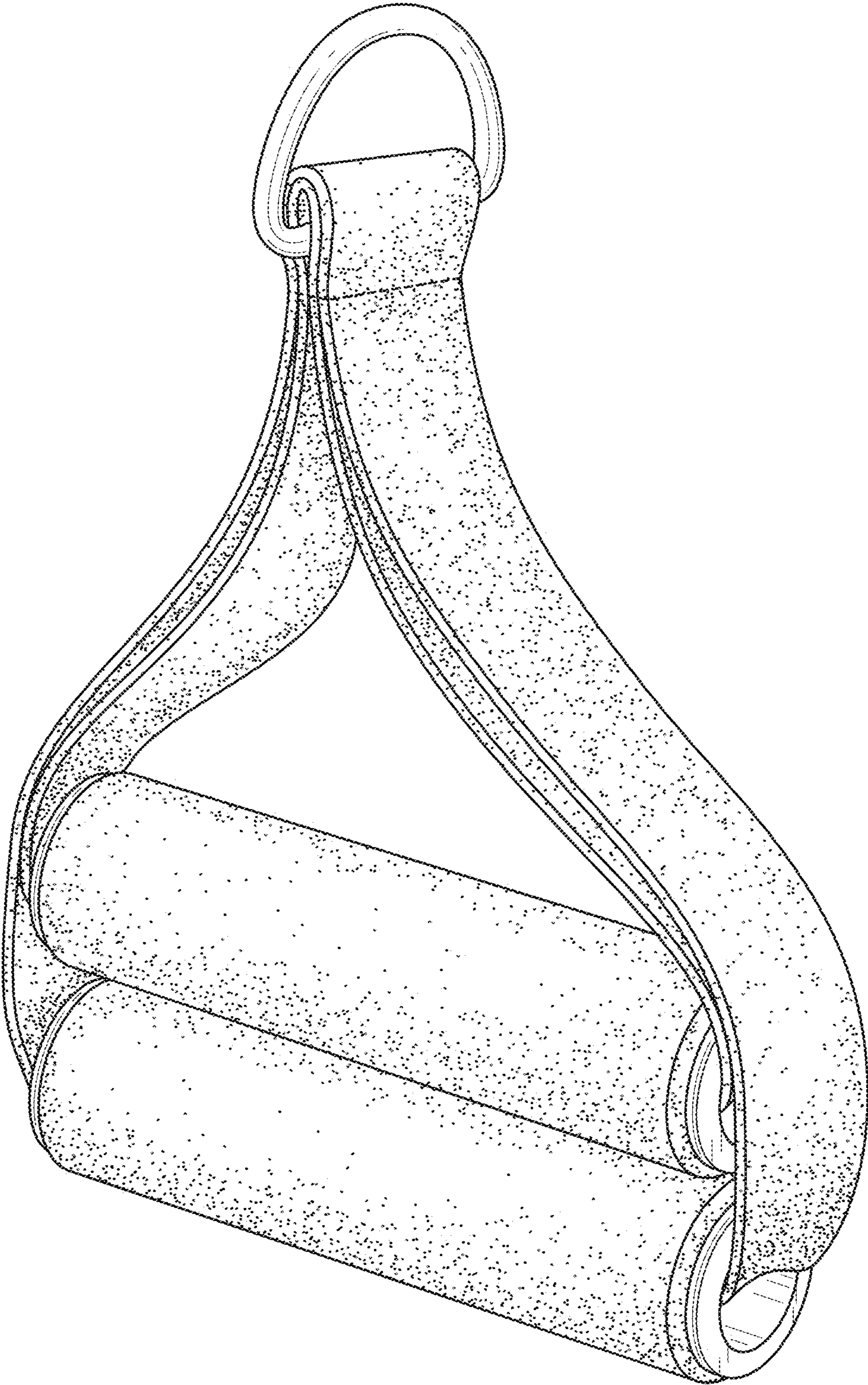

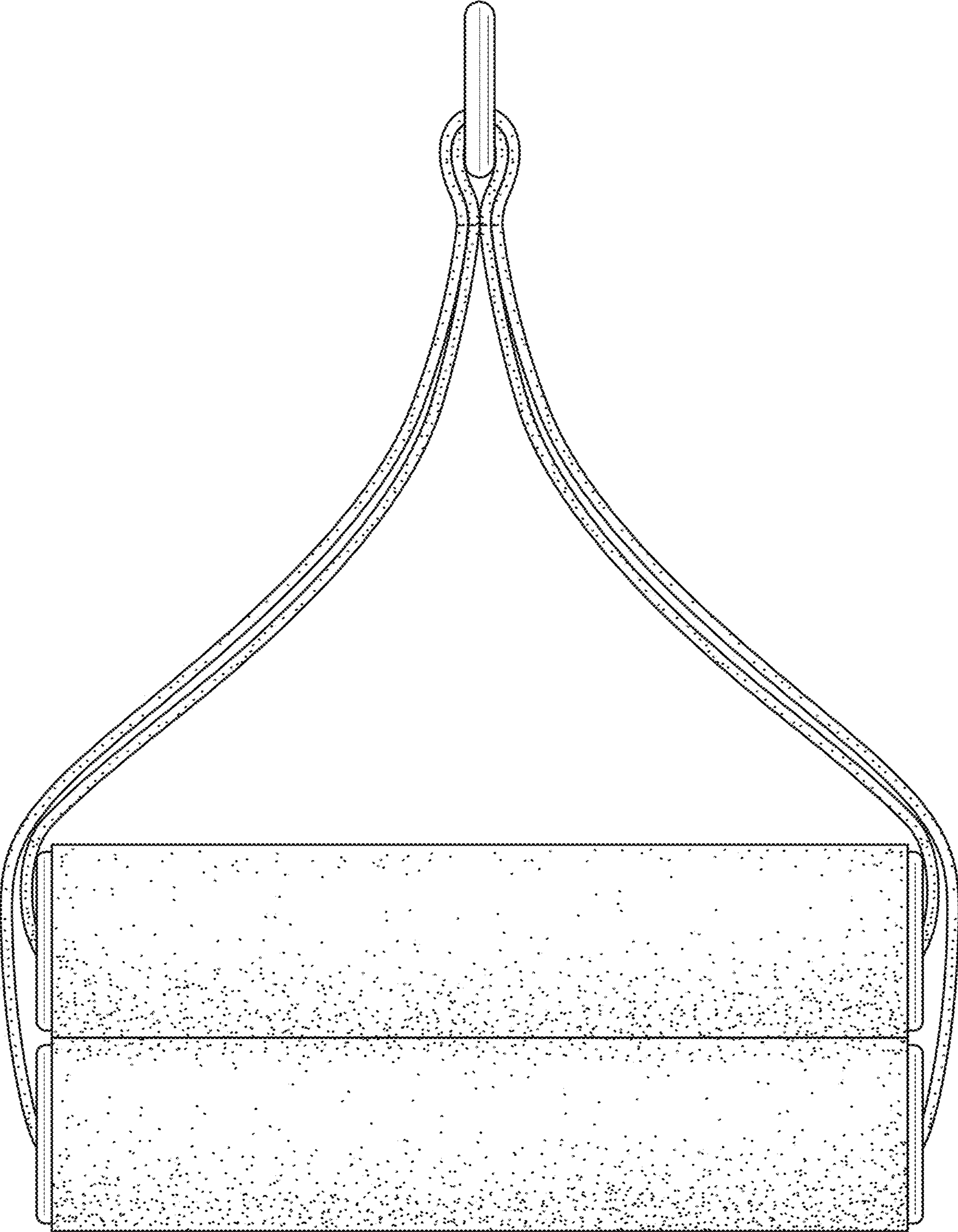

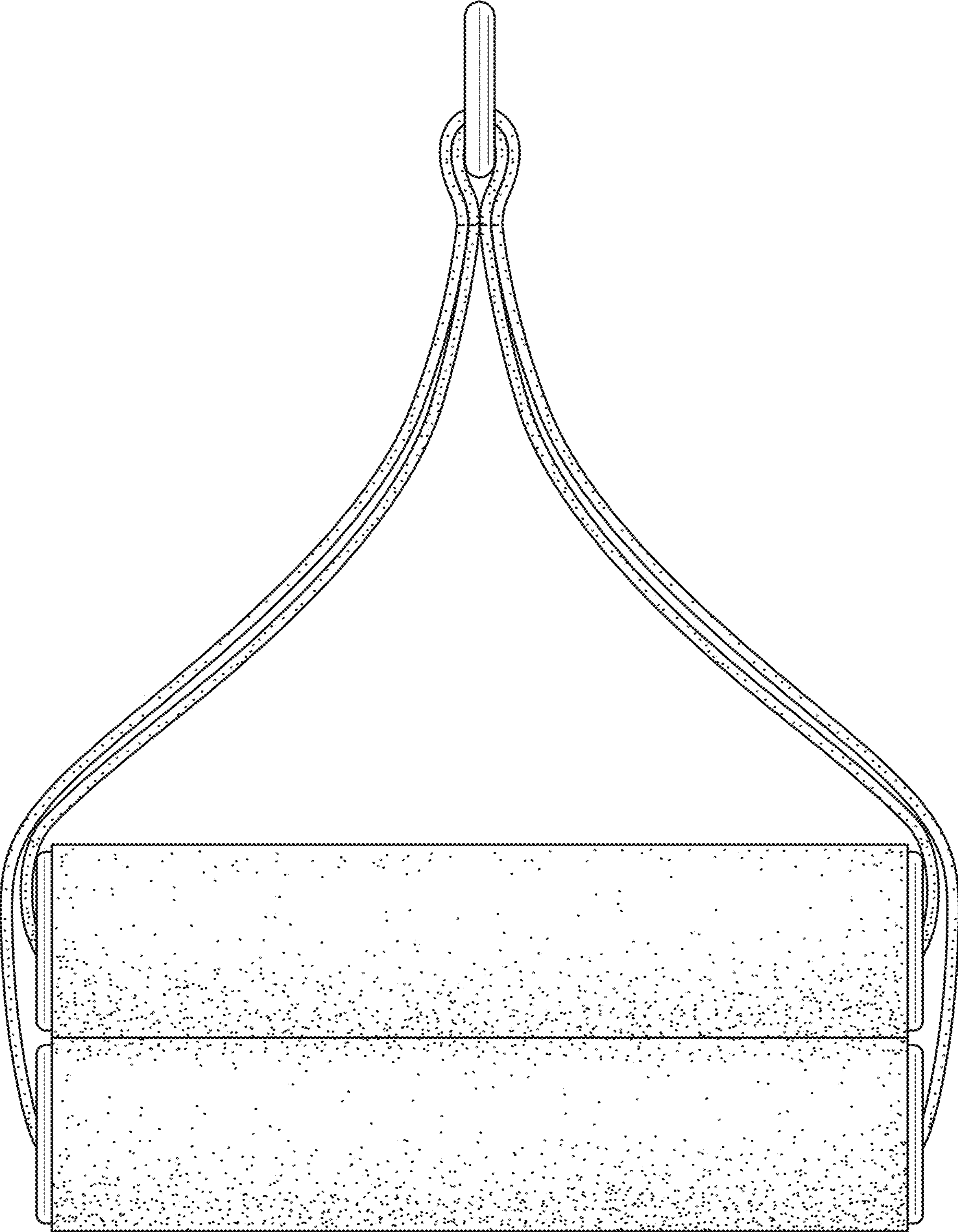

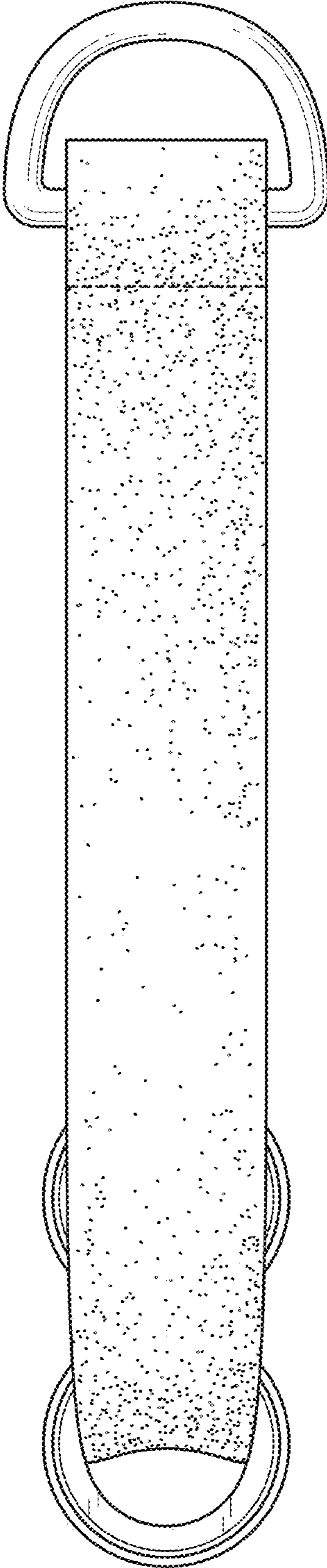

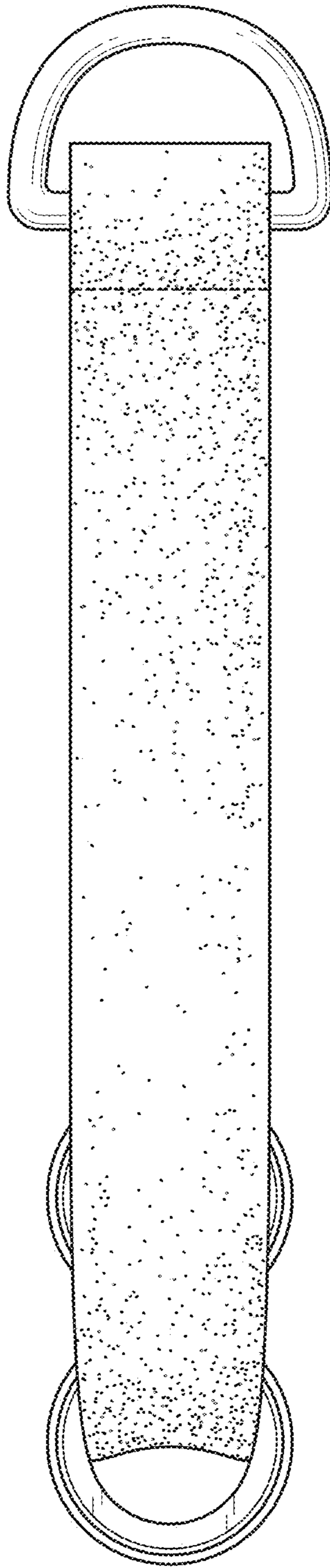

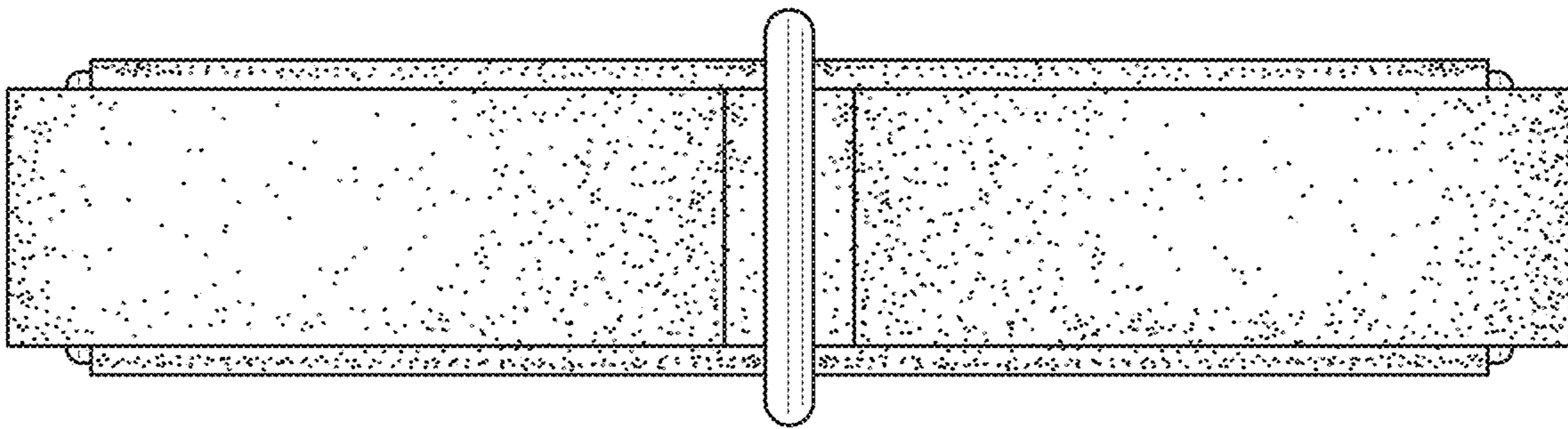

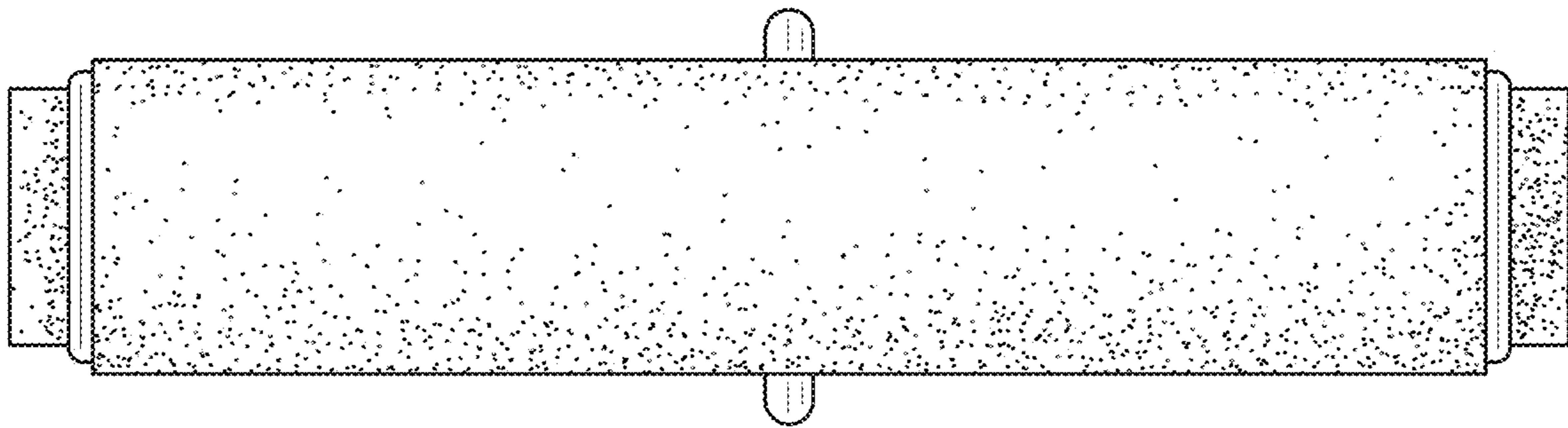
