(57) **CLAIM**

The ornamental design for a pull buoy, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a pull buoy according to the present design.

FIG. 2 is a top, rear, left perspective view of the pull buoy shown in FIG. 1.

FIG. 3 is a front elevation view of the pull buoy shown in FIG. 1.

FIG. 4 is a rear elevation view of the pull buoy shown in FIG. 1.

FIG. 5 is a top plan view of the pull buoy shown in FIG. 1.

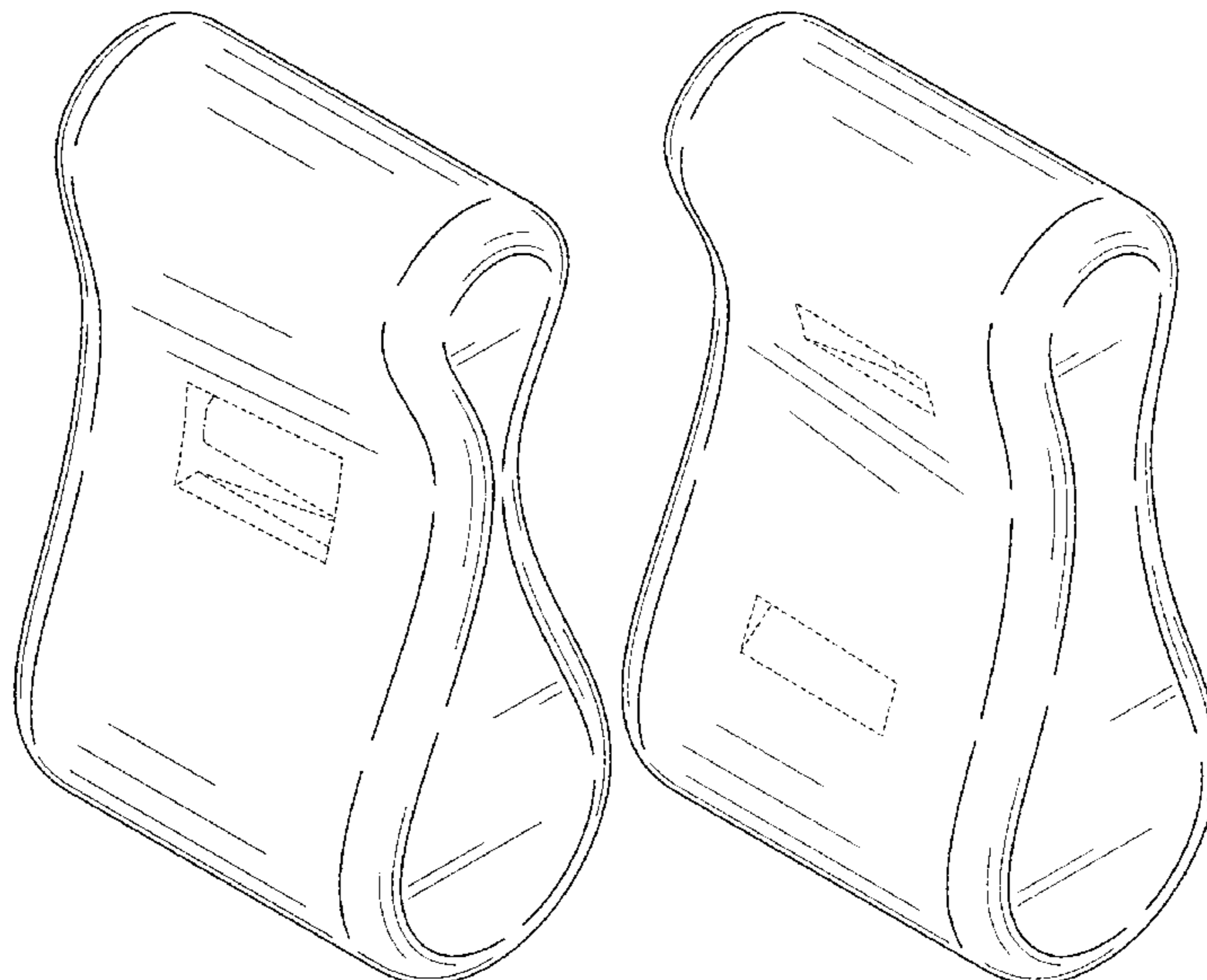
FIG. 6 is a bottom plan view of the pull buoy shown in FIG. 1.

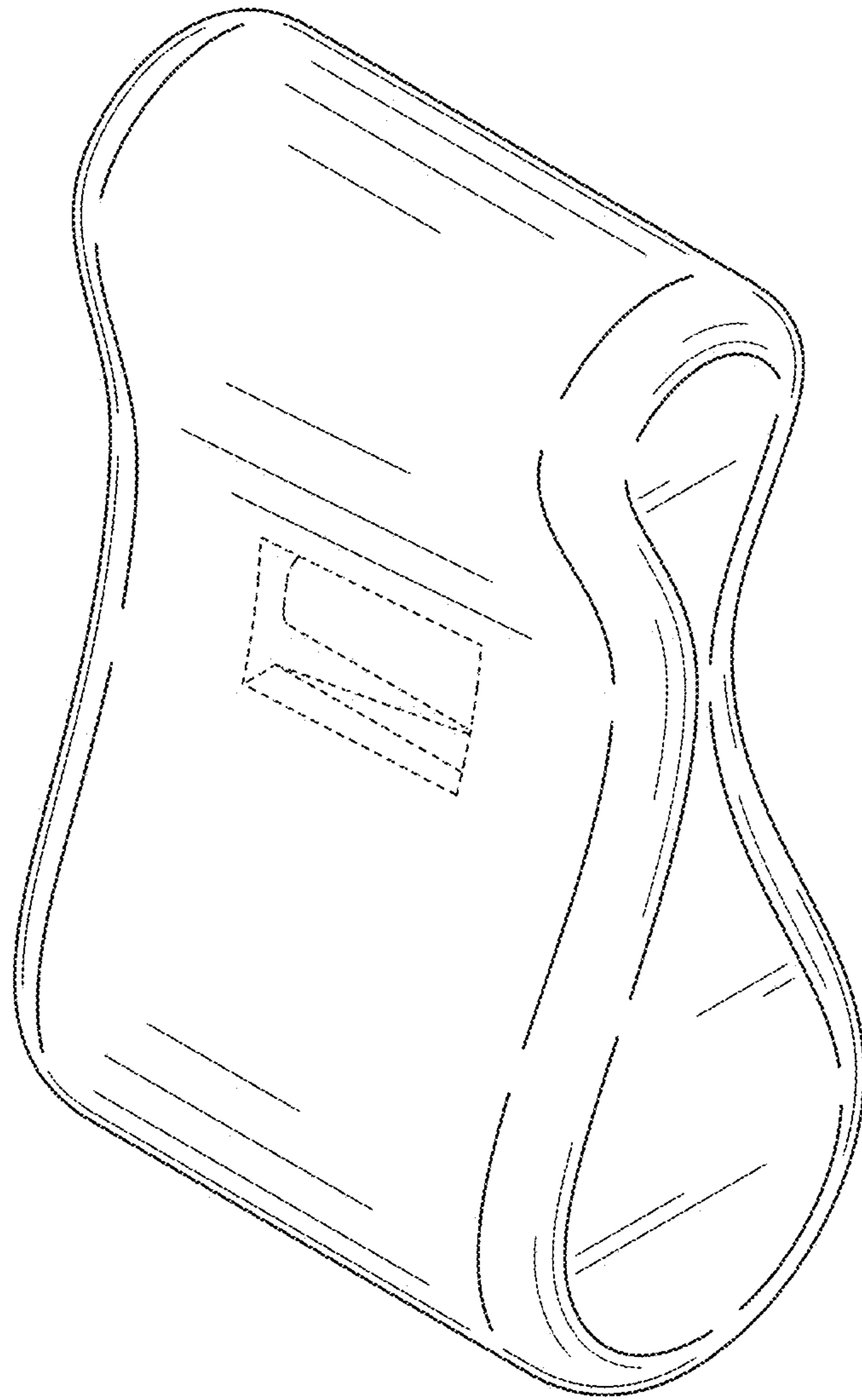

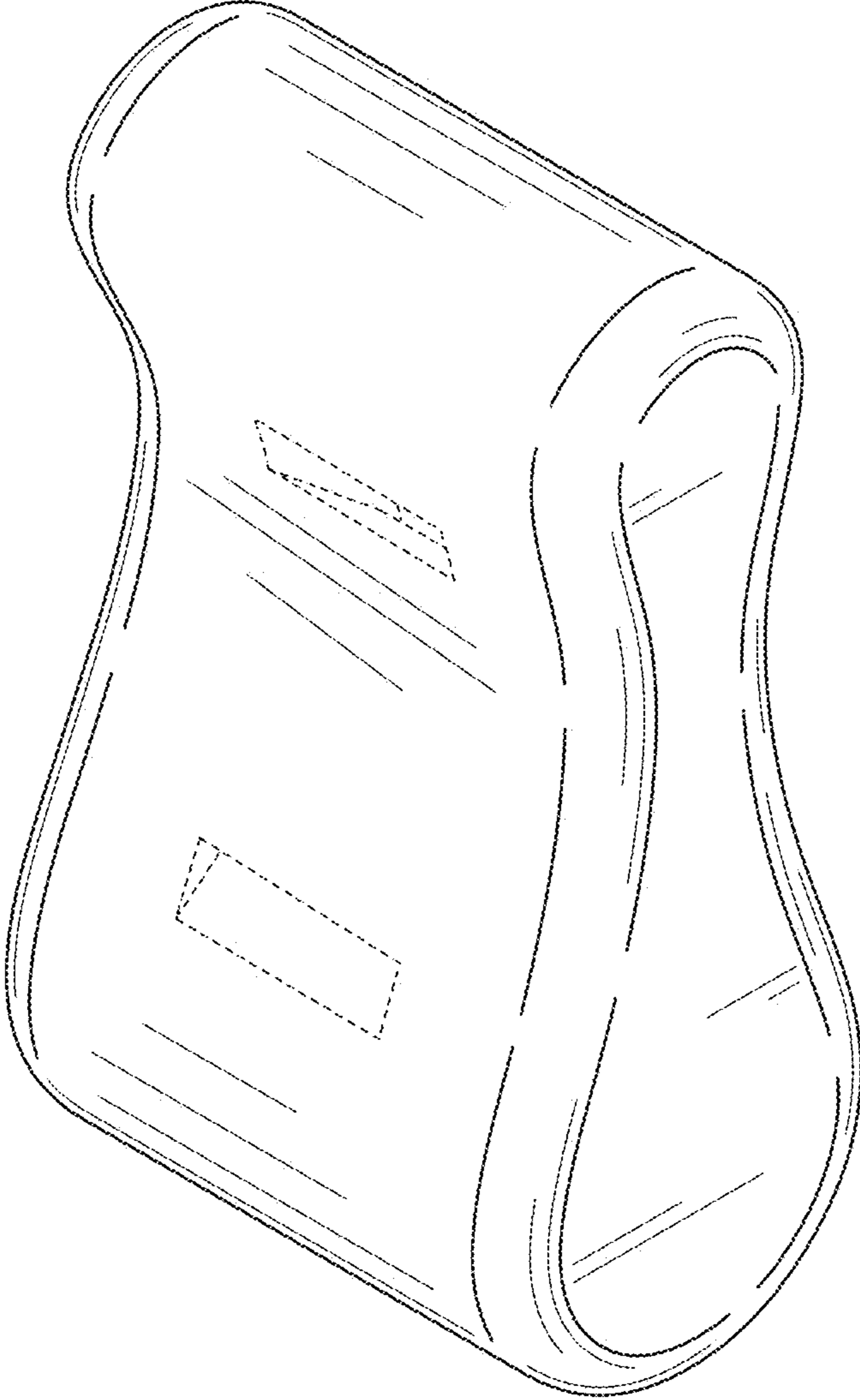

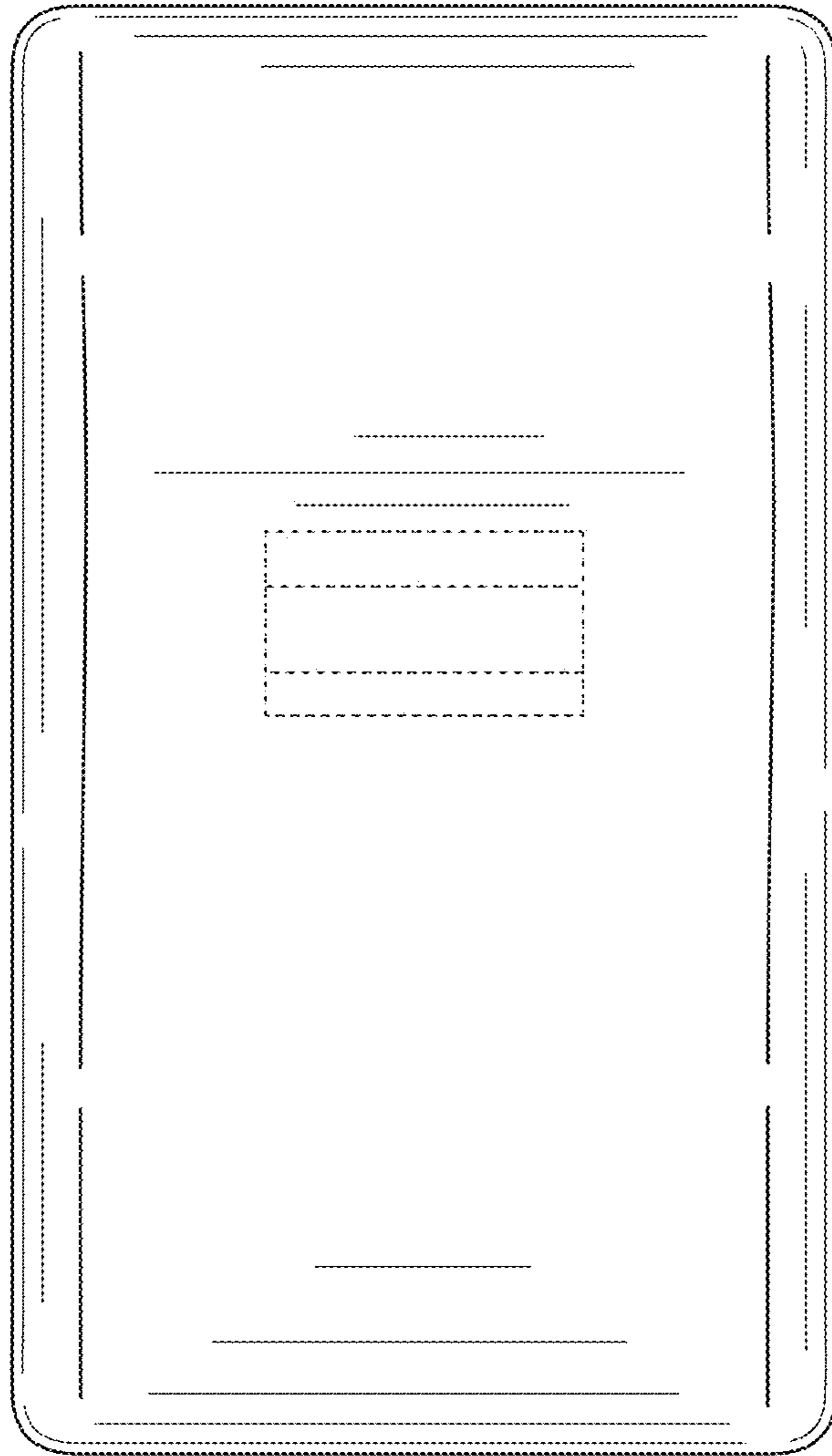

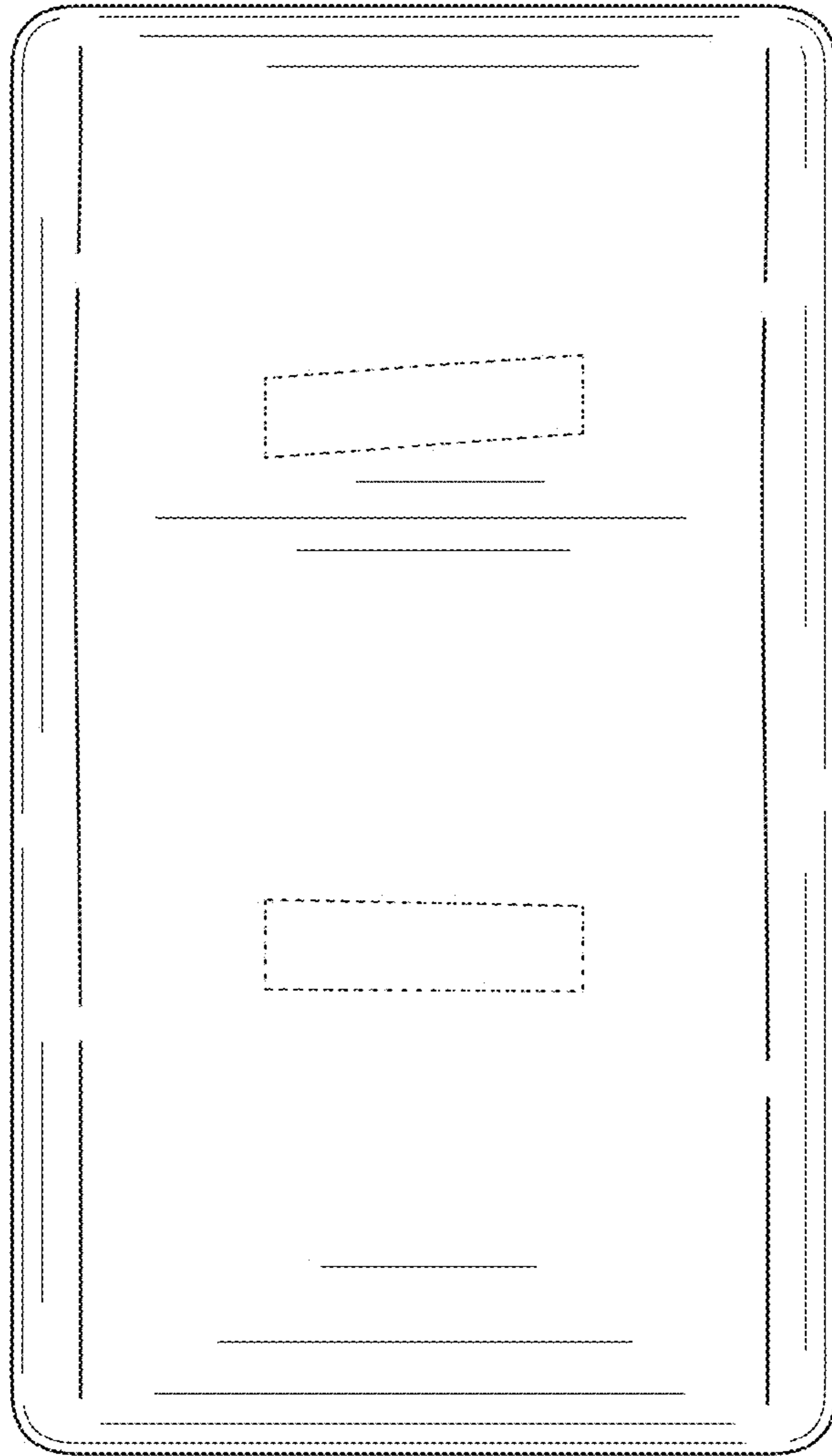

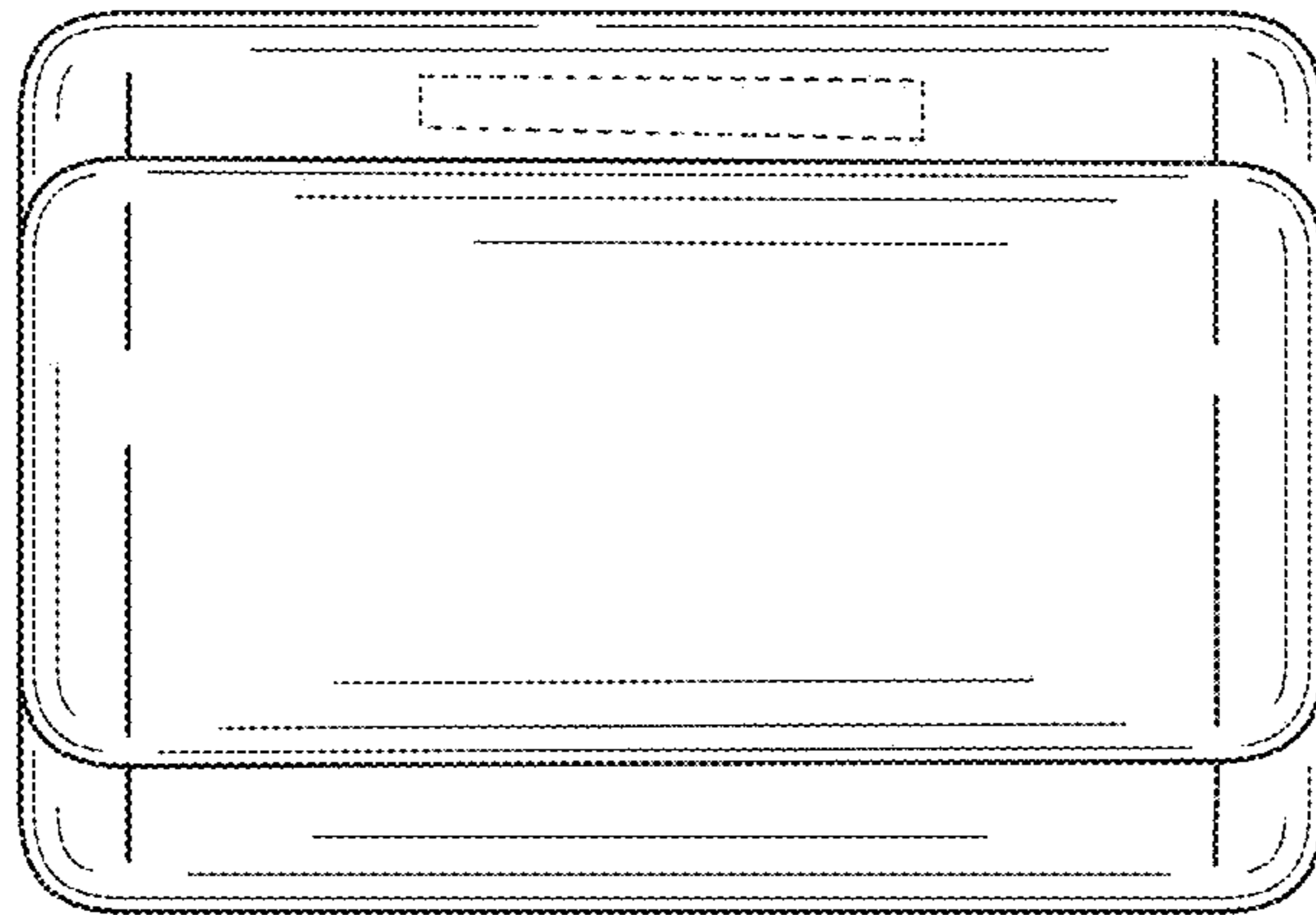

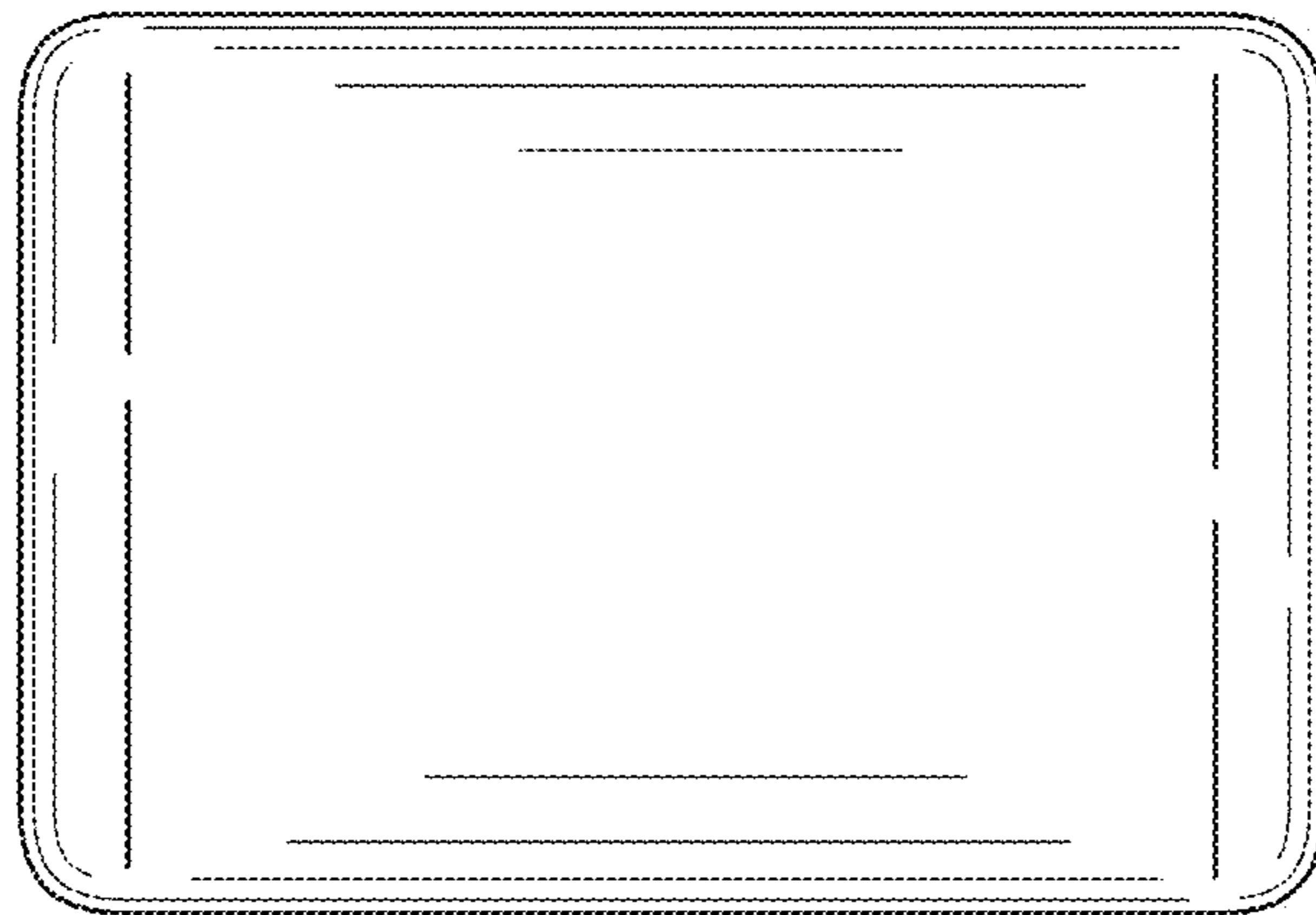

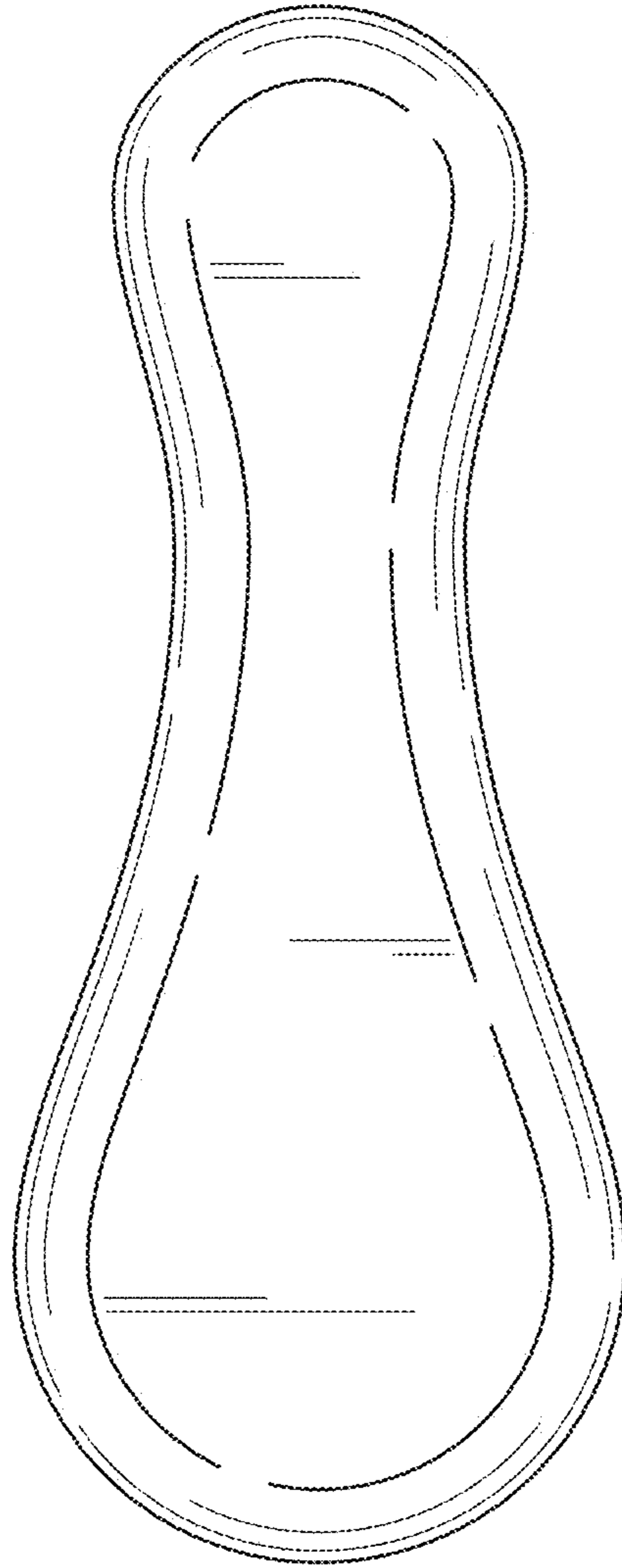

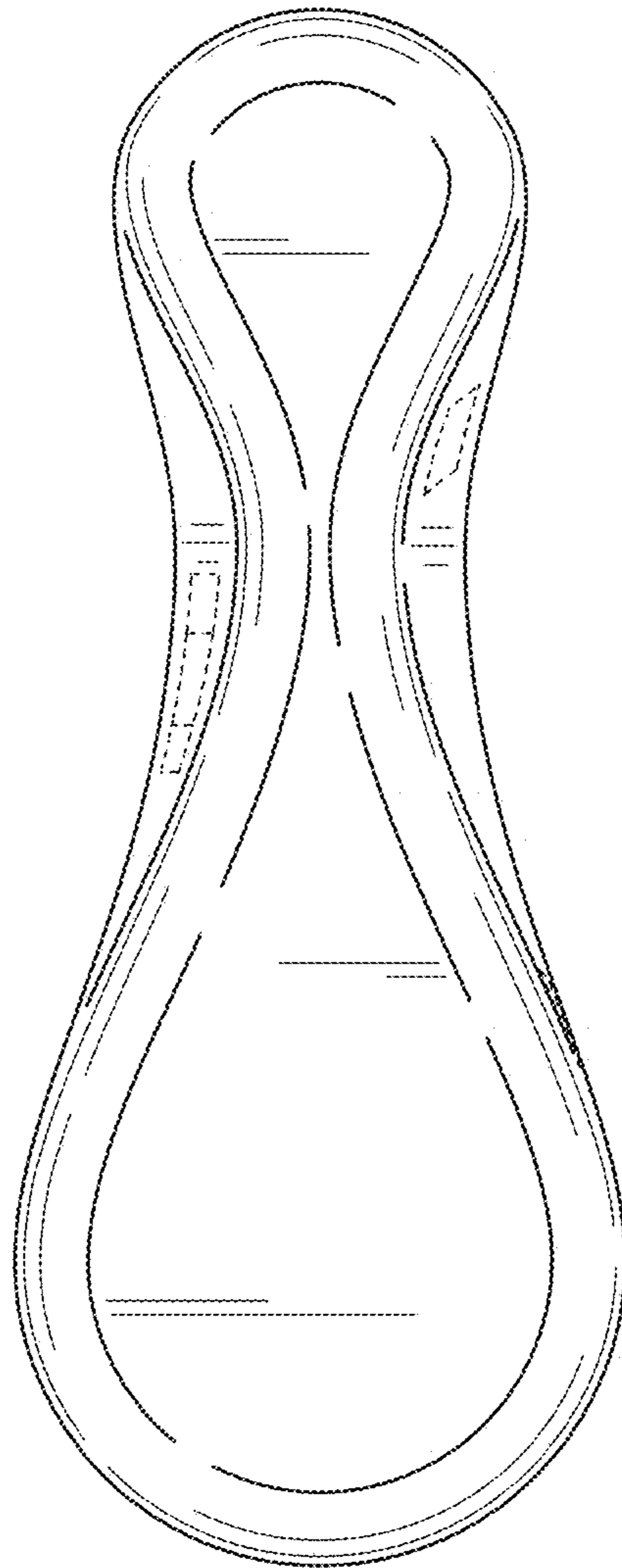
