DESCRIPTION

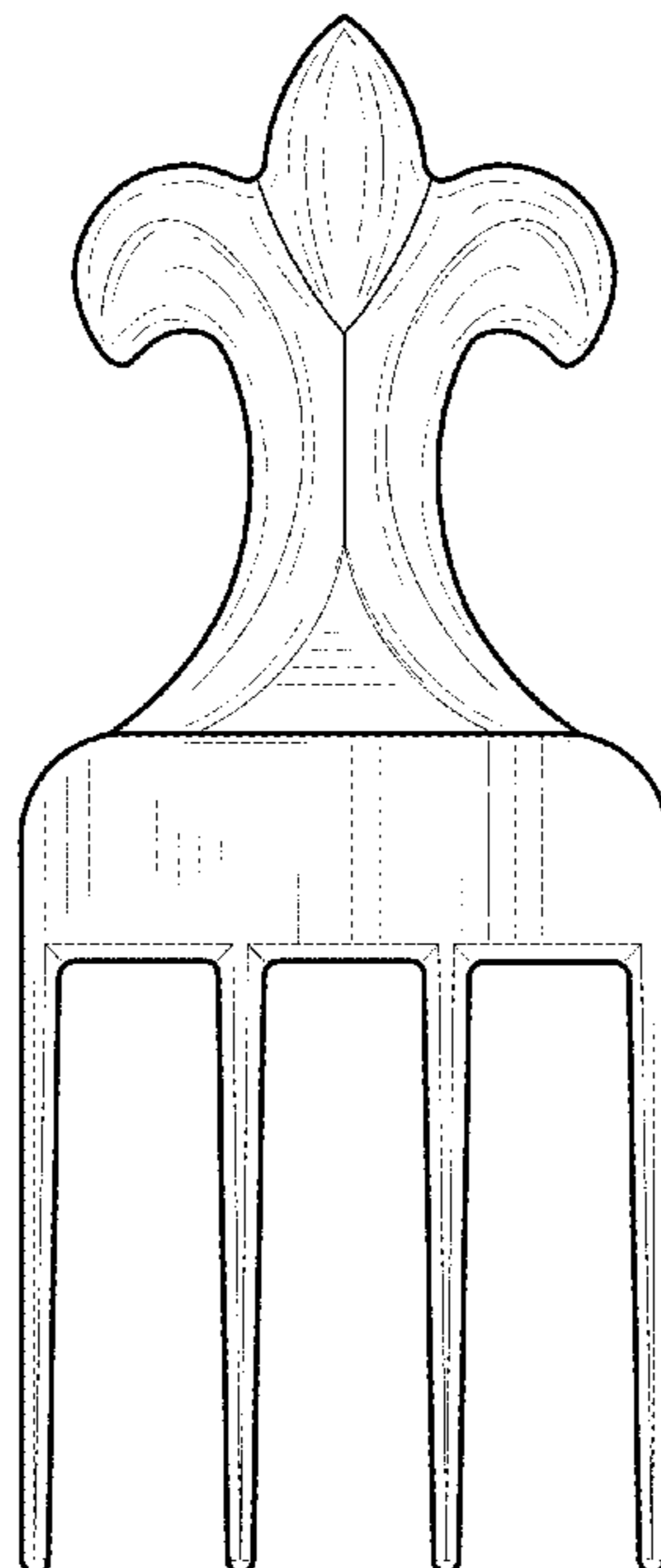
FIG. 1 is a front perspective view of an exemplary embodiment of a comb with large intertooth spacing;

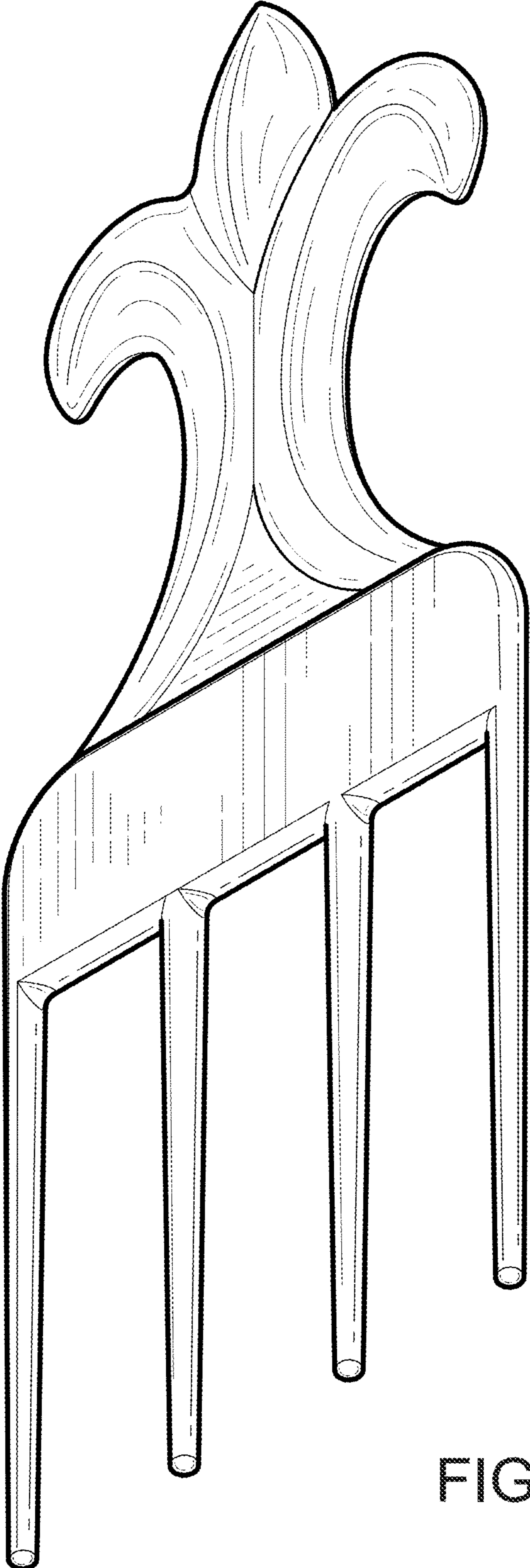

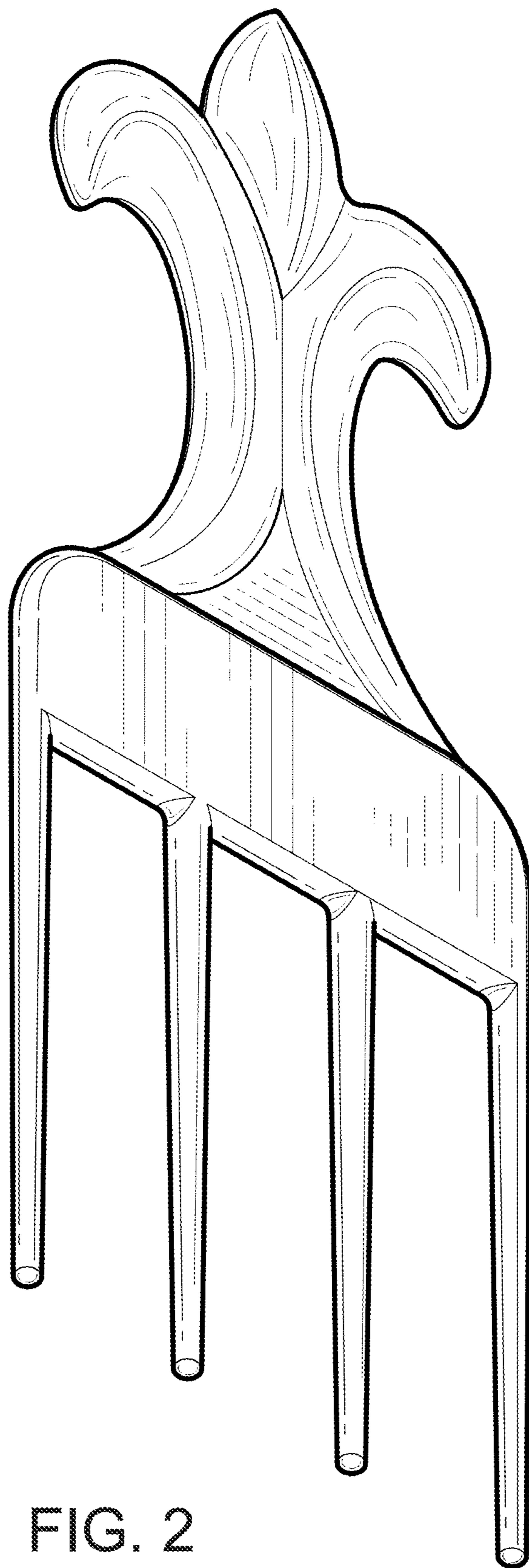

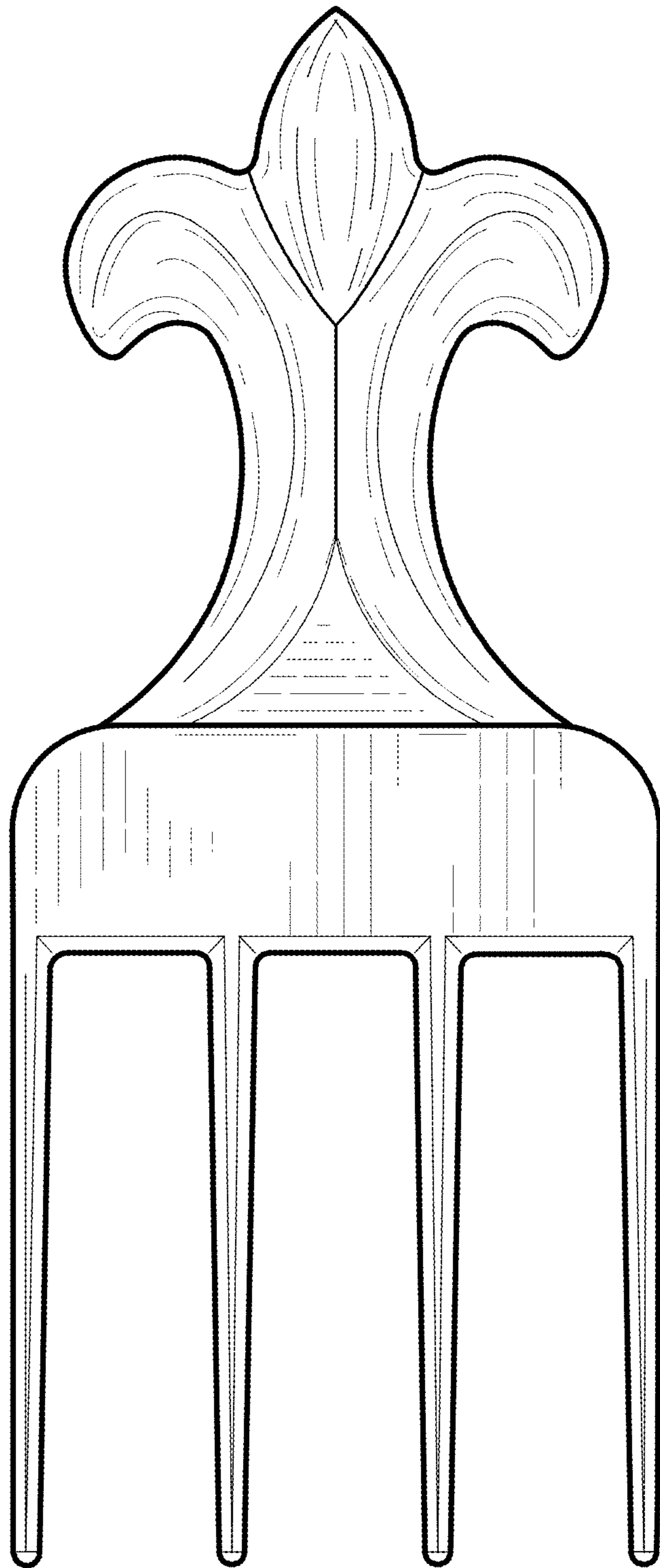

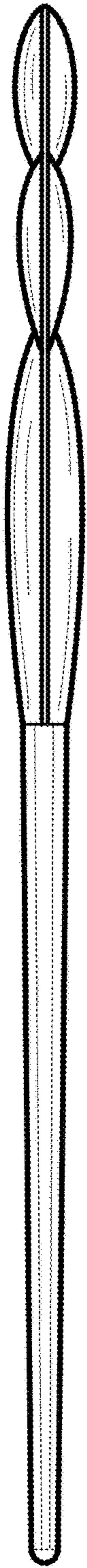

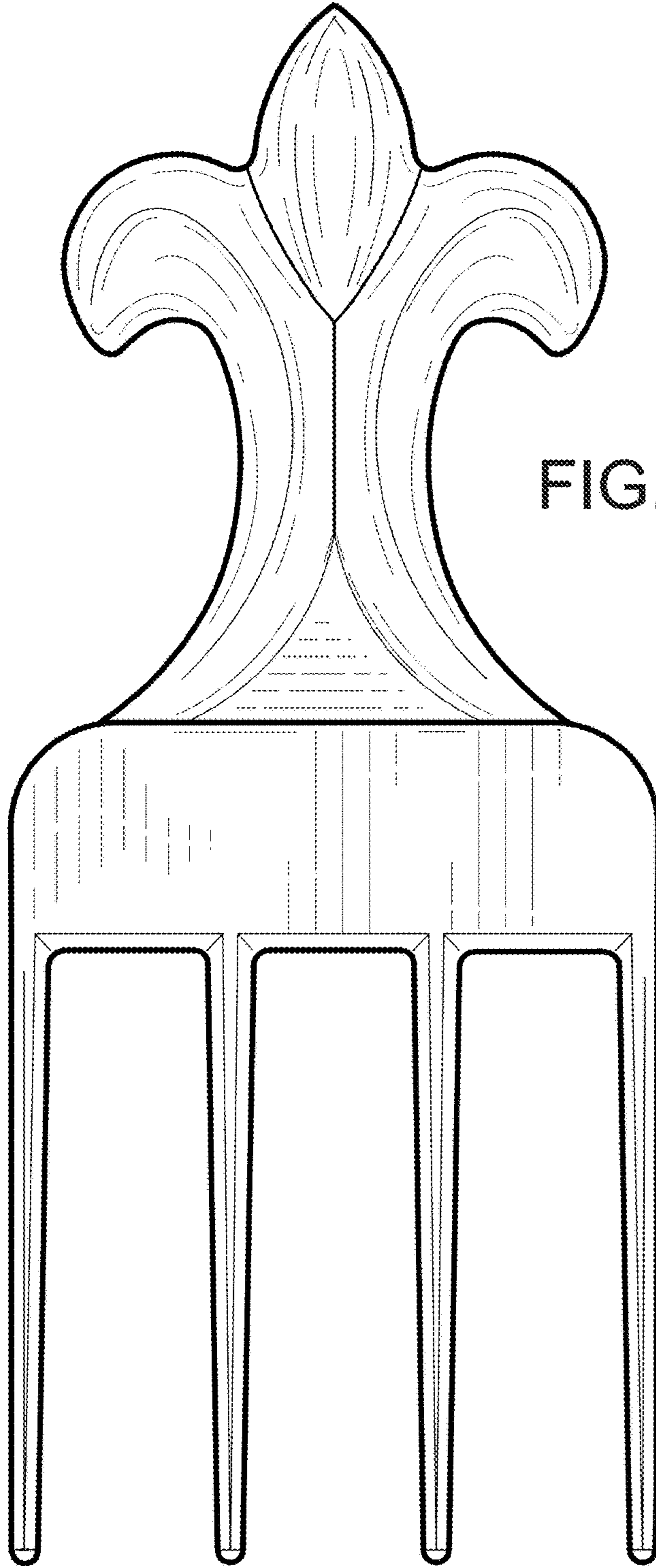

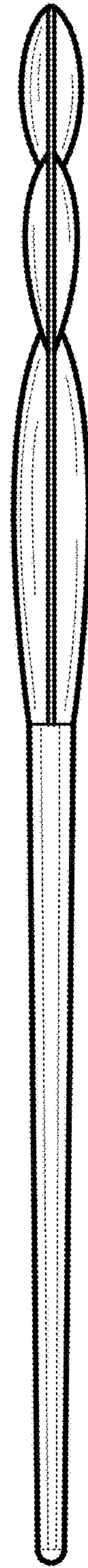
