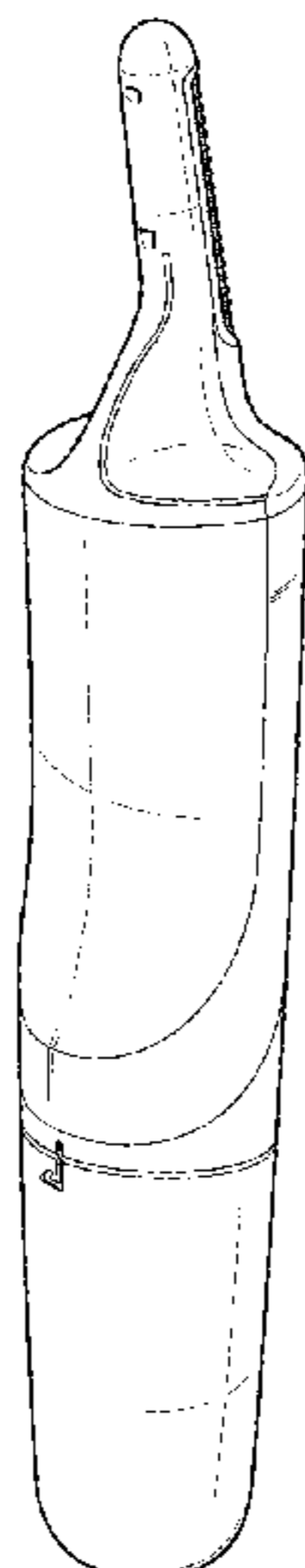
The ornamental design for a hair trimmer, as shown and described.

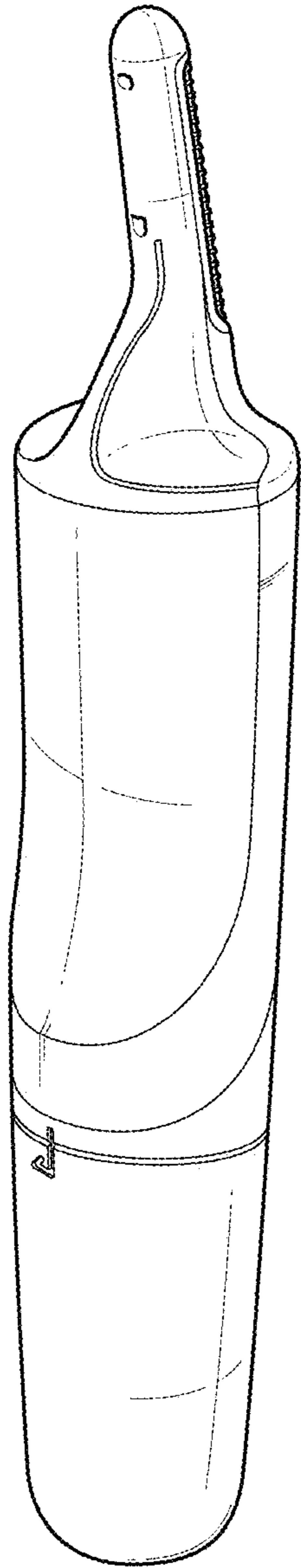

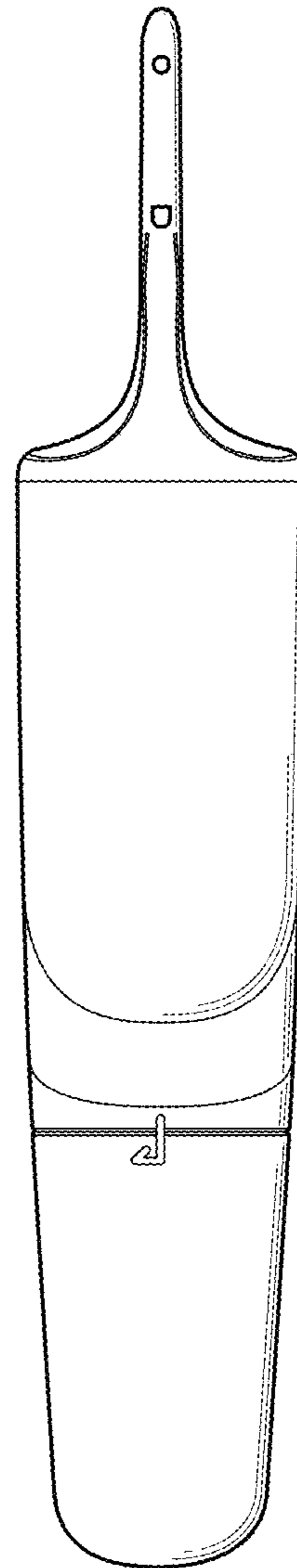

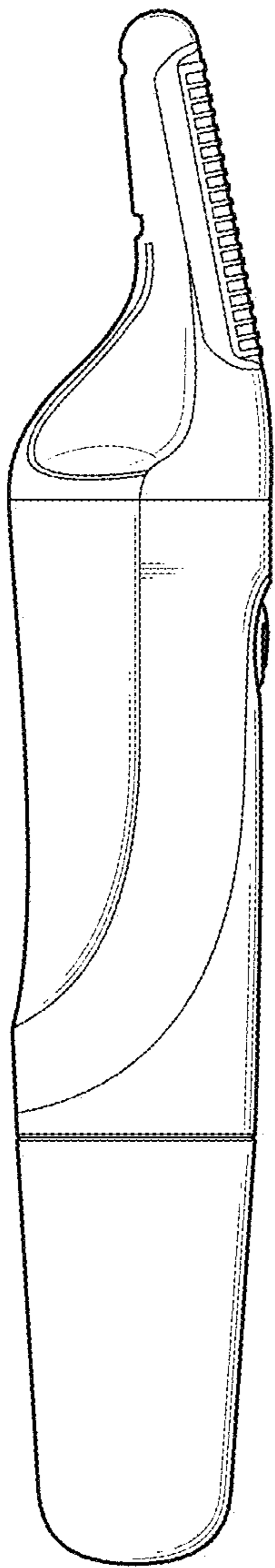

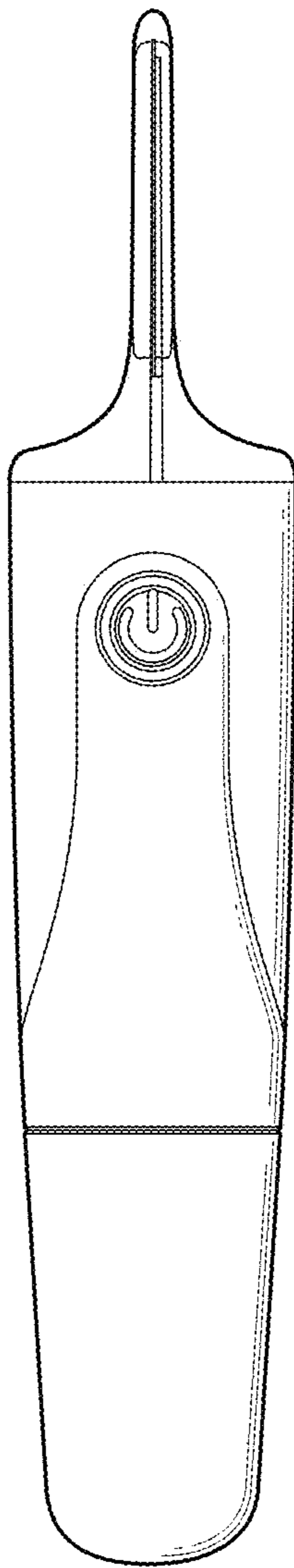

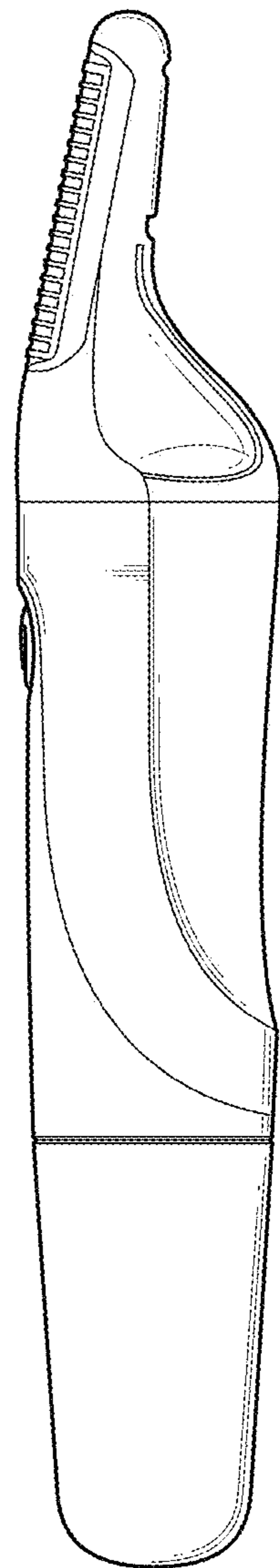

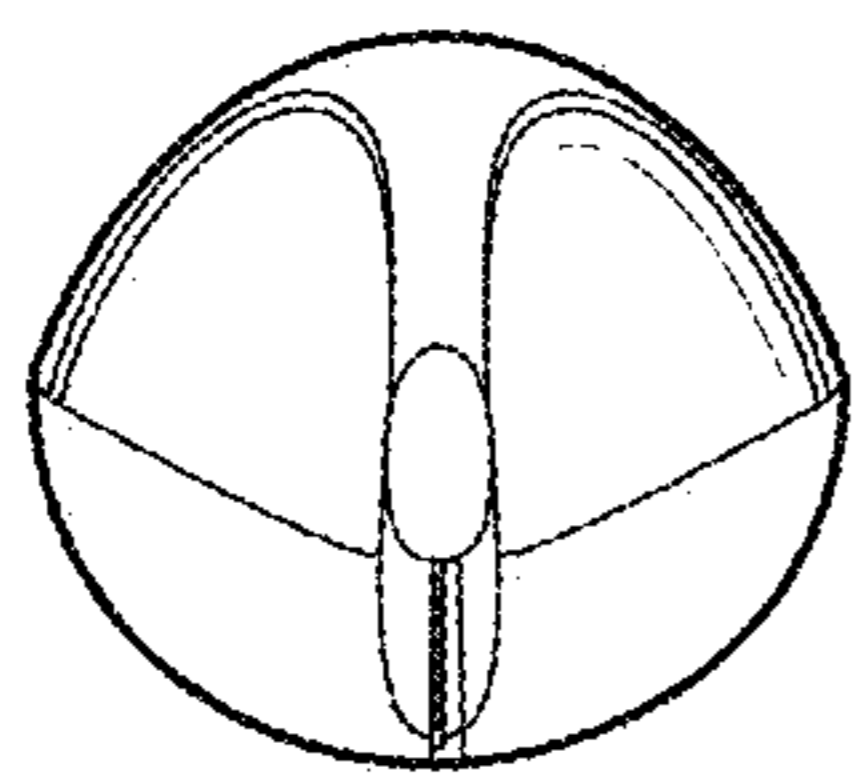

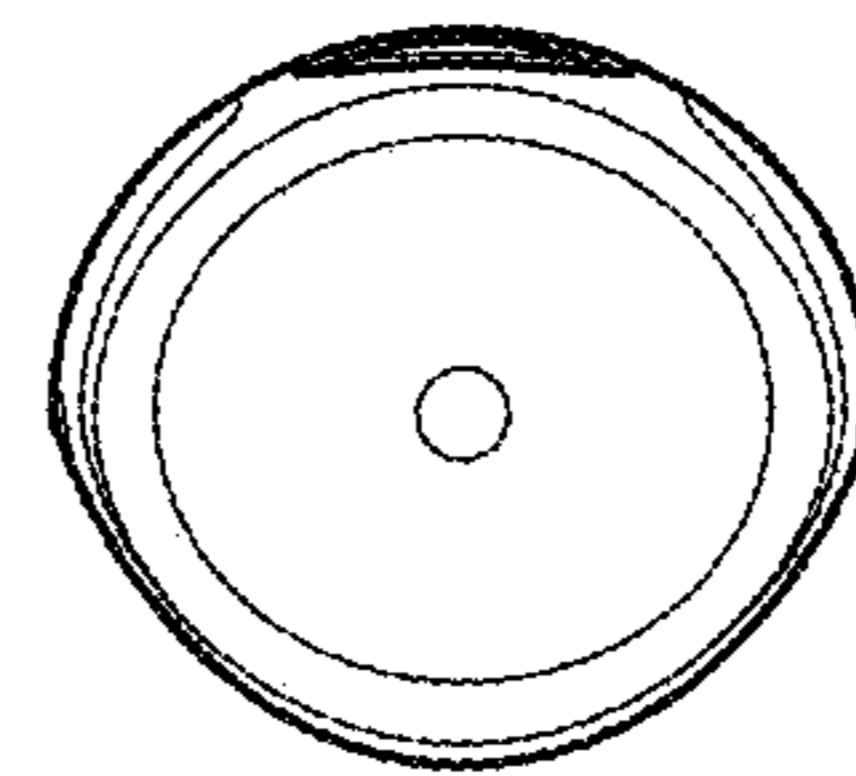
