(57) **CLAIM**

The ornamental design for a heat resistant cover, as shown and described.

FIG. 13 is a left side view of the heat resistant cover shown in FIG. 9;

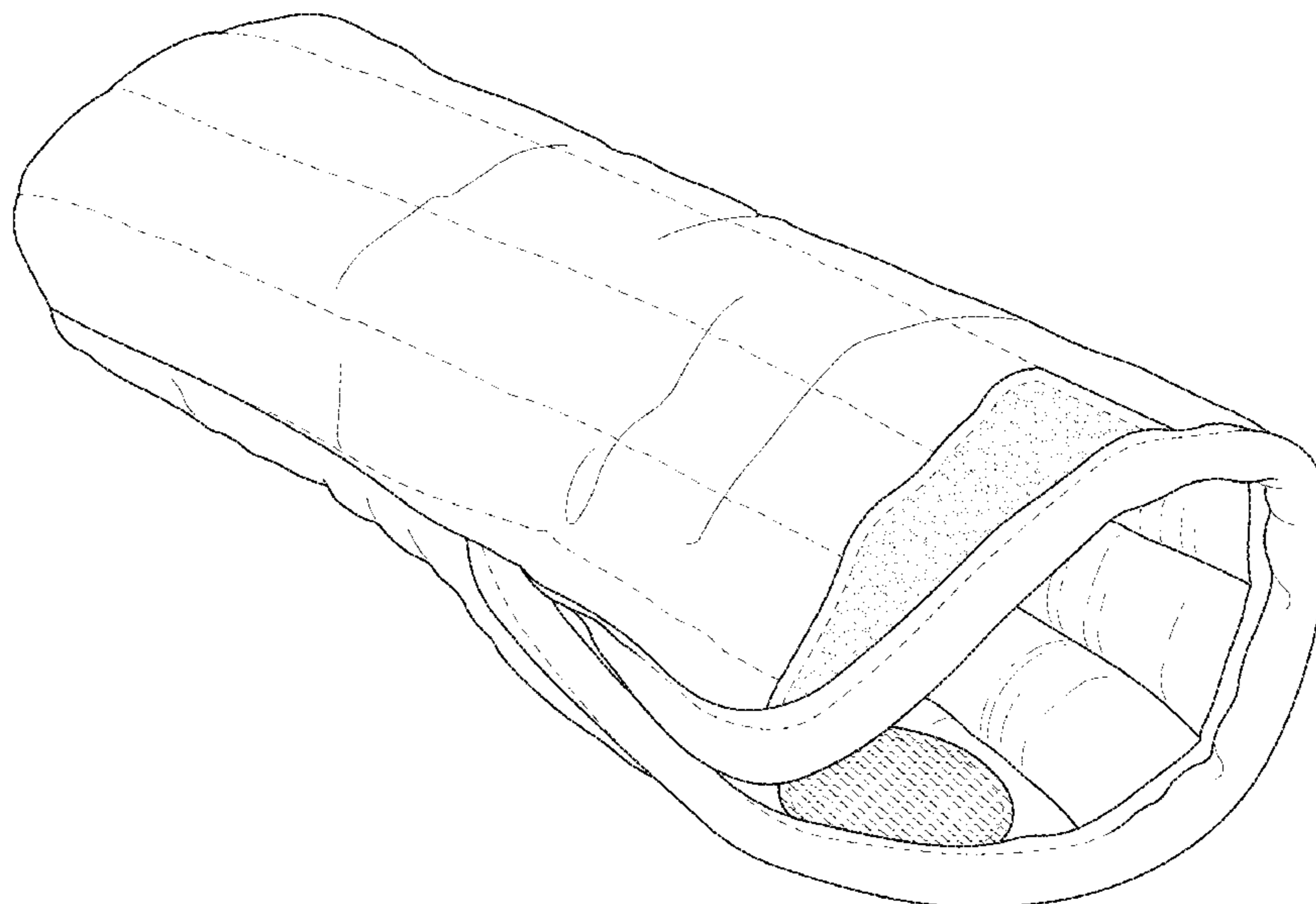
FIG. 14 is a right side view of the heat resistant cover shown in FIG. 9;

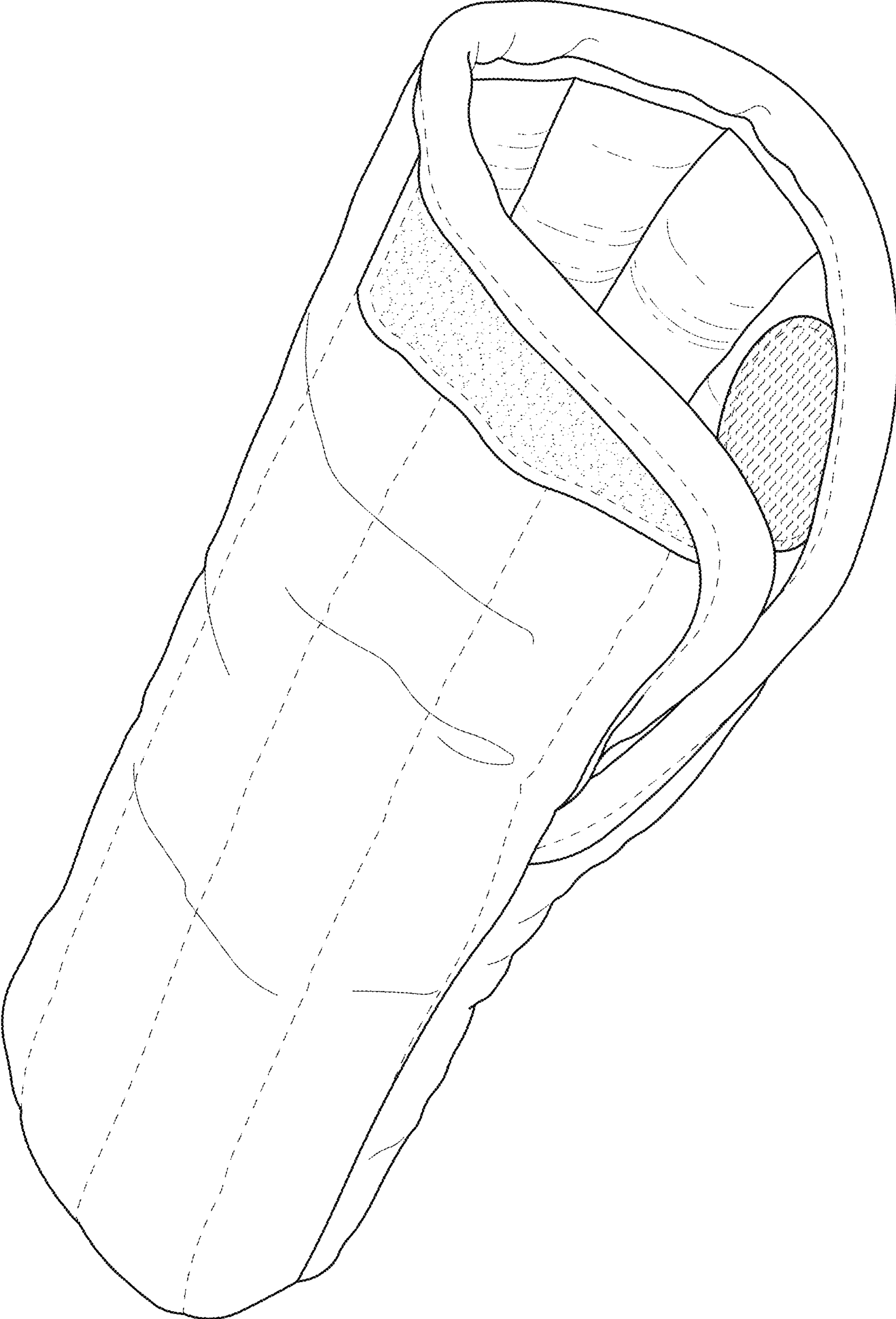

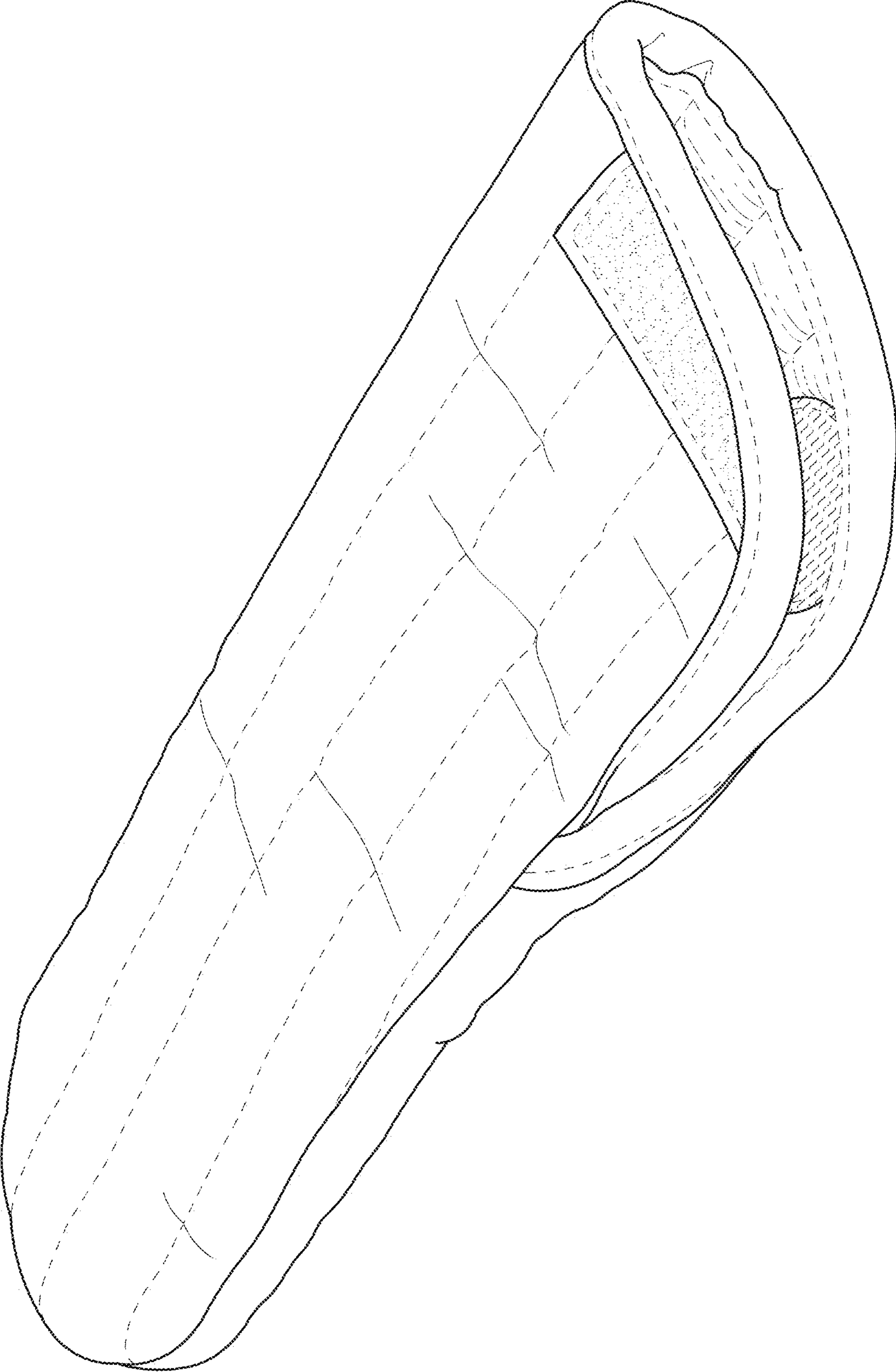

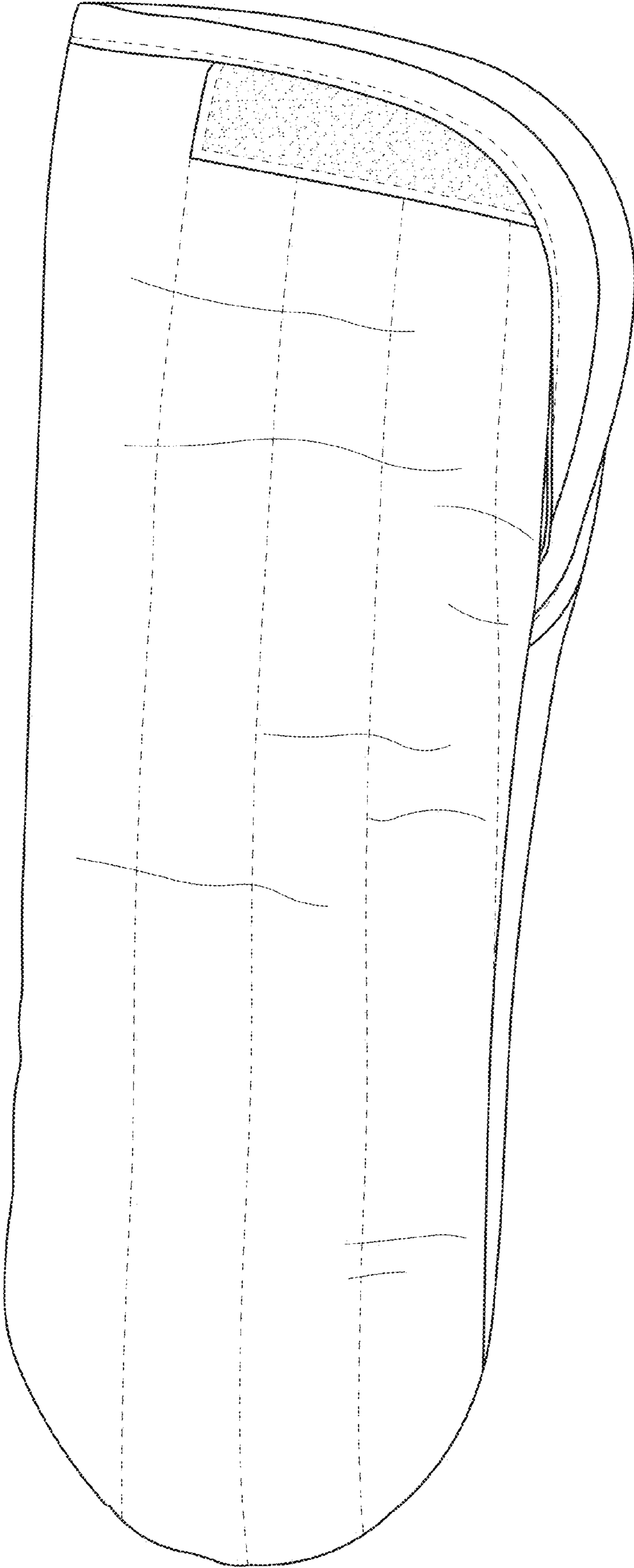

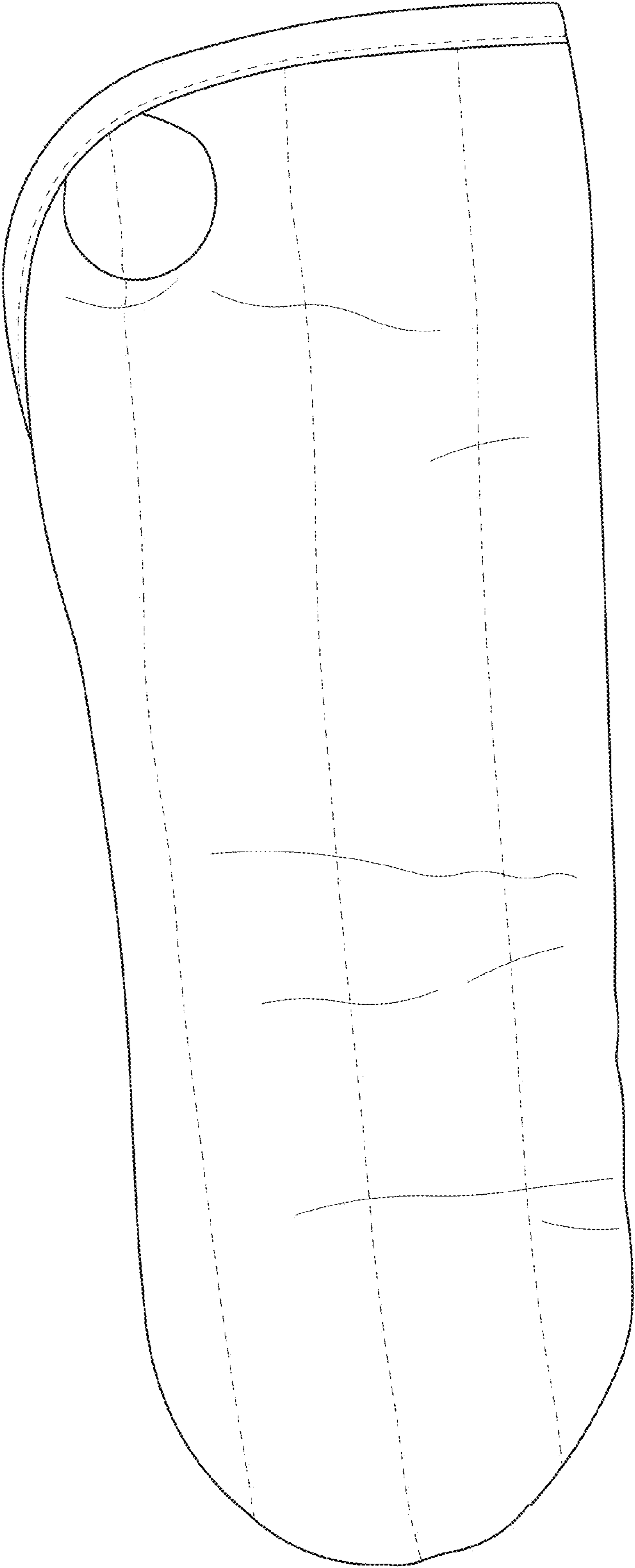

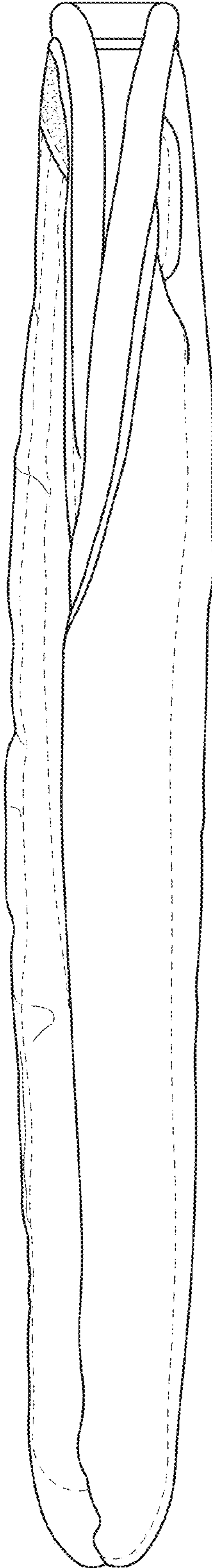

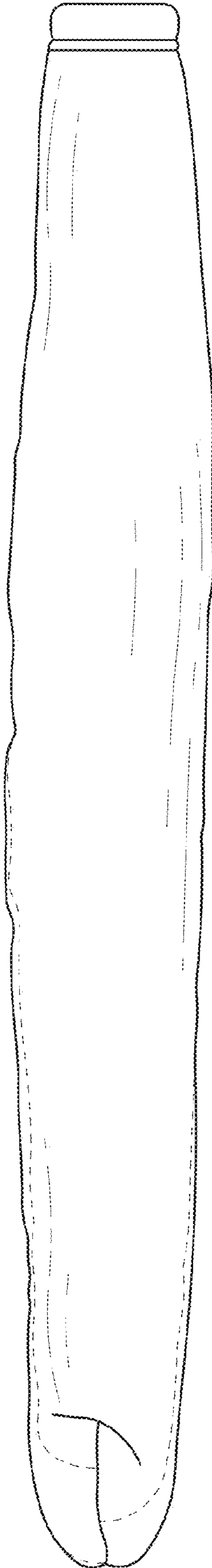

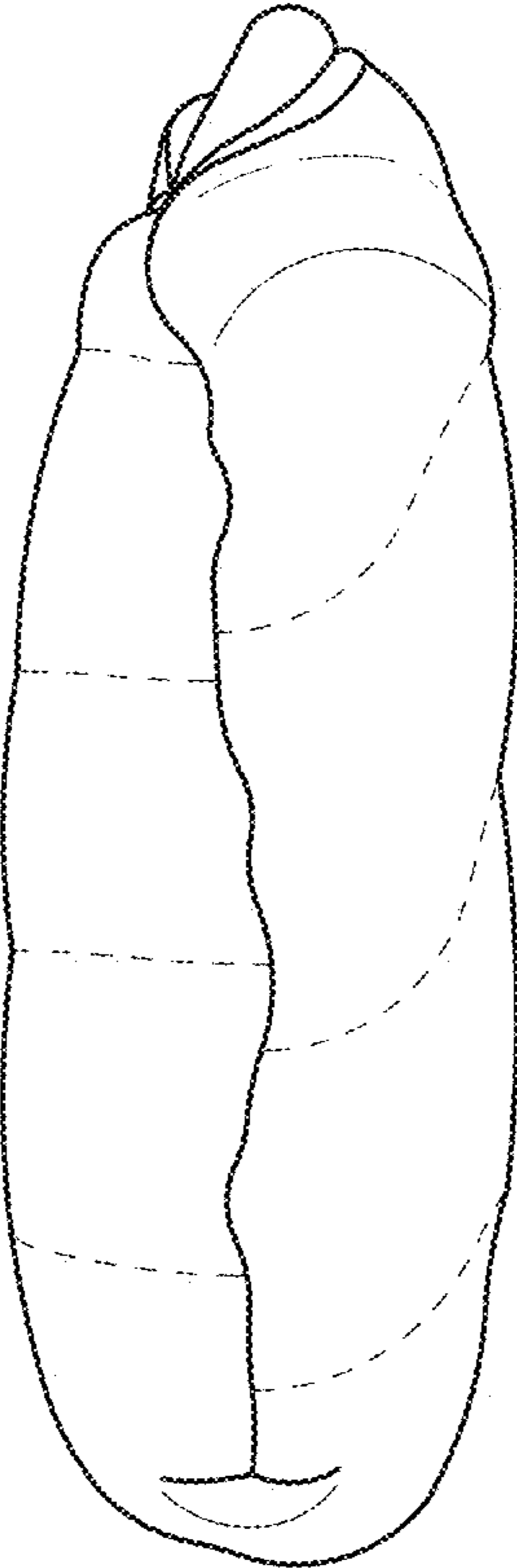

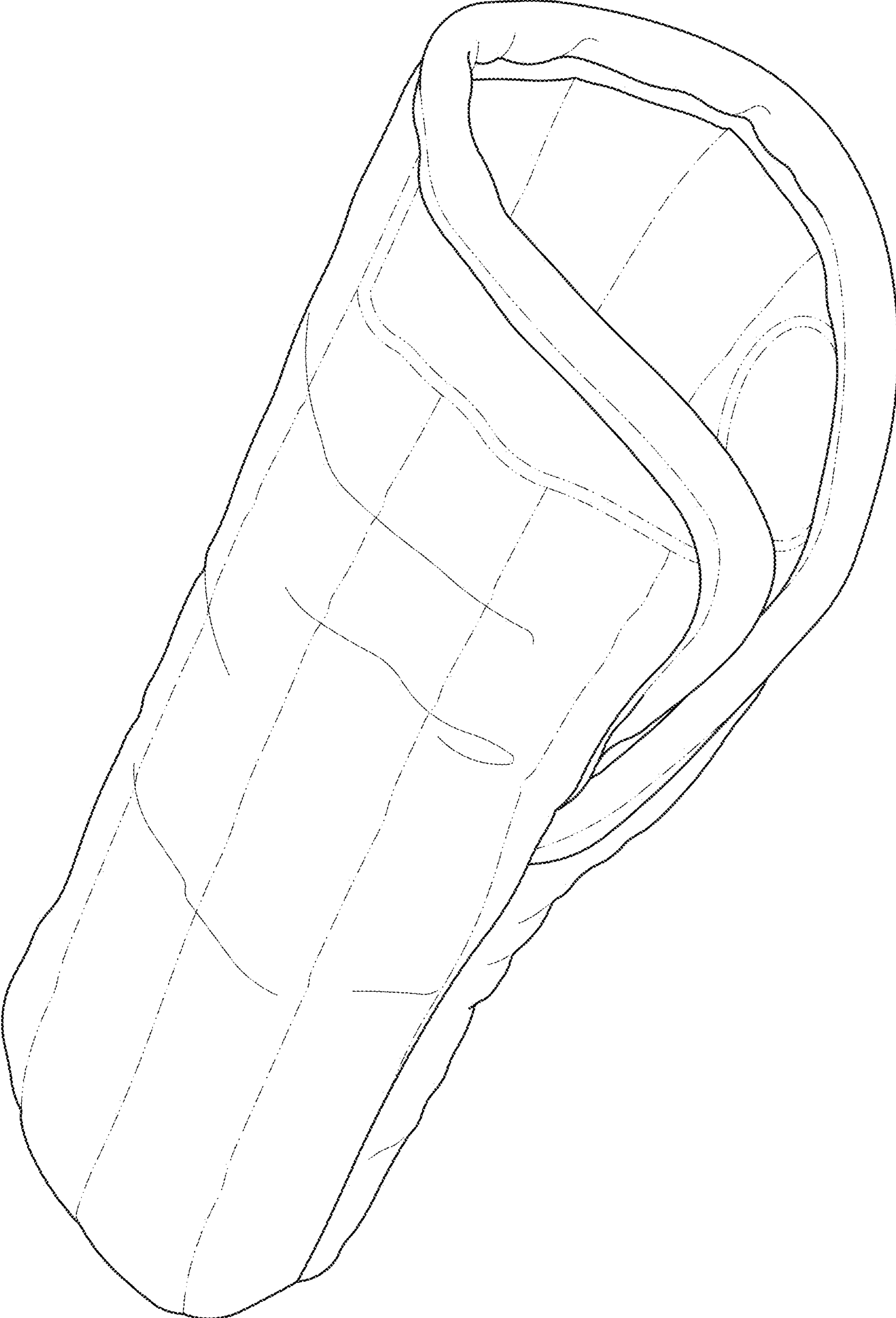

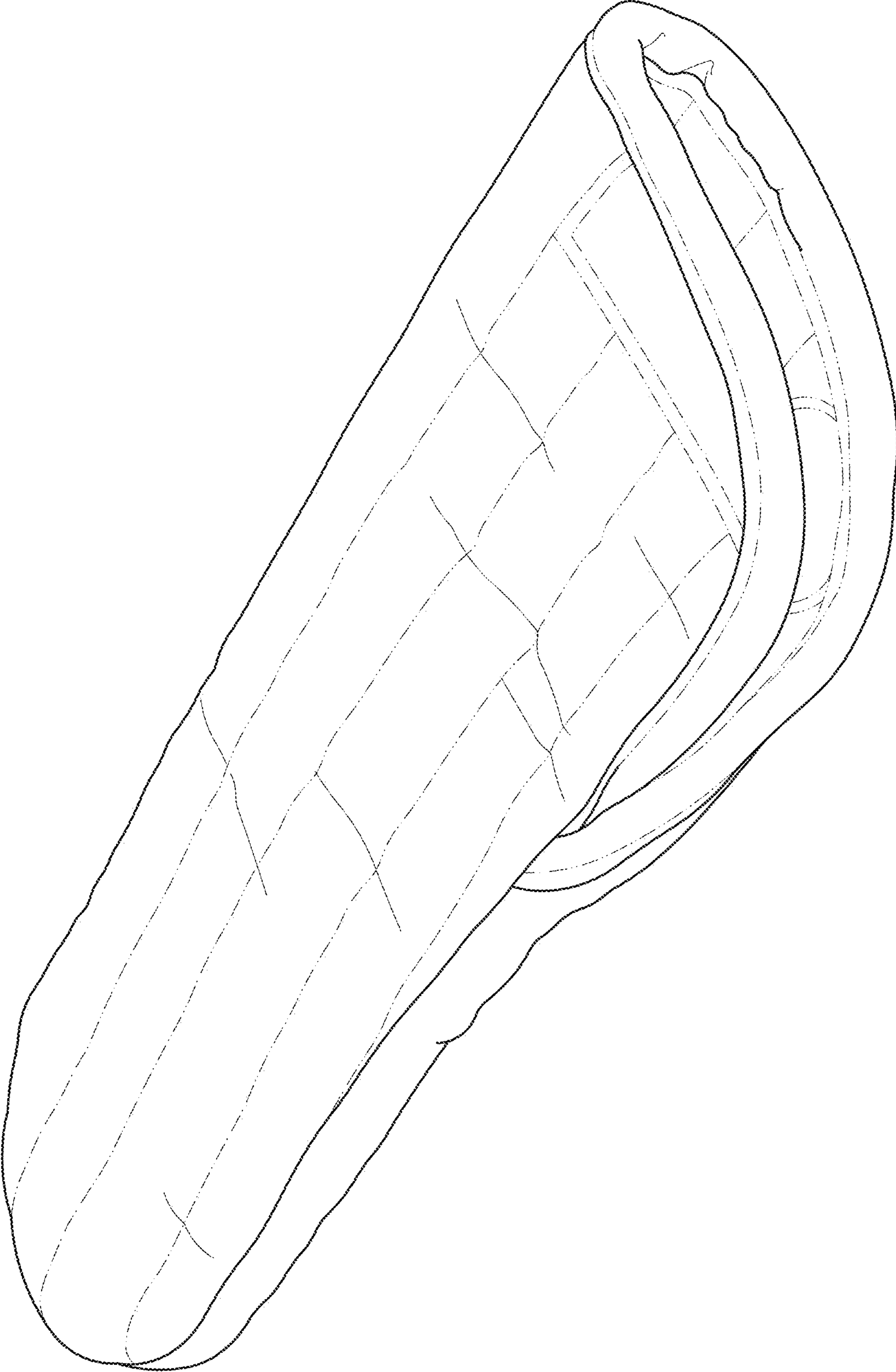

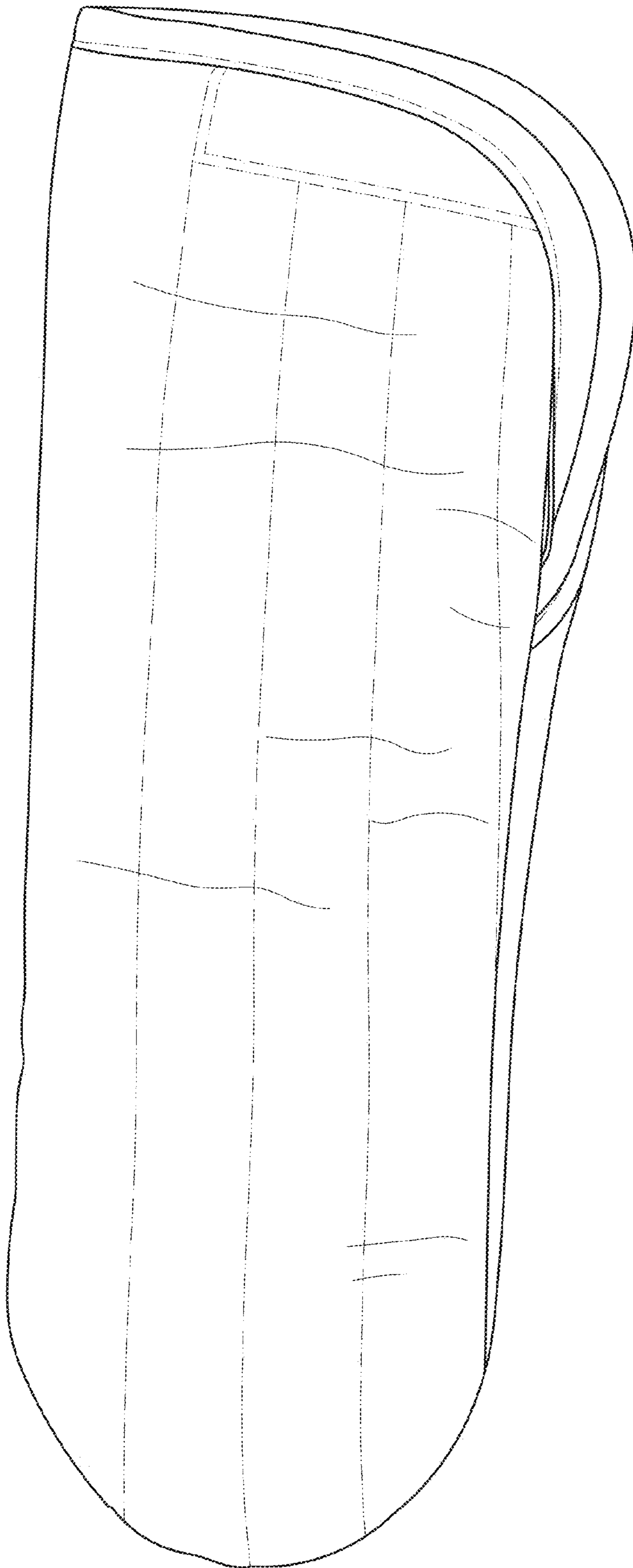

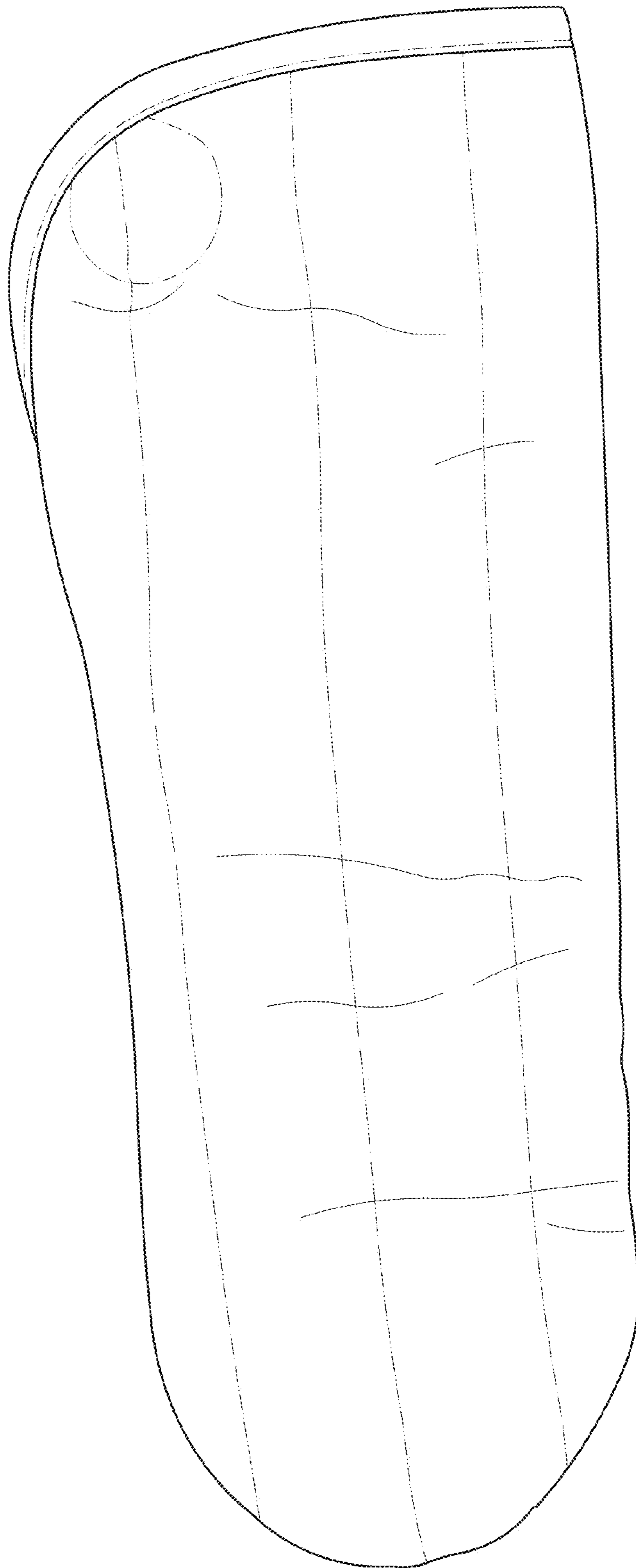

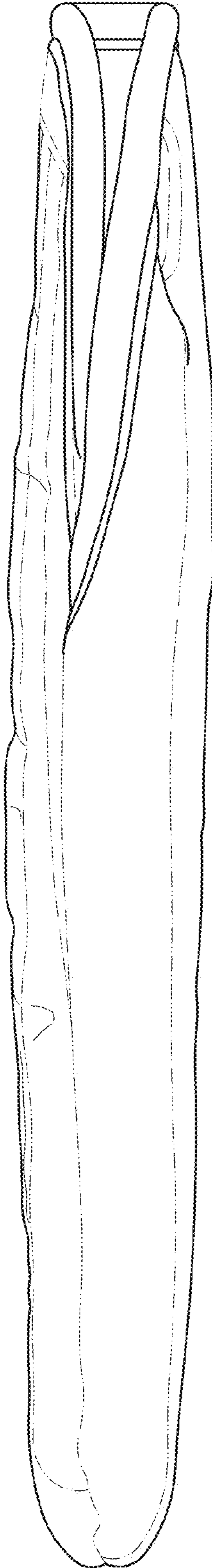

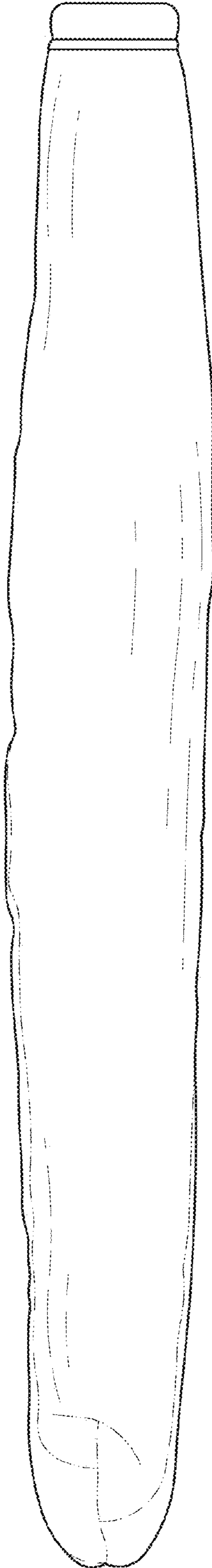

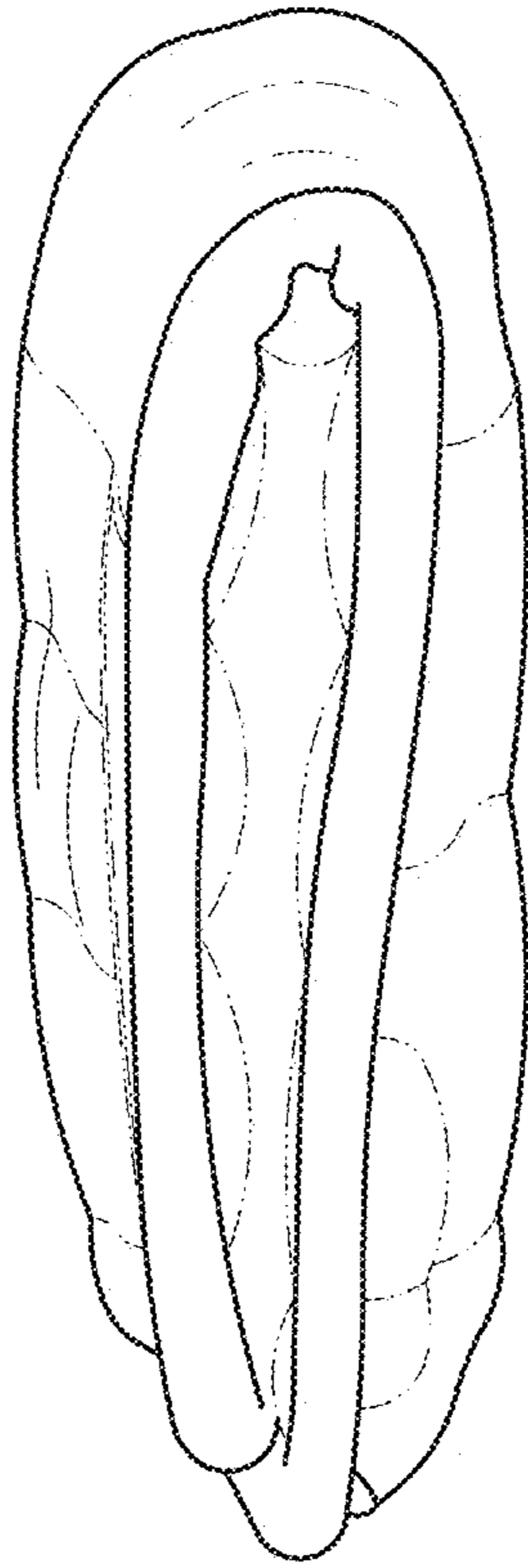

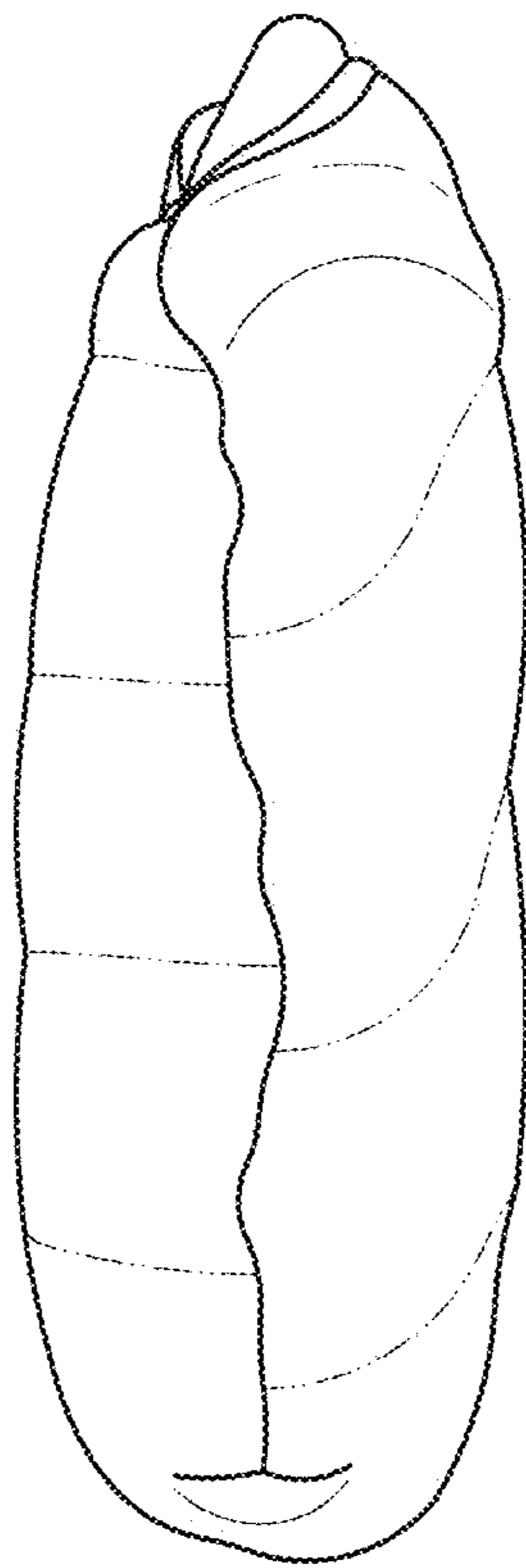
