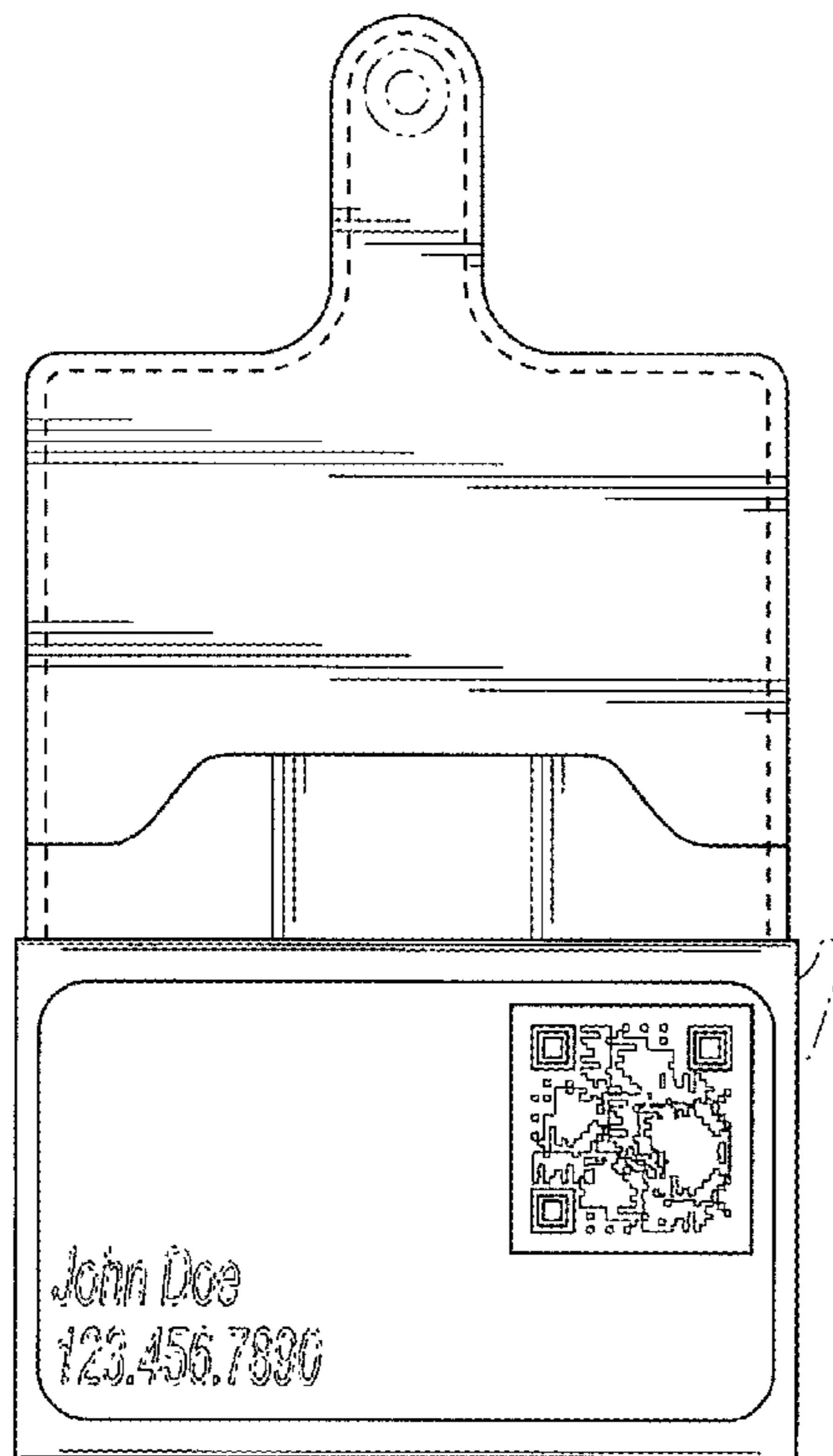
(57) **CLAIM**

We claim the ornamental design for a wallet, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a wallet of the present invention; FIG. 2 is a rear view of the wallet; FIG. 3 is a front view of the wallet in its opened position; FIG. 4 is a rear view of the wallet in its opened position; FIG. 5 is a left side view of the wallet; FIG. 6 is a right side view of the wallet; FIG. 7 is a top view of the wallet; FIG. 8 is a bottom view of the wallet; FIG. 9 is a perspective view of the wallet in its opened position; and, FIG. 10 is another perspective view of the wallet. The dot-dashed broken lines representing elements of the wallet are for the purposes of illustrating unclaimed portions of the claimed design. The evenly spaced broken lines represent stitching and are part of the claimed design.

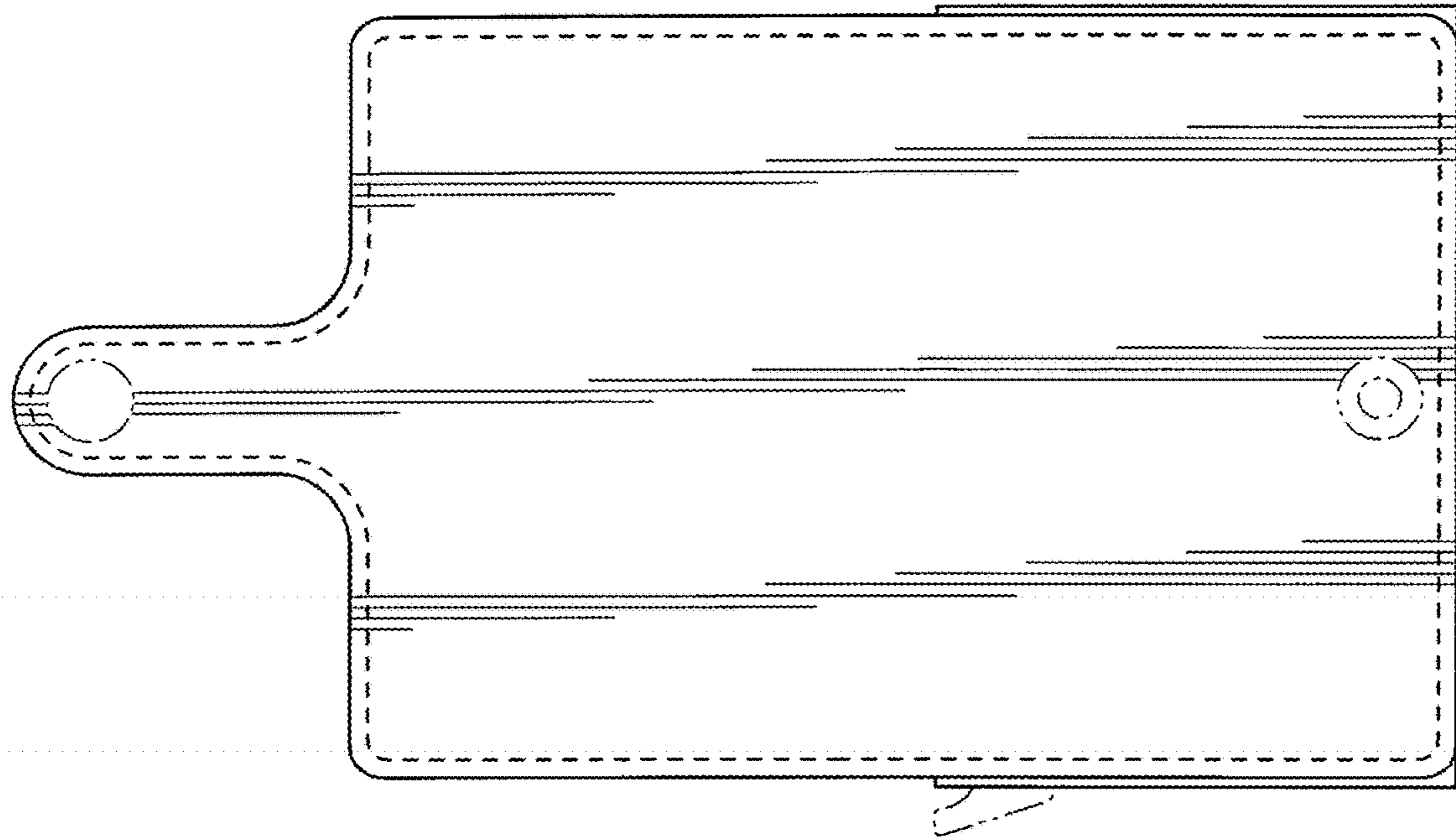

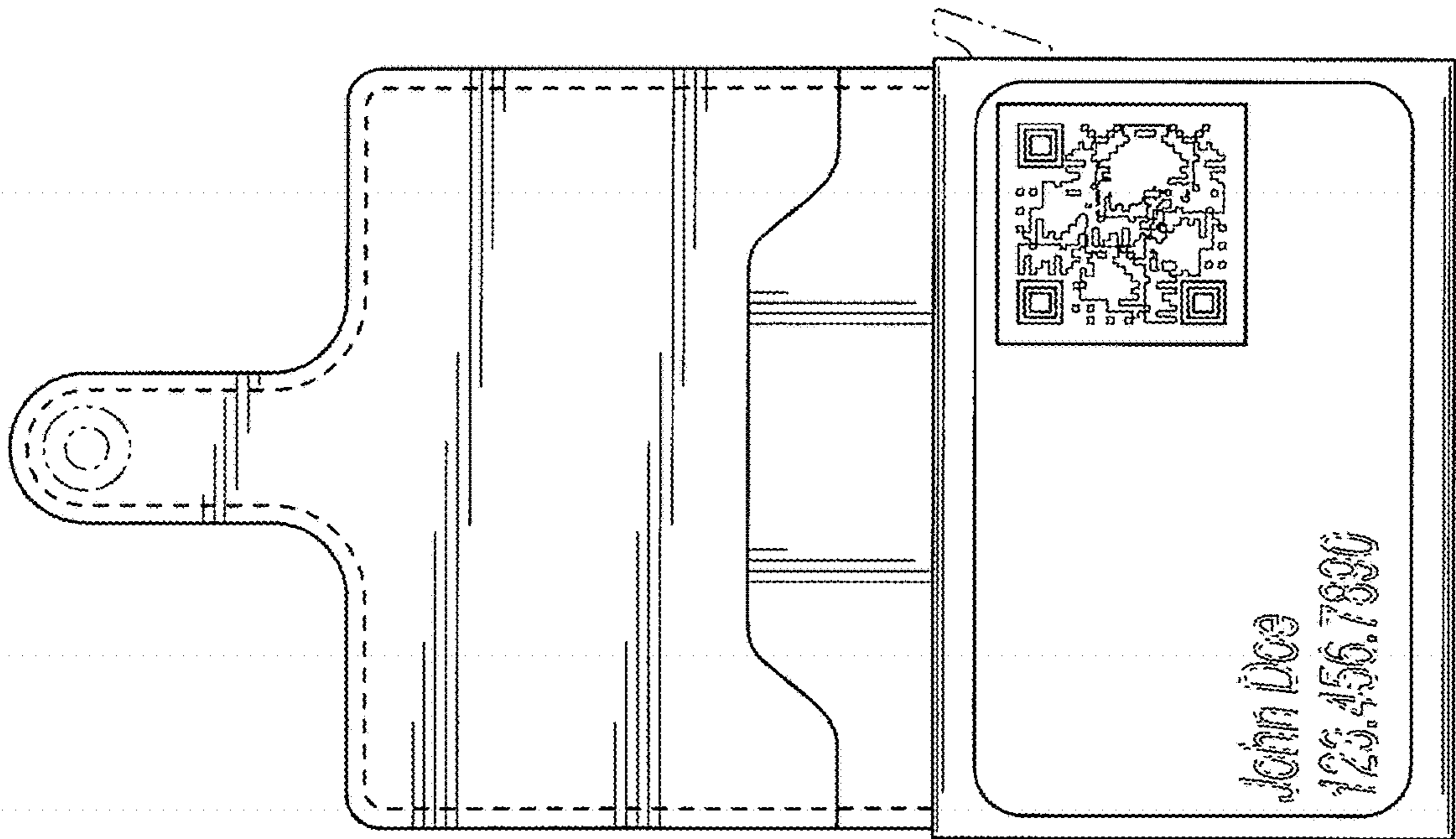

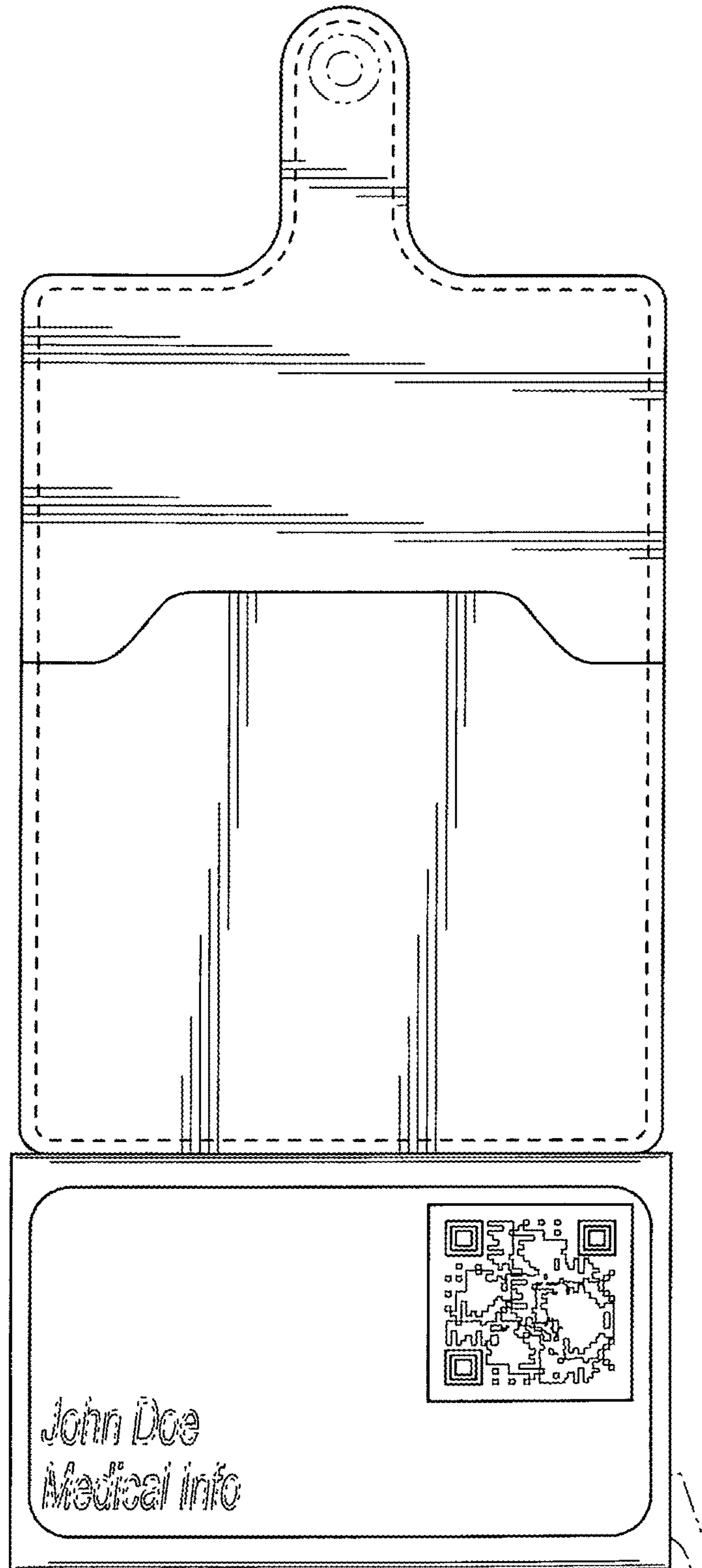

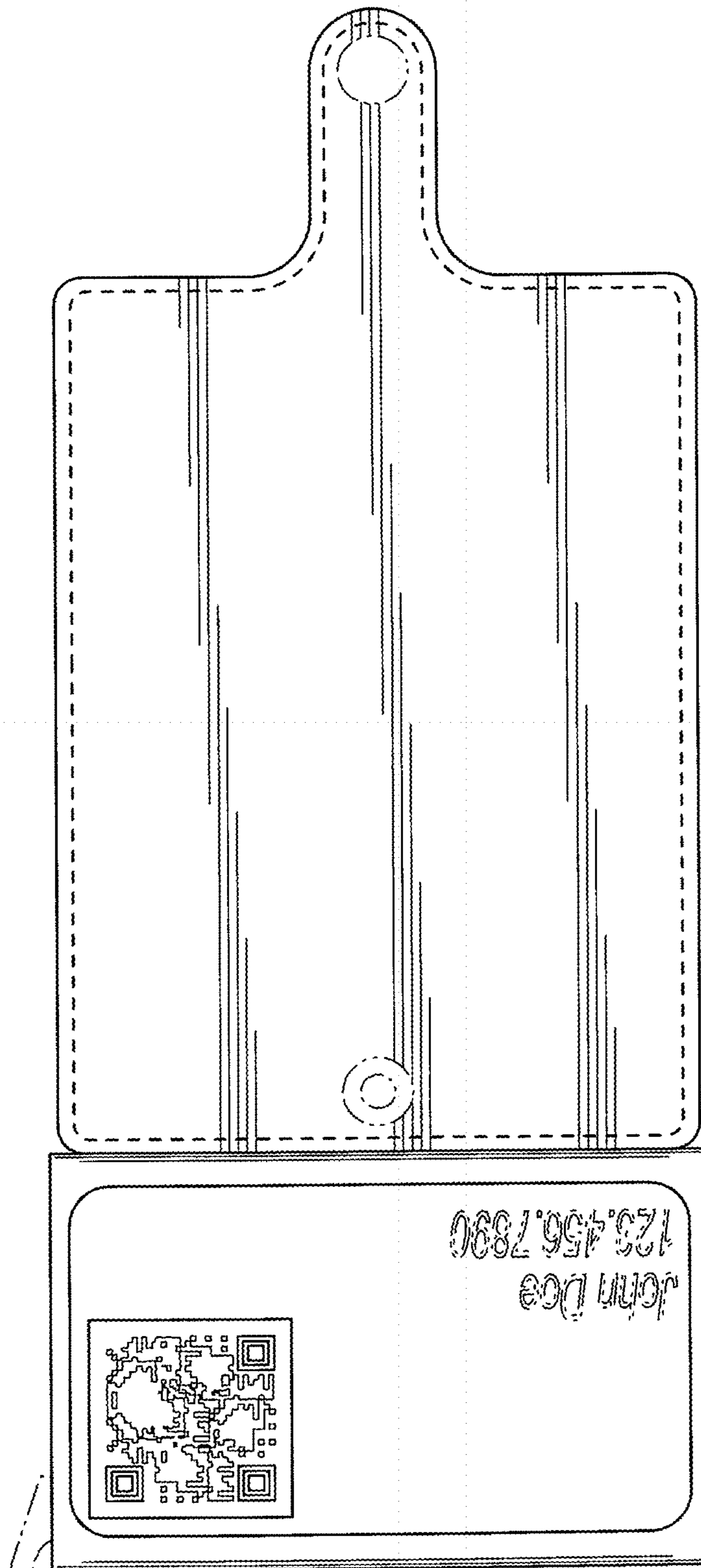

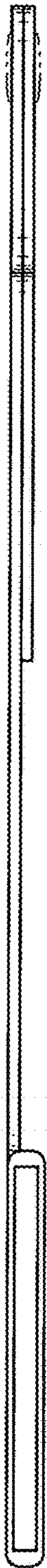

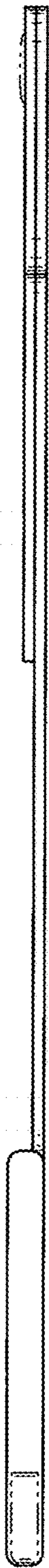

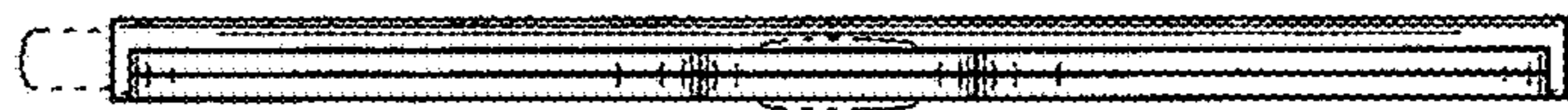

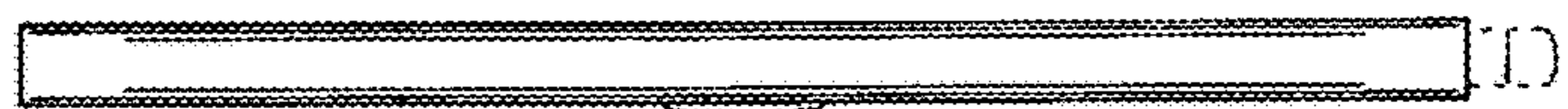

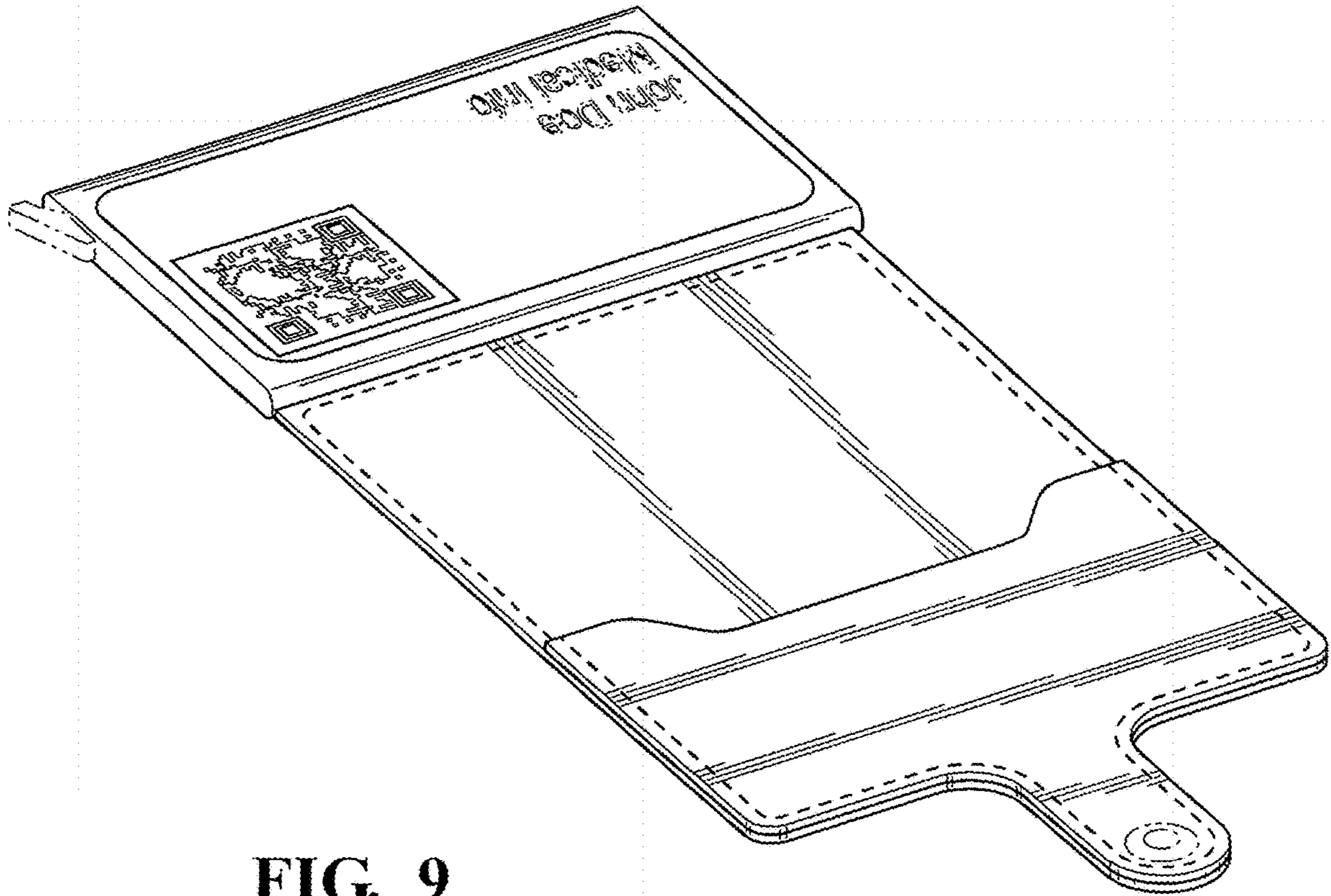

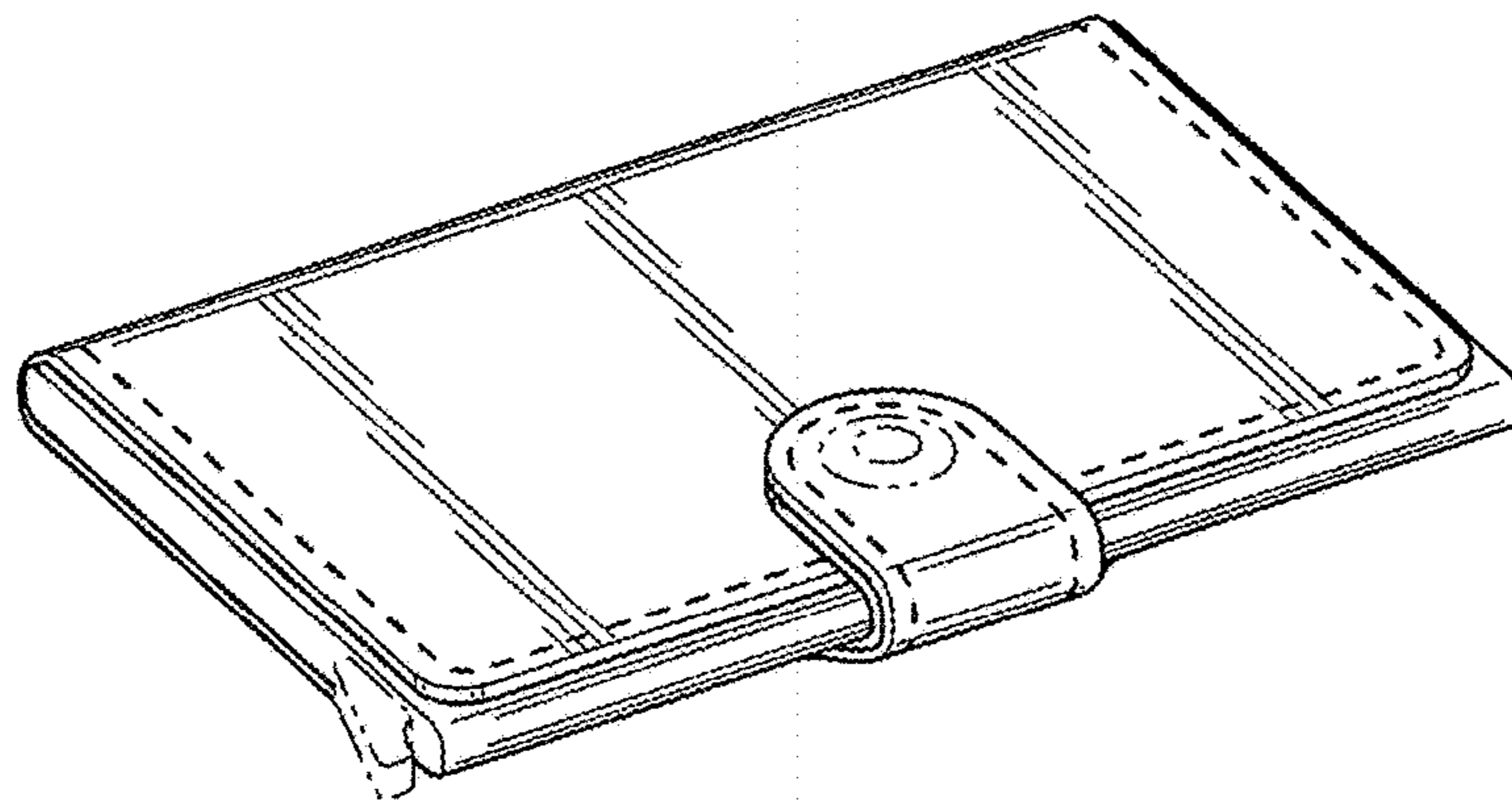
