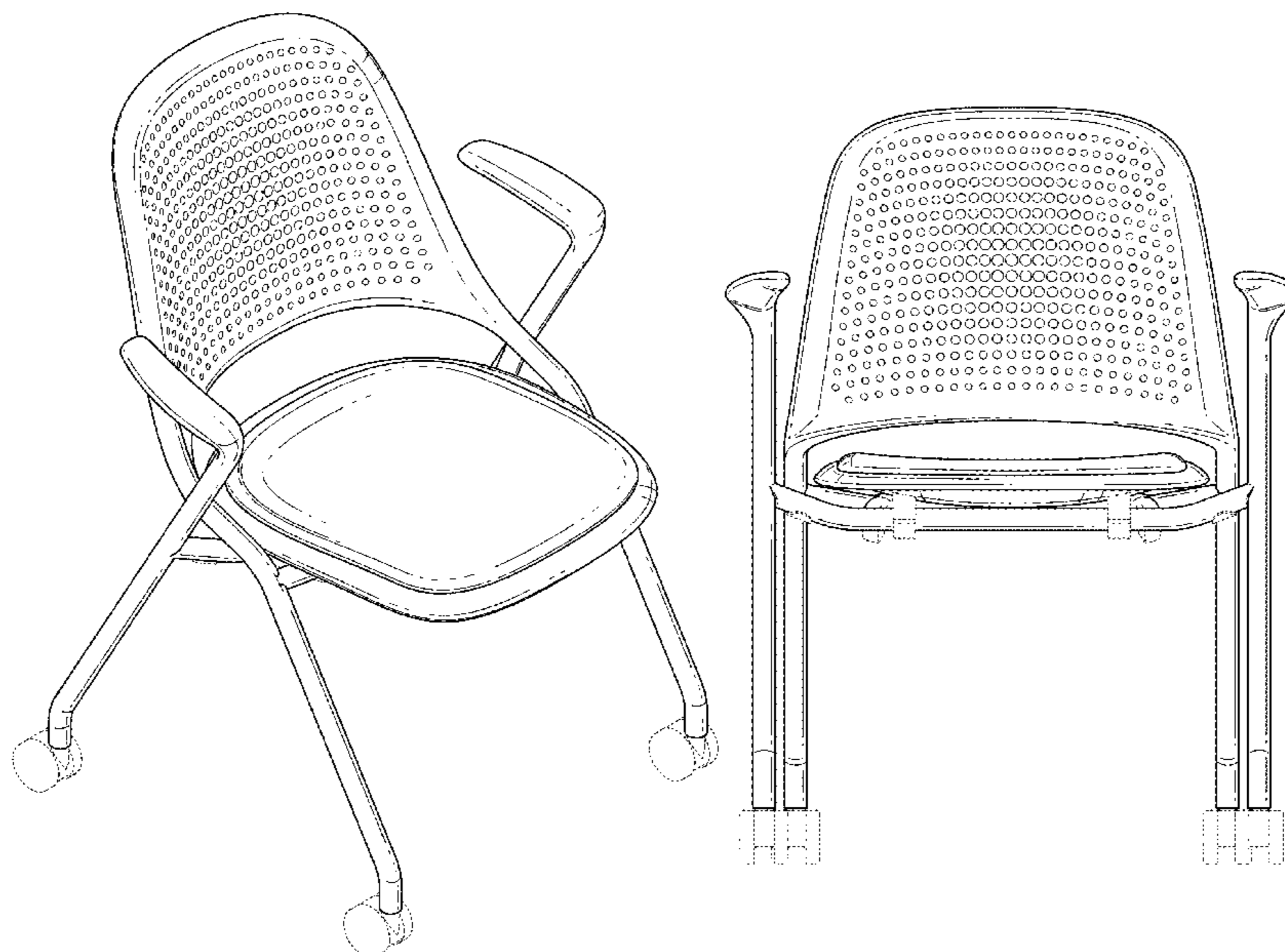
(57) **CLAIM**

We claim the ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a chair, showing our new design;
FIG. 2 is front view of the chair thereof;
FIG. 3 is a rear view of the chair thereof;
FIG. 4 is a right side view of the chair thereof, the left side view is a mirror image of the right side view of FIG. 4;
FIG. 5 is a top view of the chair thereof; and,
FIG. 6 is a bottom view of the chair thereof.

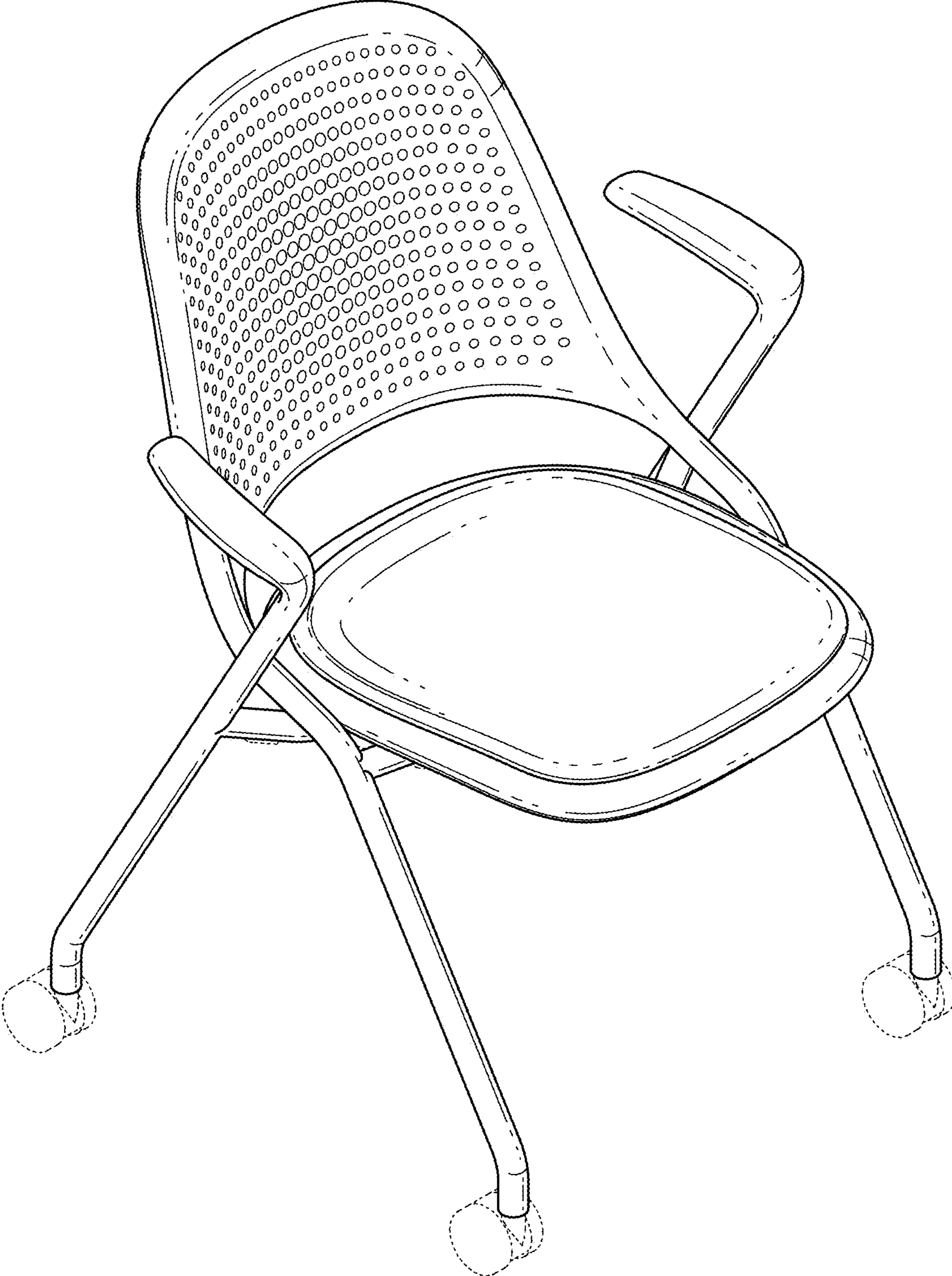

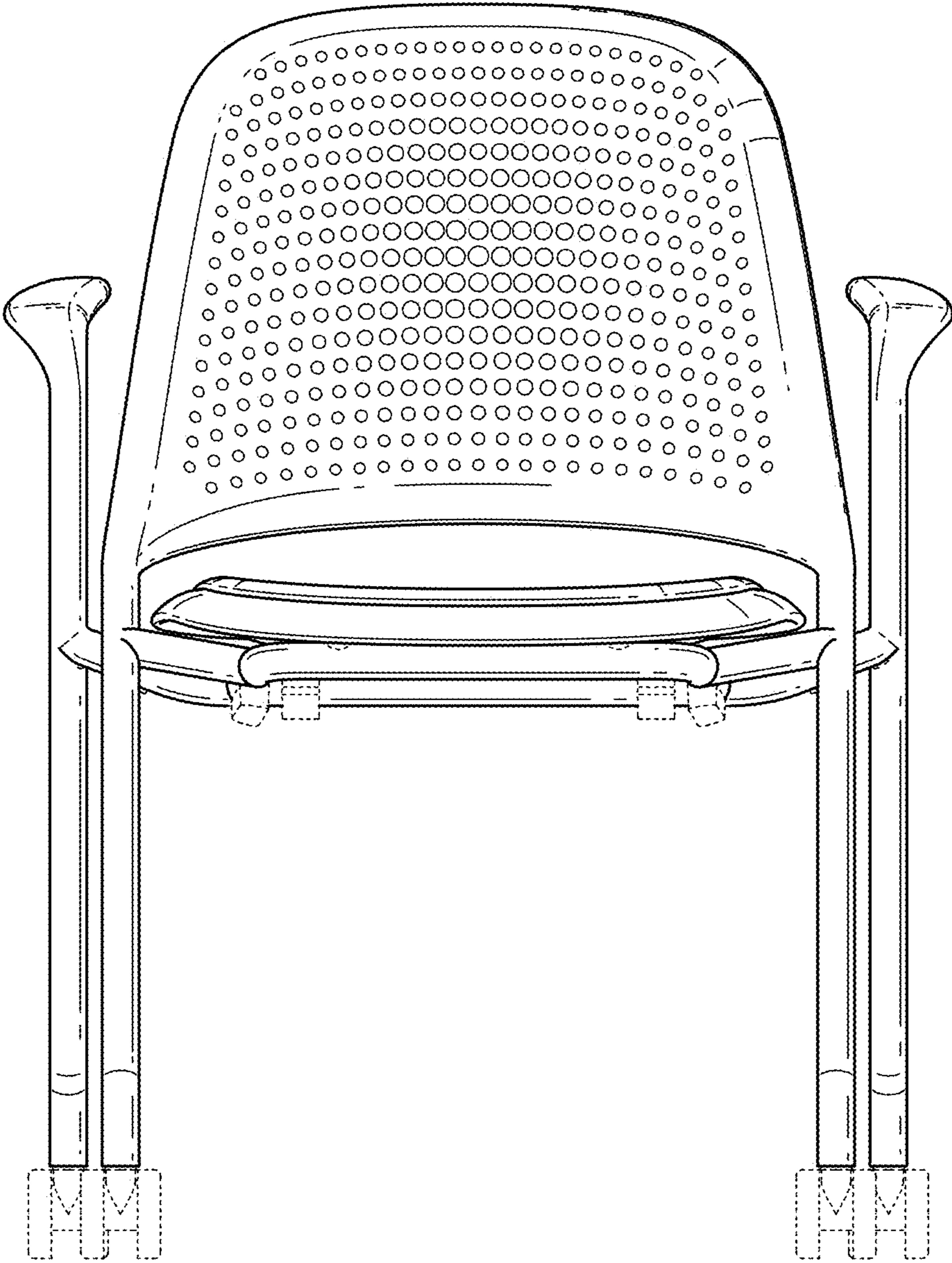

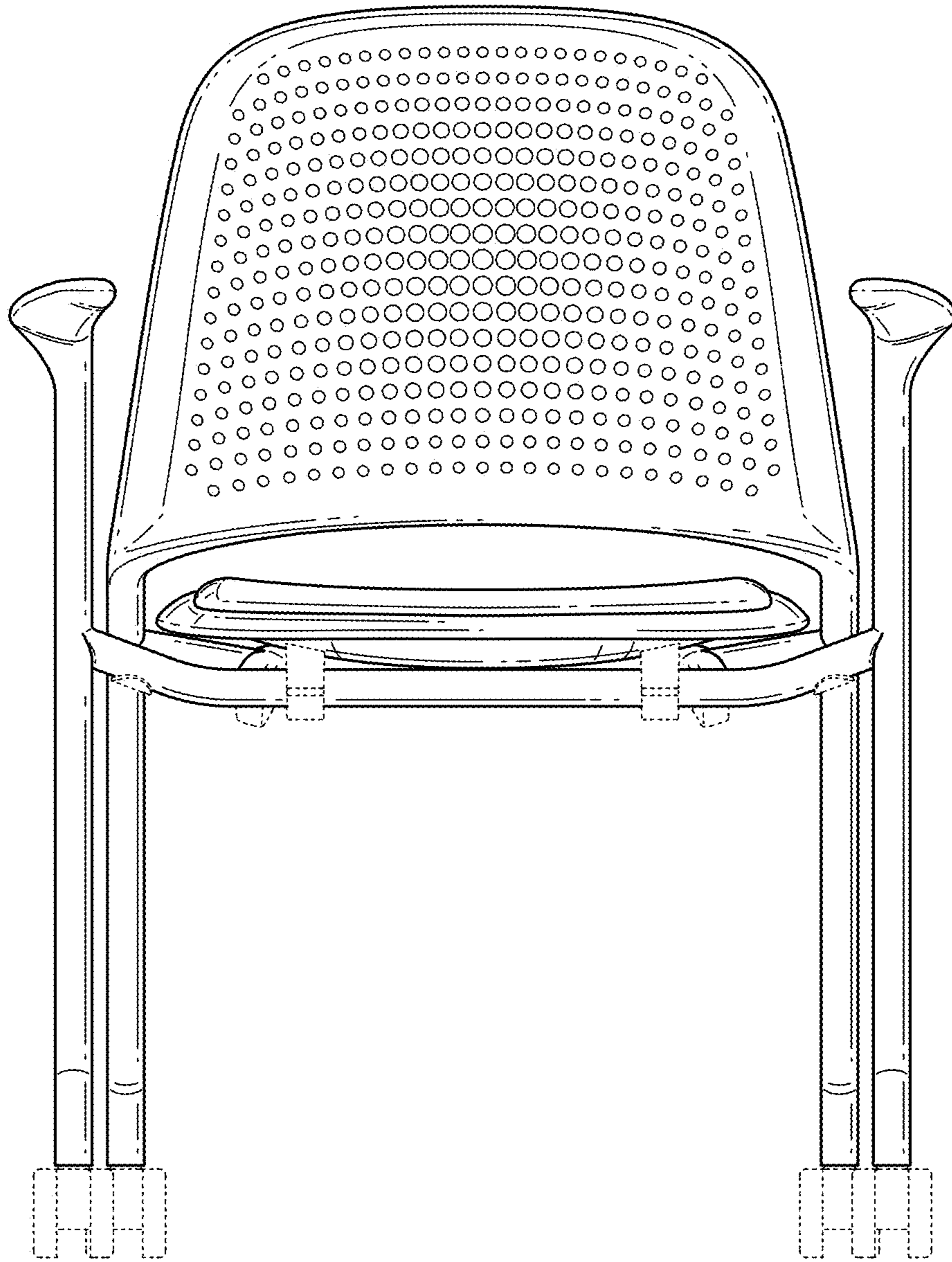

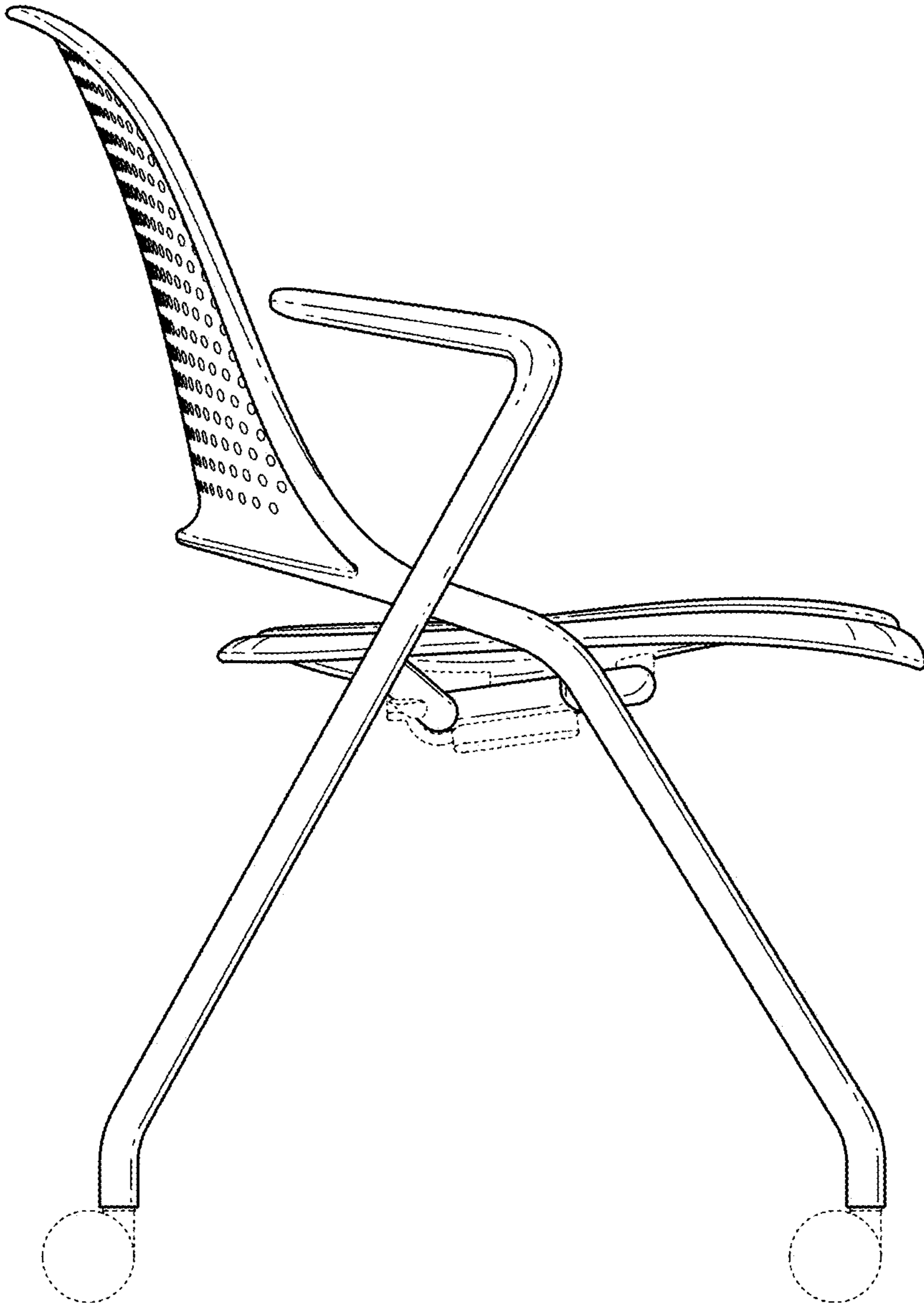

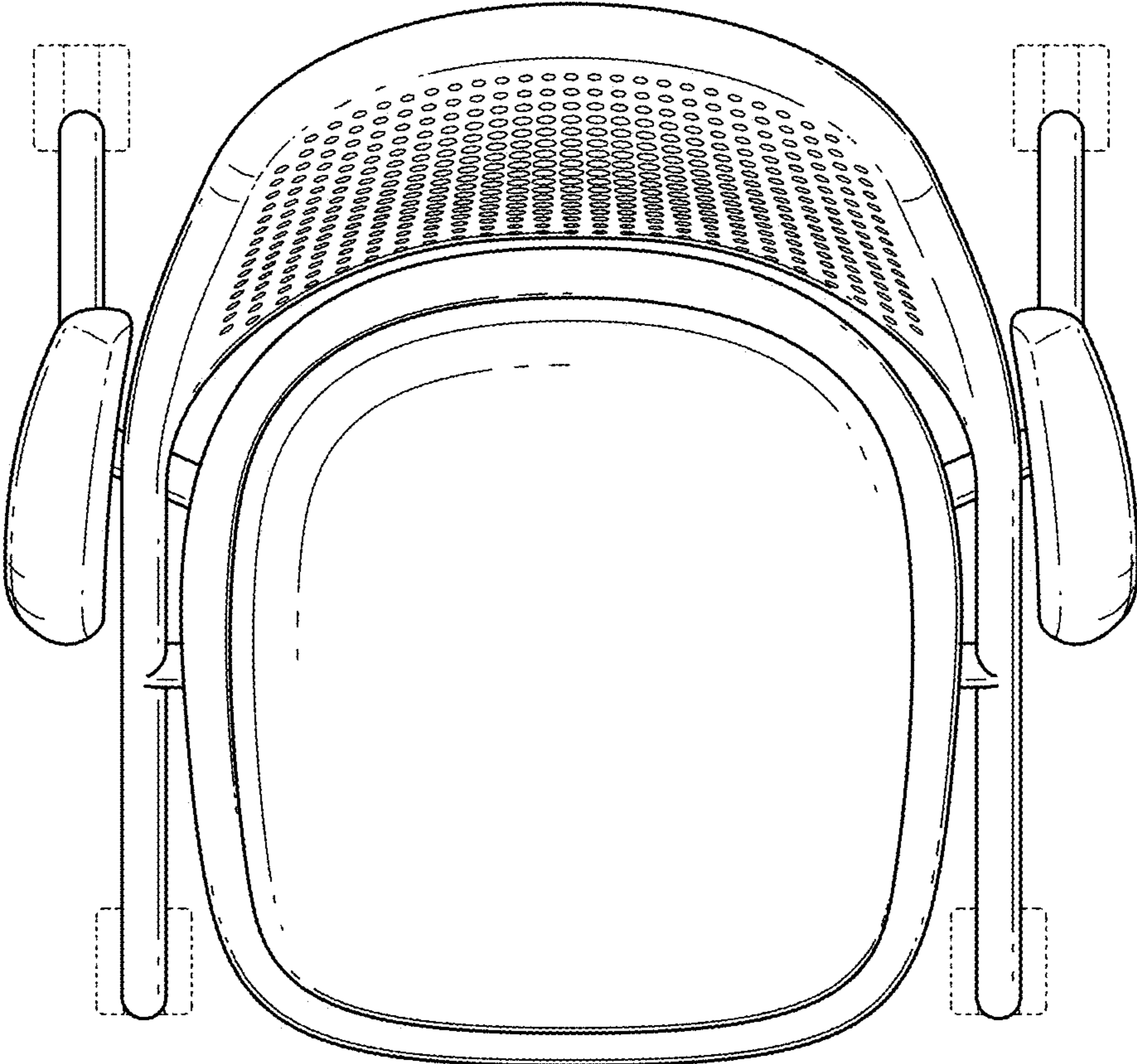

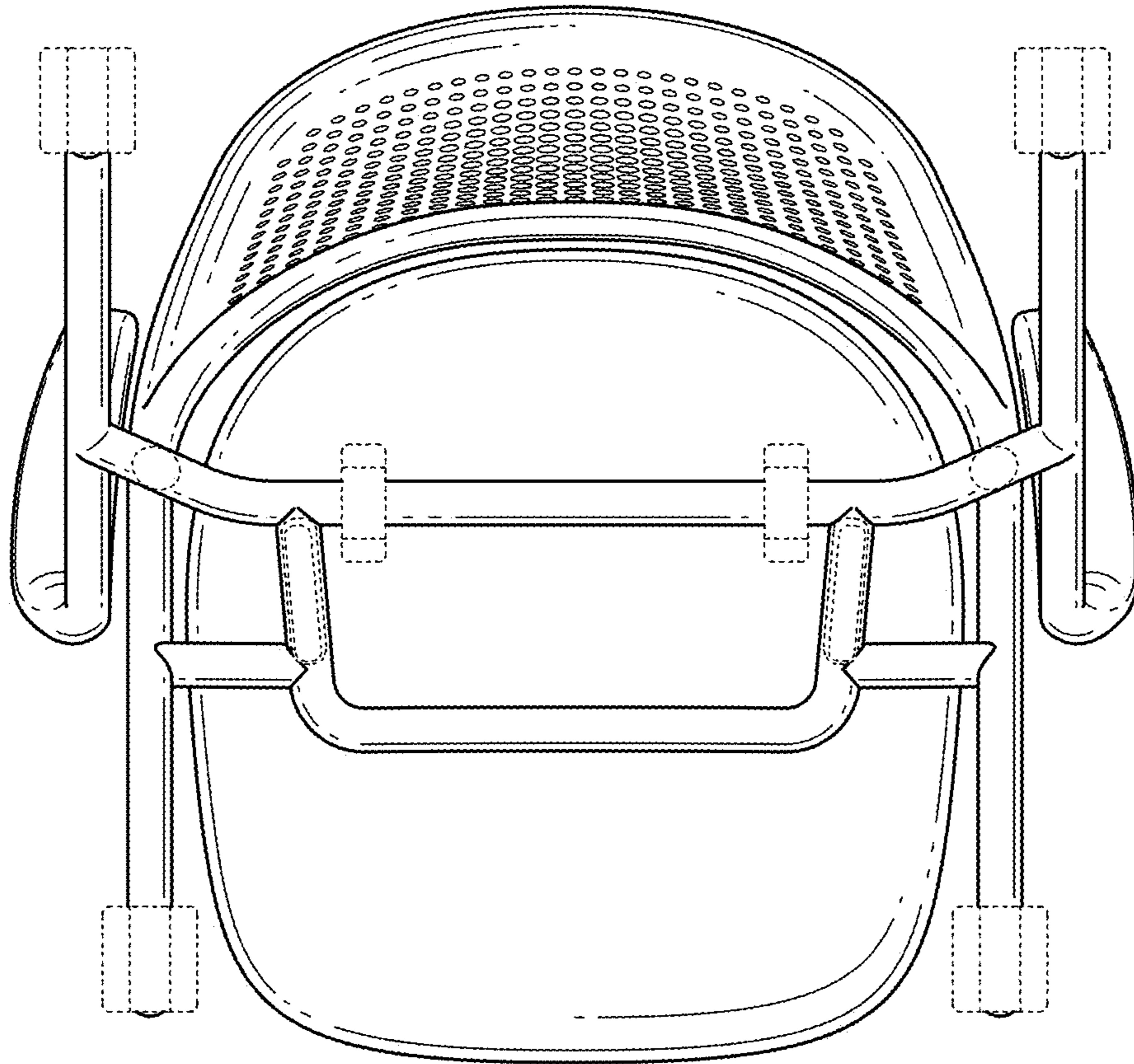
