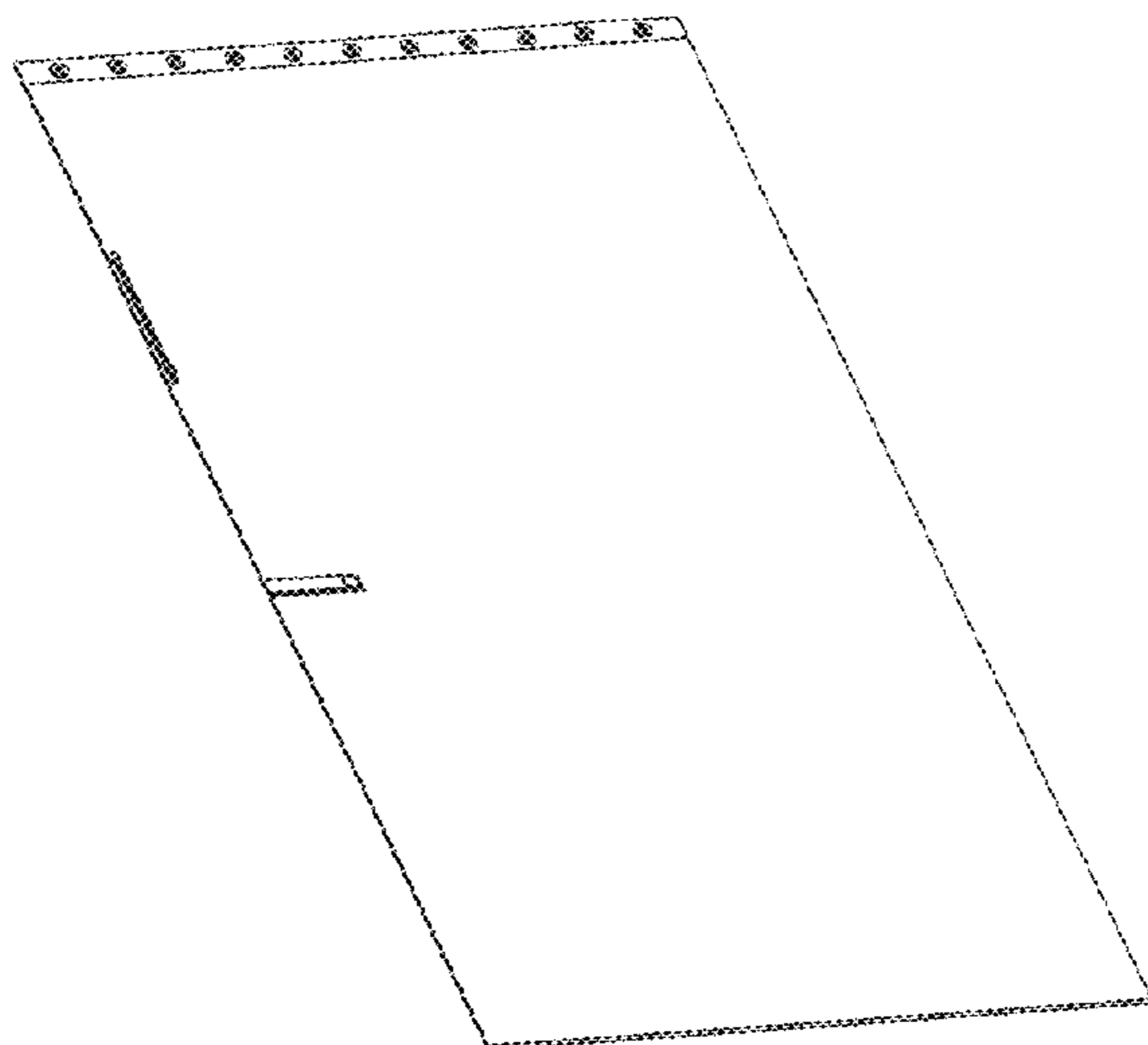
(57) **CLAIM**

We claim the ornamental design for a travel scarf blanket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an travel scarf blanket; FIG. 2 is a left-side view of the travel scarf blanket of FIG. 1; FIG. 3 is a right-side view of the travel scarf blanket of FIG. 1; FIG. 4 is a front view of the travel scarf blanket of FIG. 1; FIG. 5 is a back view of the travel scarf blanket of FIG. 1; FIG. 6 is a top view of the travel scarf blanket of FIG. 1; FIG. 7 is a bottom view of the travel scarf blanket of FIG. 1; FIG. 8 is a perspective view of the travel scarf blanket of FIG. 1, showing the design used as a travel scarf; FIG. 9 is another perspective view thereof, showing the design used as a travel scarf; and, FIG. 10 is a perspective view of the travel scarf blanket of FIG. 1, showing the design used as a blanket. Broken lines illustrate environmental features and form no part of the claimed design.

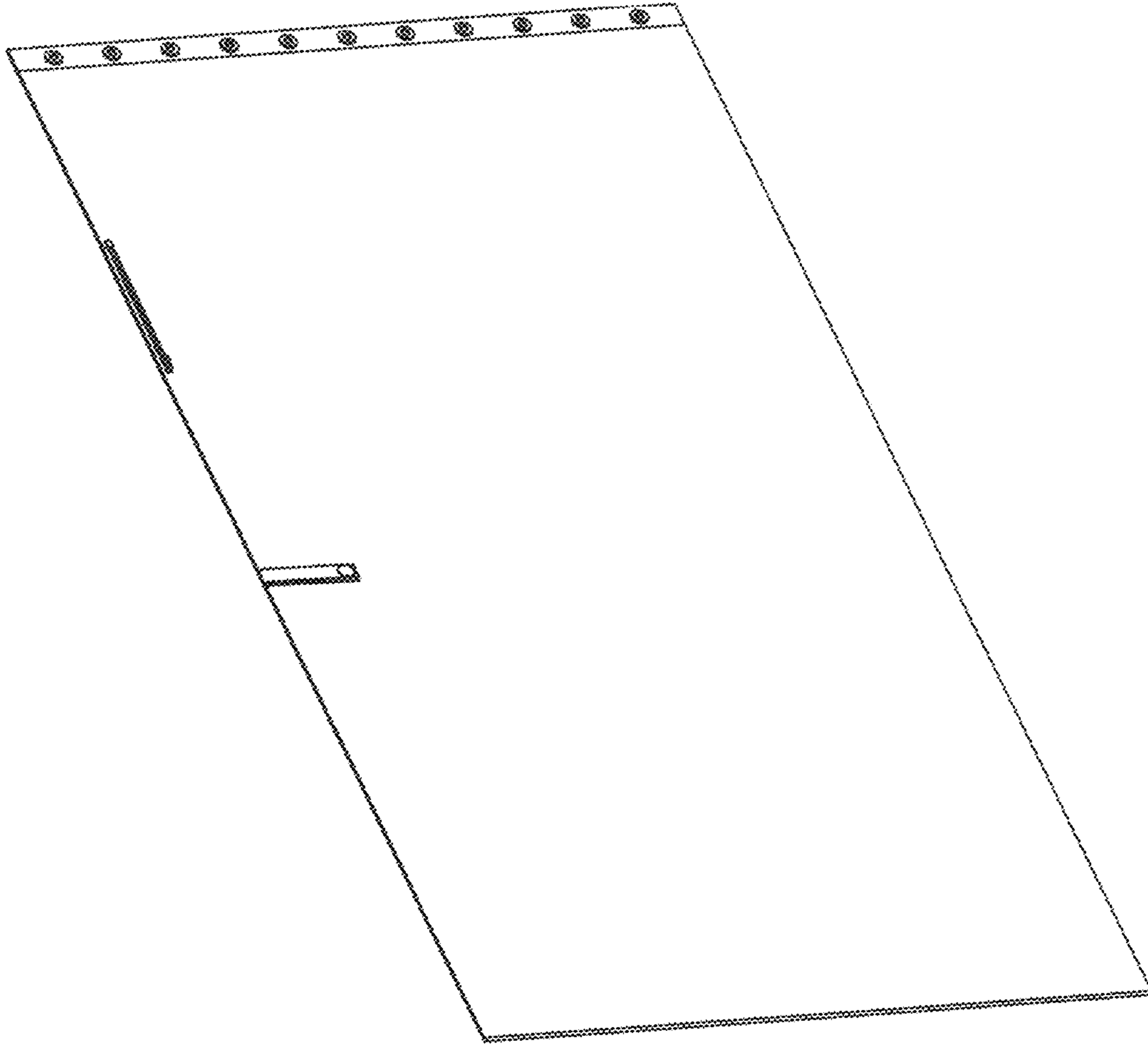

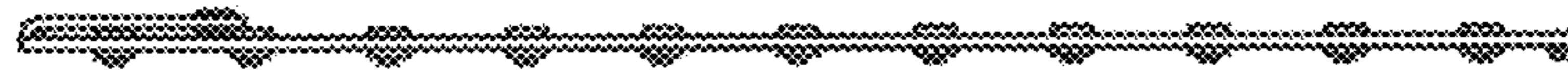

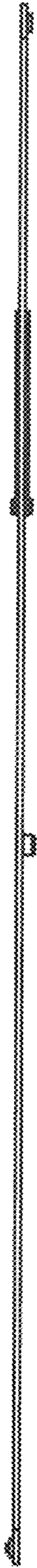

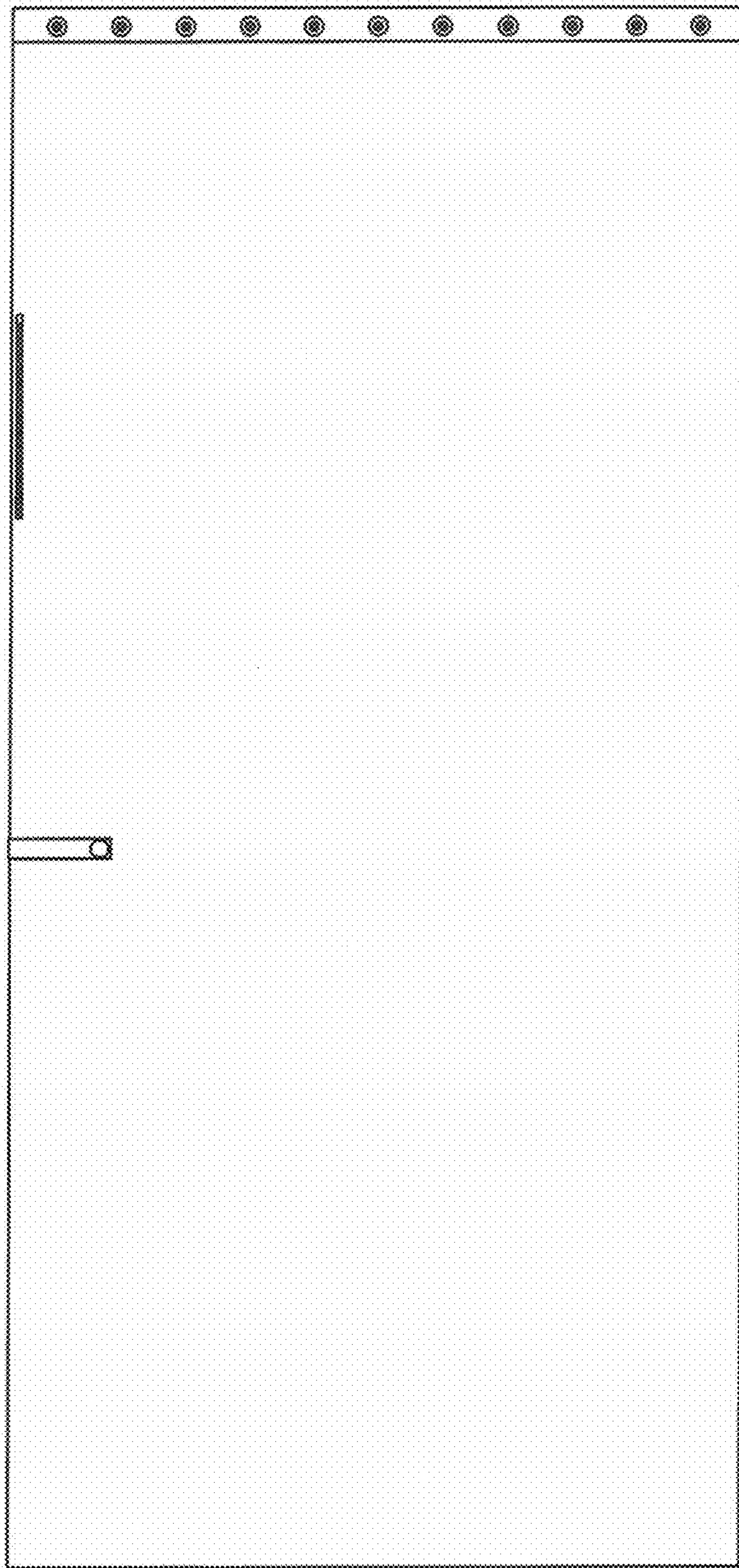

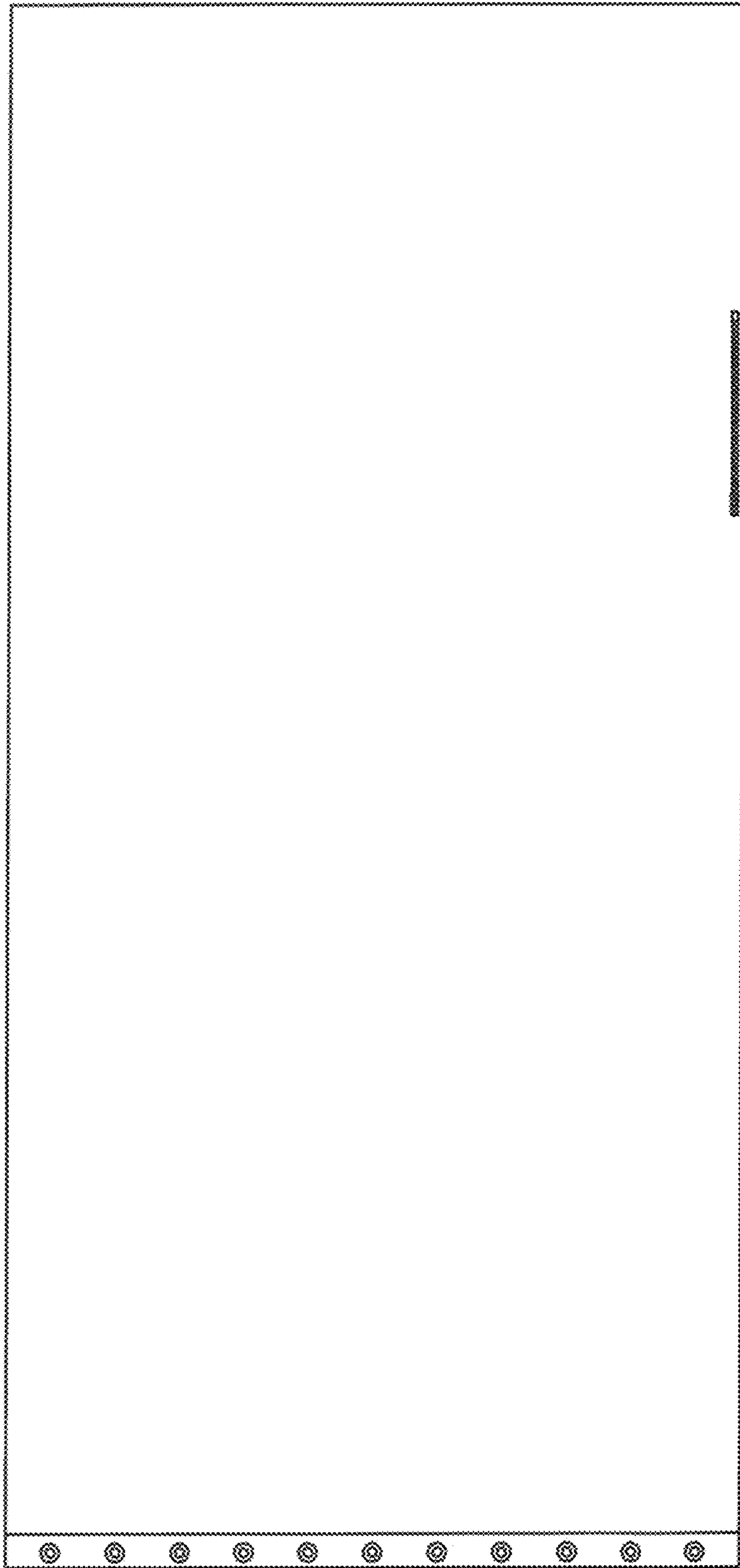

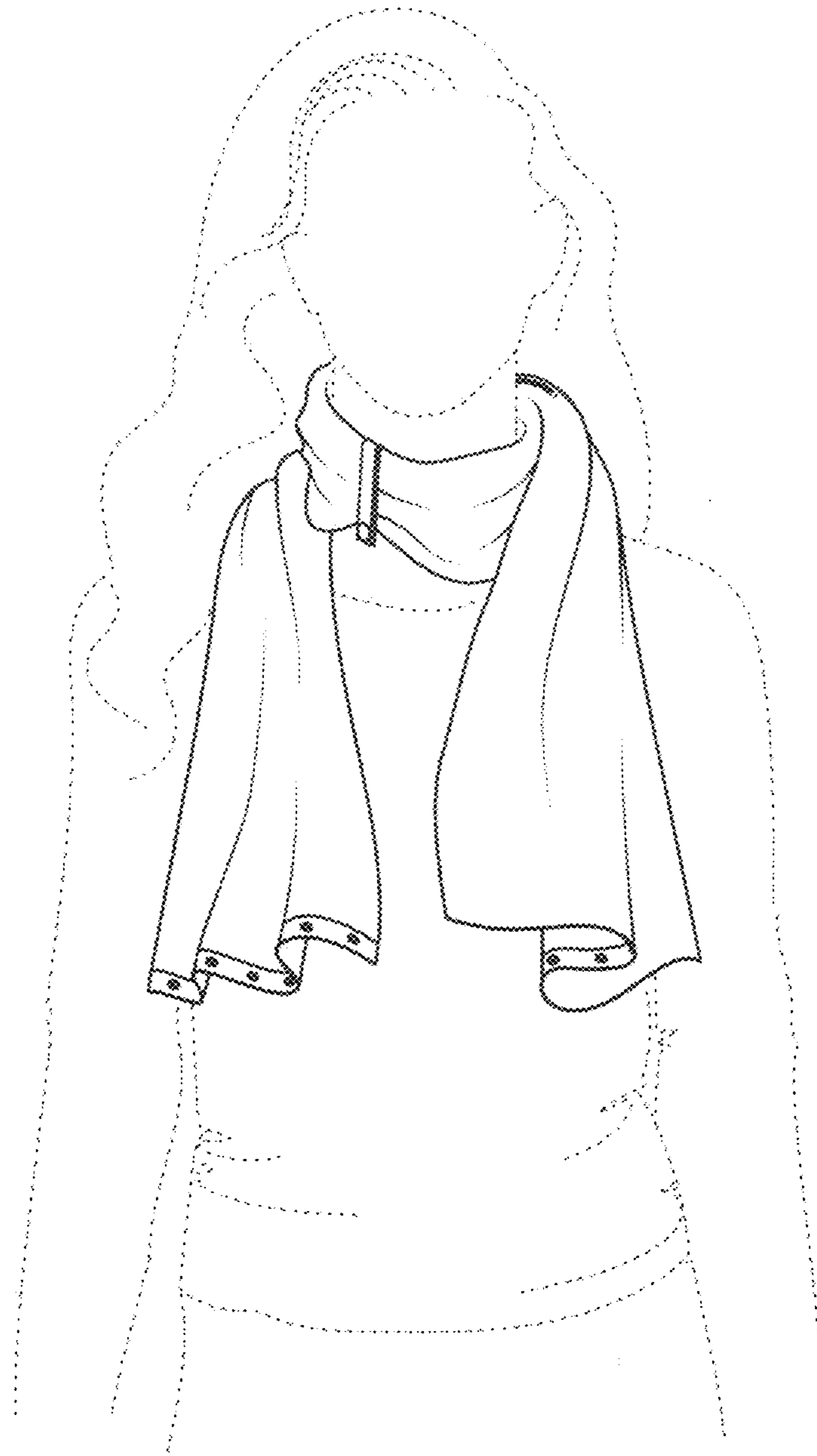

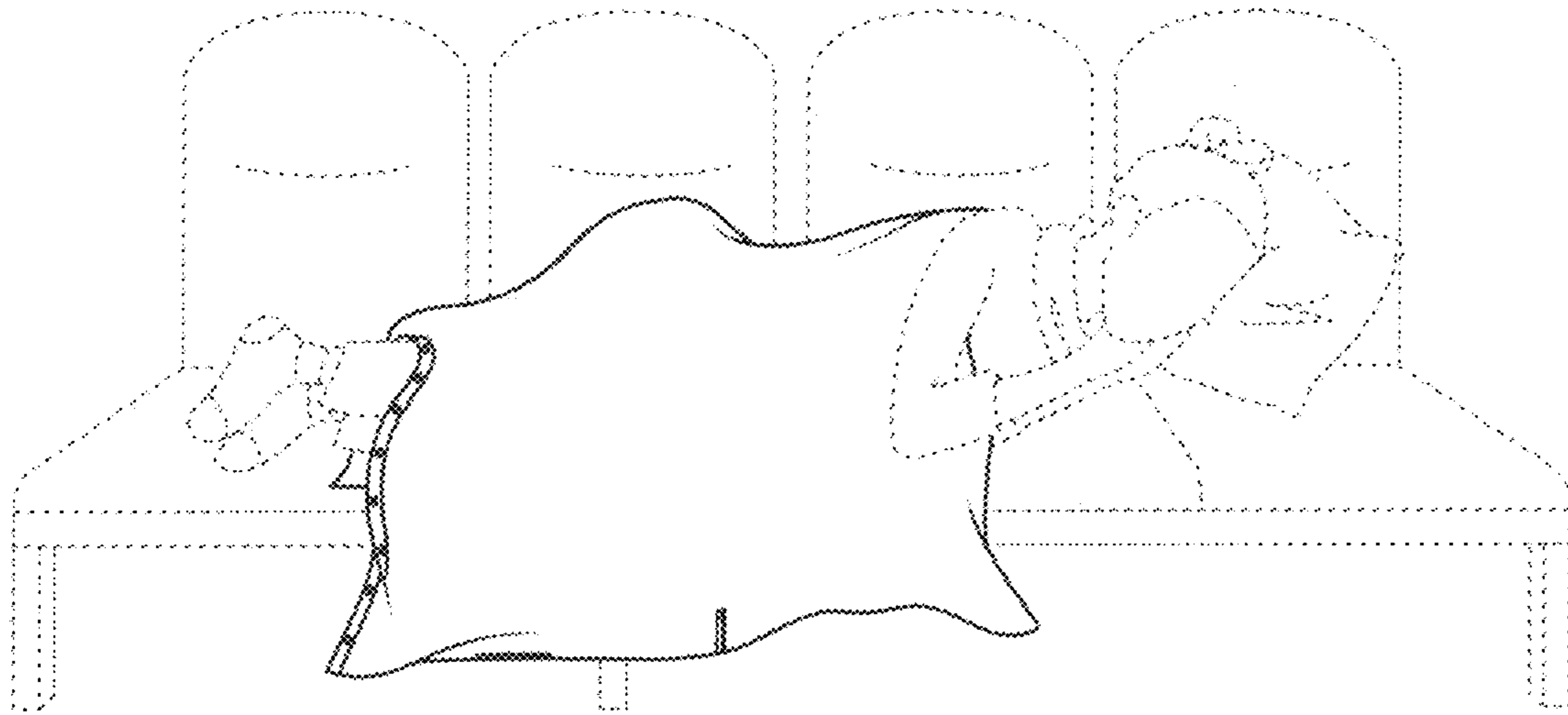
