FIG. 2 is a back view of the claimed design.

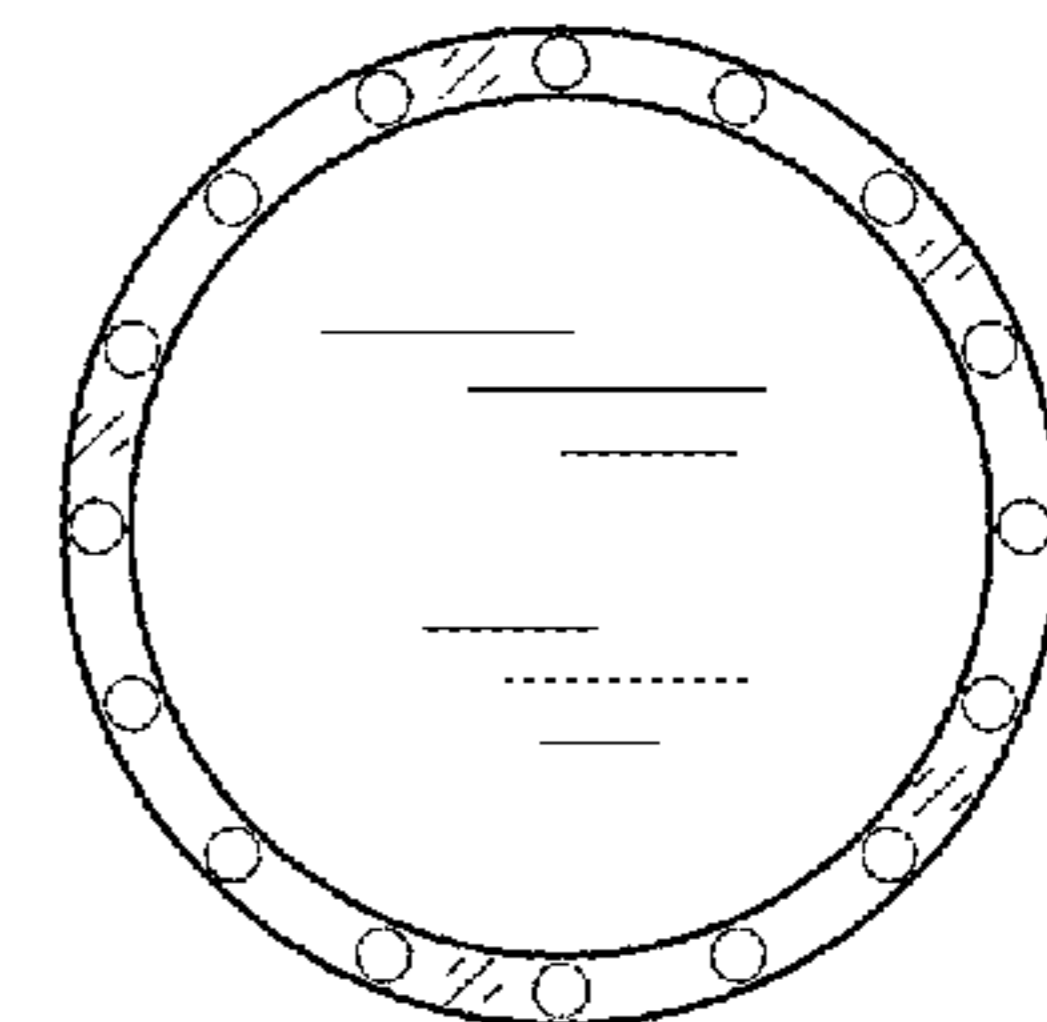
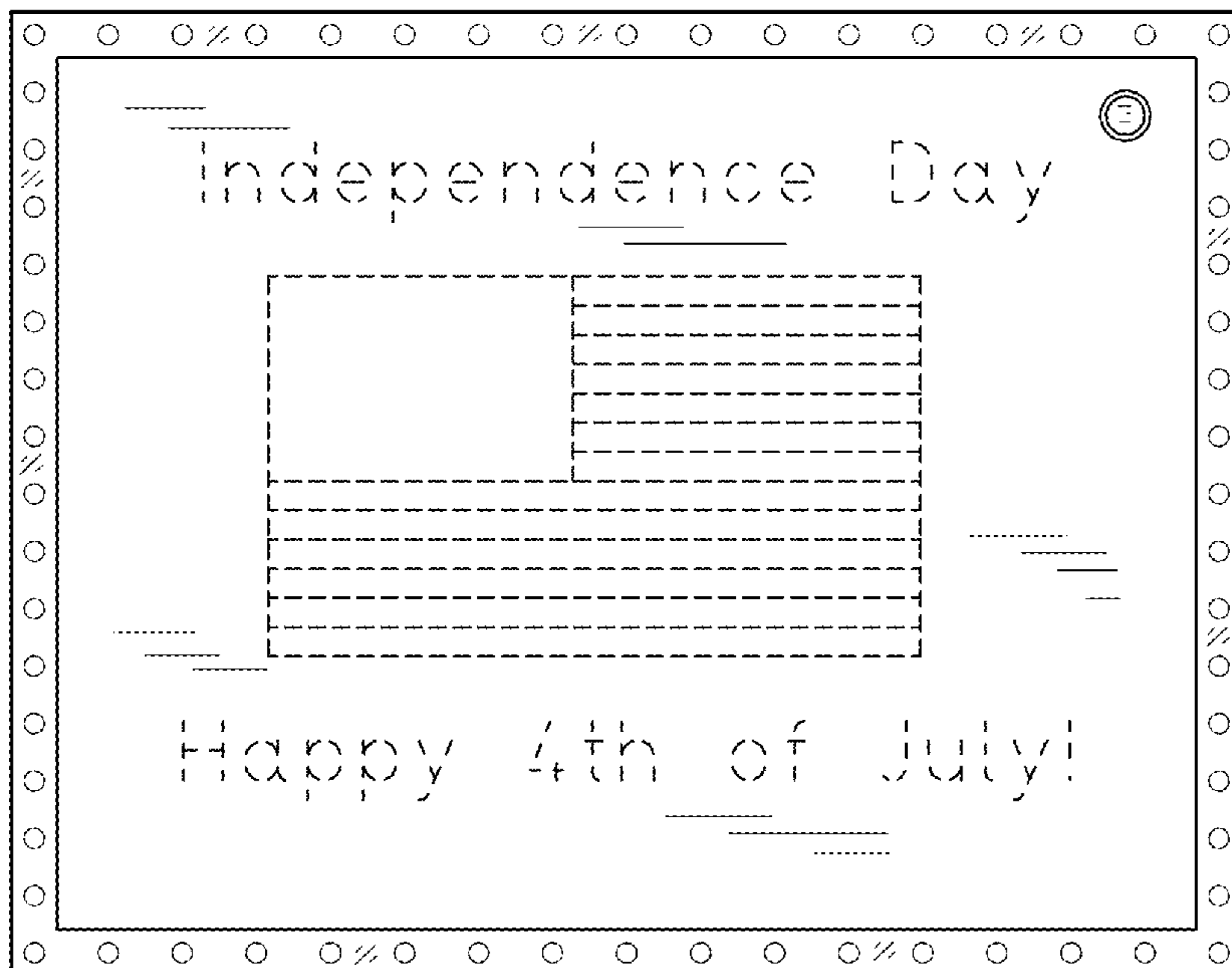
FIG. 3 is a side view of the claimed design.

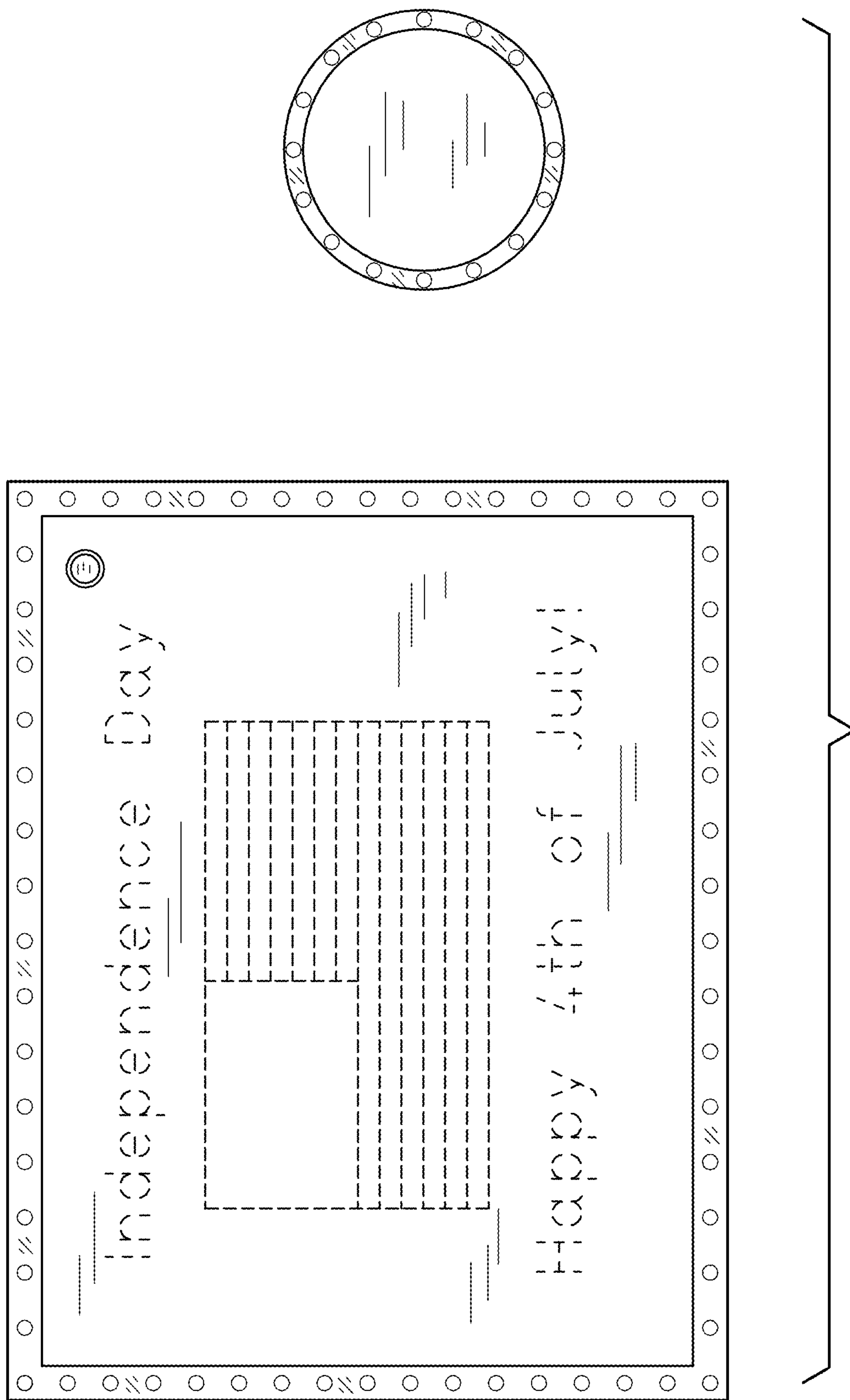

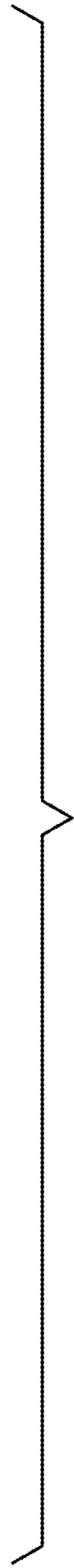
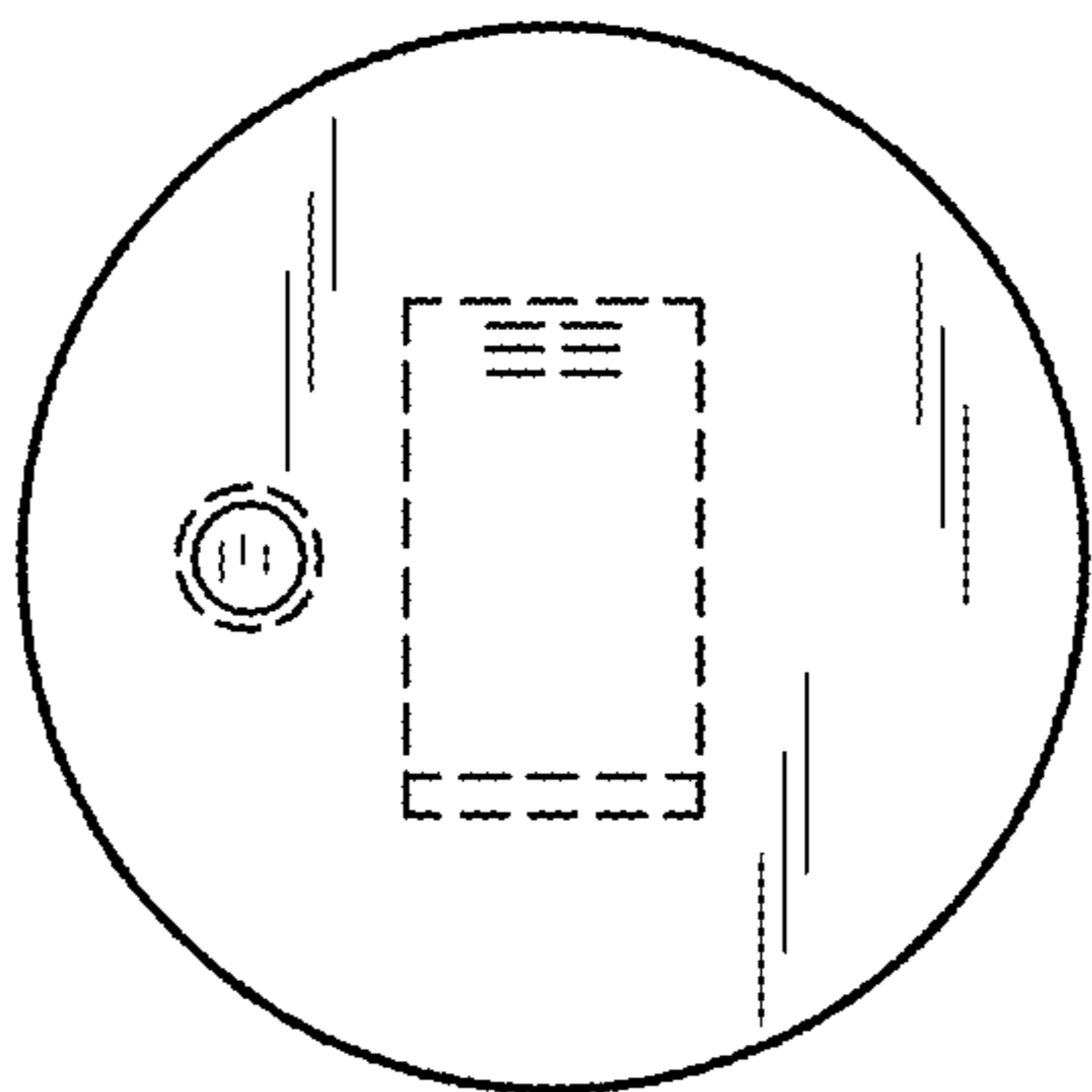
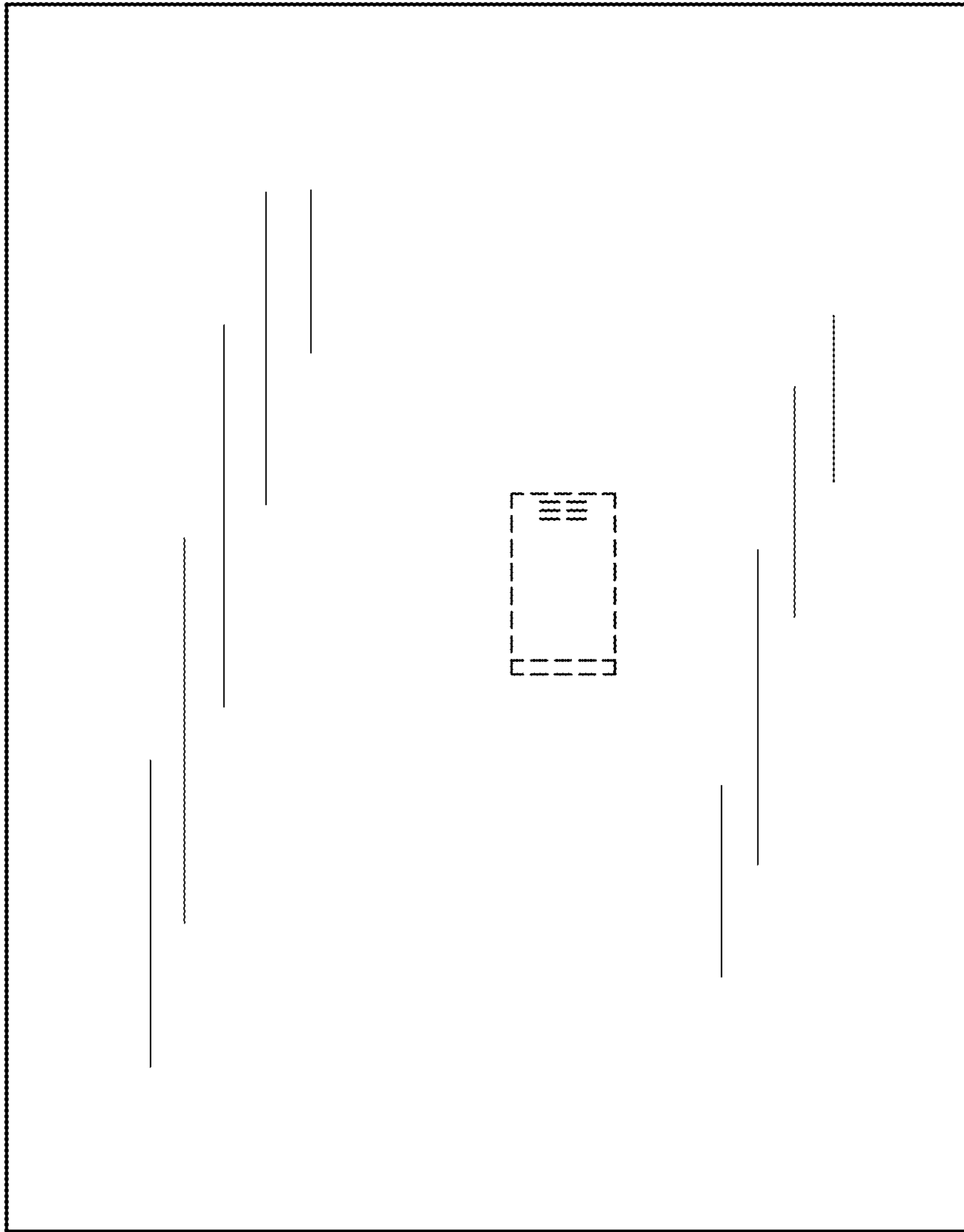
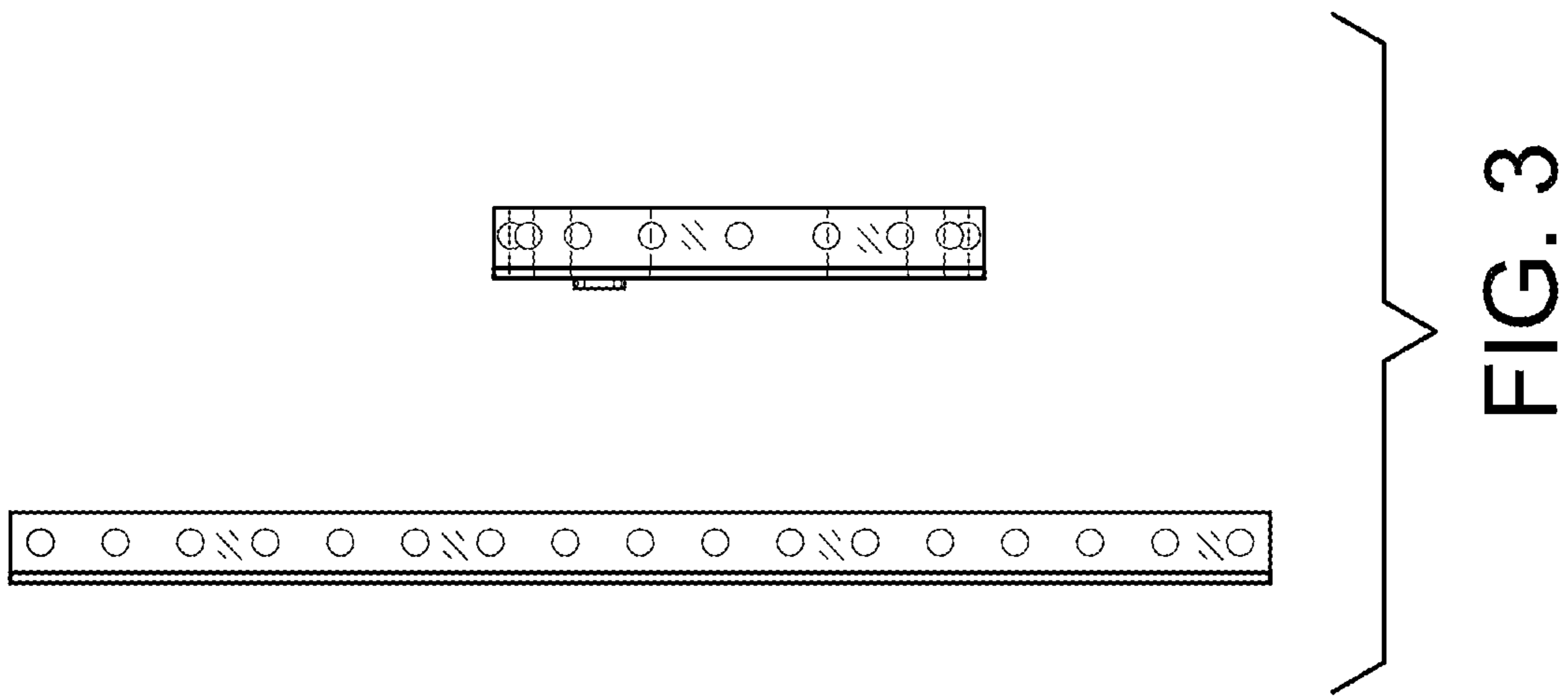

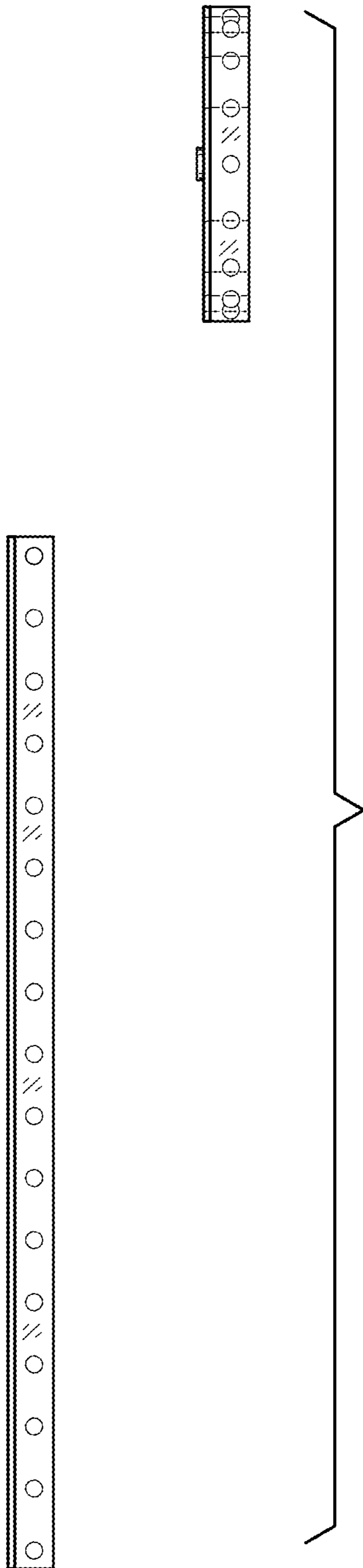

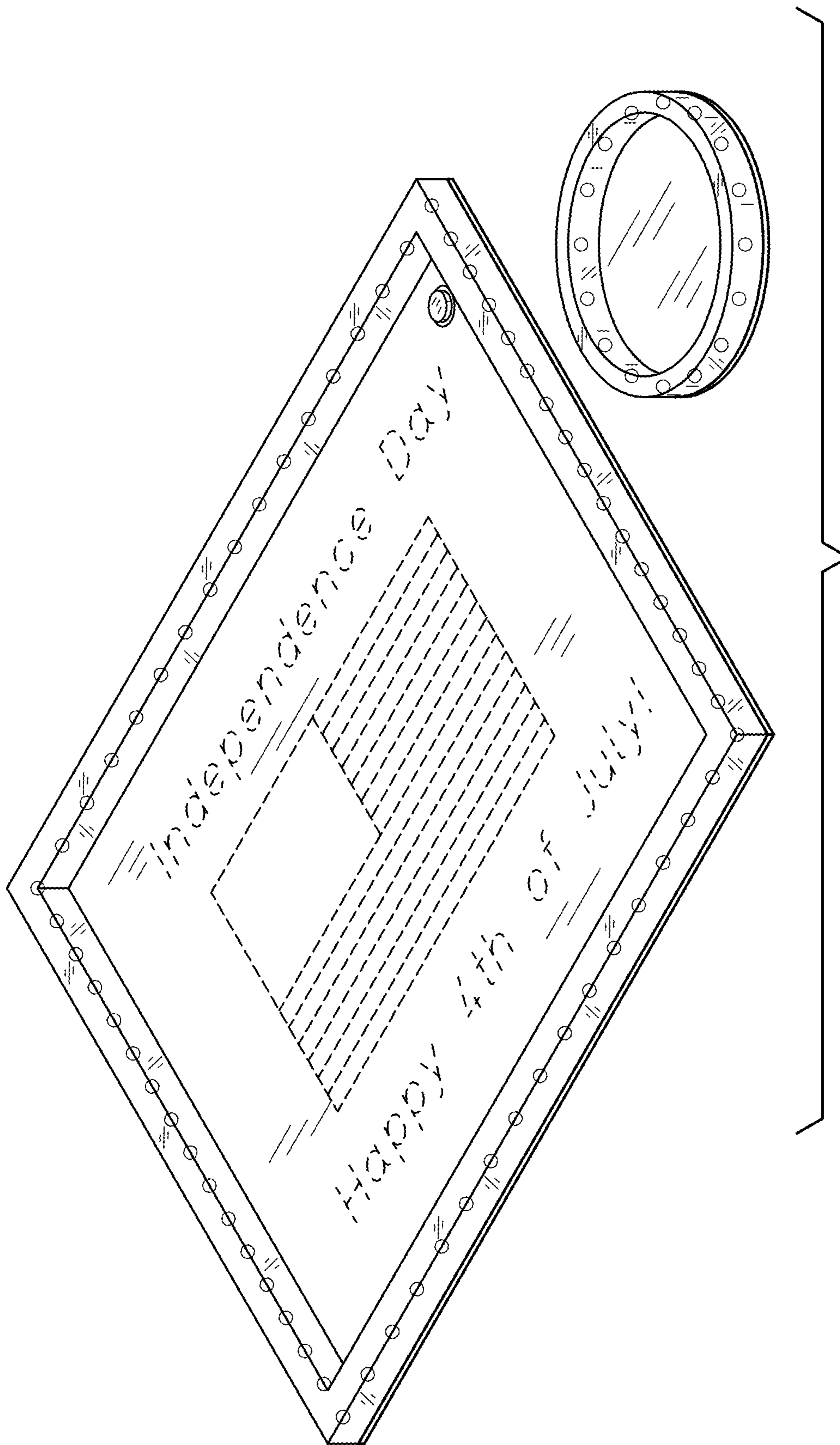
