DESCRIPTION

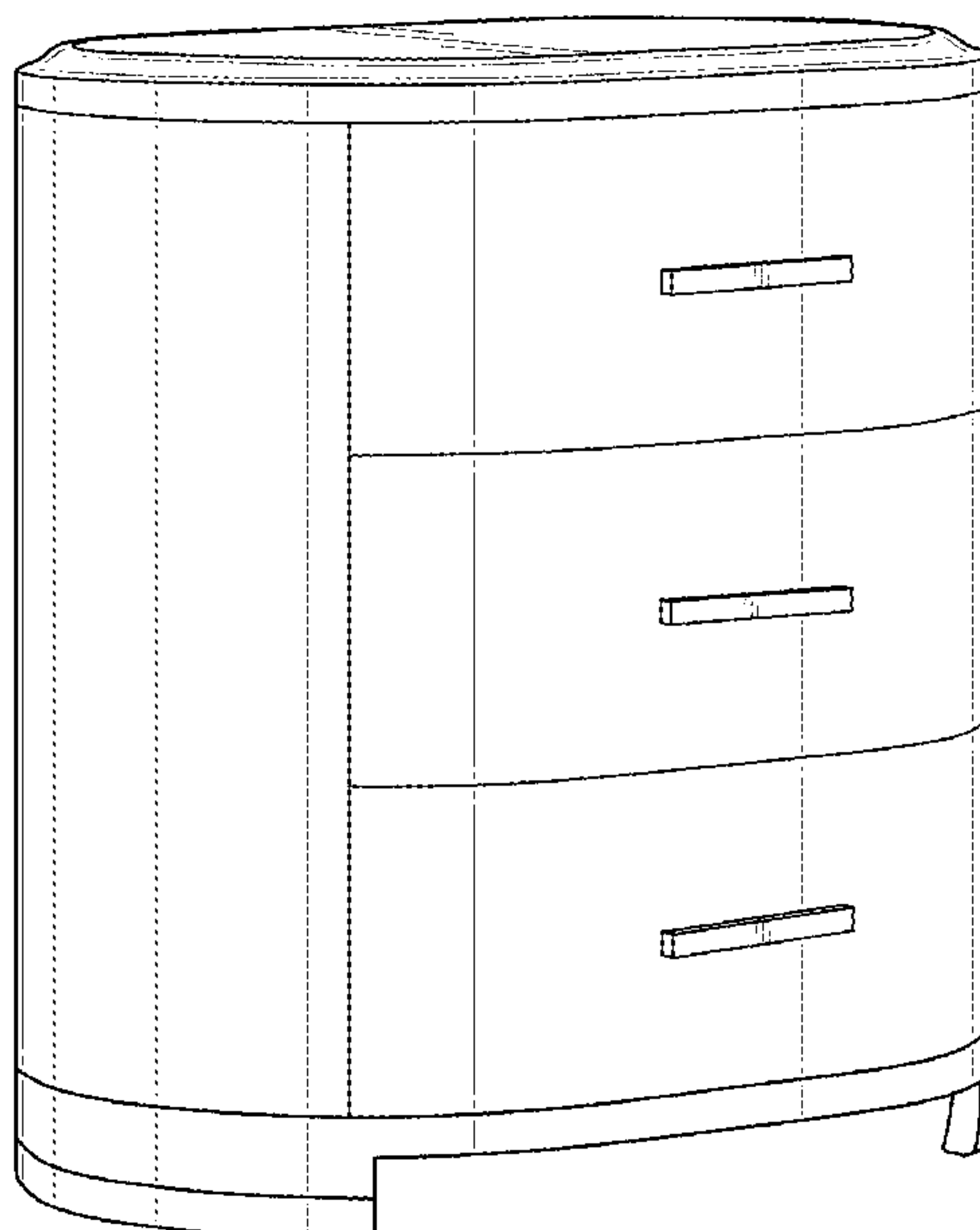
FIG. 1 is perspective view of a nightstand, showing my new design;

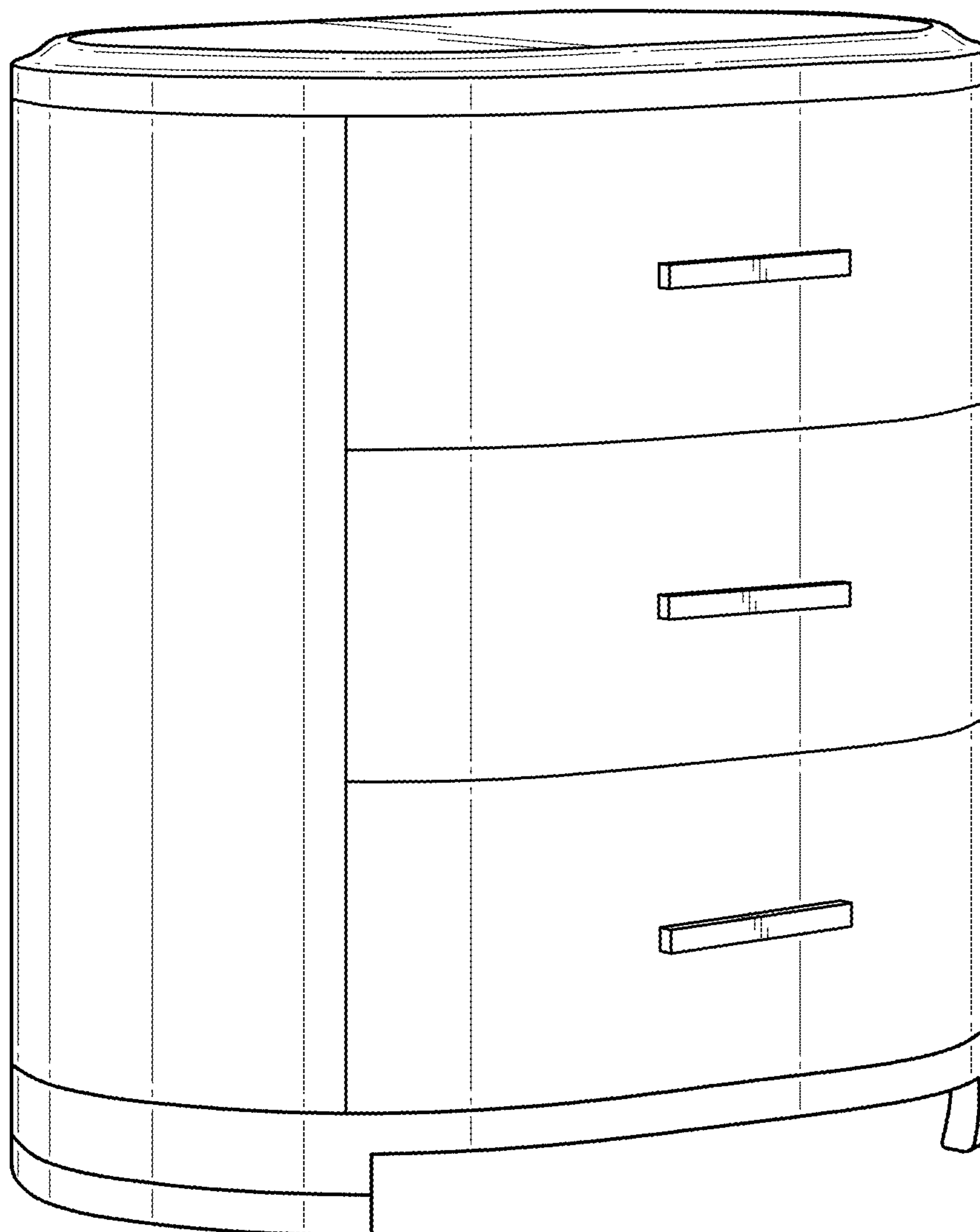

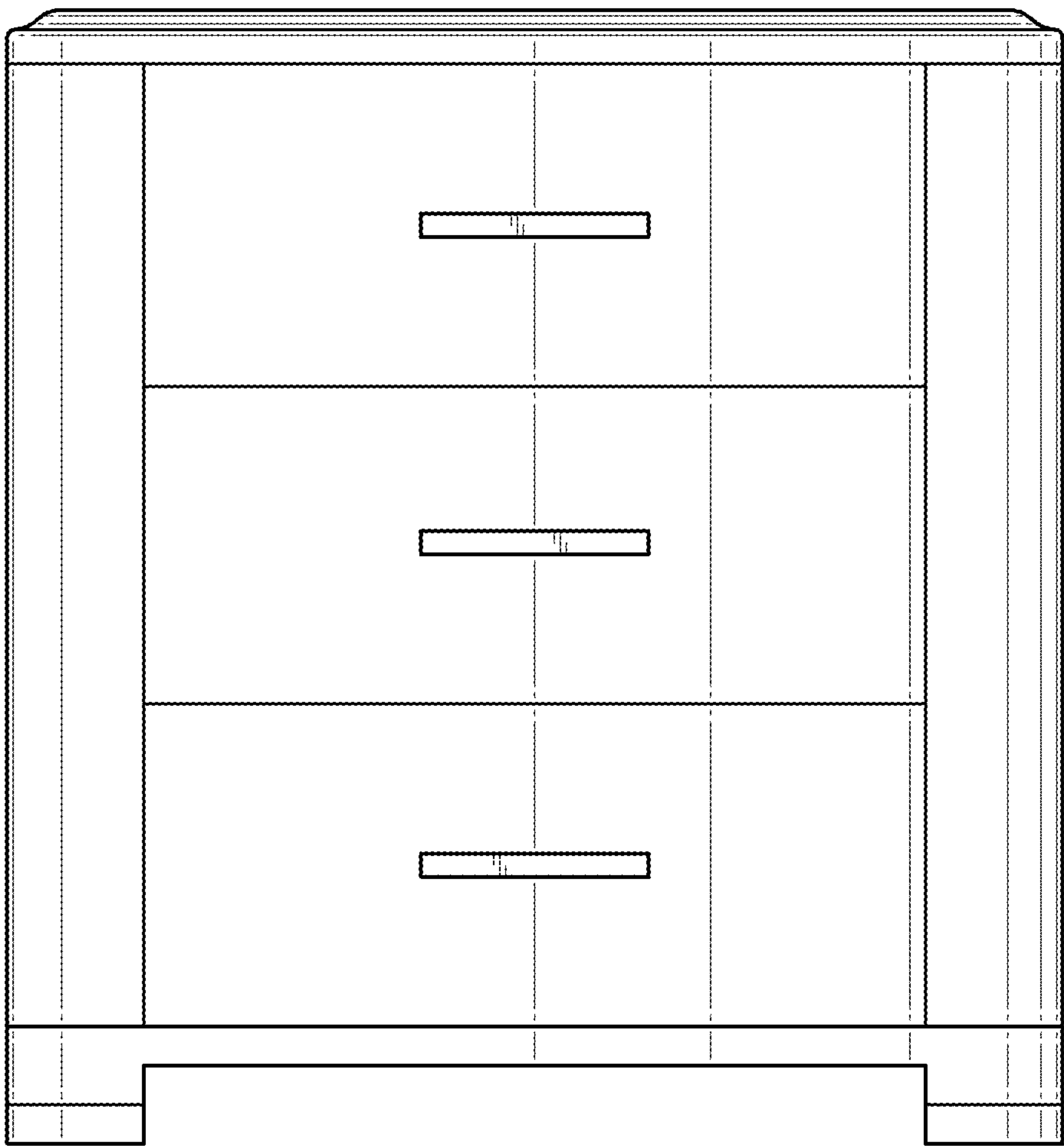

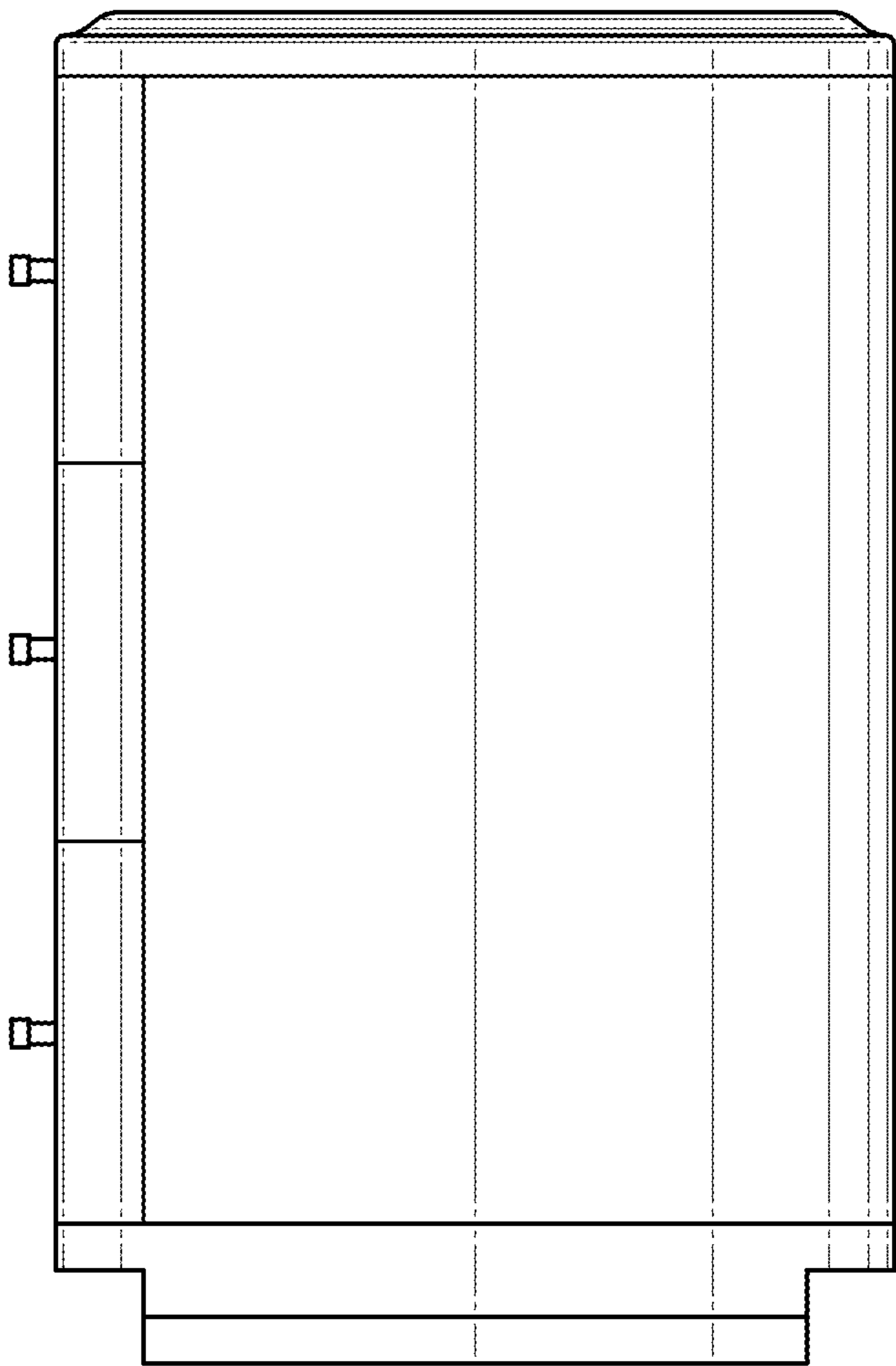
