(57) **CLAIM**

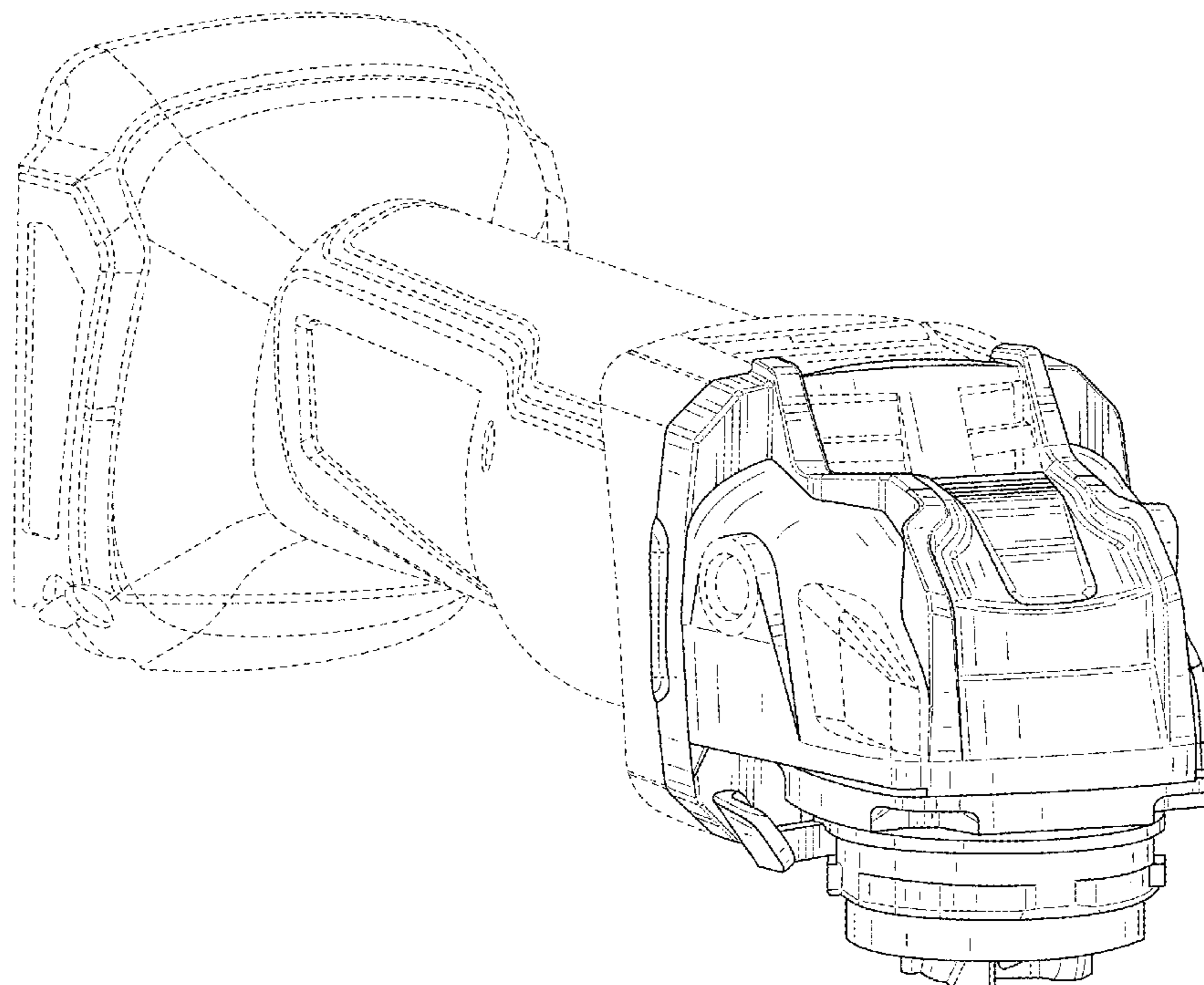
The ornamental design for an angle grinder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an angle grinder showing our new design;  
 FIG. 2 is a left side elevational view of the angle grinder of FIG. 1;

 FIG. 4 is a bottom plan view of the angle grinder of FIG. 1;

 FIG. 7 is a rear elevational view of the angle grinder of FIG. 1.

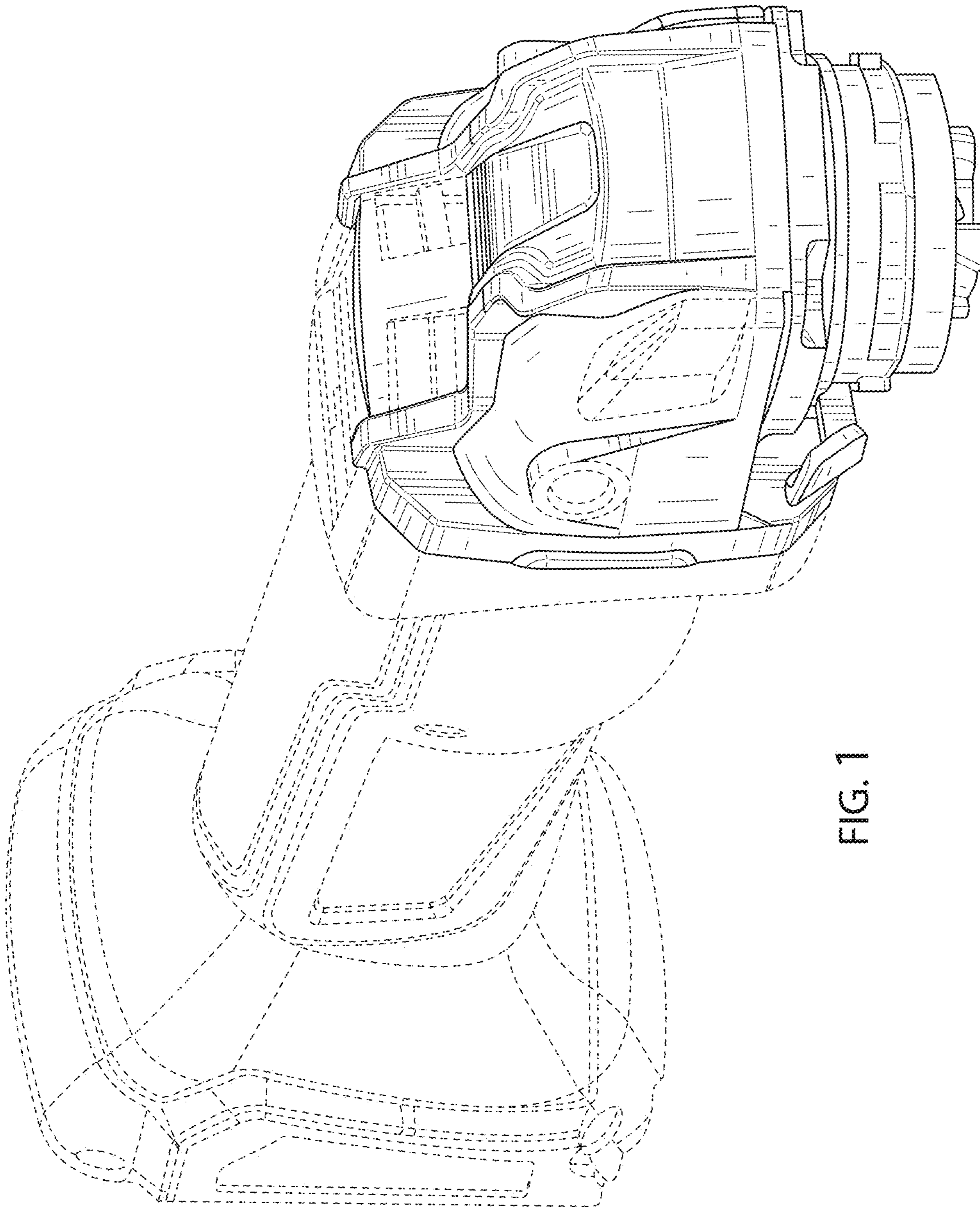

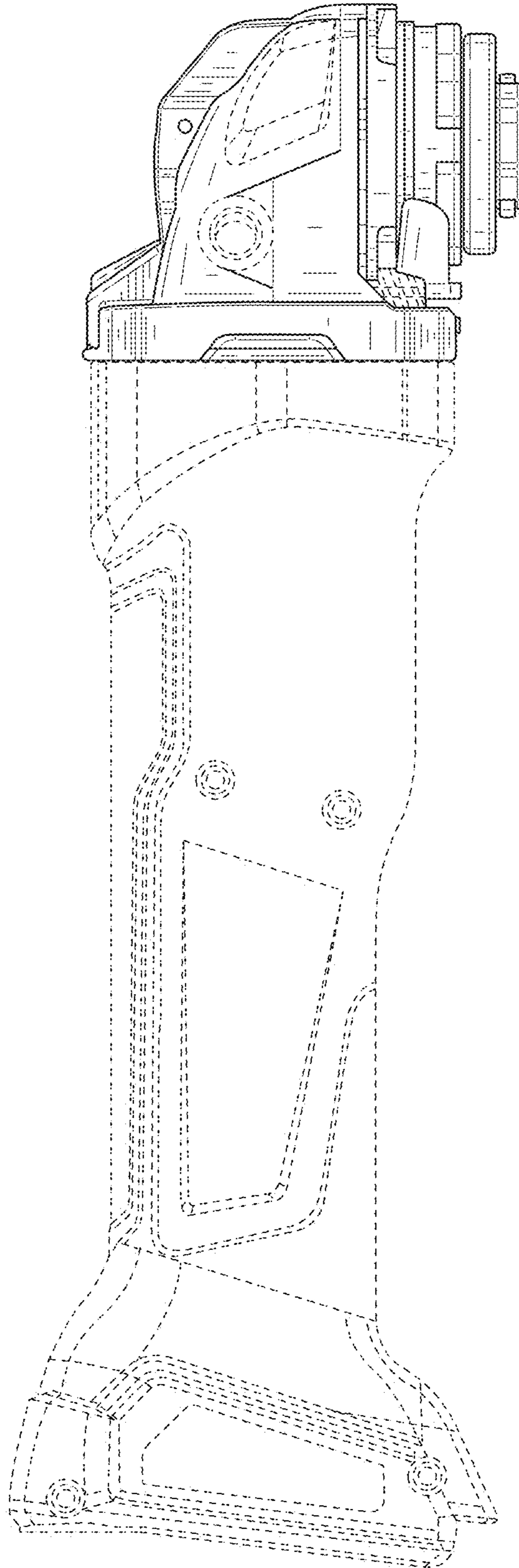

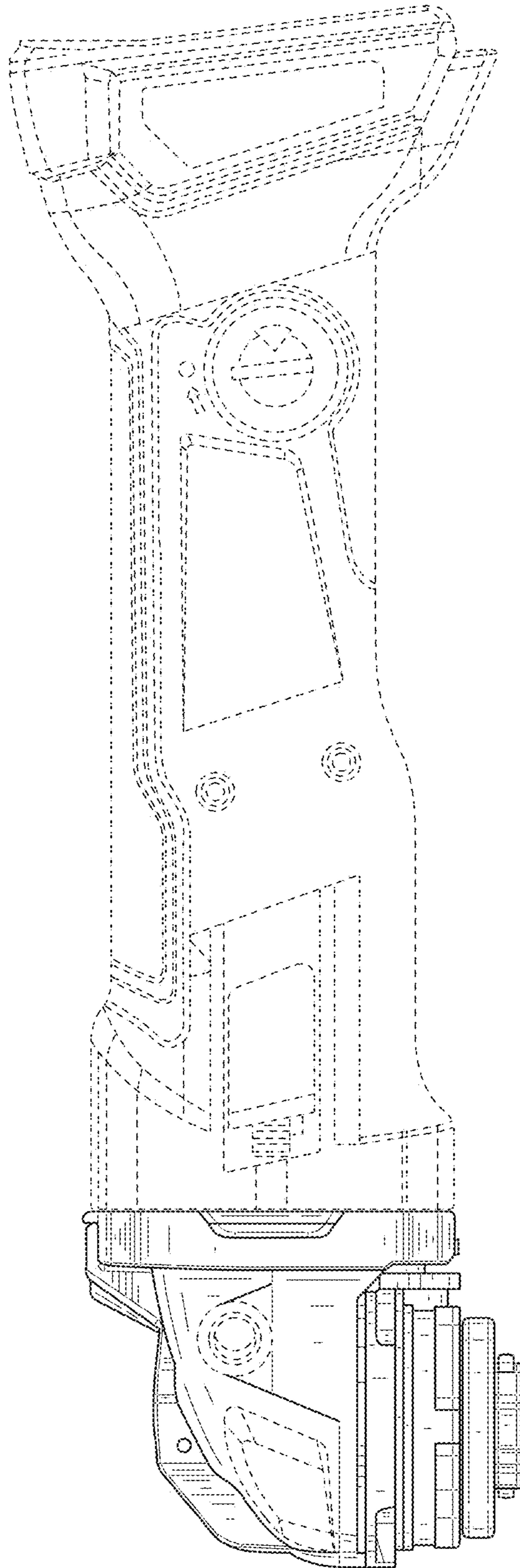

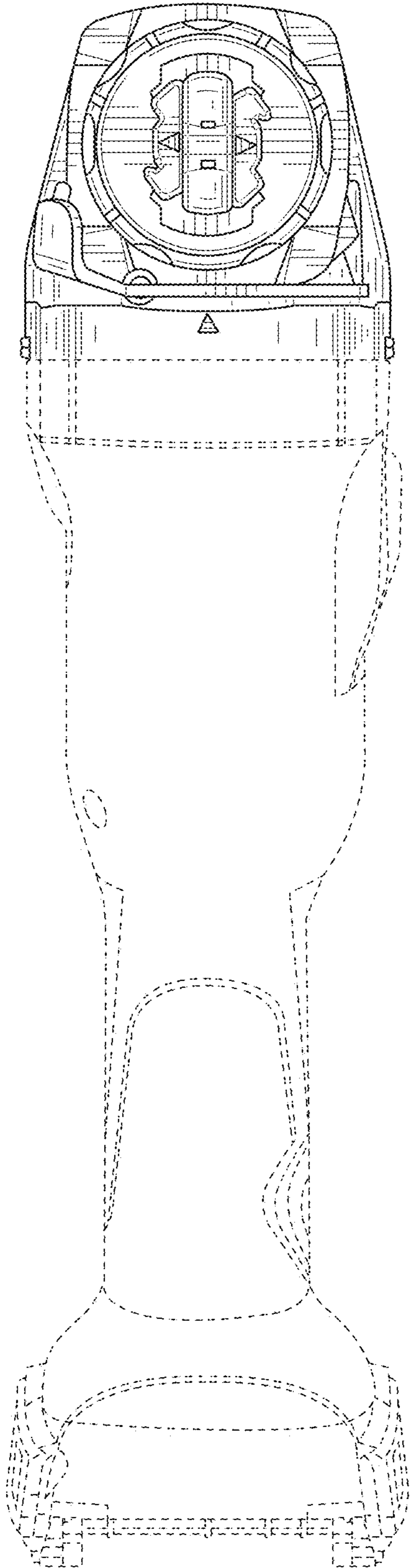

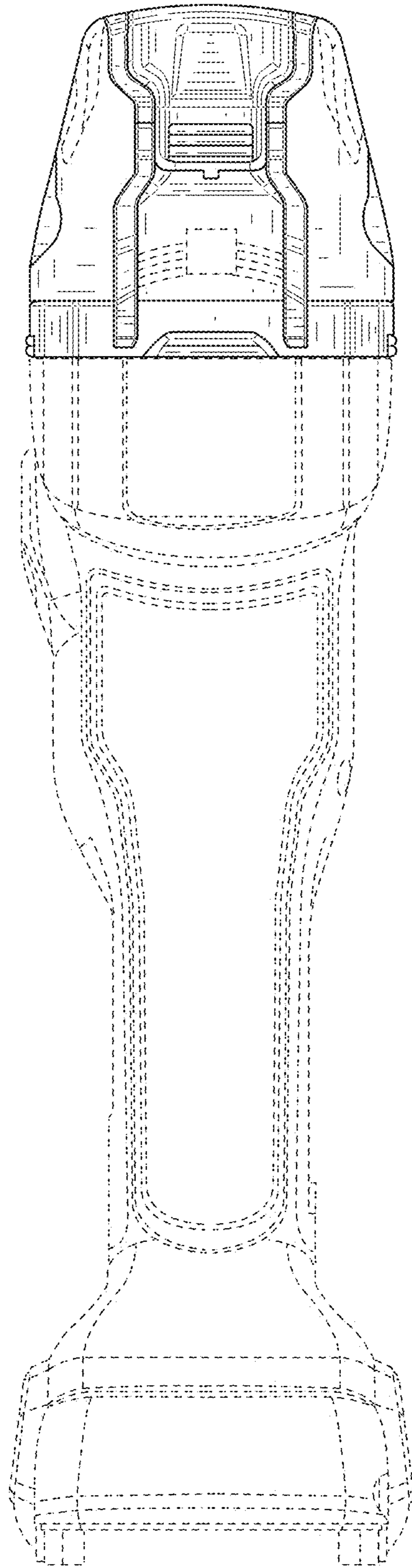

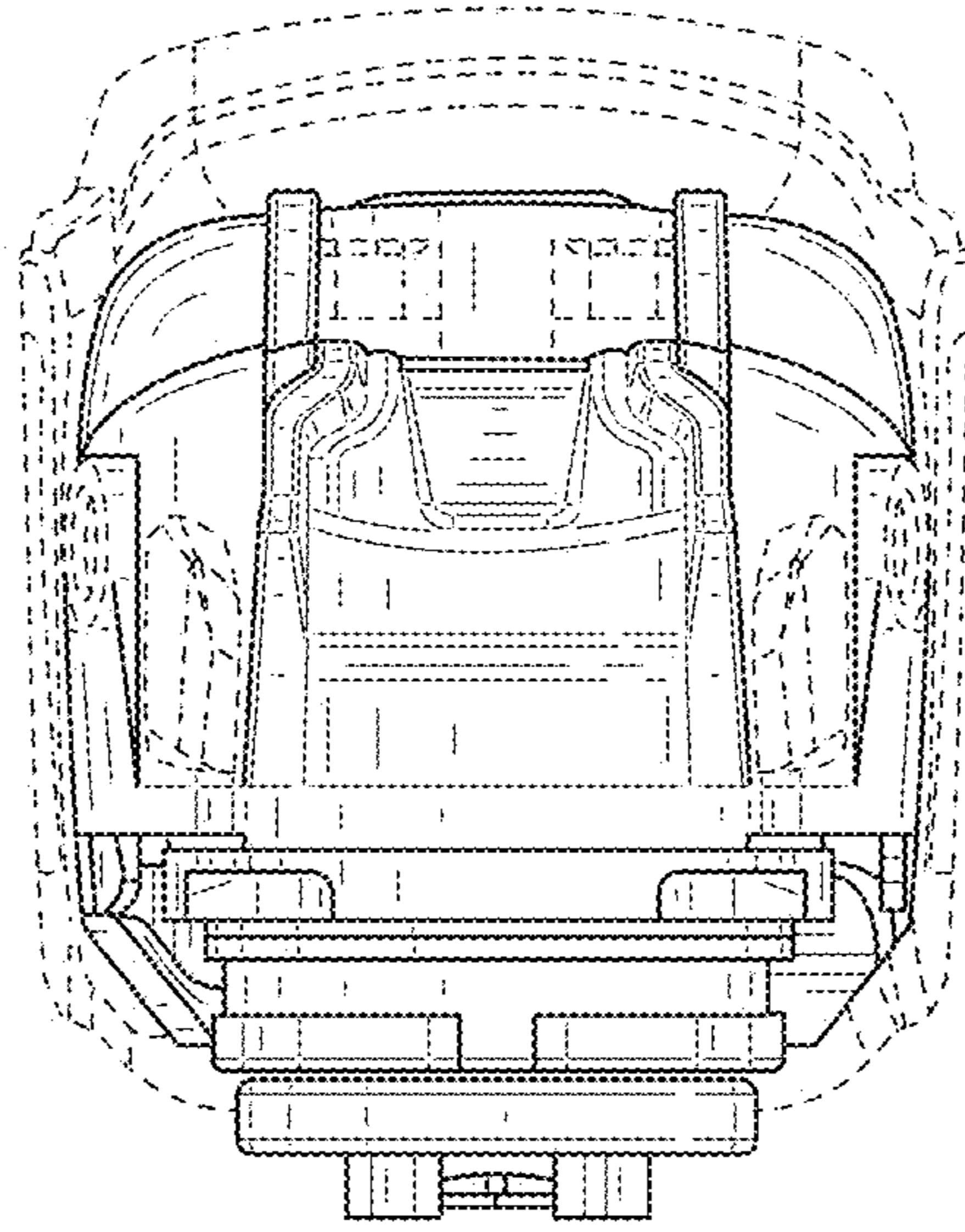

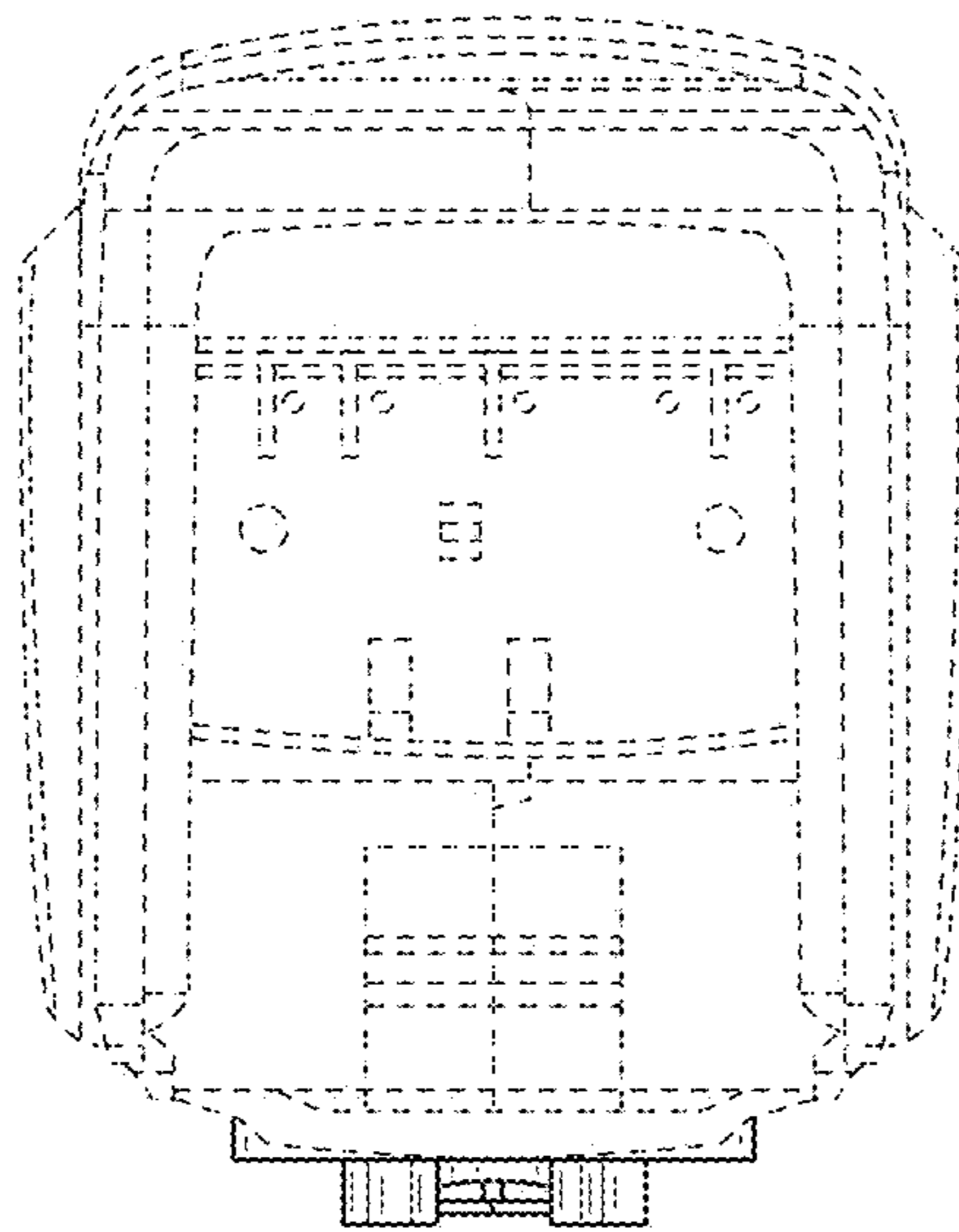
