The ornamental design of a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a bottle in accordance with the present invention;

FIG. 2 is a second perspective view thereof;

FIG. 4 is back view thereof;

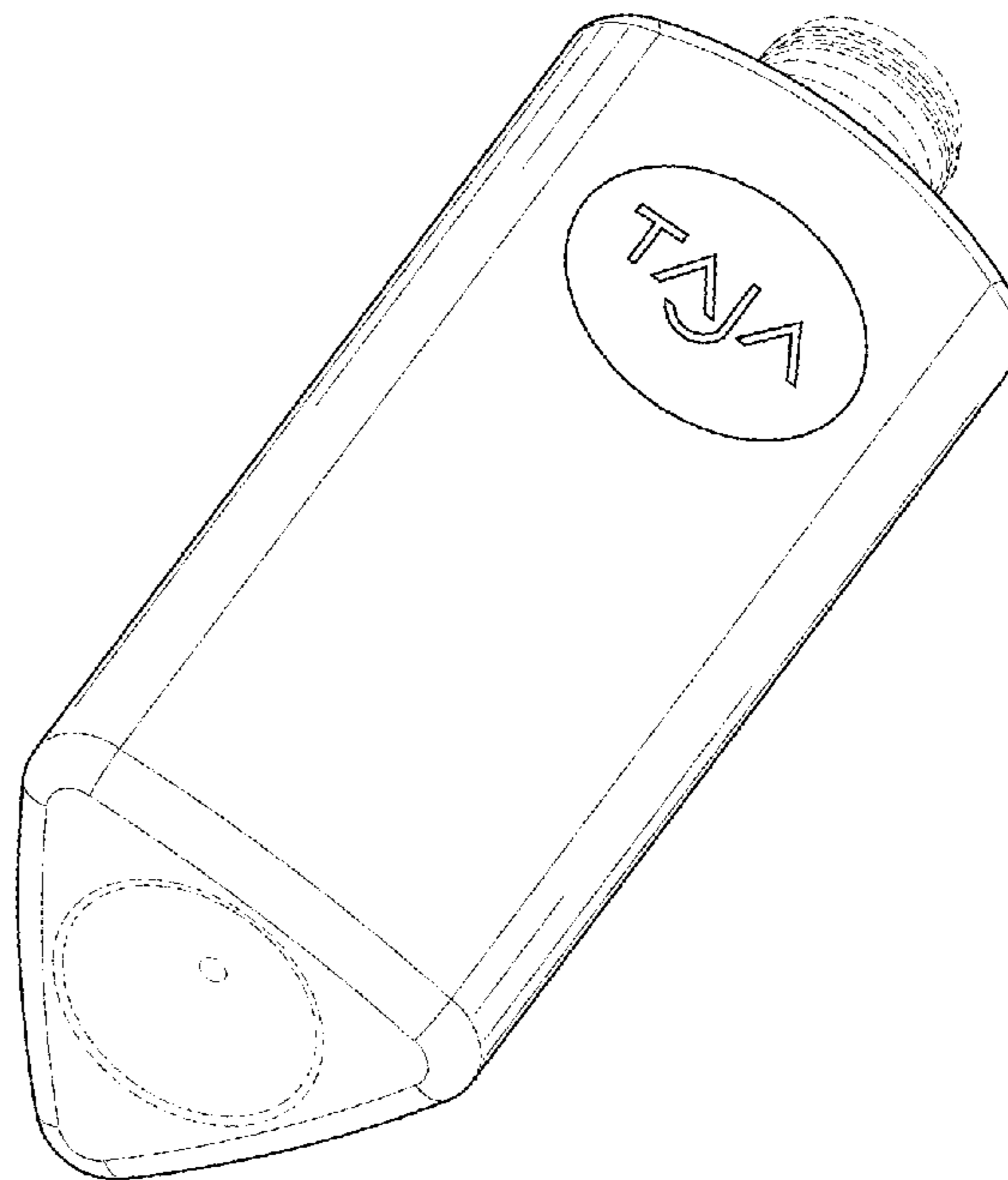
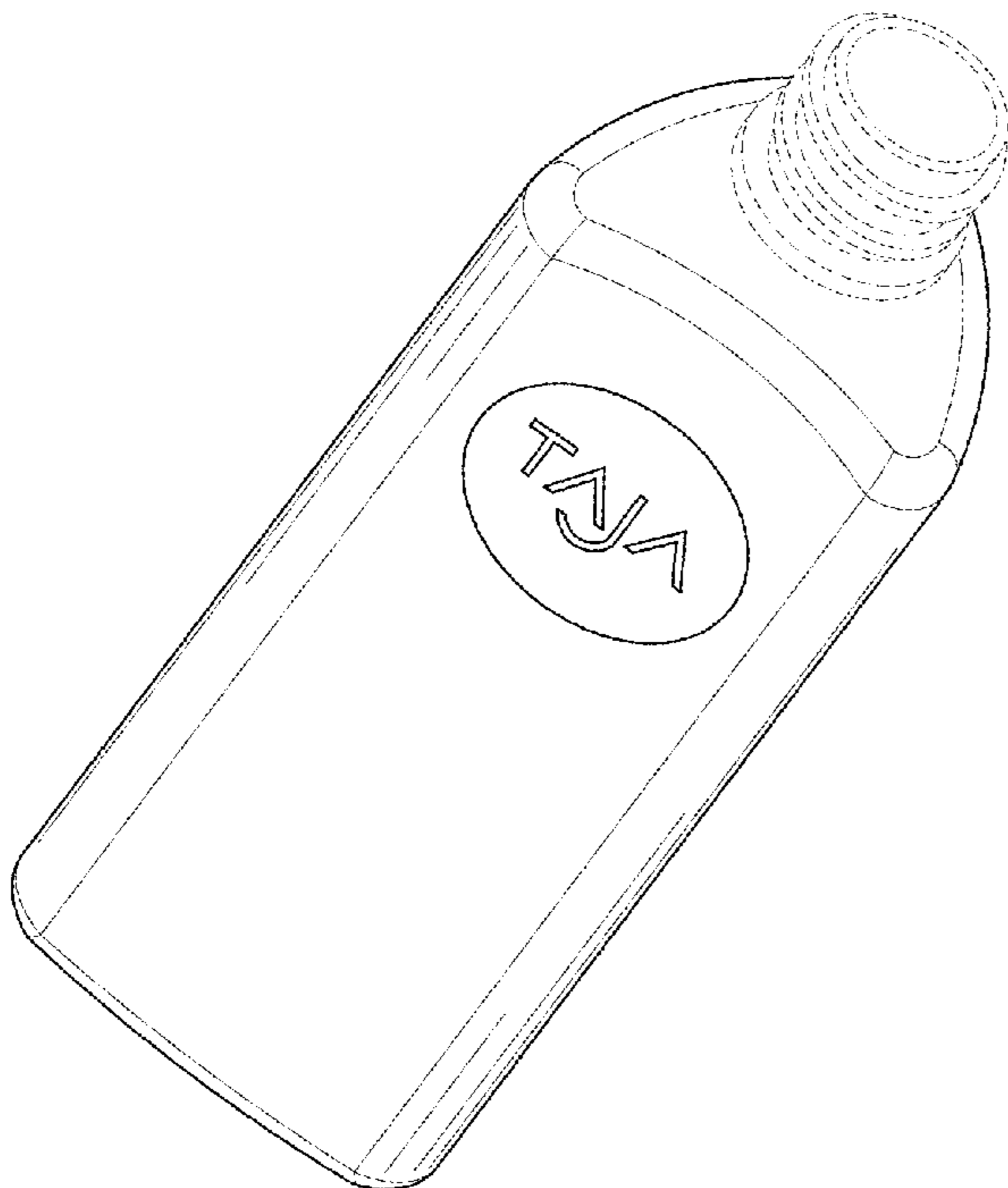
FIG. 5 is a top view thereof;

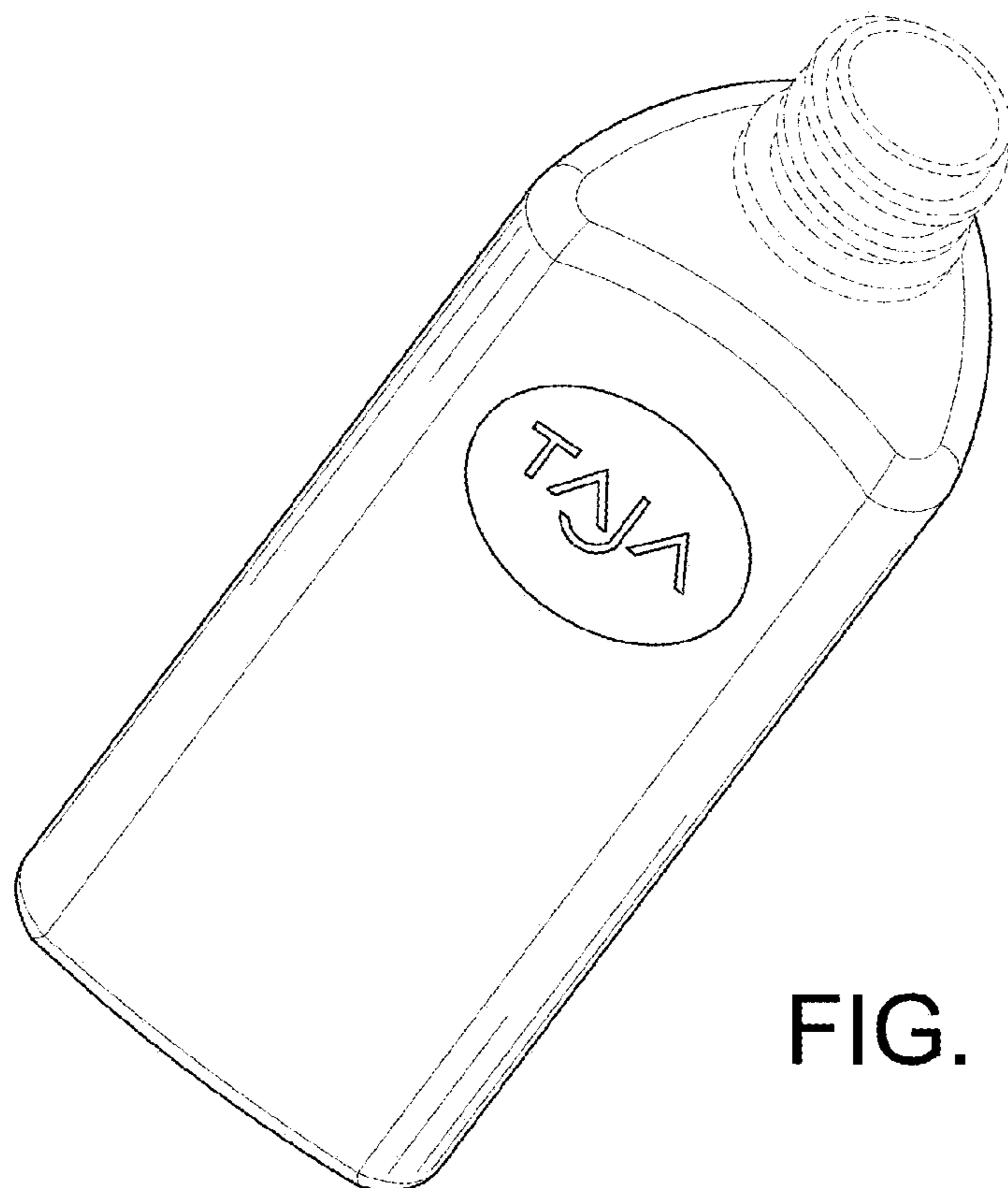

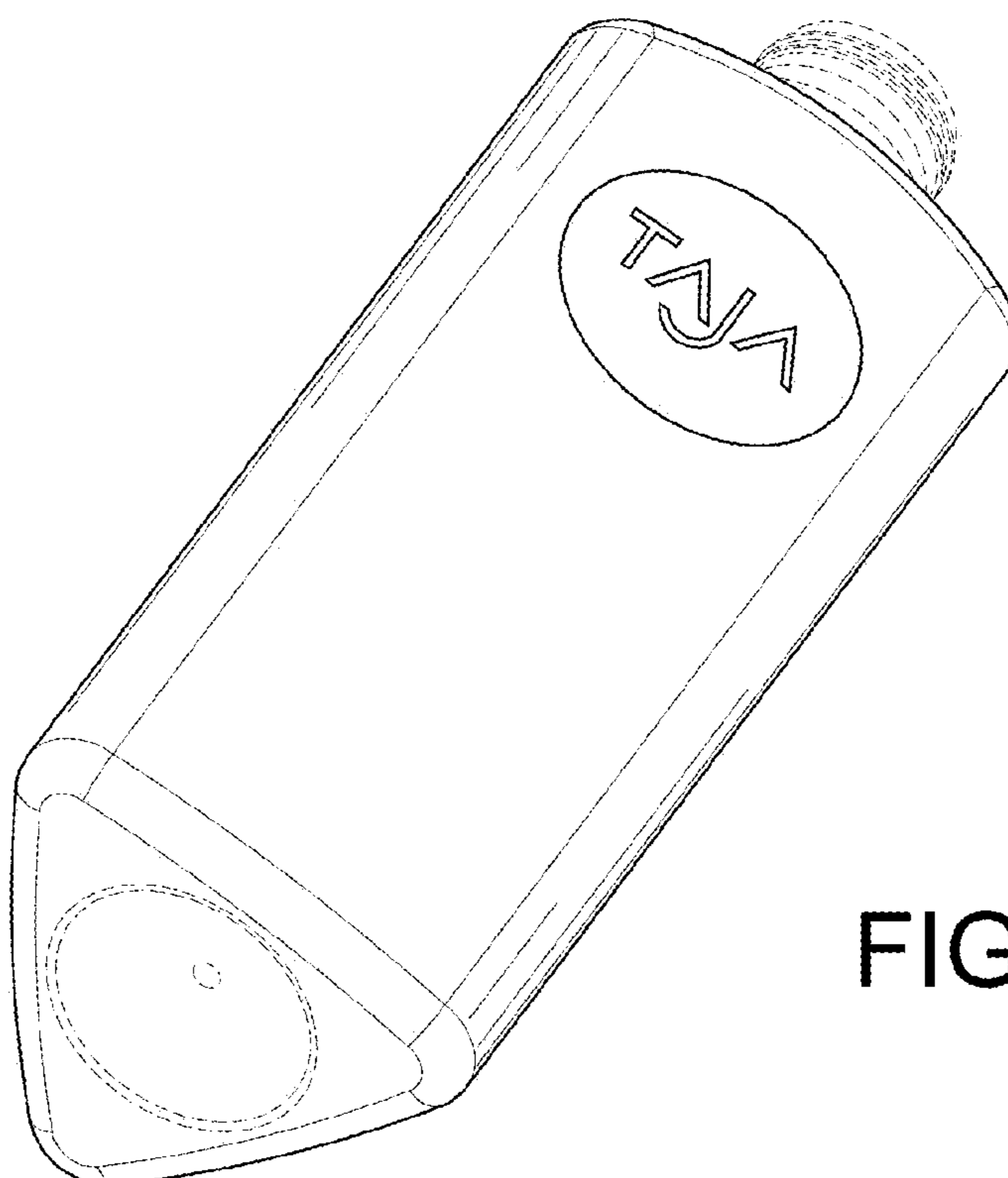

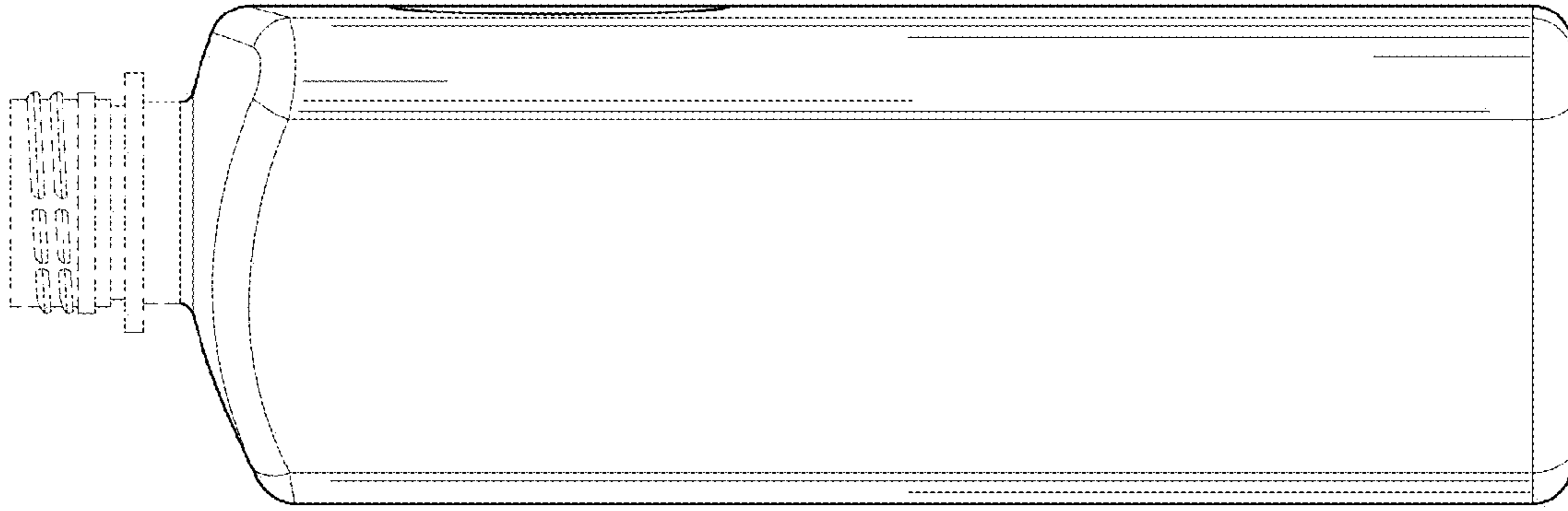

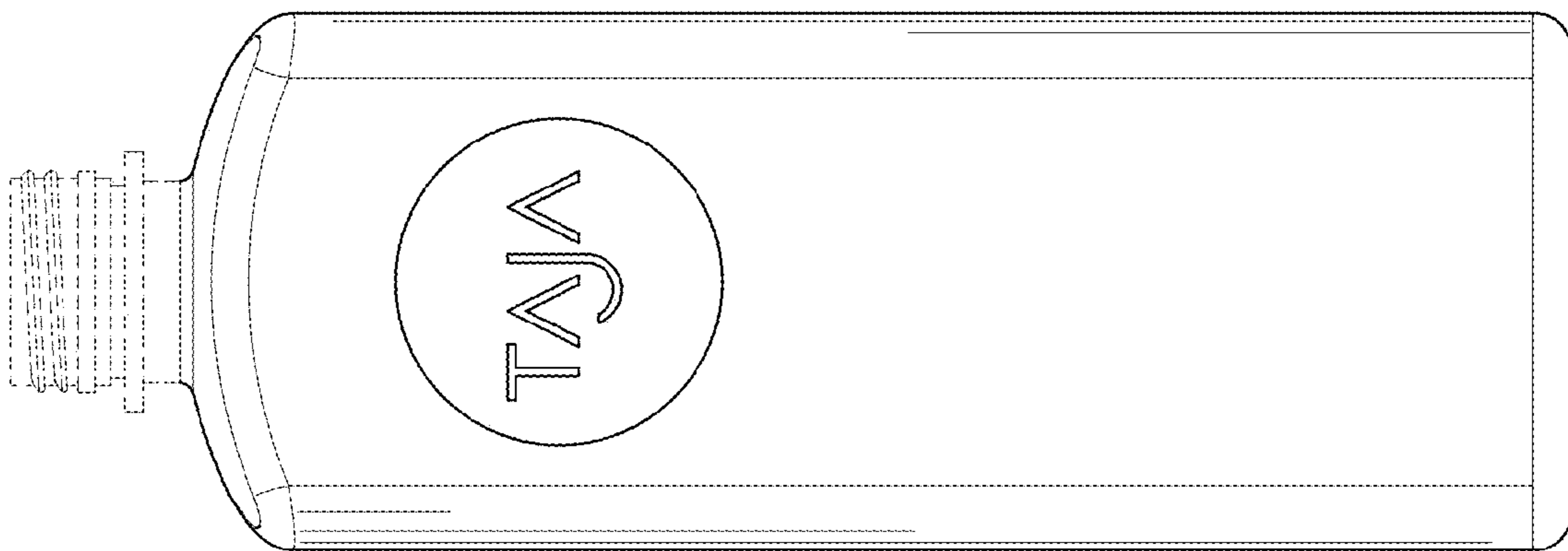

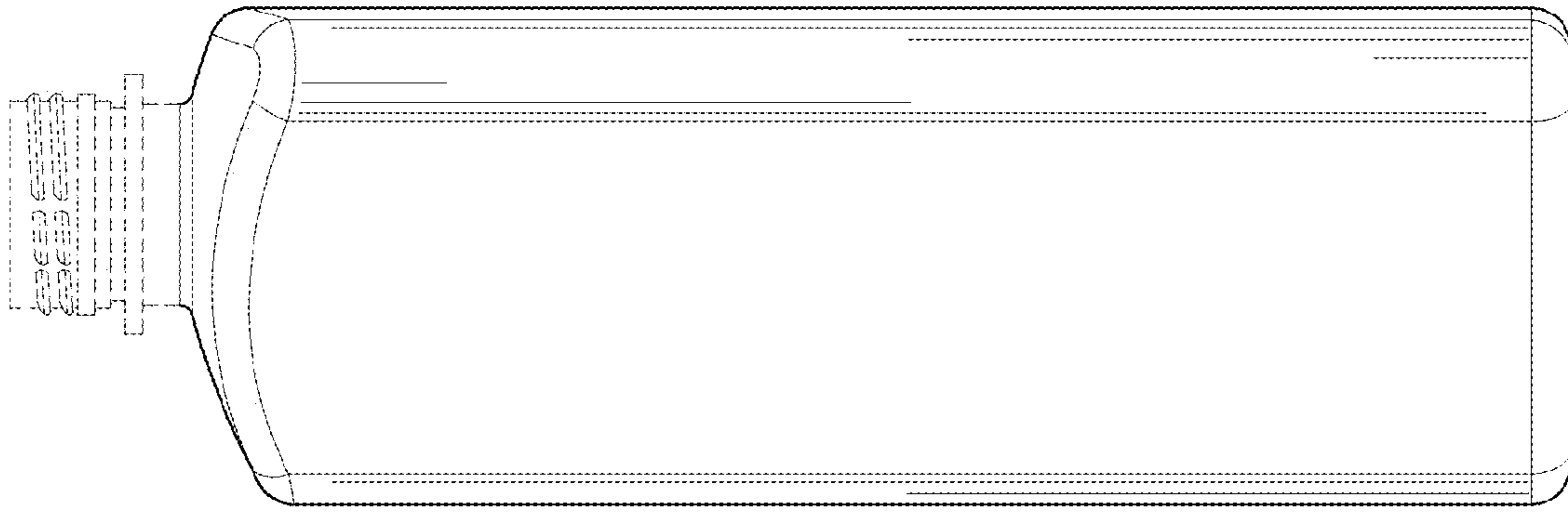

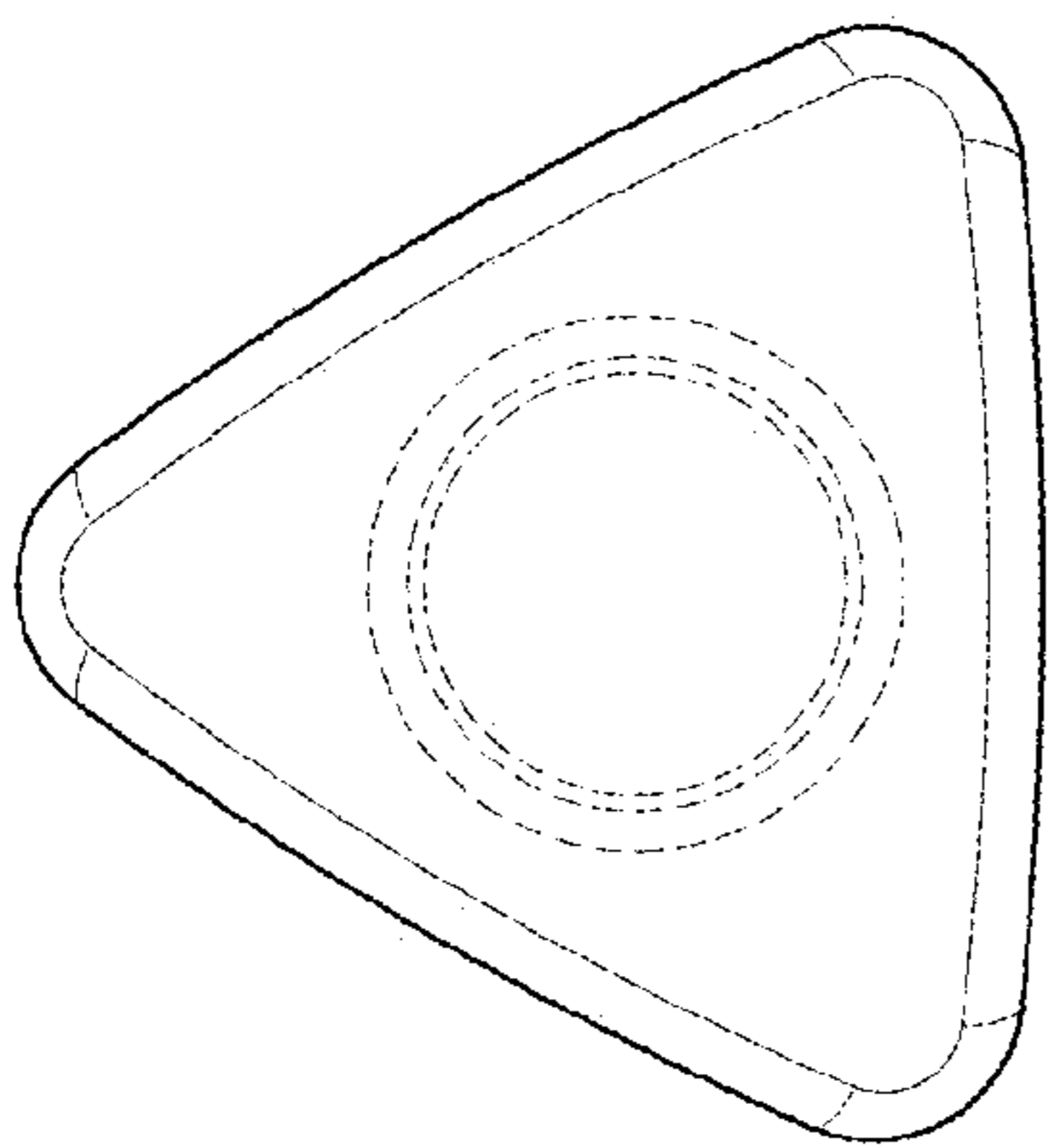

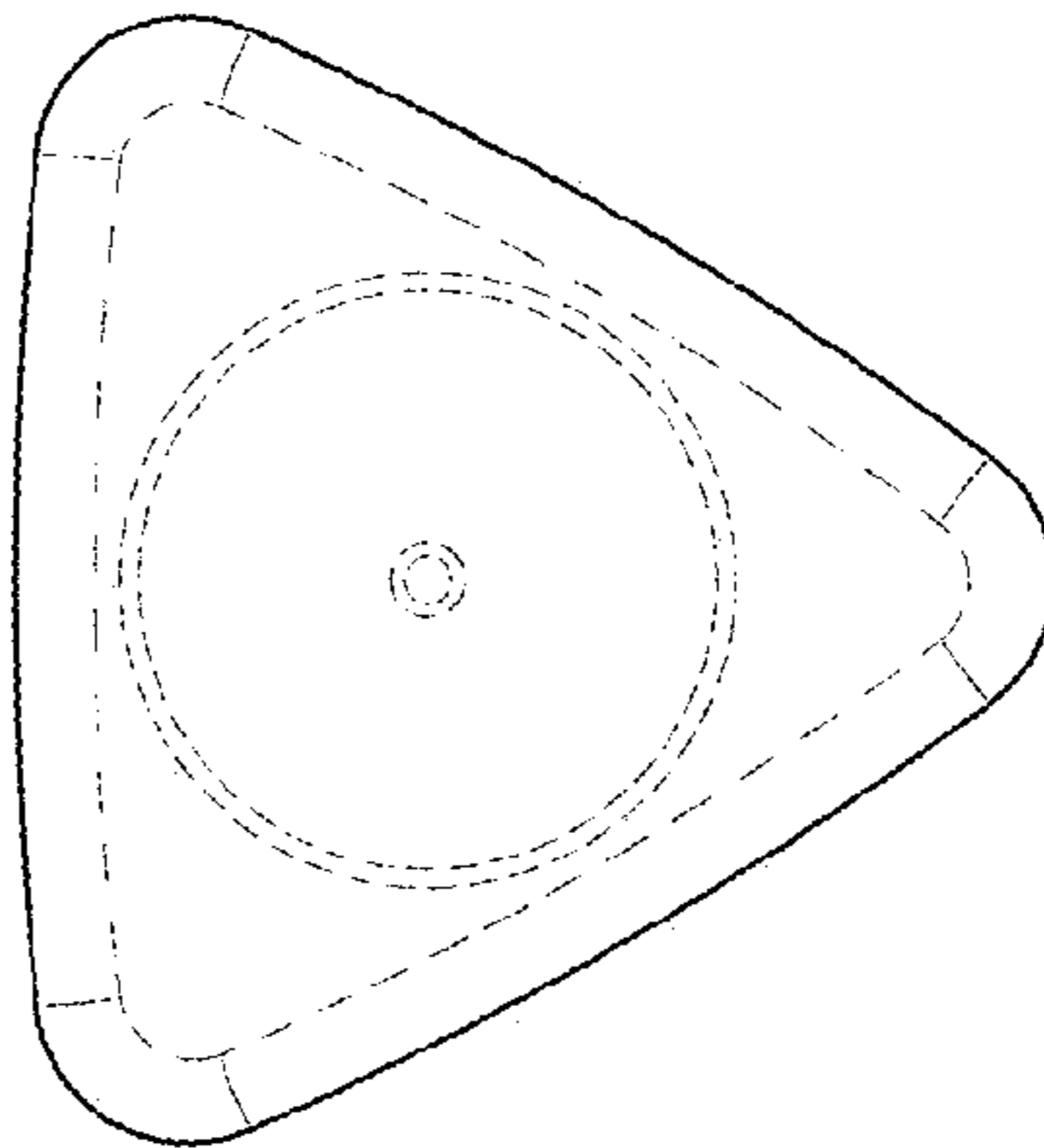
