FIG. 8 is a bottom plan view thereof.

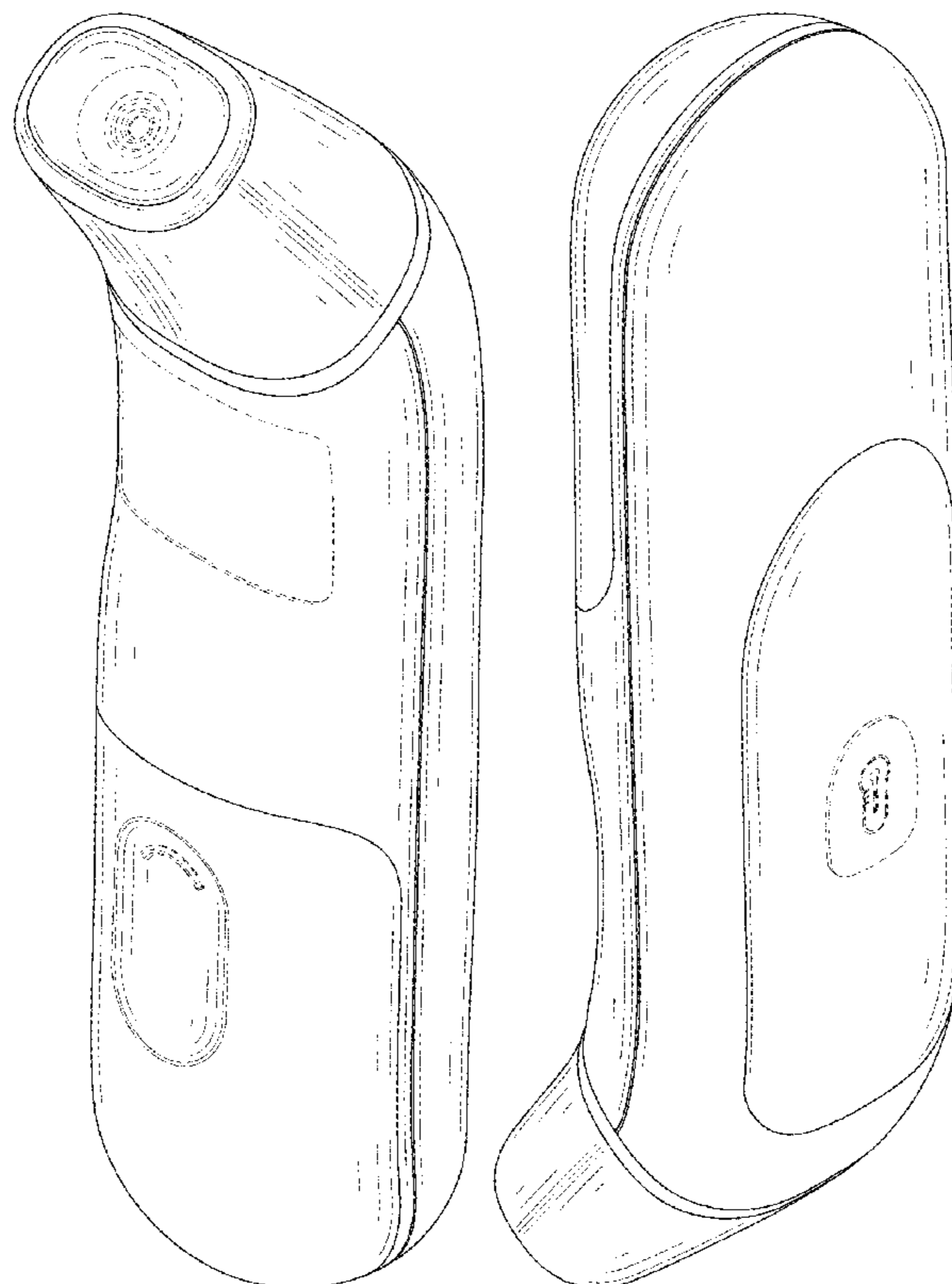
The dashed or broken lines shown in the drawings depict portions of the medical infrared thermometer in which the design is embodied that form no part of the claimed design.

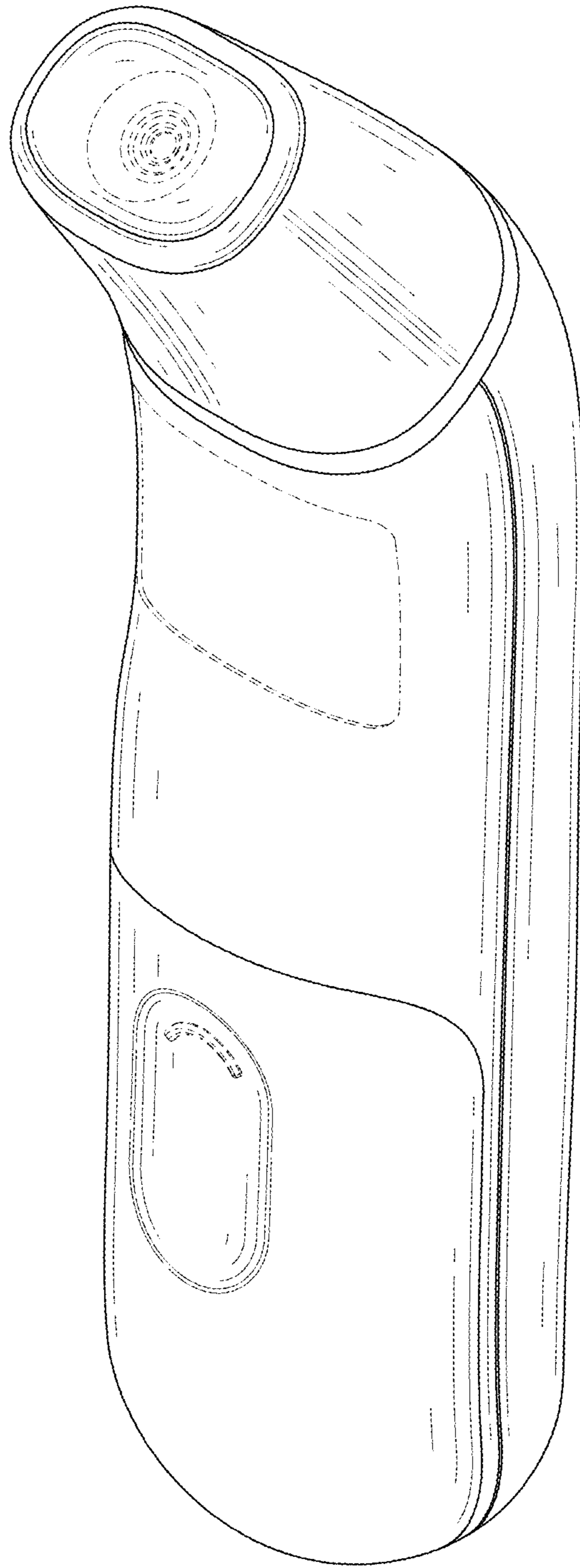

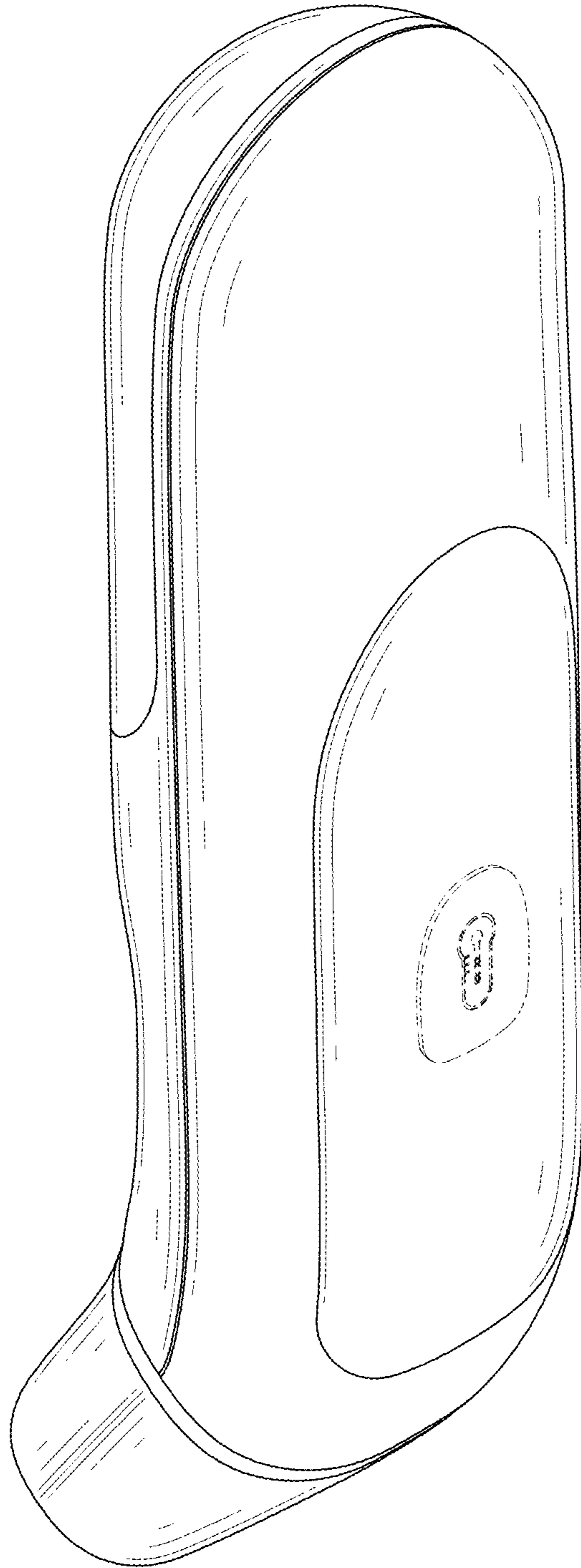

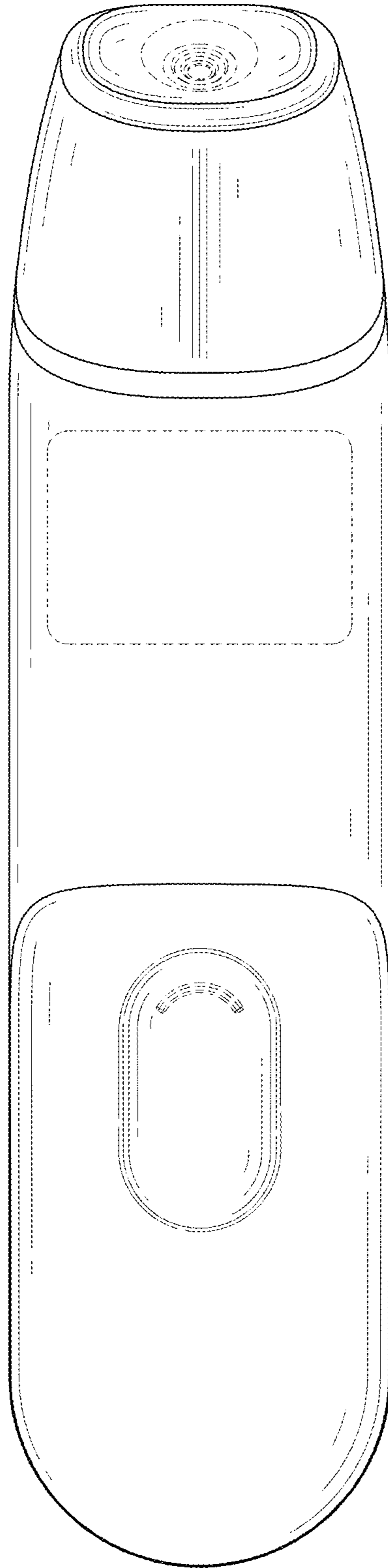

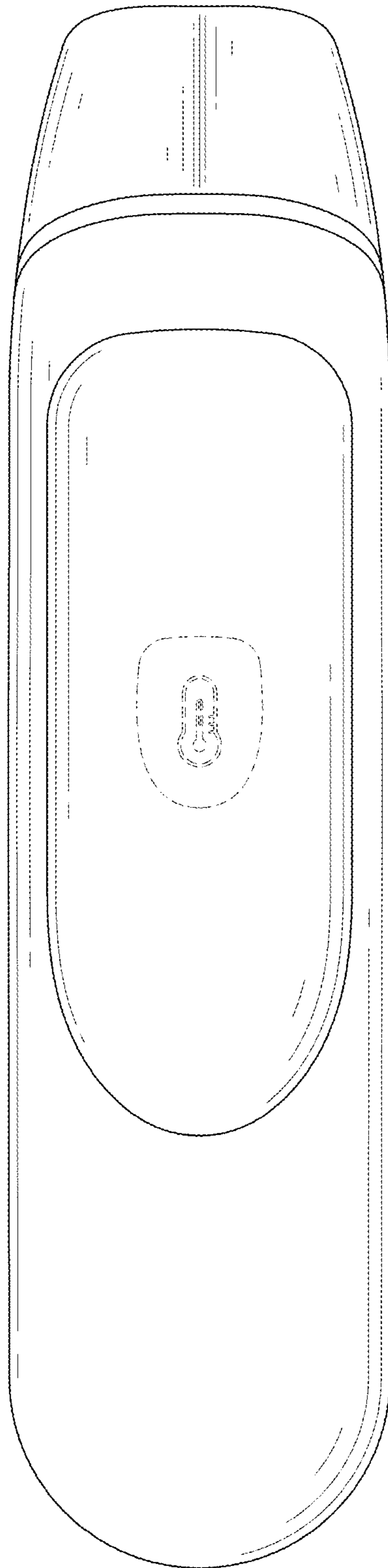

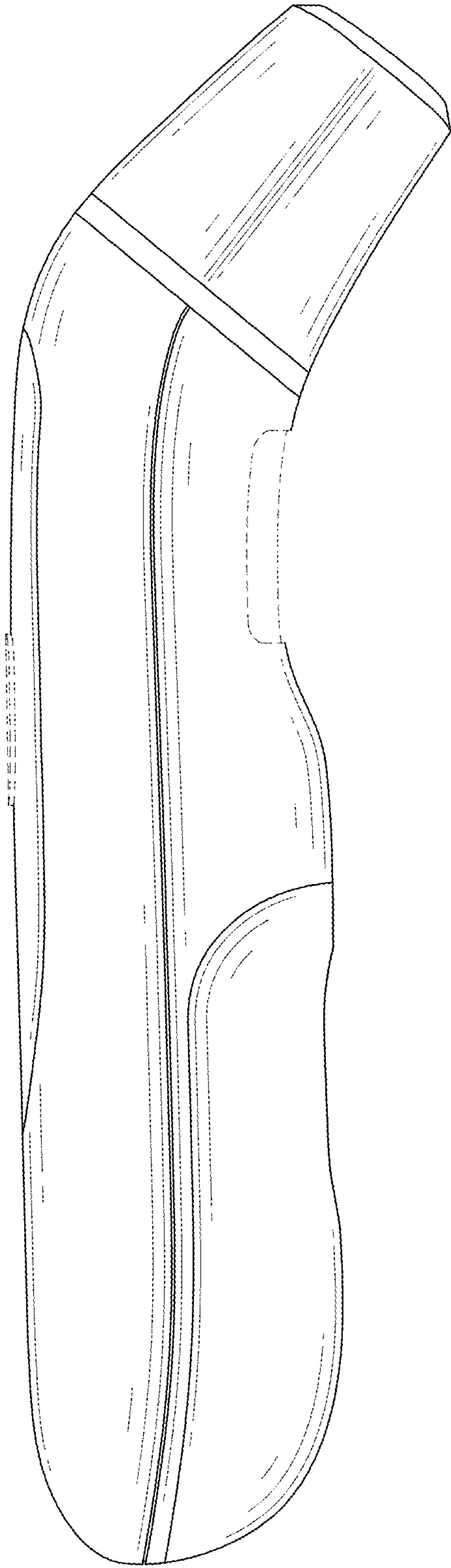

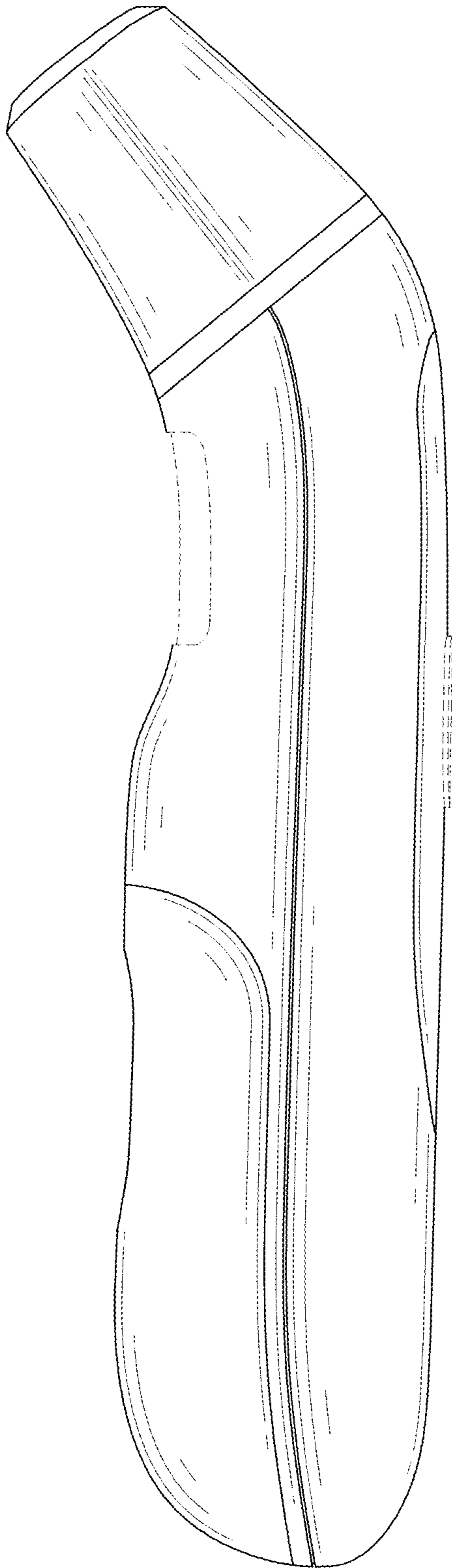

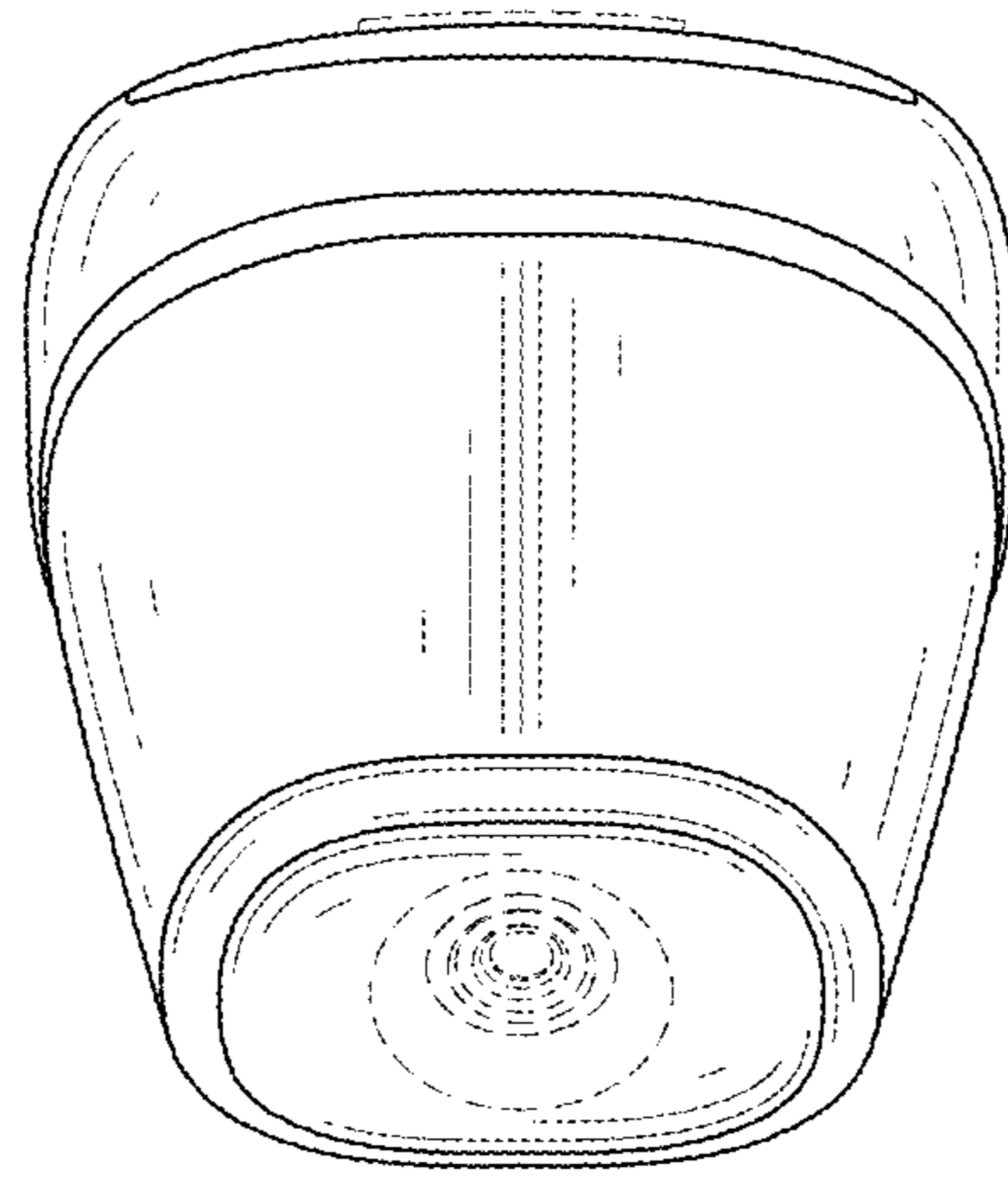

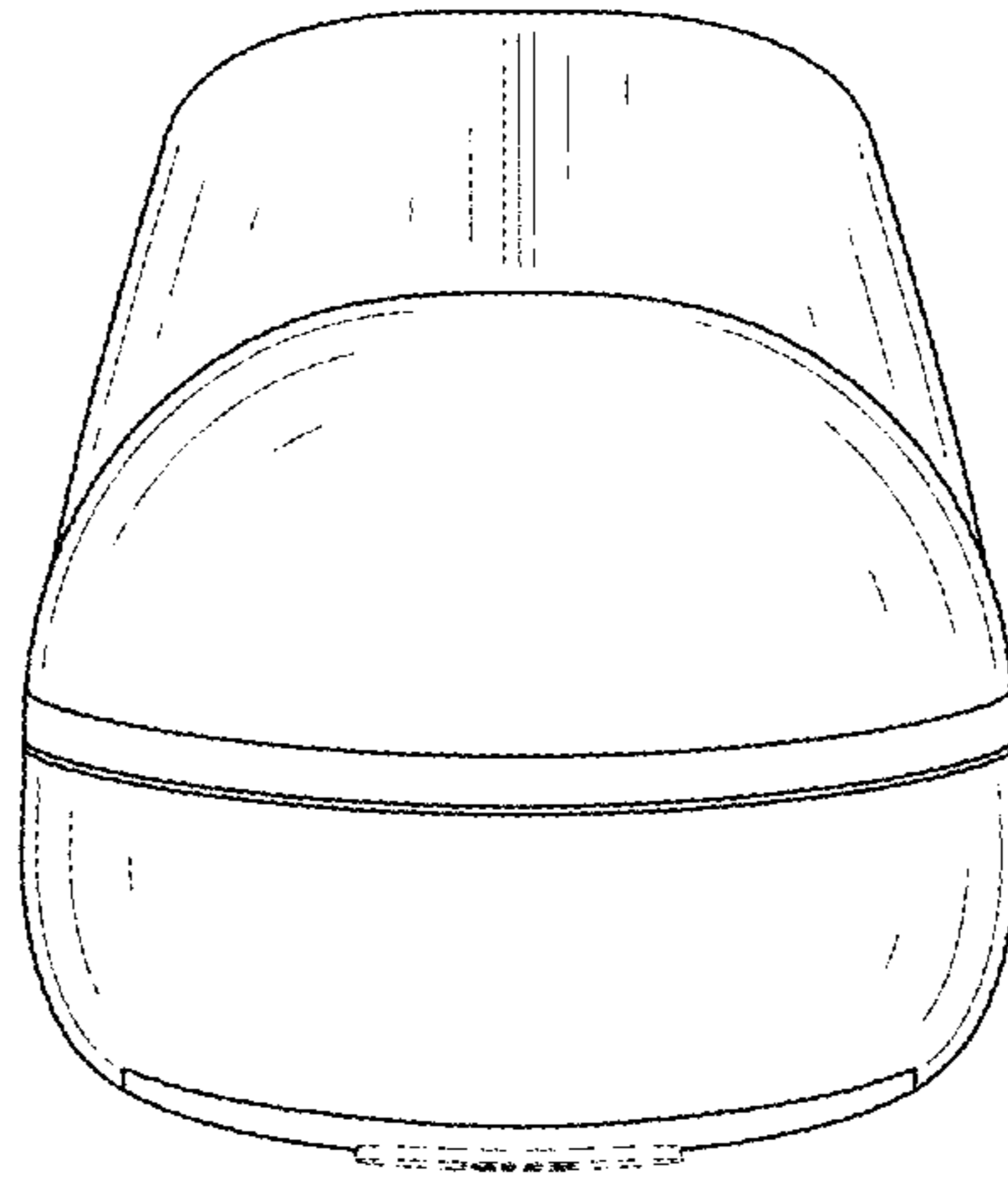
